The ornamental design for a remote control for multimedia controller, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a remote control for multimedia controller showing our new design;

FIG. 2 is a right side elevational view thereof, the left side being a mirror image of the right side;

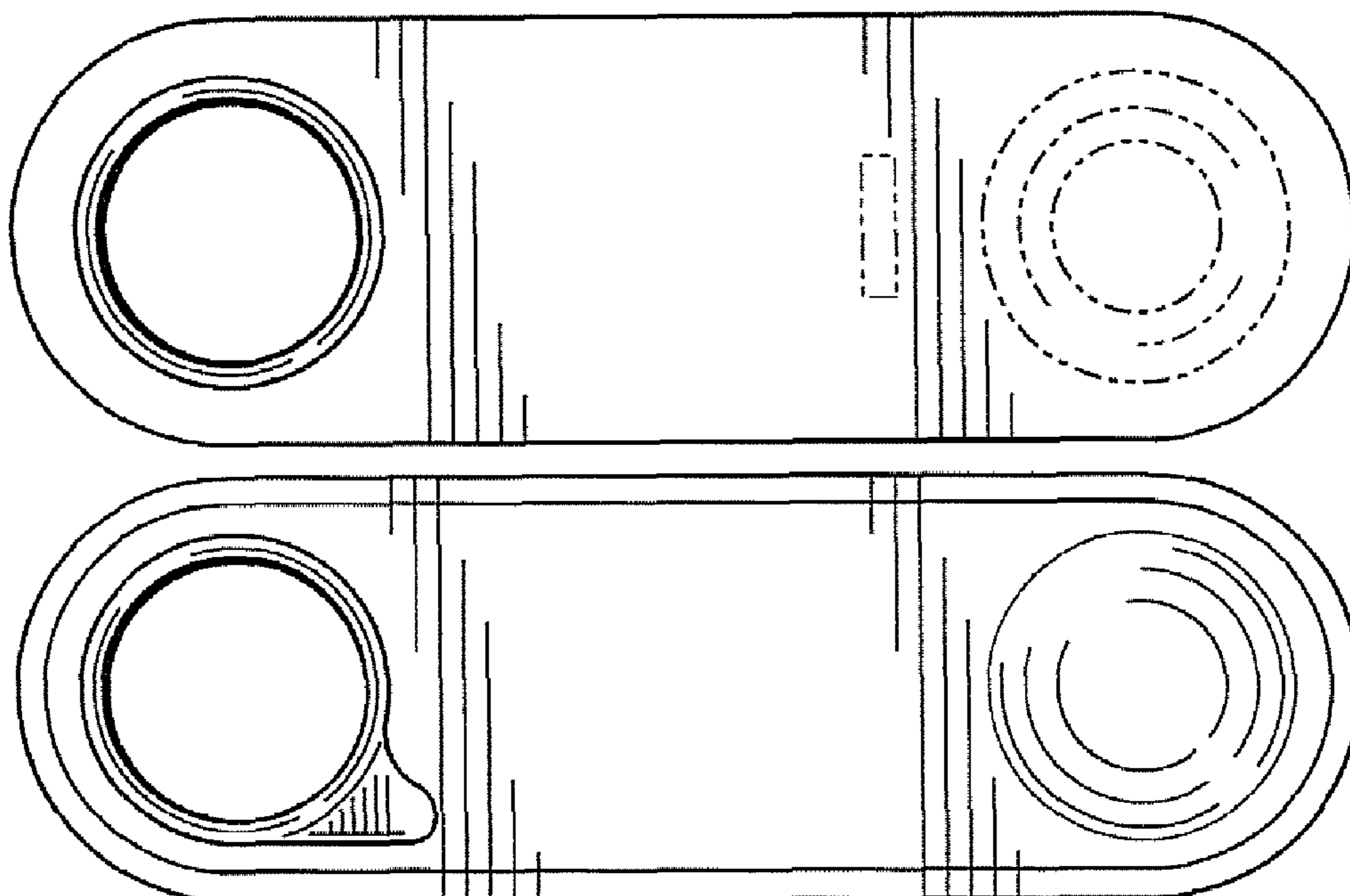
FIG. 3 is a front elevational view thereof;

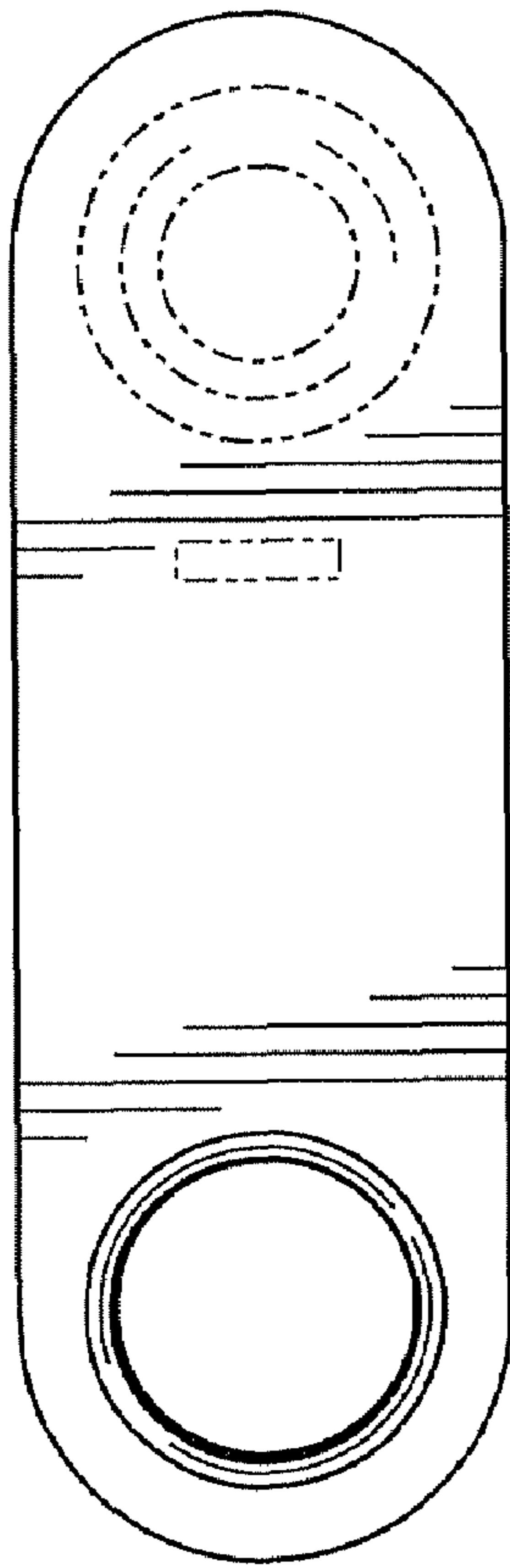

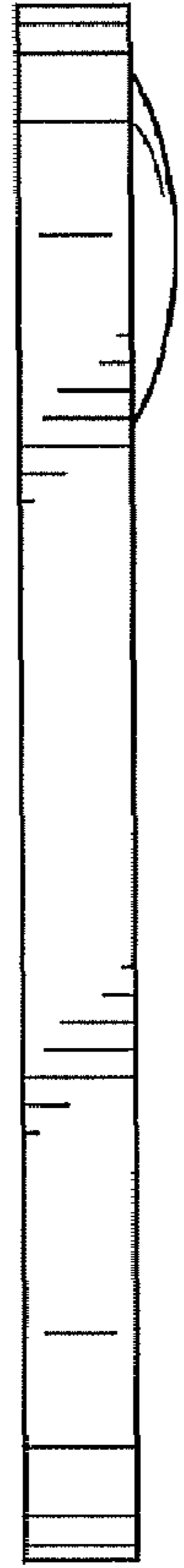

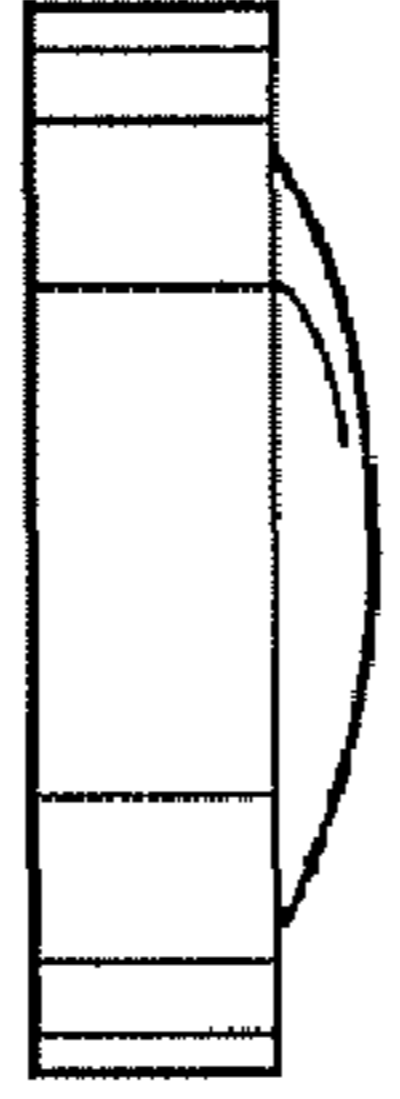

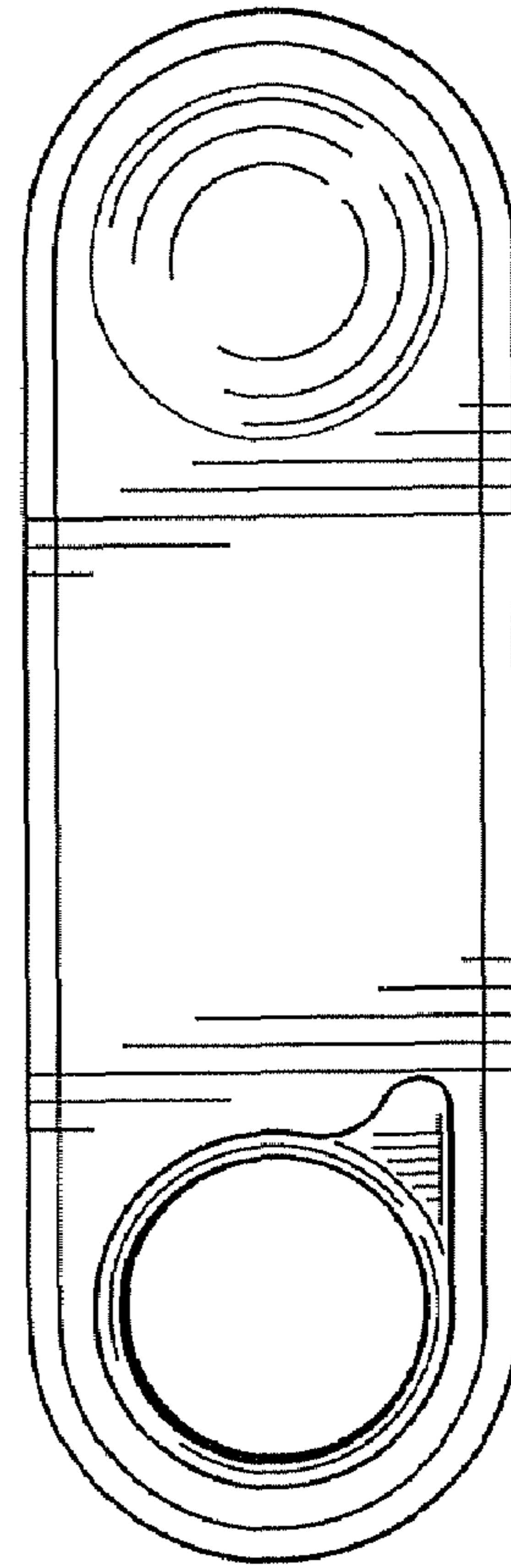
