FIG. 1 is a perspective view of a freezer showing the design;

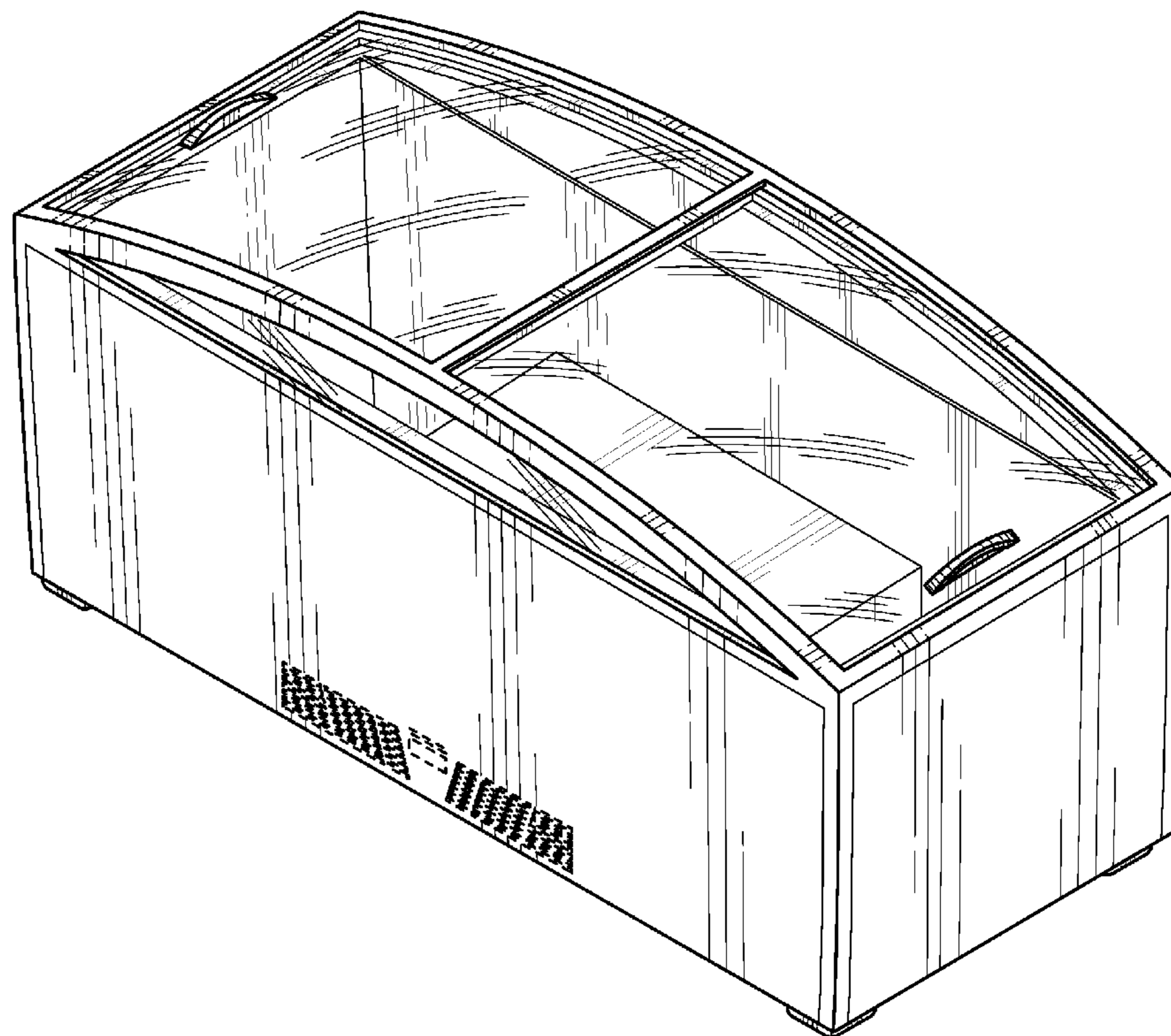
FIG. 2 is a front elevation view thereof;

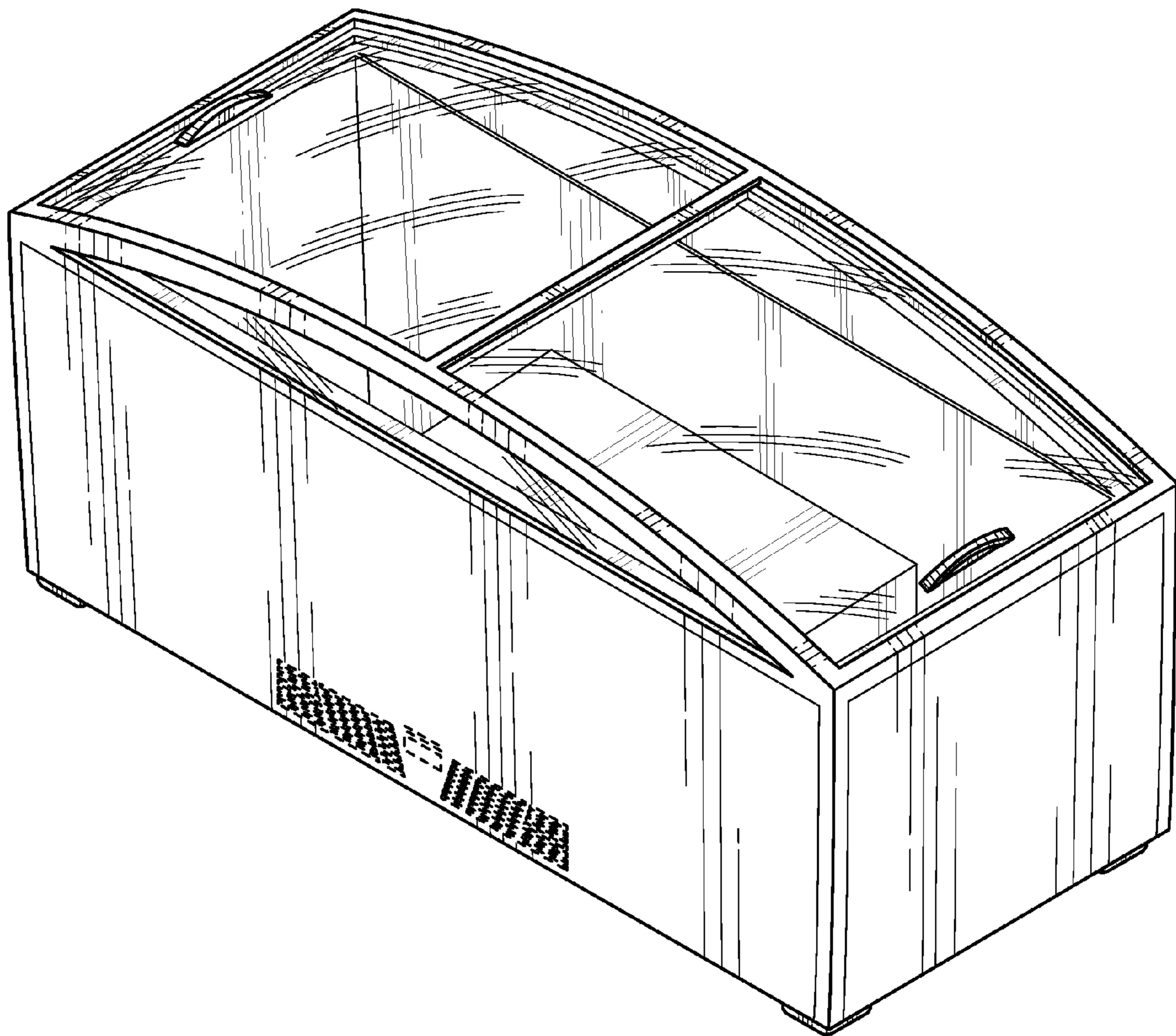

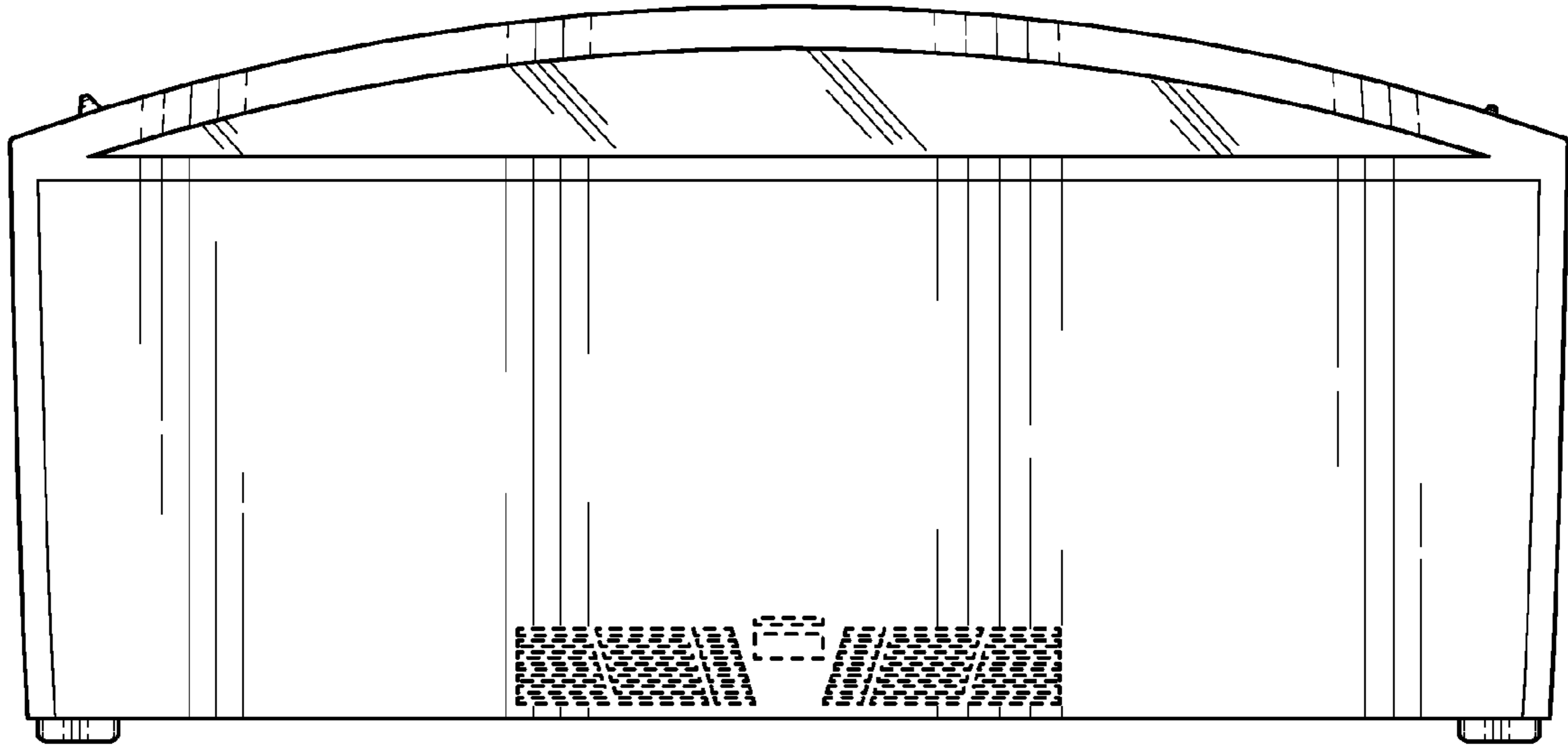

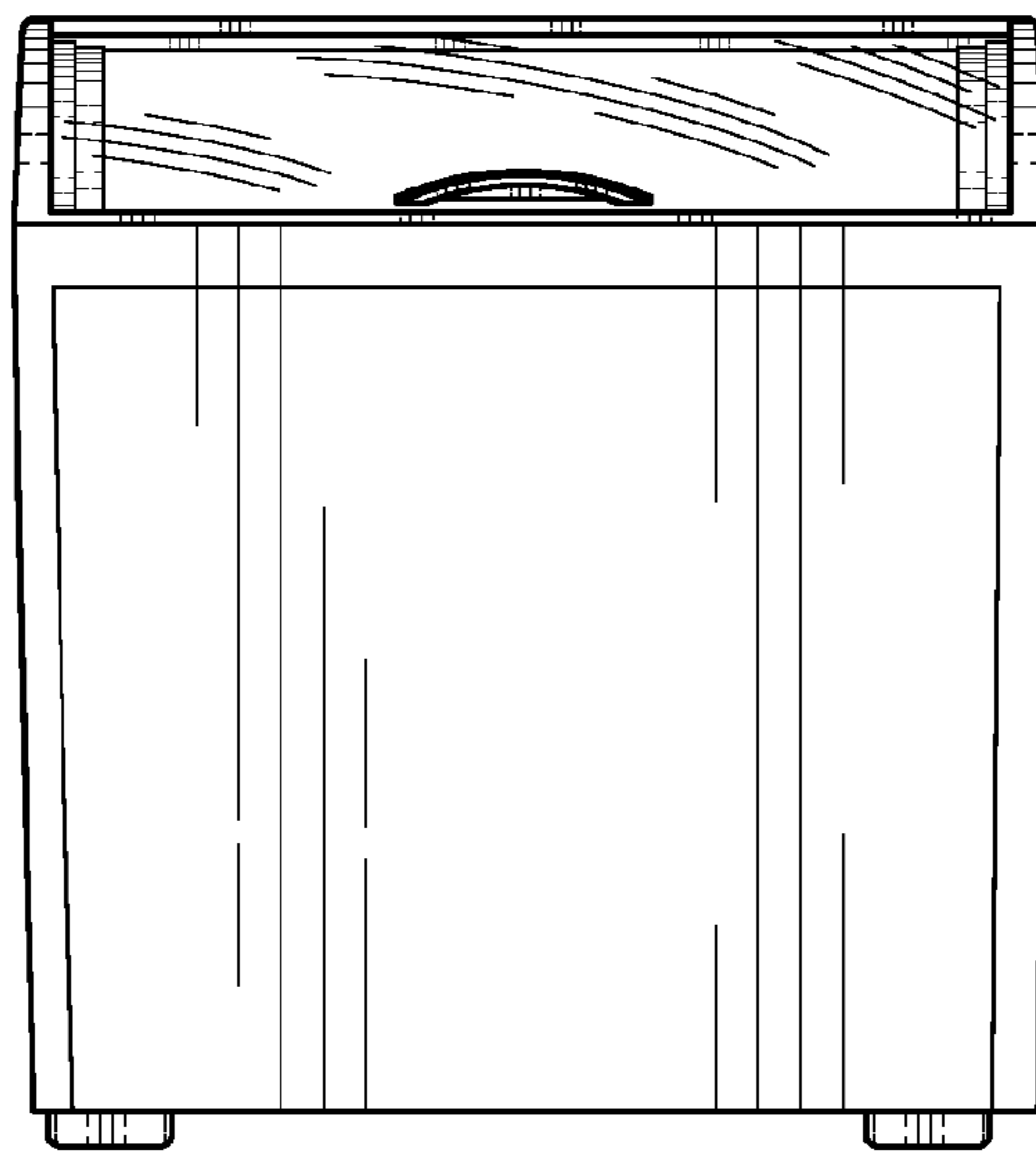

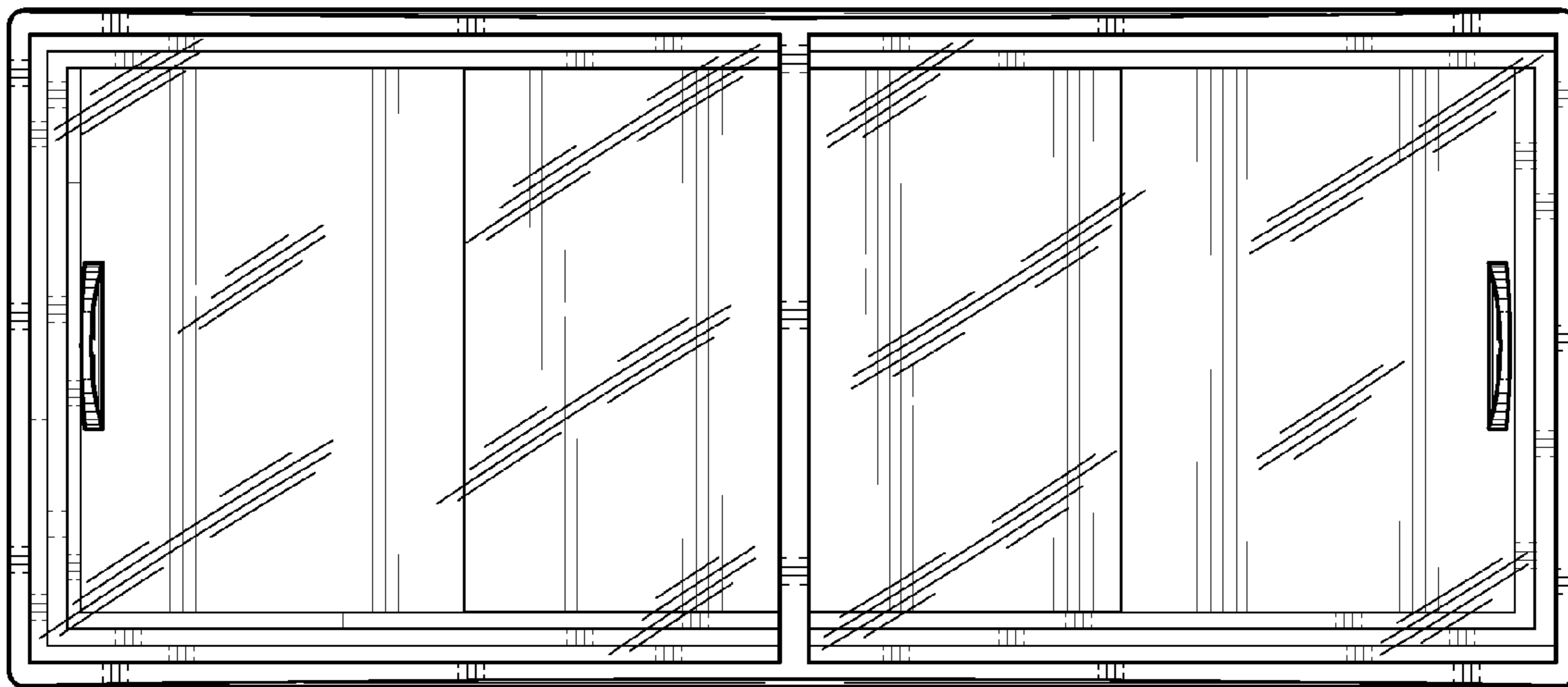
