(57) **CLAIM**

I claim a human shaped toilet stationery organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the human shaped toilet stationery organizer showing my new design;

FIG. 4 is a top view thereof;

FIG. 5 is an opposite side view thereof;

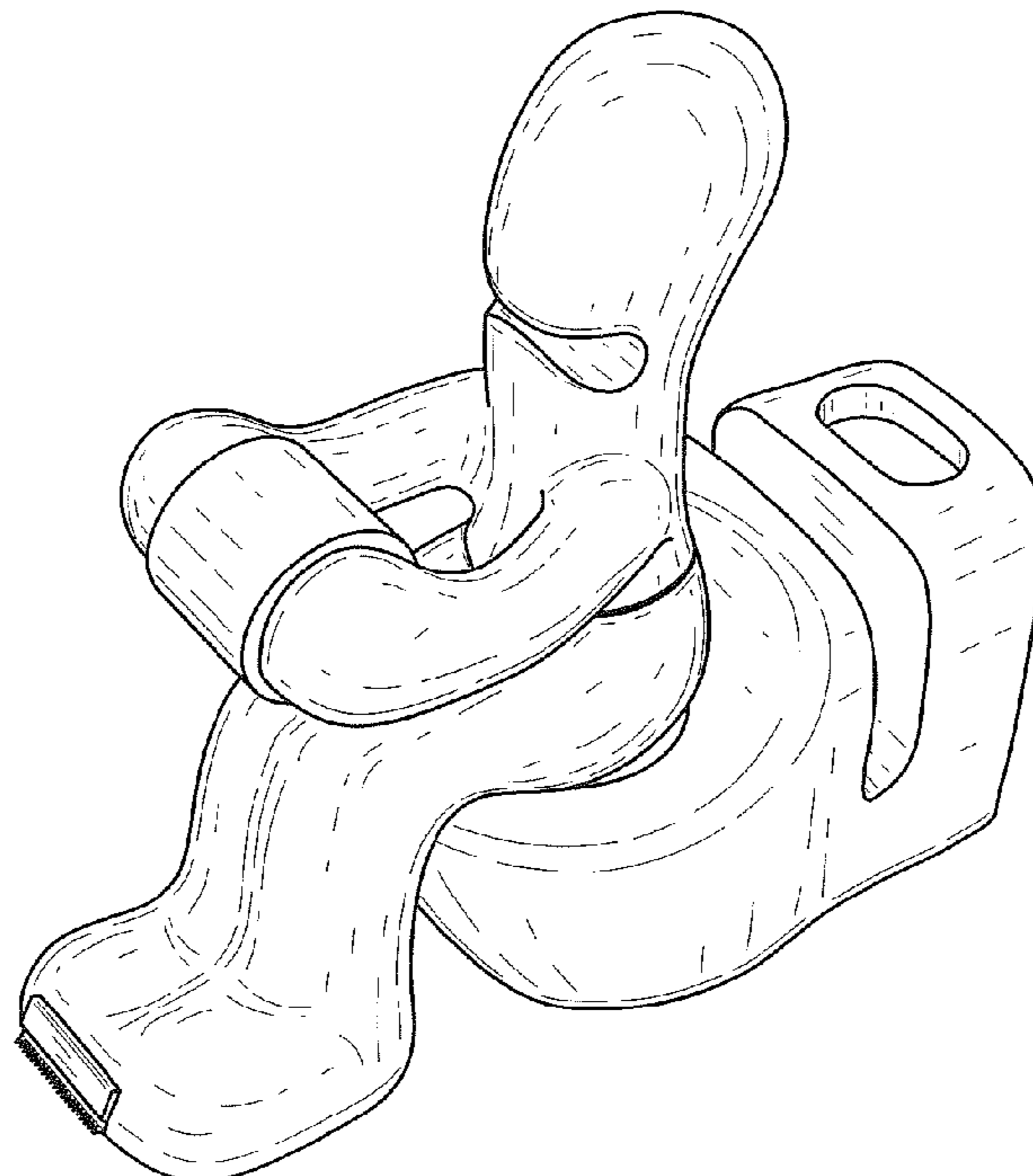
FIG. 6 is a bottom view thereof;

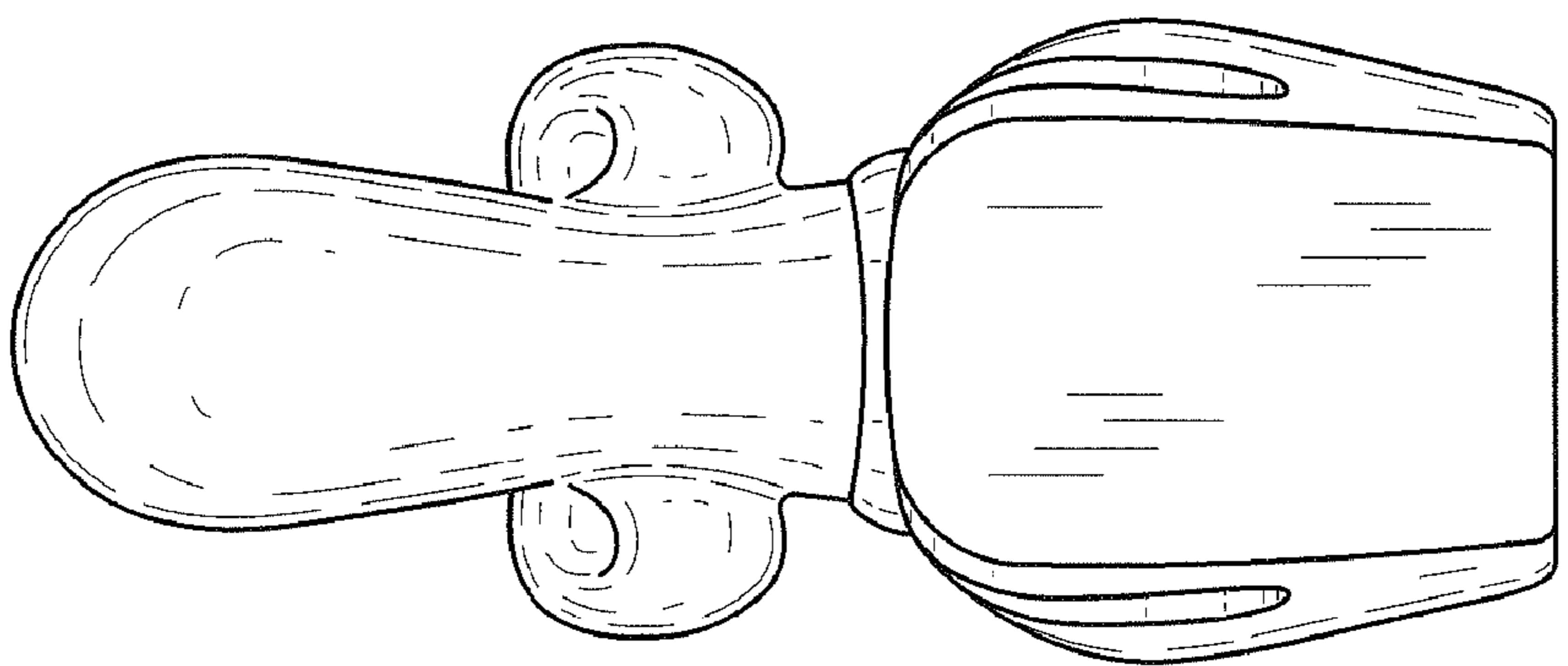

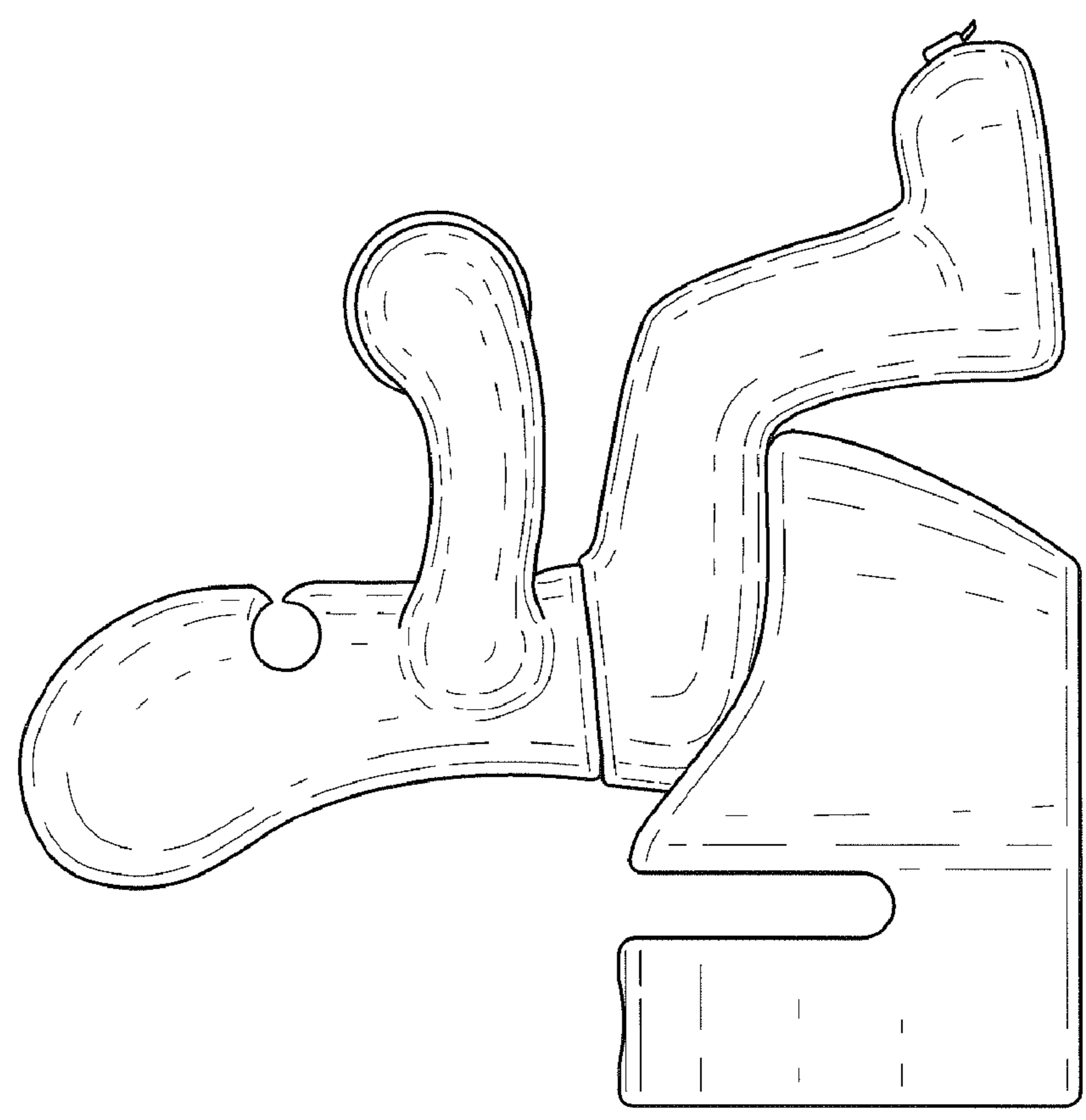

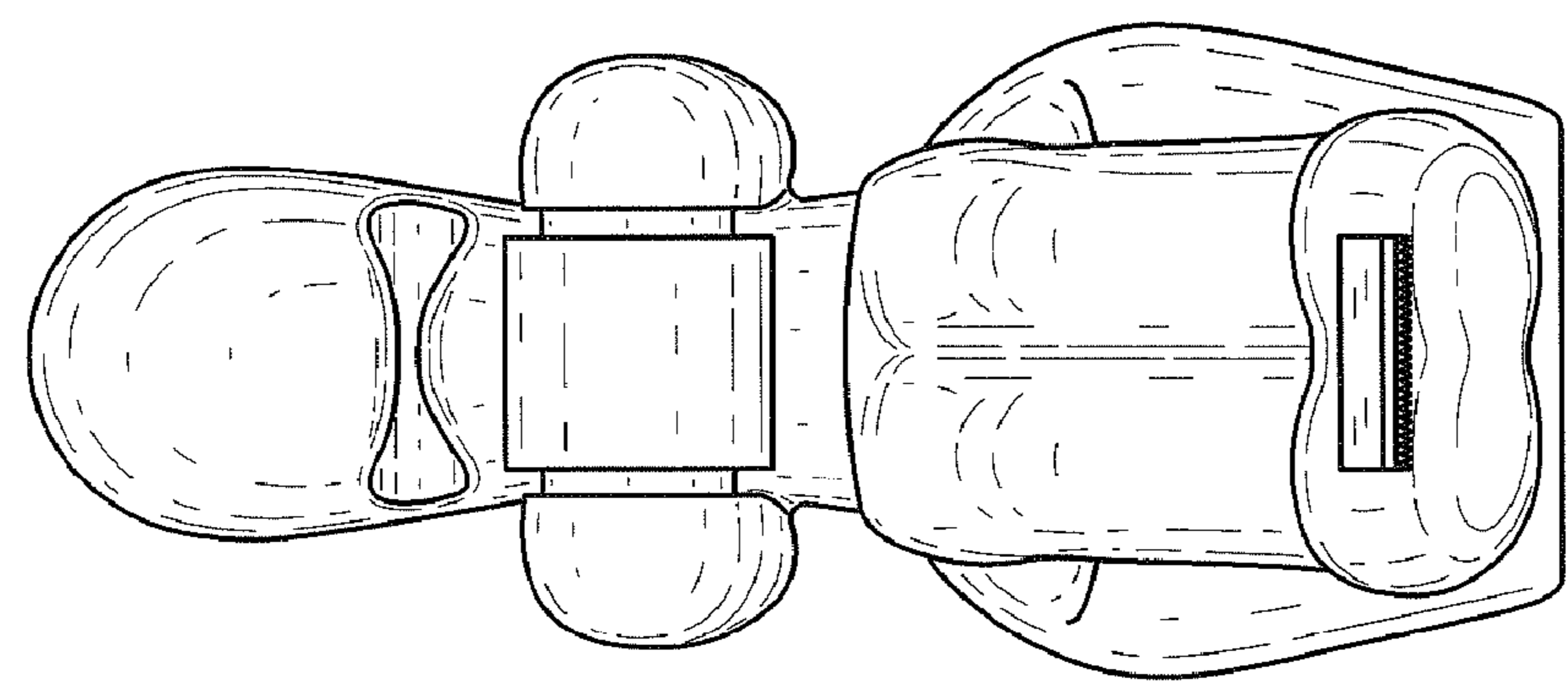

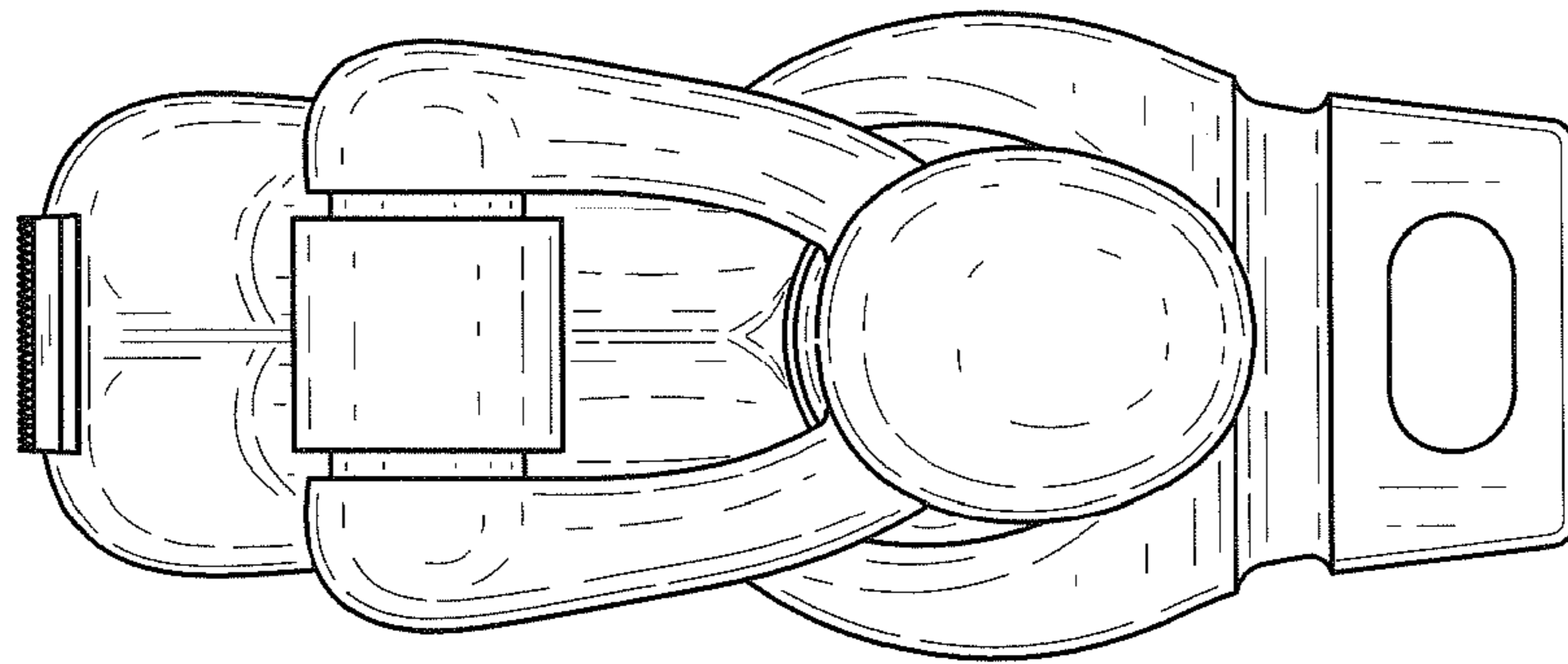

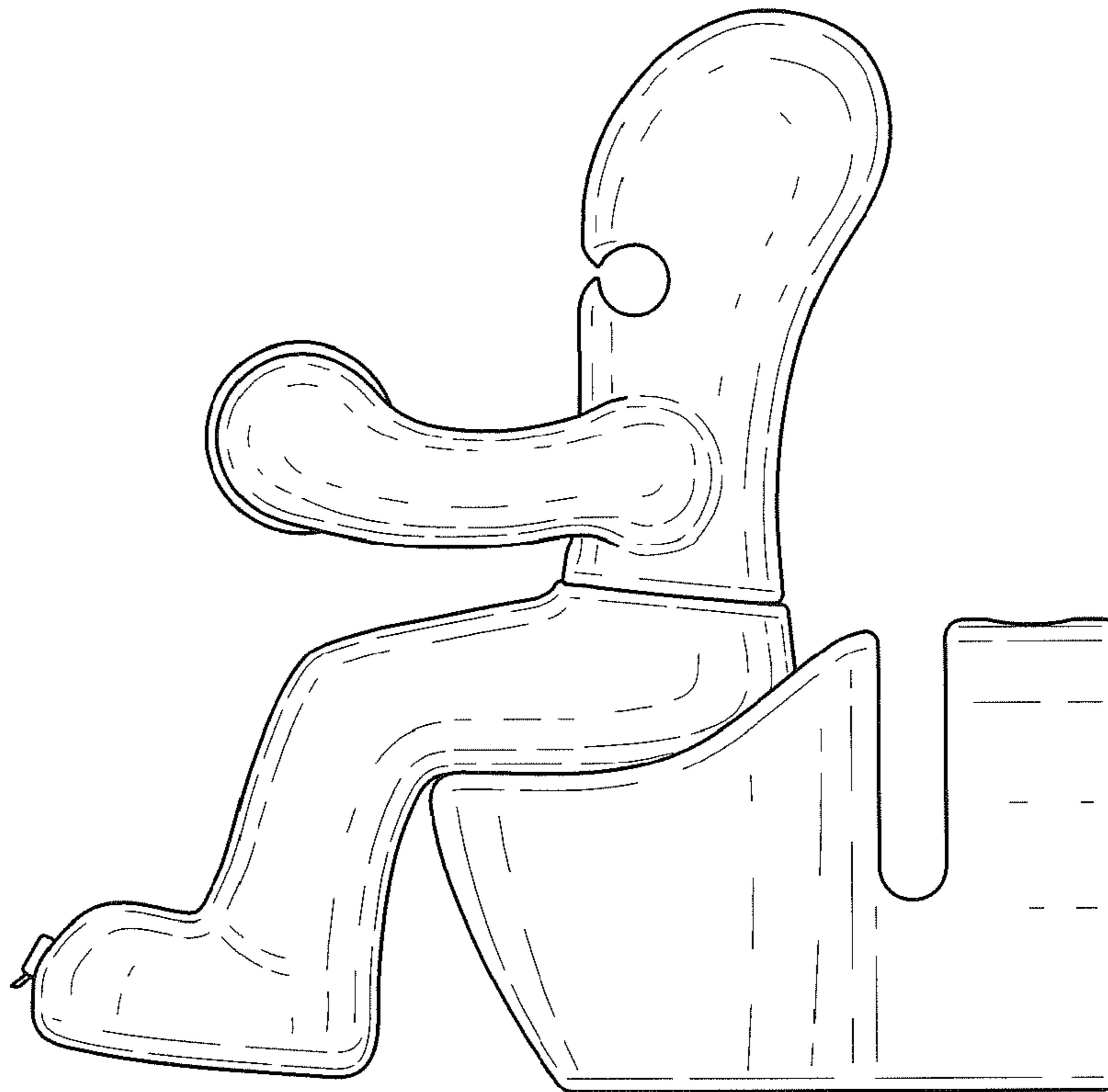

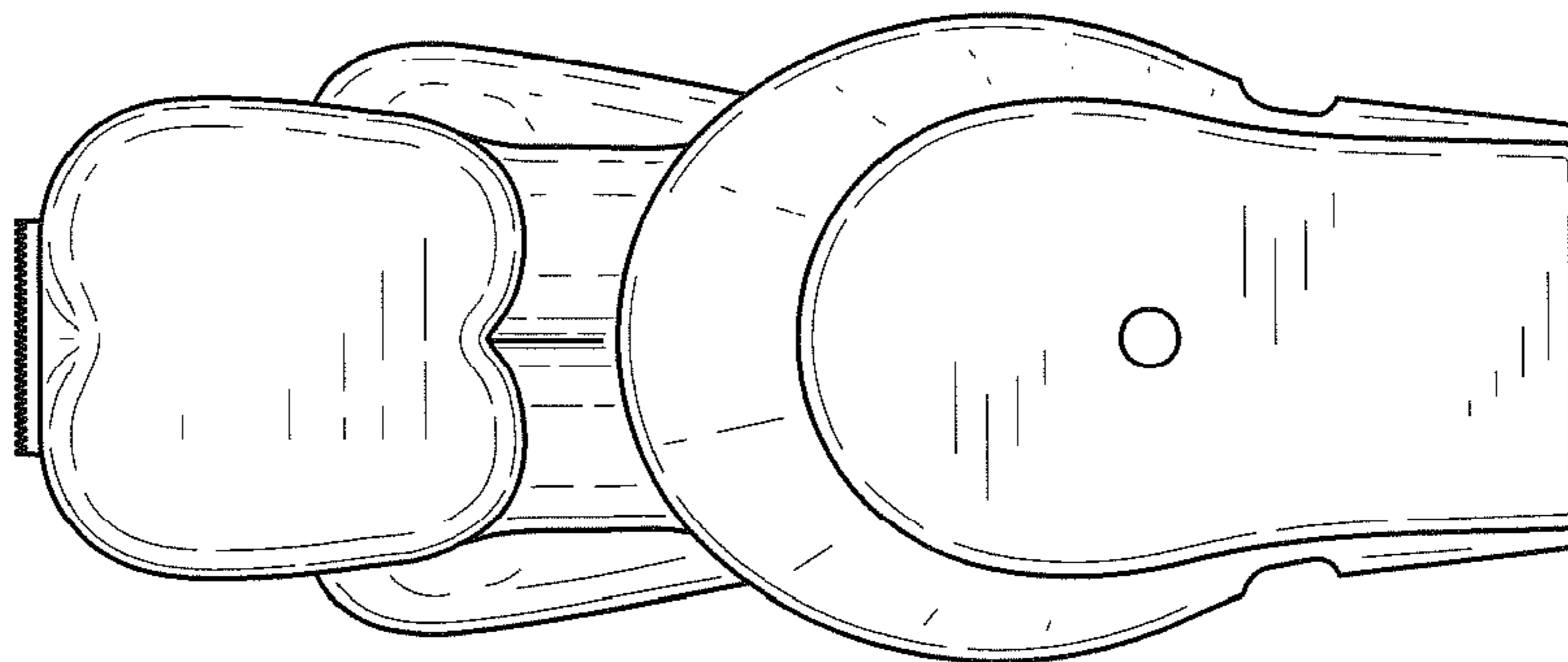

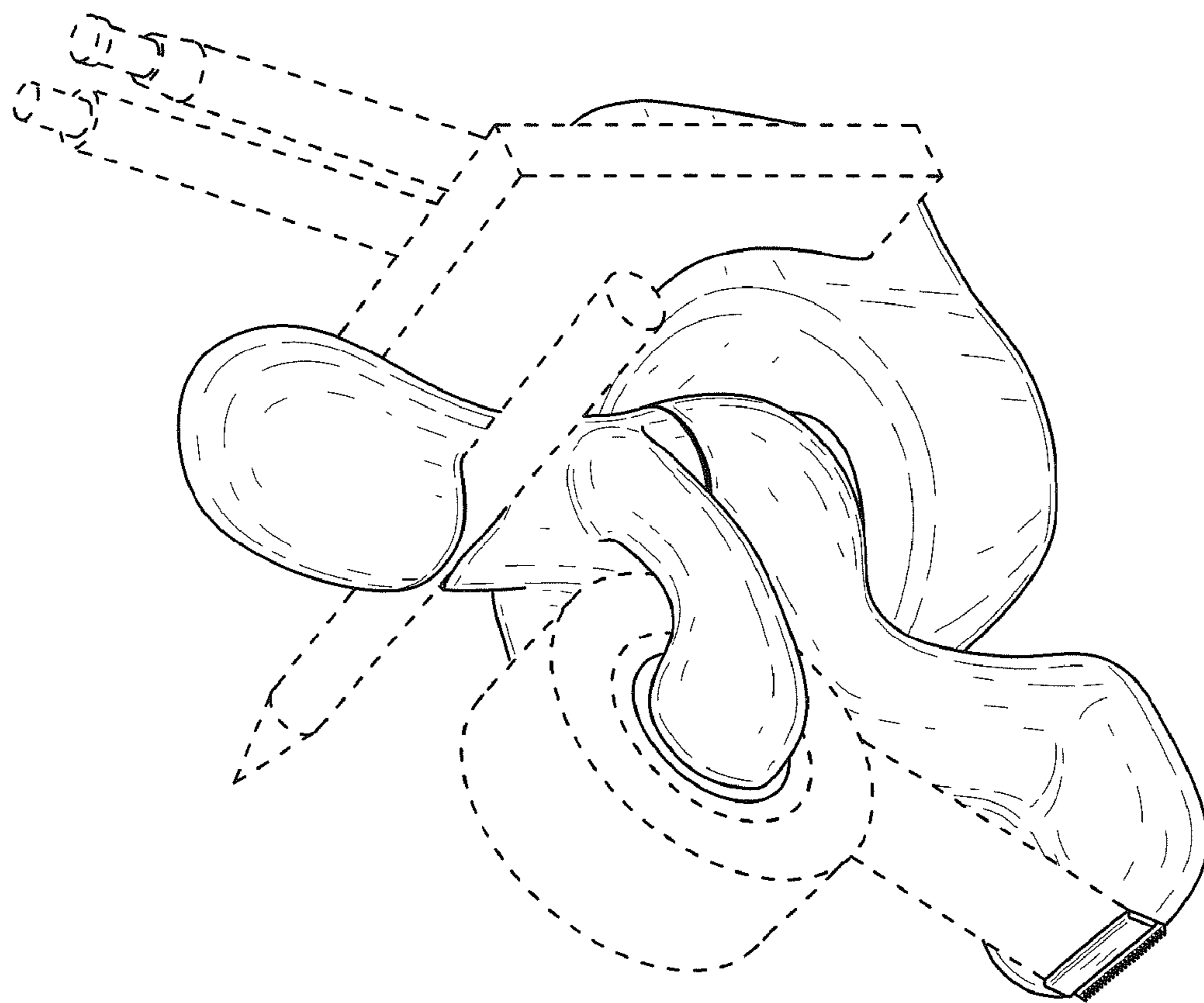

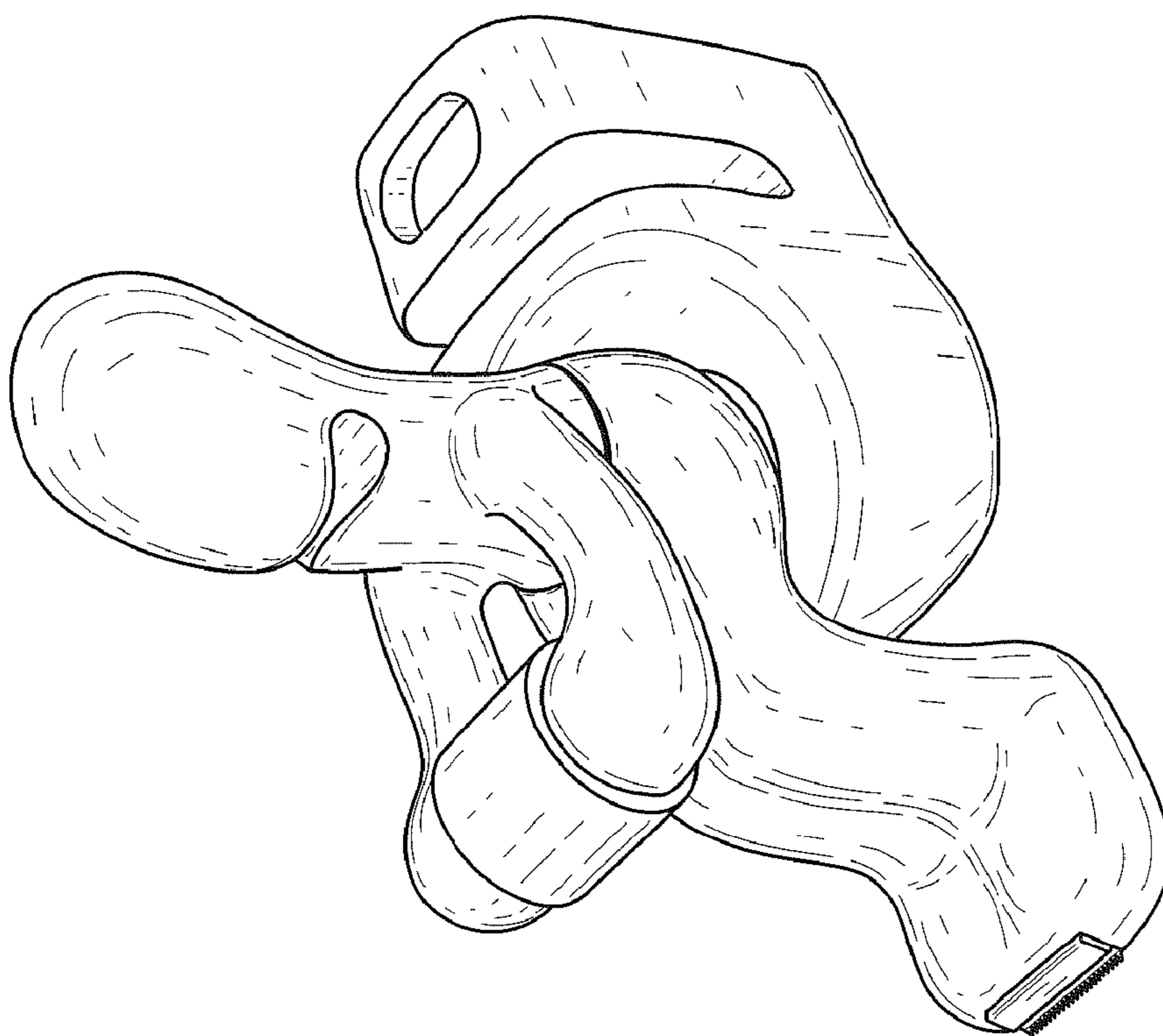

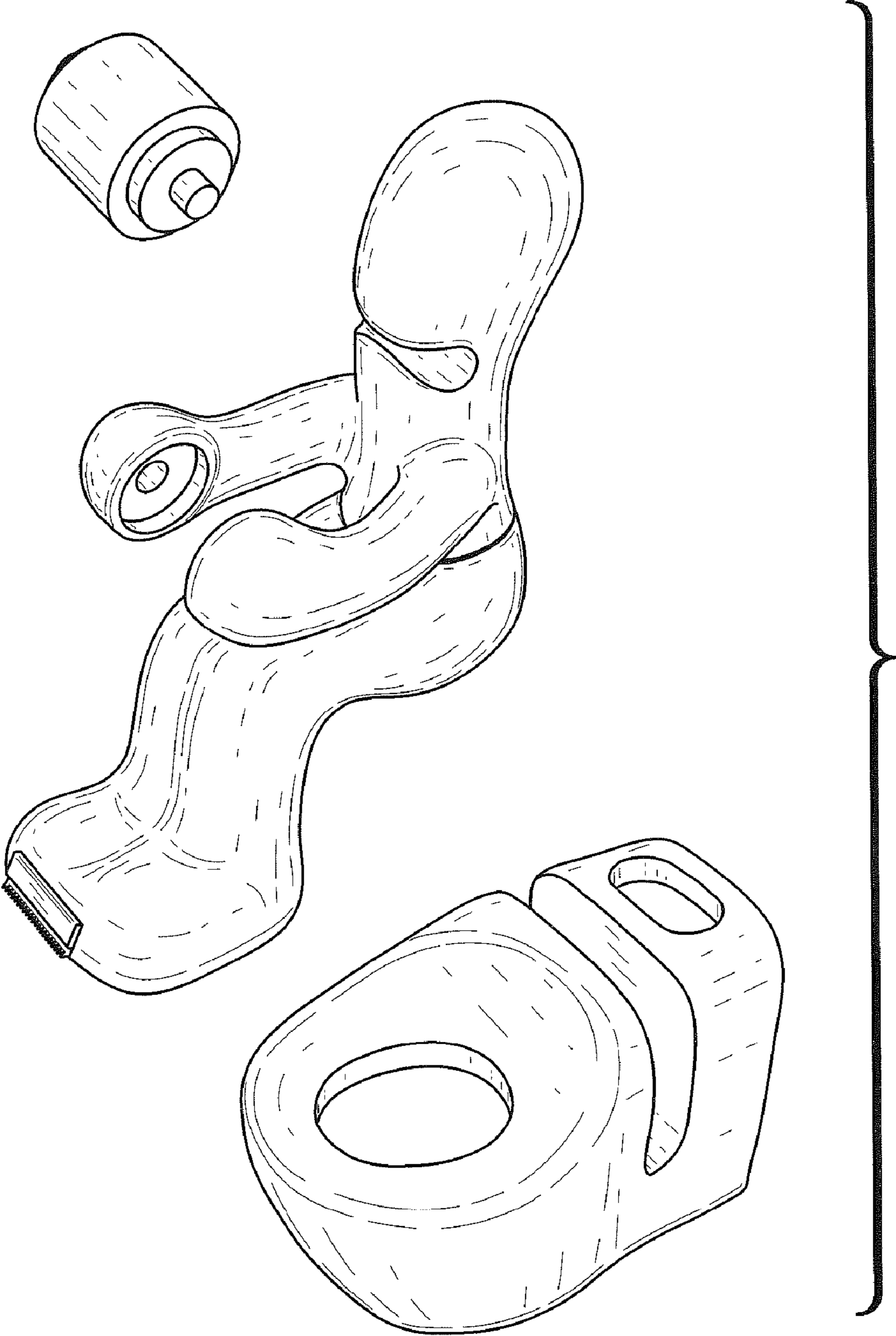
