**DESCRIPTION**

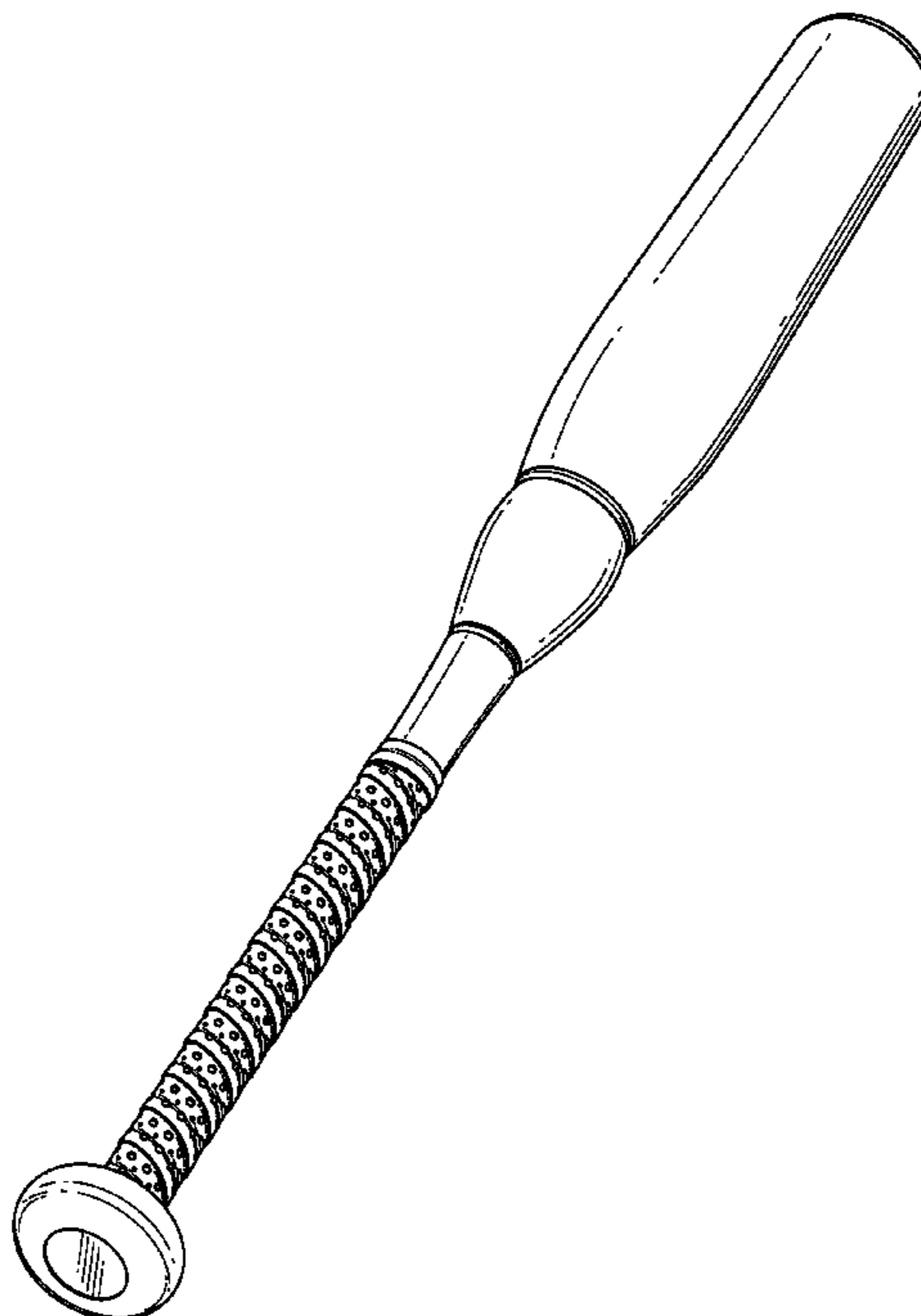
FIG. 1 is a perspective view of a baseball bat showing my new design;

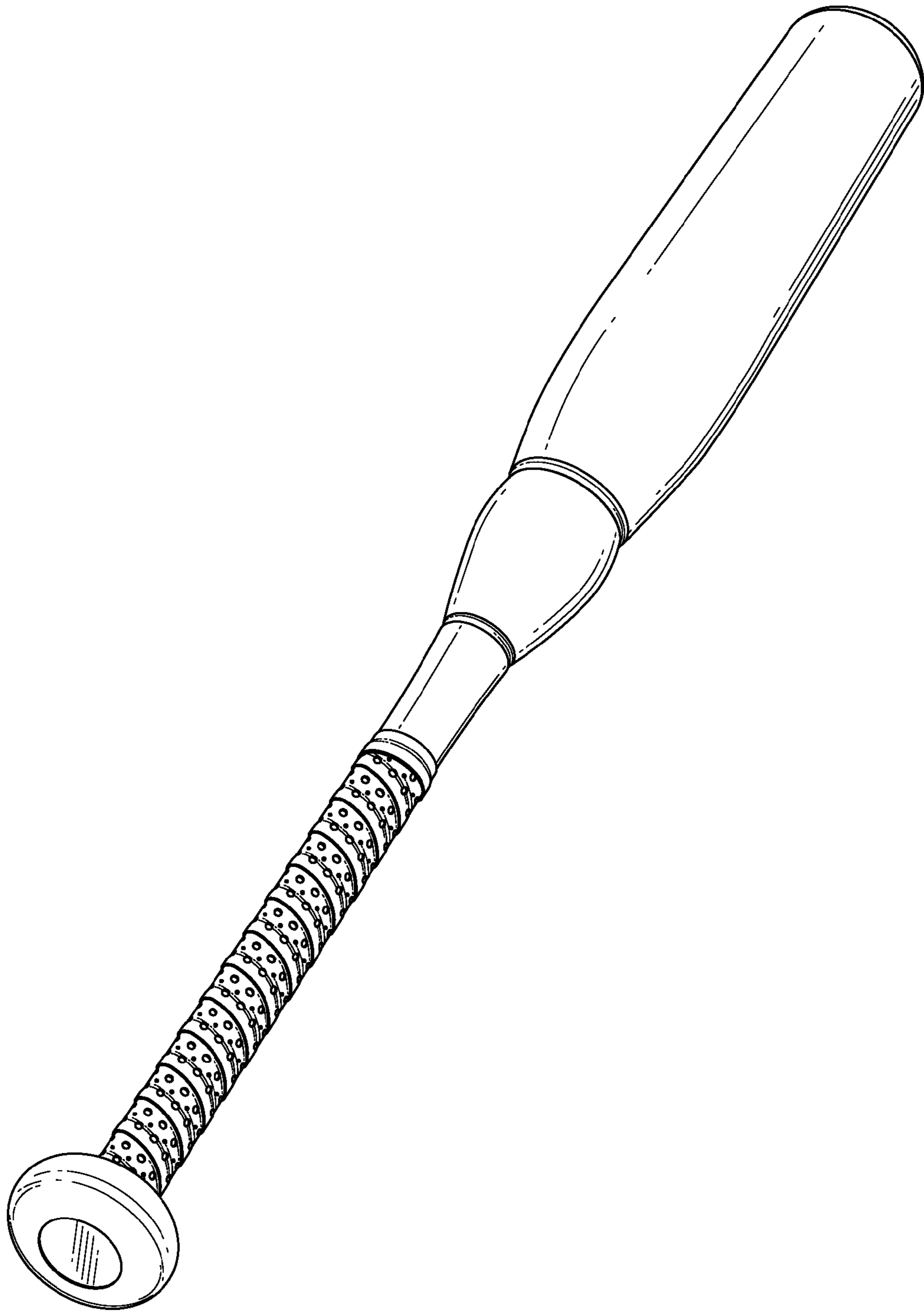

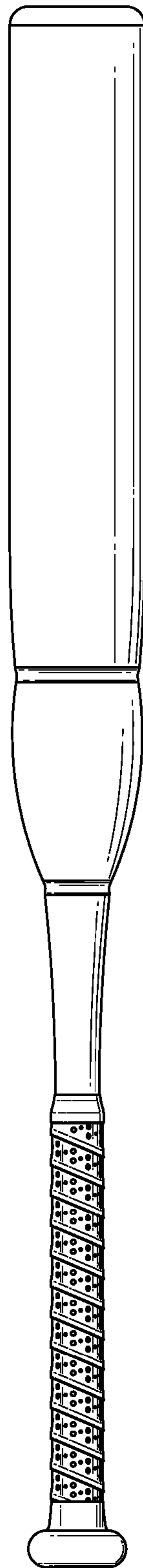

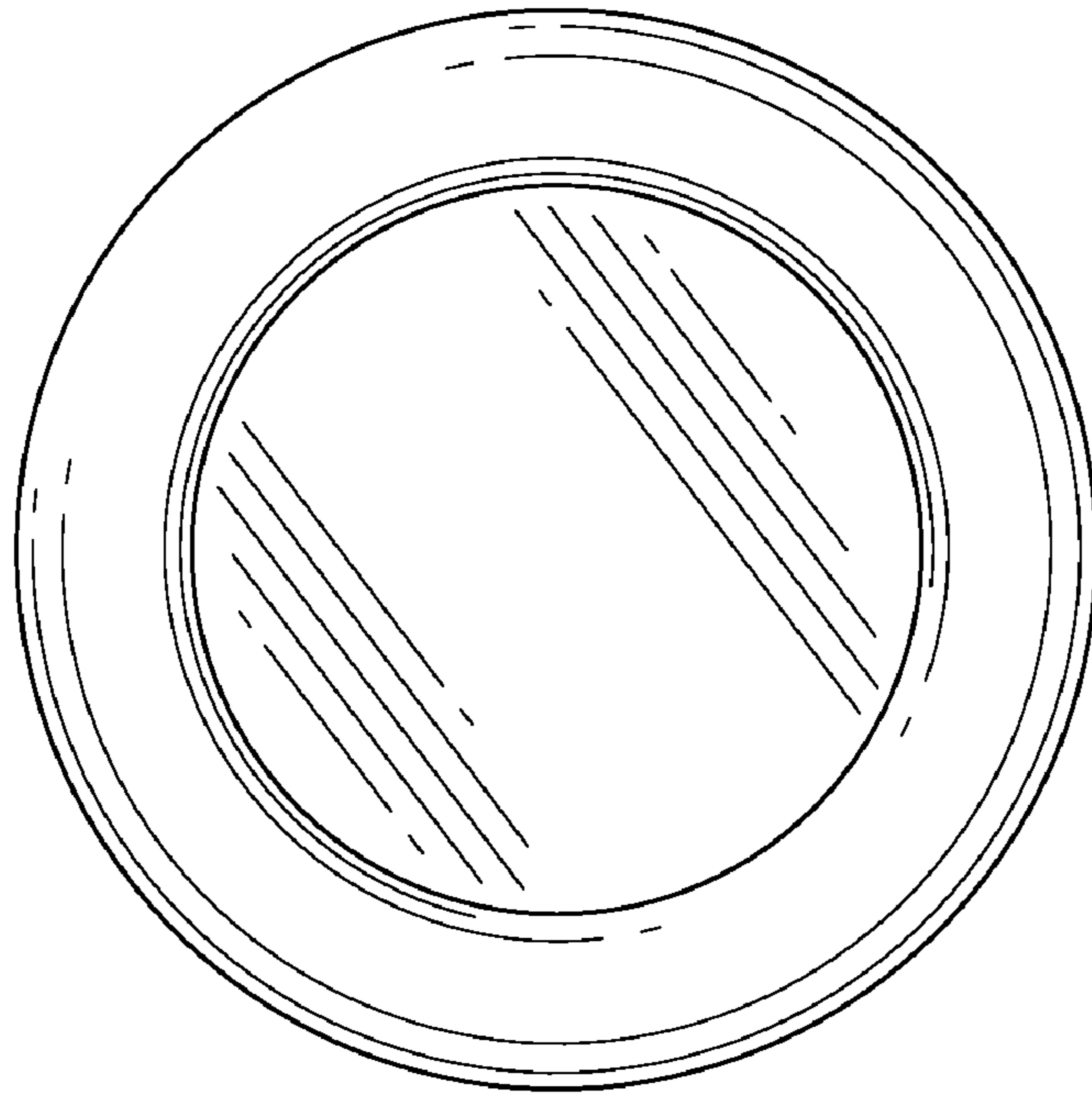

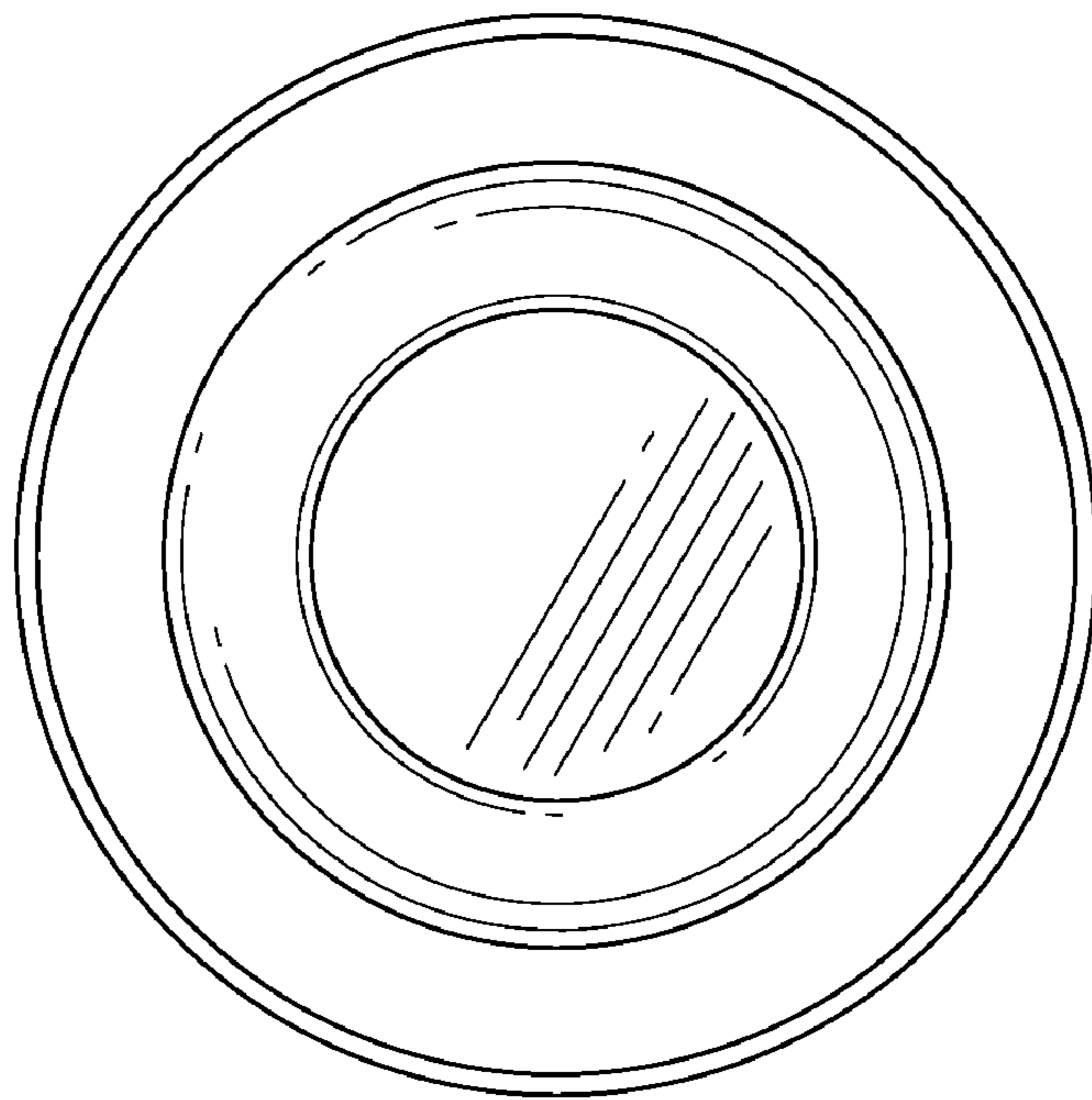
