(57) **CLAIM**

The ornamental design of a badge for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a badge for a golf club head;

FIG. 2 is a top perspective view of the badge portion of the golf club head, shown for clarity of illustration;

FIG. 3 is a front elevational view of FIG. 2;

FIG. 4 is a rear elevational view of FIG. 2;

FIG. 5 is a top view of FIG. 2;

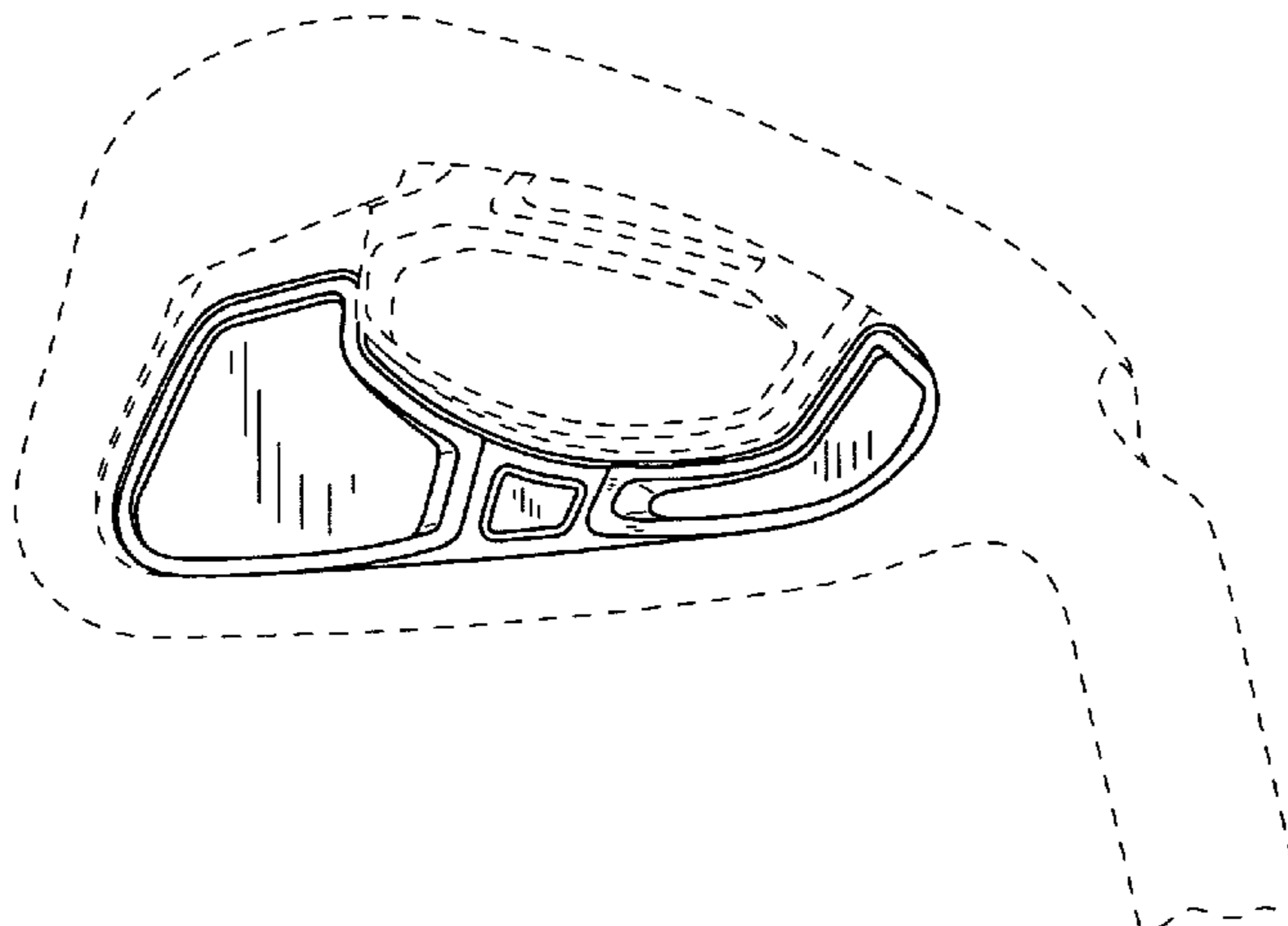
FIG. 6 is a bottom view of FIG. 2;

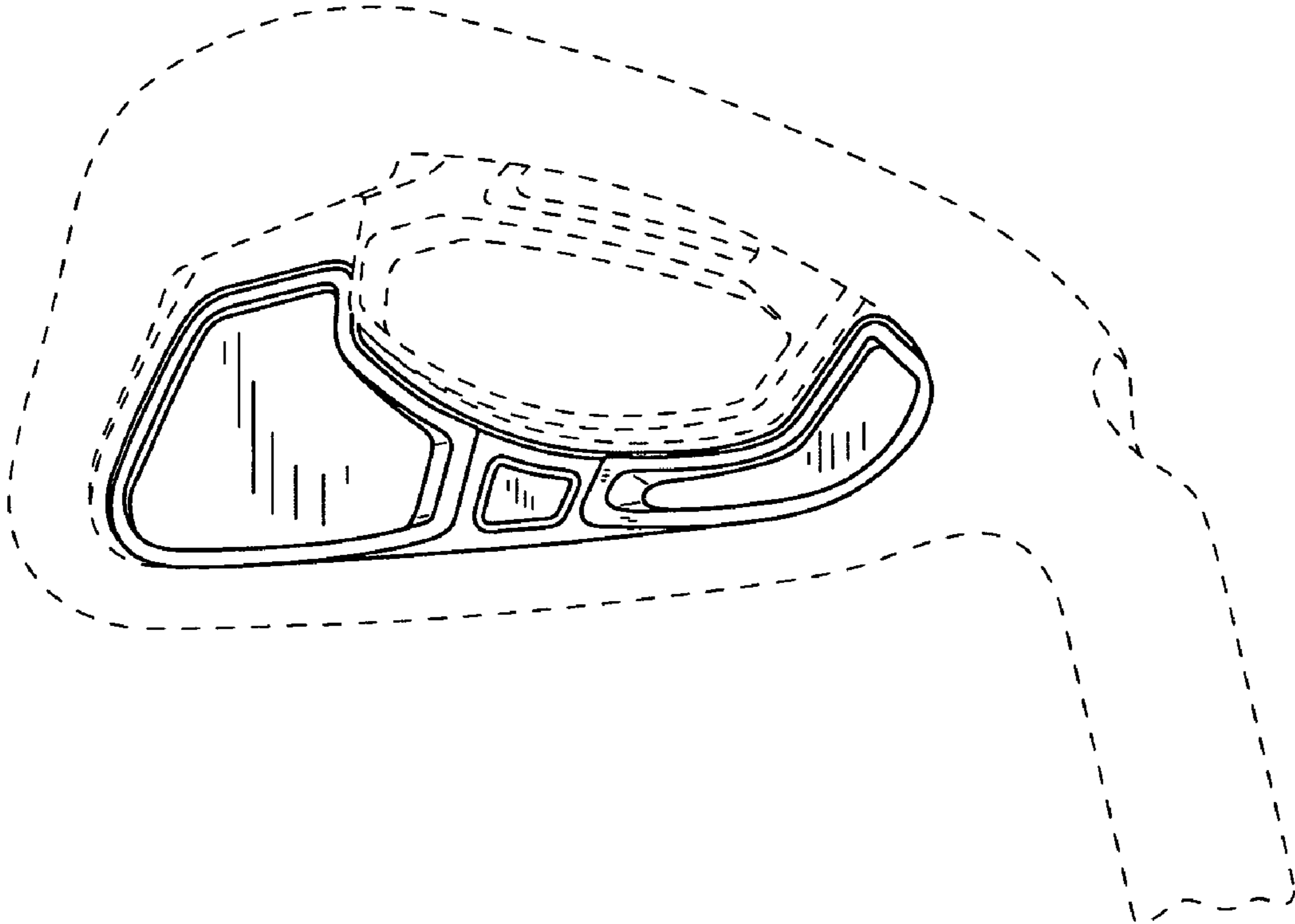

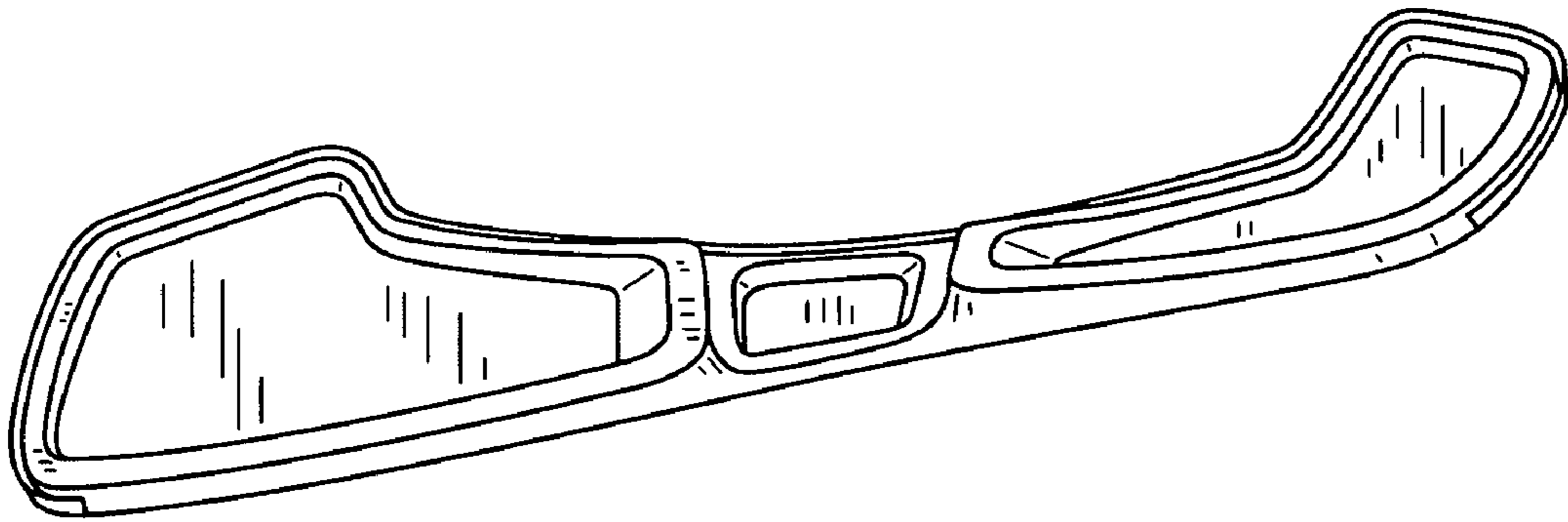

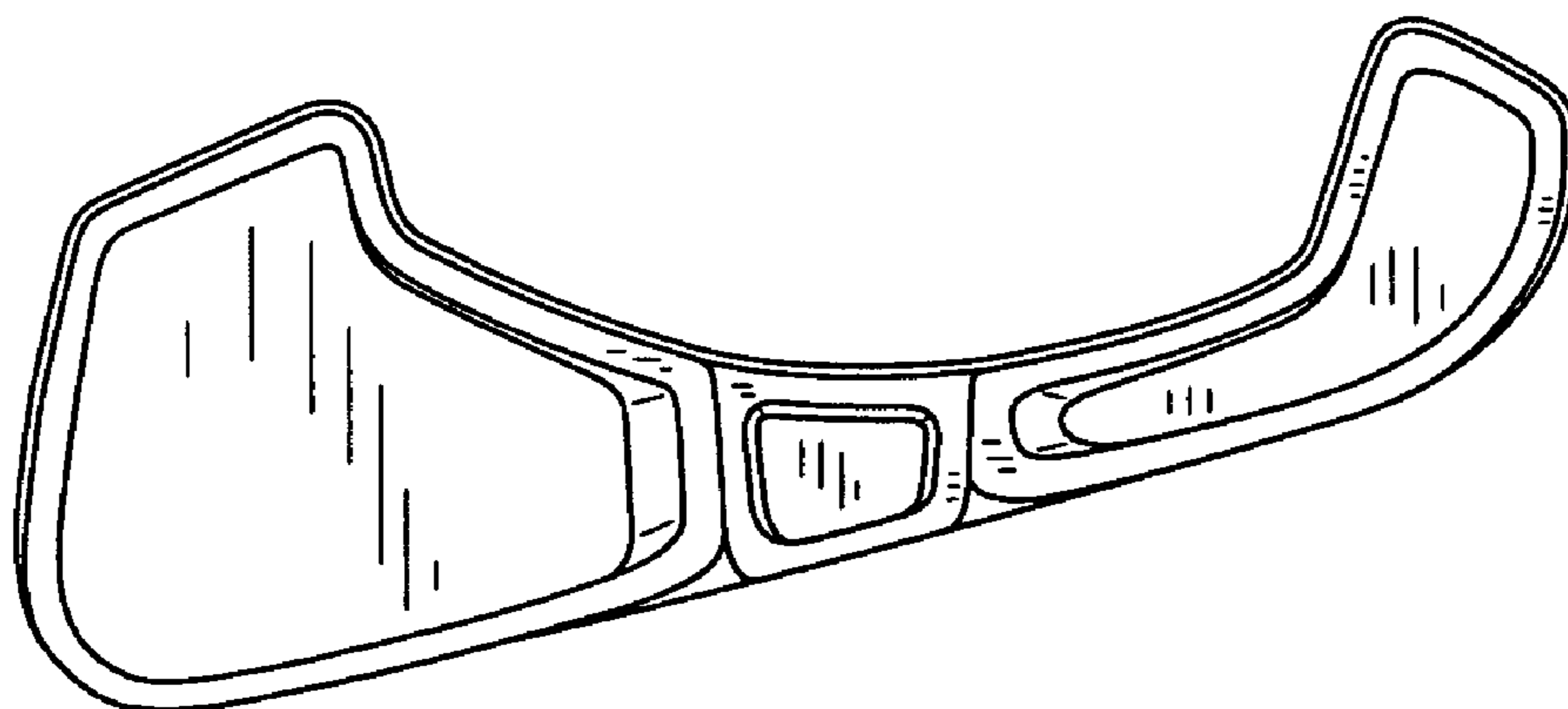

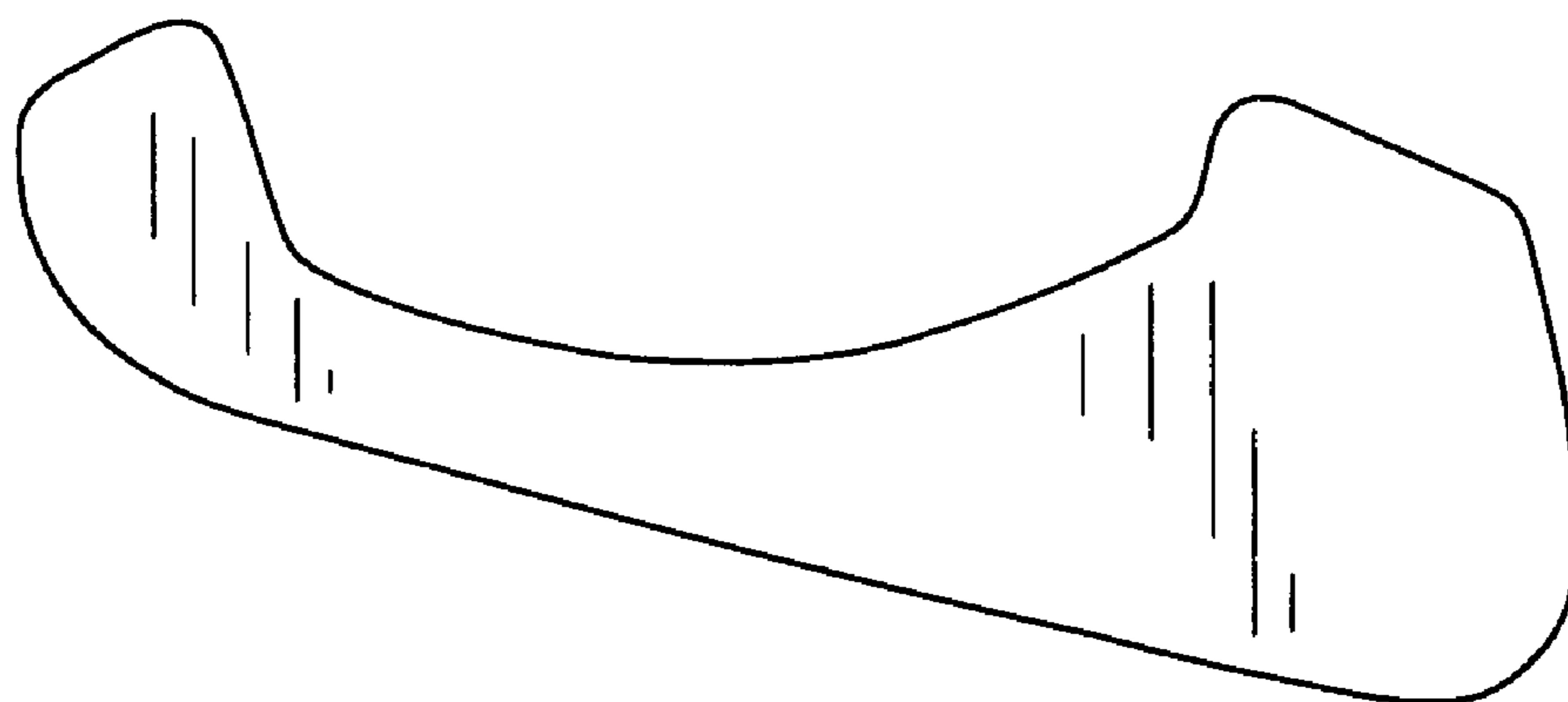

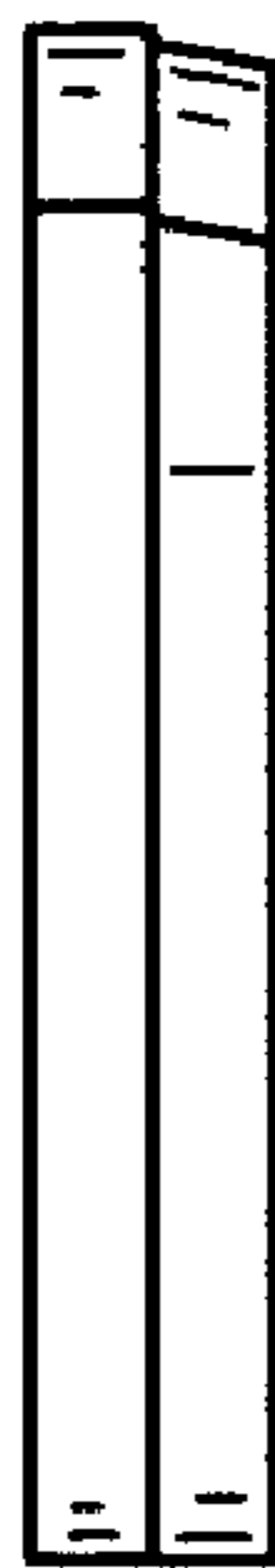
