The ornamental design for the hearing protector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hearing protector according to the present invention;

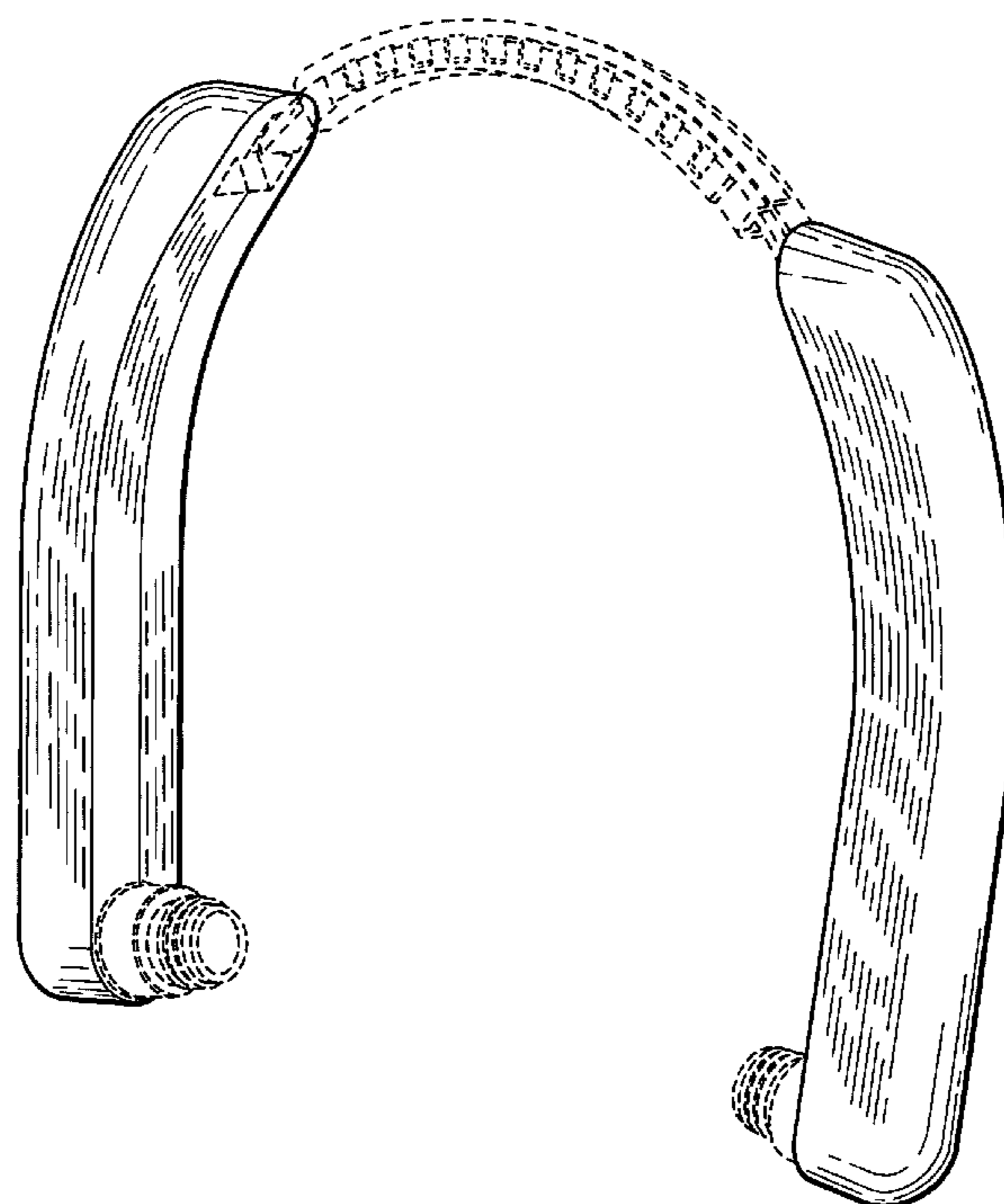
FIG. 2 is a front elevational view of the hearing protector of FIG. 1, wherein the opposite, rear elevational view is a mirror image thereof;

FIG. 3 is a top plan view of the hearing protector of FIG. 1; FIG. 4 is a bottom plan view of the hearing protector of FIG. 1; and,

FIG. 5 is a side elevational view of the hearing protector of FIG. 1, wherein the opposite side elevational view is a mirror image thereof.

The portions of the hearing protector shown in broken lines form no part of the claimed design.

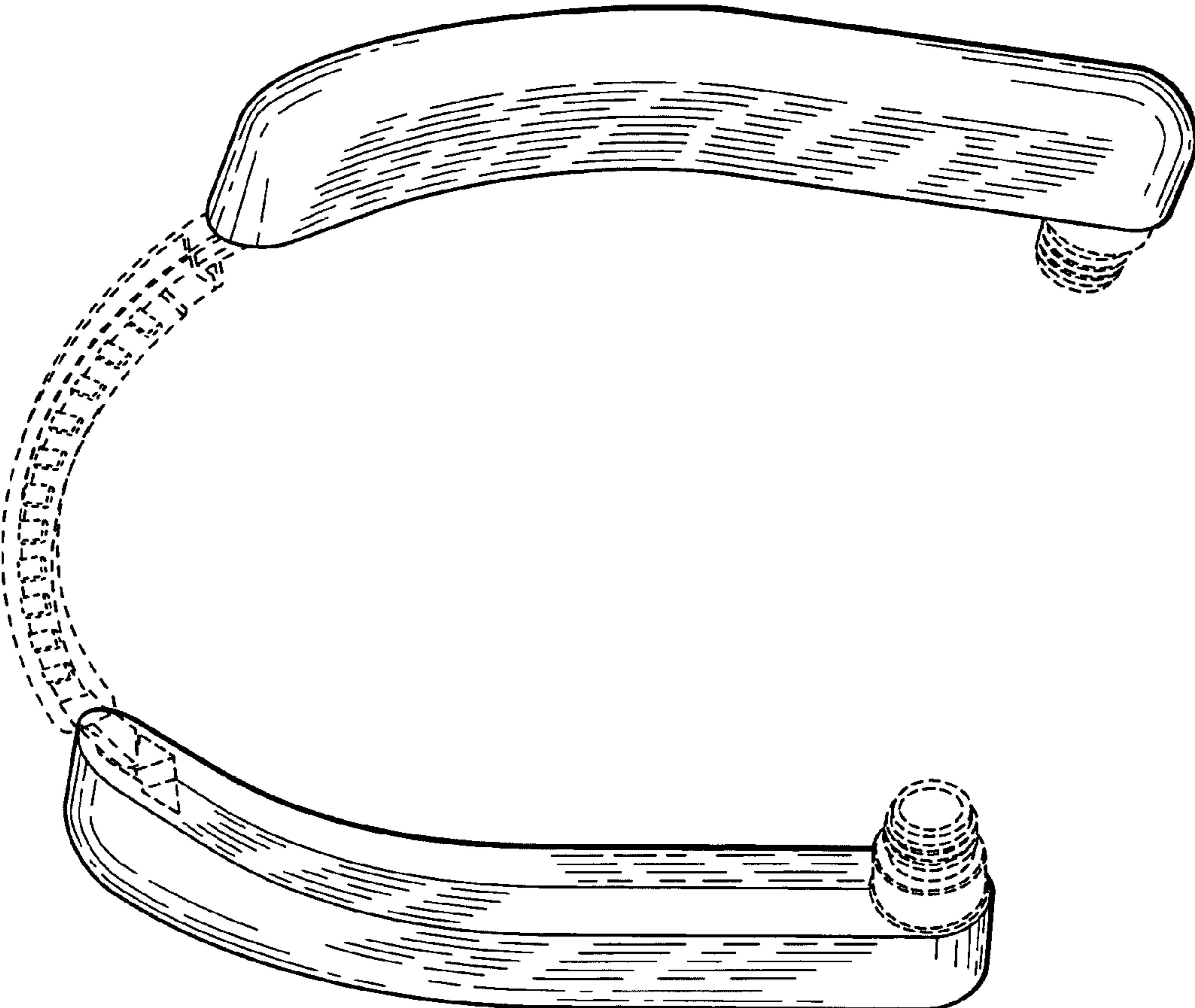

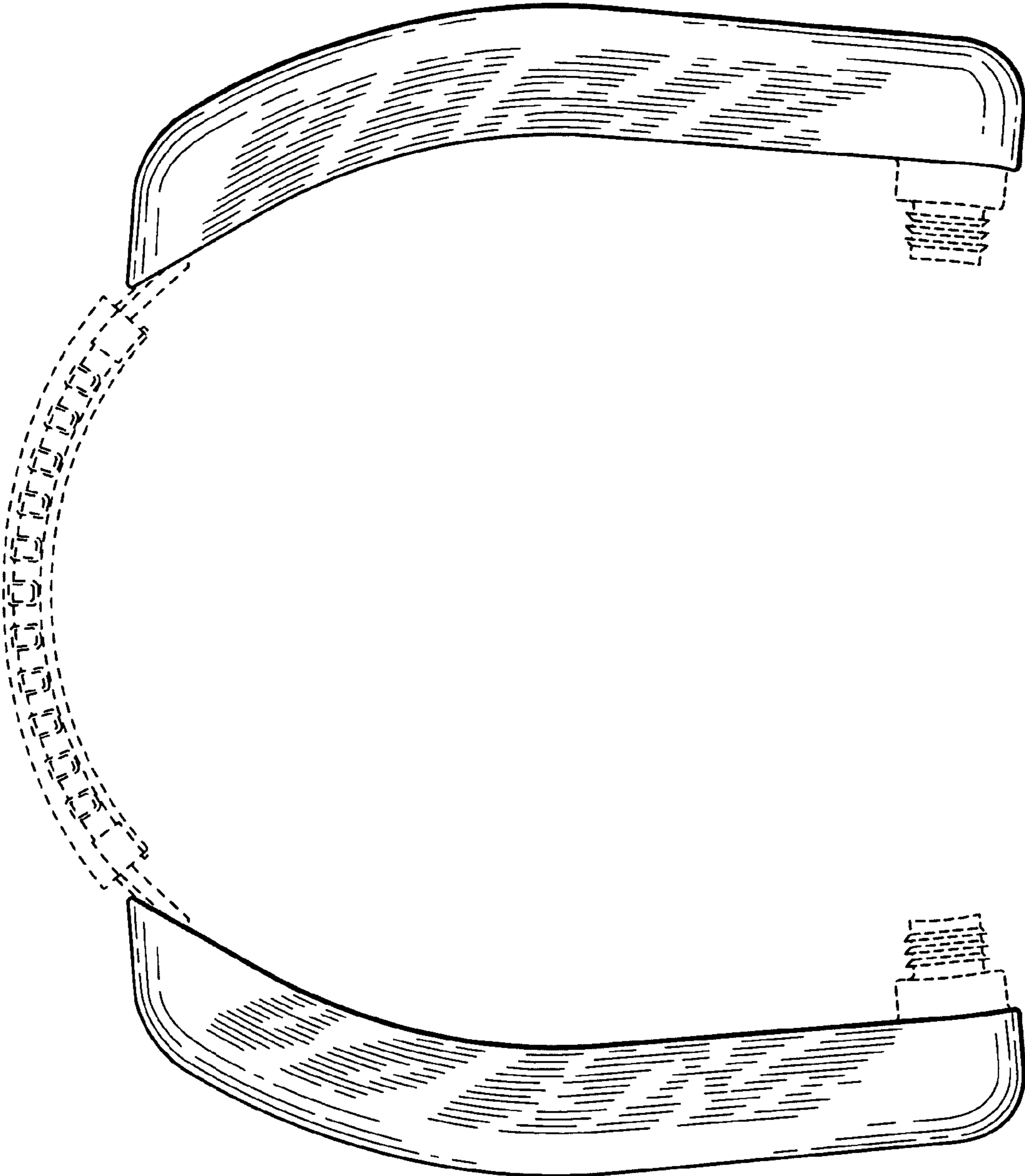

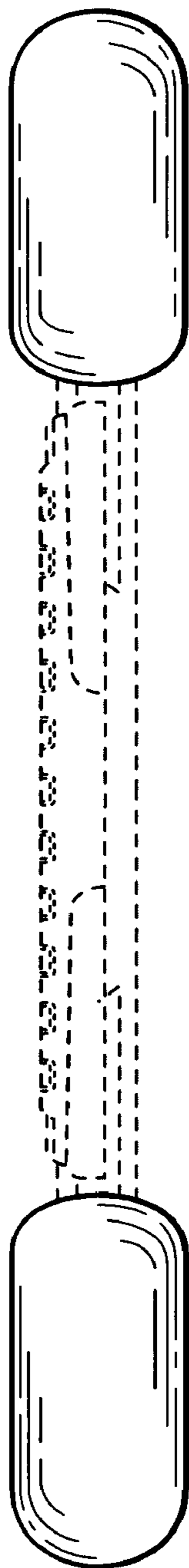

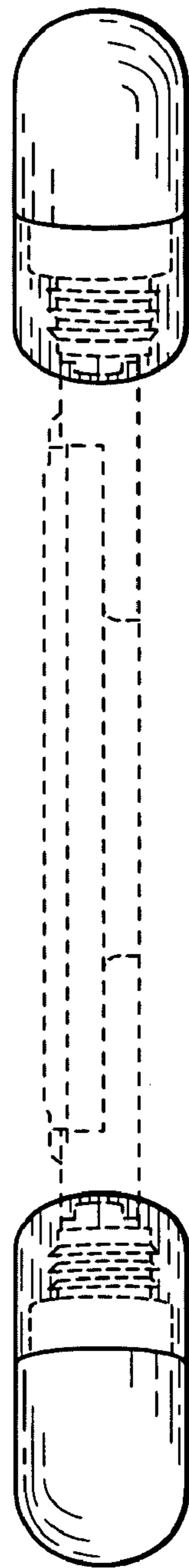
