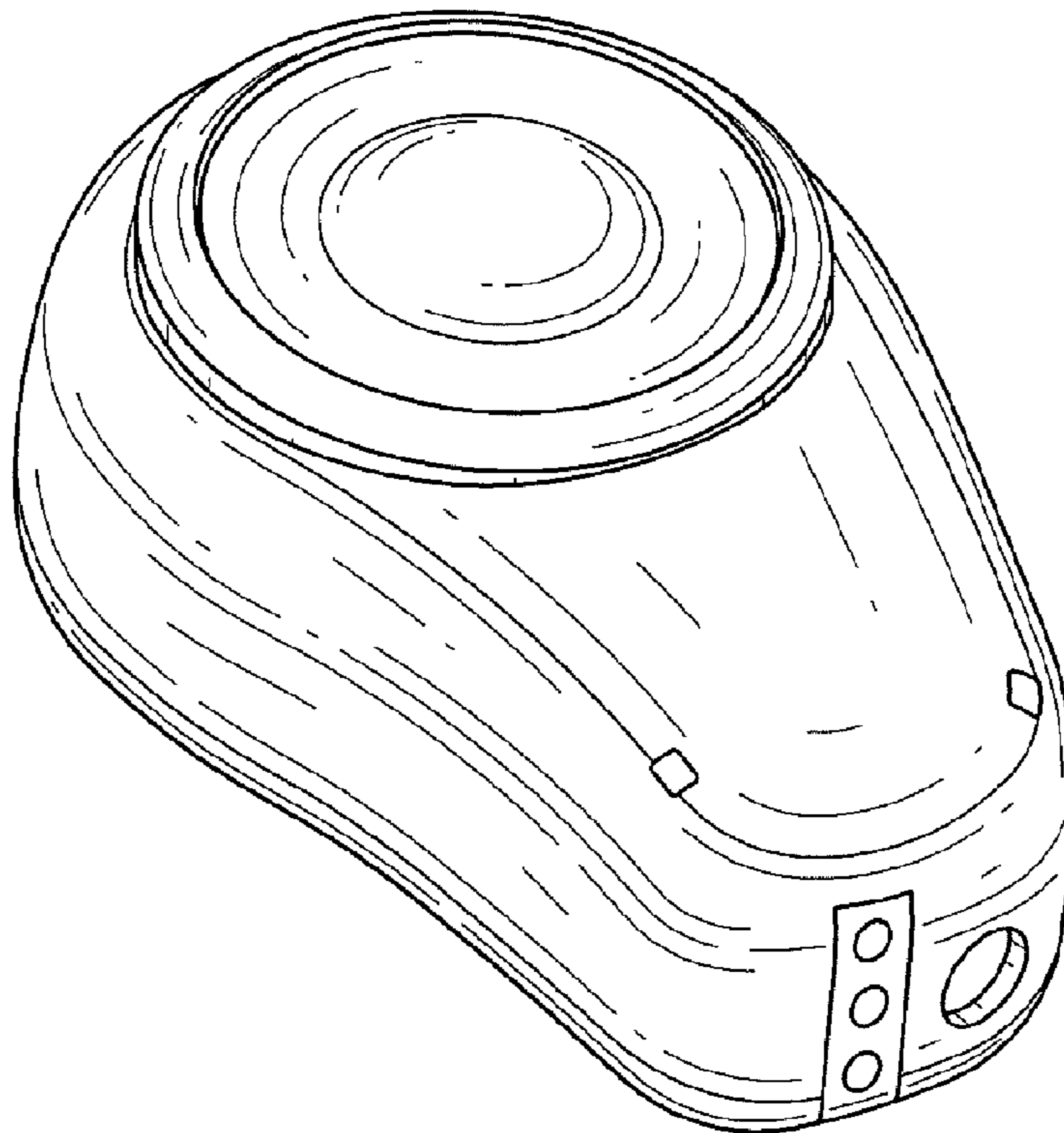
(57) **CLAIM**

The ornamental design for a bone anchored hearing aid, as shown and described.

**DESCRIPTION**

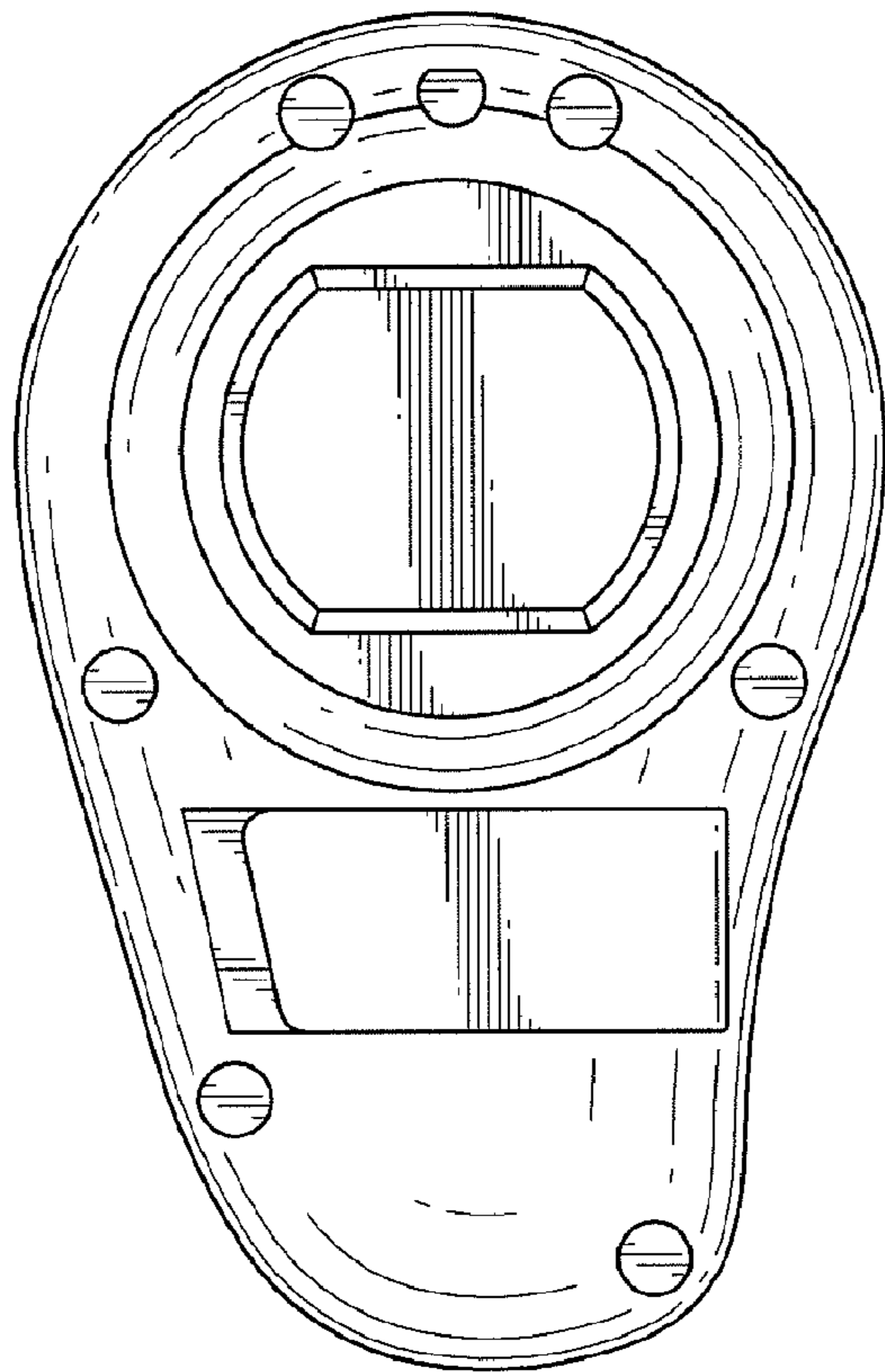

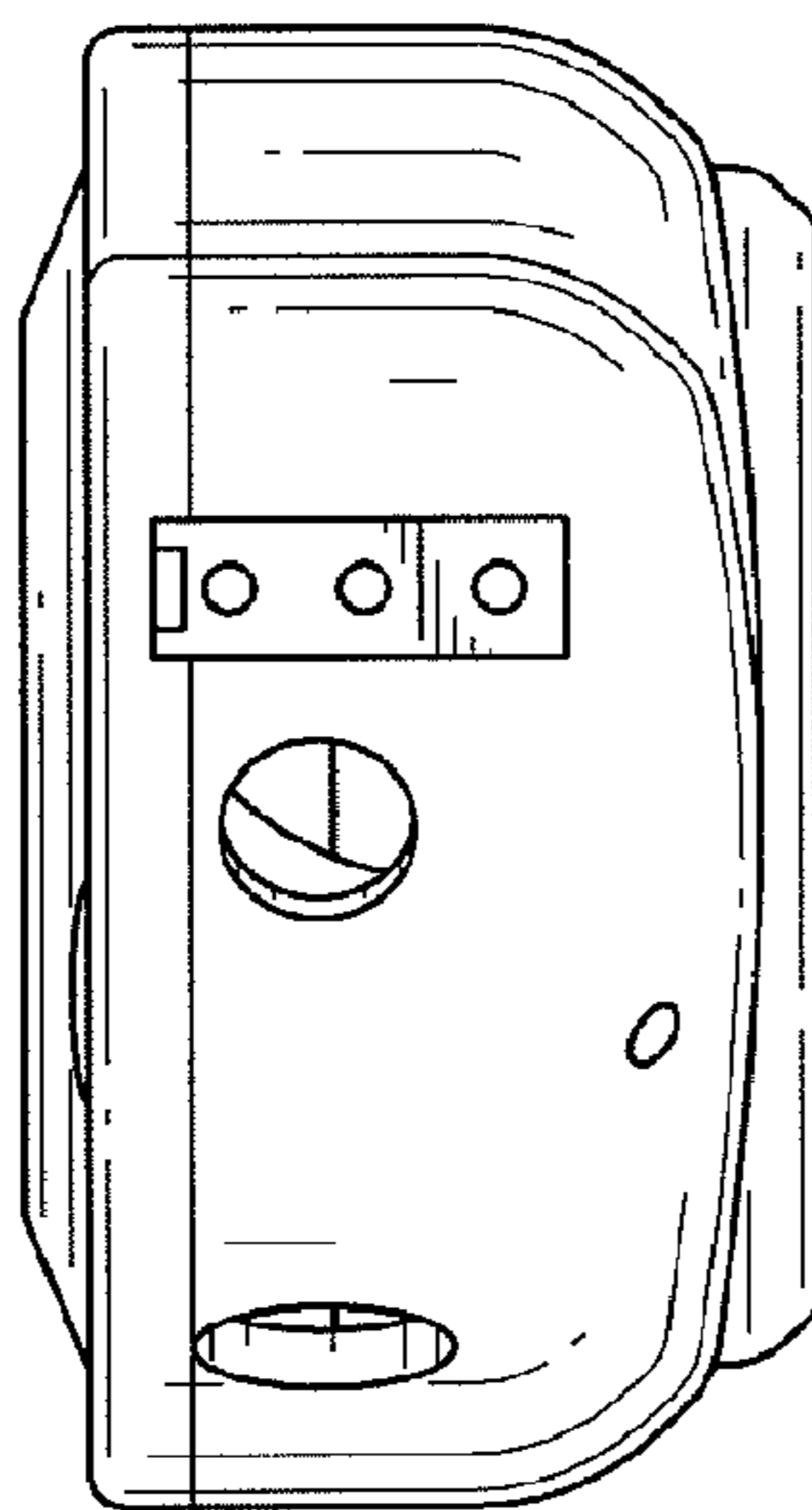

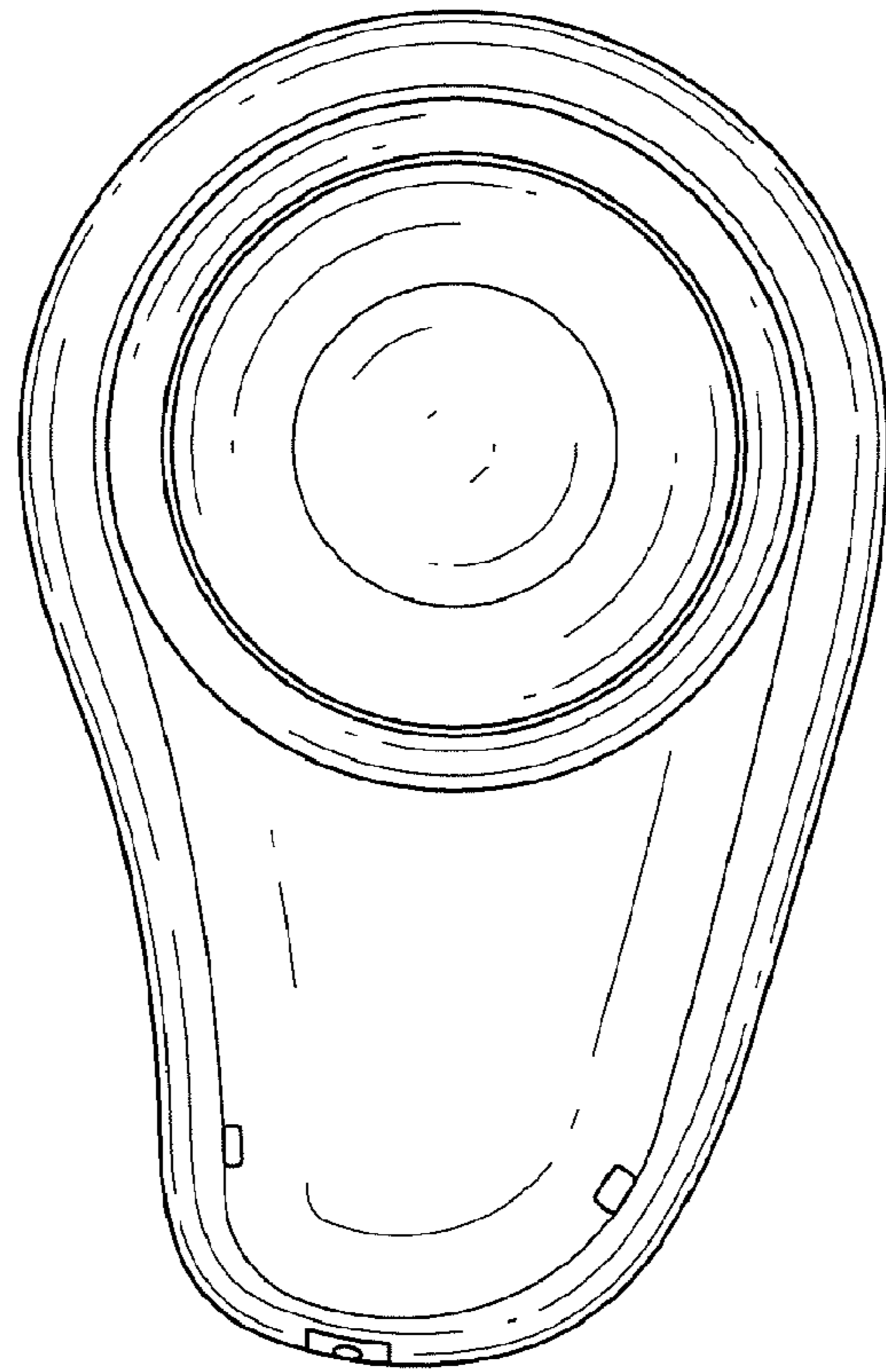

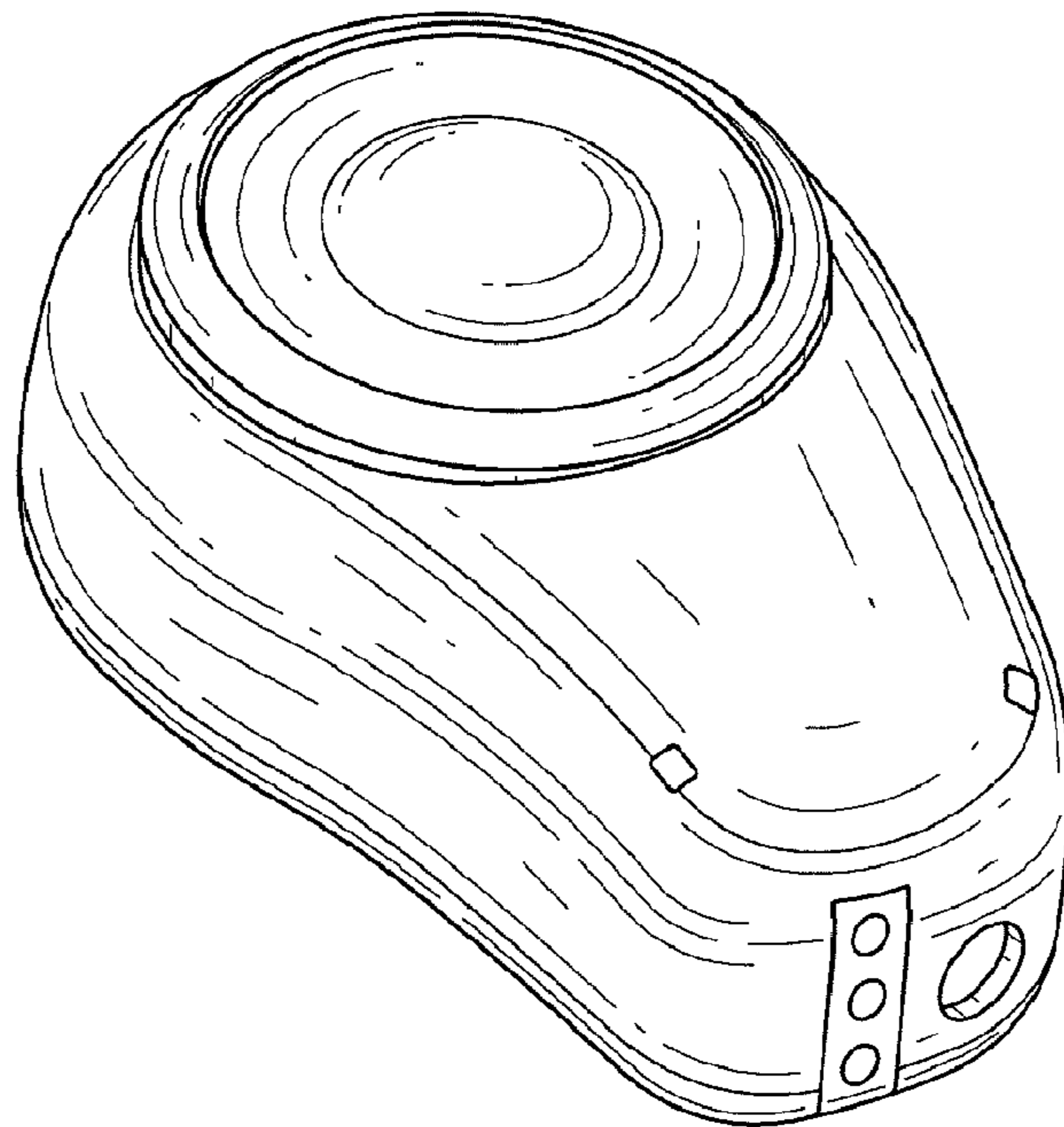

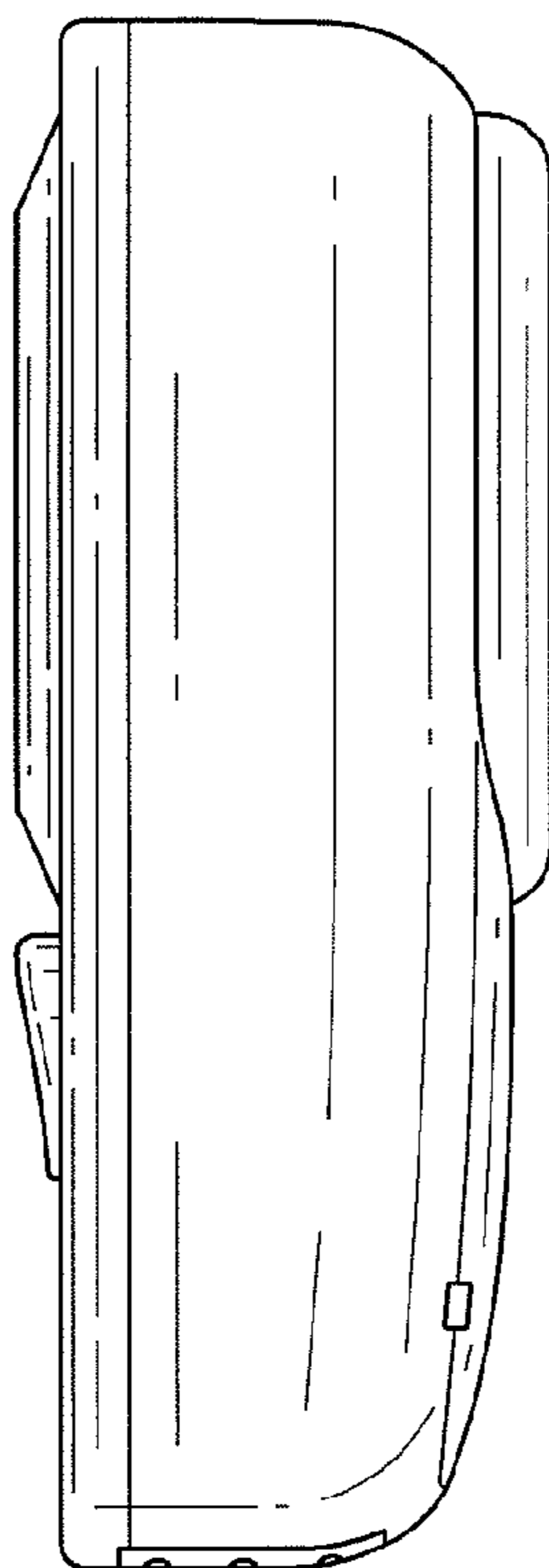

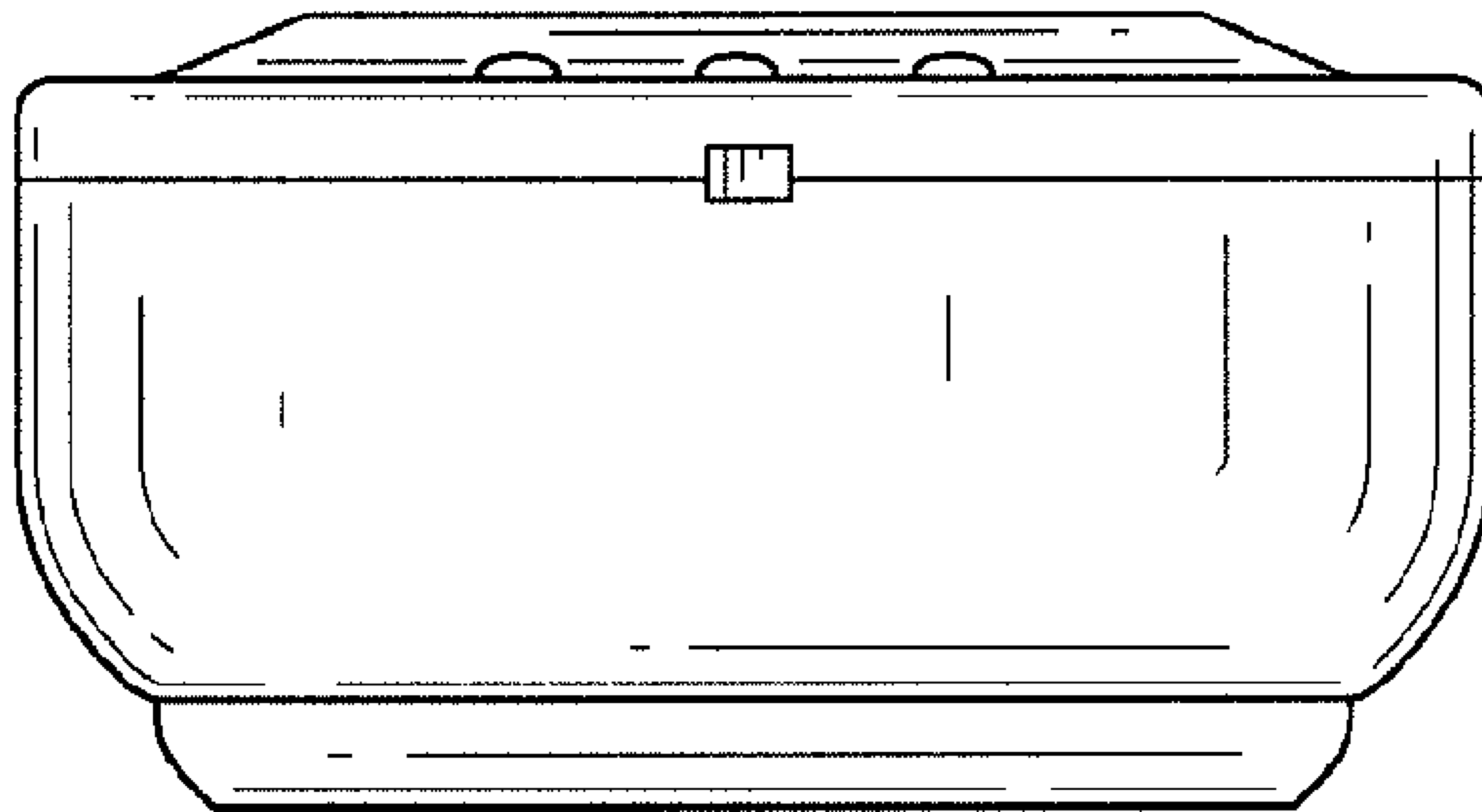
