The ornamental design for a pacifier cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a pacifier cover showing our design;

FIG. 5 is a side elevation view thereof, the opposite side being identical thereto;

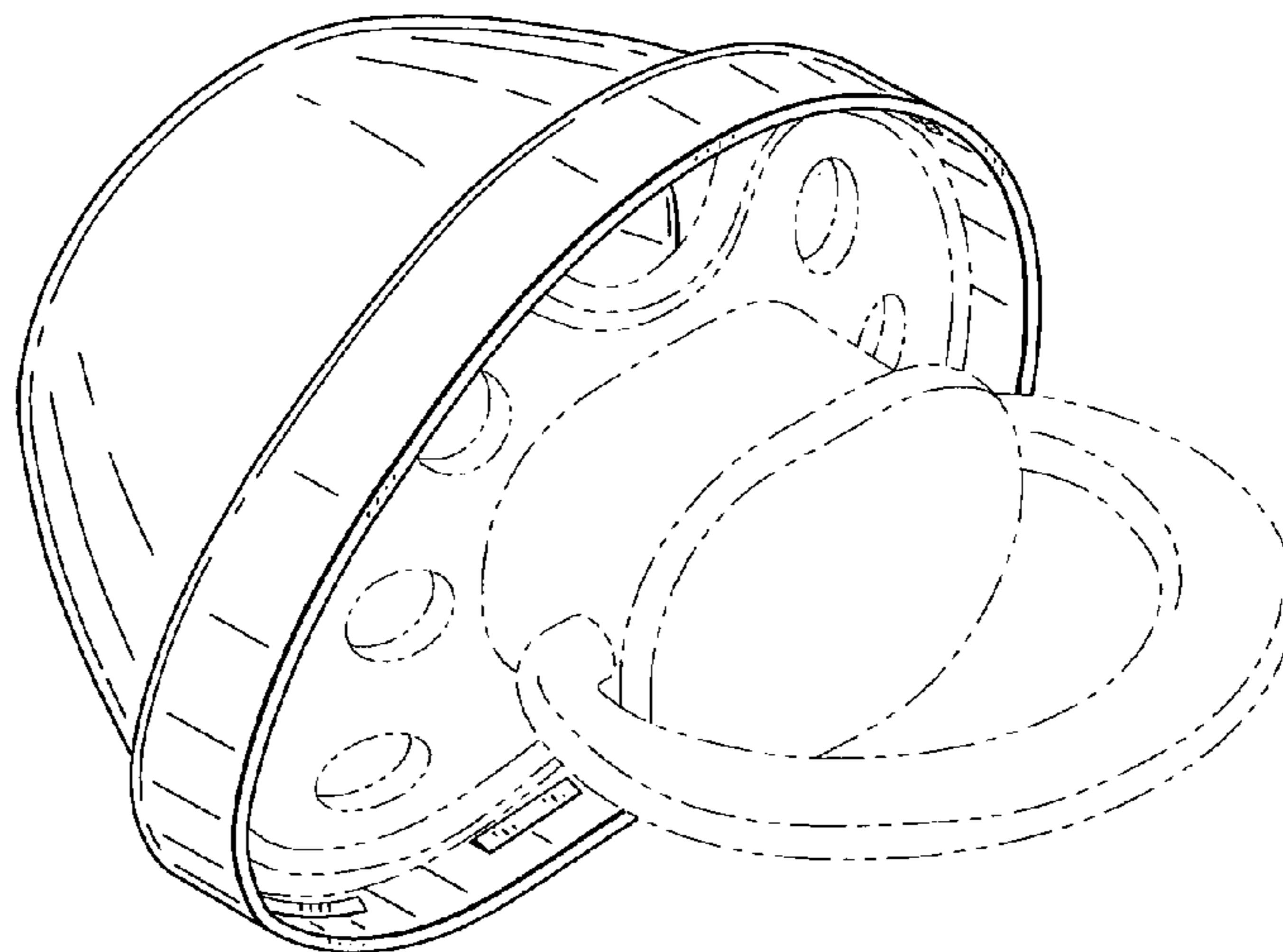
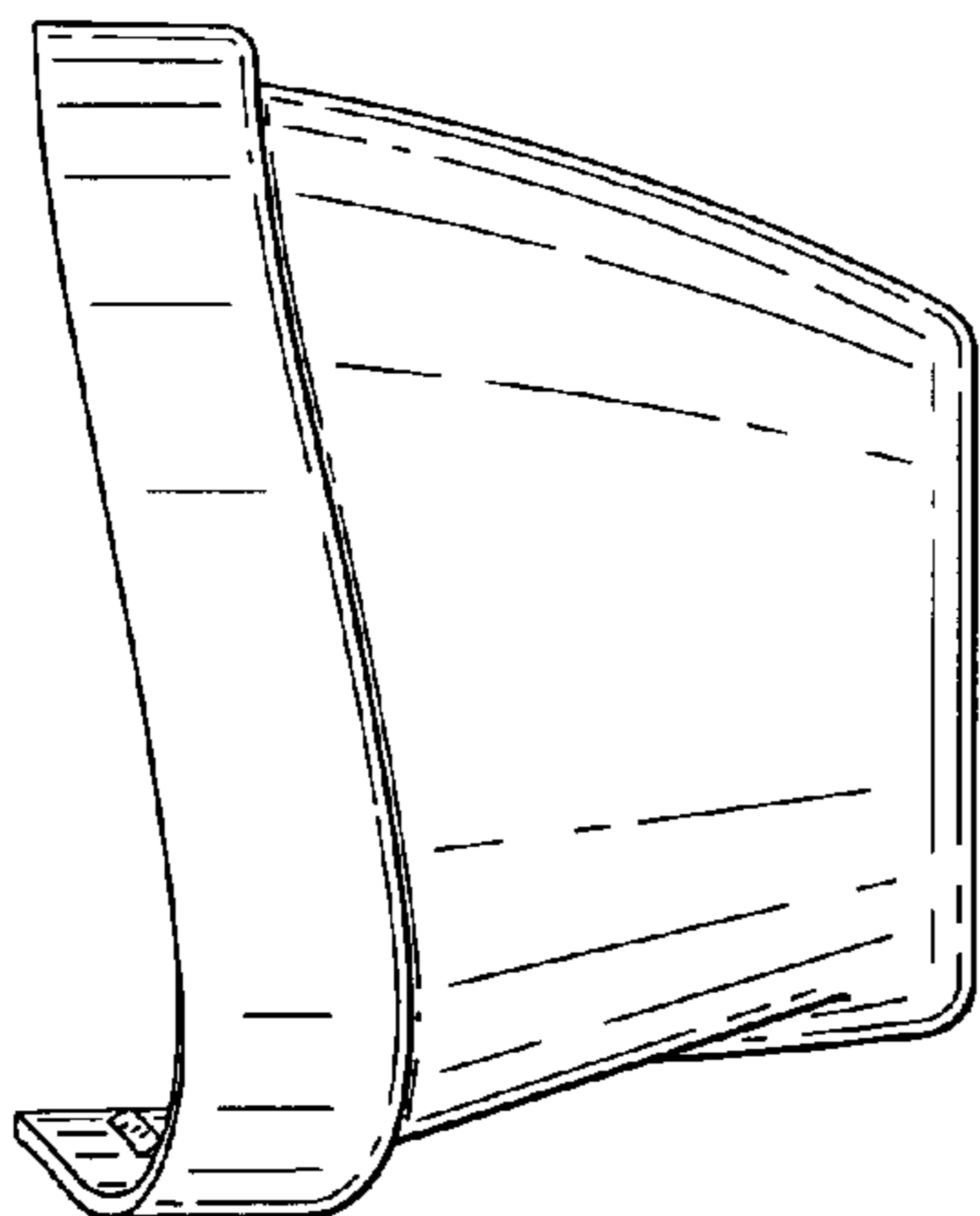
FIG. 6 is a top plan view thereof;

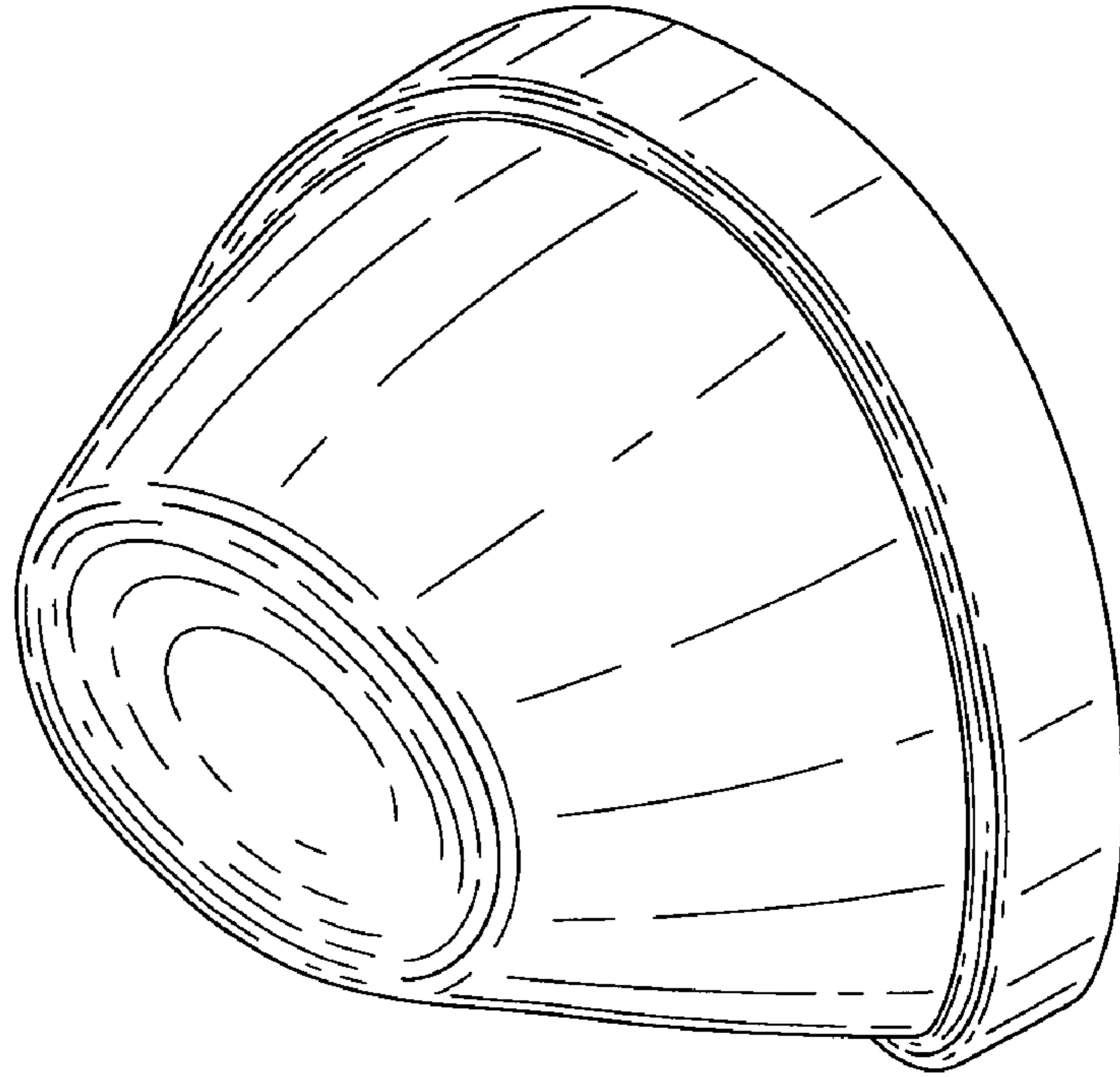
FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a rear perspective view thereof, shown in use.

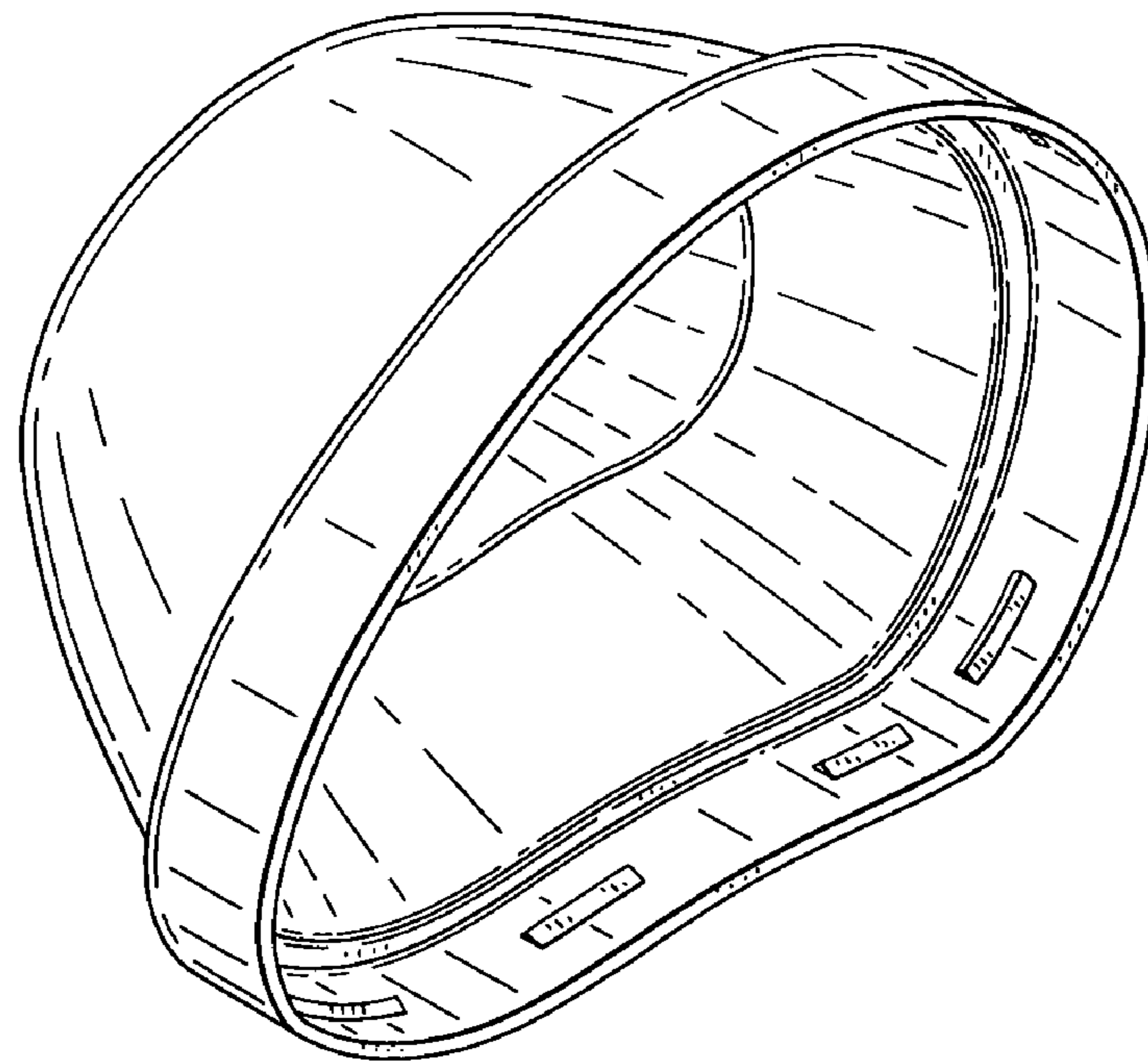
The broken lines in FIG. 8 showing a pacifier illustrate environmental structure and form no part of the claimed design.

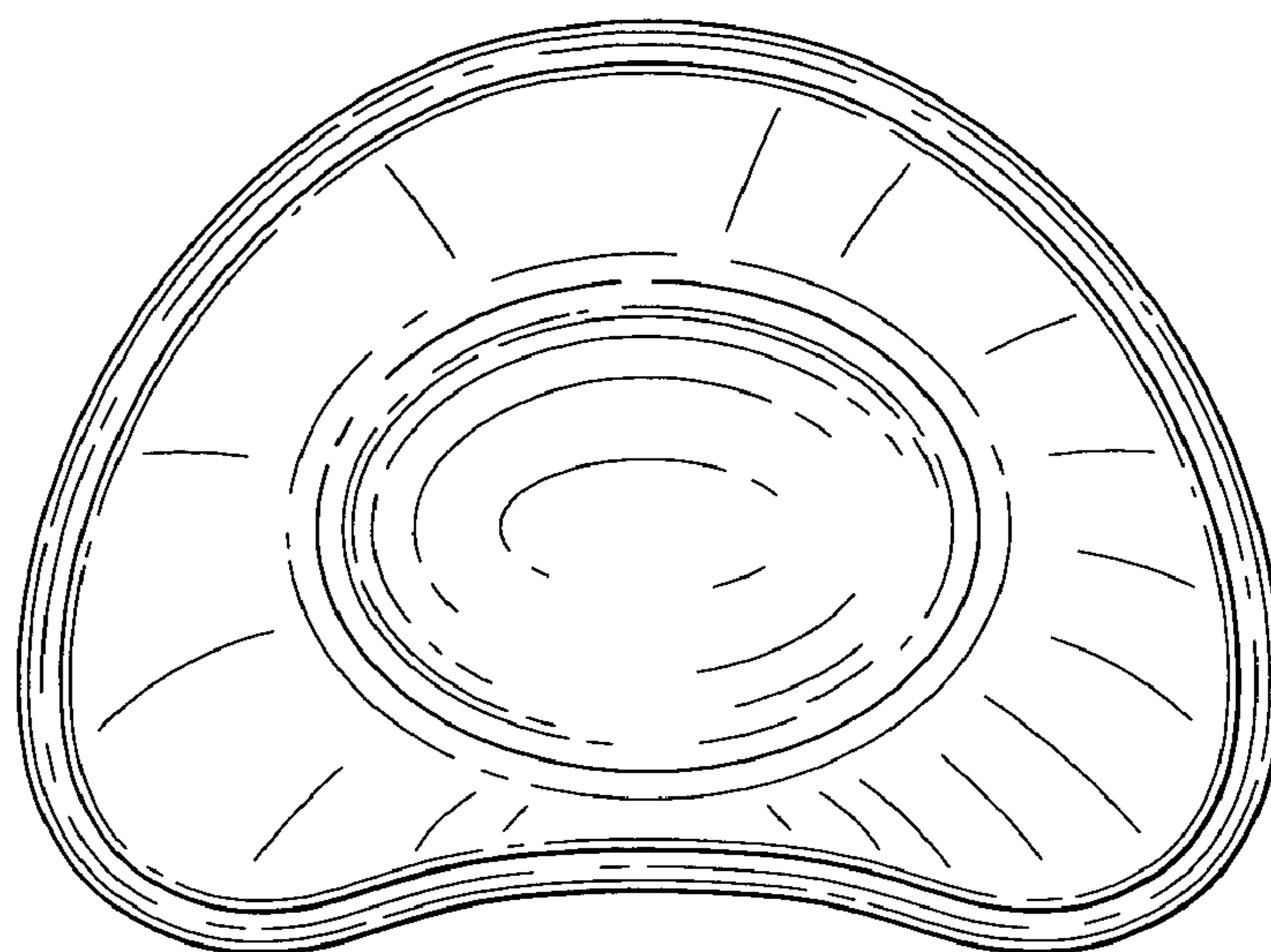

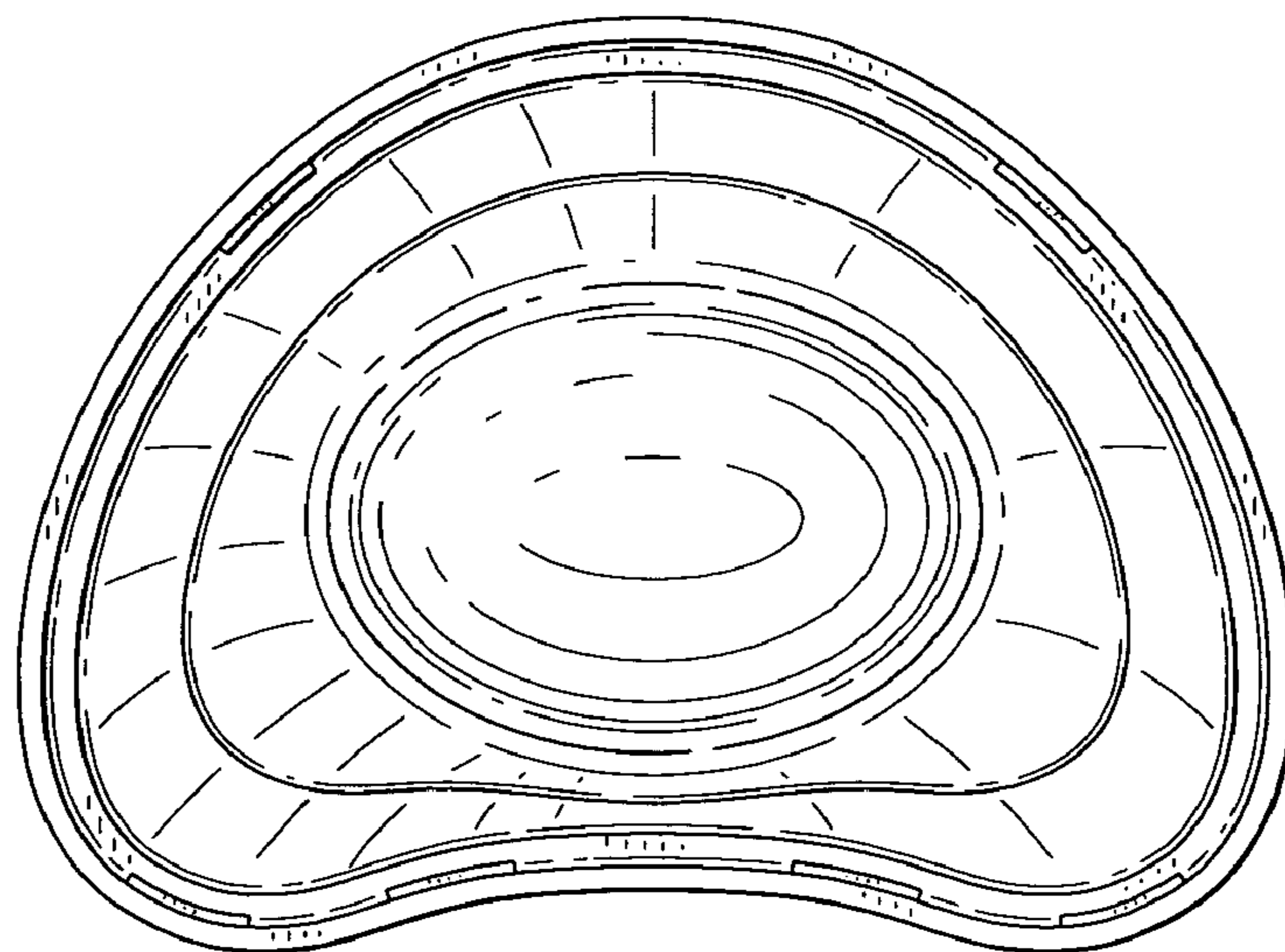

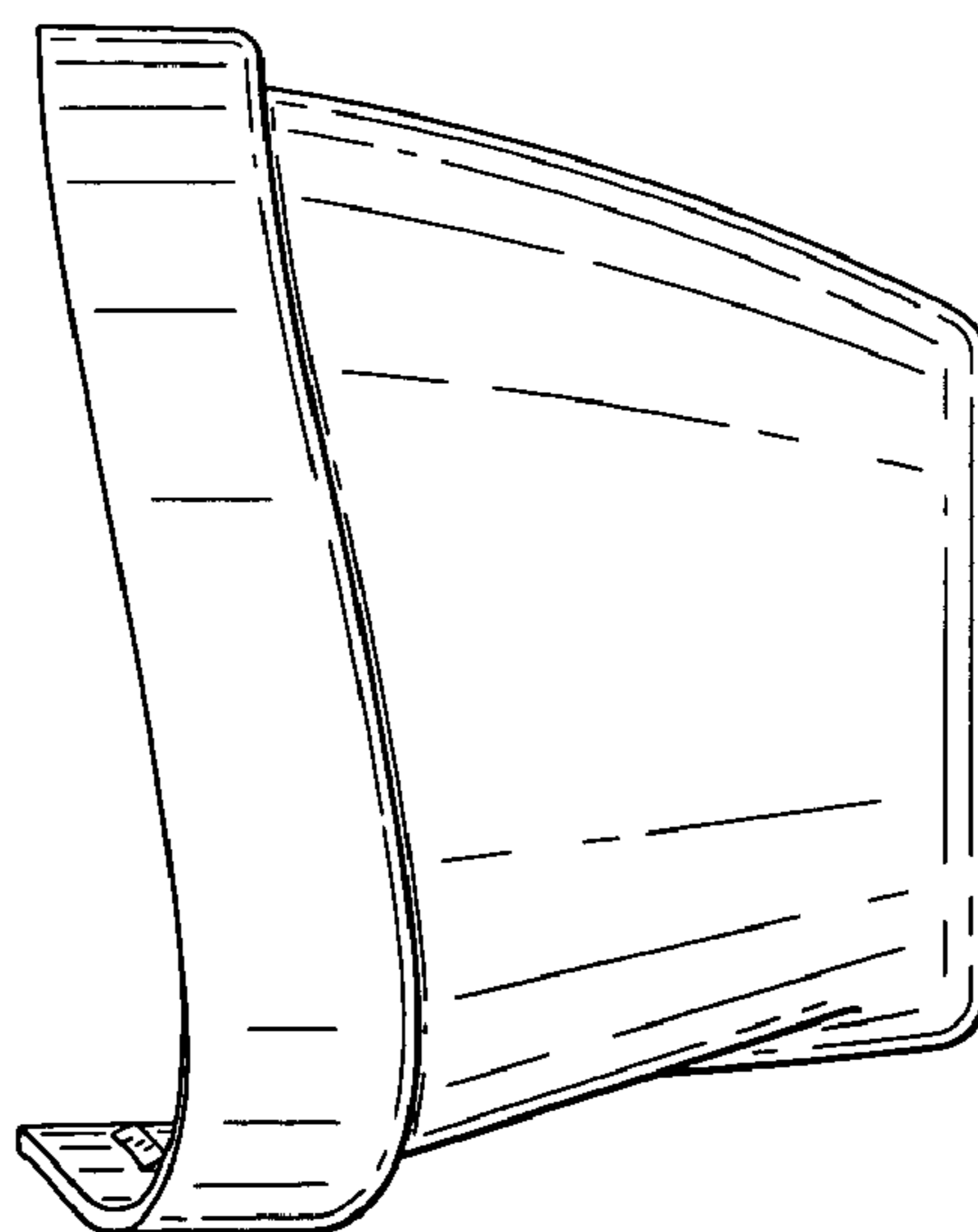

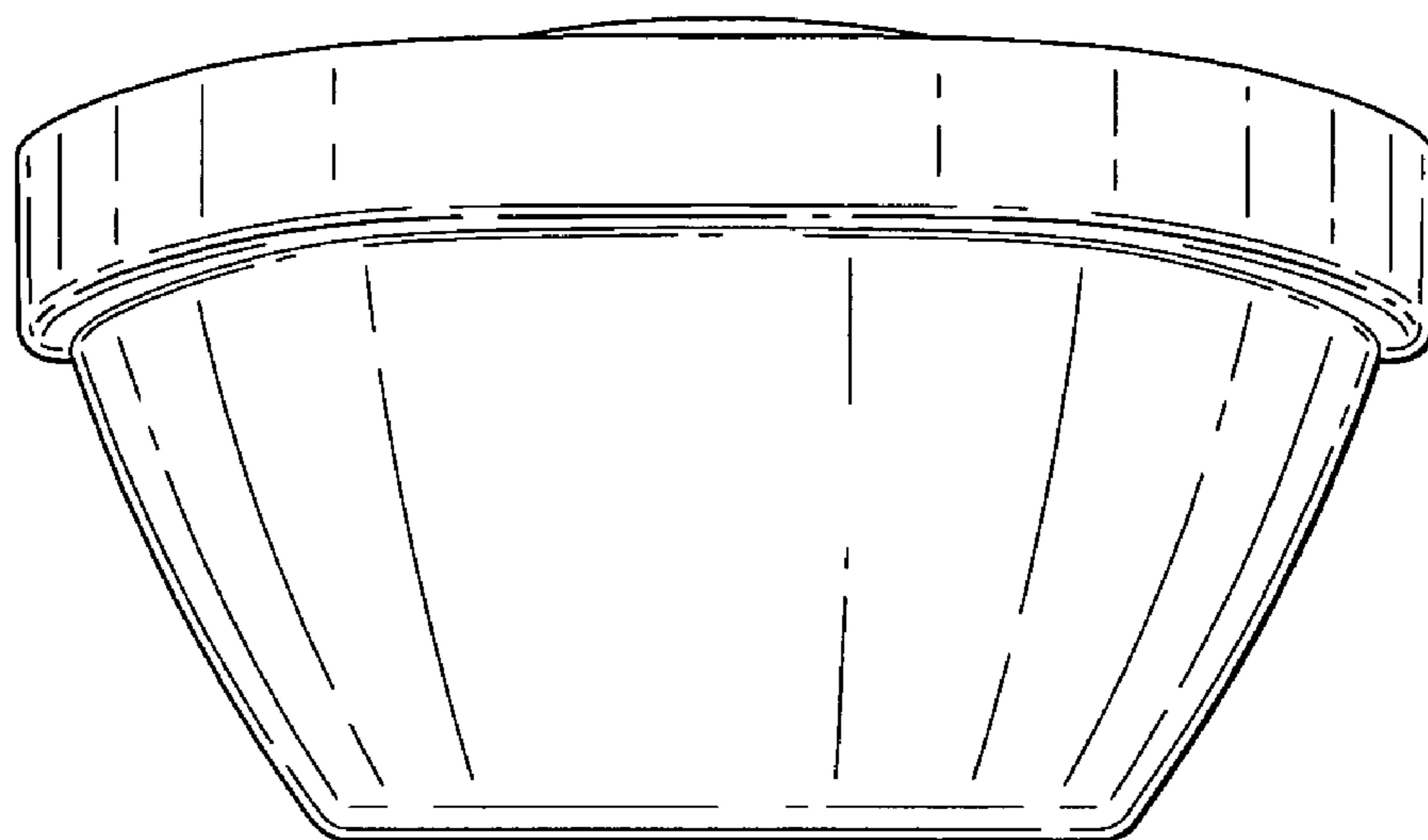

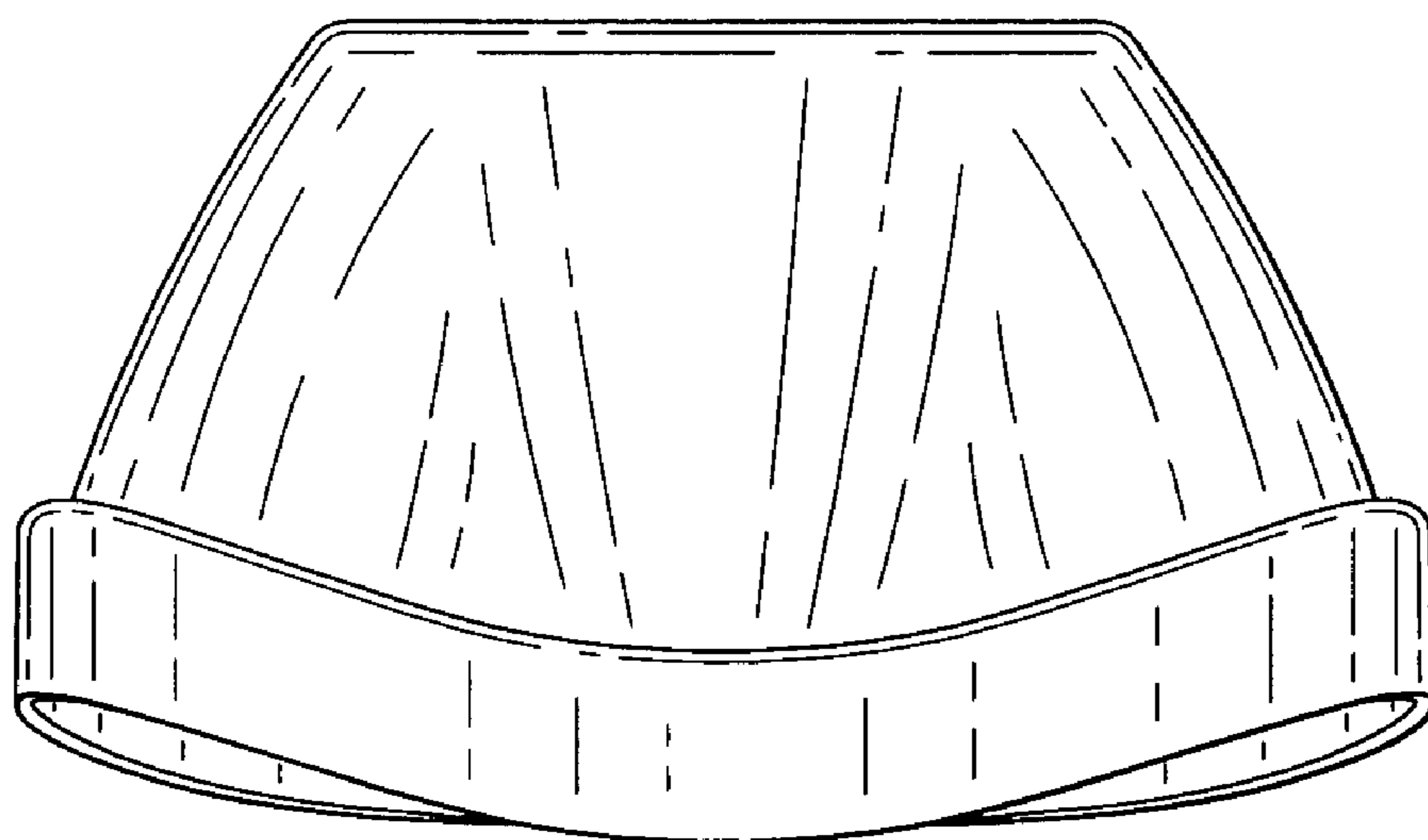

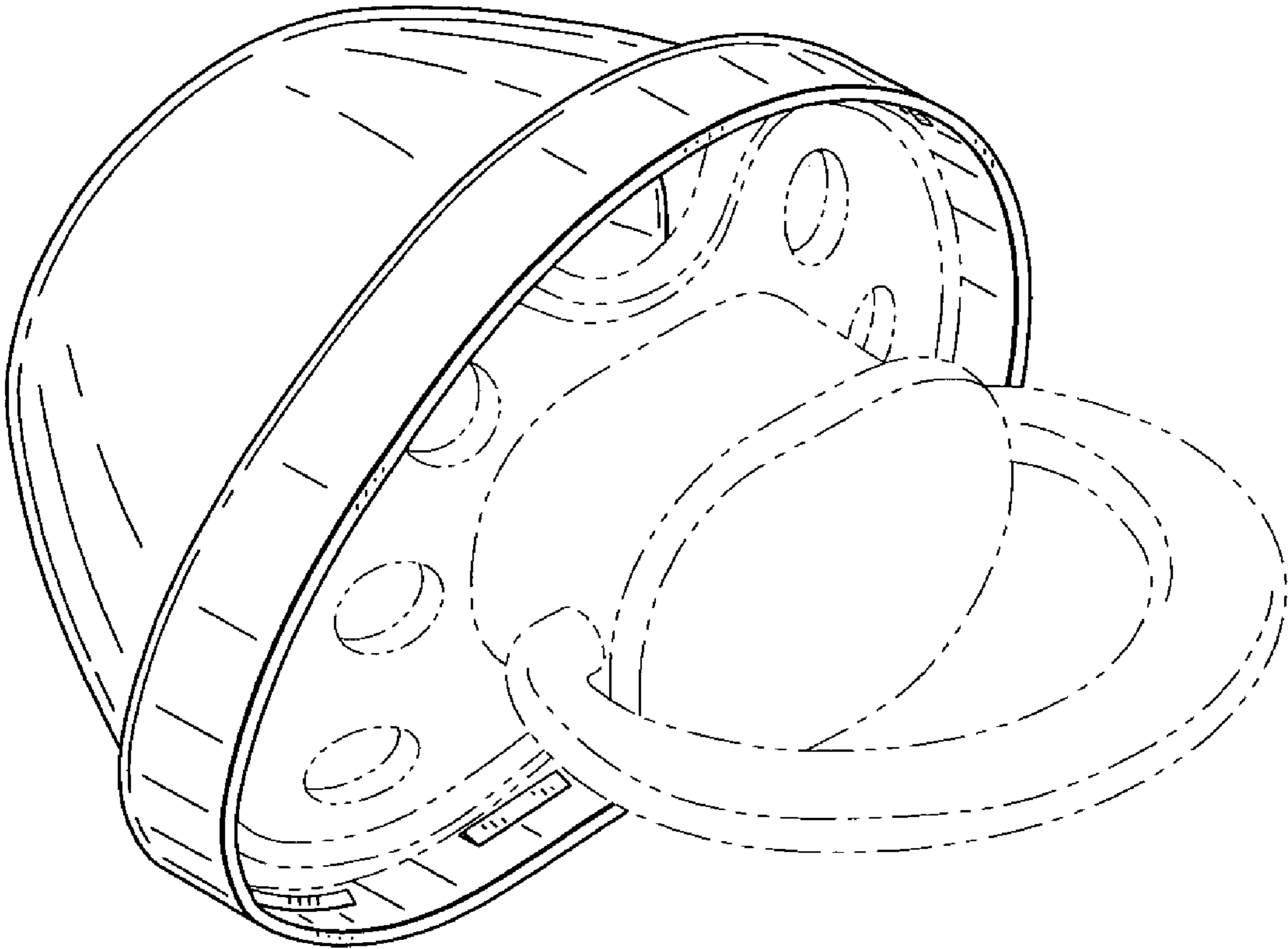
