FIG. 1 is a front and top perspective view of a massager showing my new design;

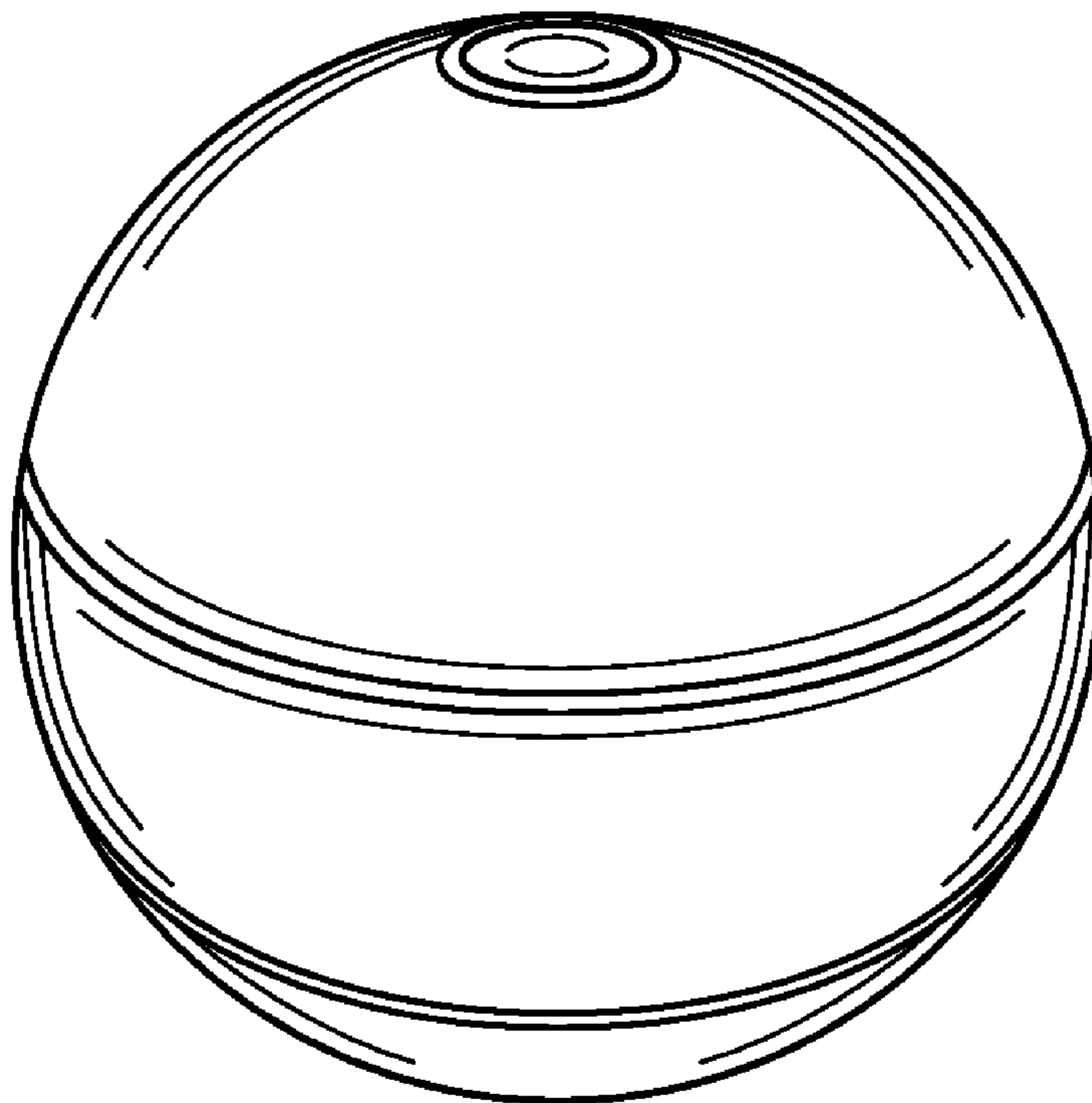
FIG. 2 is a front and bottom perspective view thereof;

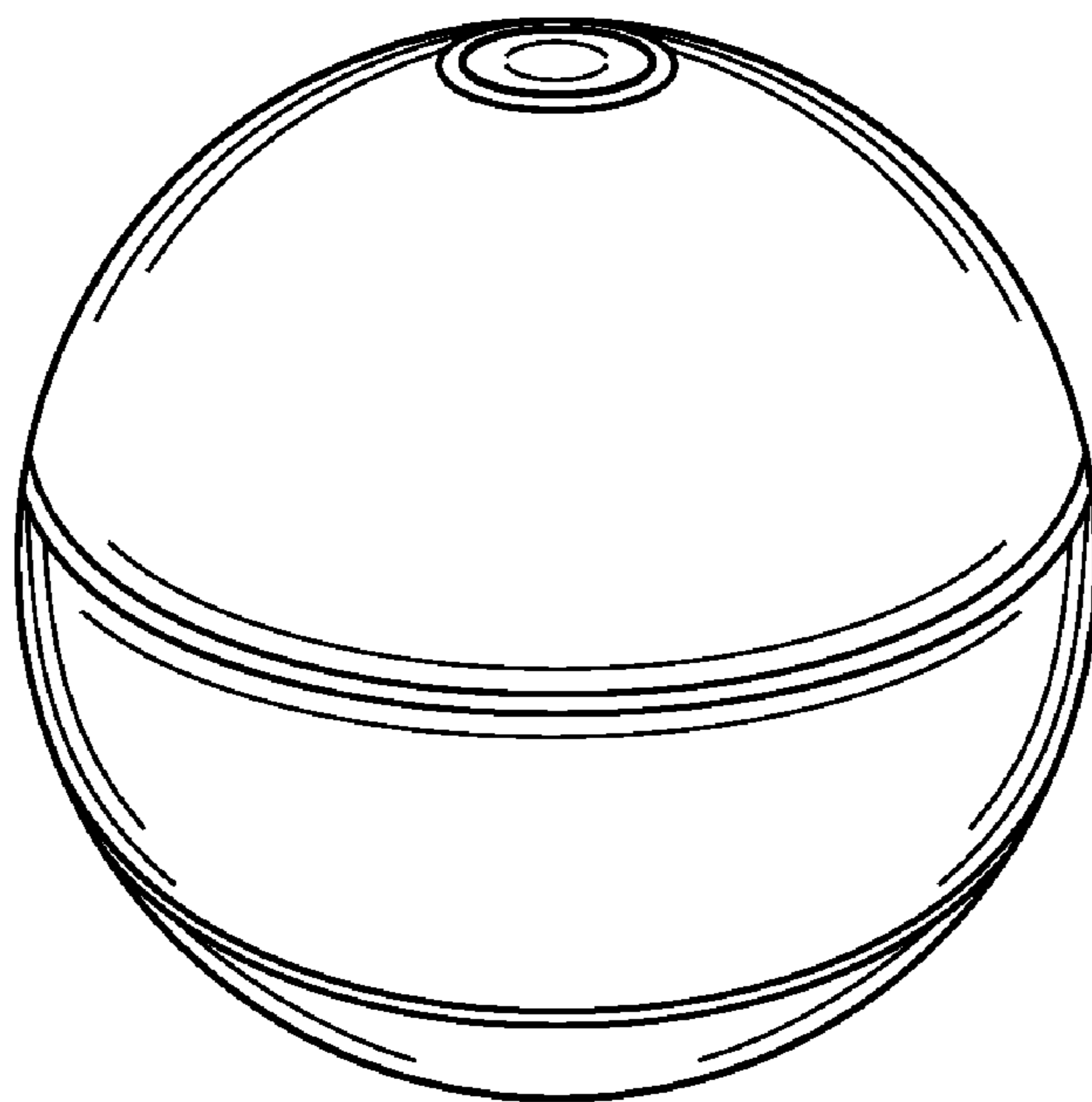

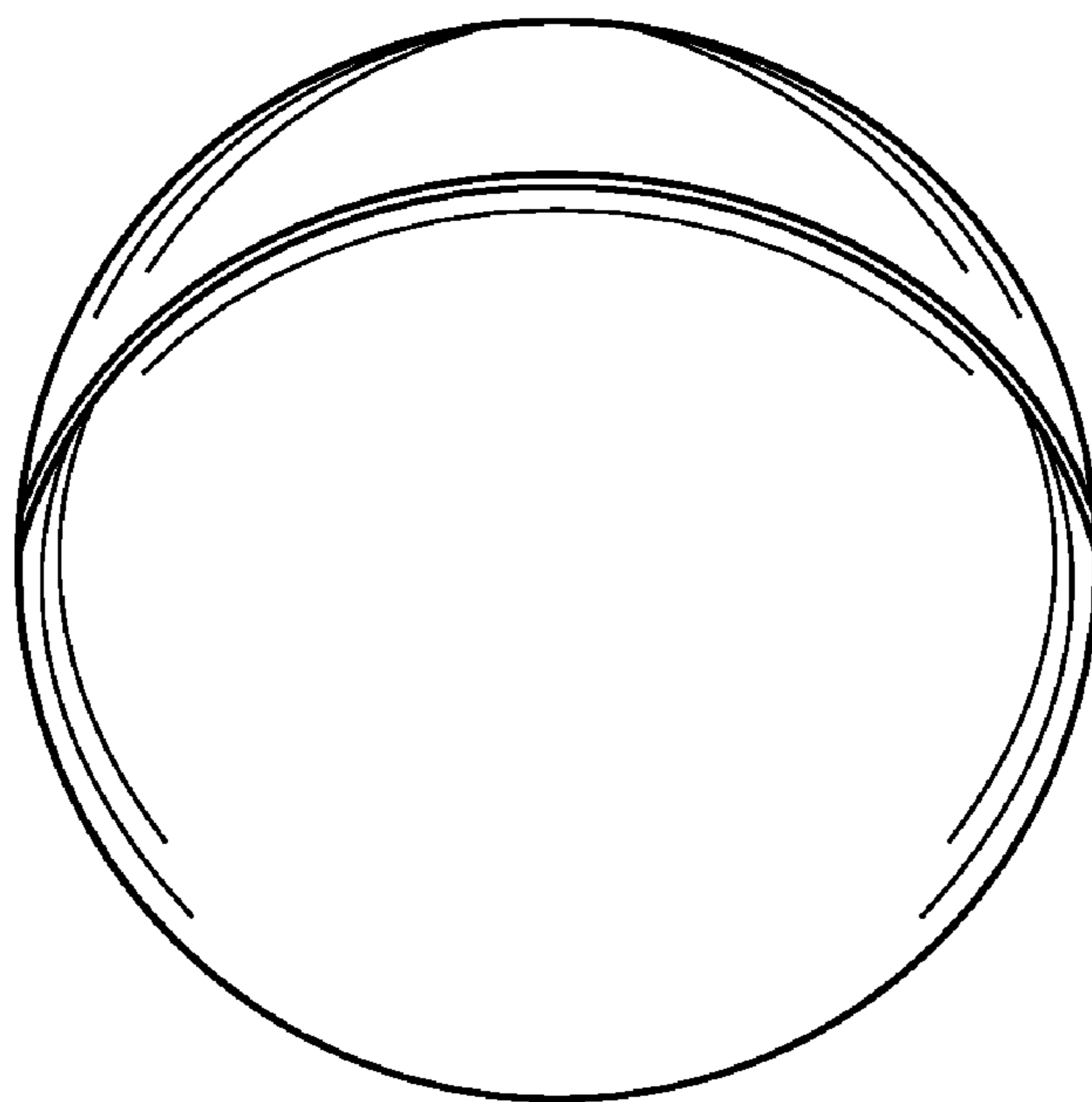

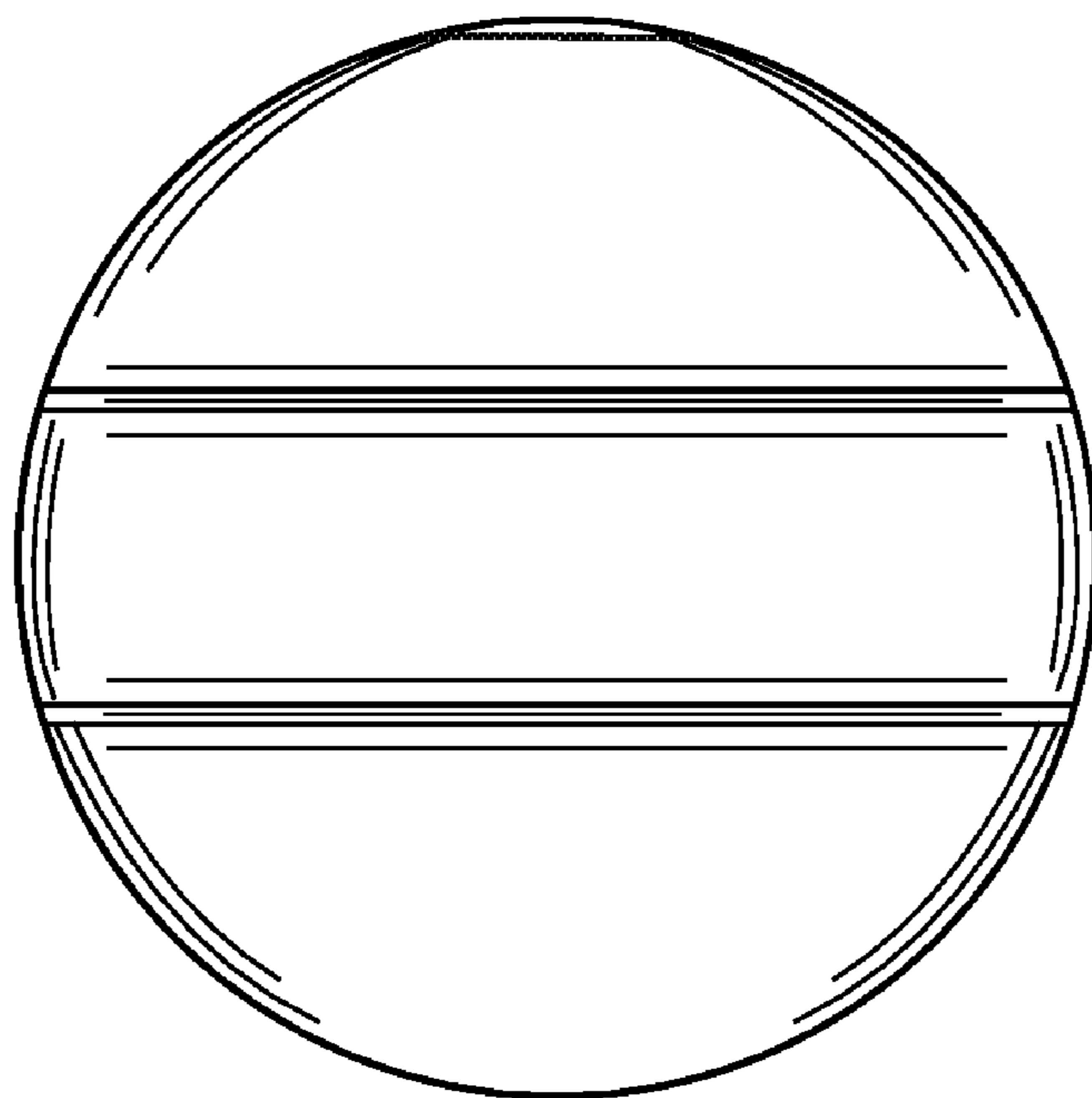

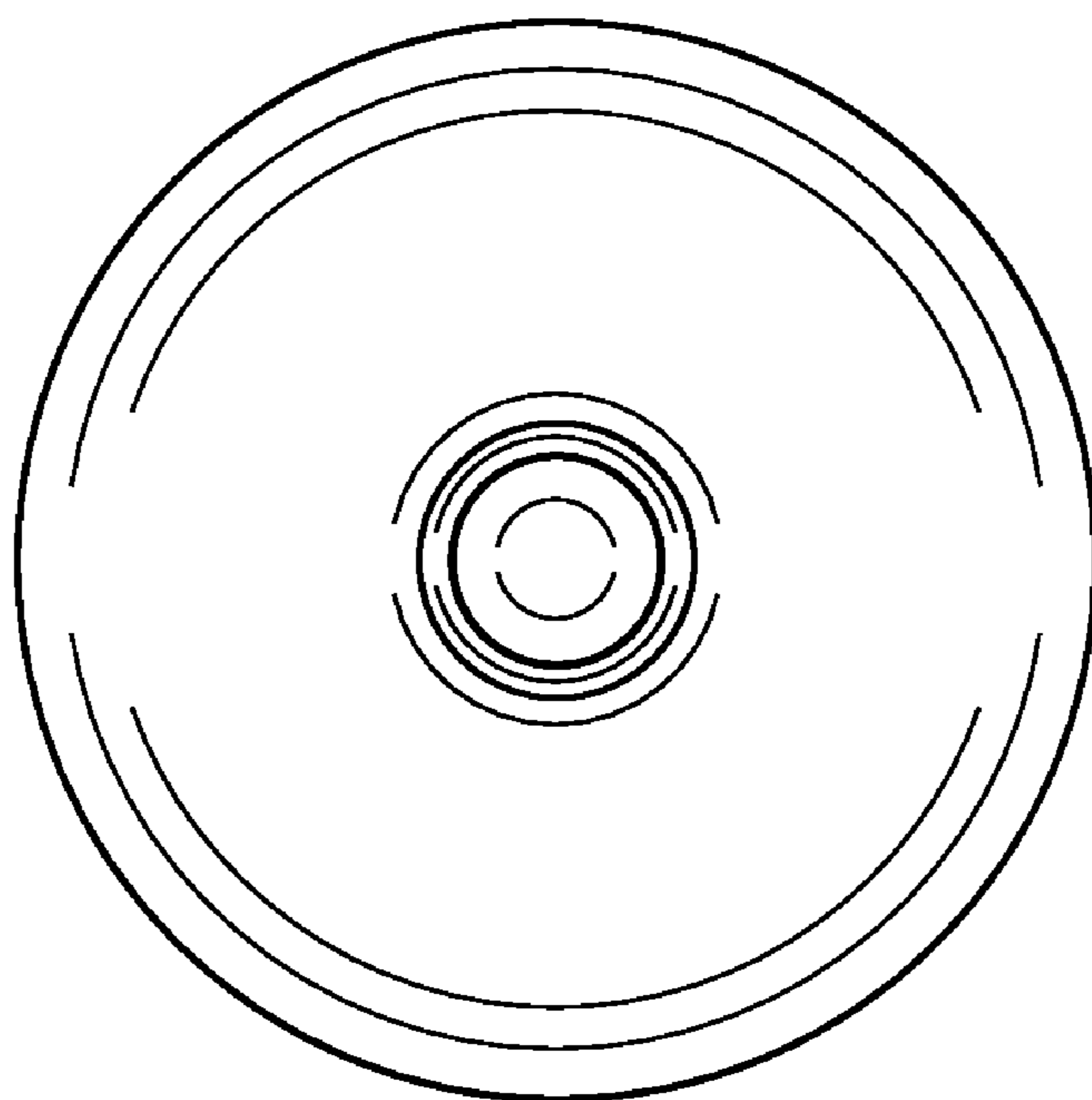

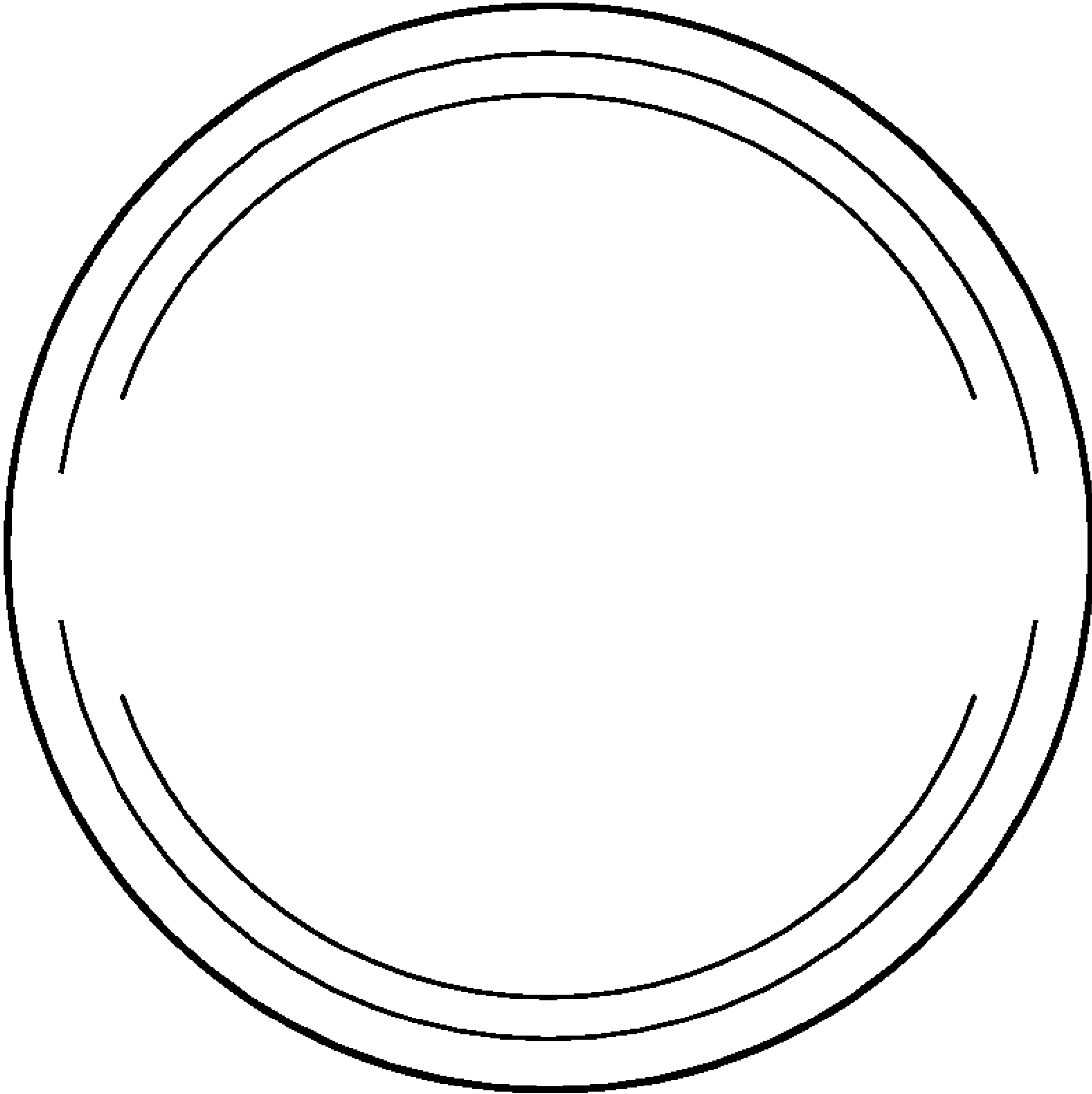
