FIG. 7 is a perspective view of the stroller cart frame with storage baskets taken from a top, rear and right side perspective; and,

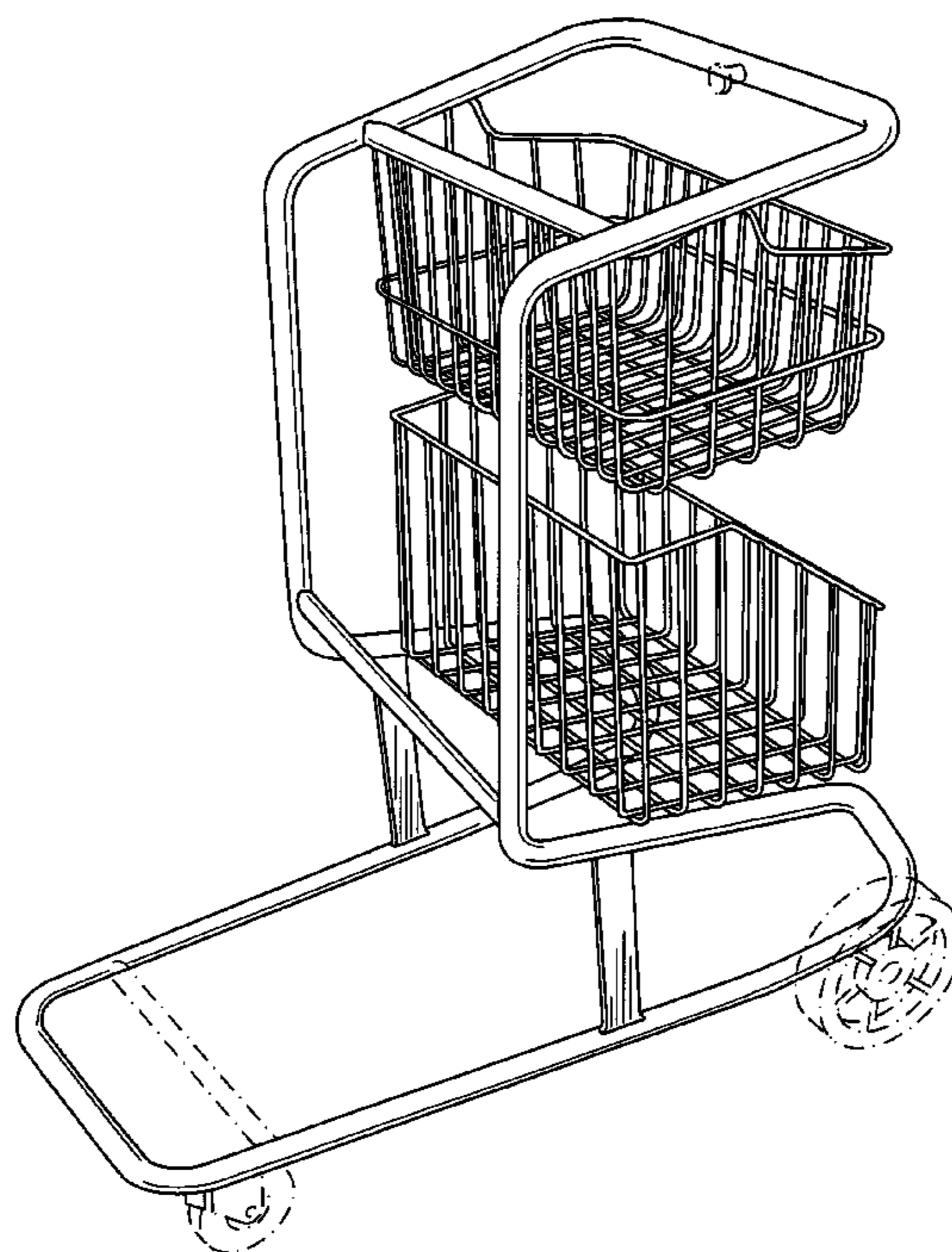
FIG. 8 is a perspective view of the stroller cart frame with storage baskets taken from a top, front and left side perspective.

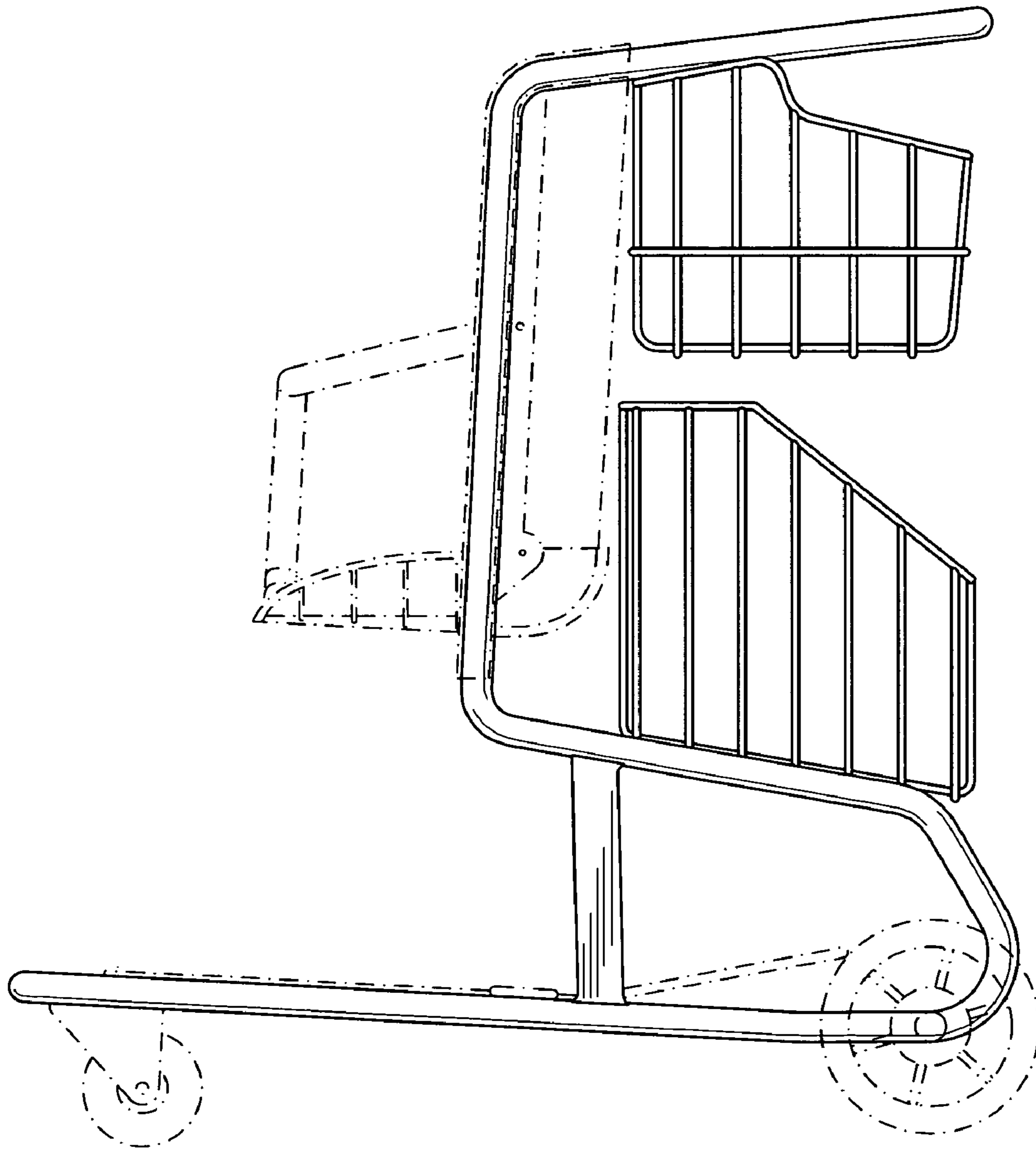

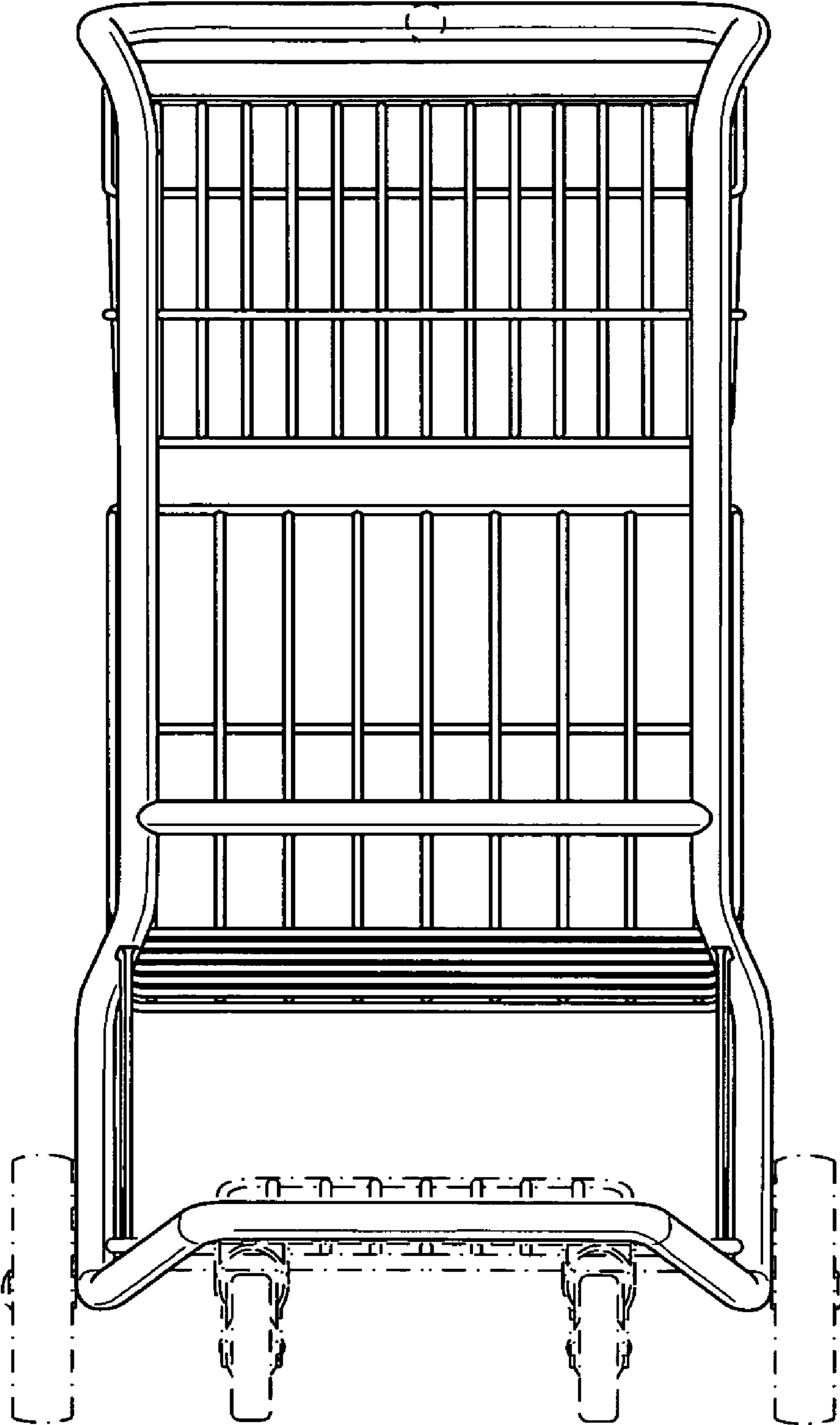

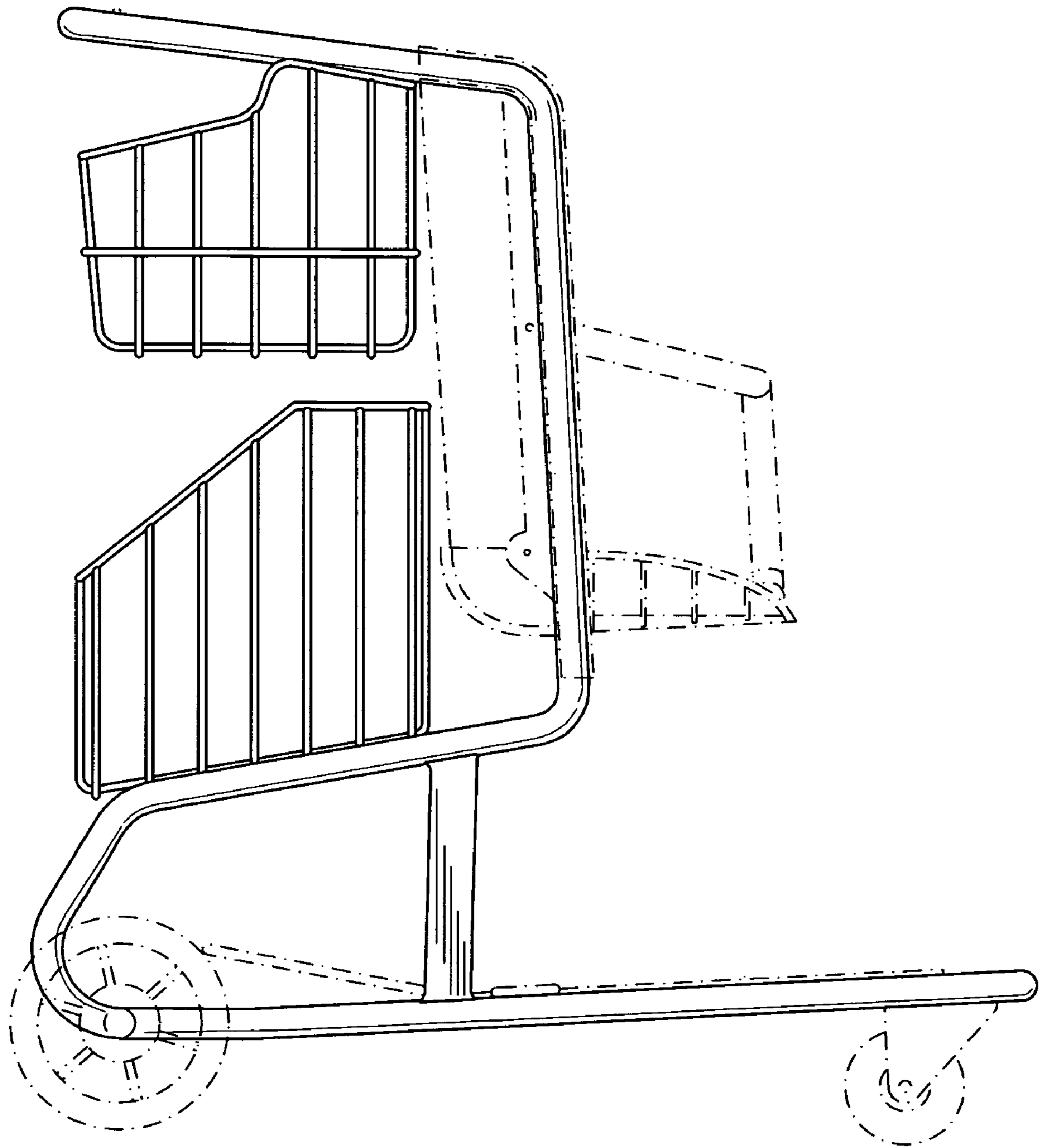




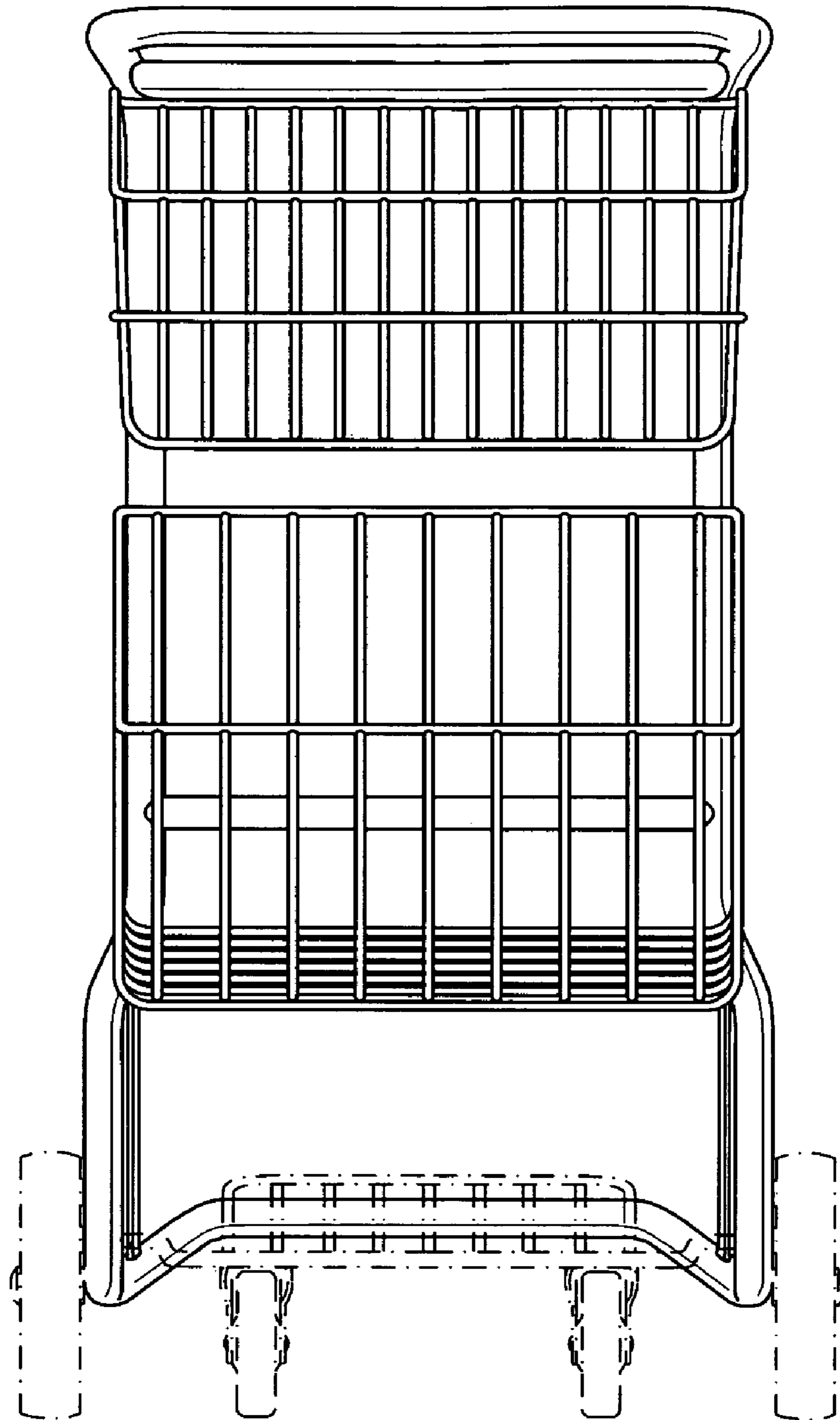

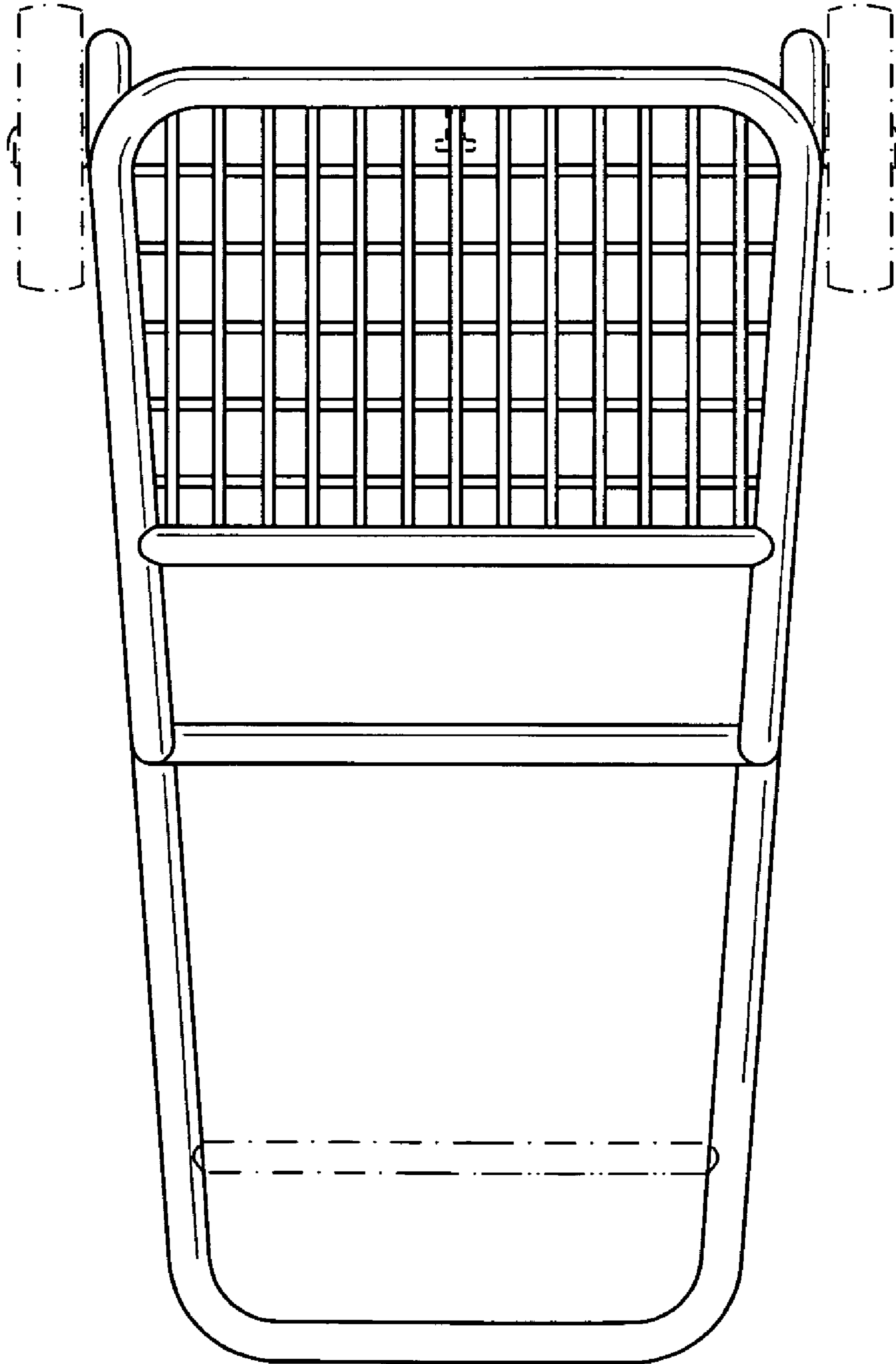

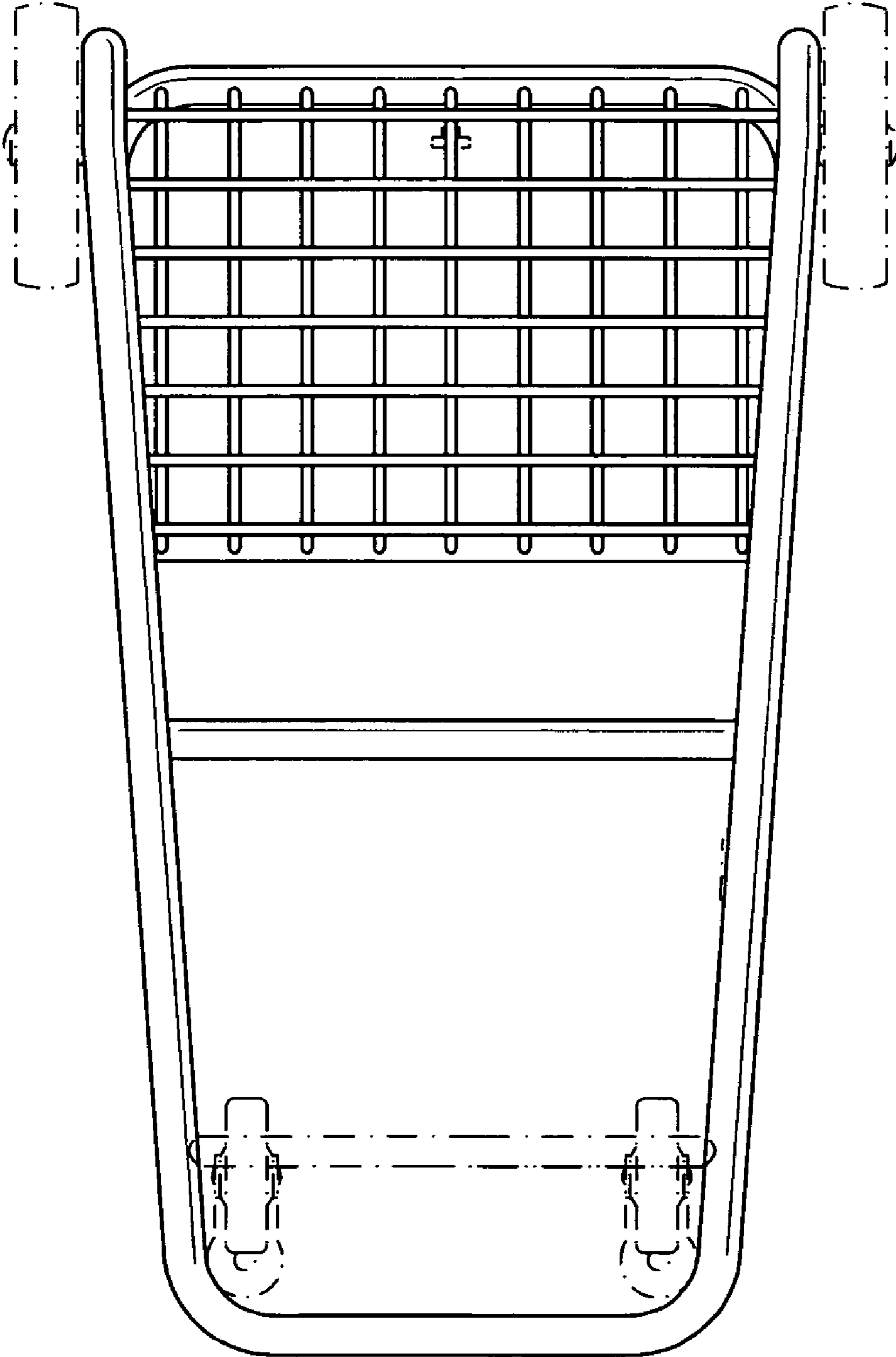

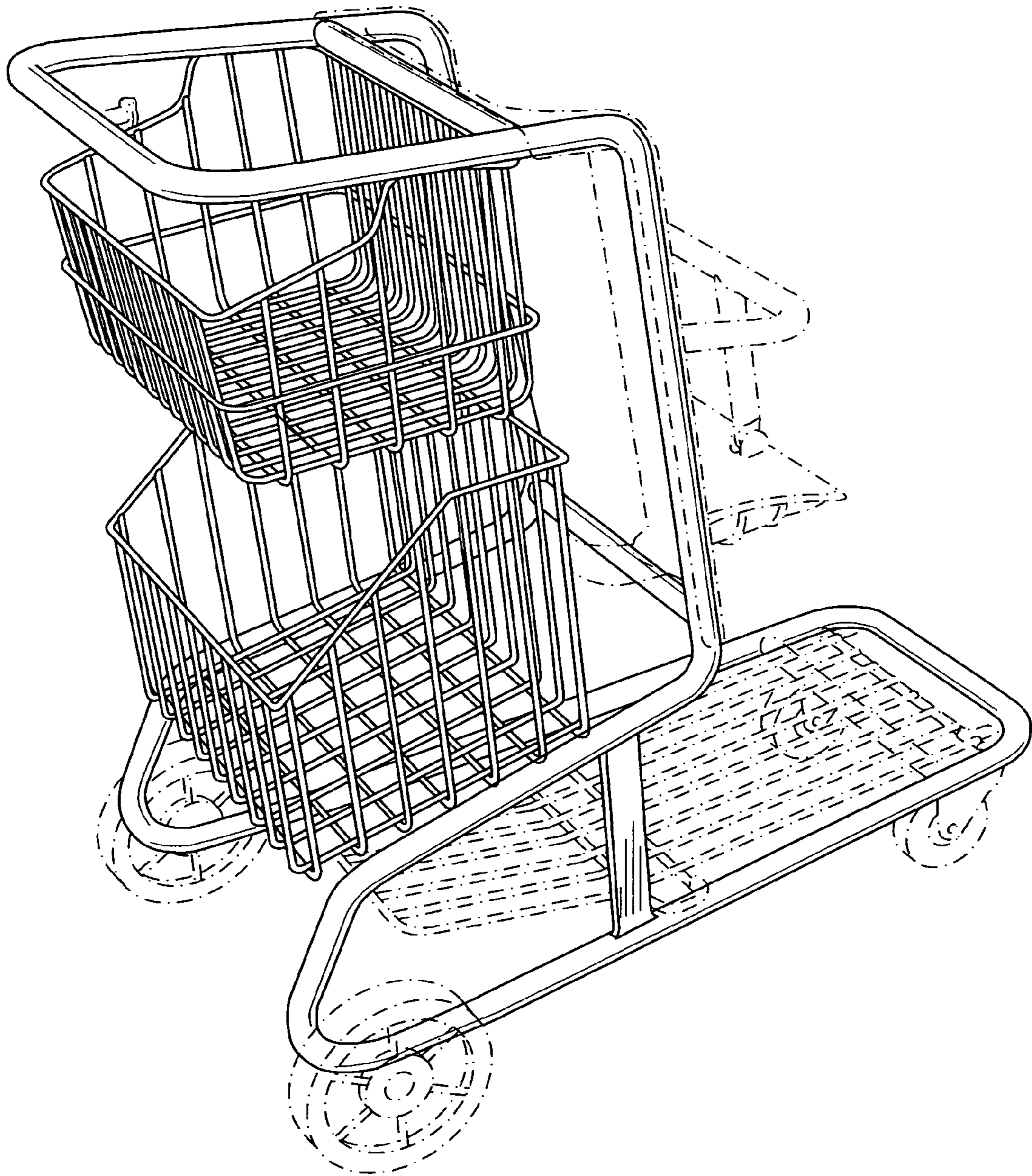

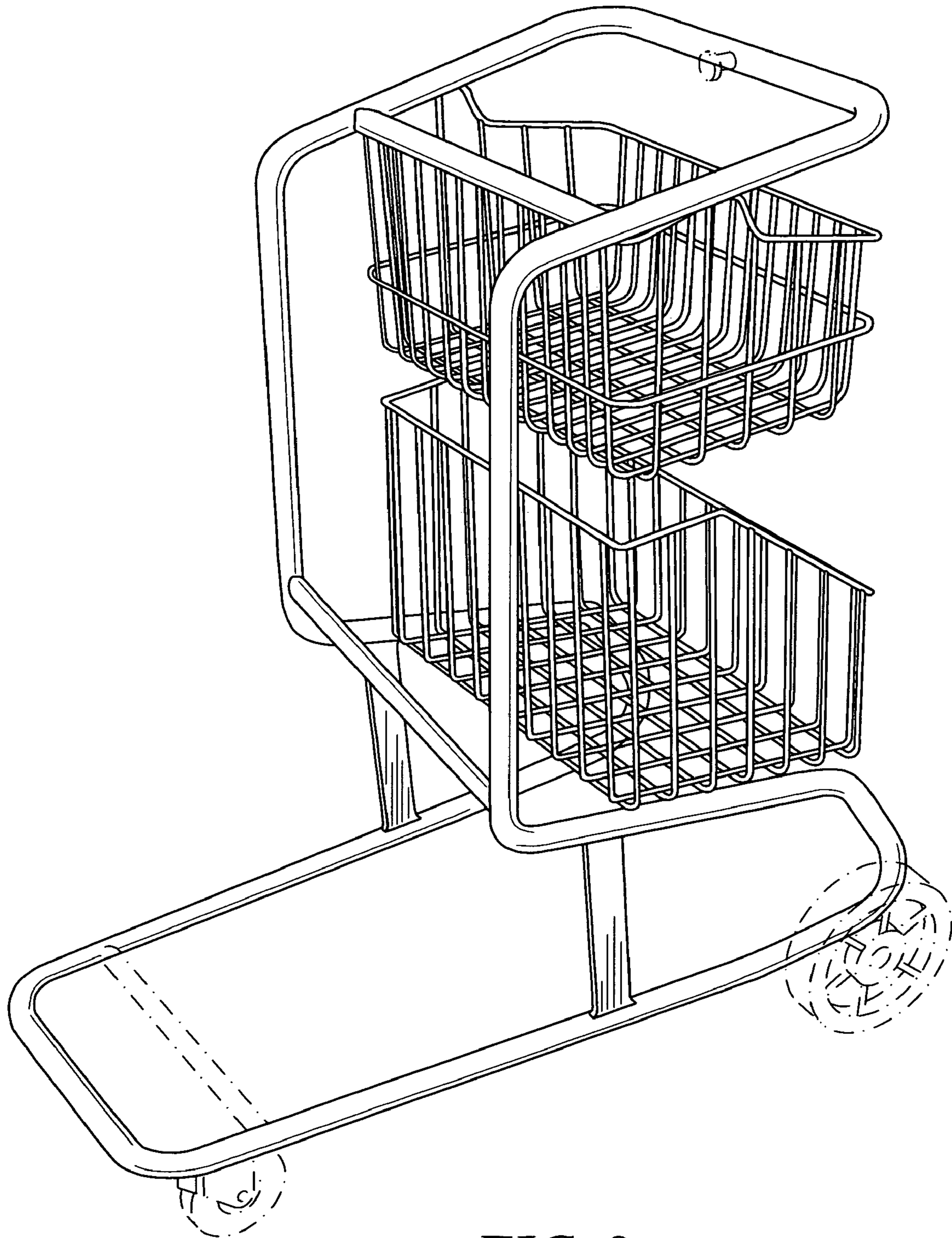
