**DESCRIPTION**

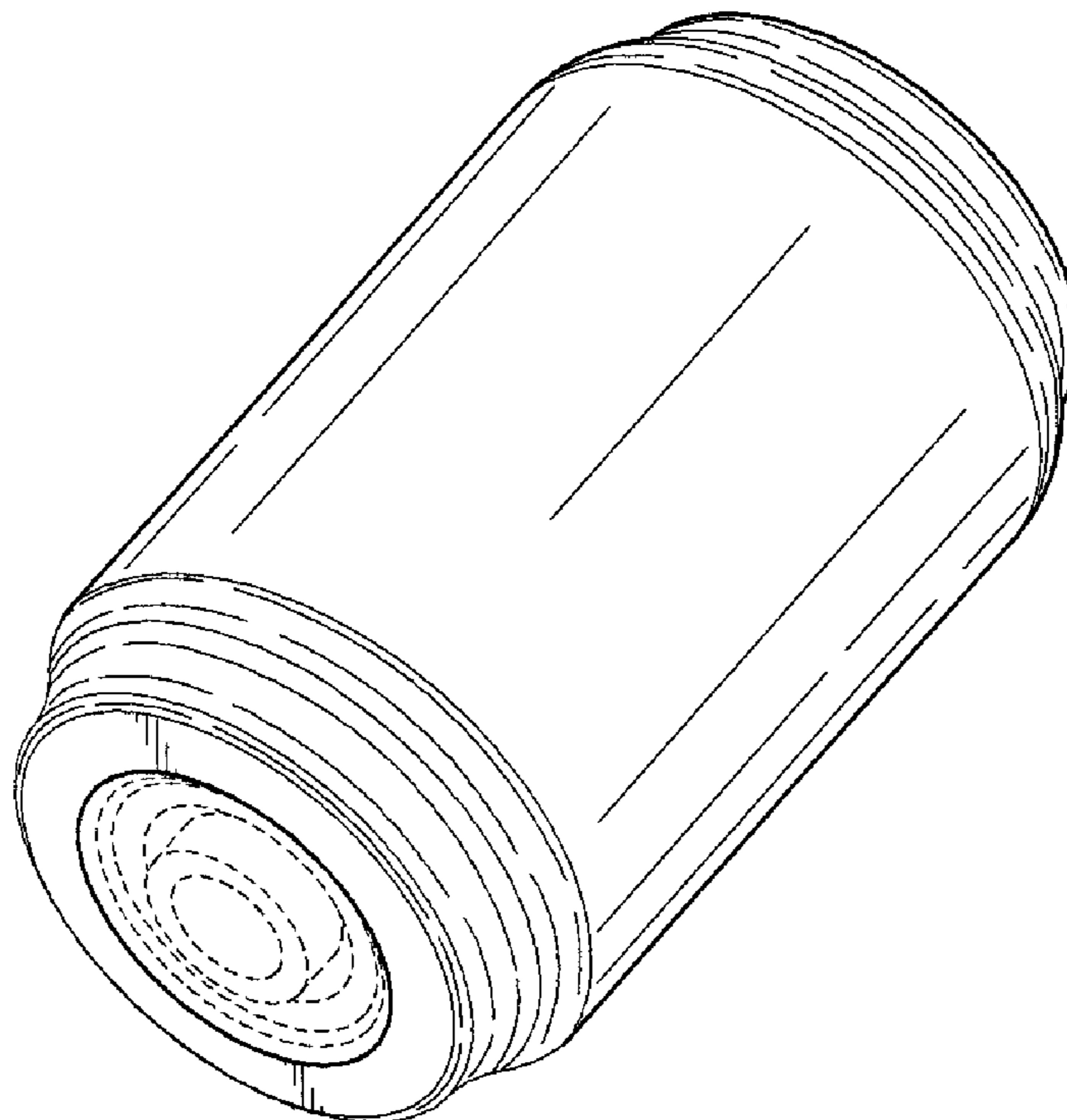
FIG. 1 is a perspective view of a cargo roller of the present invention;

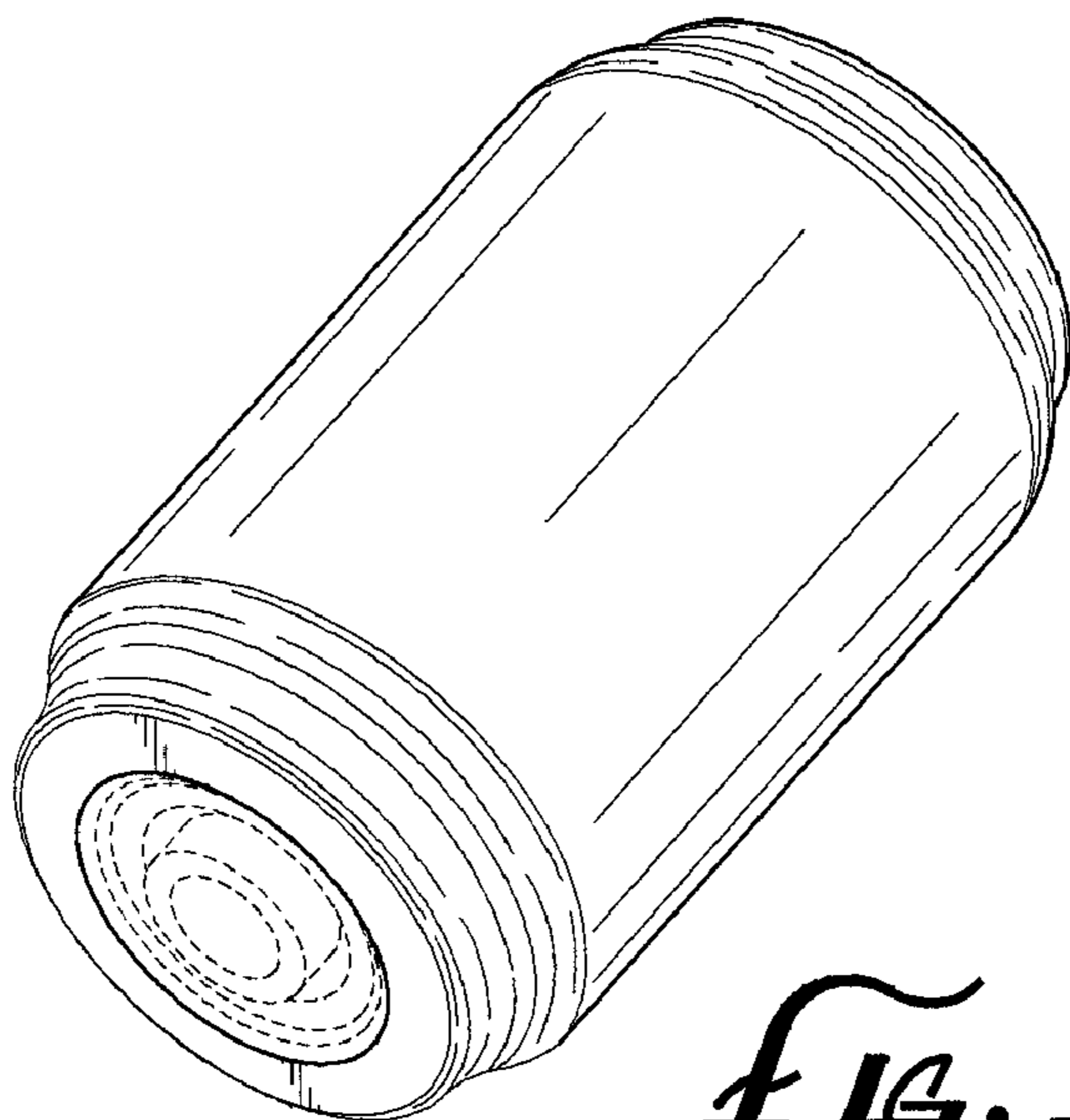
FIG. 2 is a front elevation view thereof, with the rear elevation view being the same; and,

FIG. 3 is a side elevation view thereof, with the other side, the top and the bottom views being the same.

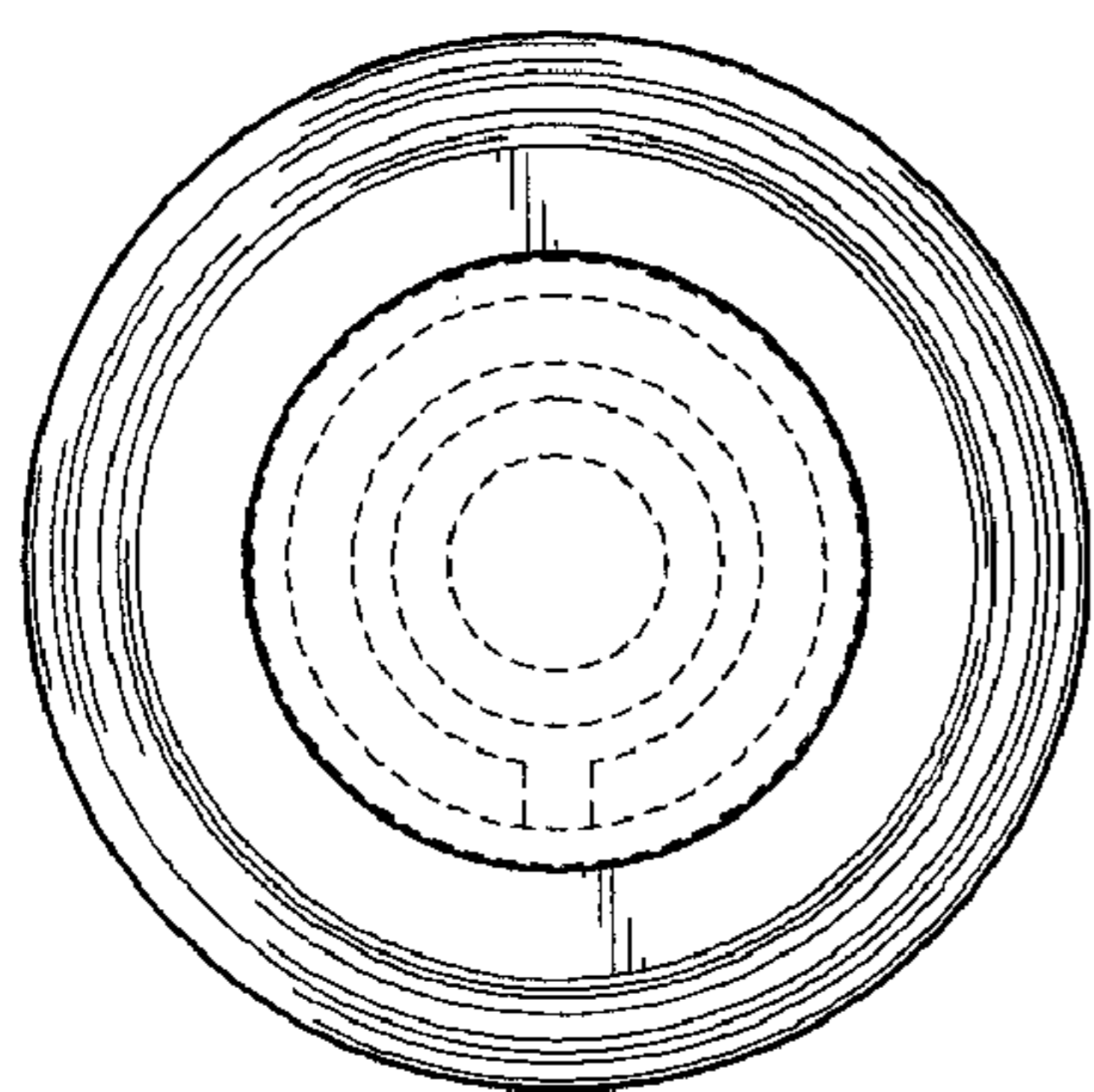

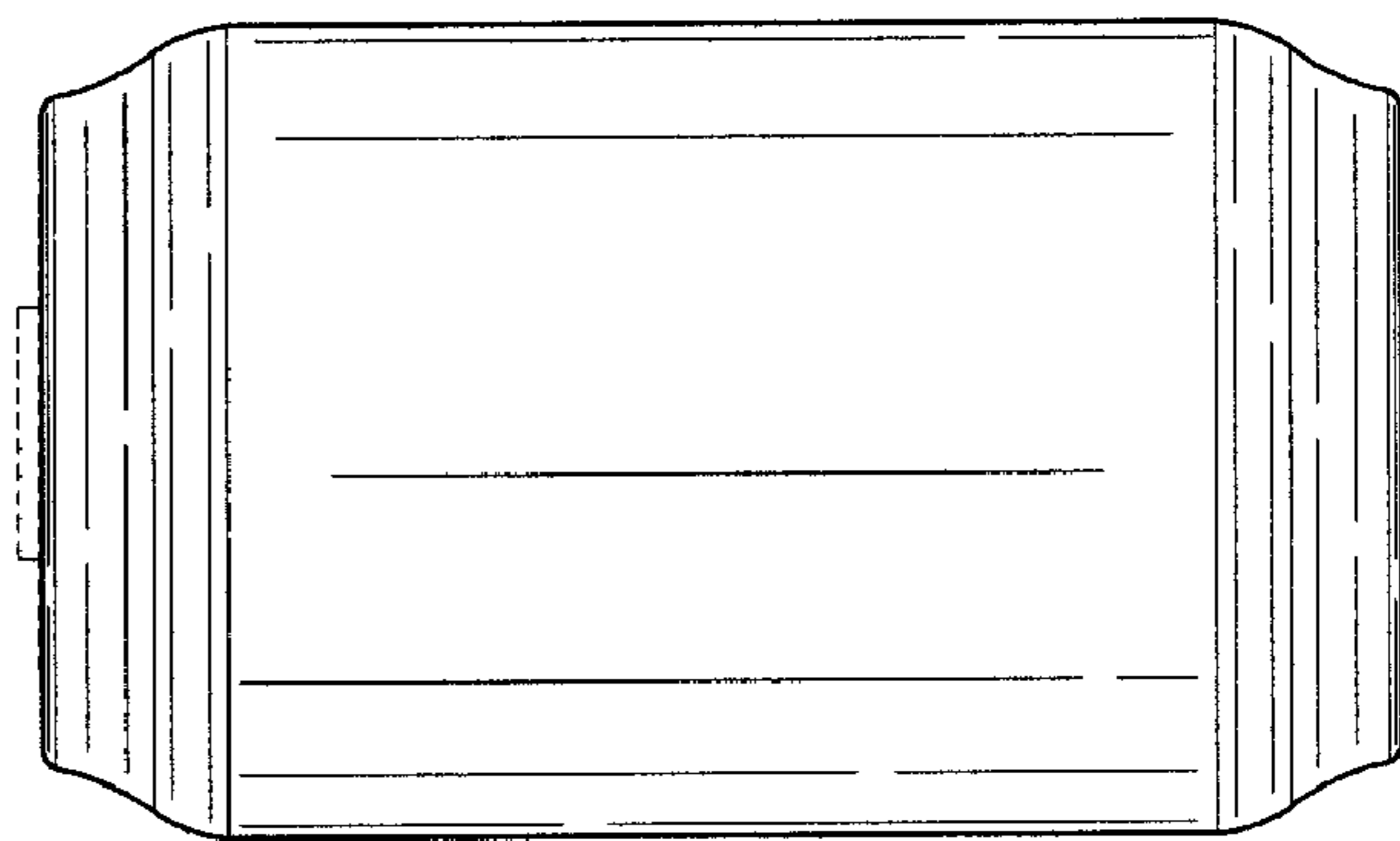
