FIG. 5 is a bottom plan view thereof;

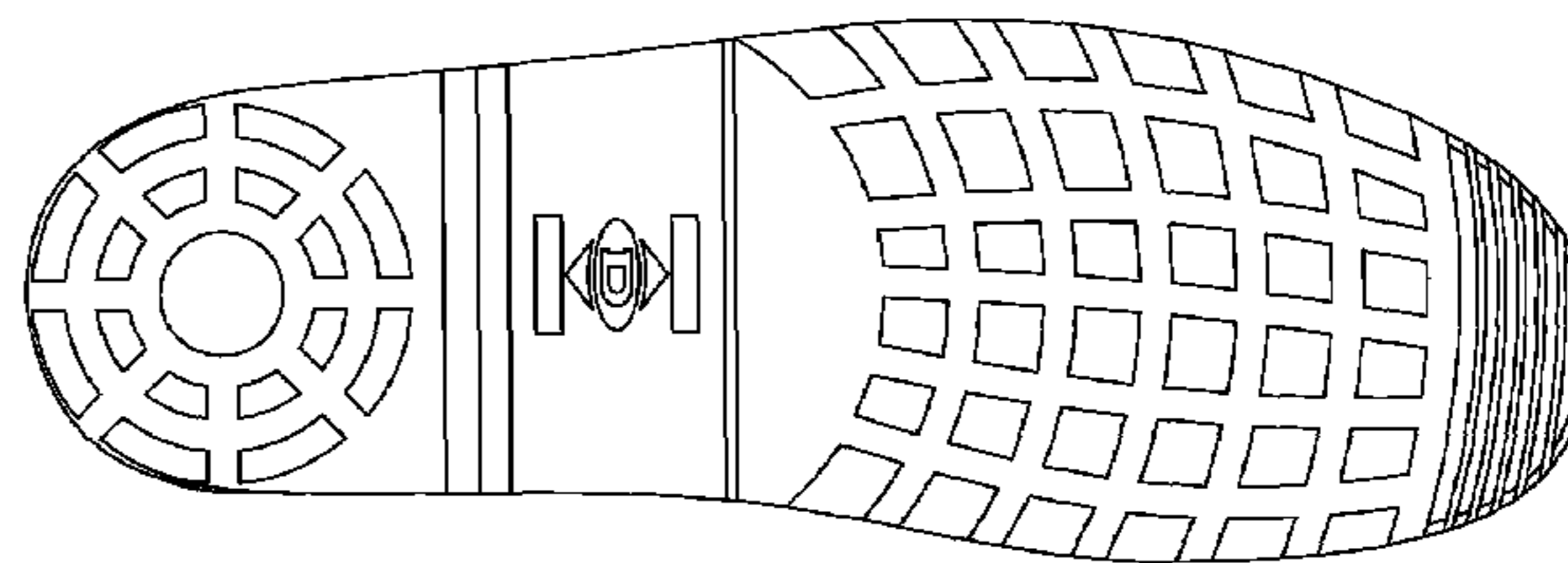
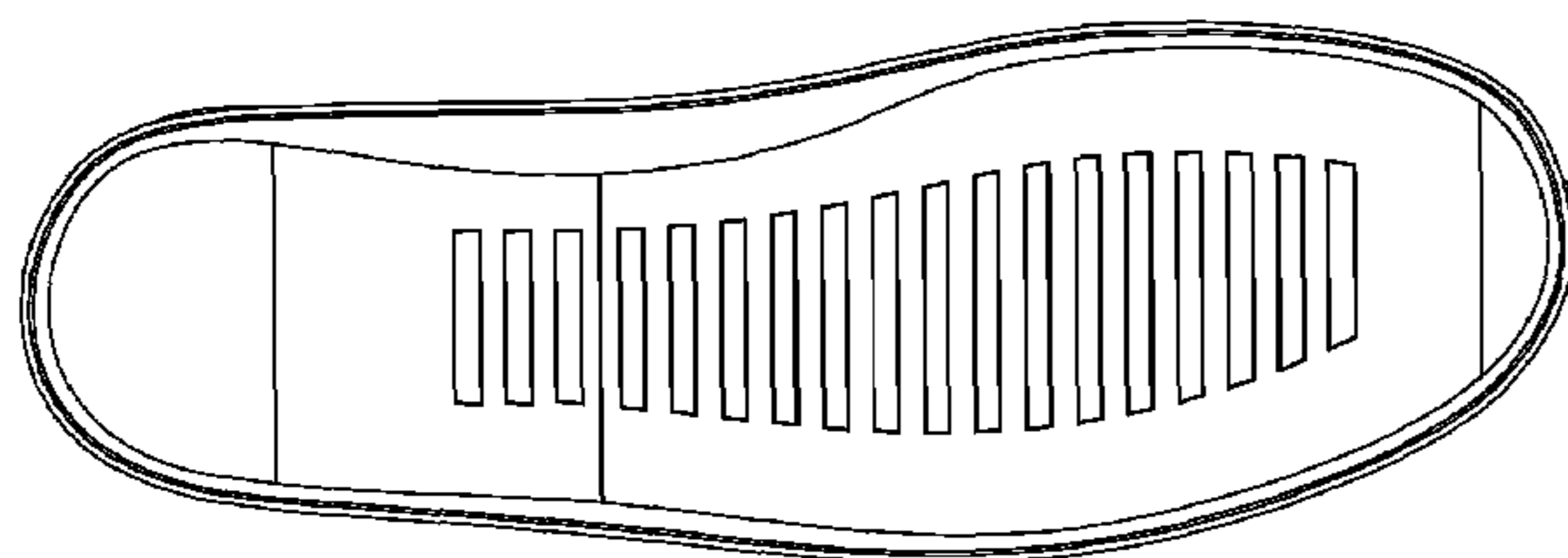
FIG. 6 is a perspective view thereof, from the right, front and above;

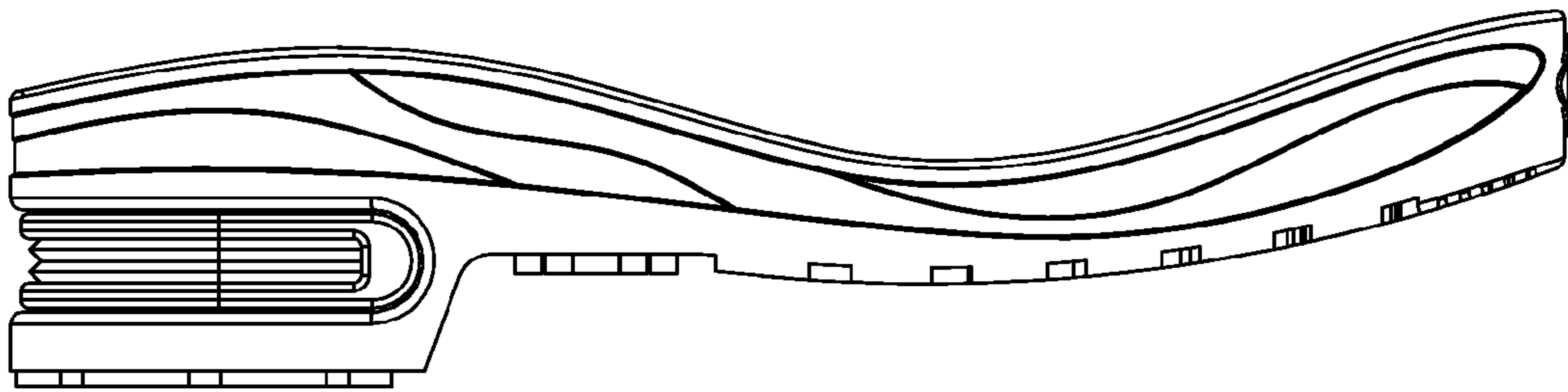

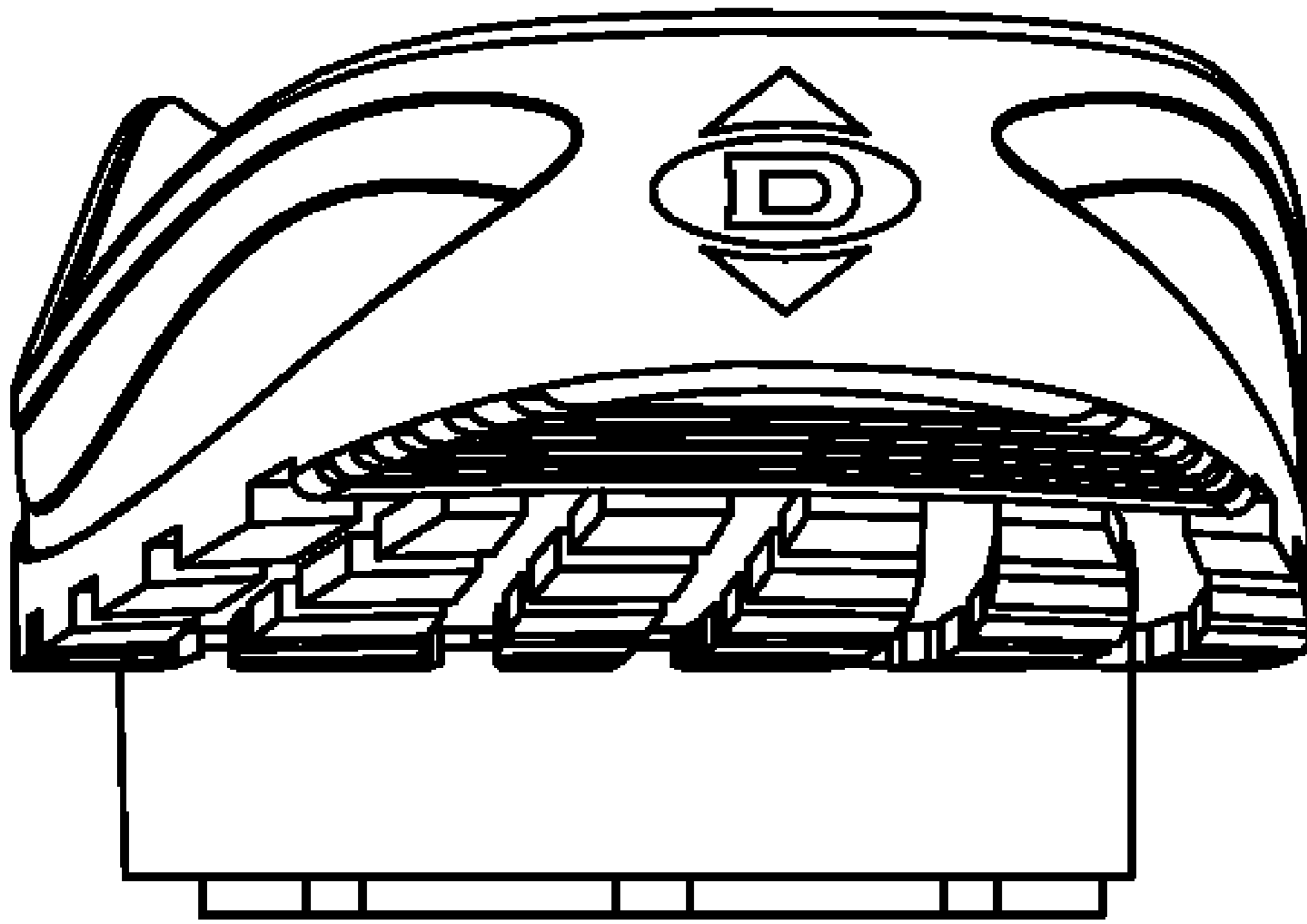

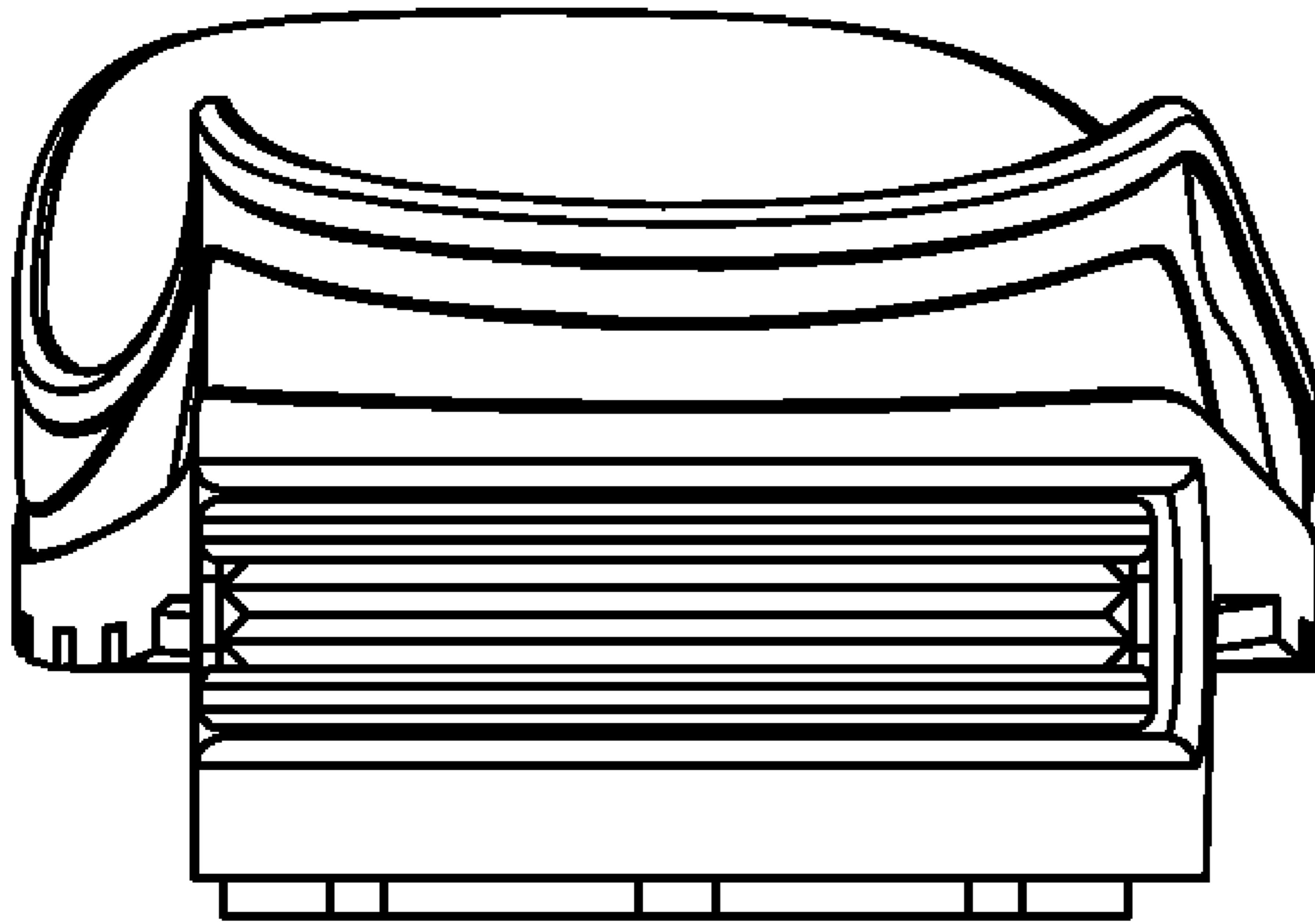

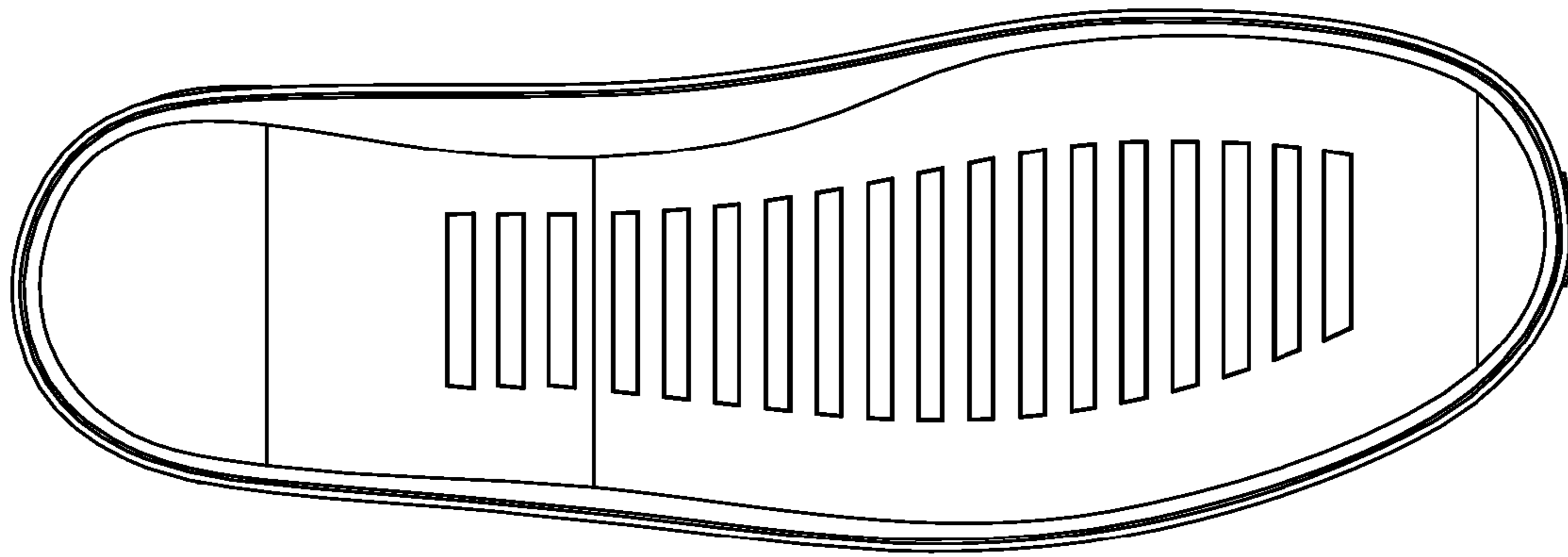

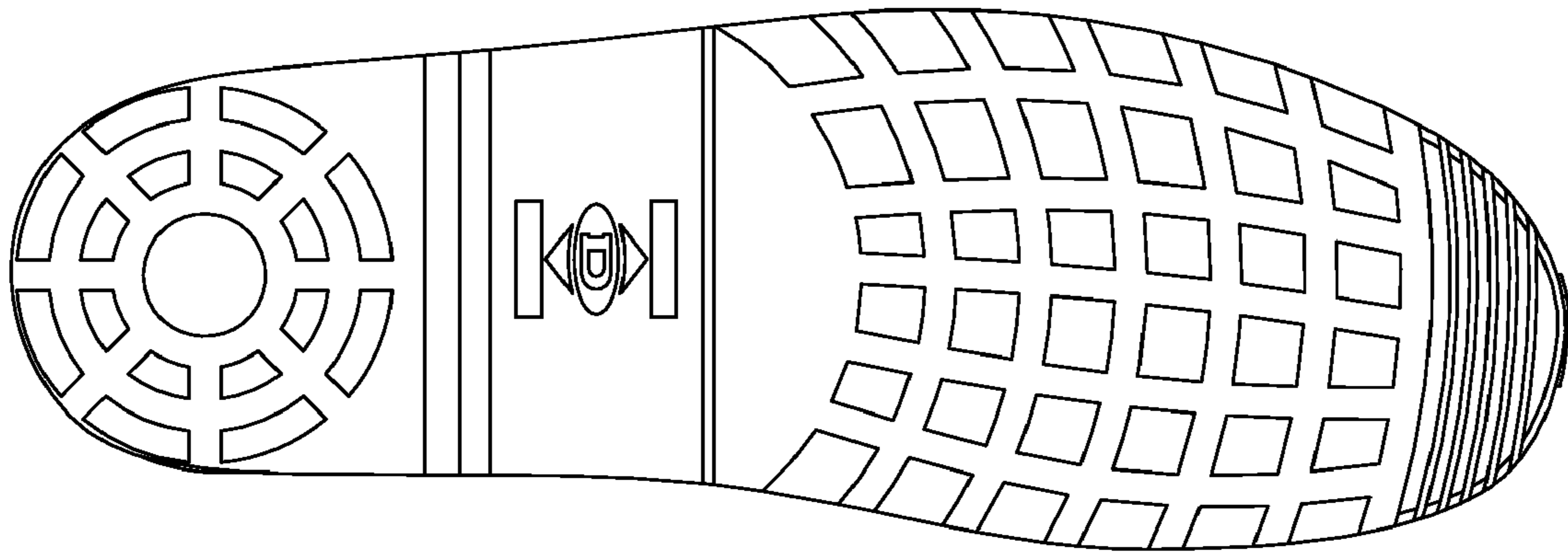

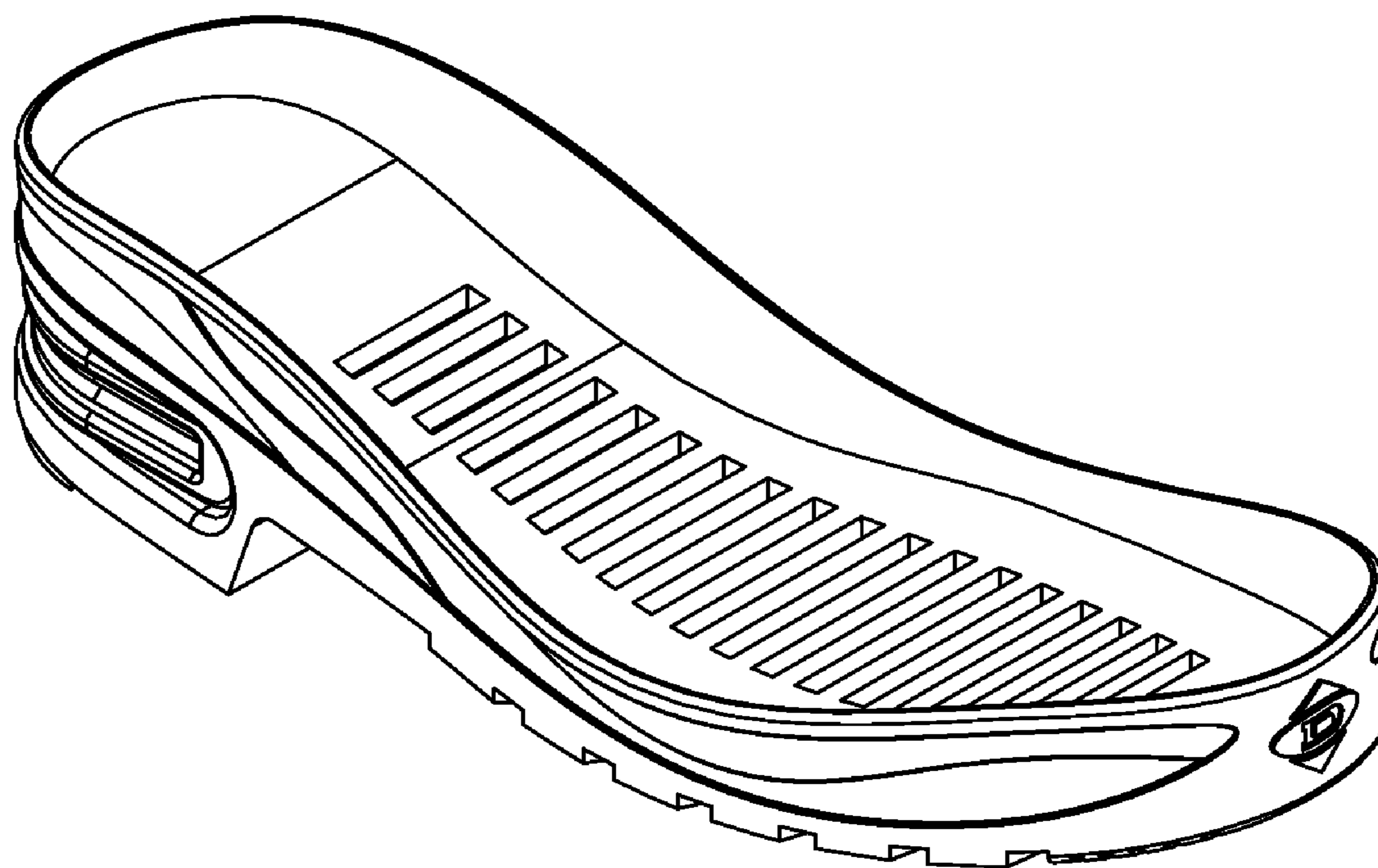

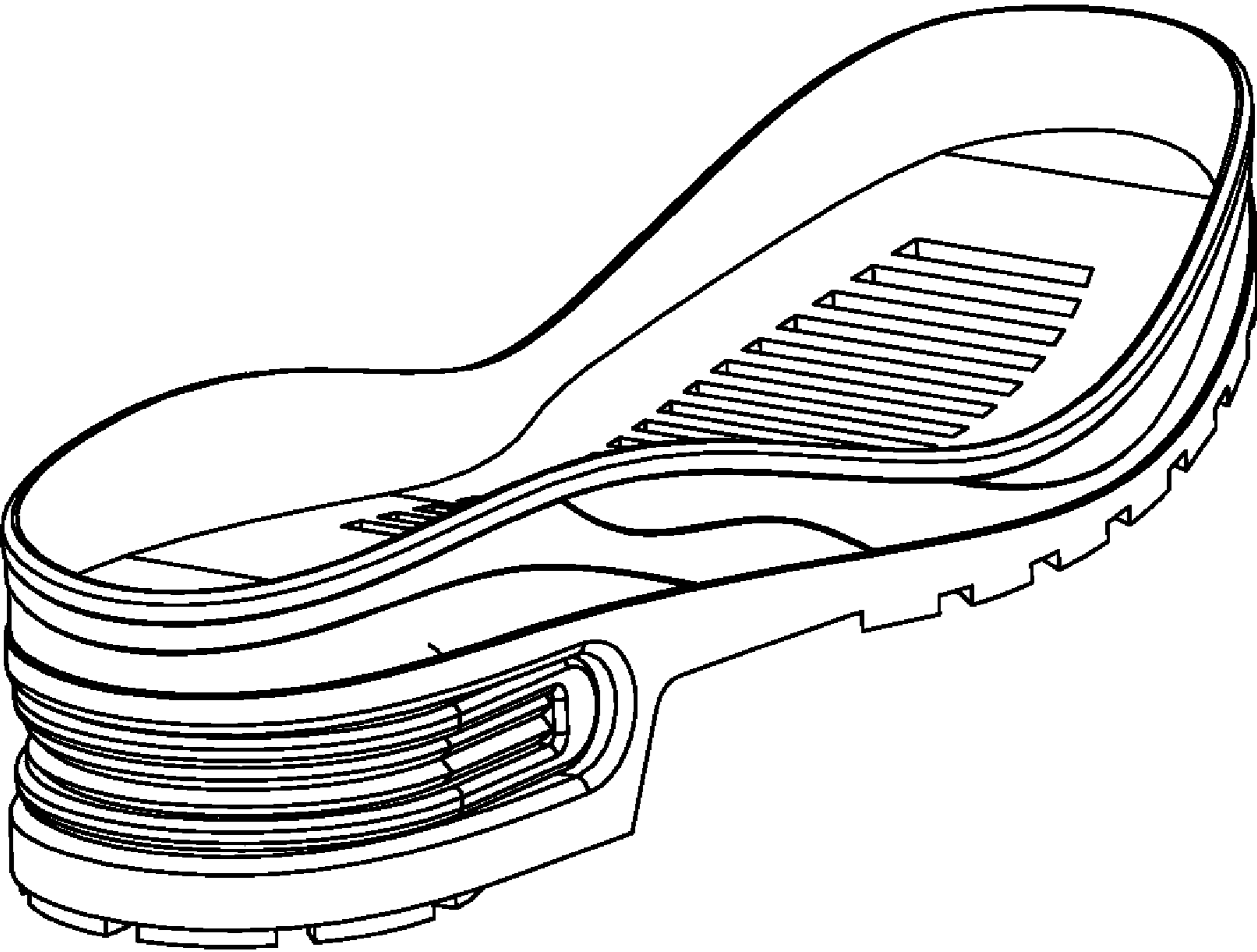

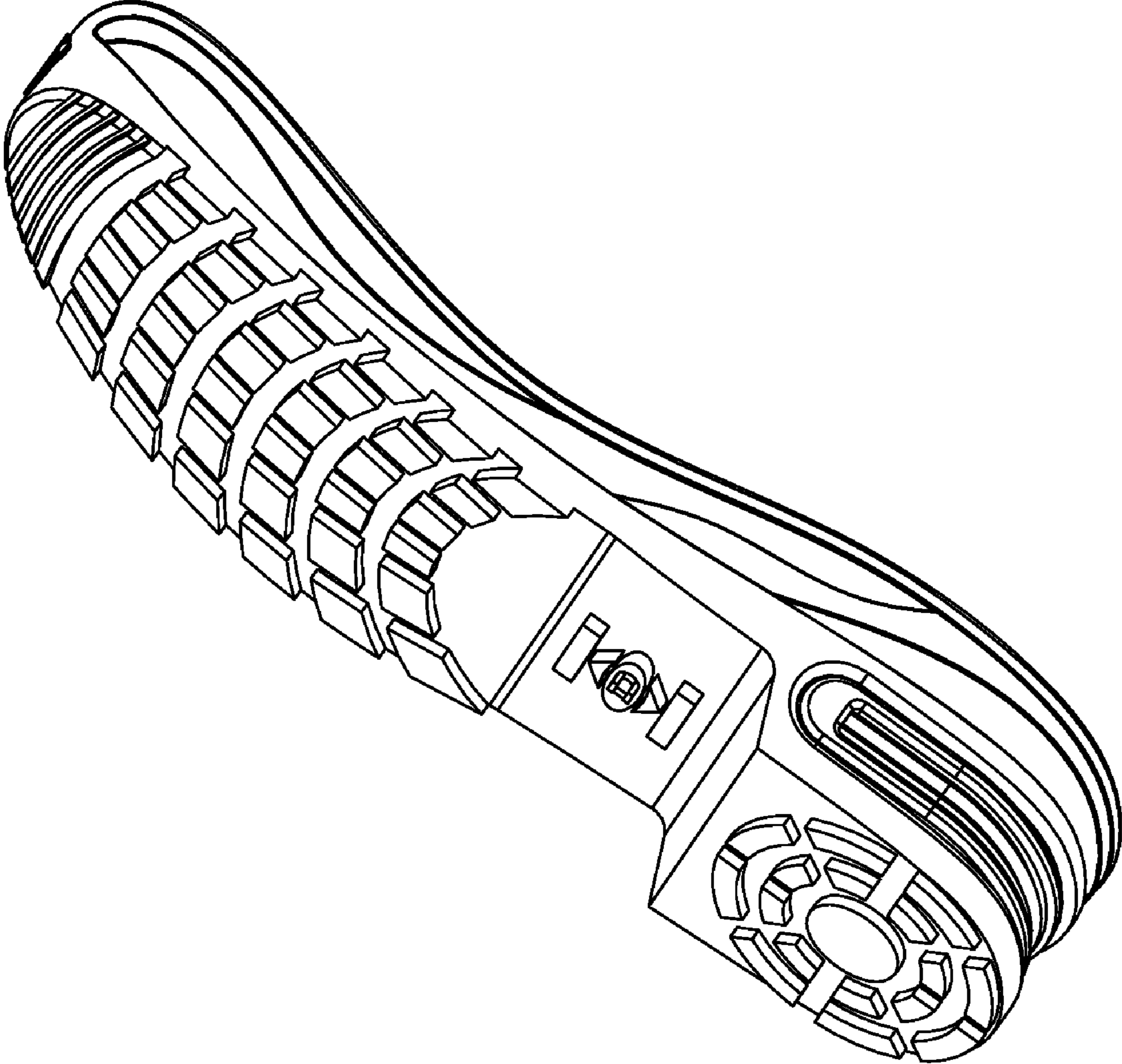

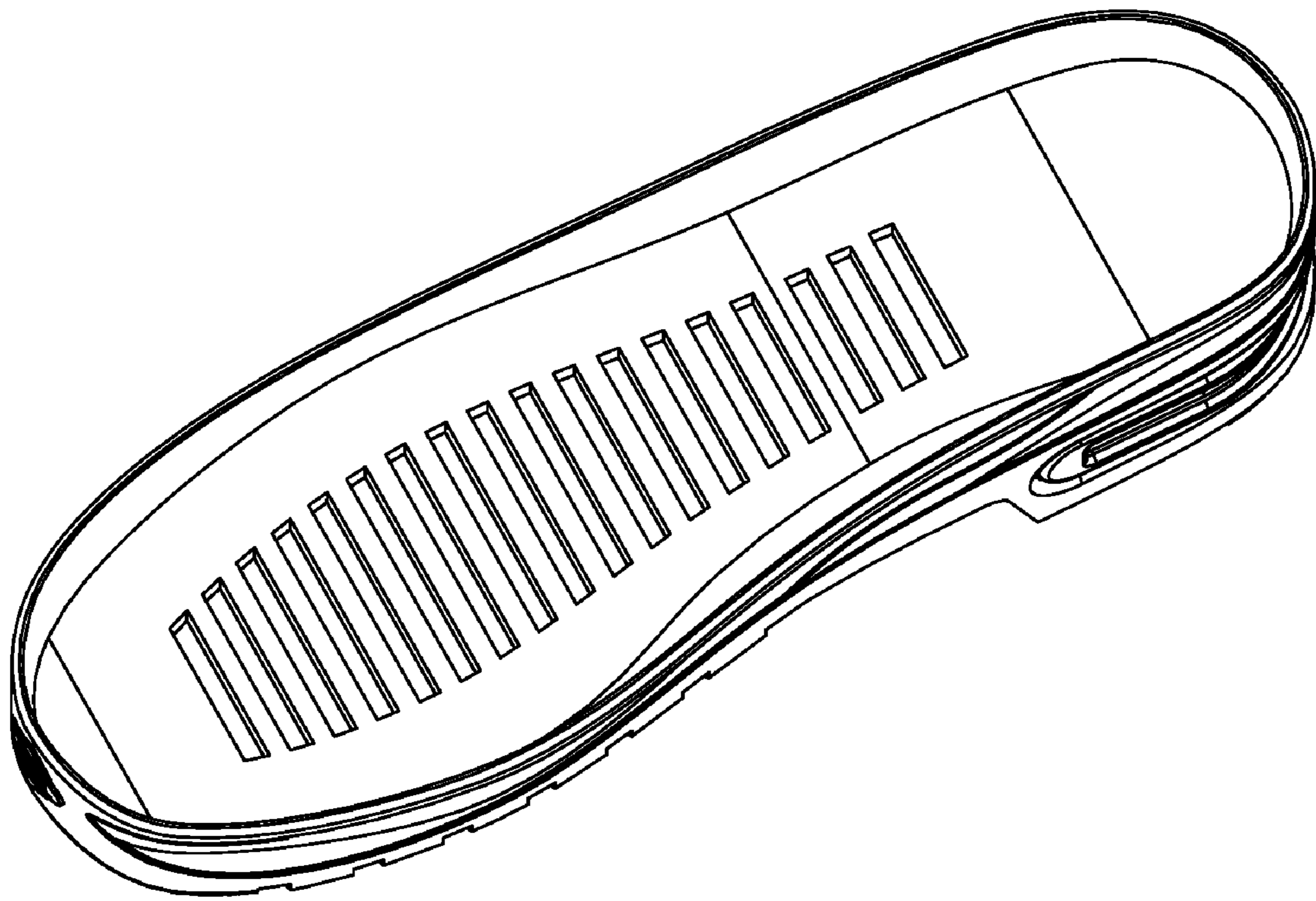
