FIG. 2 is top plan view thereof;

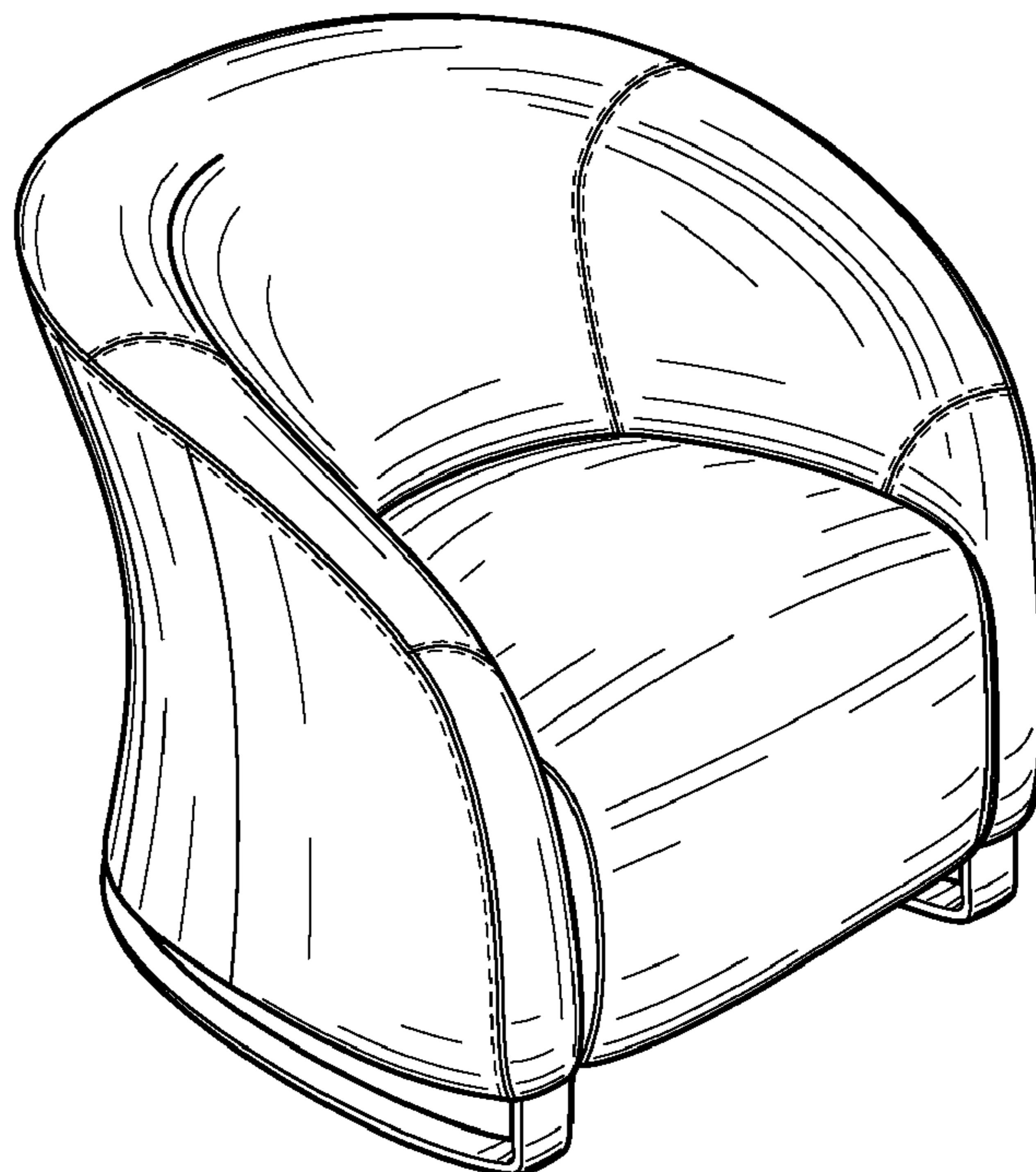
FIG. 3 is a back view thereof;

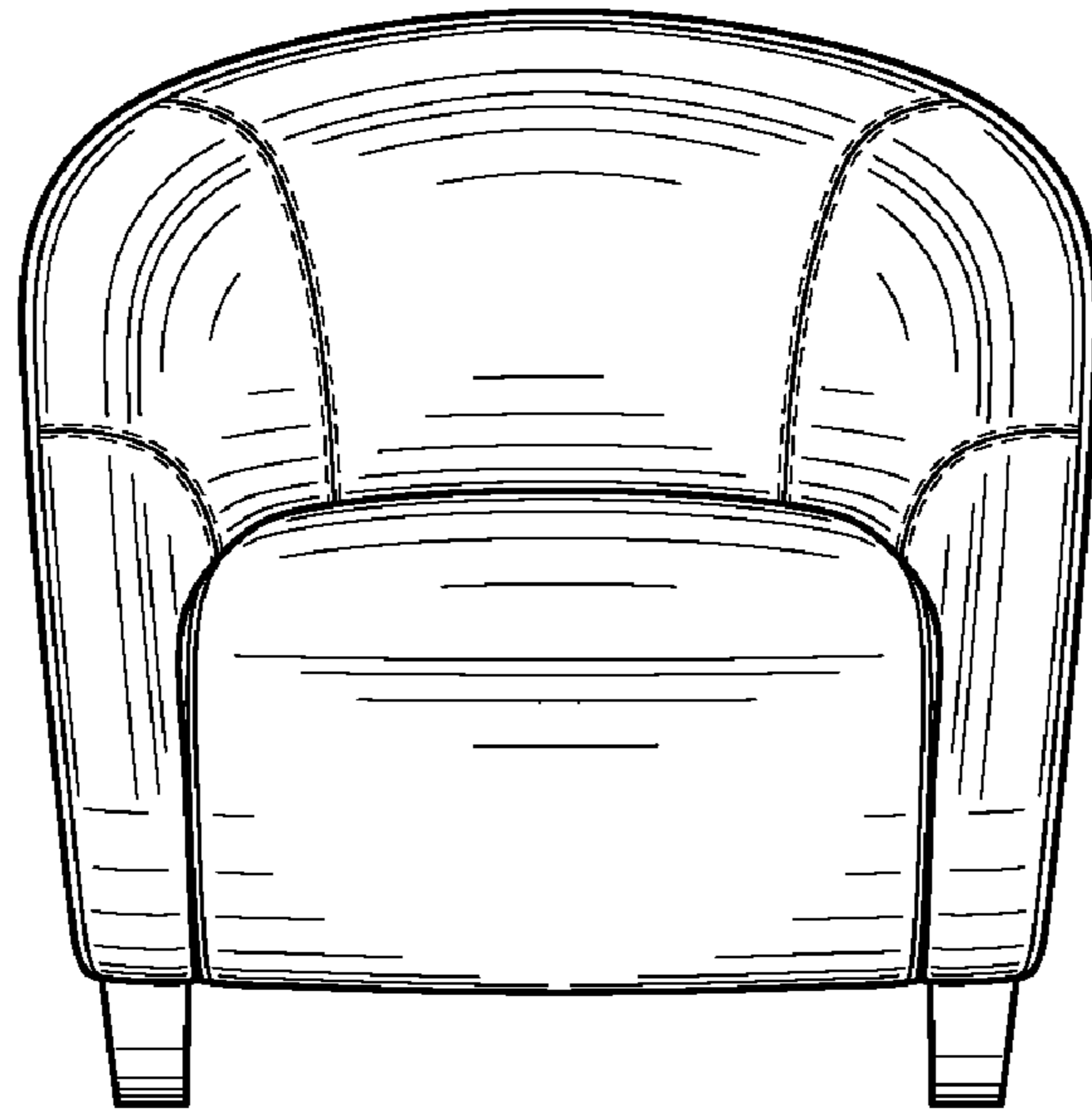

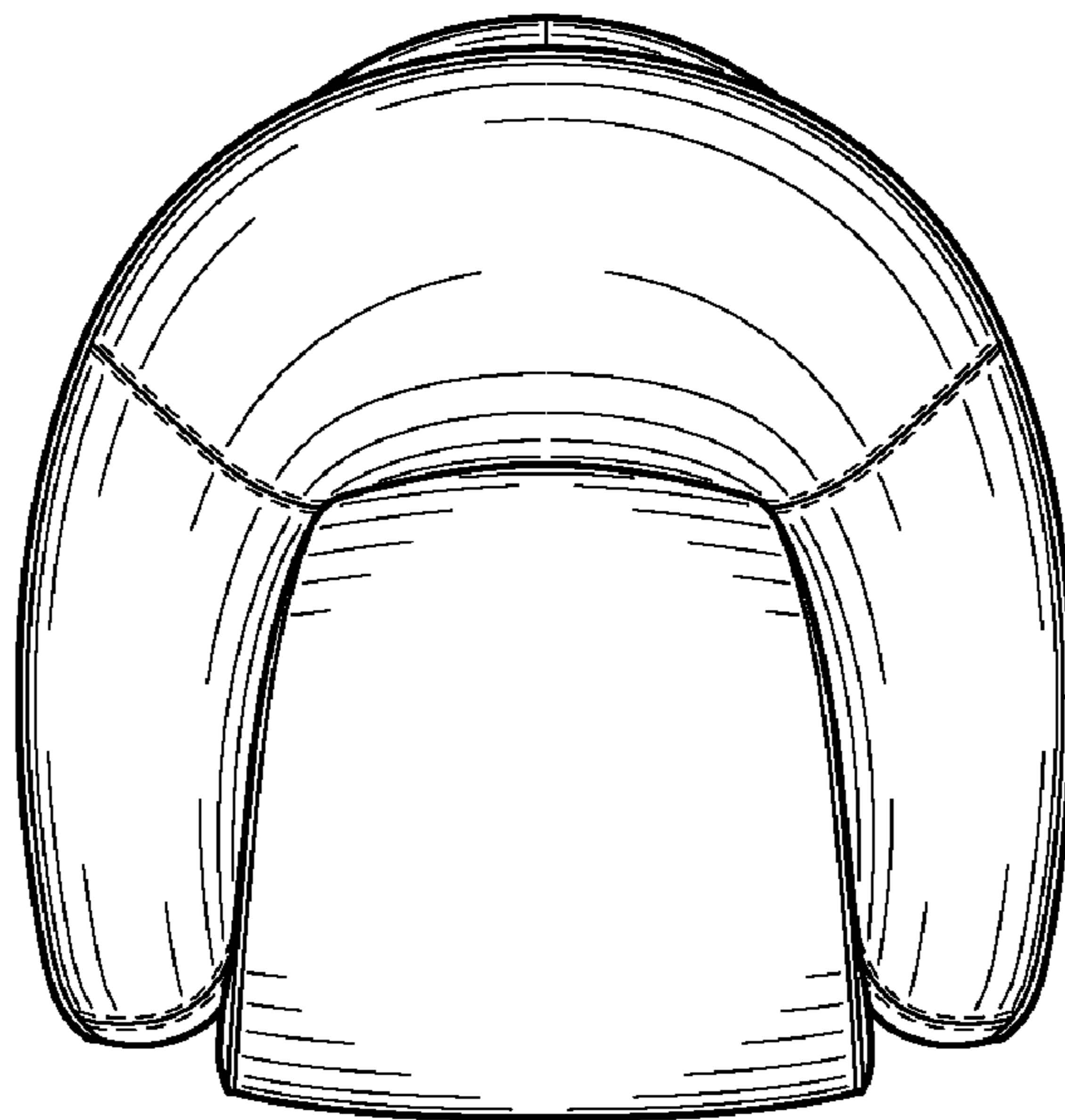

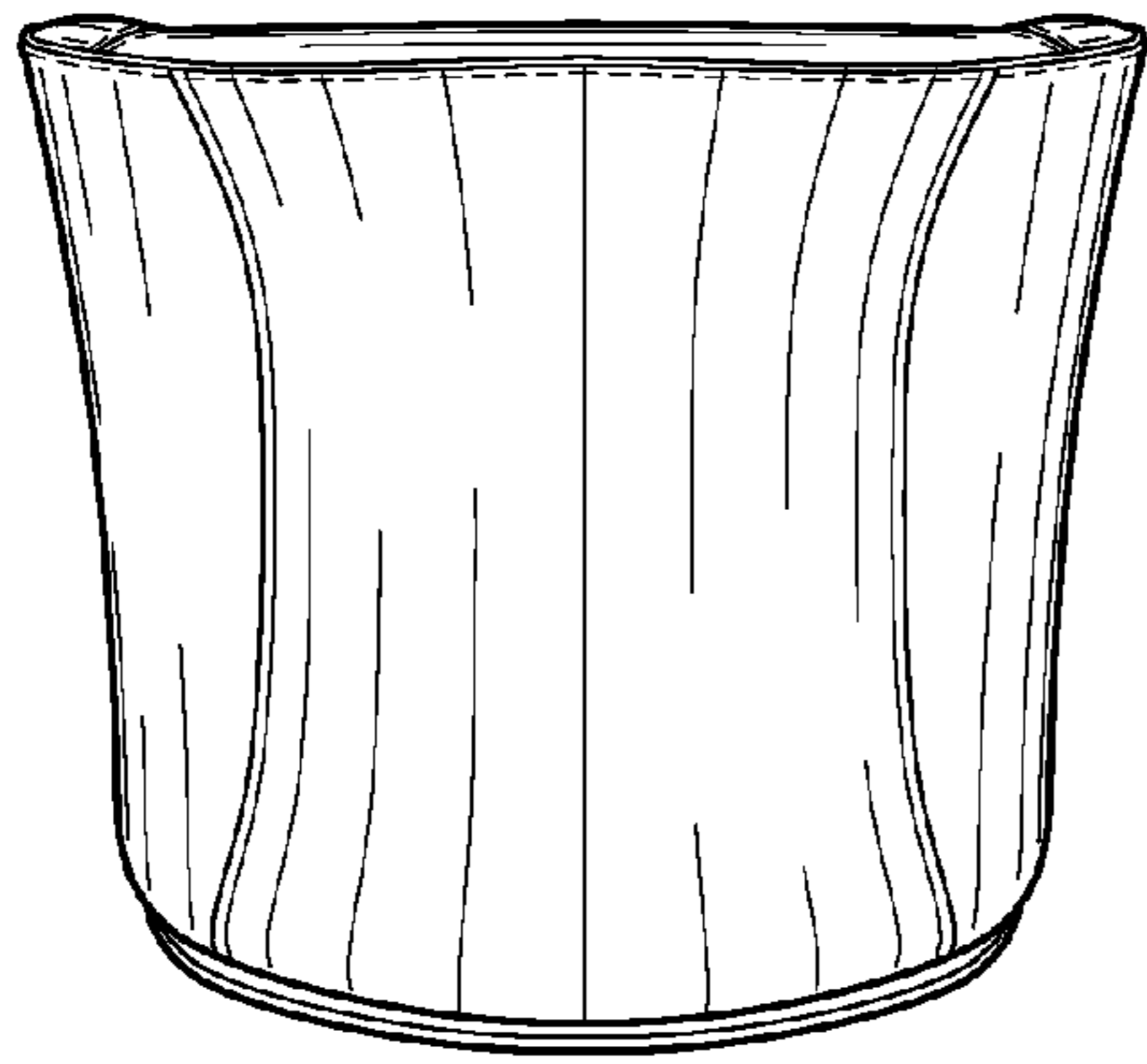

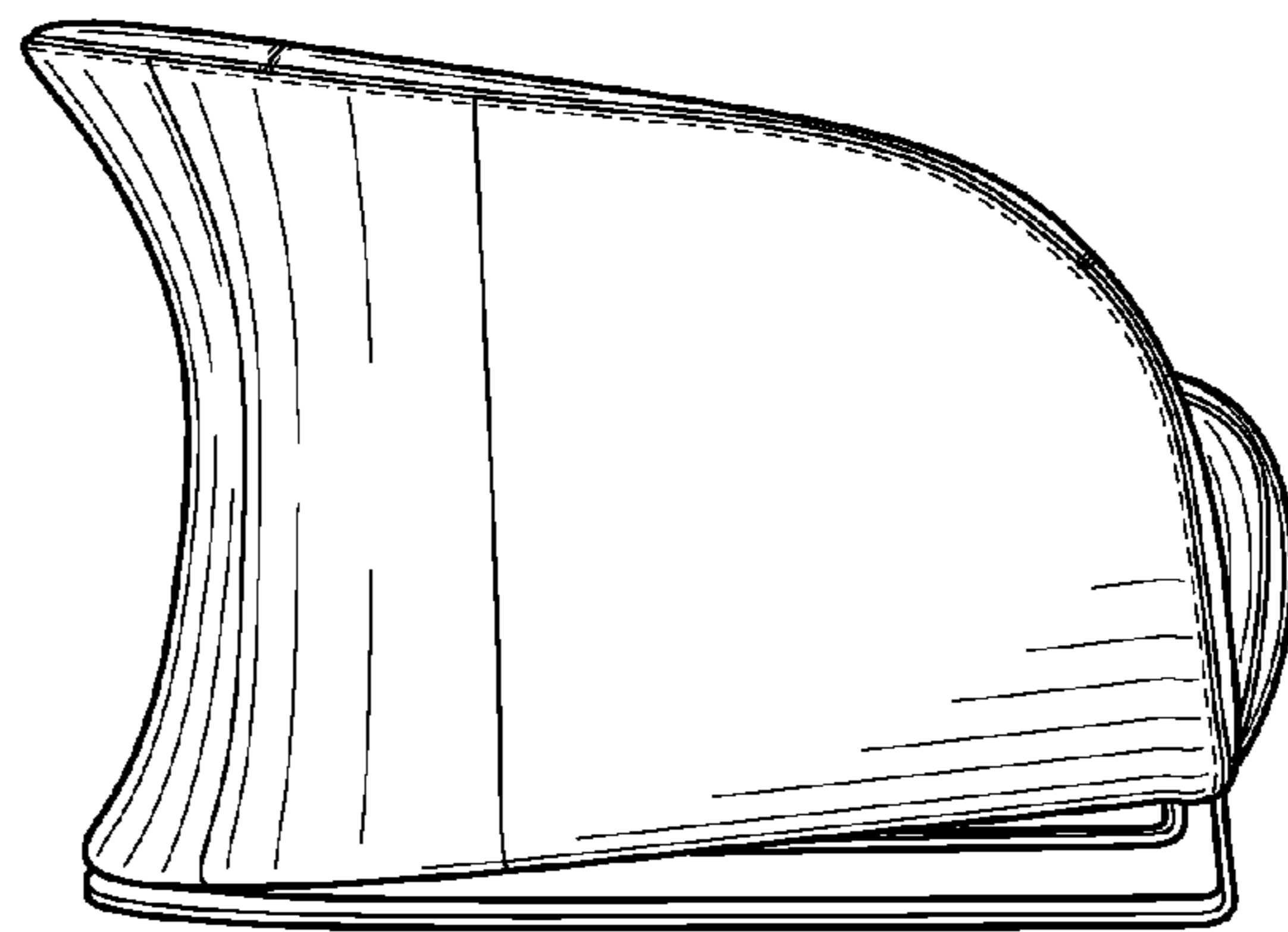

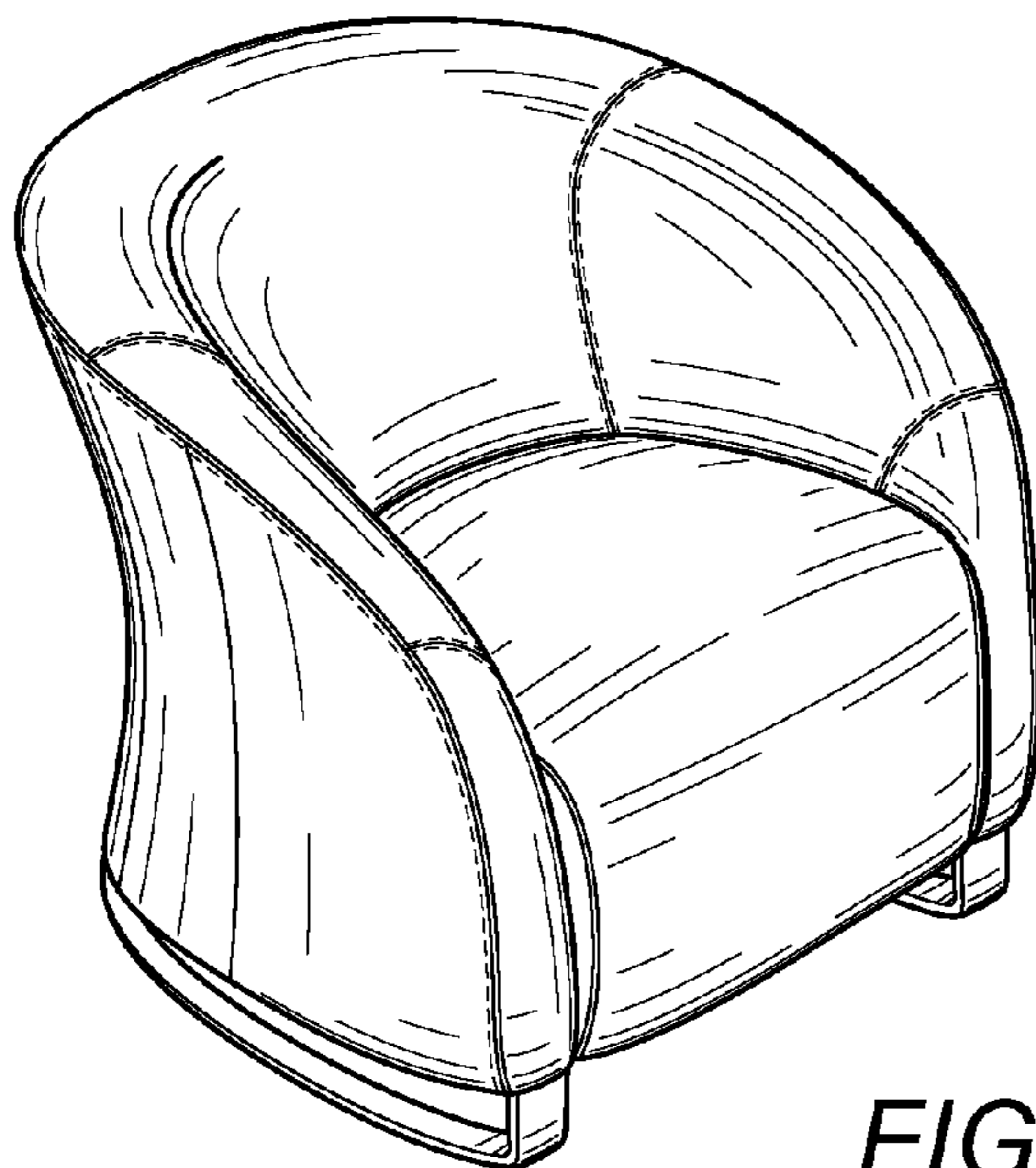
