(57) **CLAIM**

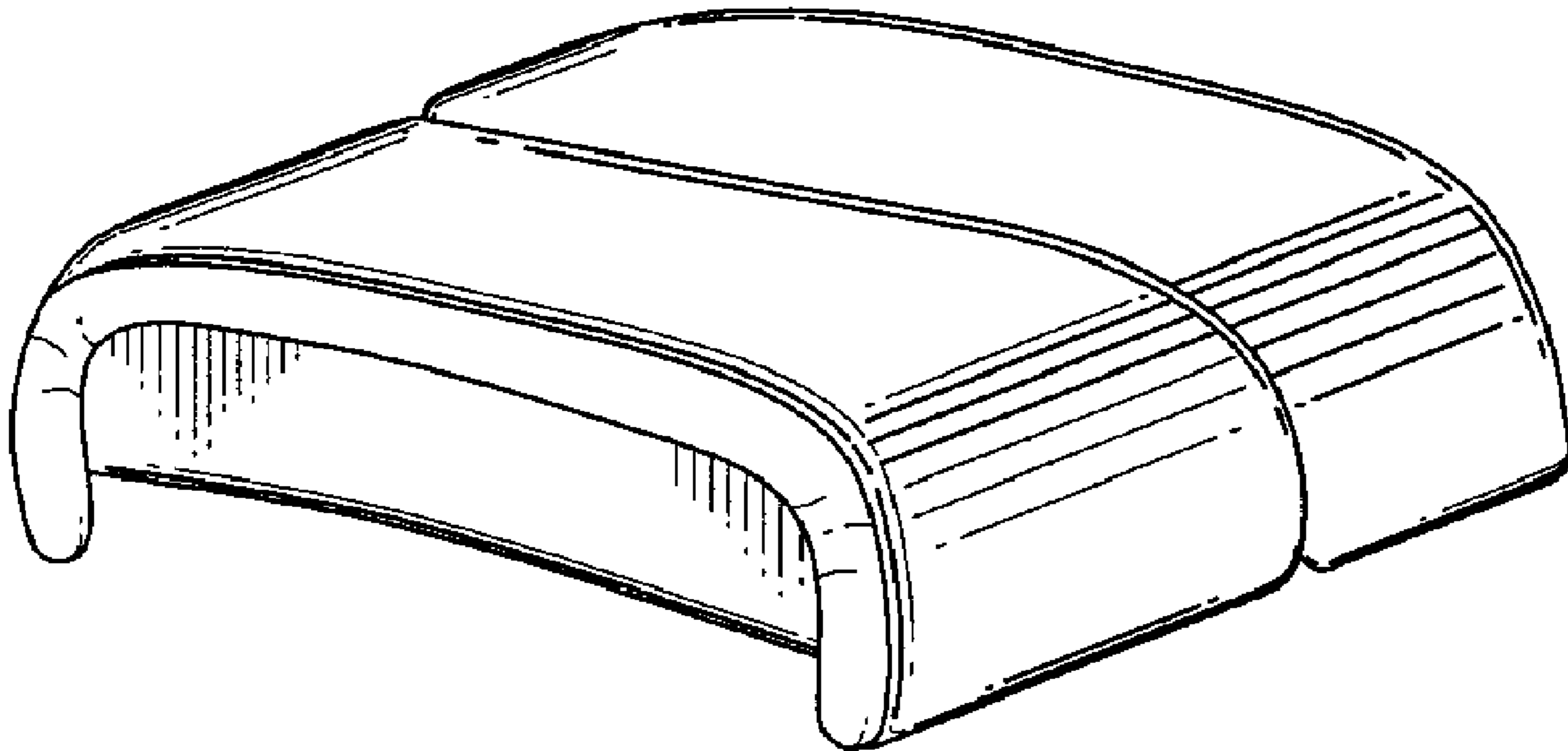
I claim the design for a stool, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a stool of my design.
FIG. 2 is a rear perspective view of the stool shown in FIG. 1.
FIG. 3 is a front elevation view of the stool shown in FIG. 1.
FIG. 4 is a rear elevation view of the stool shown in FIG. 1.
FIG. 5 is a right side view of the stool shown in FIG. 1.
FIG. 6 is a left side view of the stool shown in FIG. 1.
FIG. 7 is a top view of the stool shown in FIG. 1; and,
FIG. 8 is a bottom view of the stool shown in FIG. 1.

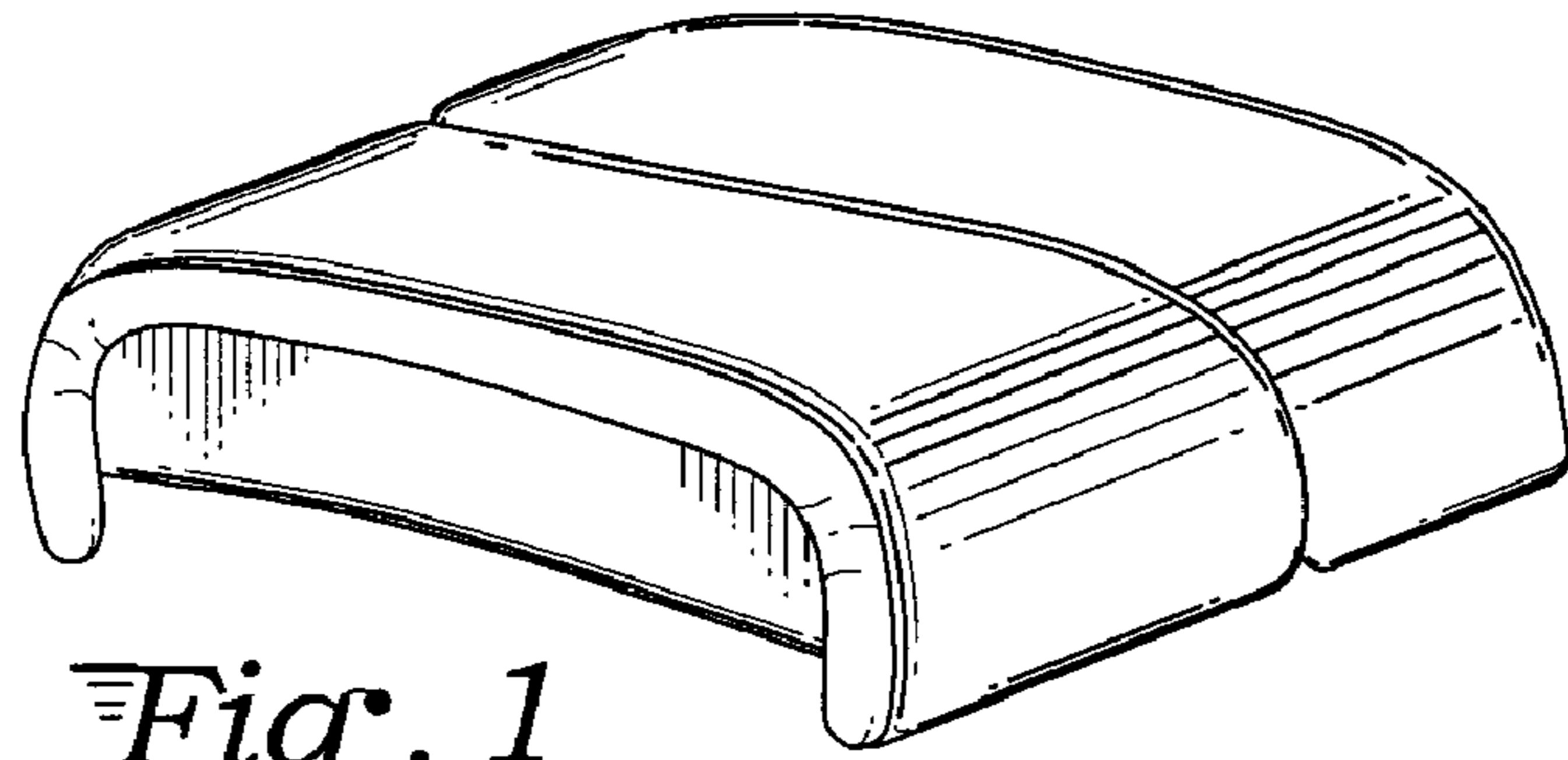

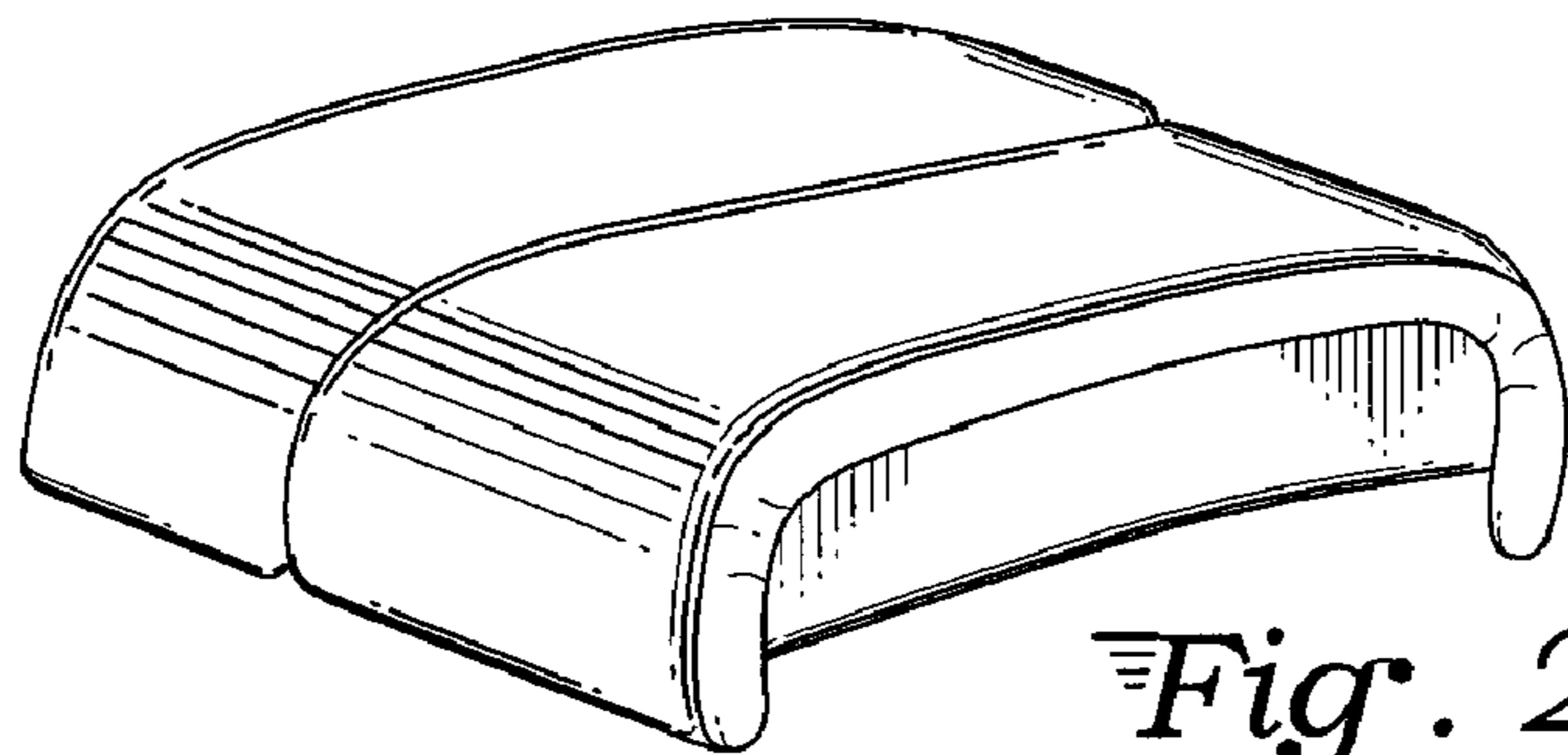

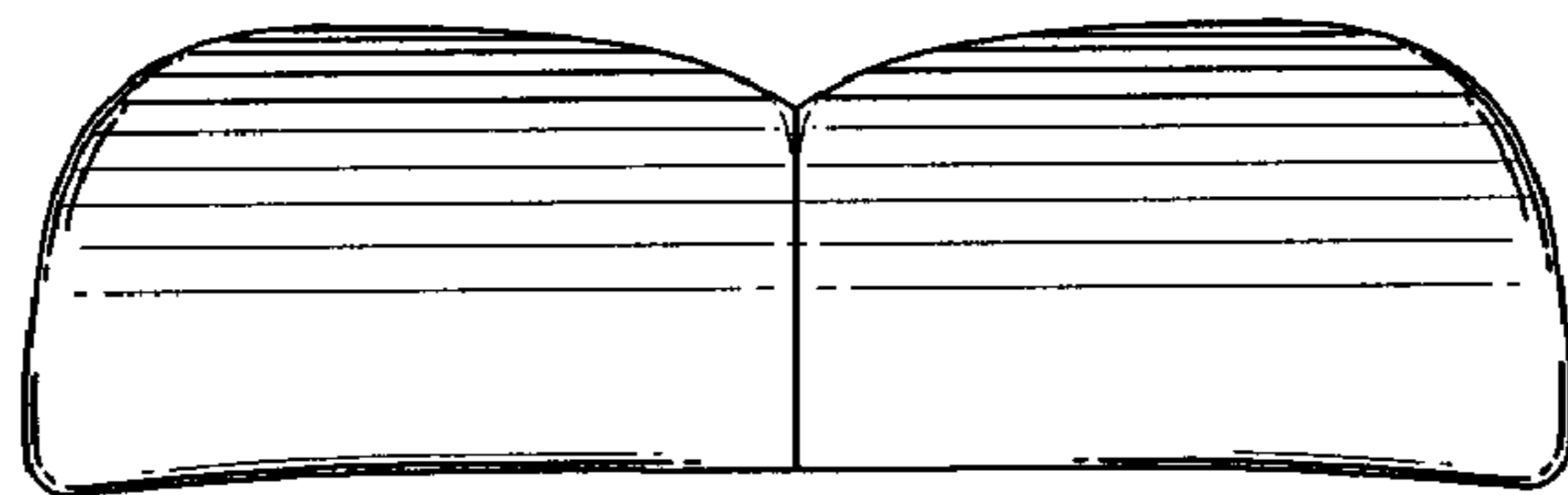

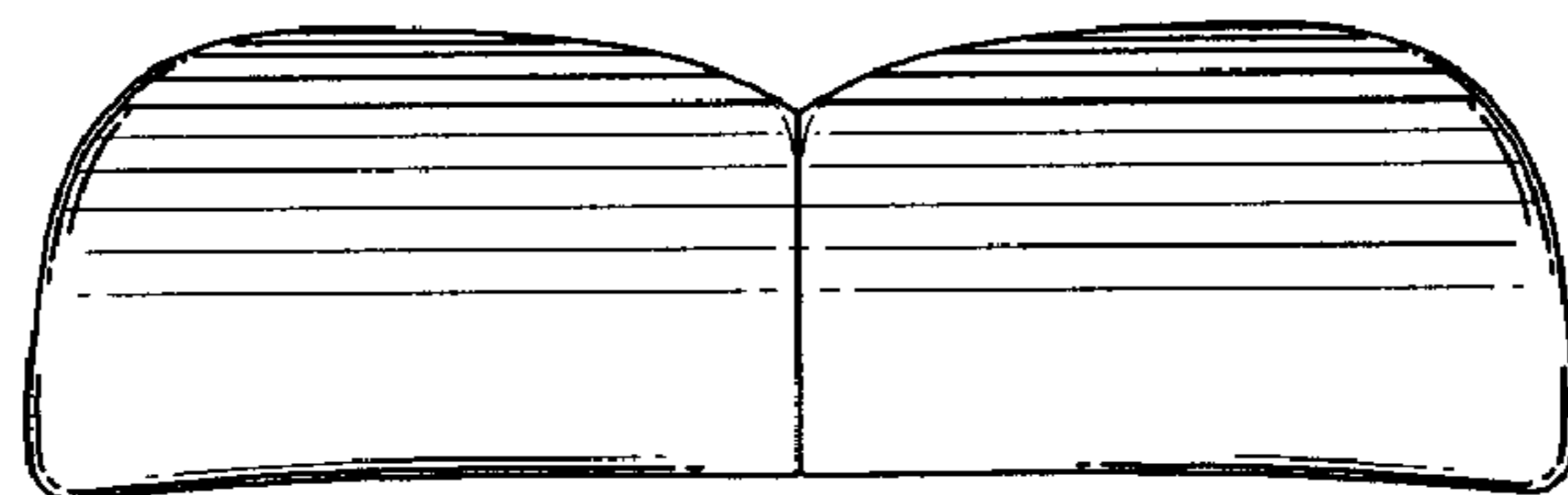

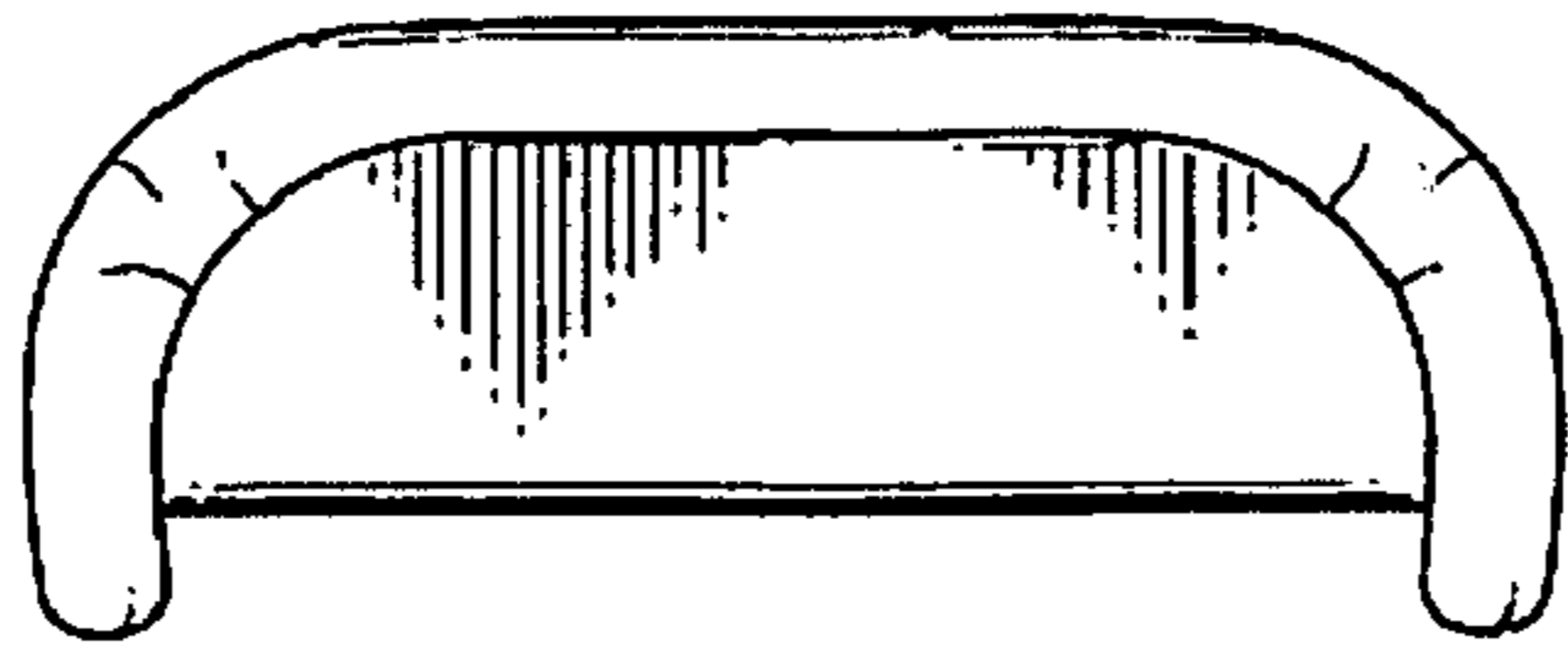

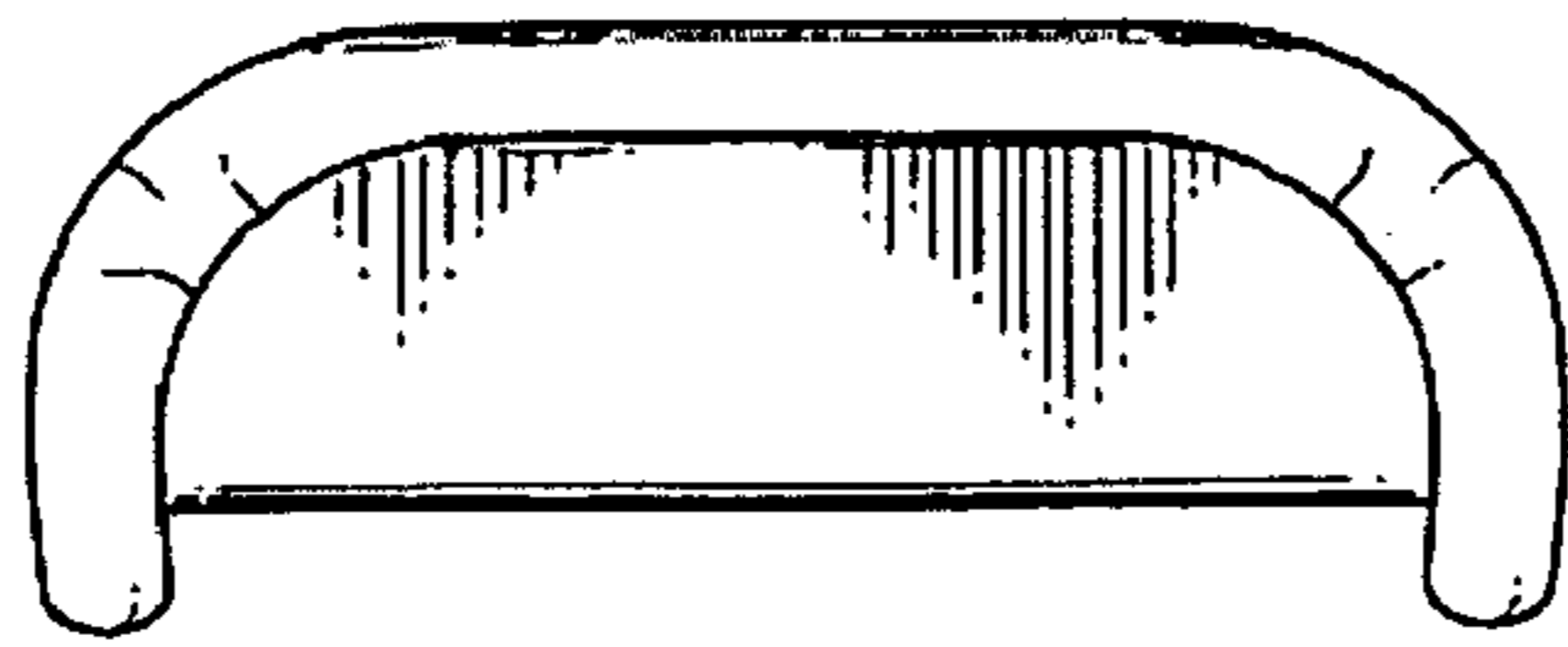

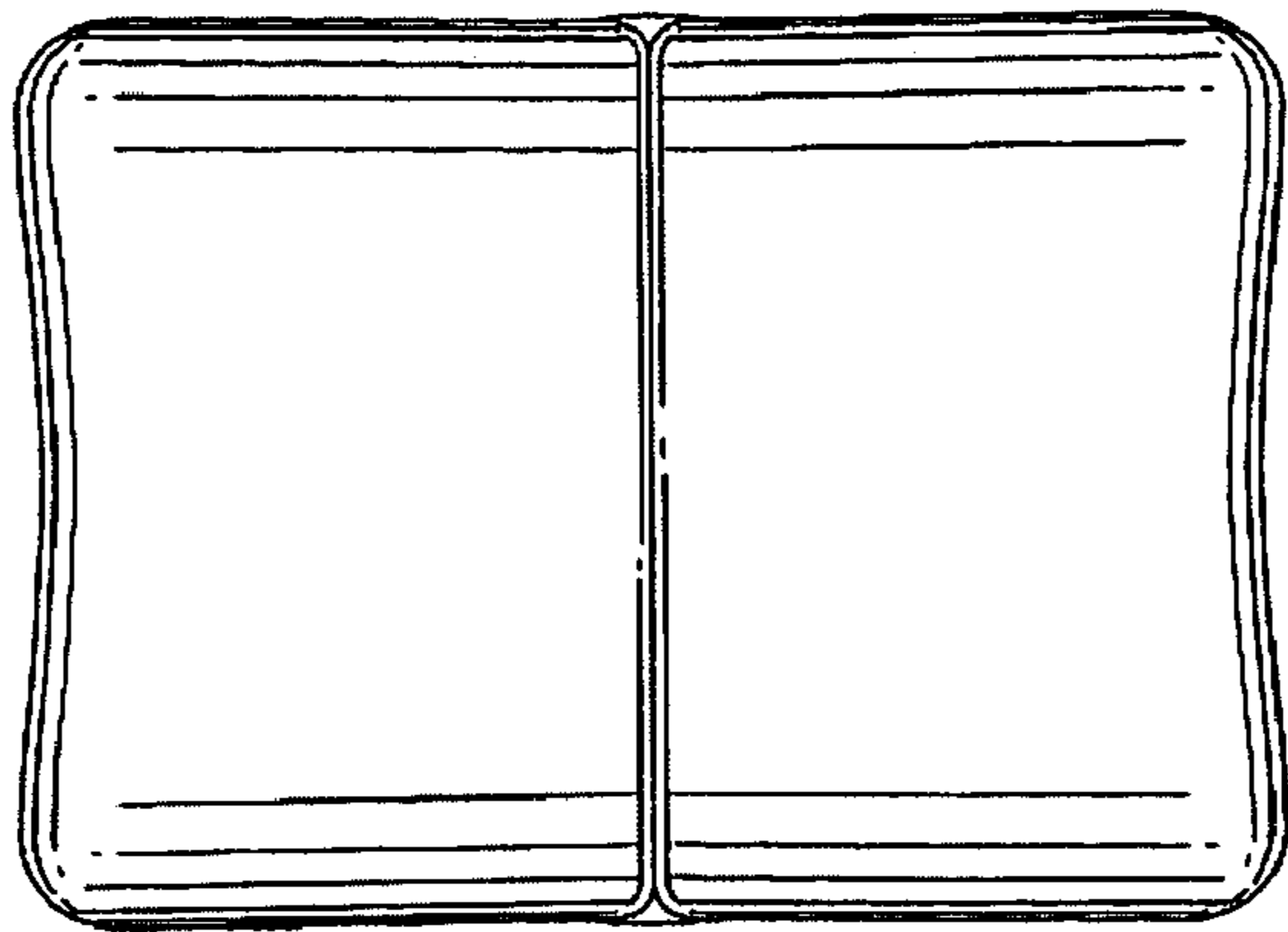

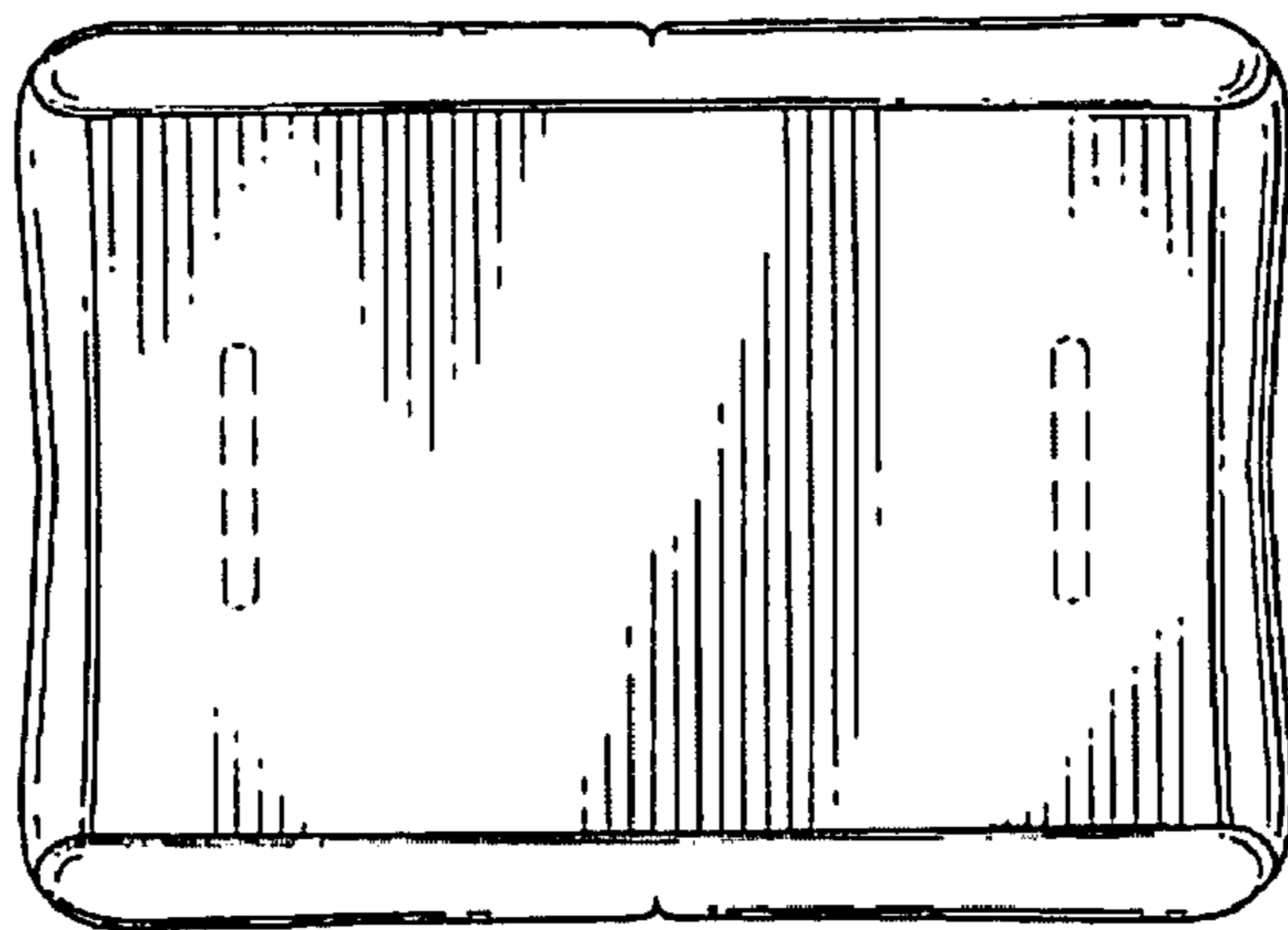
