**DESCRIPTION**

FIG. 1 is a right side elevation view of a workstation.

FIG. 4 is a back elevation view of the workstation of FIG. 1.

FIG. 5 is a top plan view of the workstation of FIG. 1.

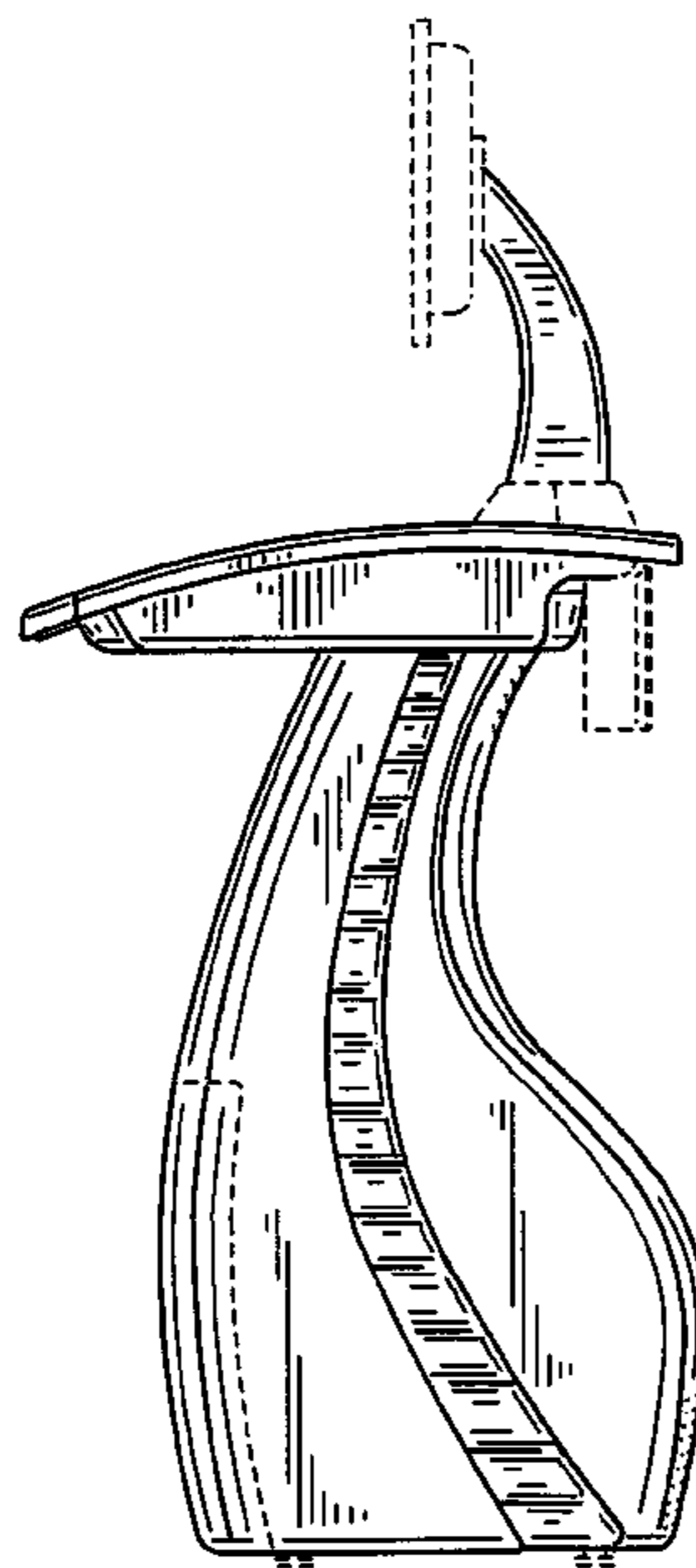
FIG. 6 is a bottom plan view of the workstation of FIG. 1.

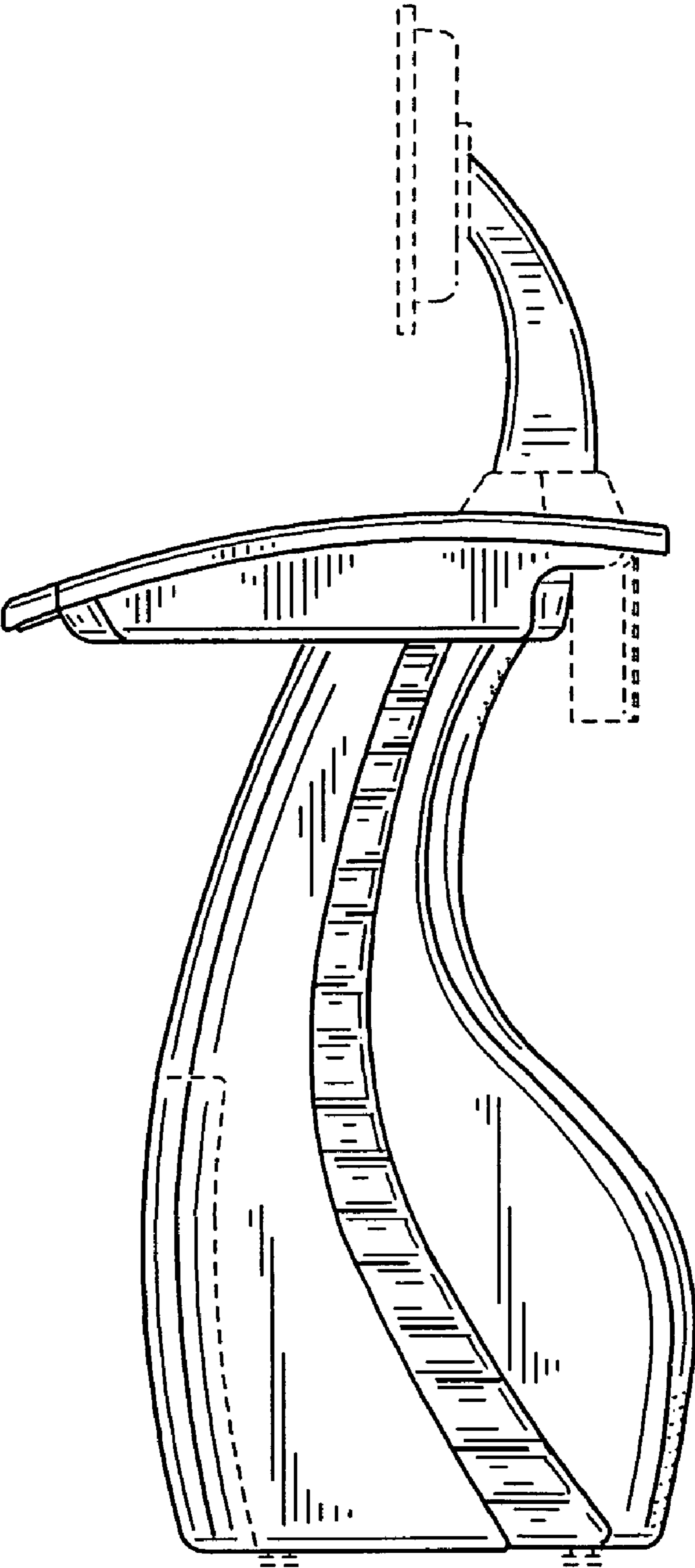

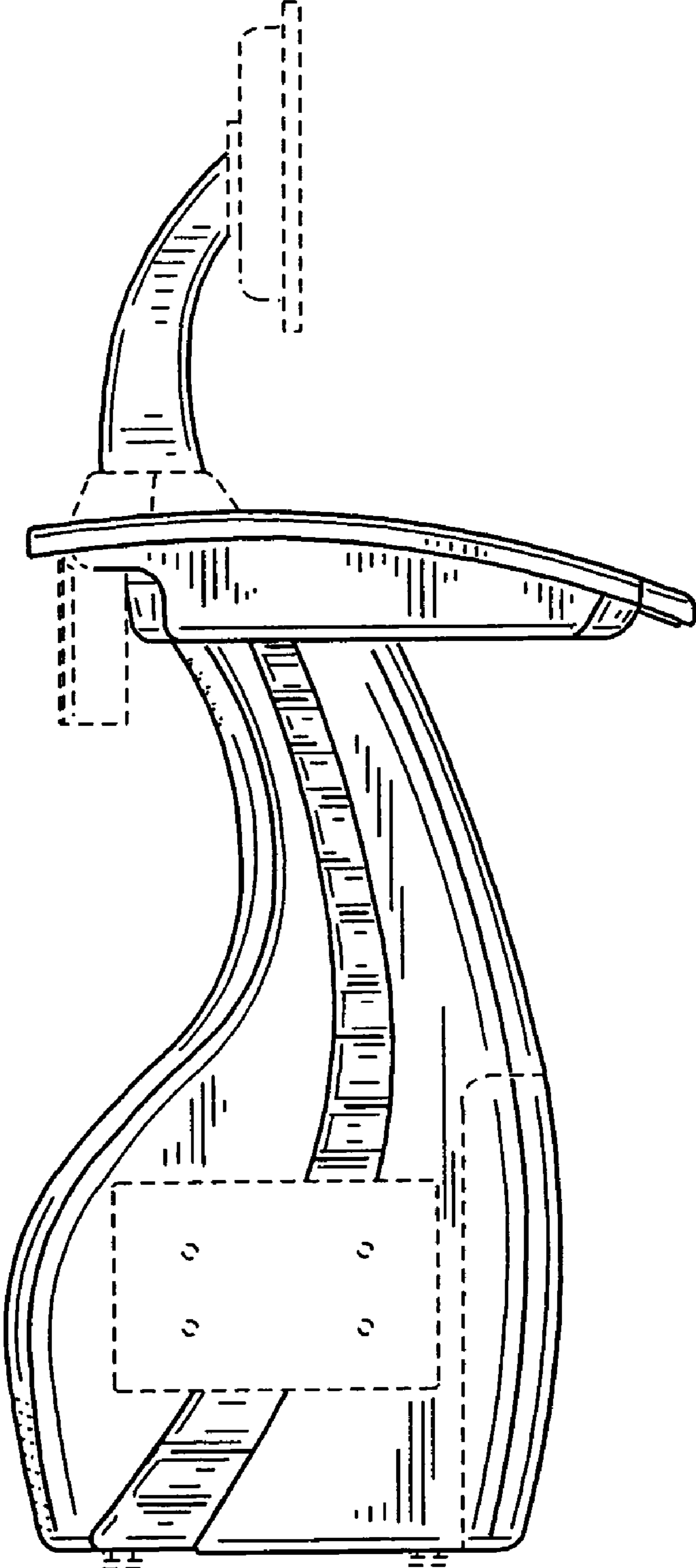

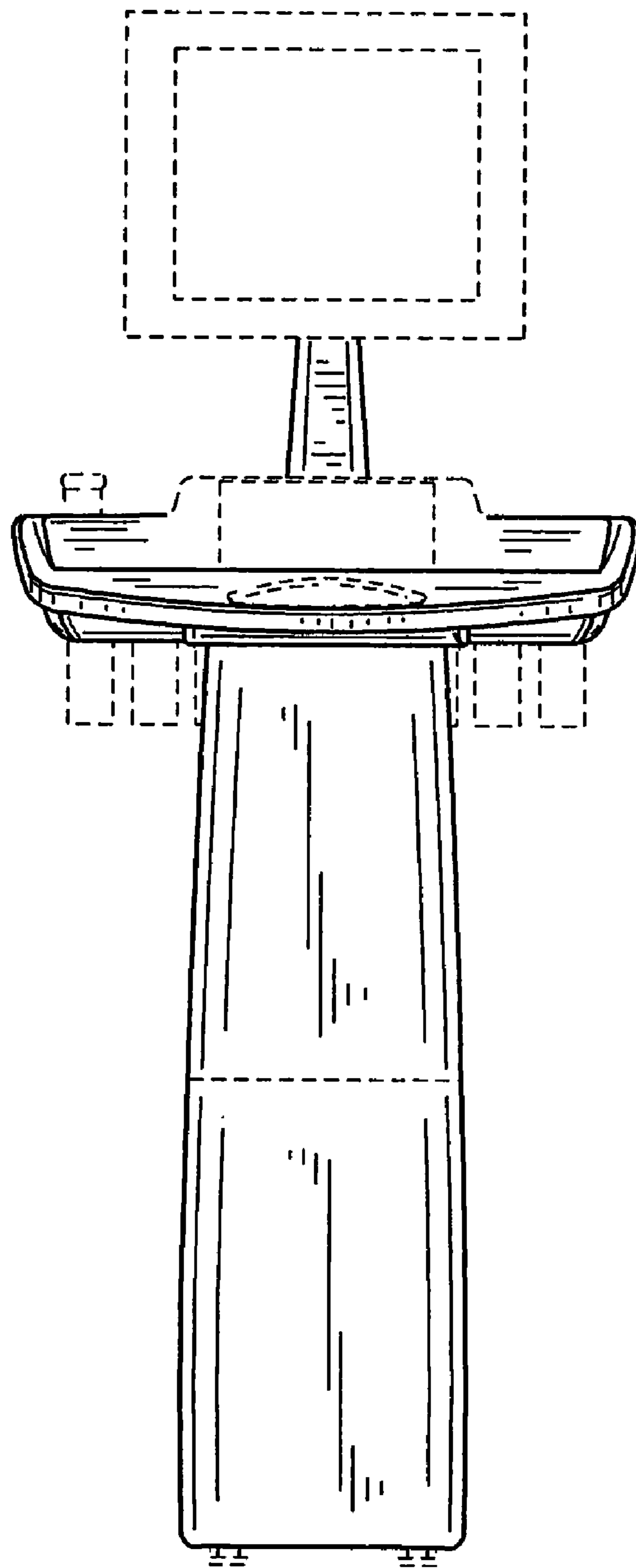

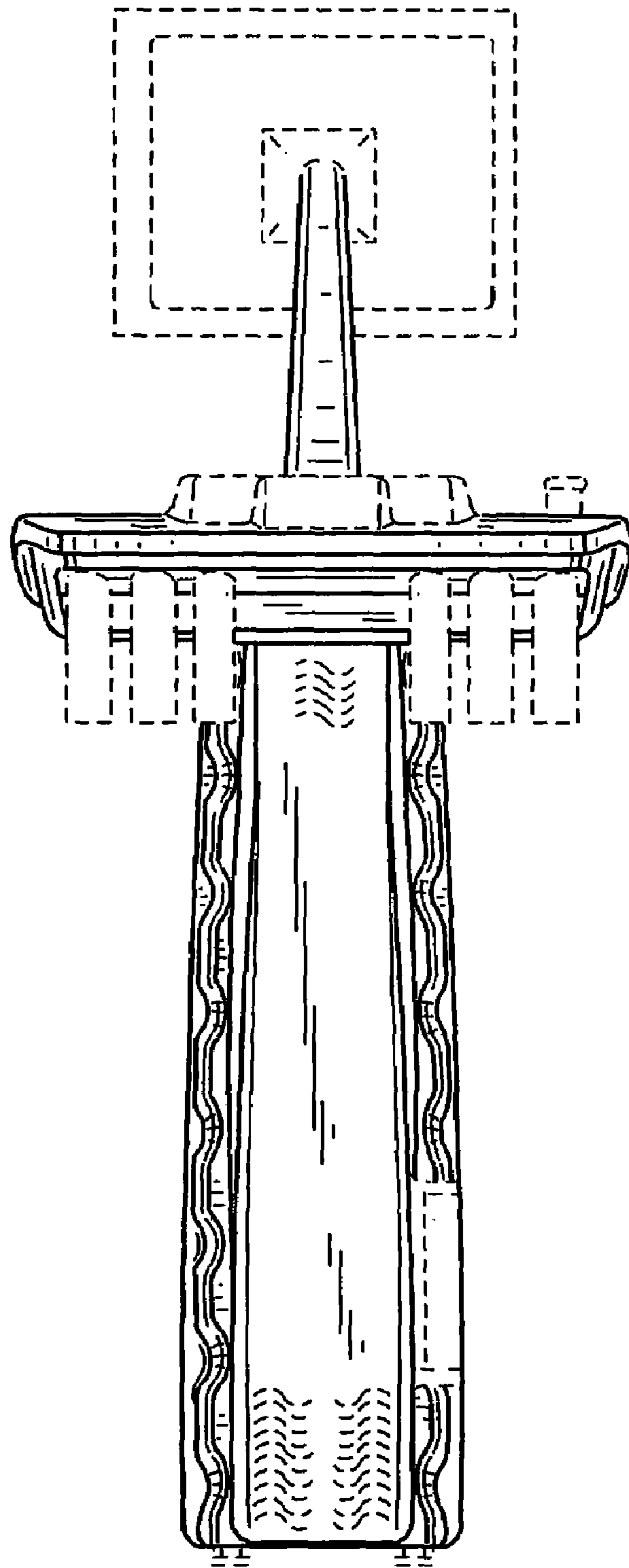

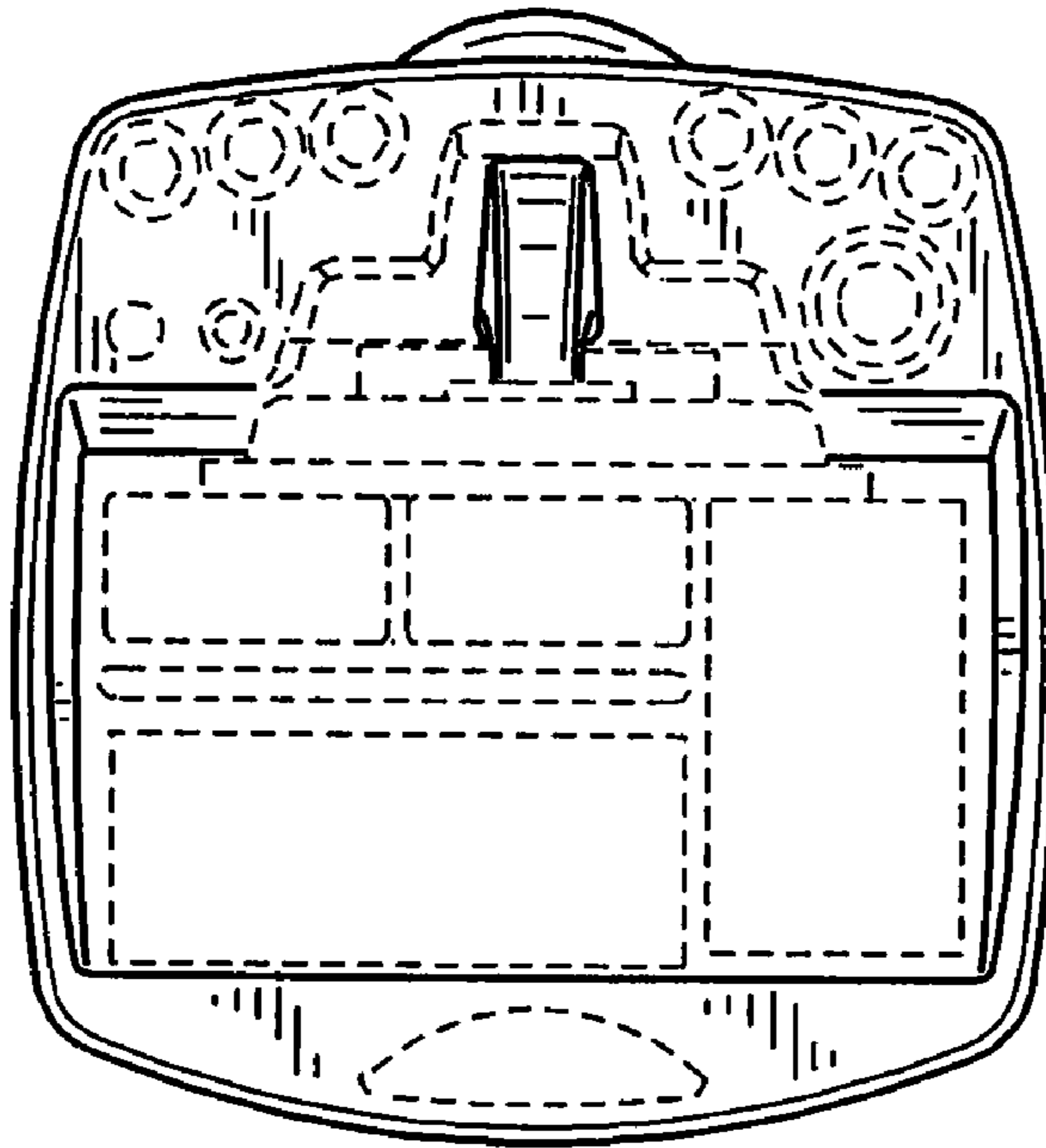
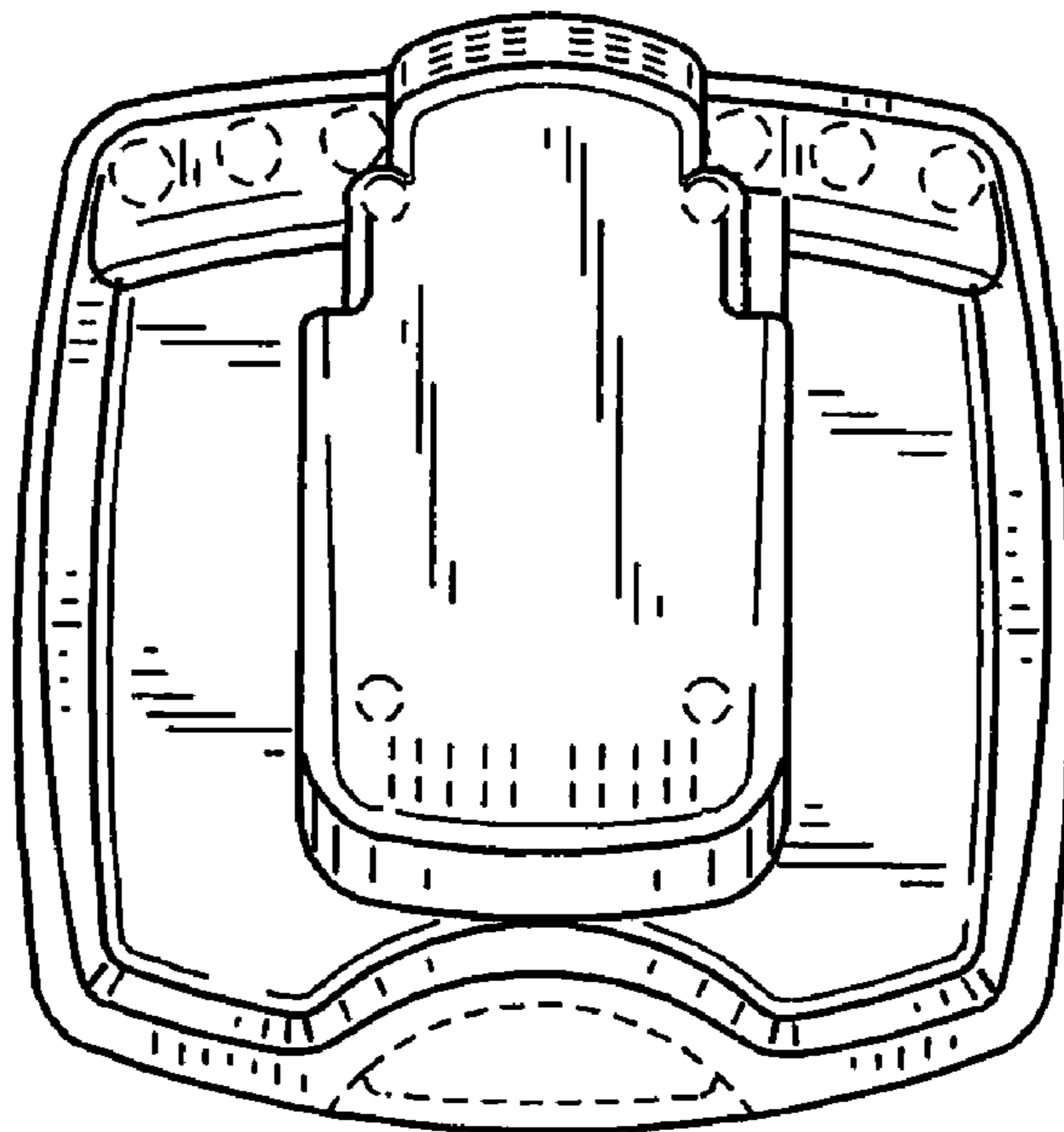

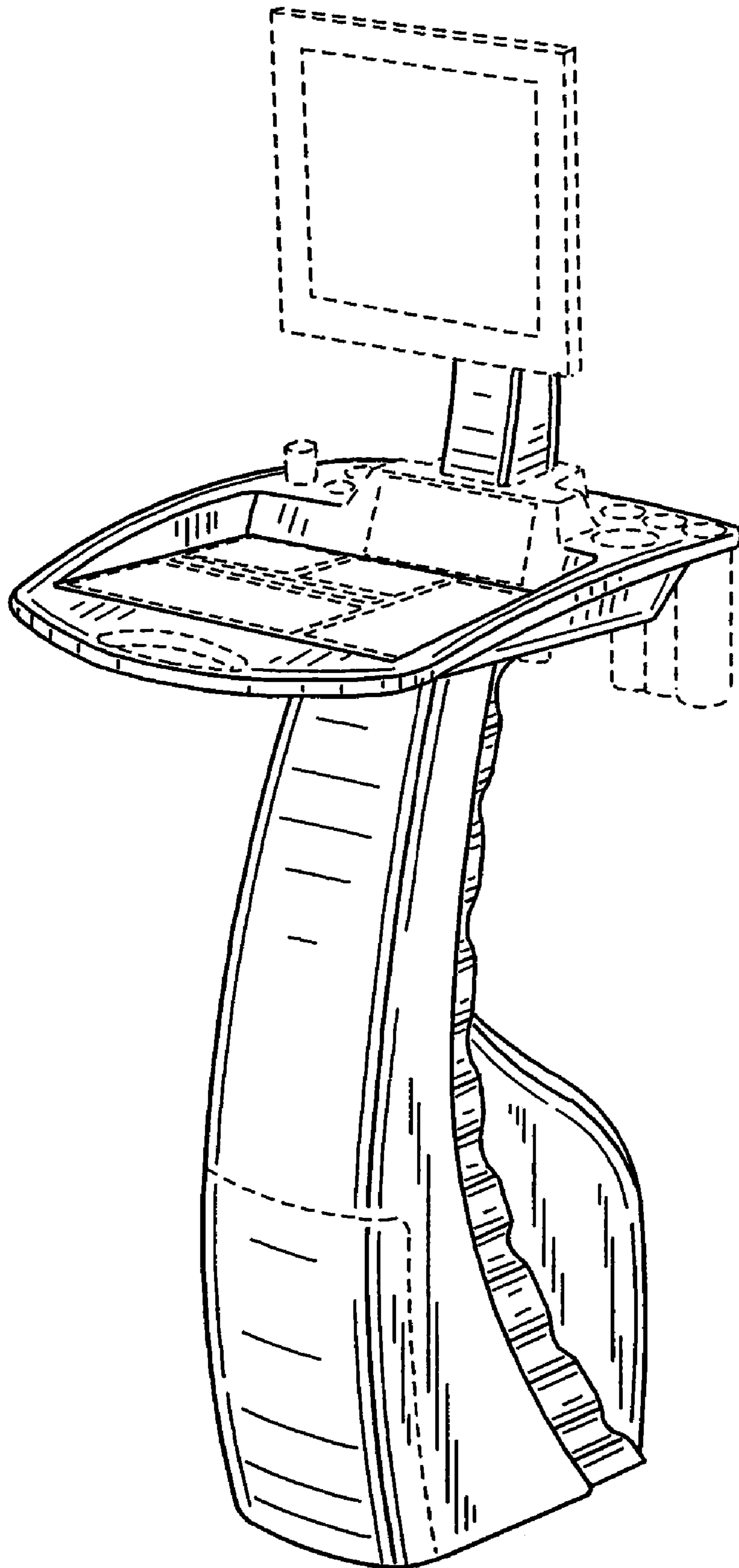

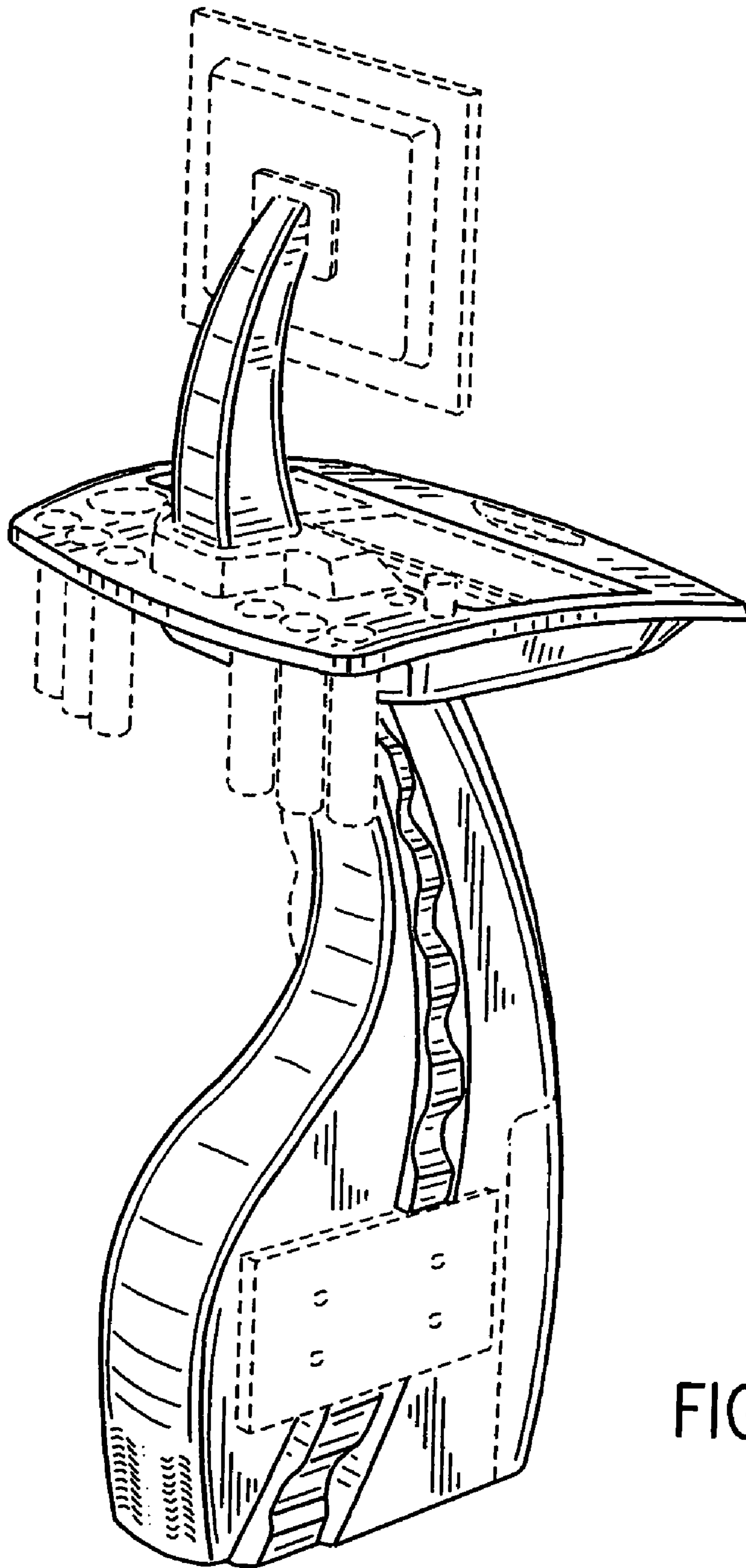
