FIG. 2 is a top view of the microwave cooking accessory of the present invention;

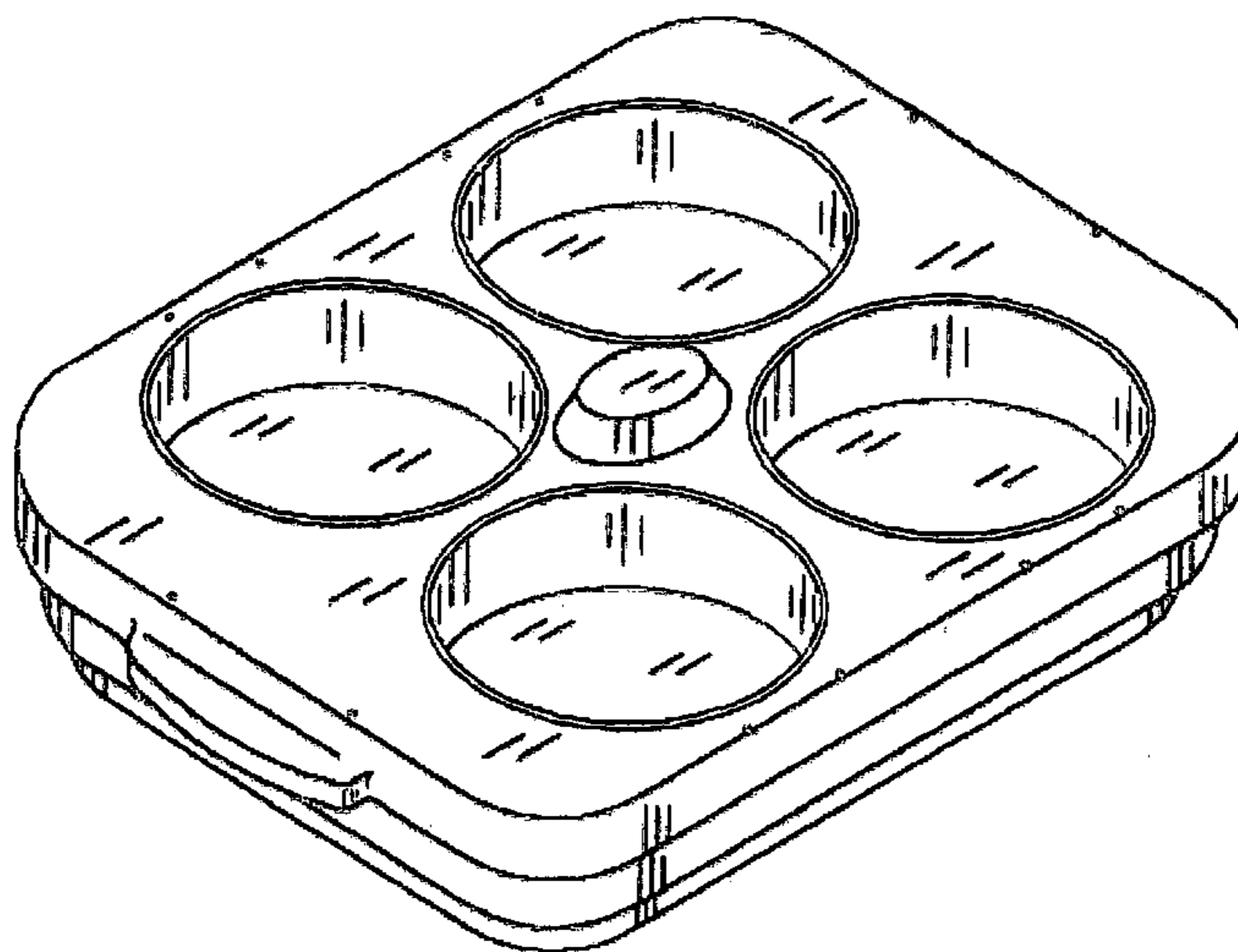
FIG. 3 is a side view of the microwave cooking accessory of the present invention;

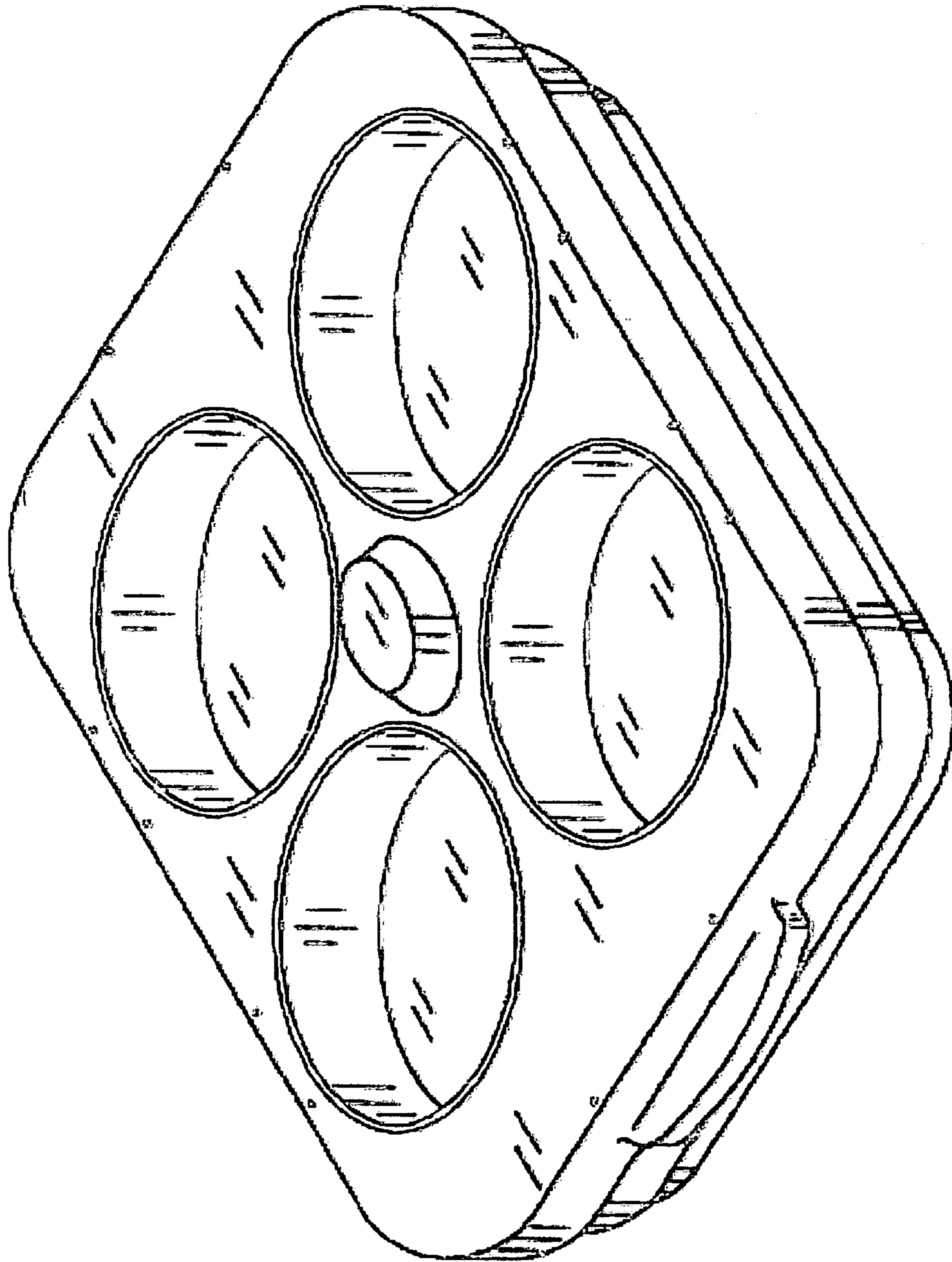

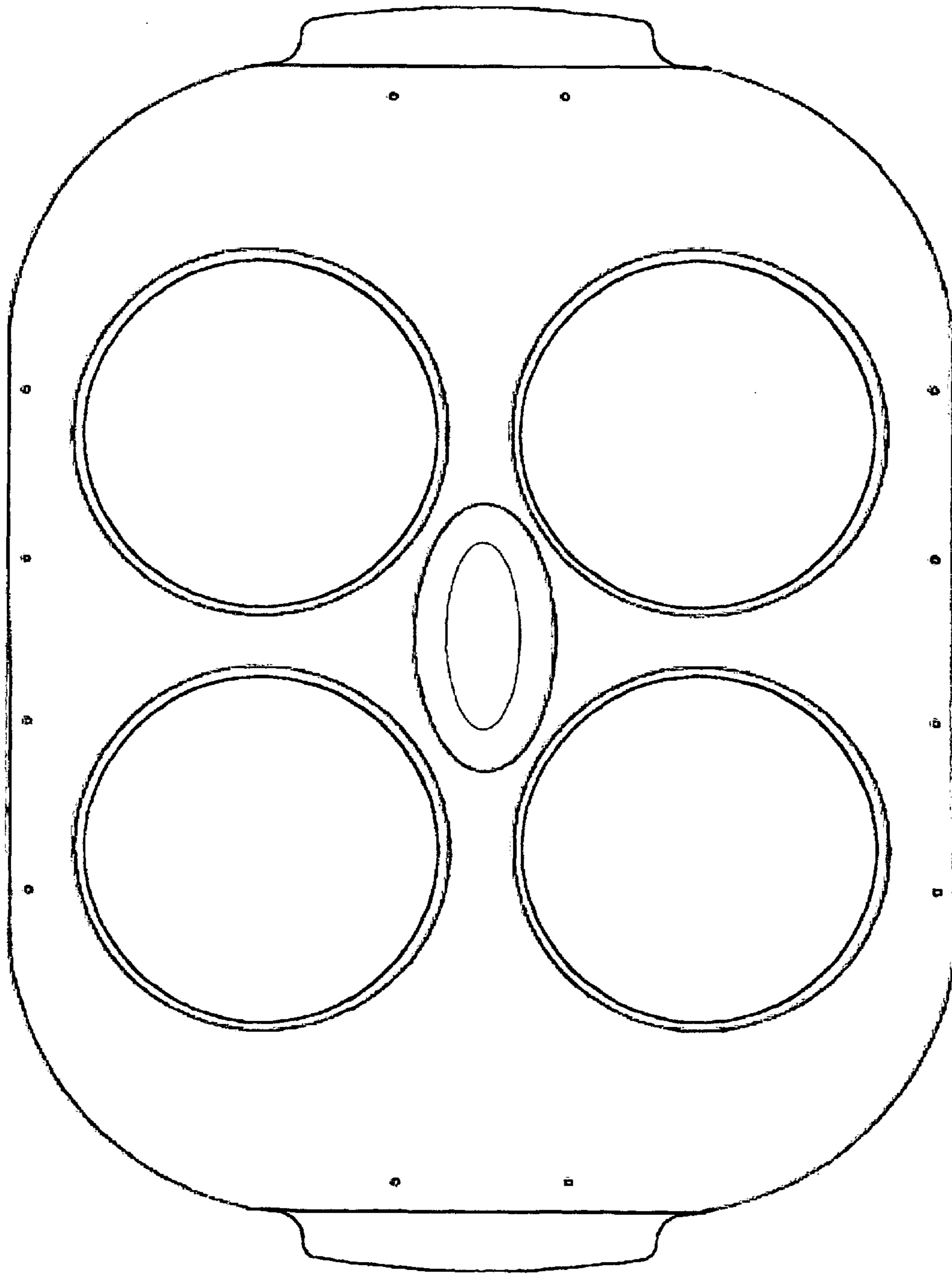

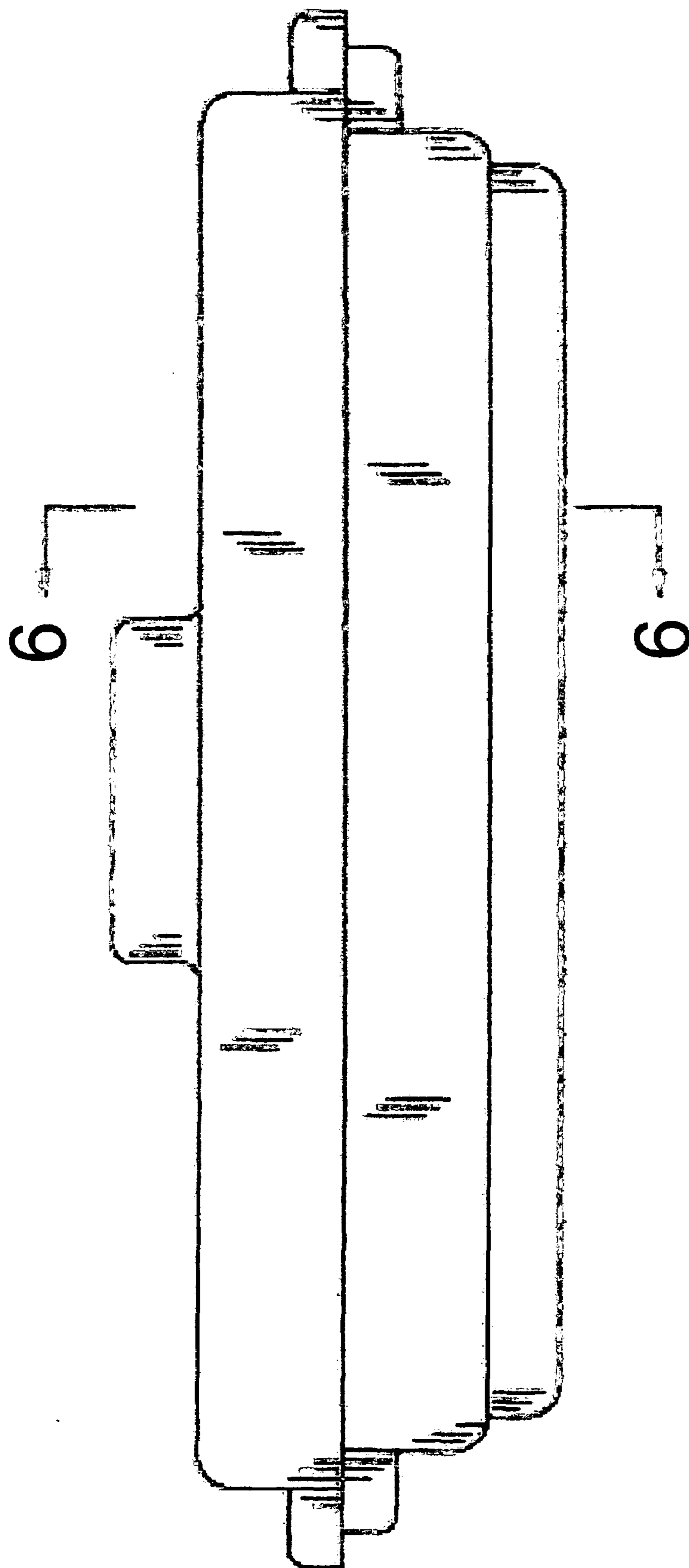

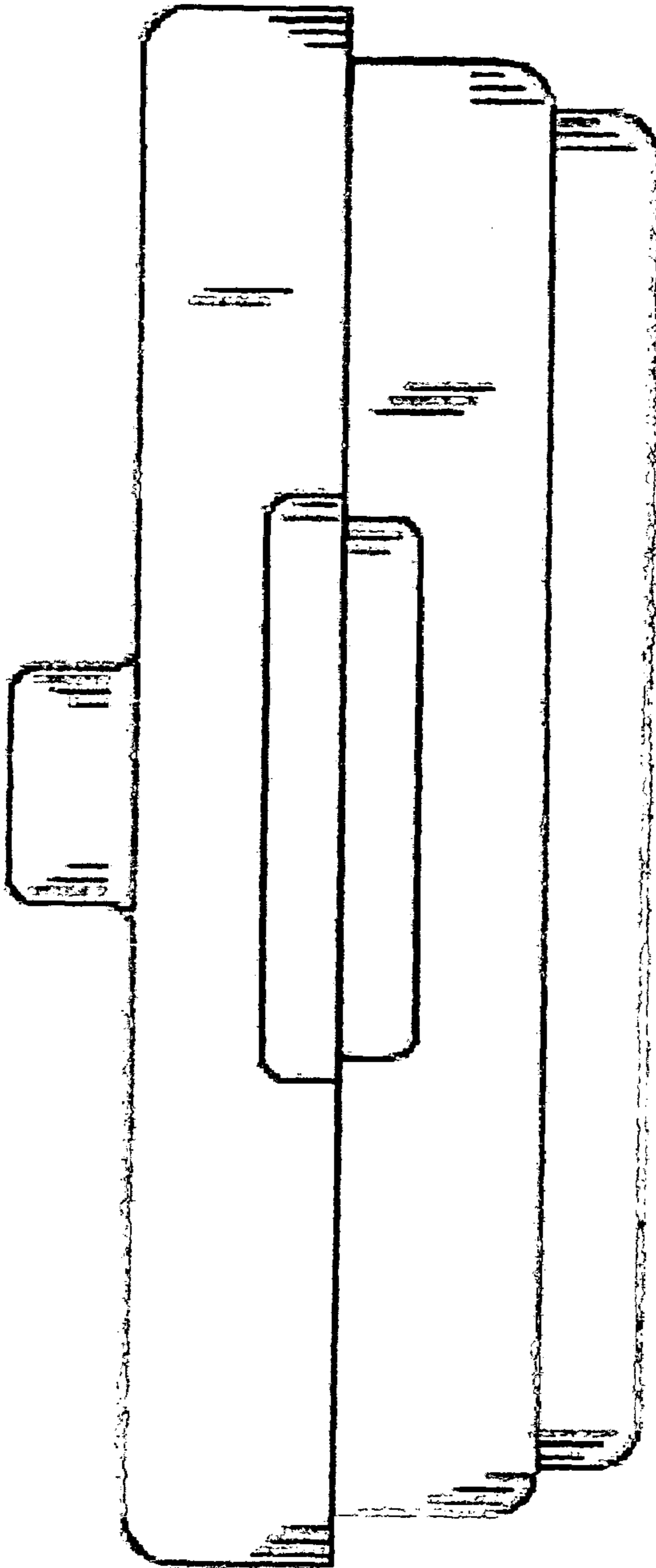

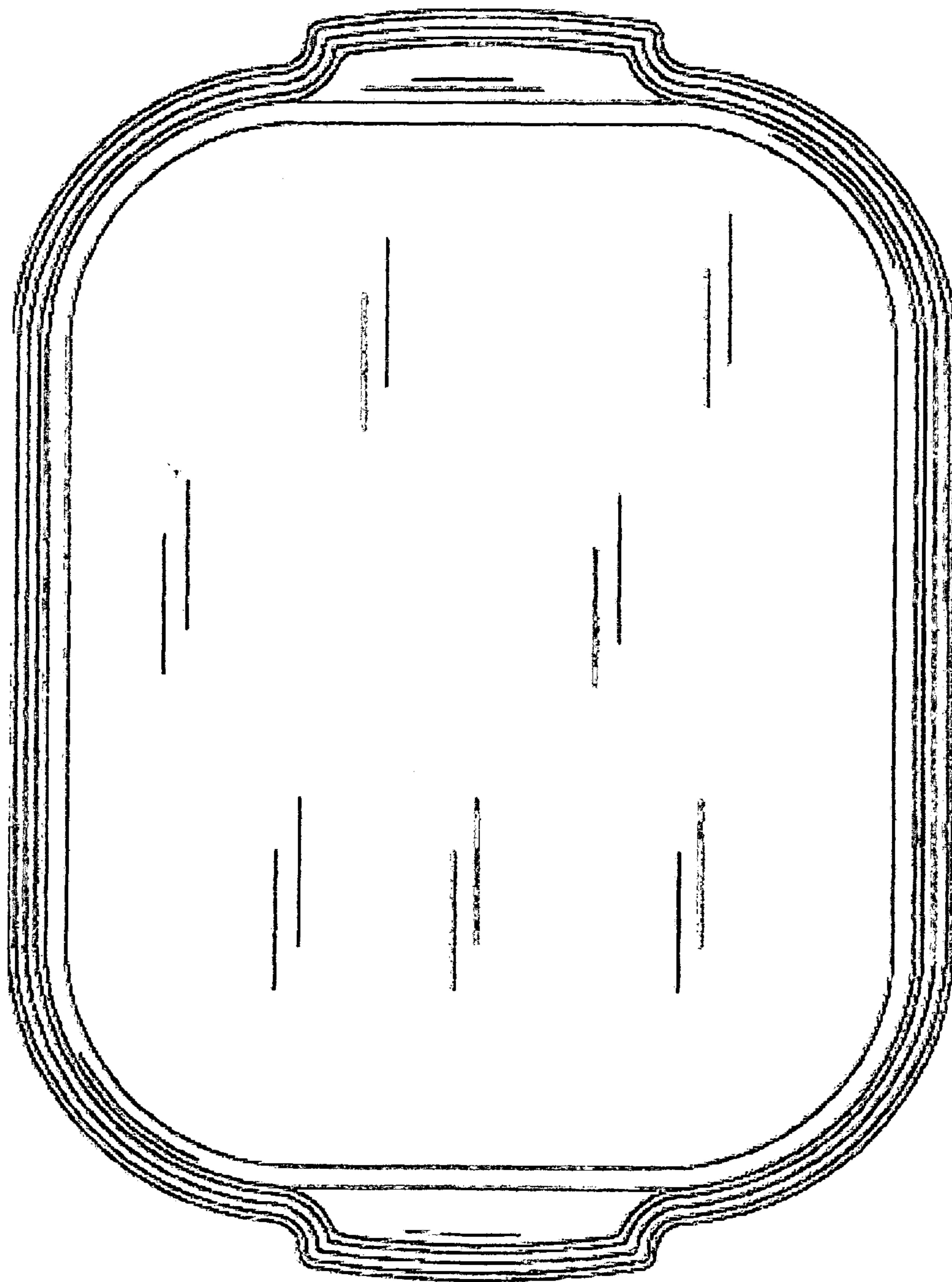

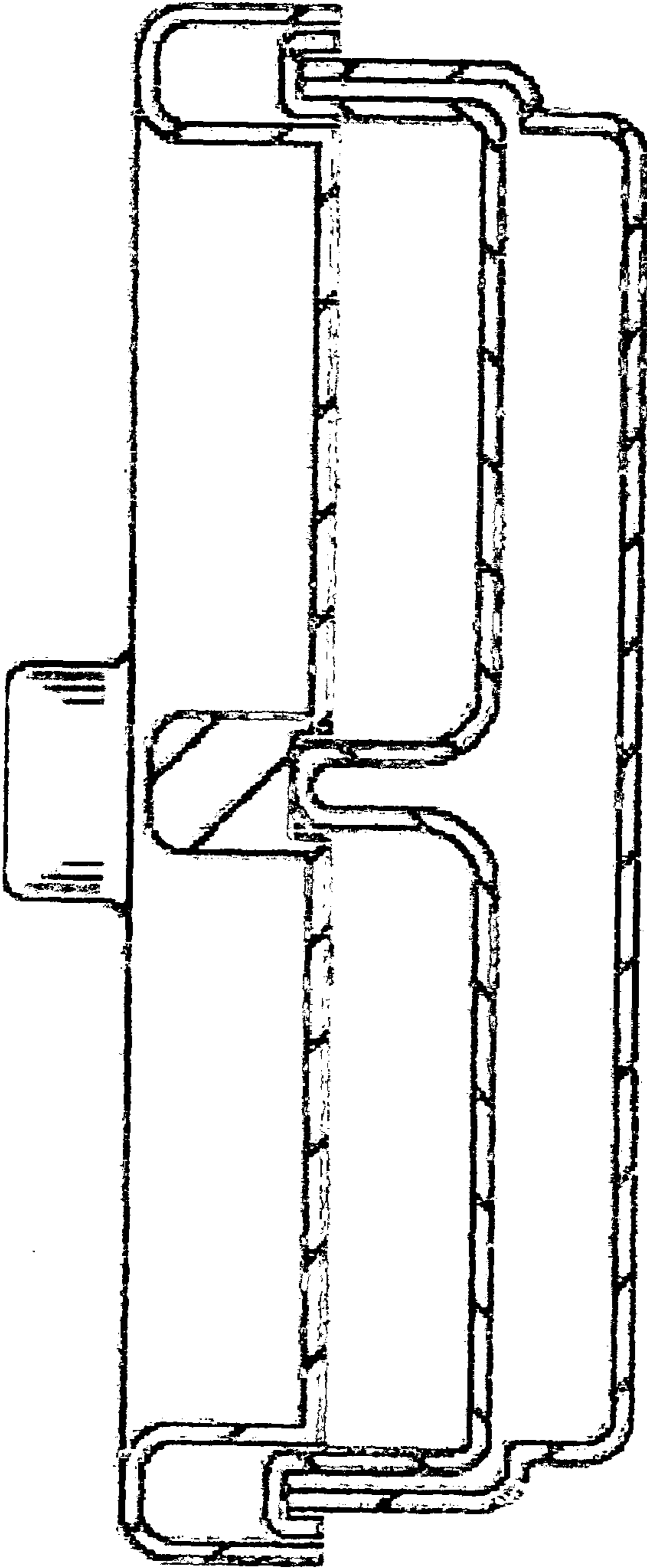
