FIG. 3 is a right side elevation view of FIG. 2.

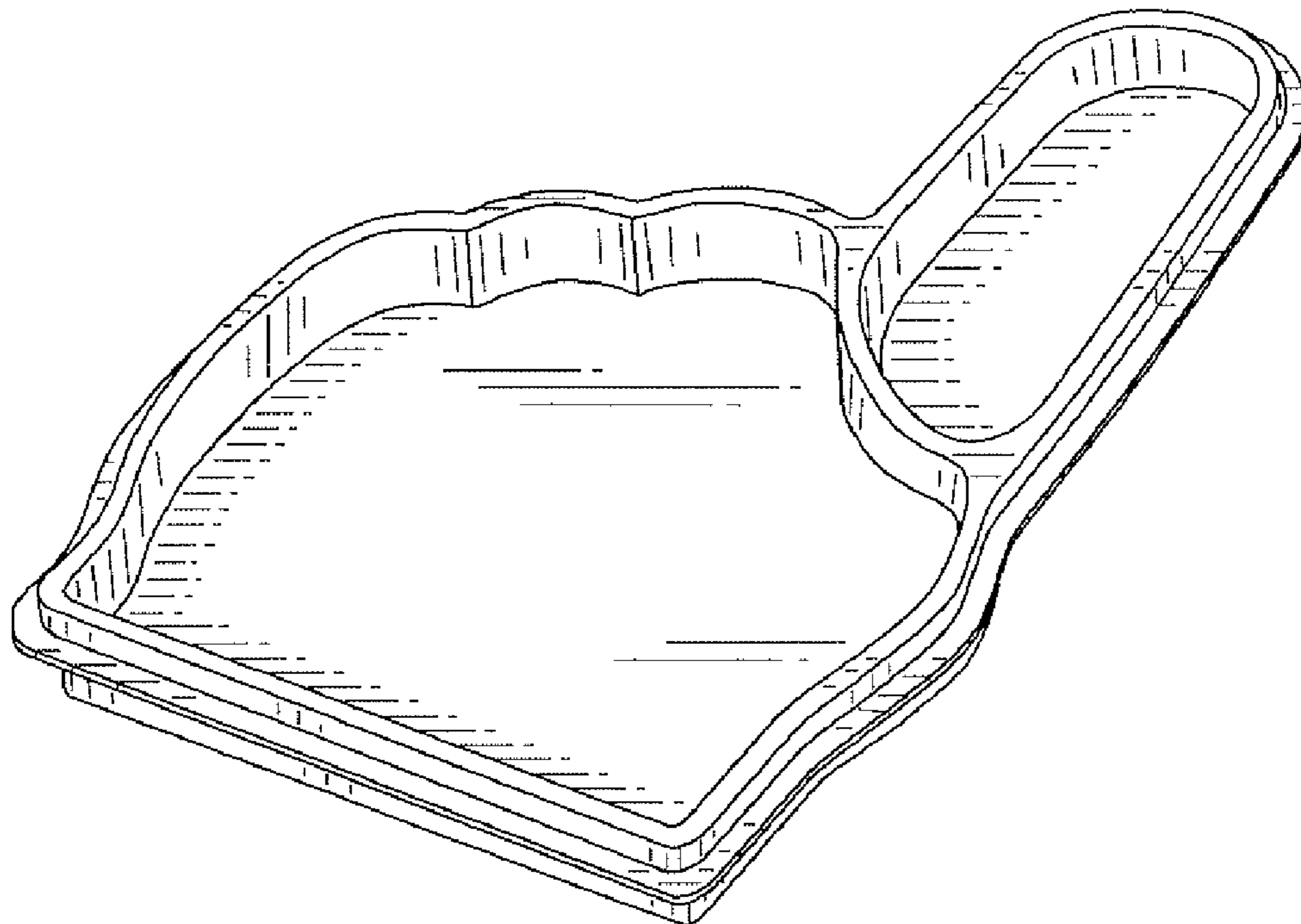
FIG. 4 is a front elevation view of FIG. 2.

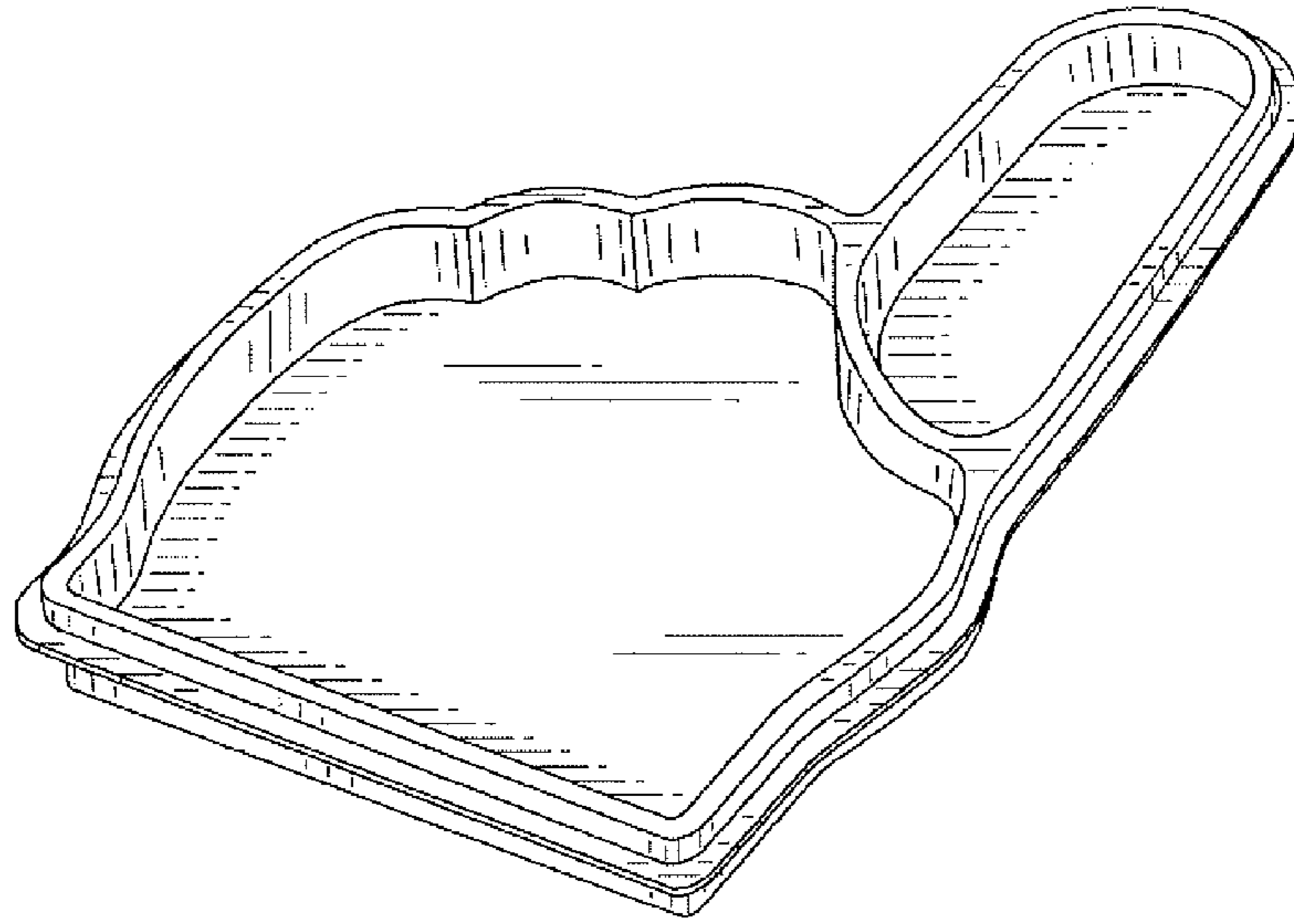

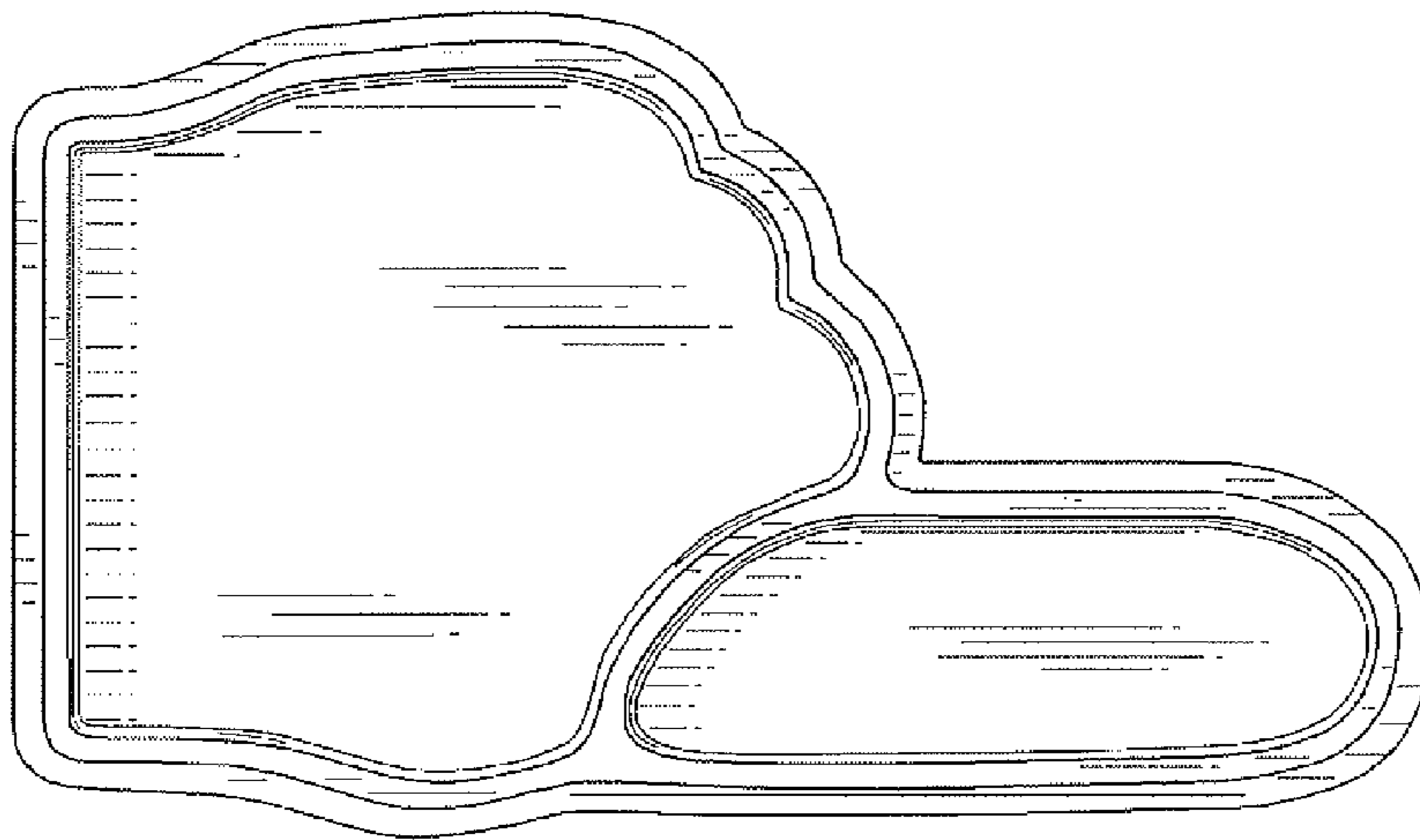

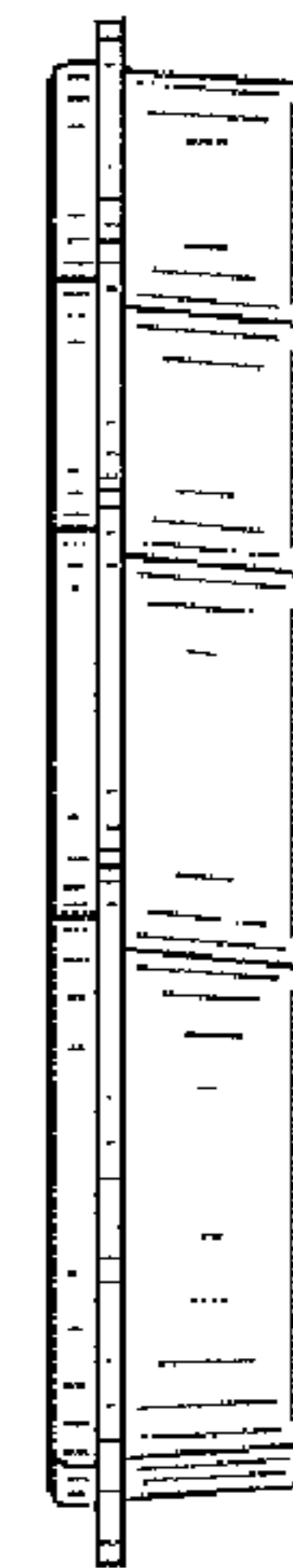

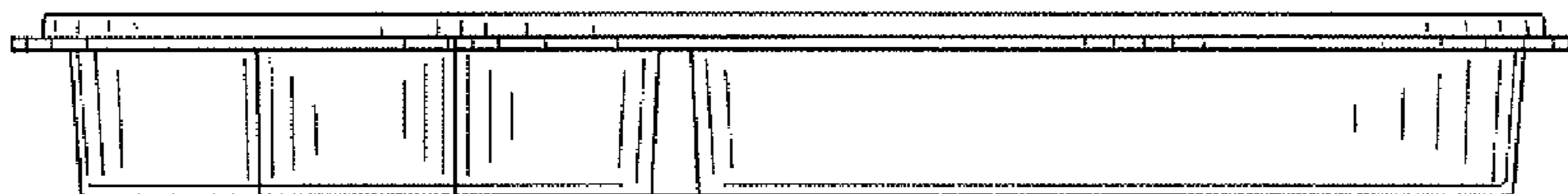

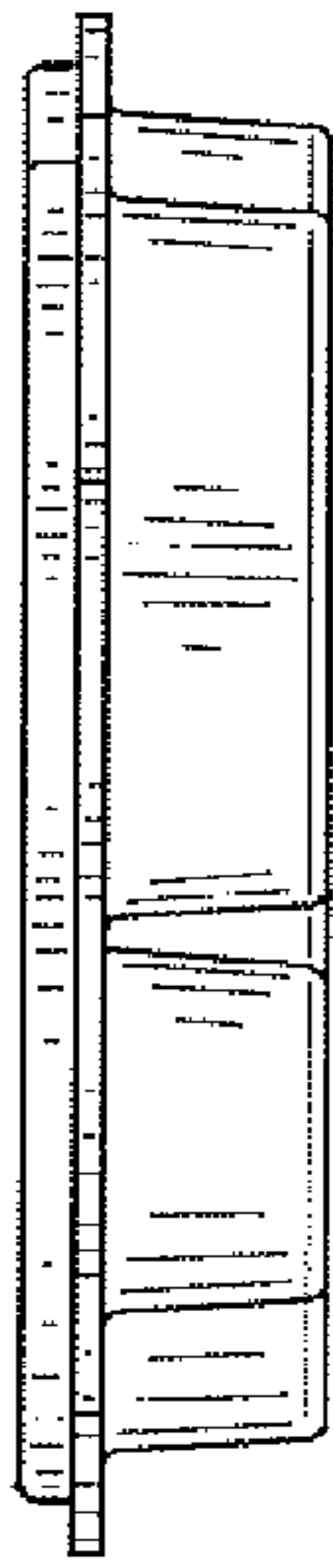

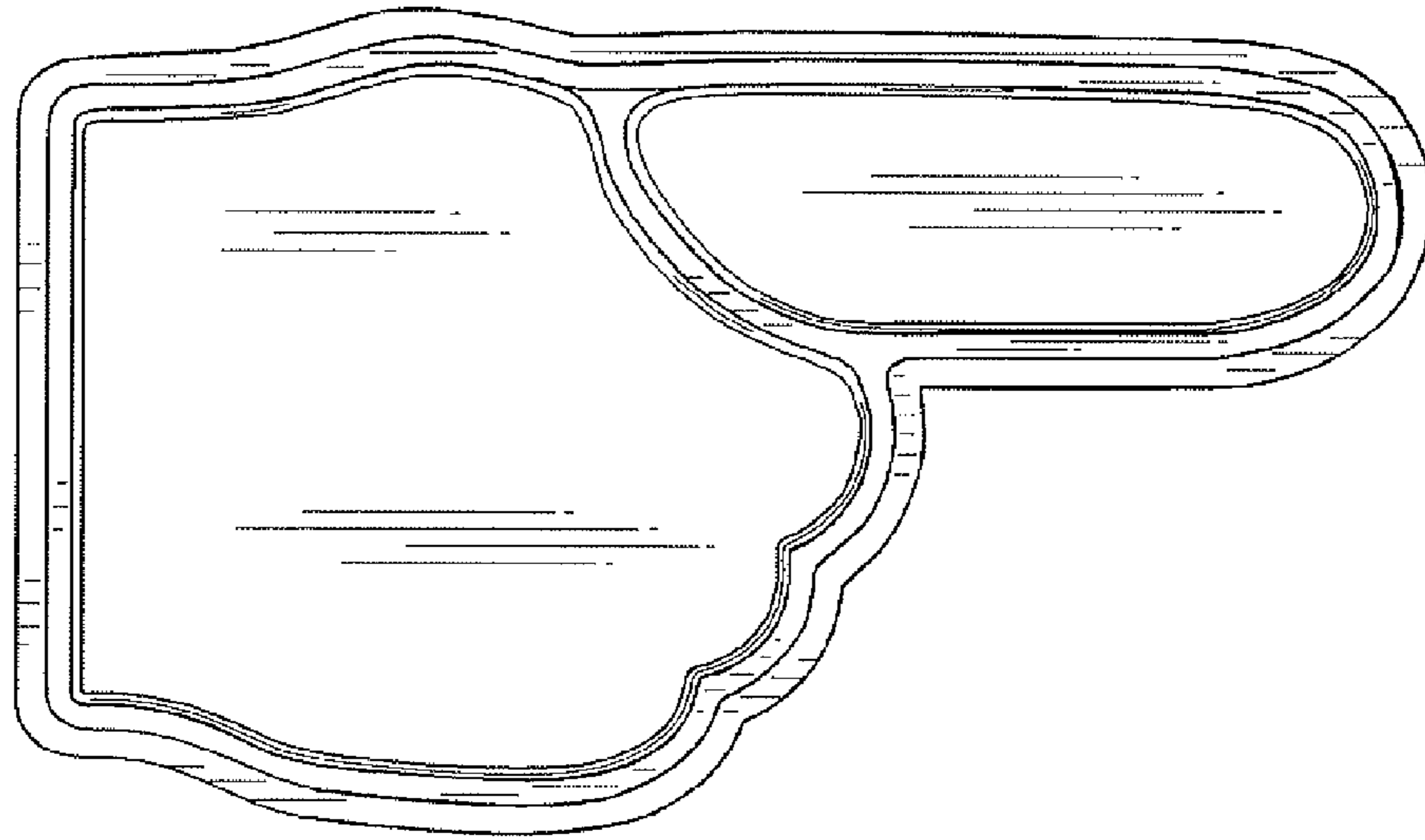

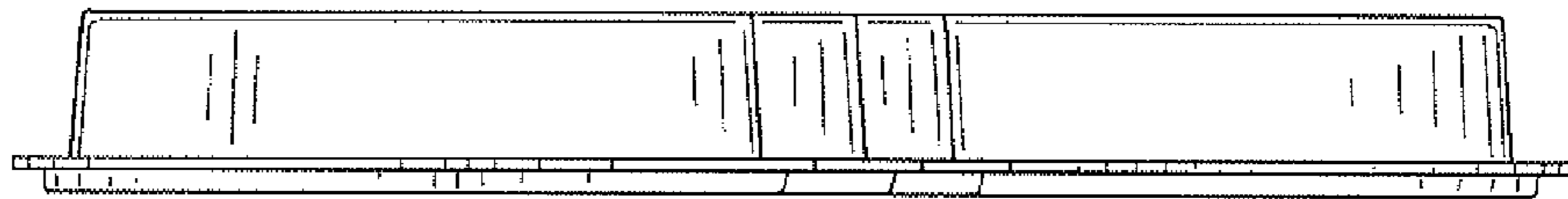
