FIG. 1 is a perspective view of a plant acclimatizing enclosure;

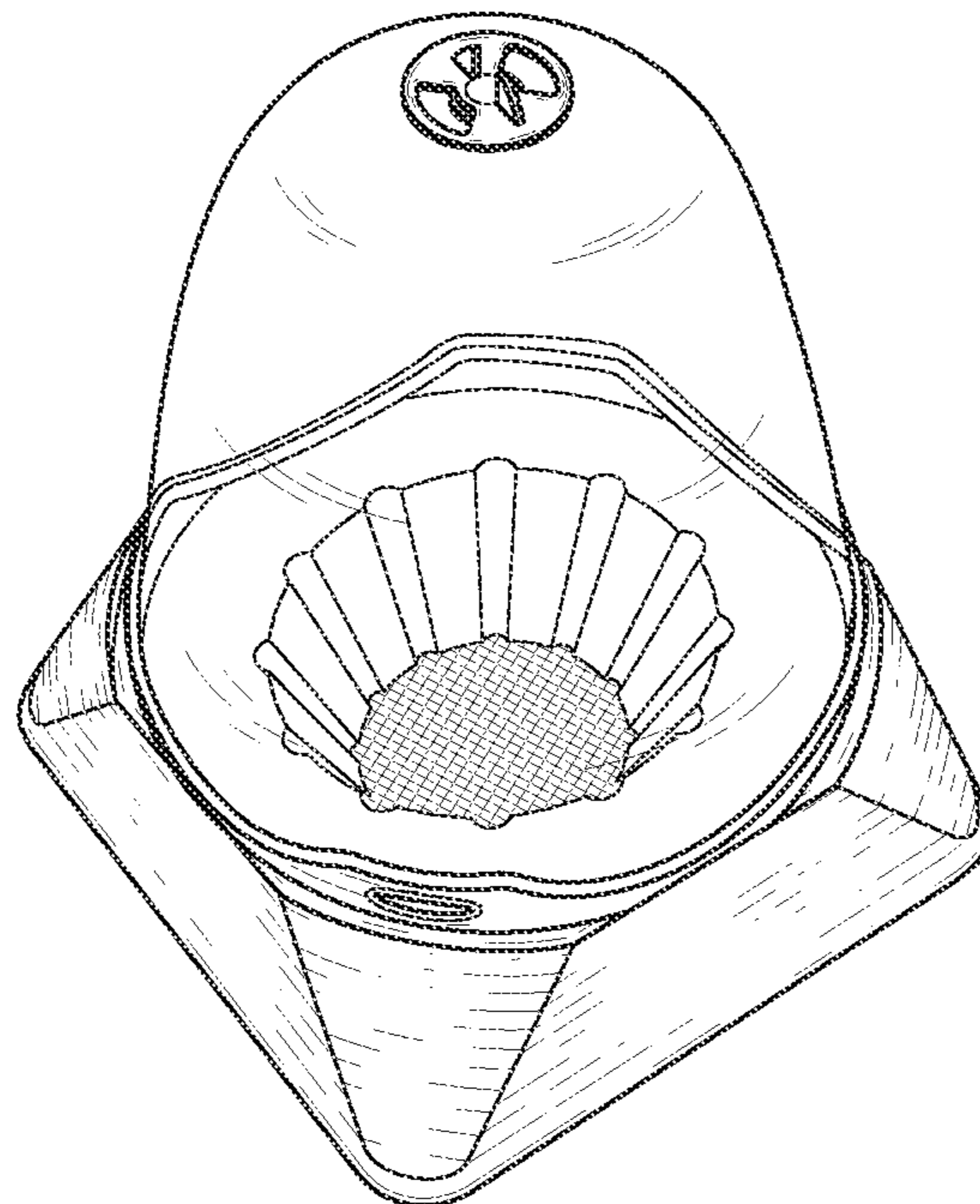
FIG. 2 is a top view thereof, shown with the top portion removed in order to better illustrate the internal design;

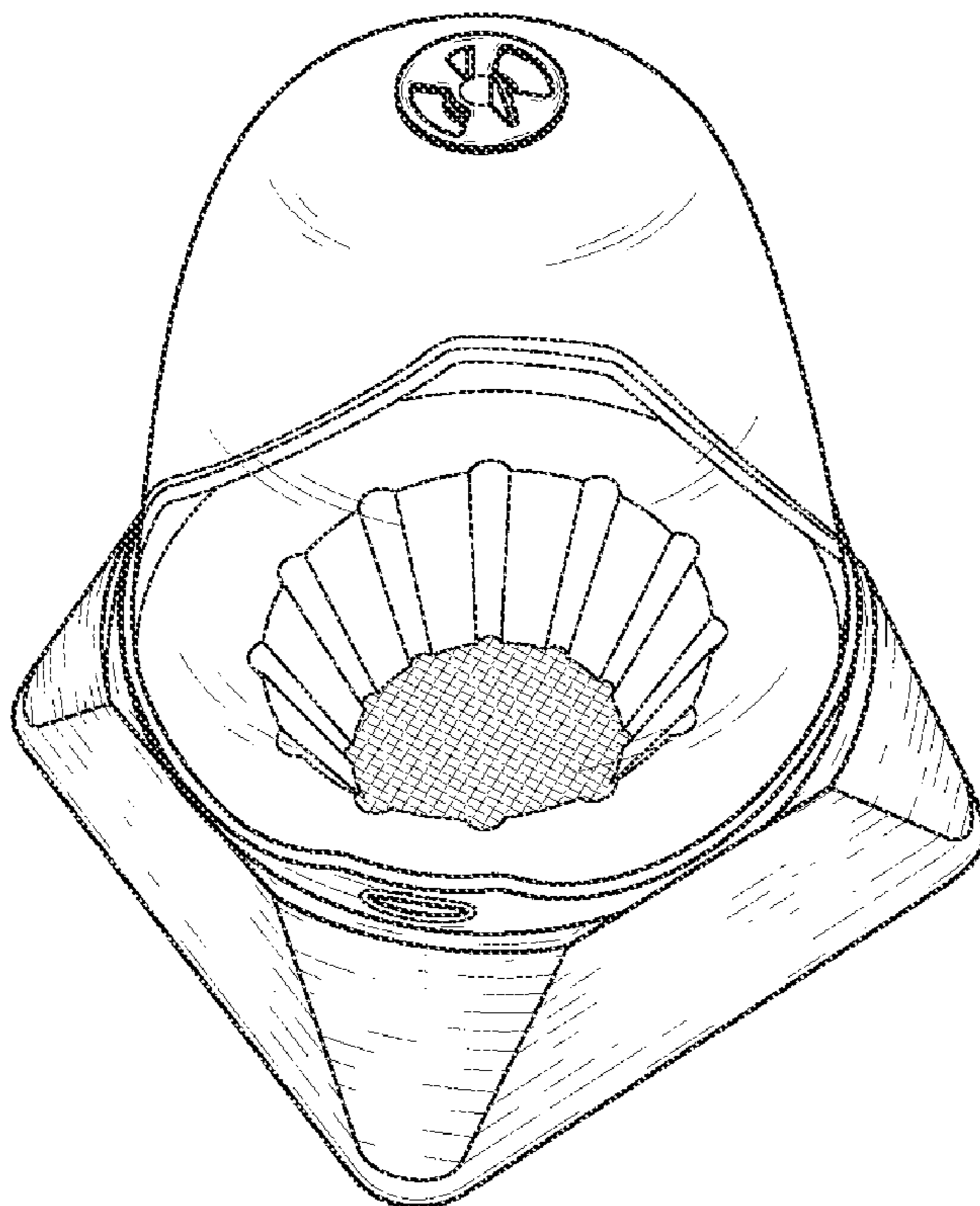

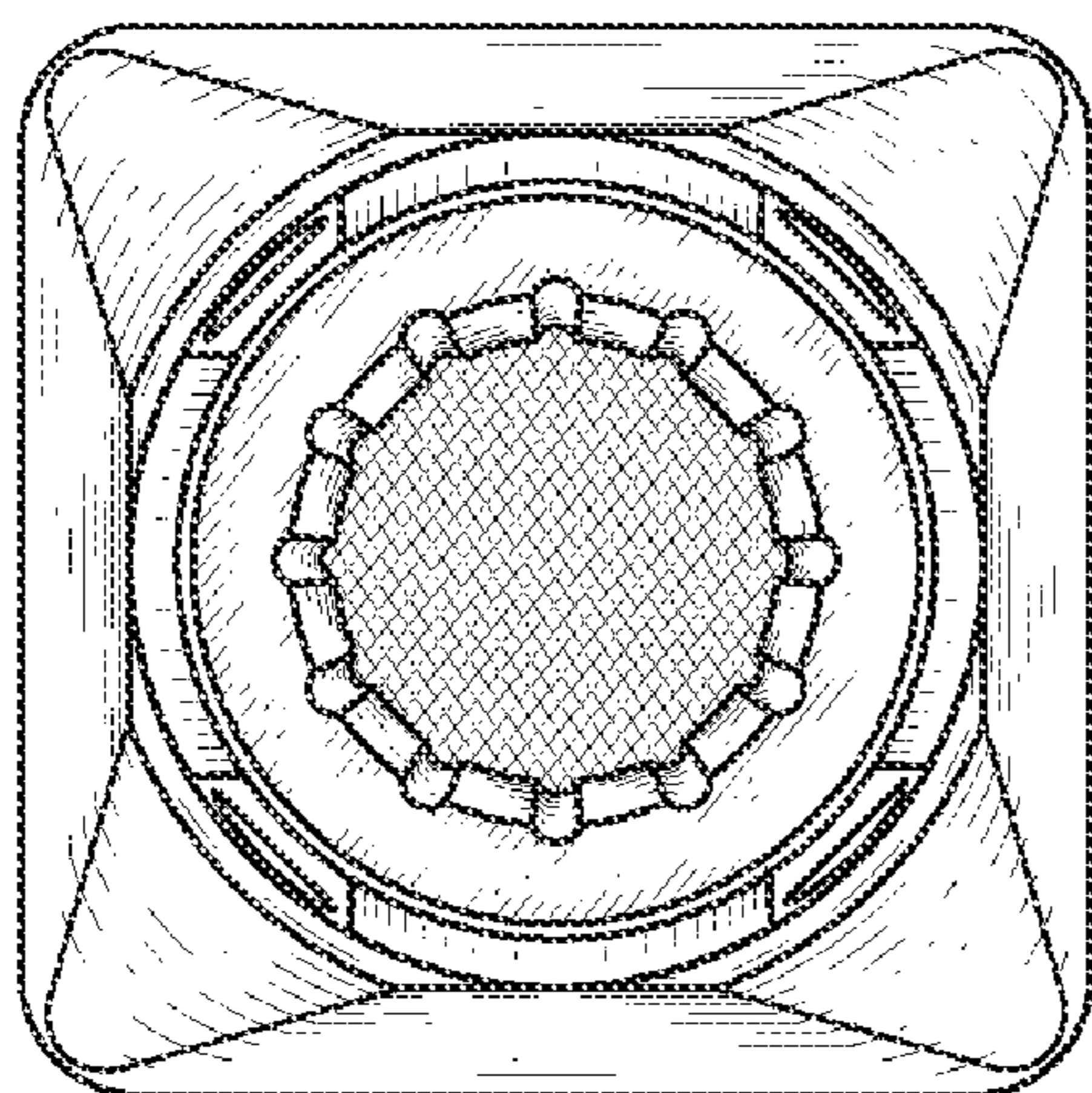

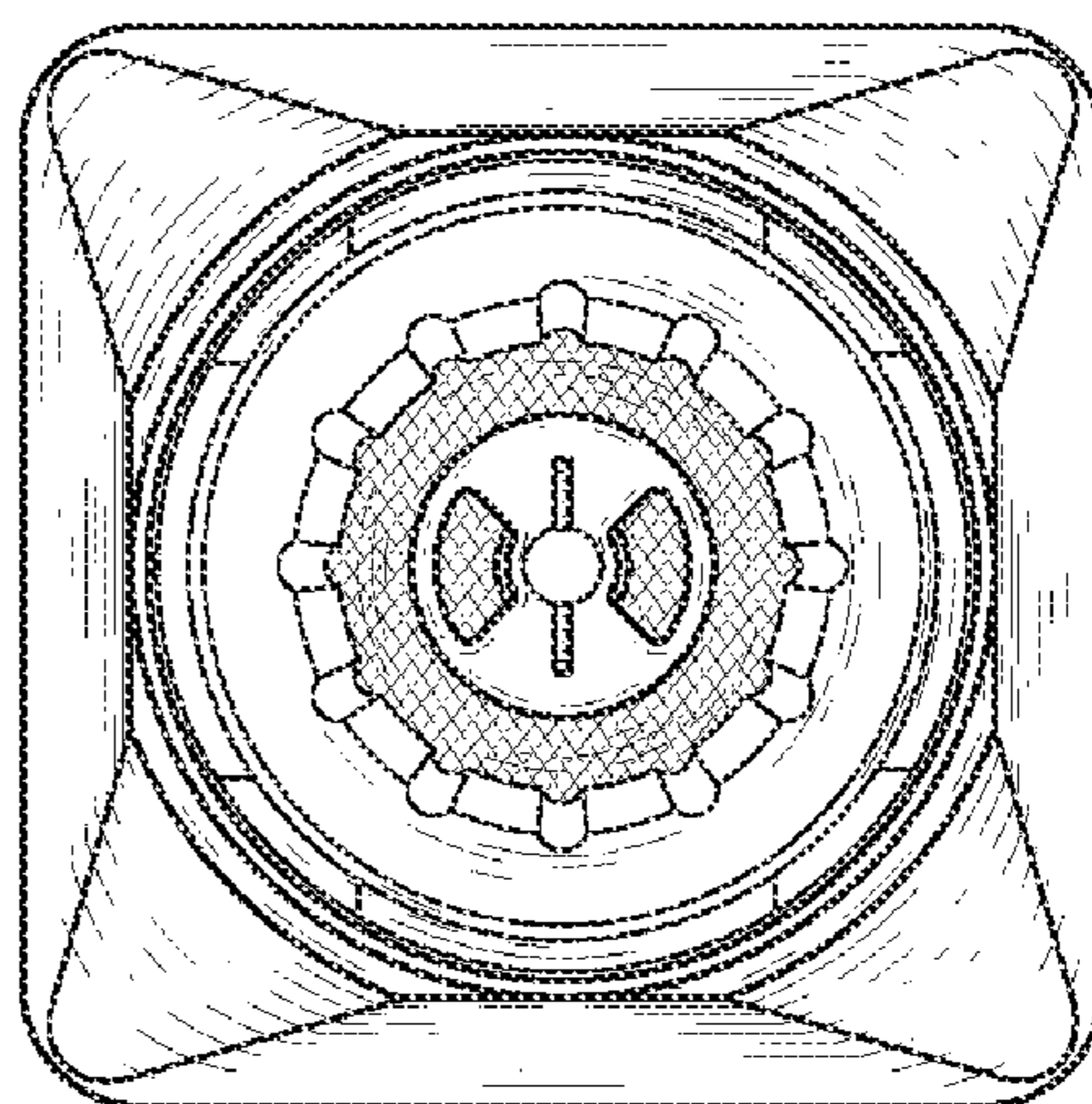

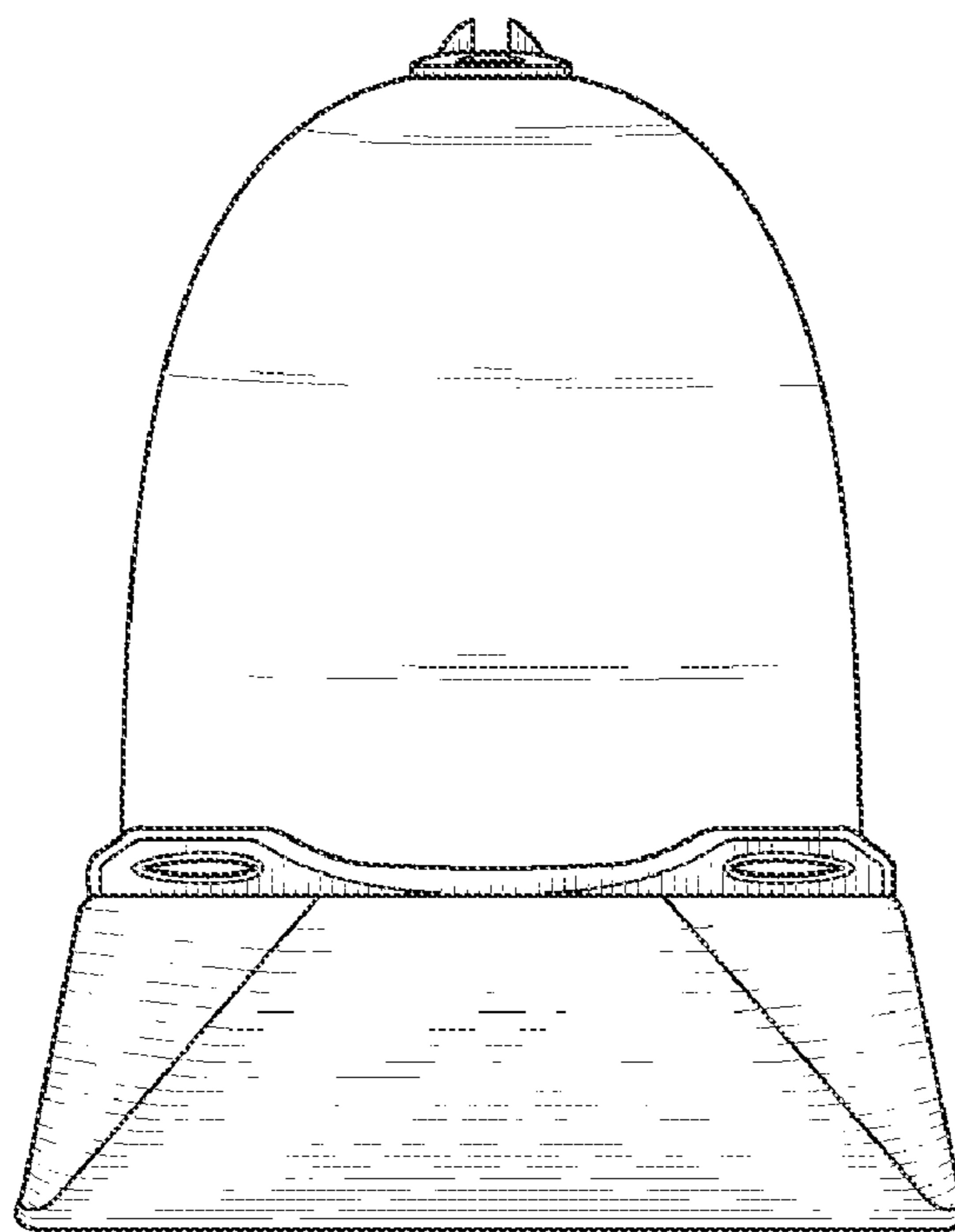

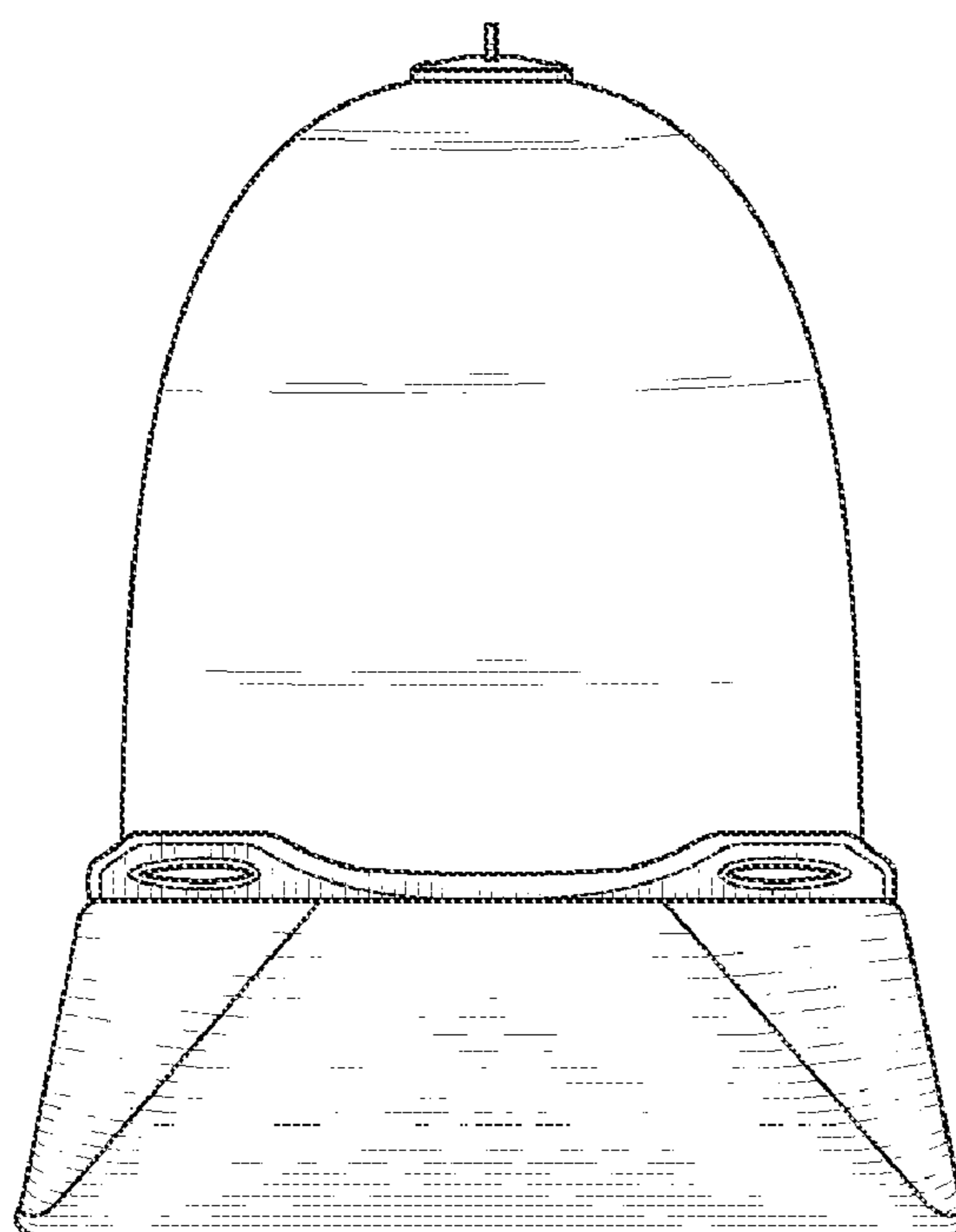
