(57) **CLAIM**

The ornamental design for an illuminated brake lever for a motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of an illuminated brake lever for a motorcycle, which has a lighting portion extending along its front and left sides.

FIG. 2 is a top side view of the illuminated brake lever for a motorcycle of FIG. 1 shown in position of use on a motorcycle, which is shown in broken lines and forms no part of the claimed design.

FIG. 3 is a front side view of the illuminated brake lever for a motorcycle of FIG. 1

FIG. 4 is a back side view of the illuminated brake lever for a motorcycle of FIG. 1.

FIG. 5 is a right side view of the illuminated brake lever for a motorcycle of FIG. 1.

FIG. 6 is a left side view of the illuminated brake lever for a motorcycle of FIG. 1.

FIG. 7 is an isolated top view of the illuminated brake lever for a motorcycle of FIG. 2; and,

FIG. 8 is a bottom view of the illuminated brake lever for a motorcycle of FIG. 1.

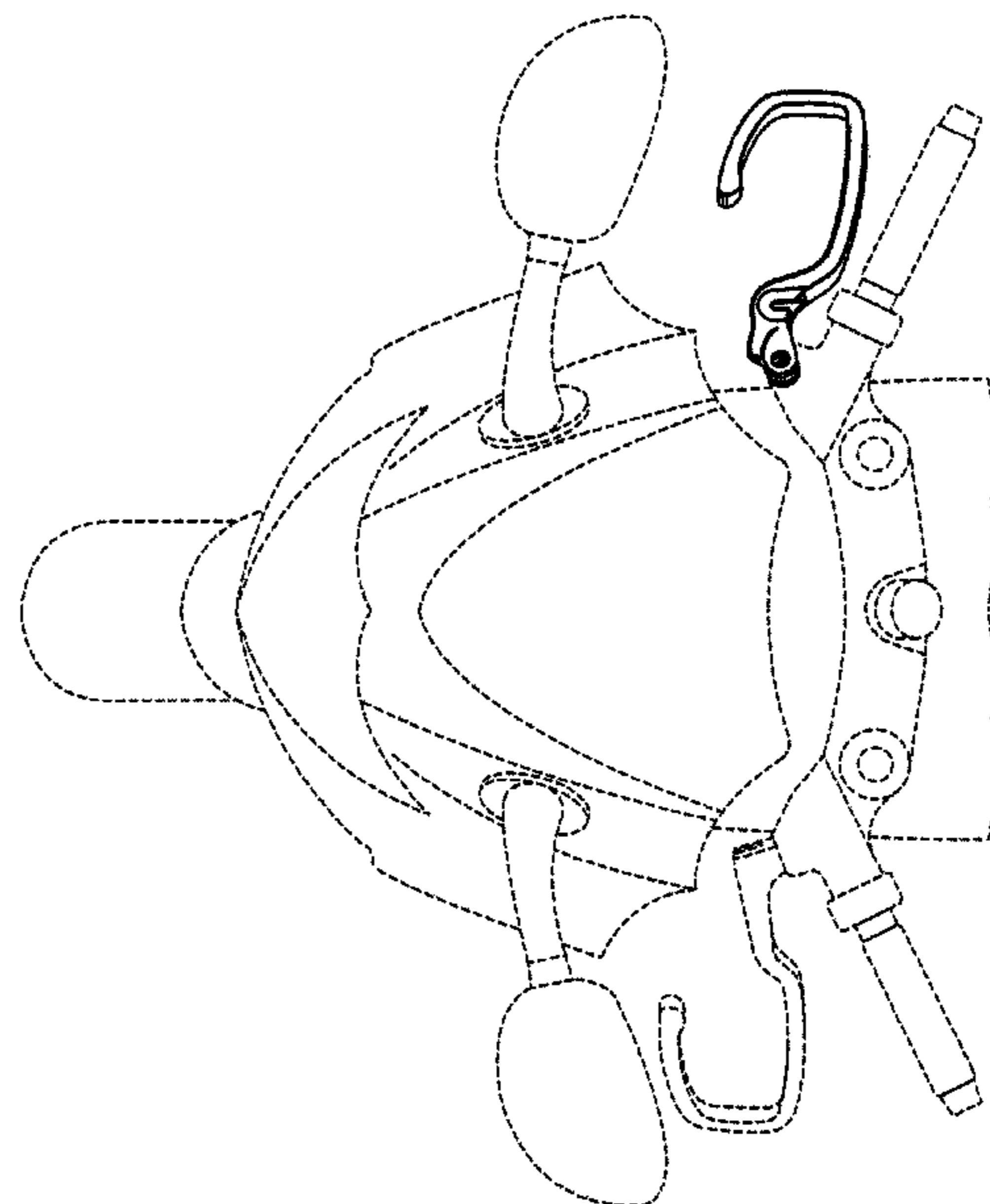
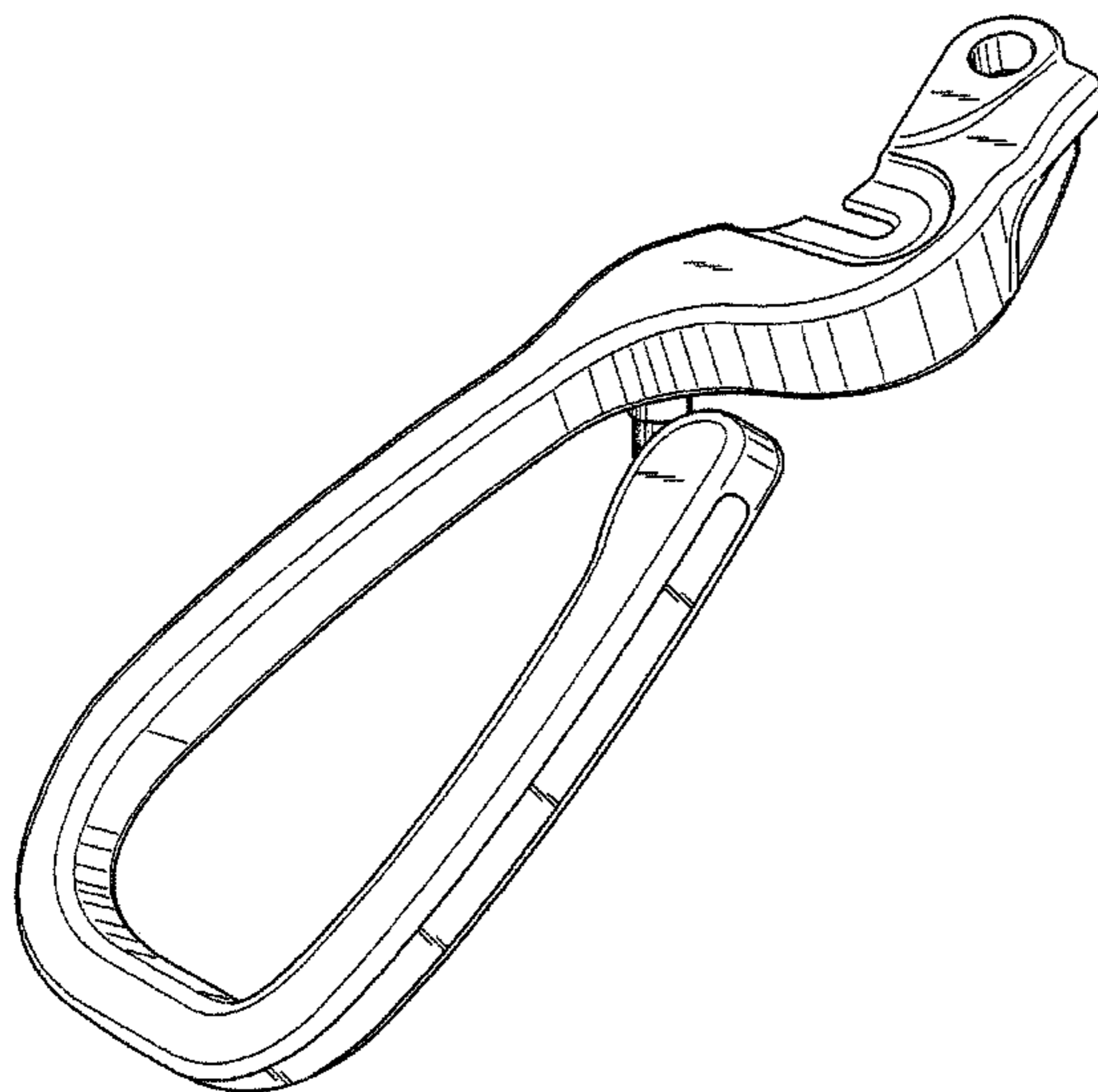
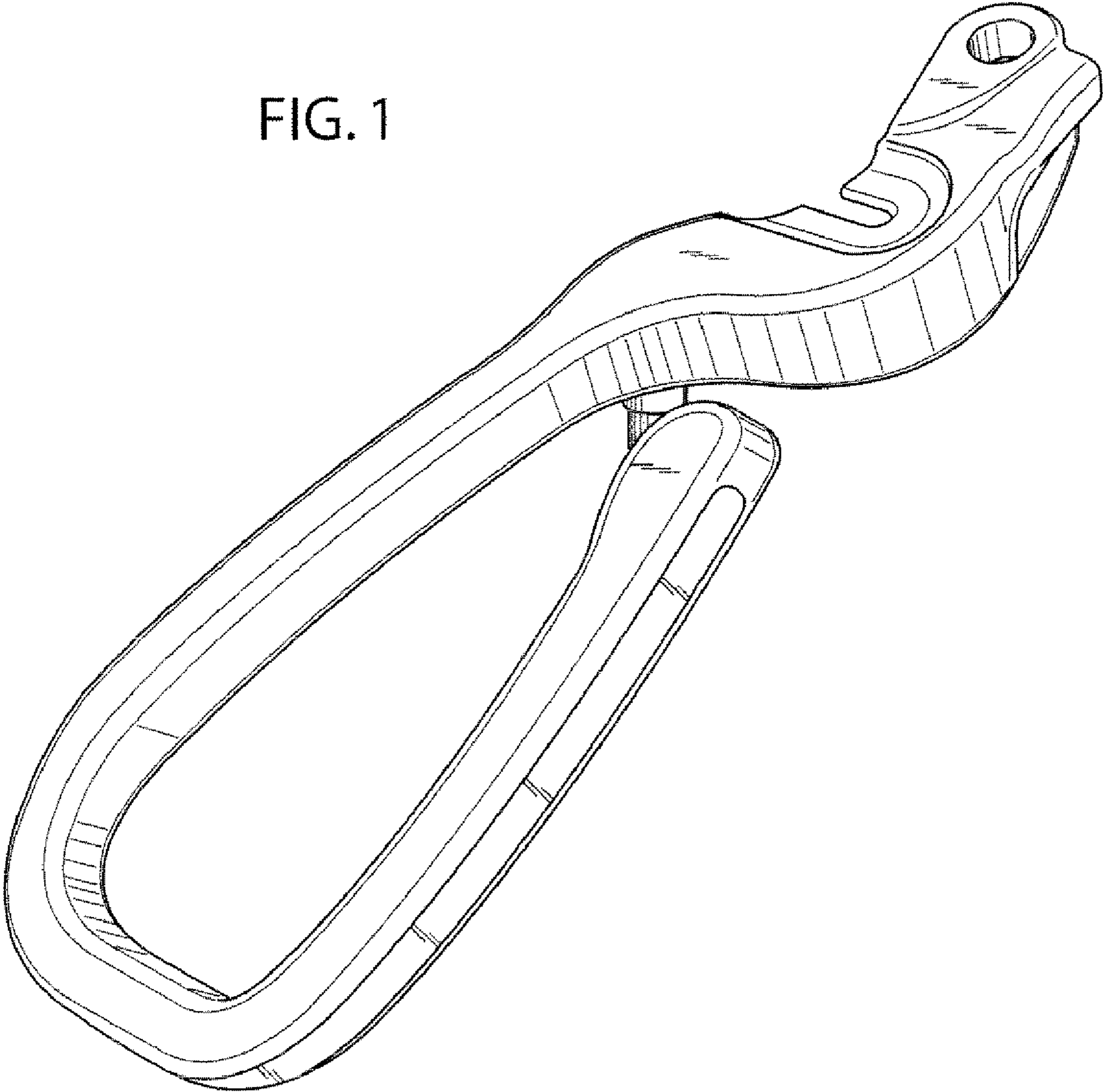

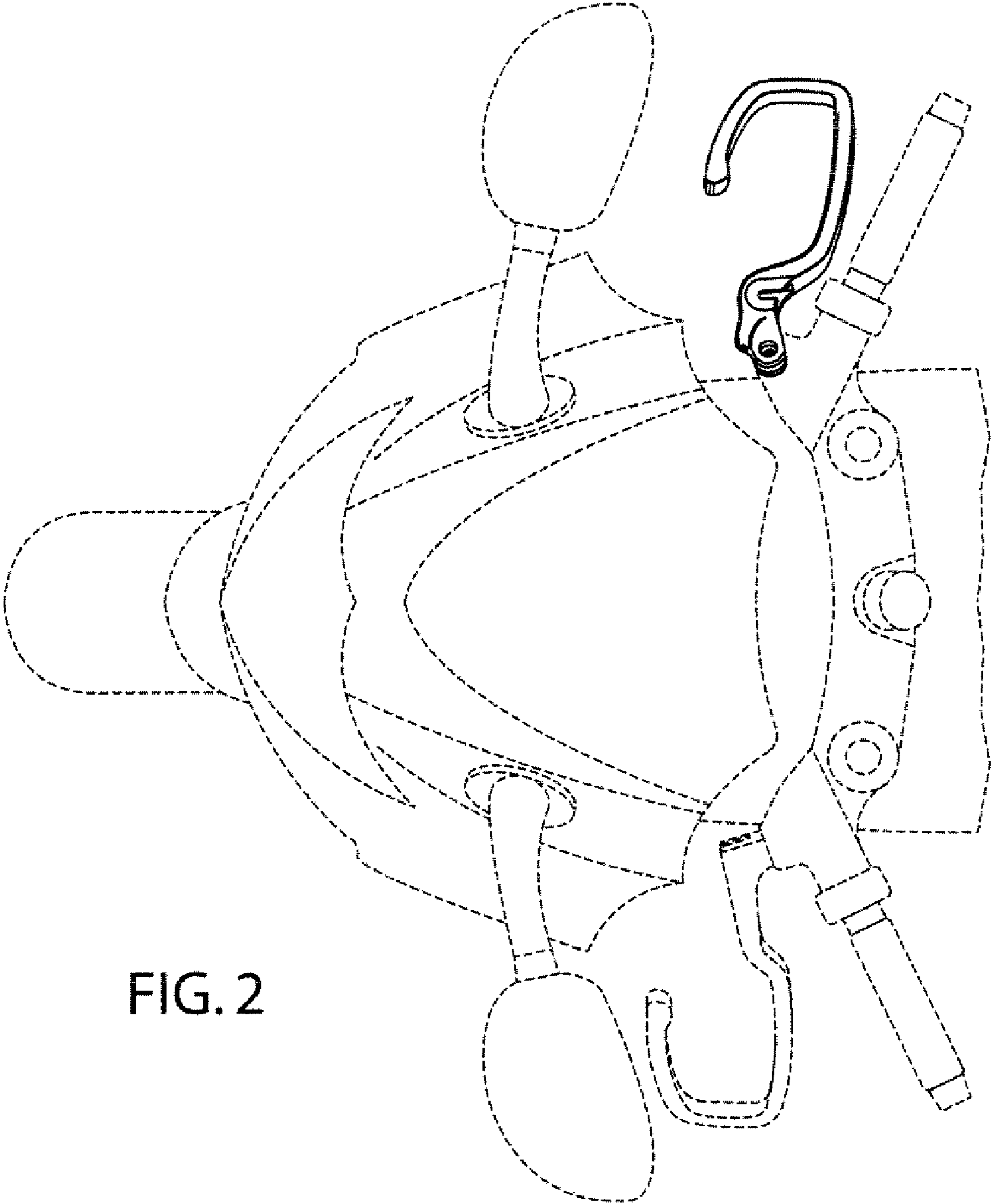

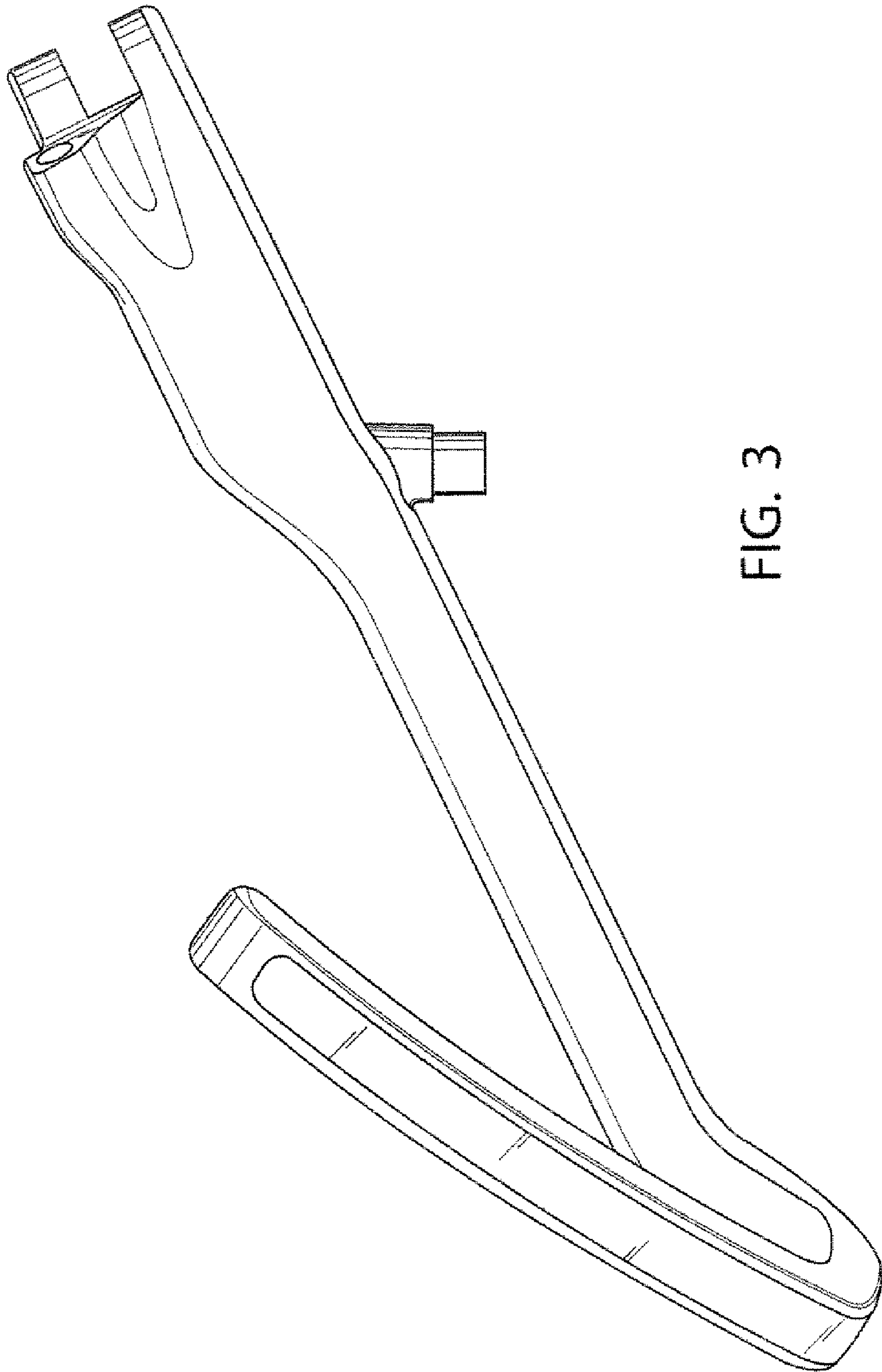

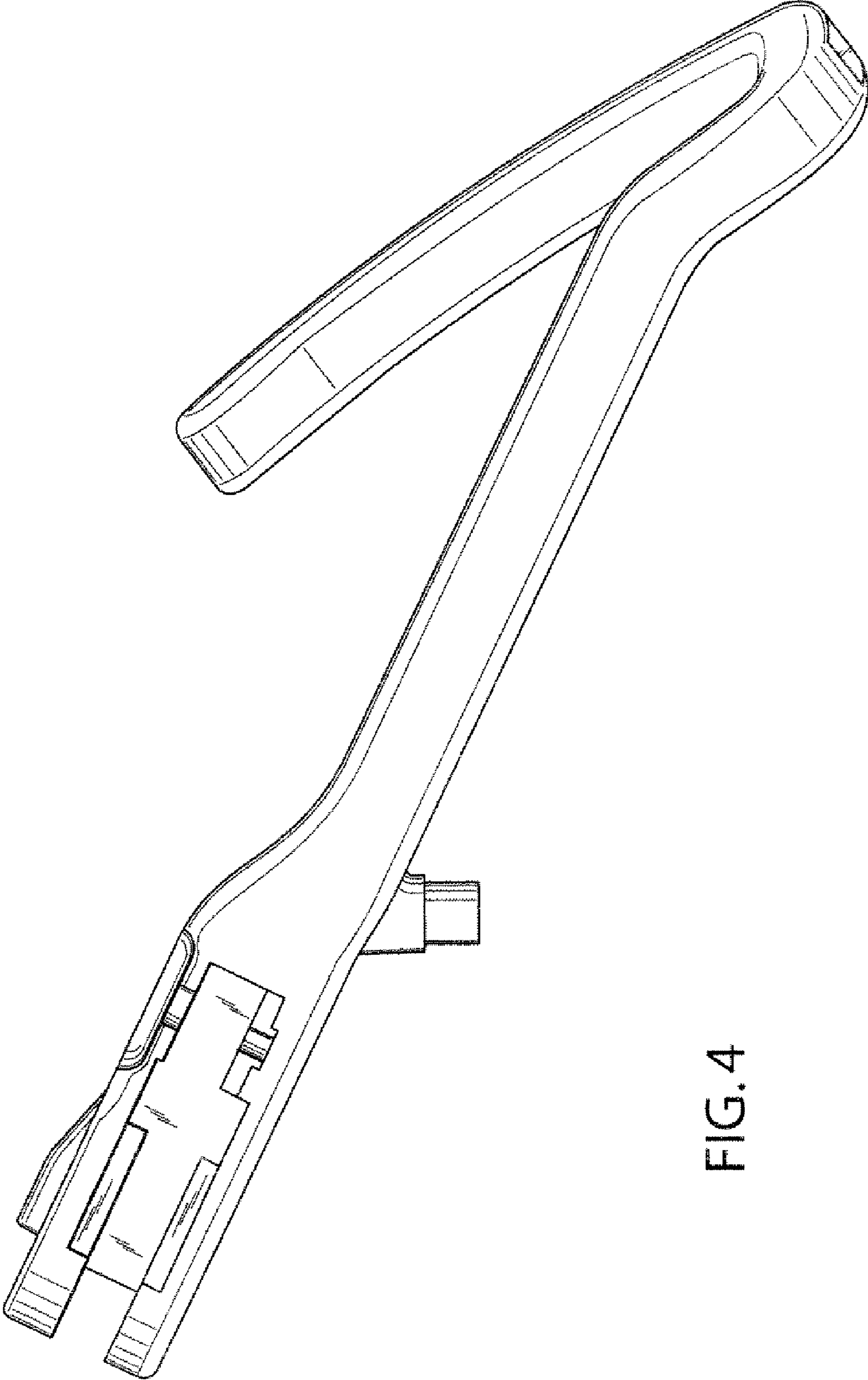

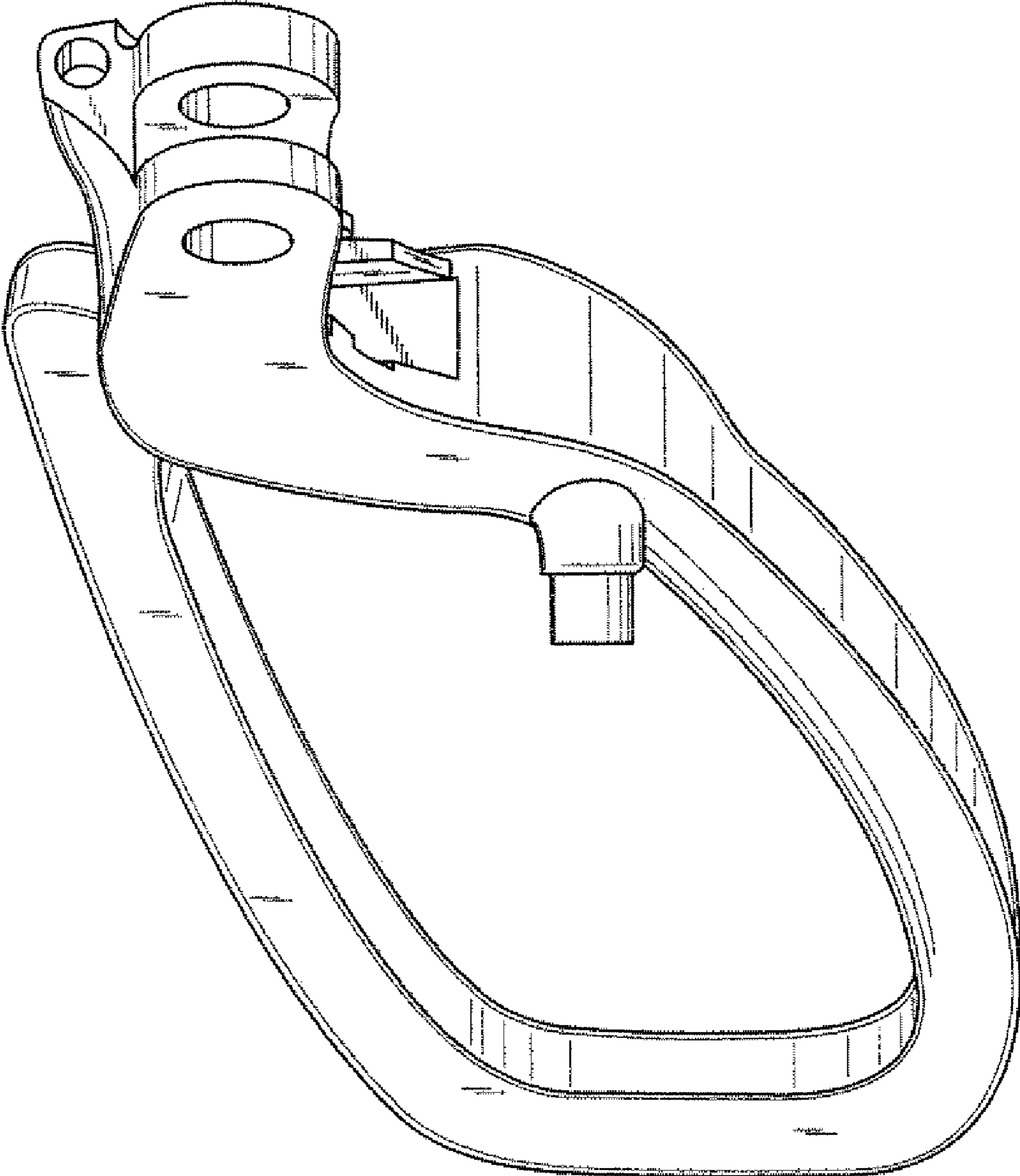

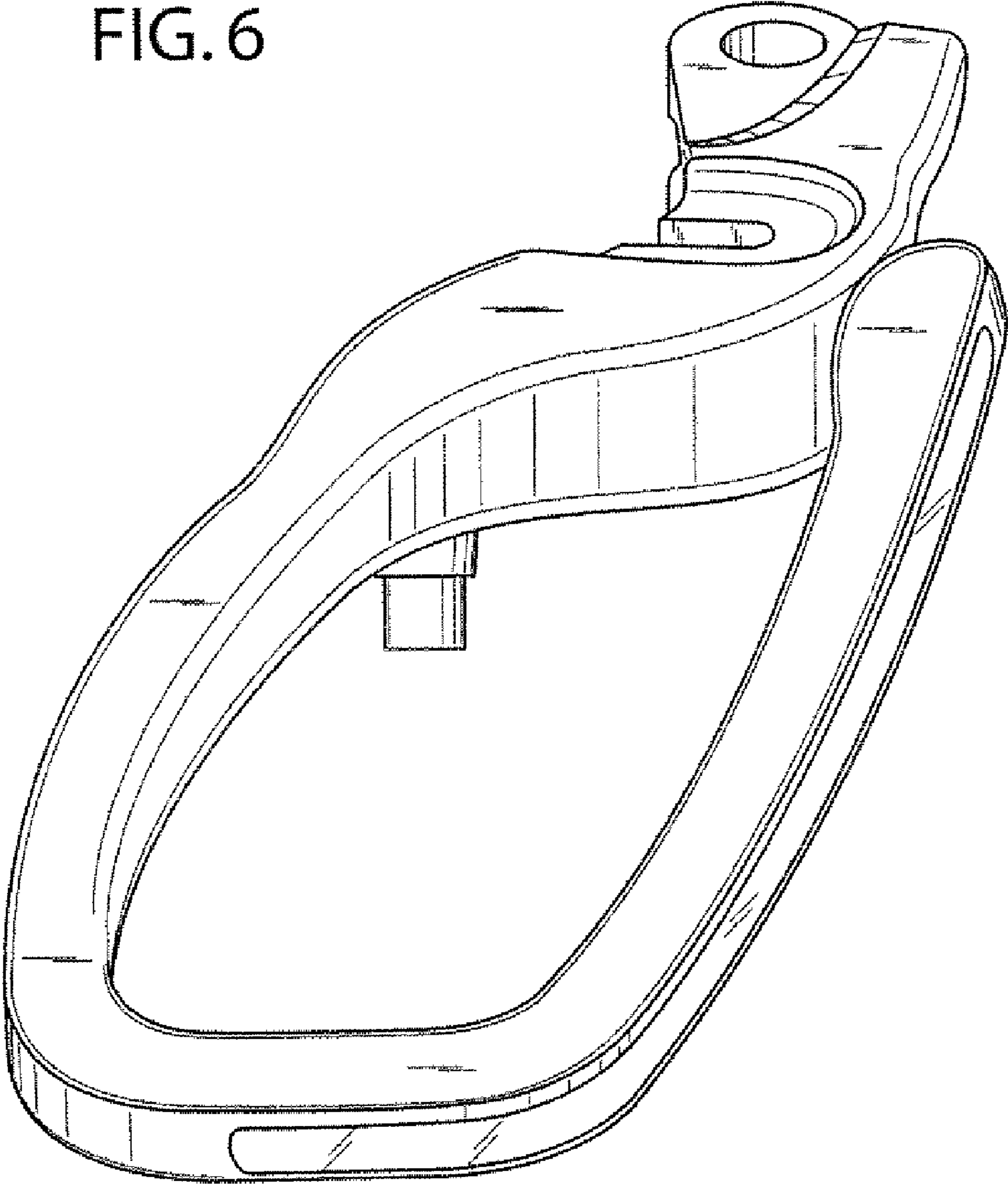
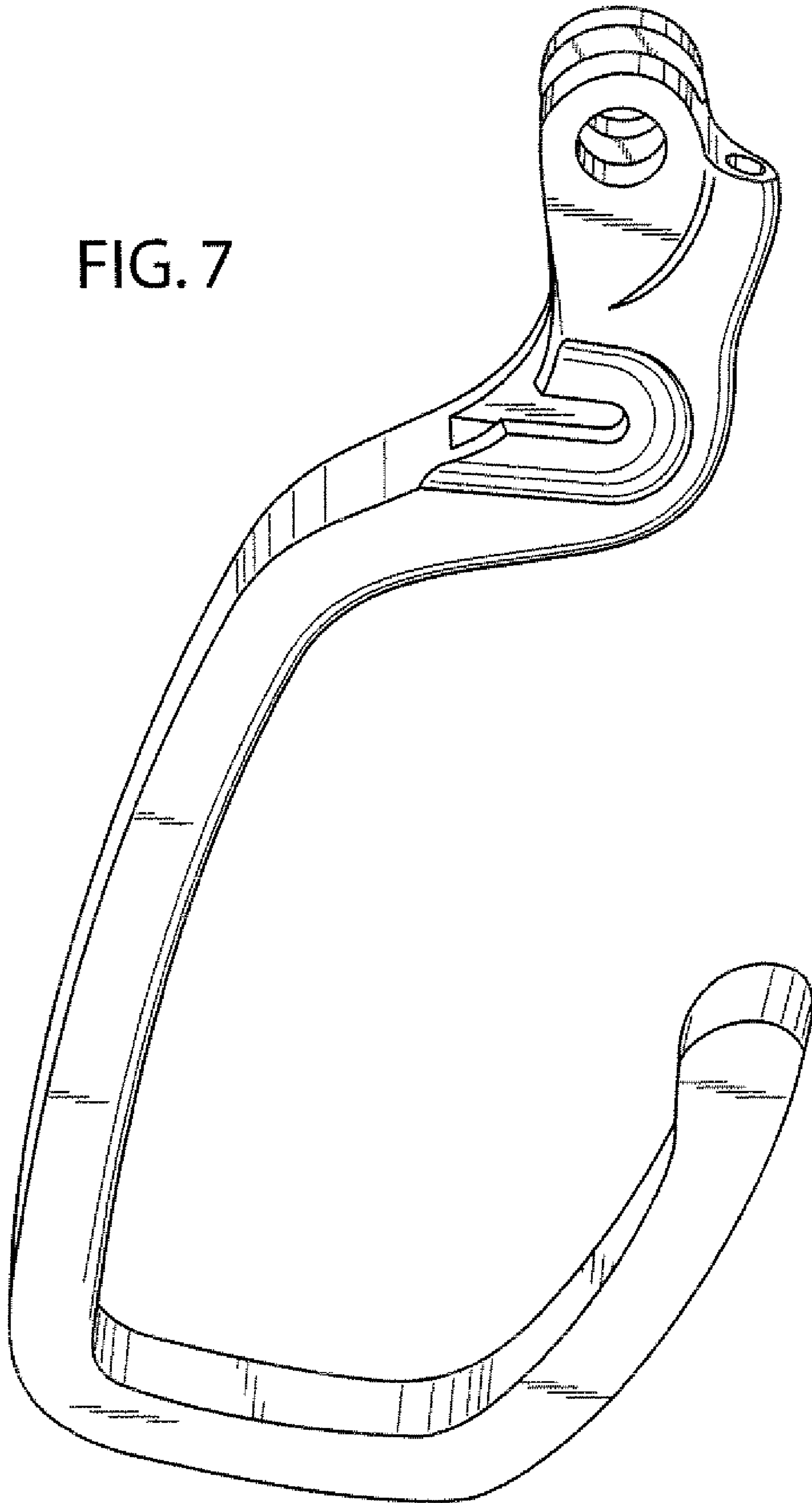

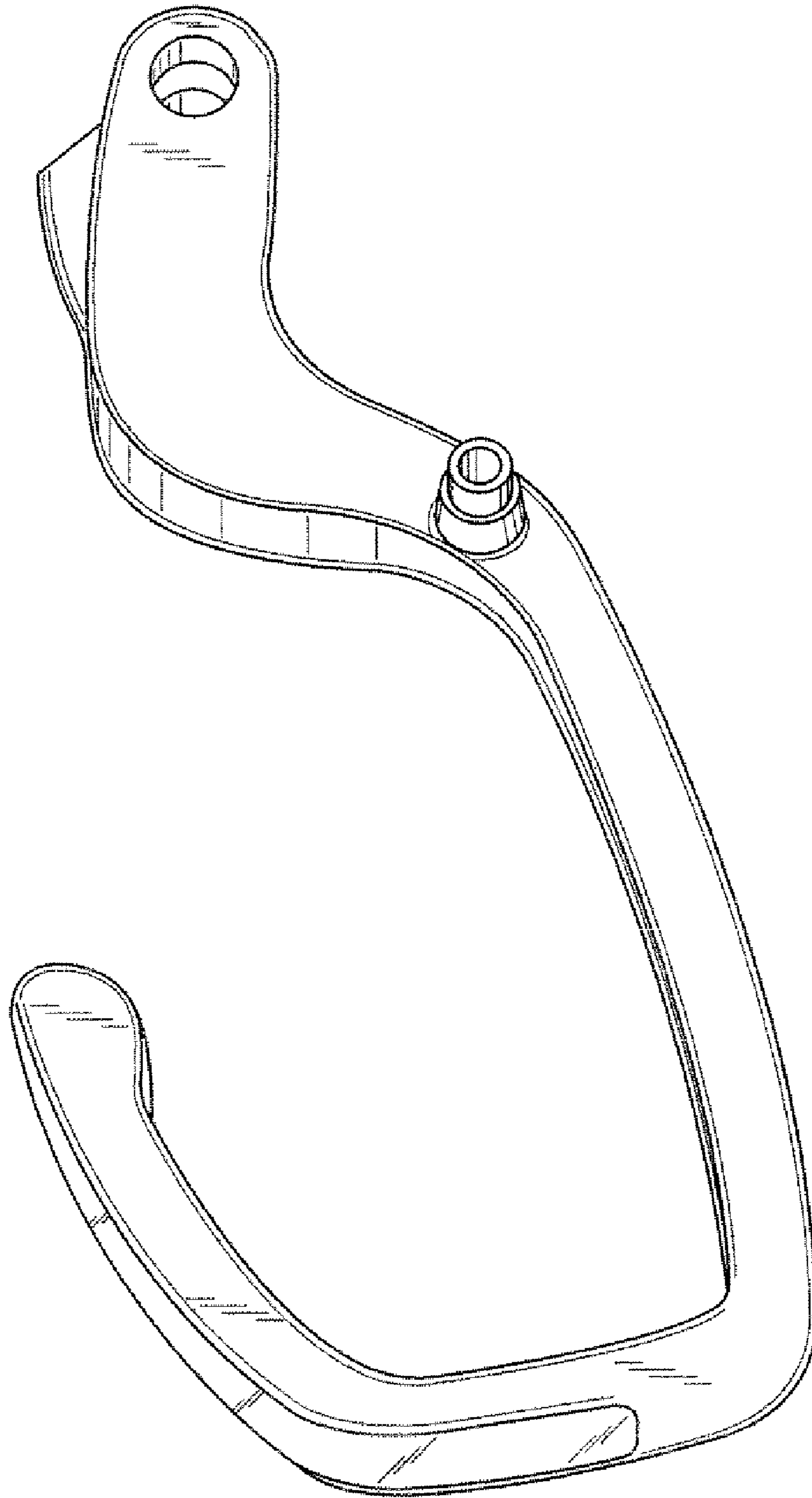
