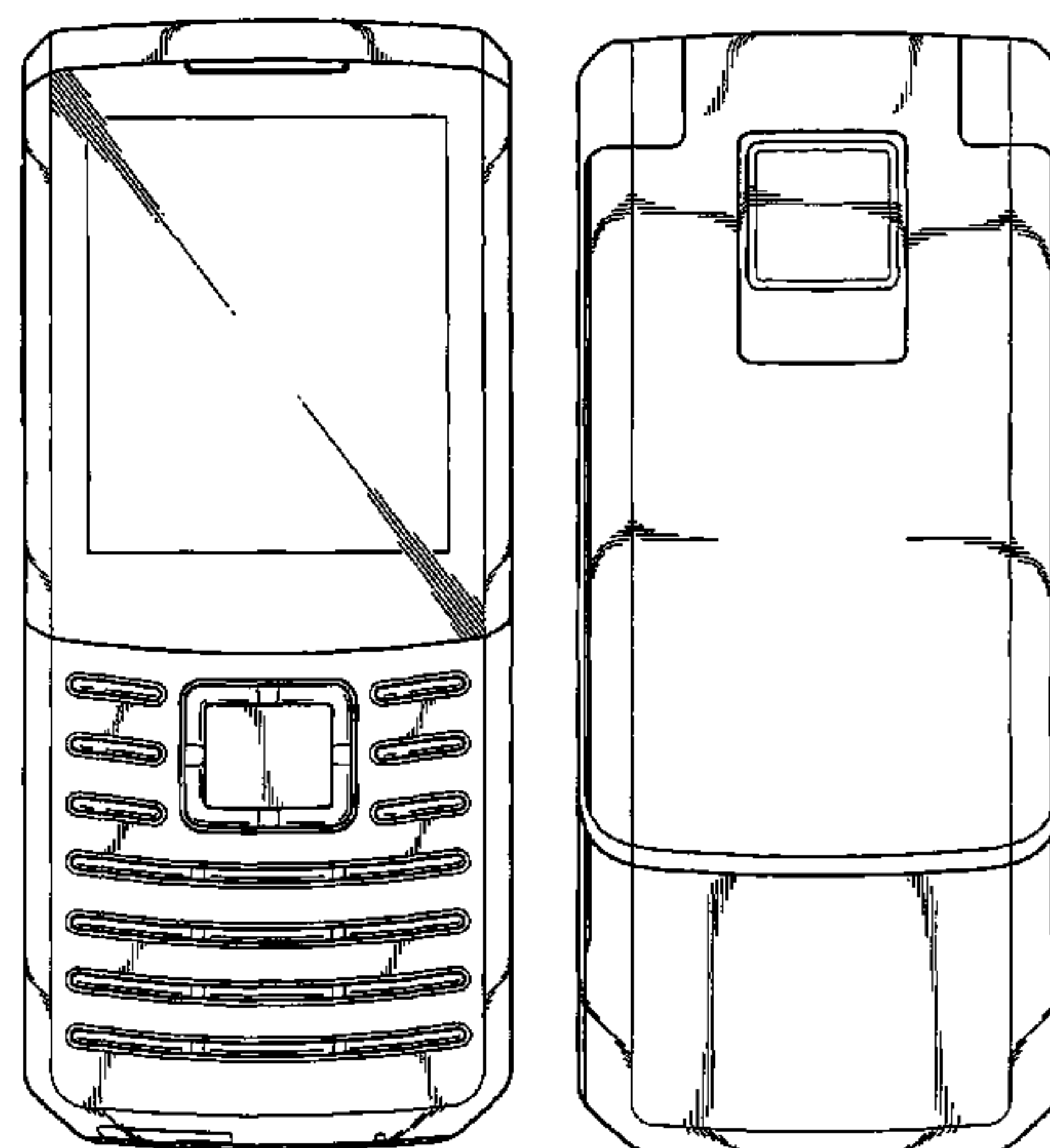
CLAIM

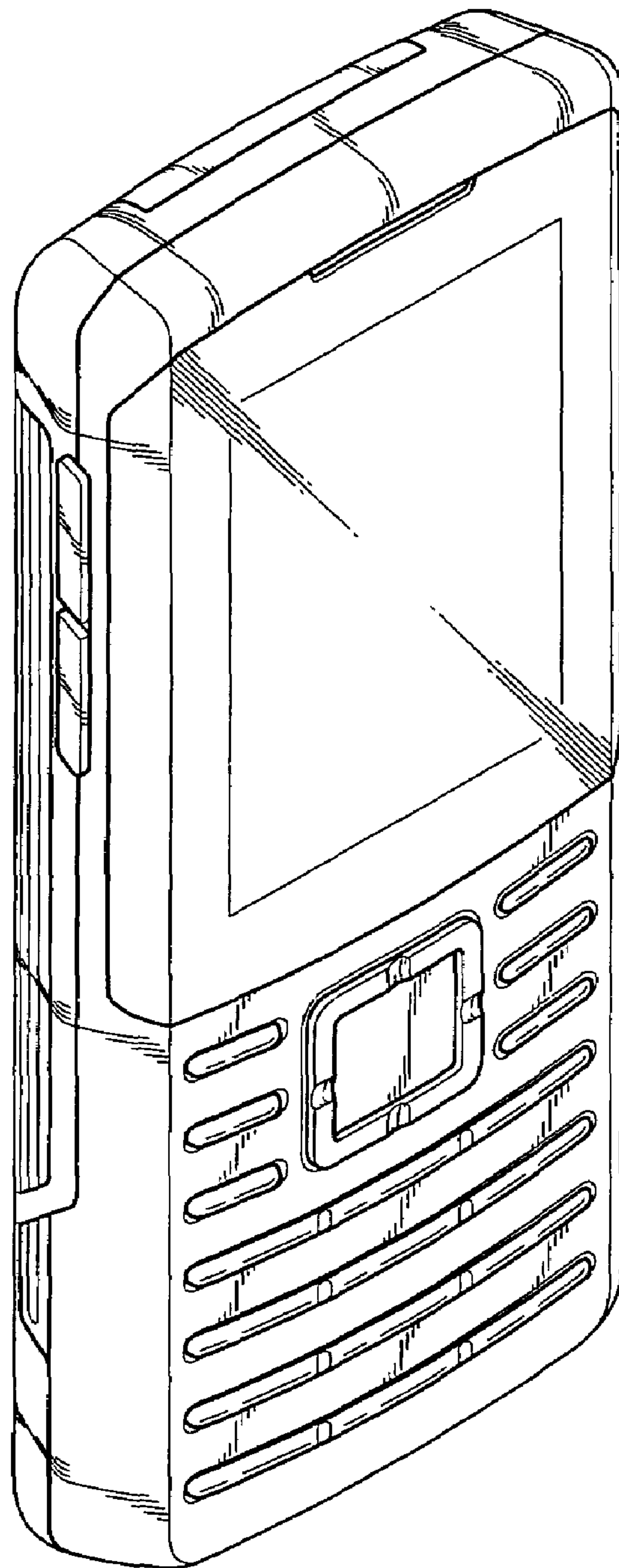

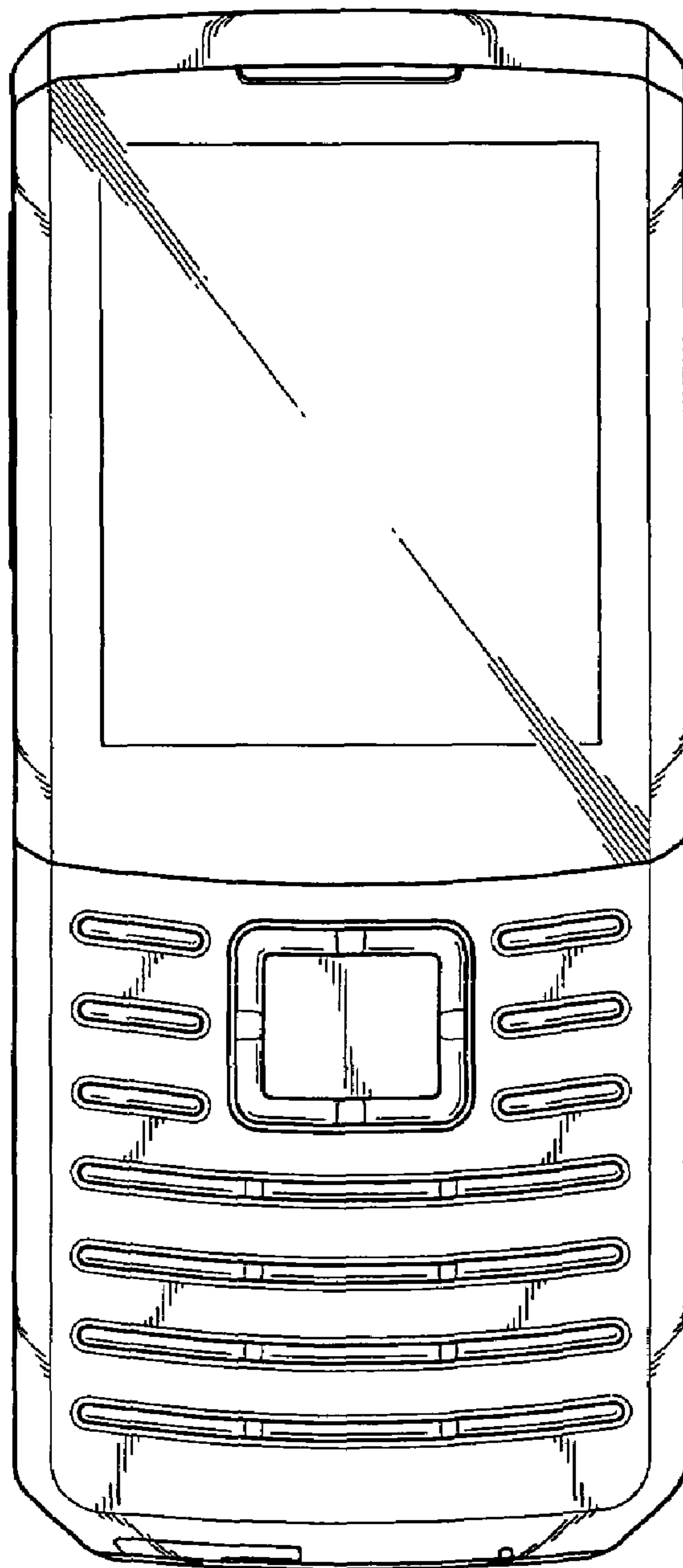

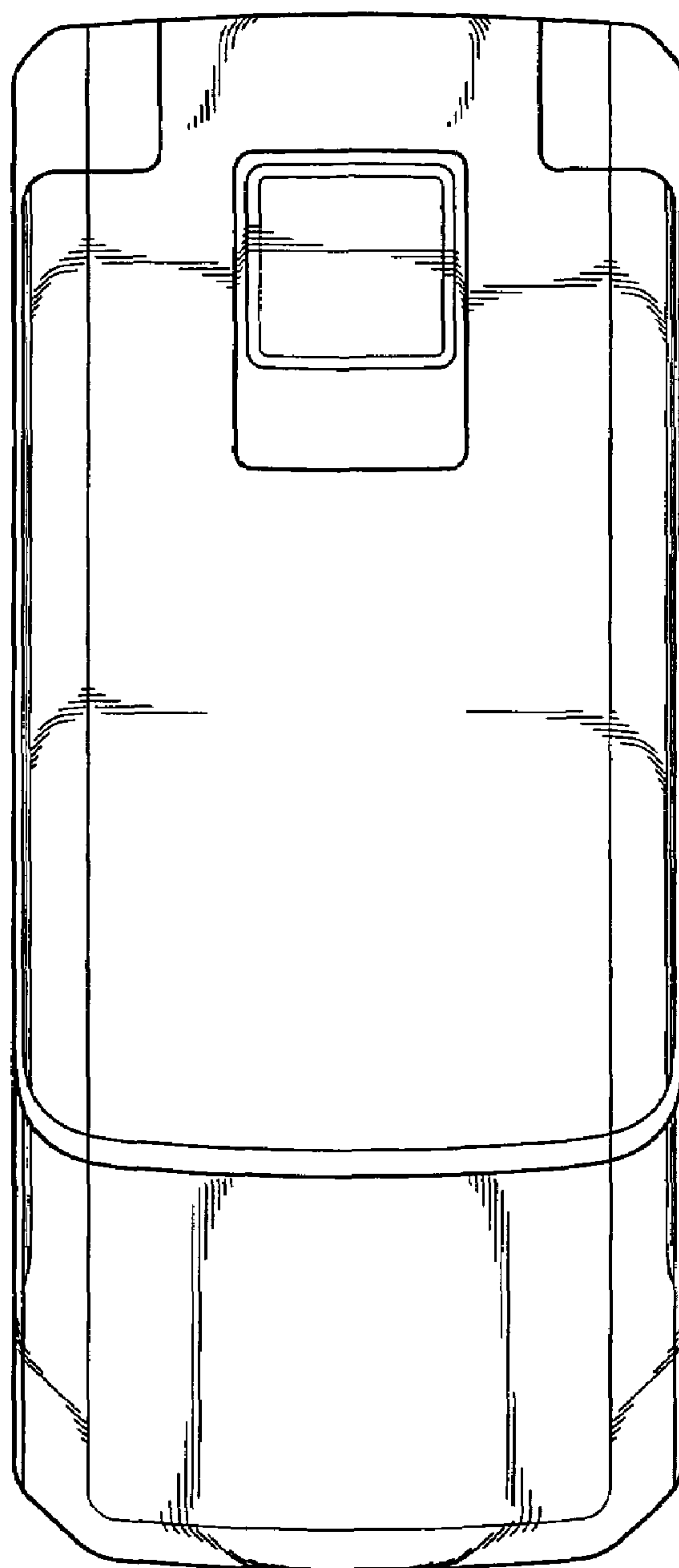

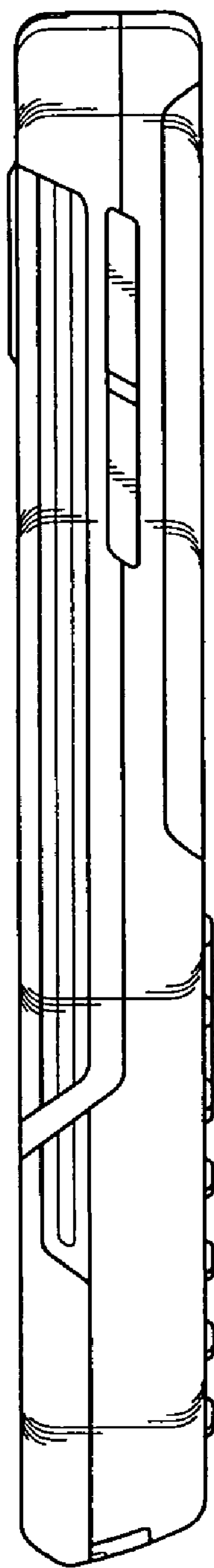

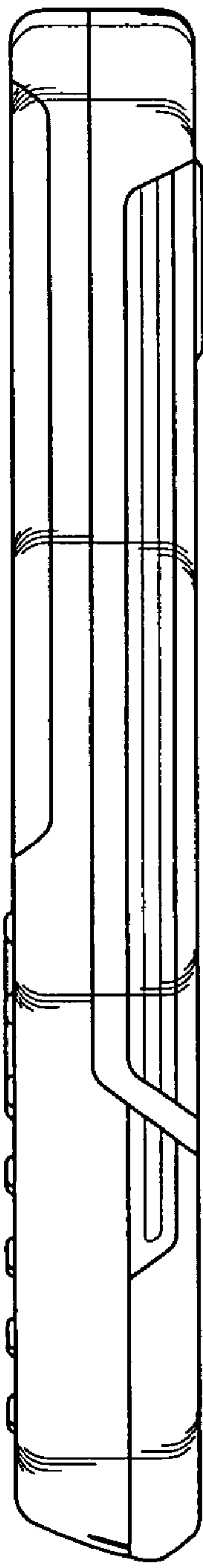

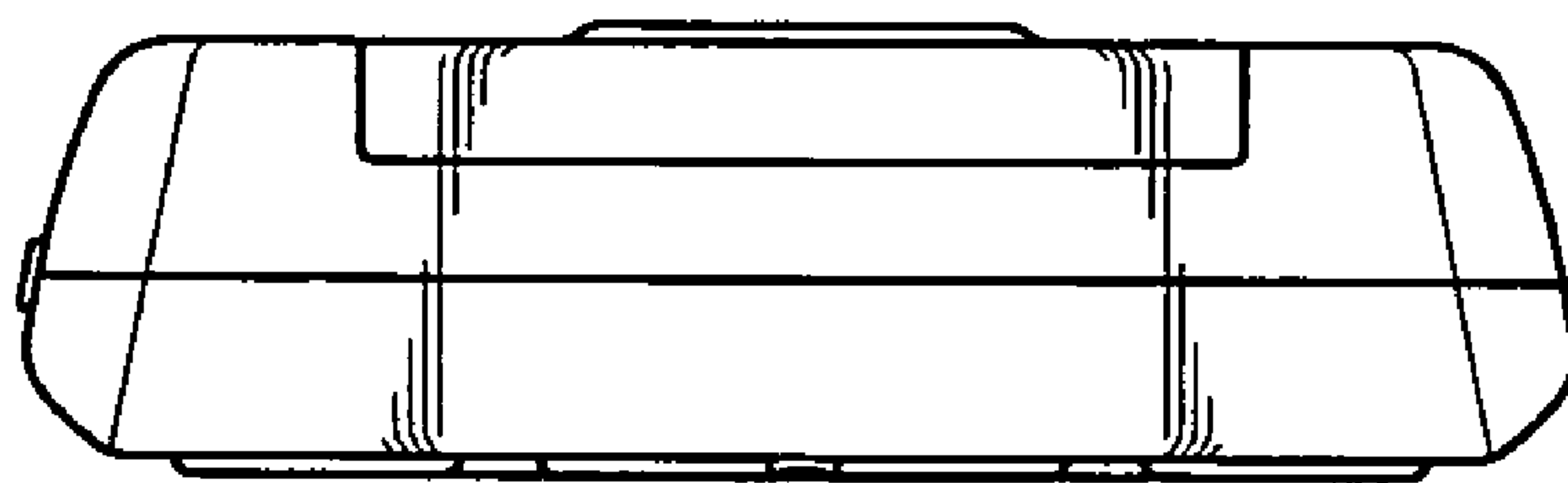

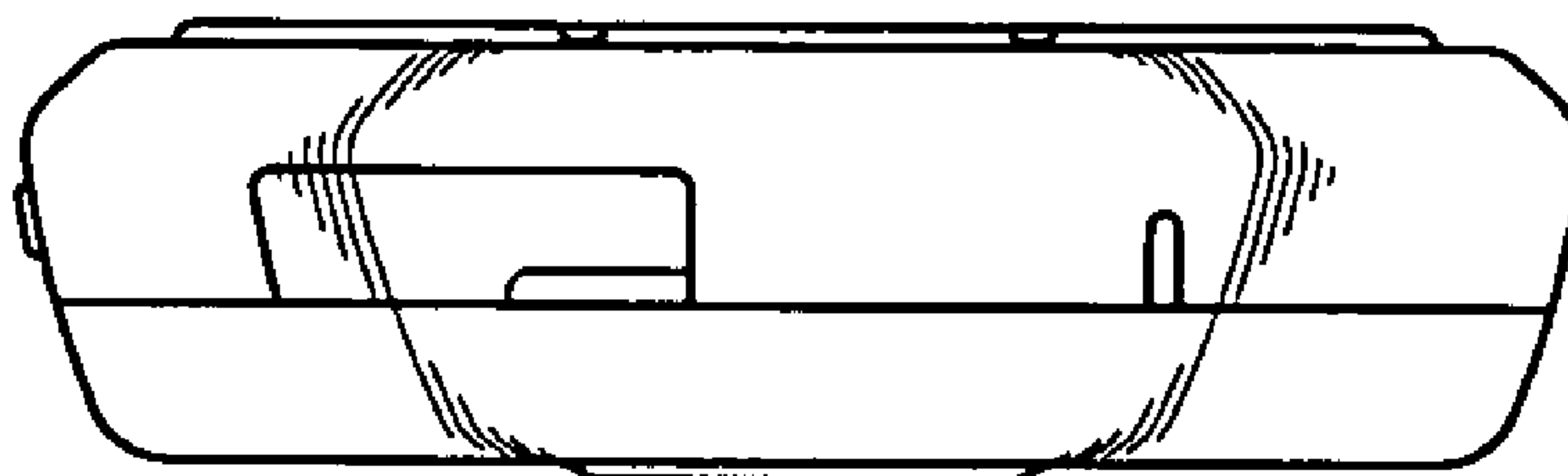
