DESCRIPTION

FIG. 11 is a first side view of the second embodiment thereof;

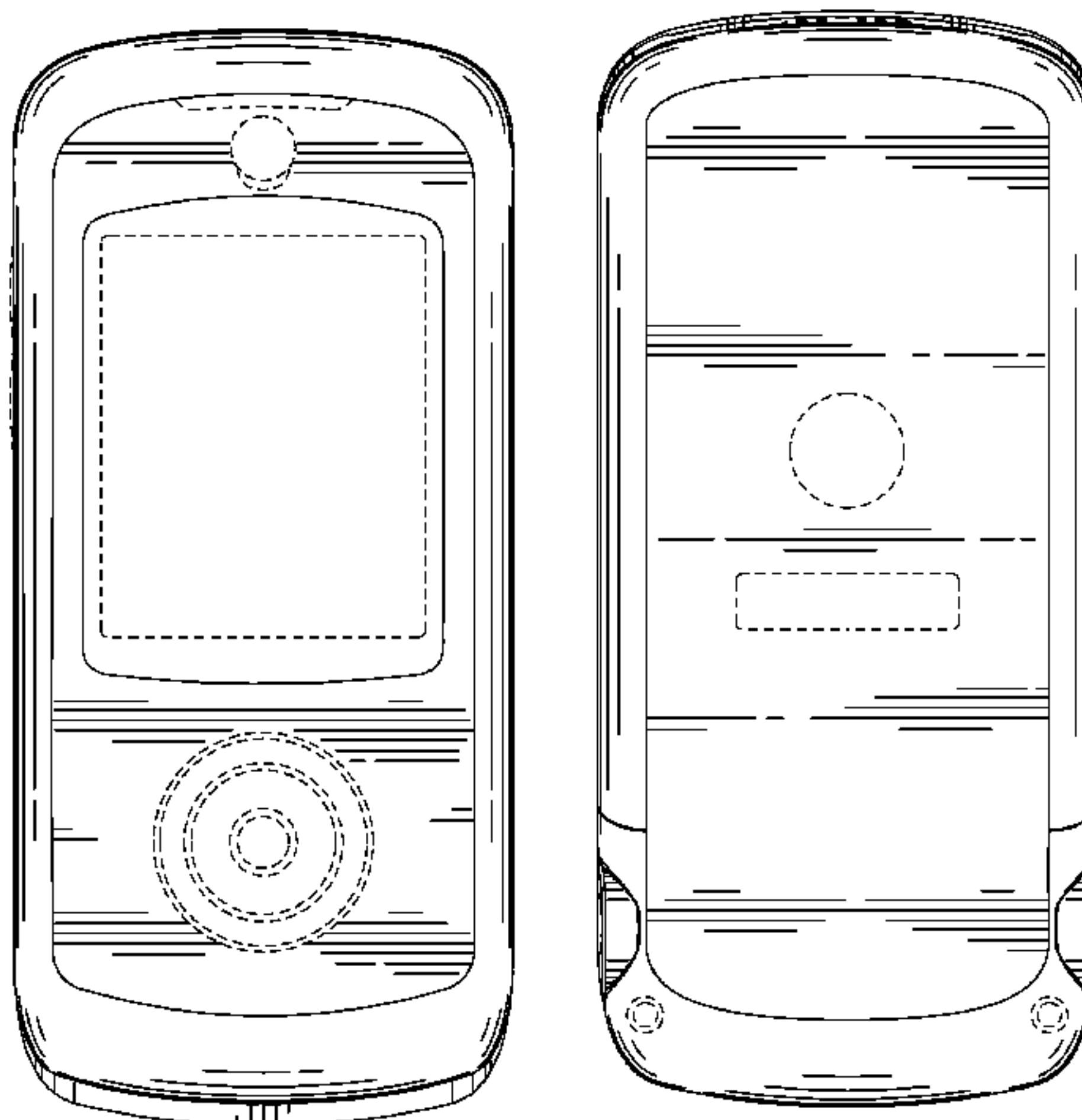
FIG. 12 is a second side view of the second embodiment thereof;

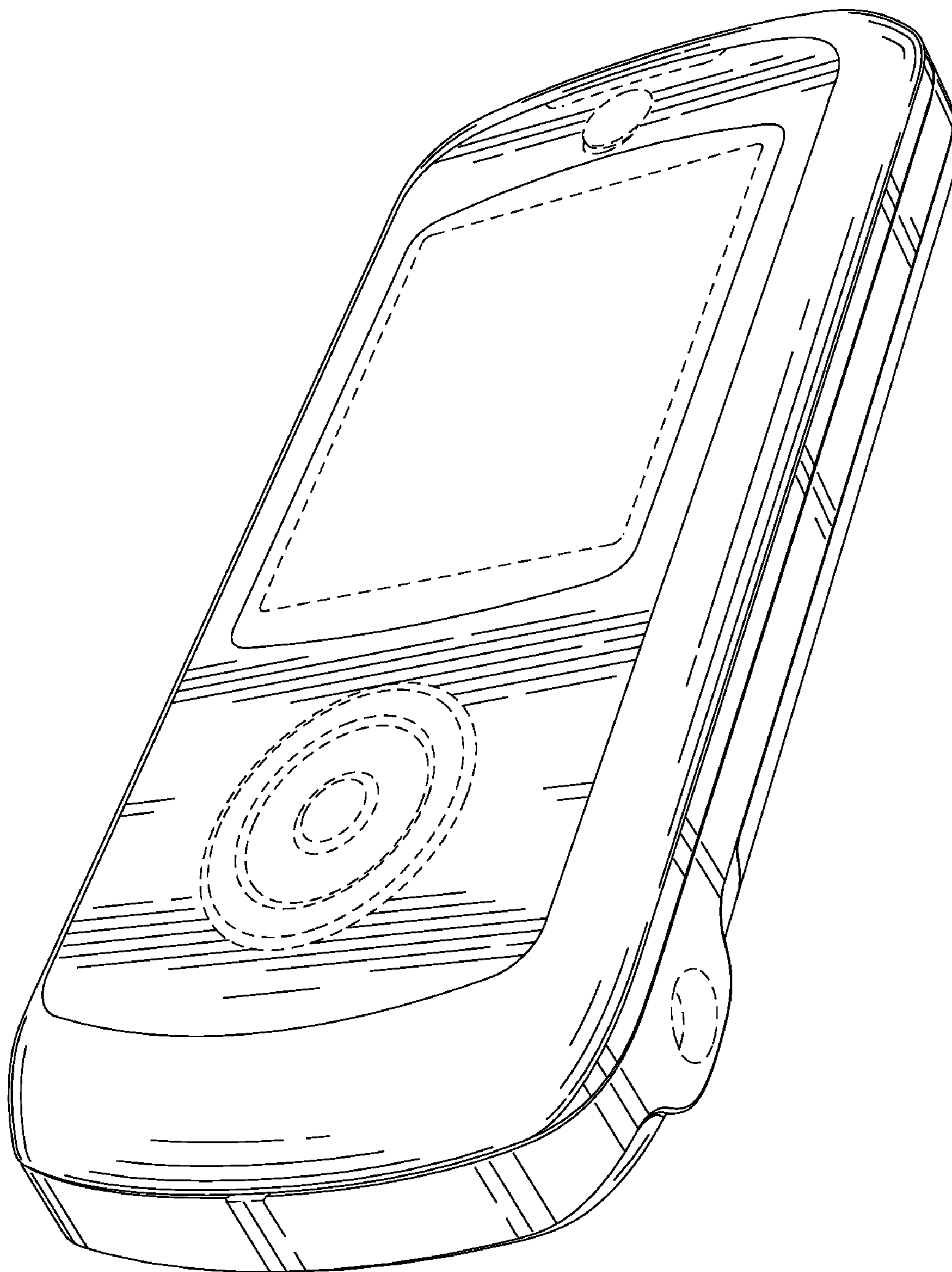

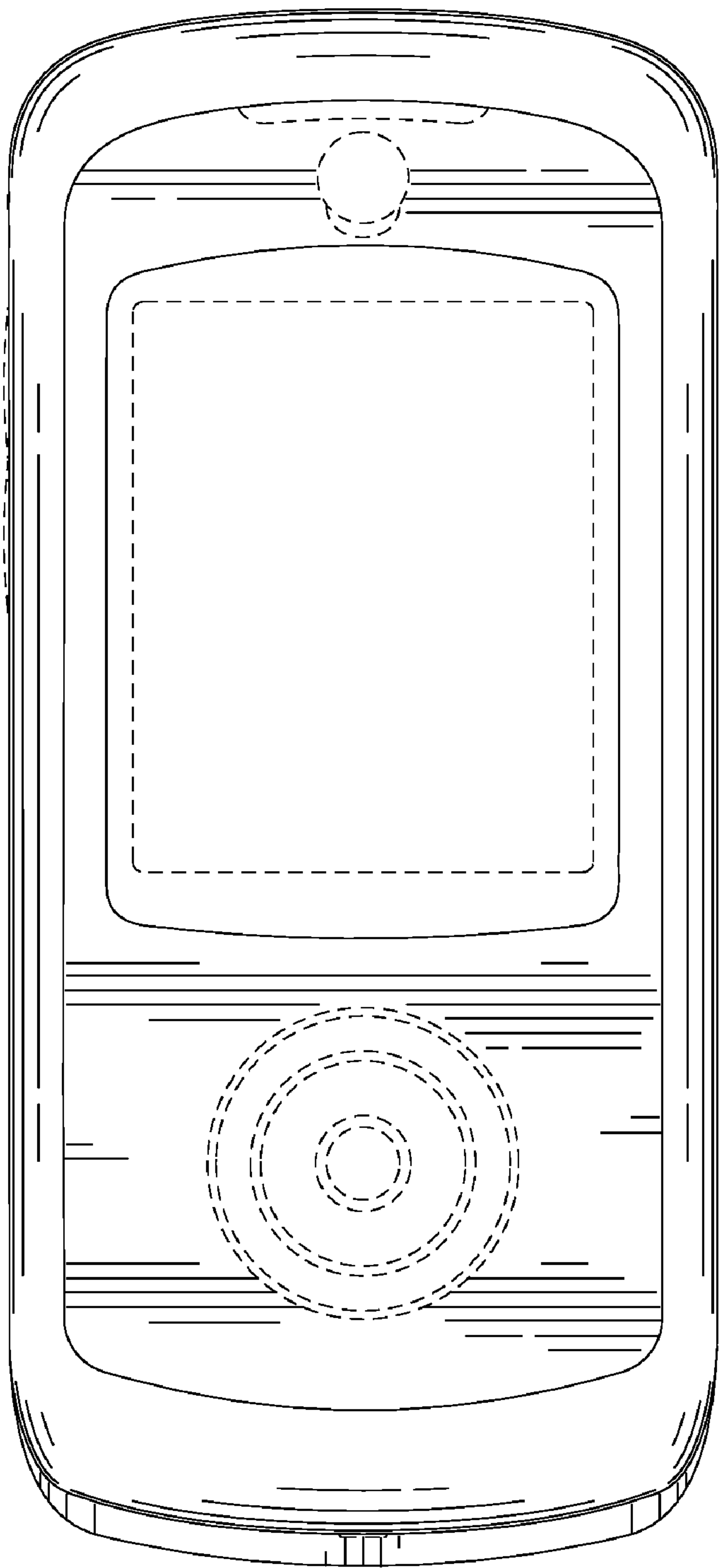

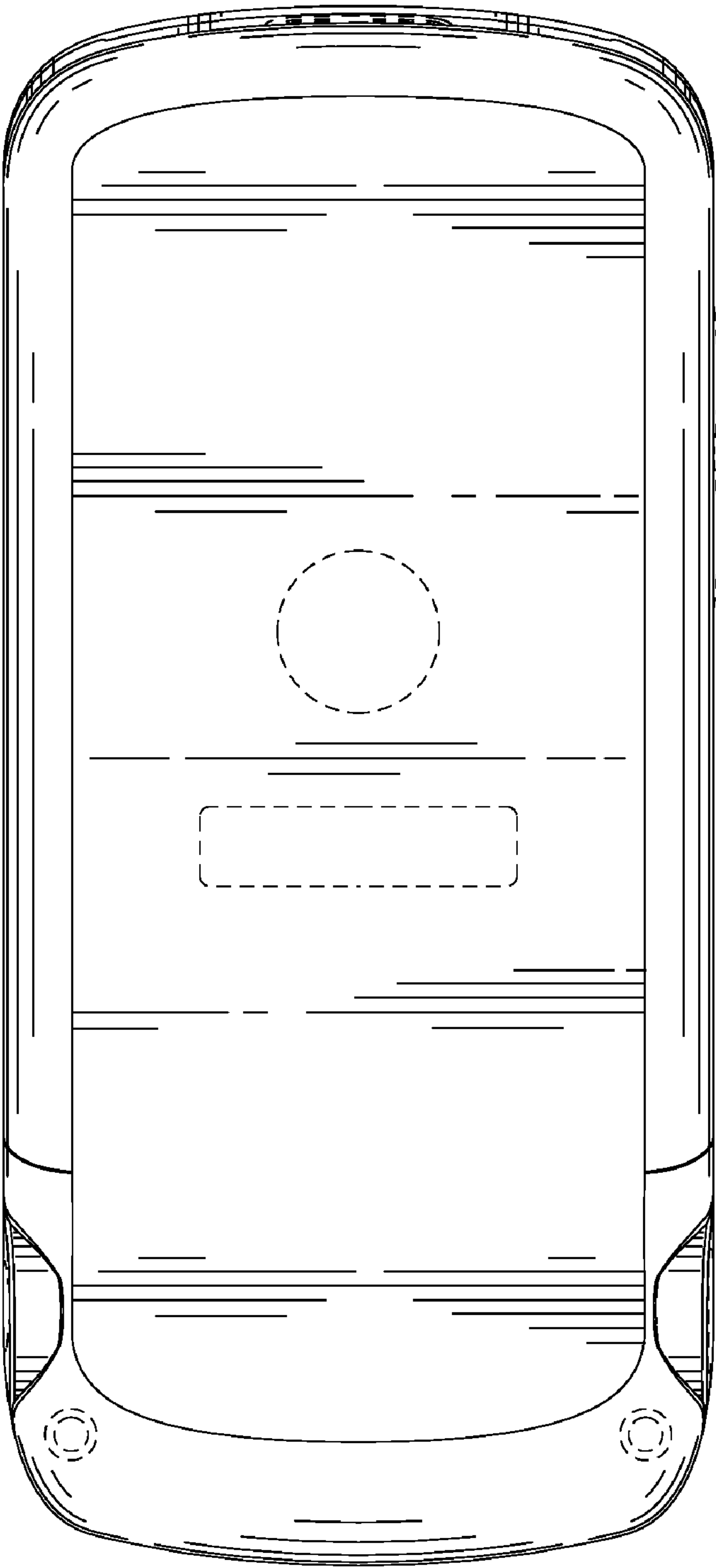

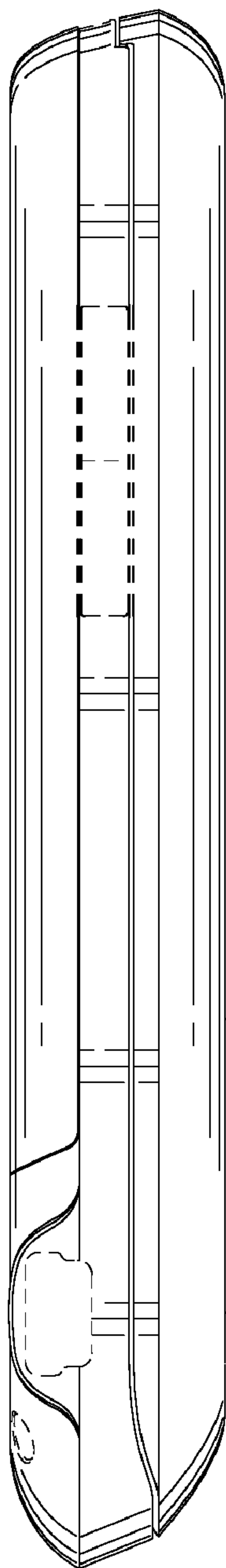

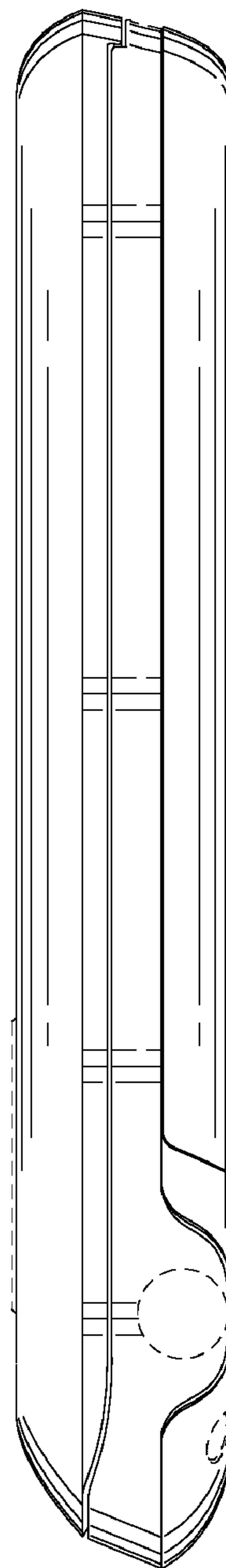

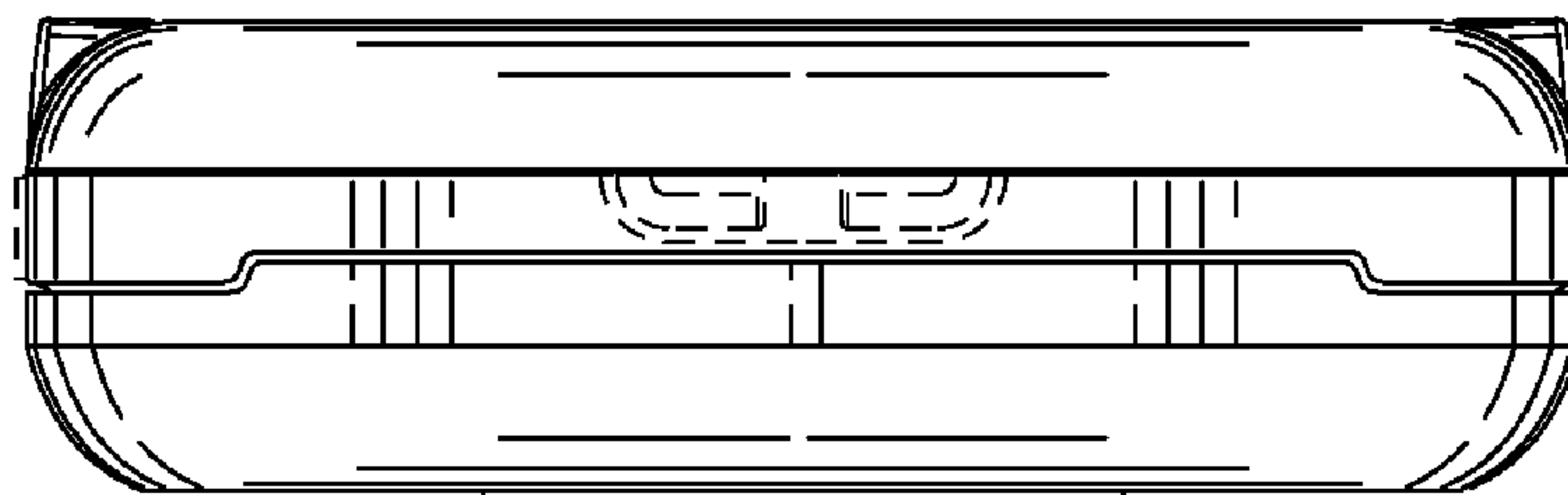

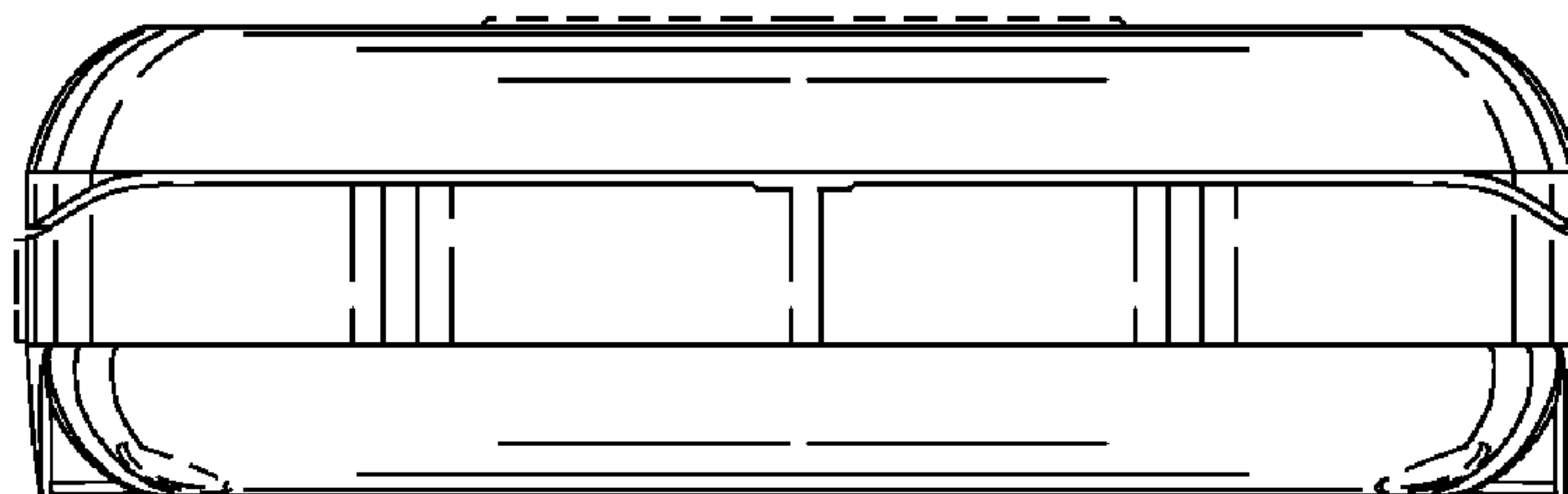

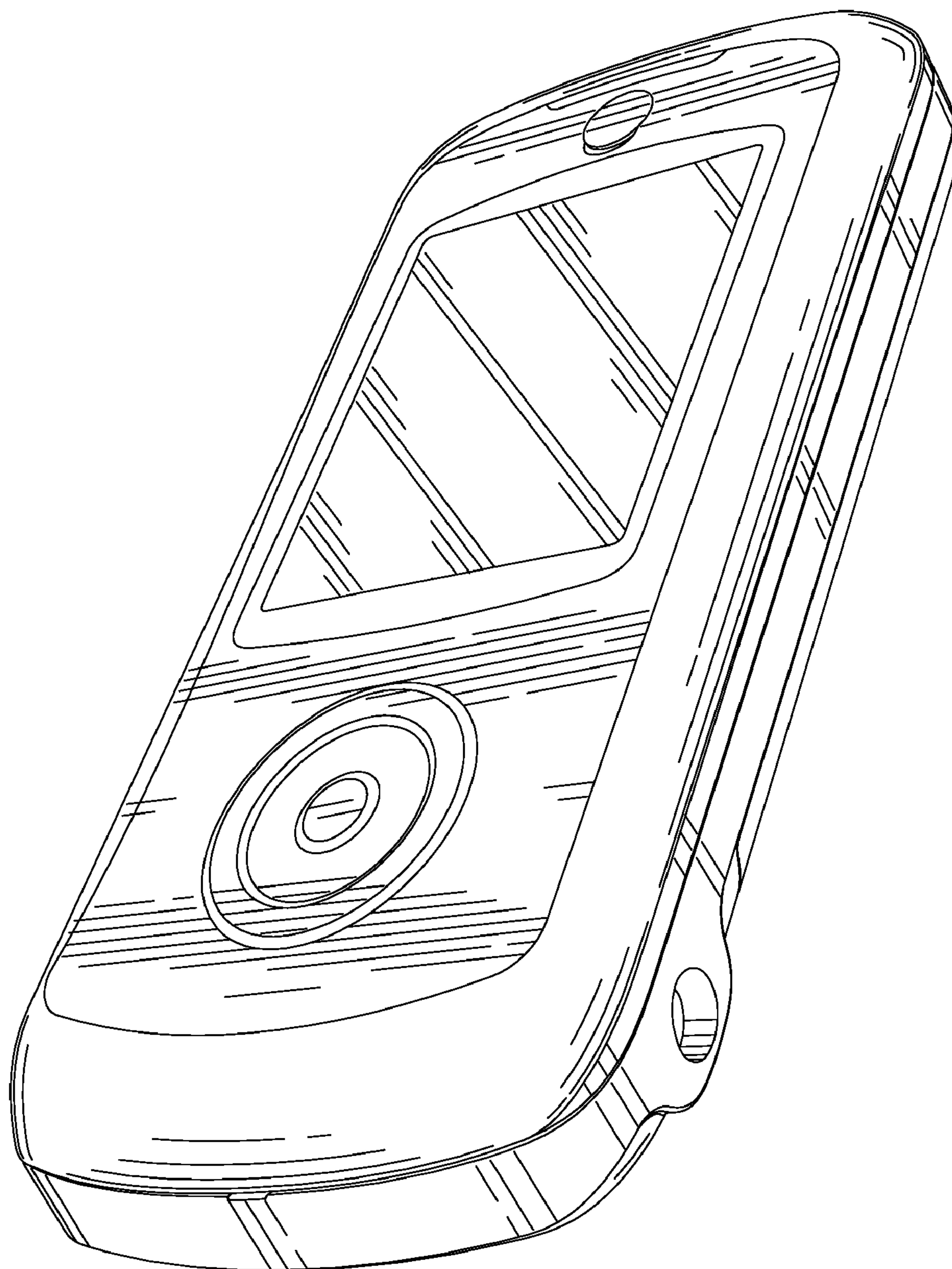

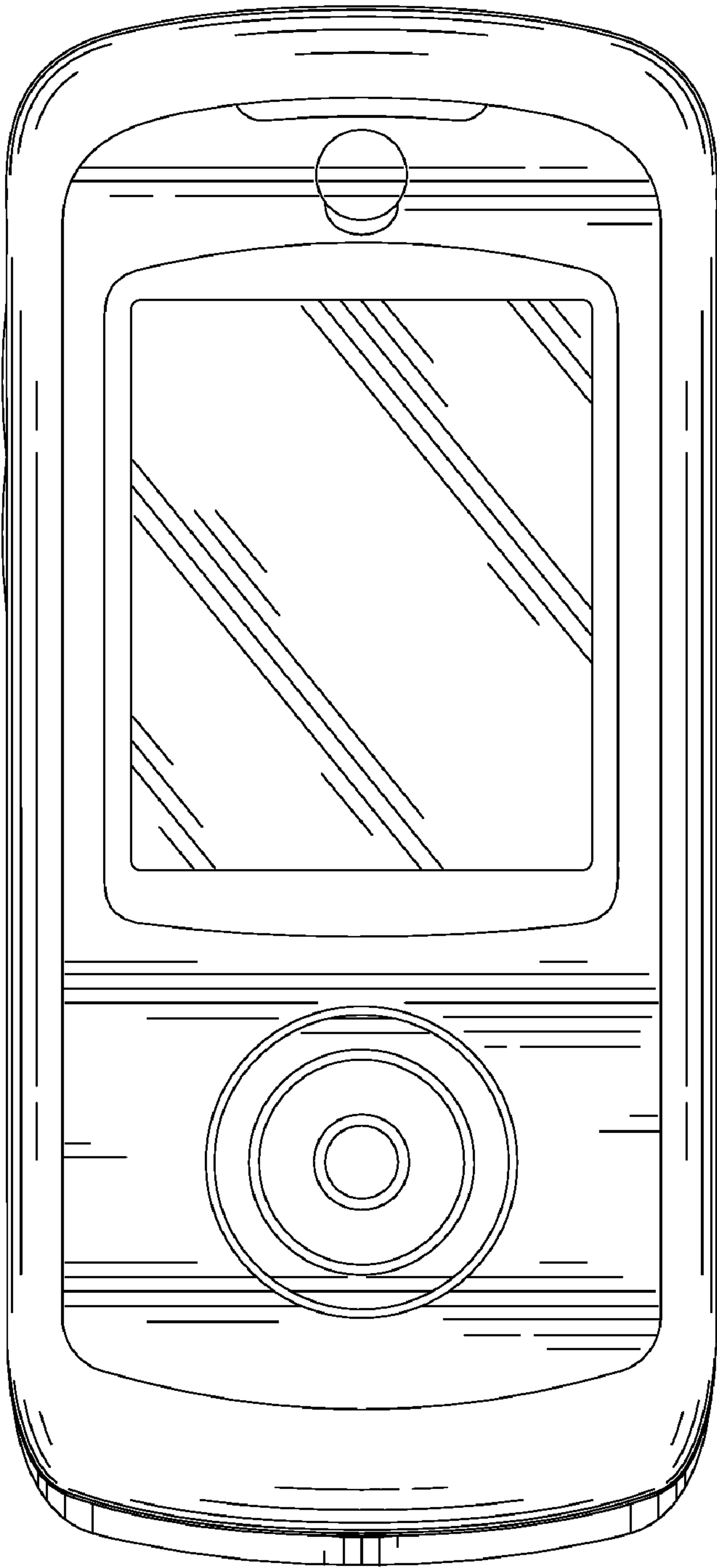

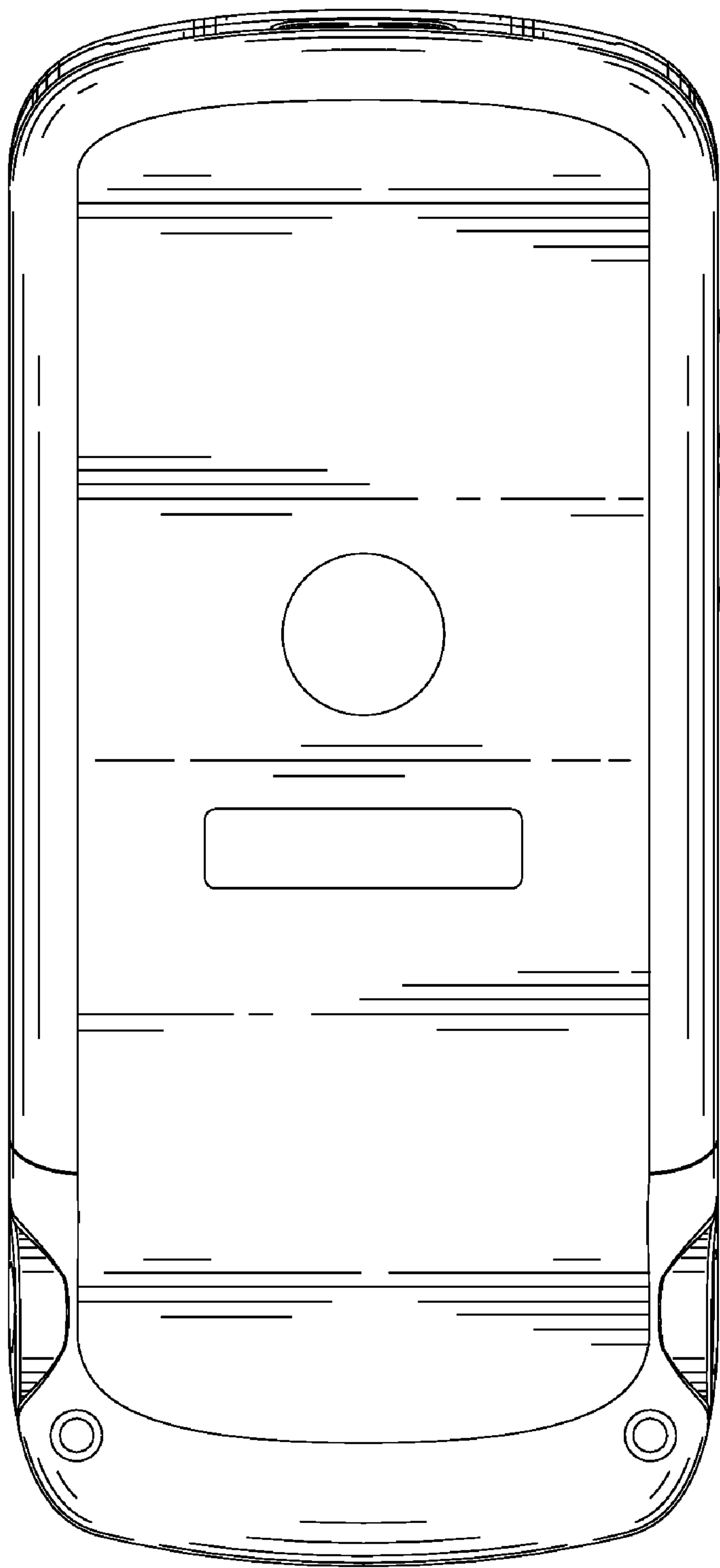

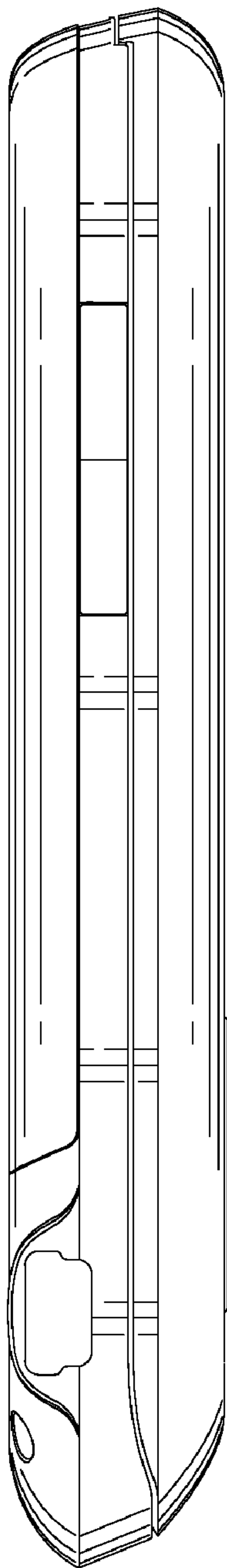

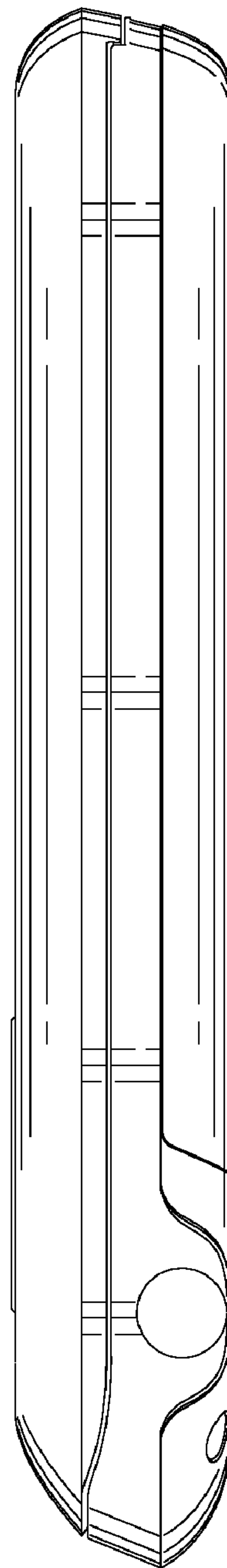

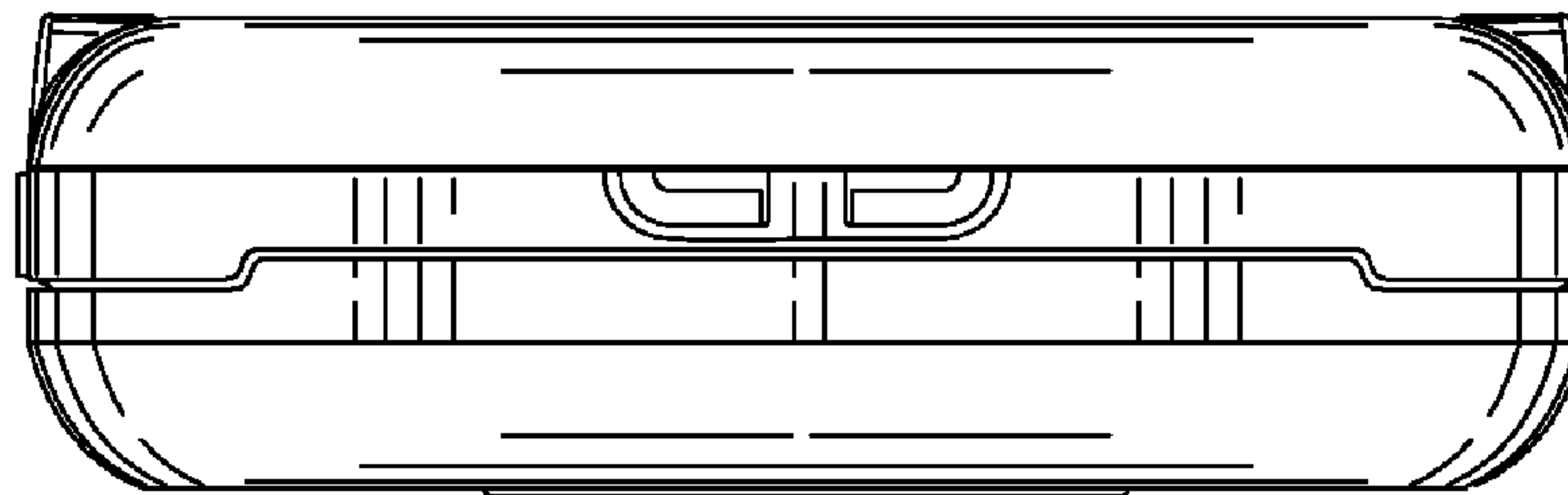

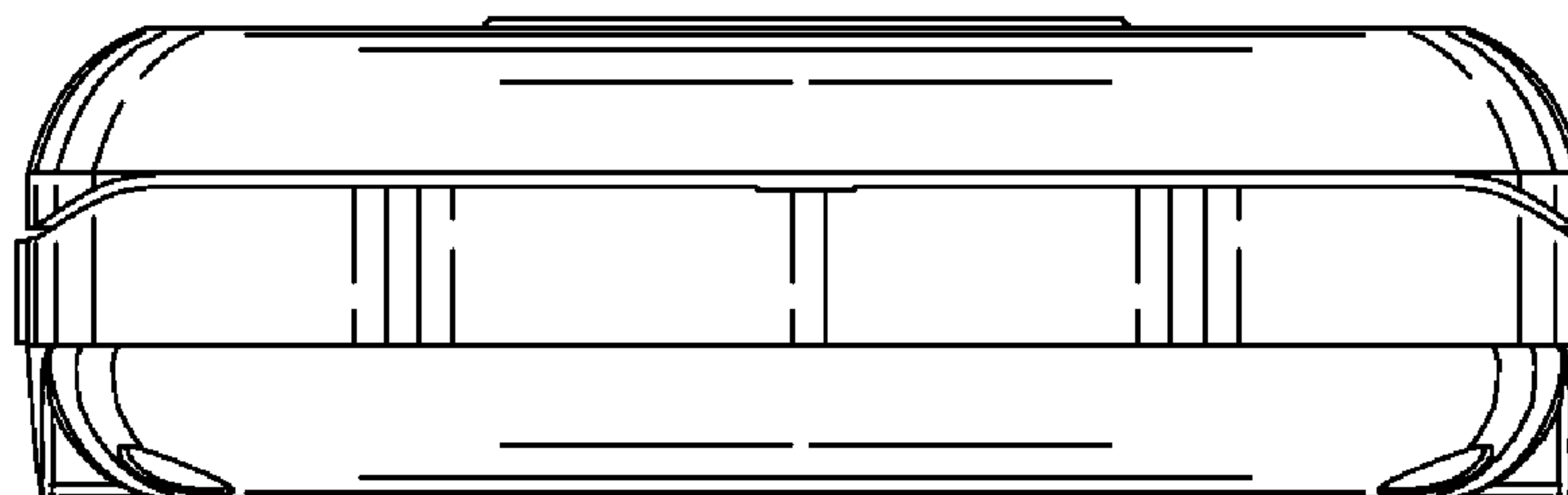
