(57) **CLAIM**

The ornamental design for a decorative element for sunglasses (rock), as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a decorative element for sunglasses (rock) showing my new design;

FIG. 2 is a left view of the portion of a decorative element for sunglasses (rock) shown in FIG. 1;

FIG. 3 is a right view of the portion of a decorative element for sunglasses (rock) shown in FIG. 1;

FIG. 4 is a top view of the portion of a decorative element for sunglasses (rock) shown in FIG. 1;

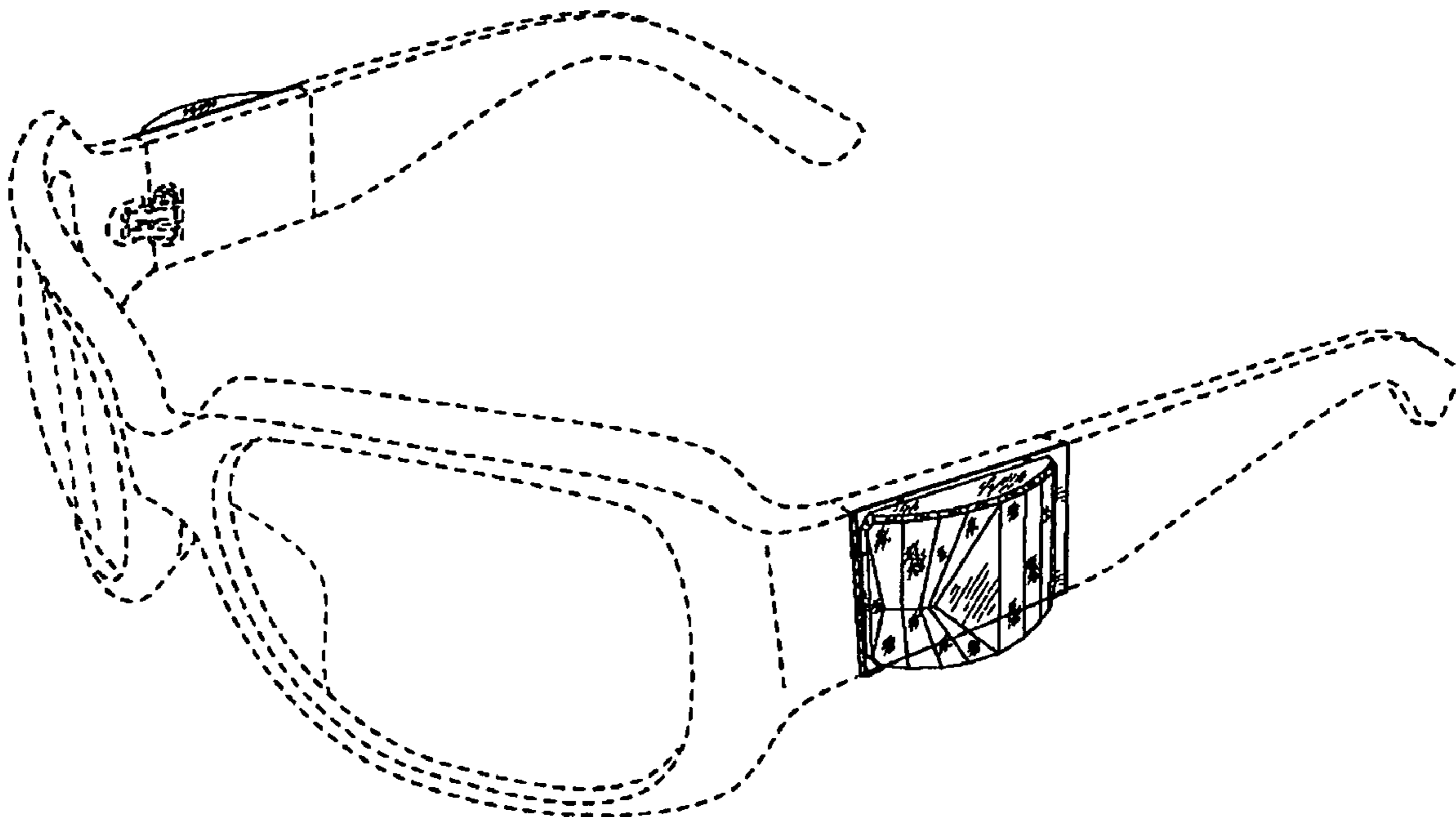
FIG. 5 is a bottom view of the portion of a decorative element for sunglasses (rock) shown in FIG. 1;

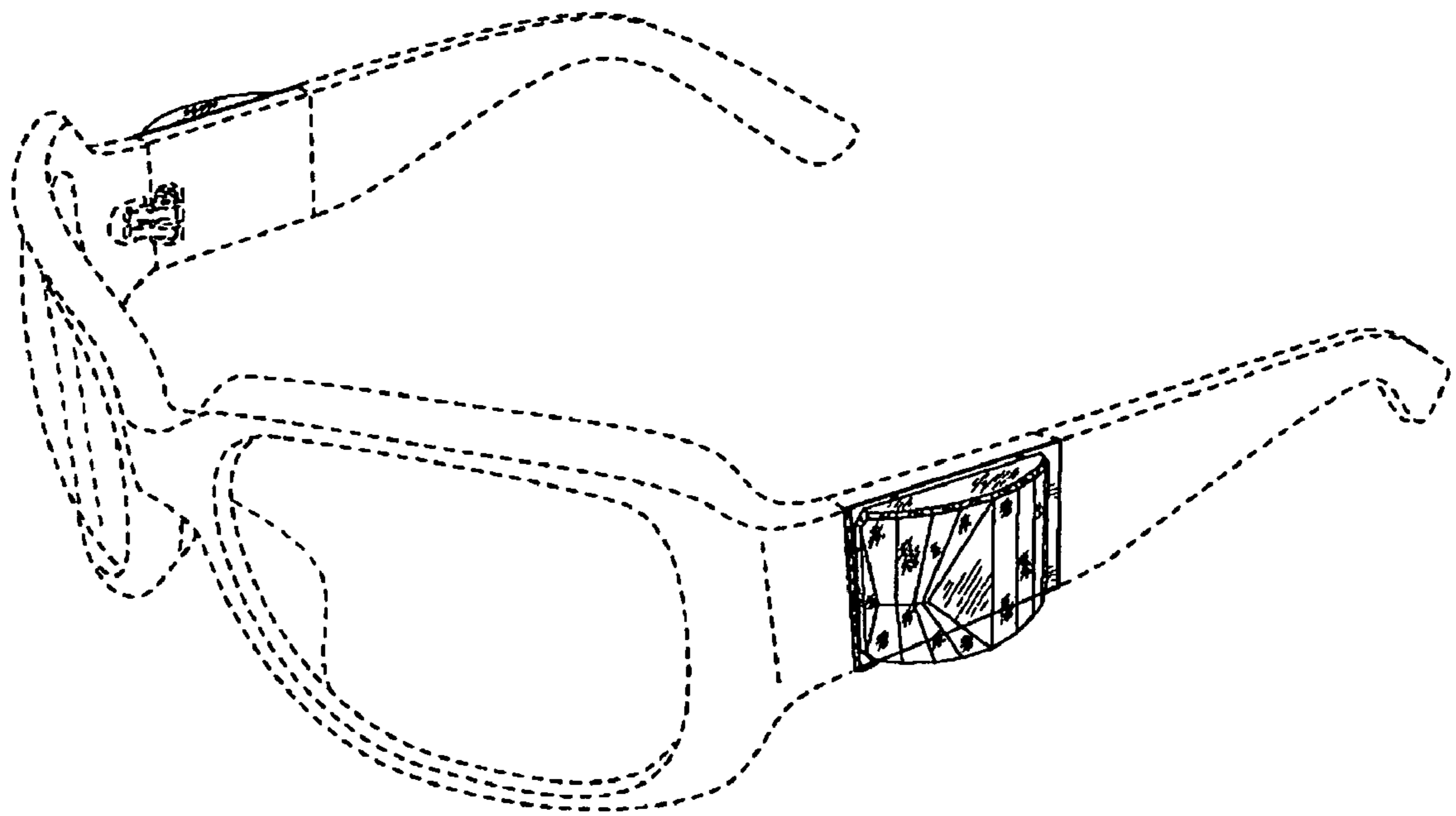

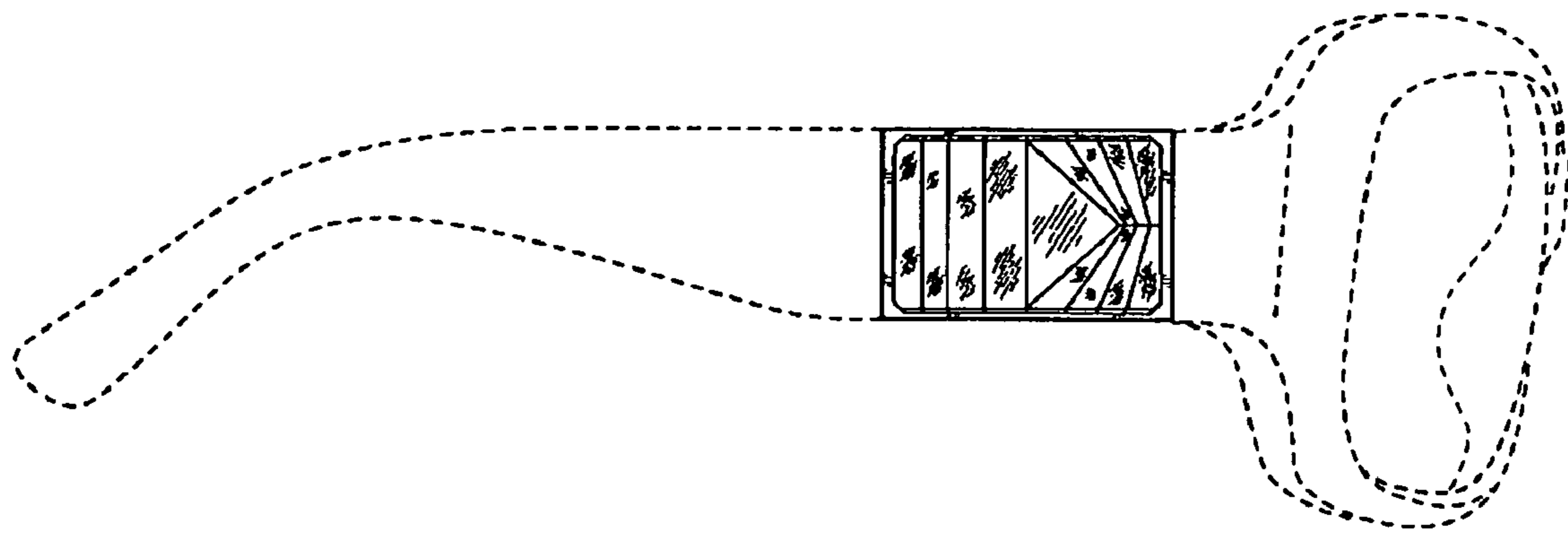

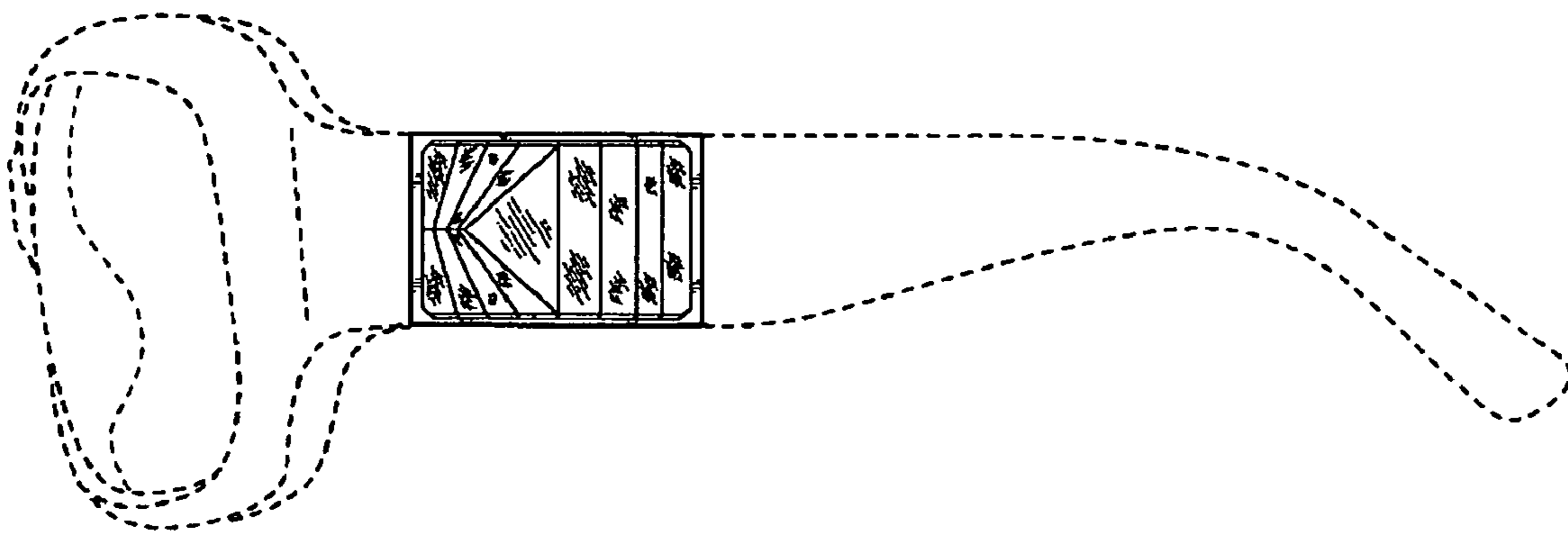

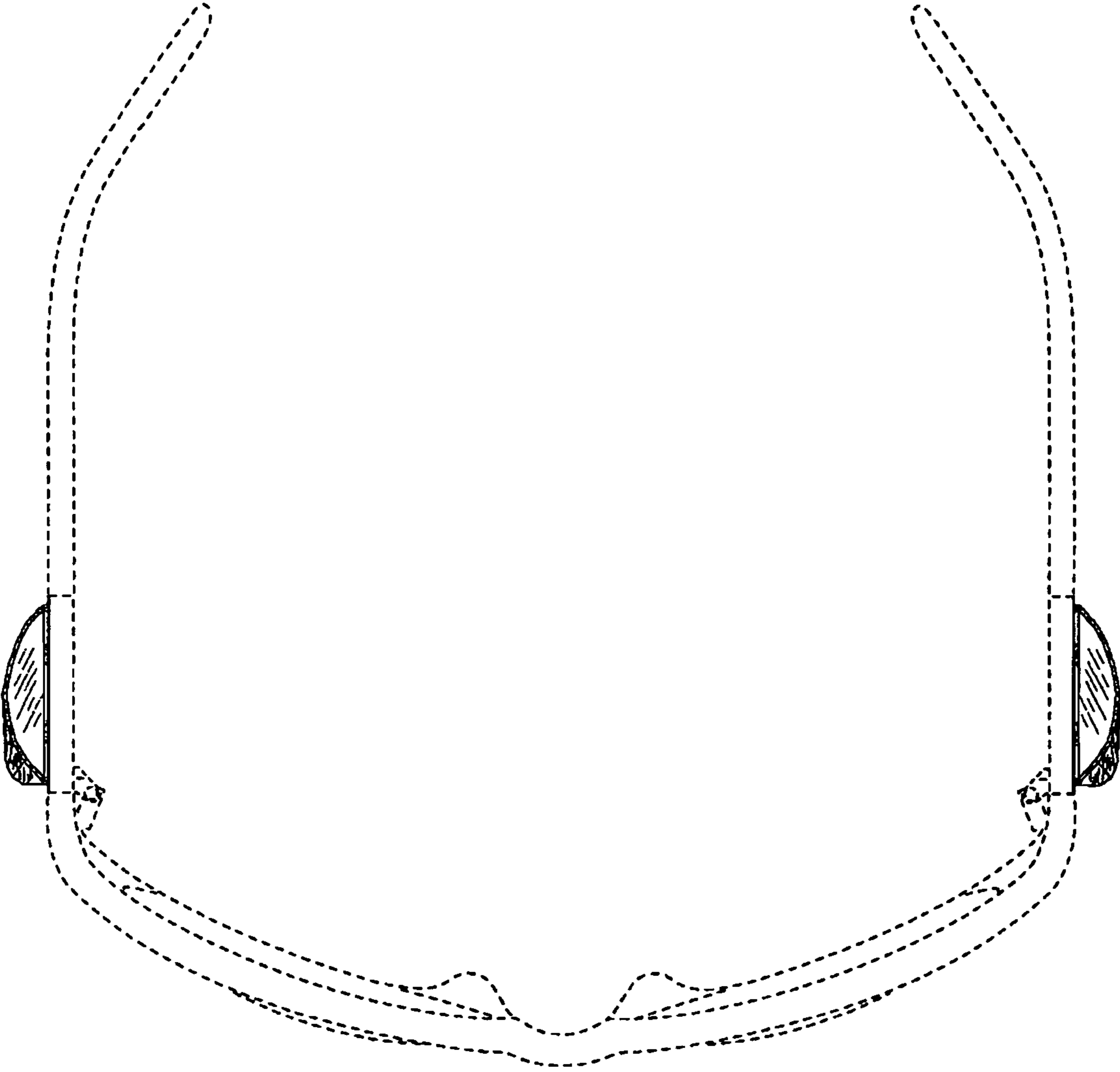

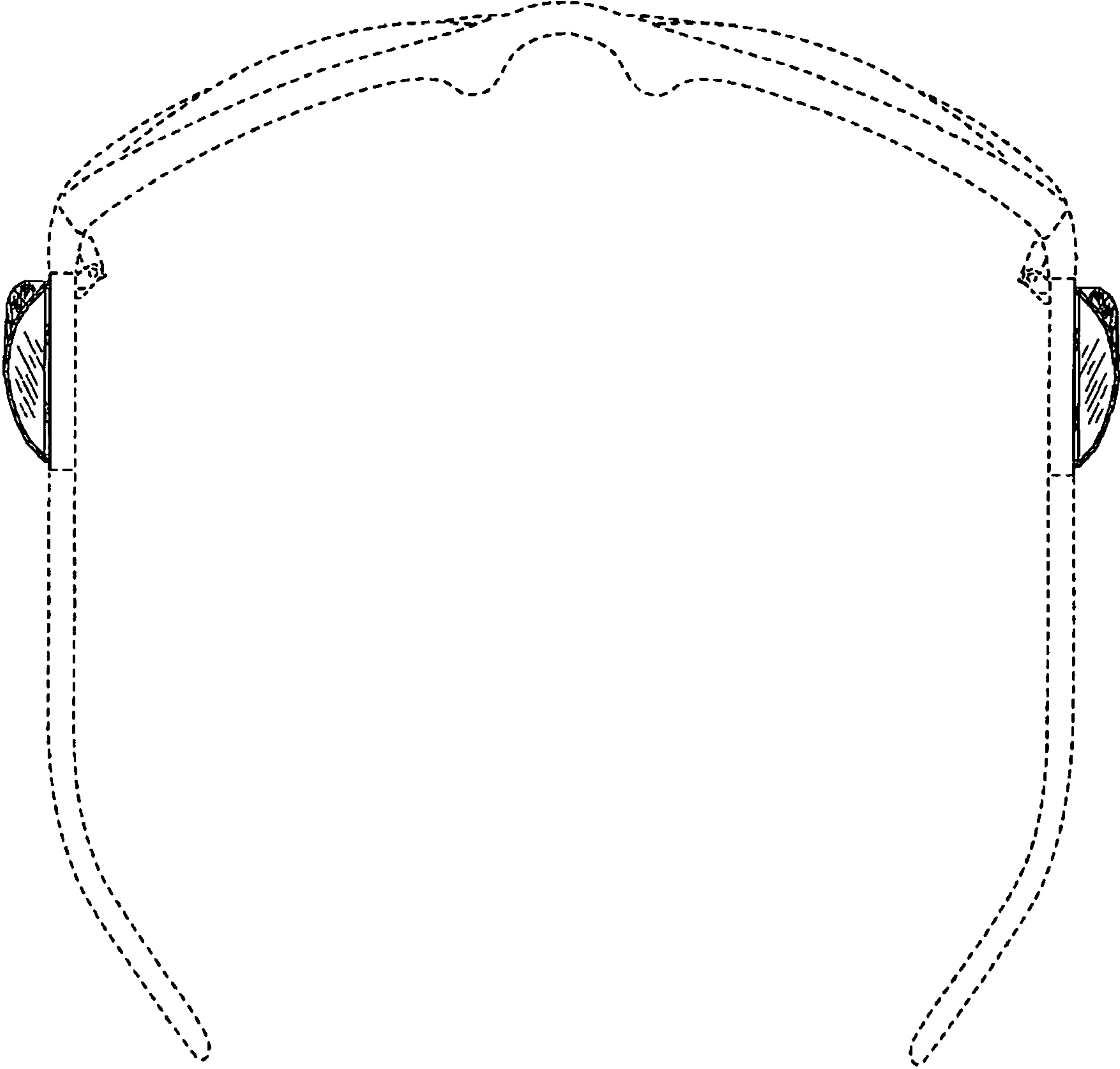

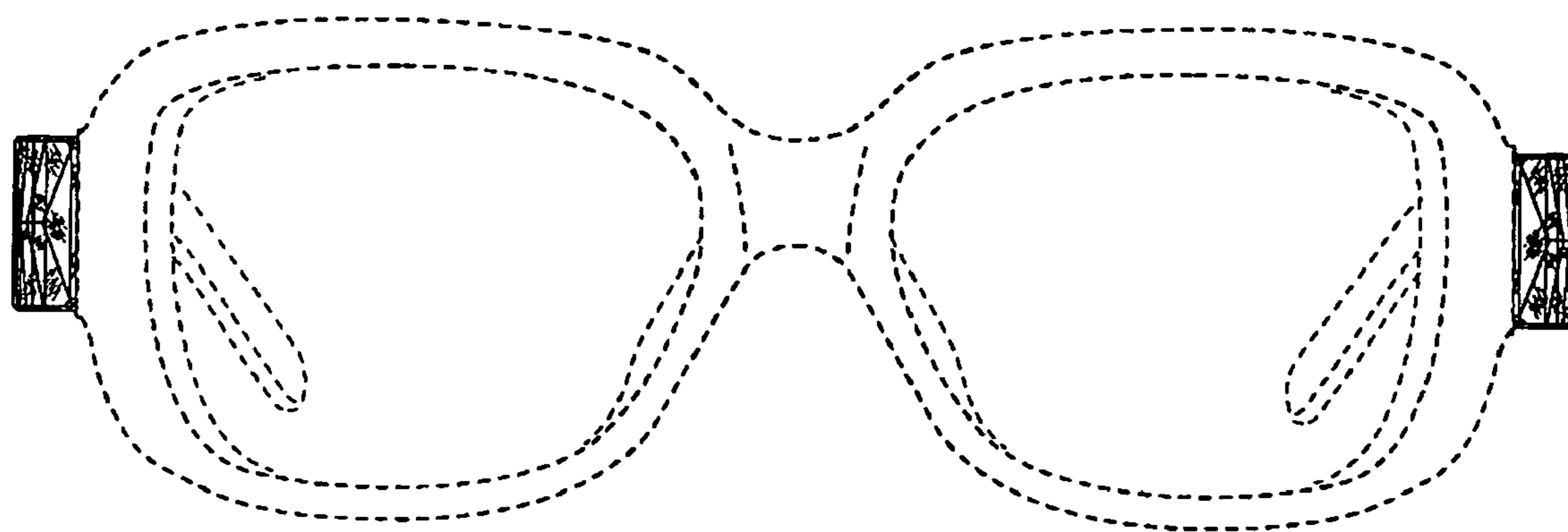

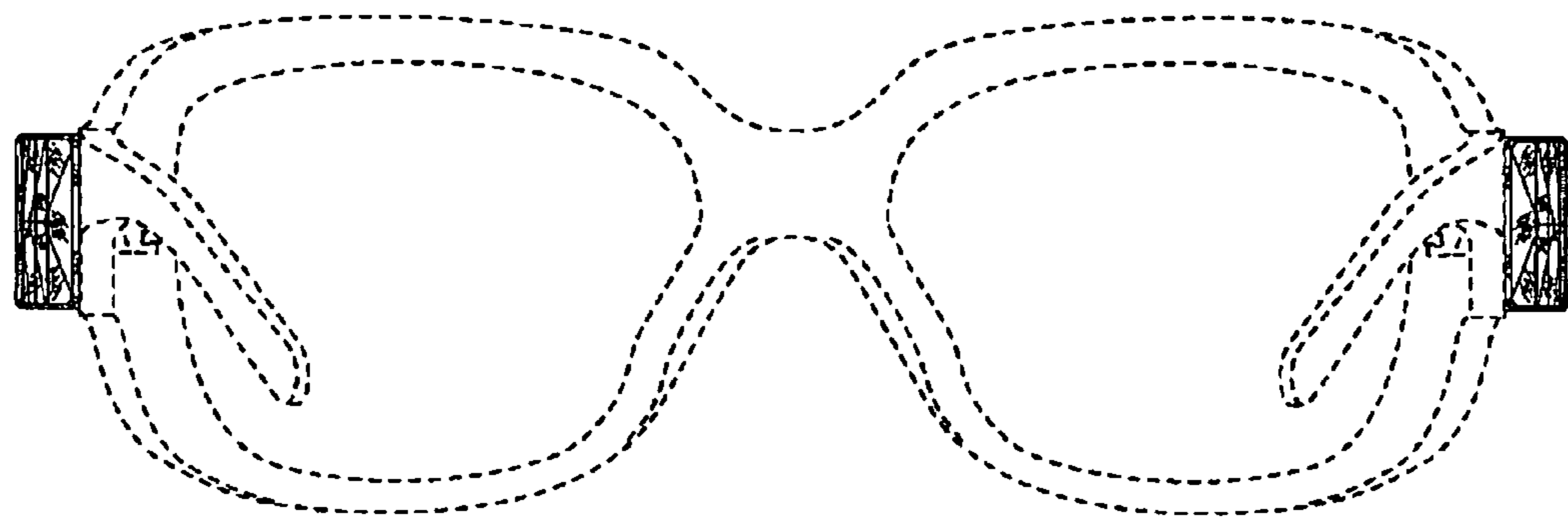
