(57) **CLAIM**

The ornamental design for a dental cleaner and massager tip, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a dental cleaner and massager tip showing our new design;

FIG. 2 is a bottom, back perspective view thereof;

FIG. 3 is a front elevational view thereof, the back view being identical thereto;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

FIG. 6 is top, front perspective view of a modified embodiment of the design shown in FIGS. 1 through 5;

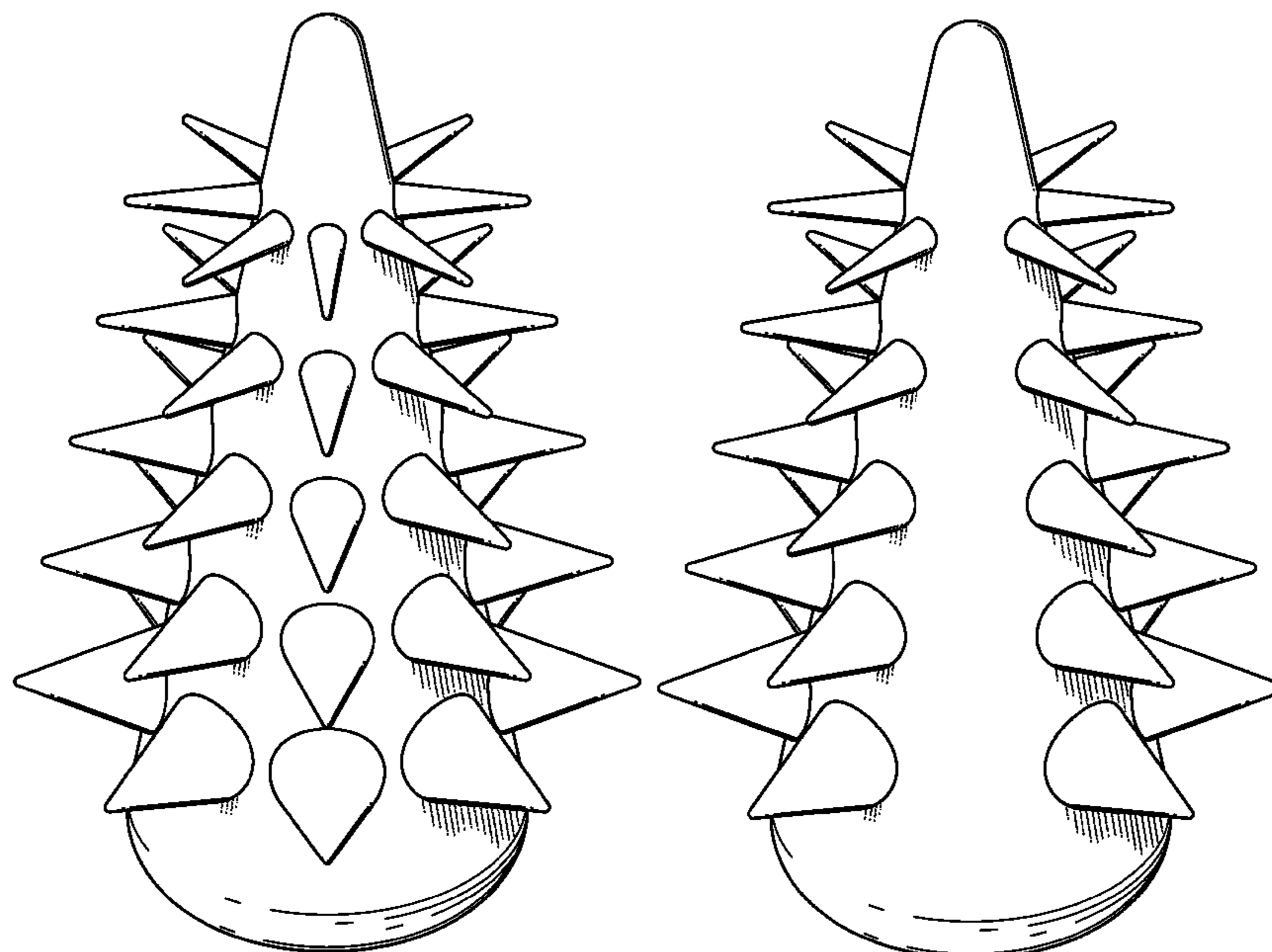
FIG. 7 is a bottom, back perspective view thereof;

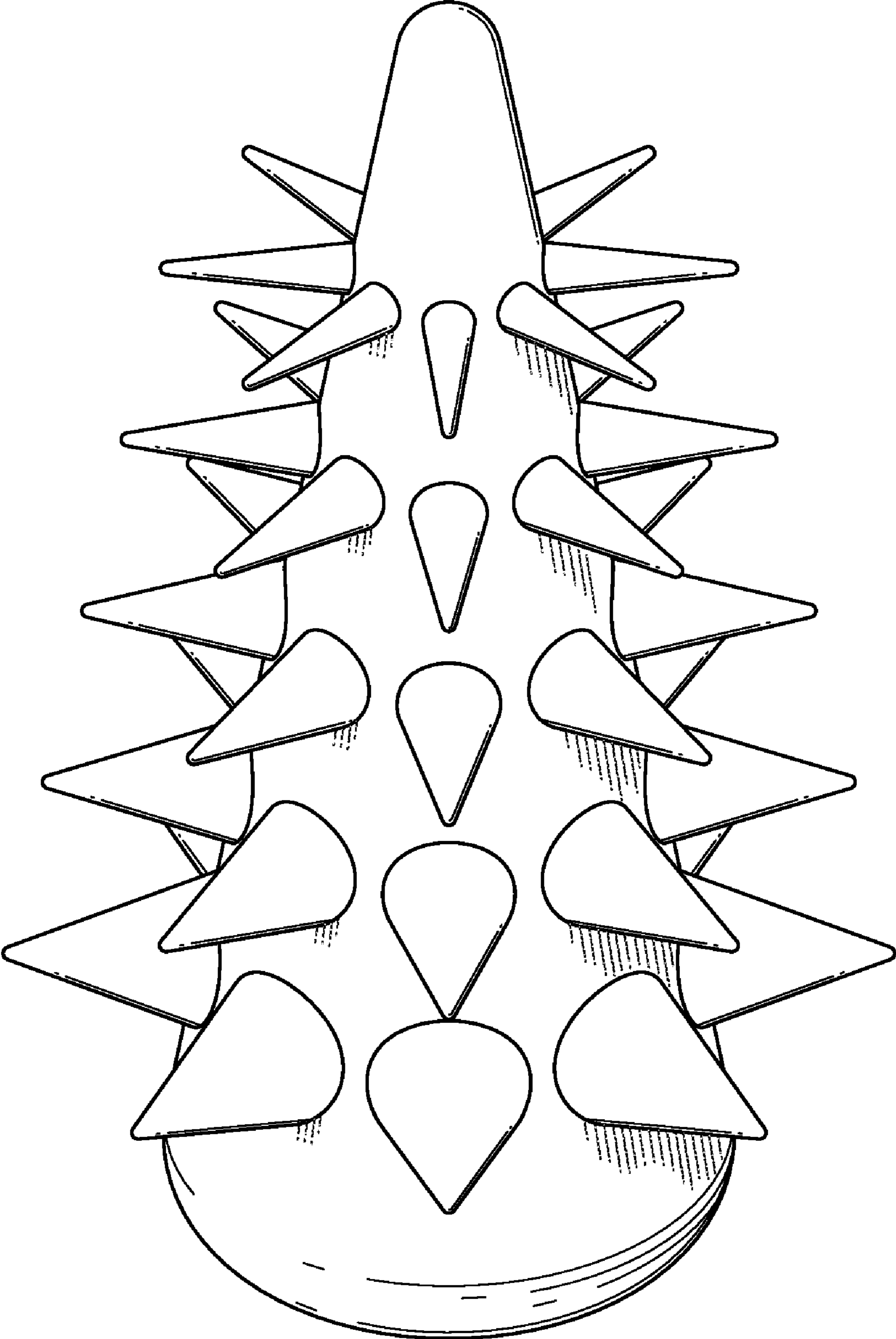

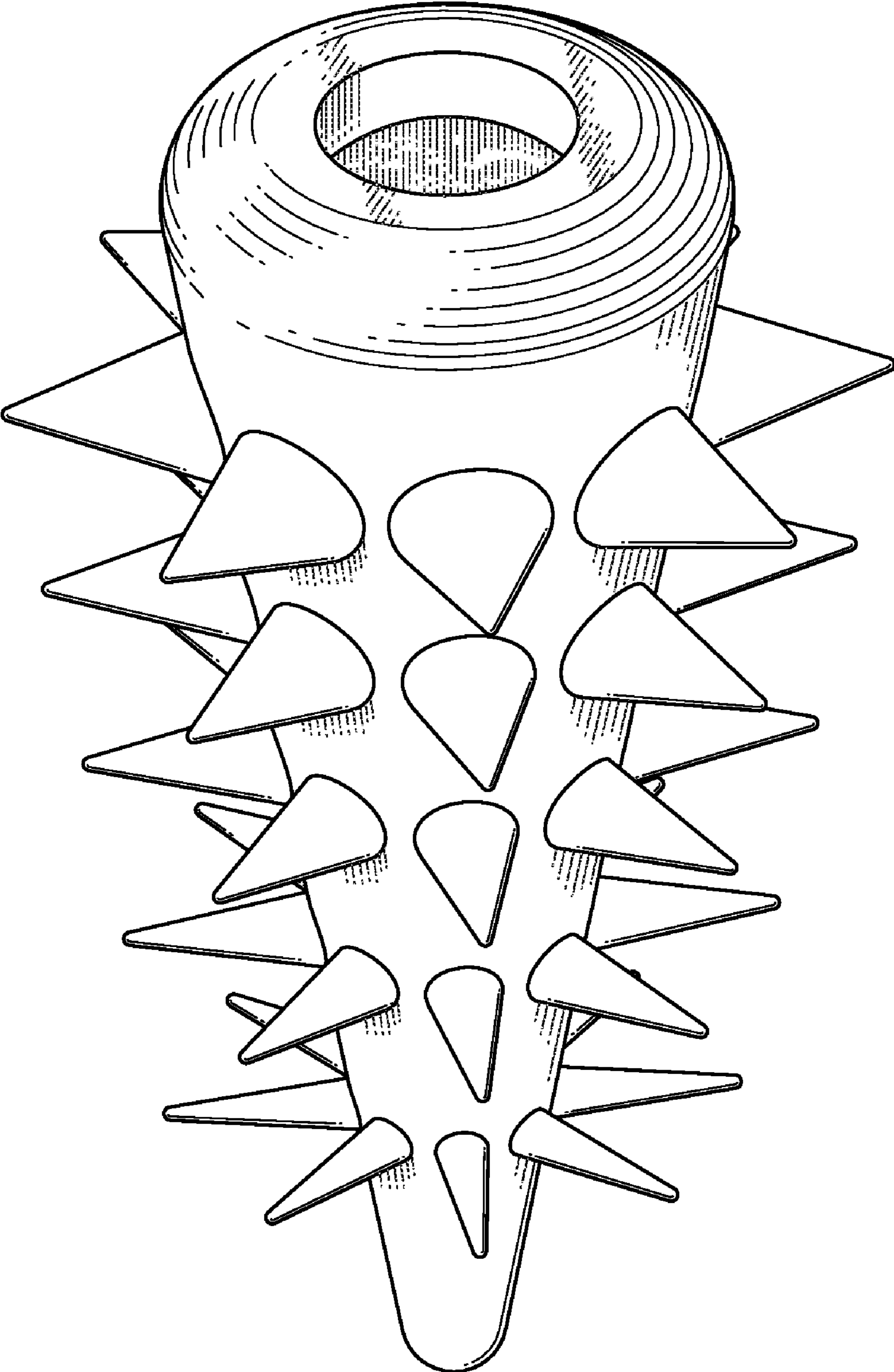

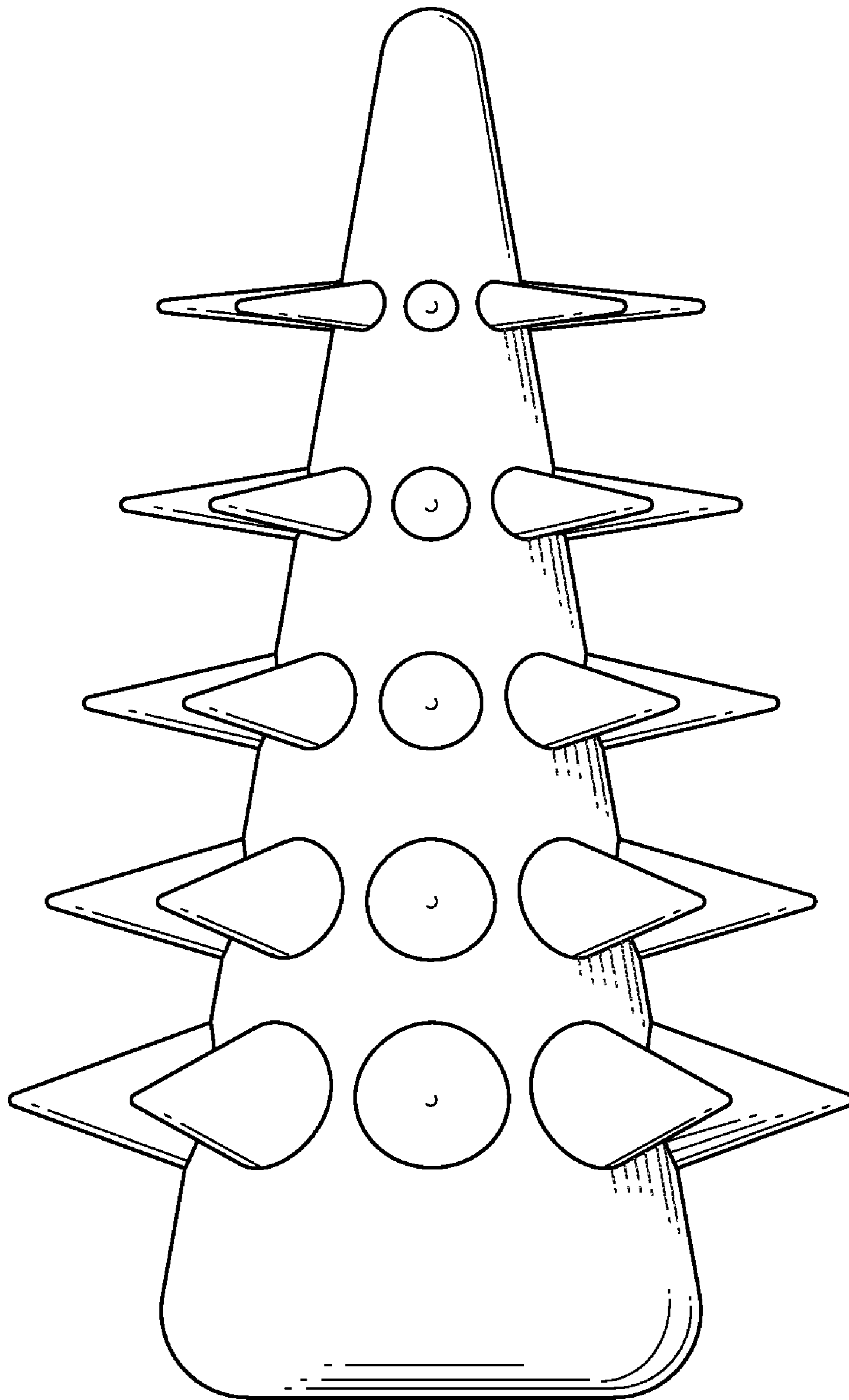

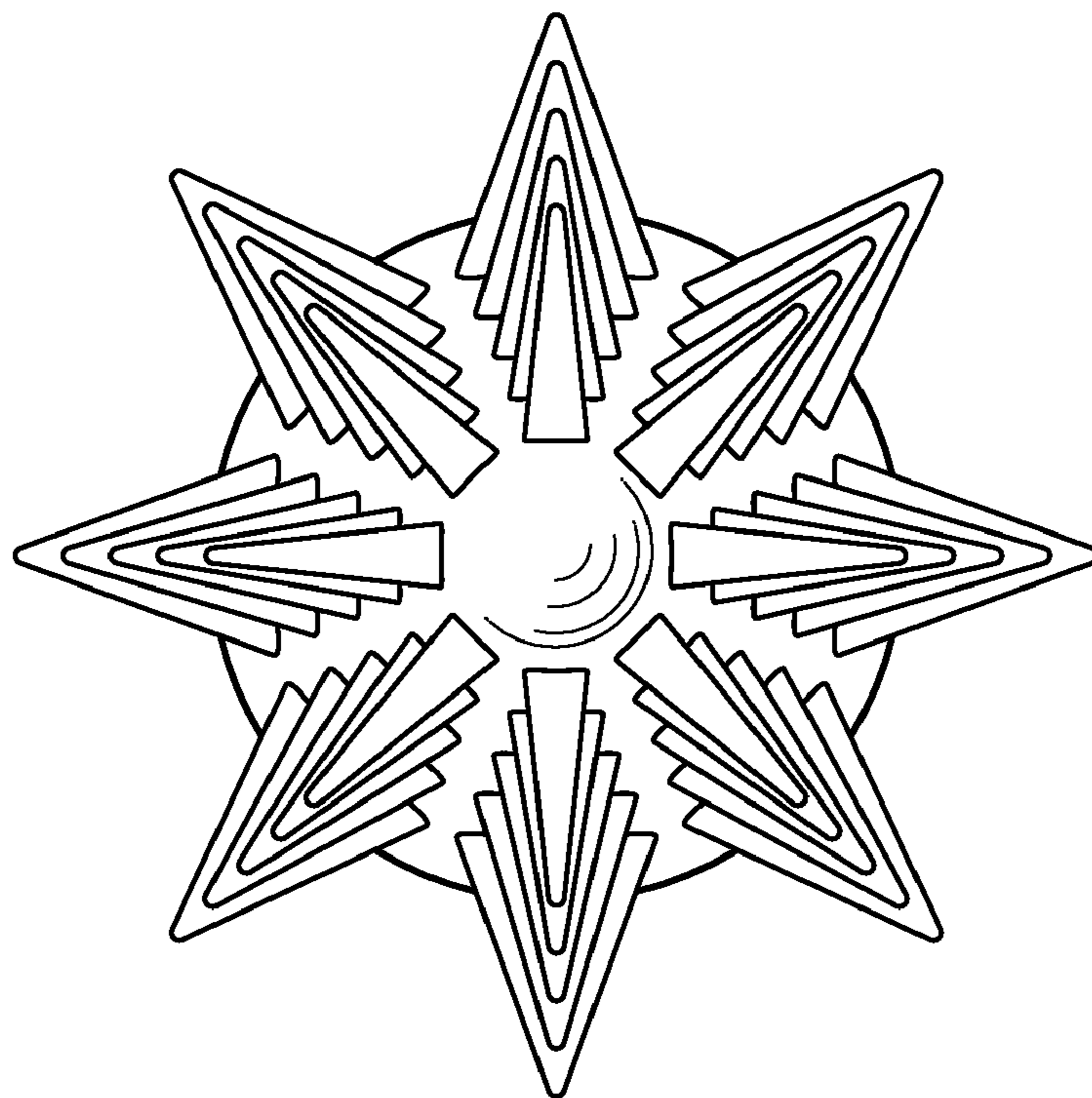

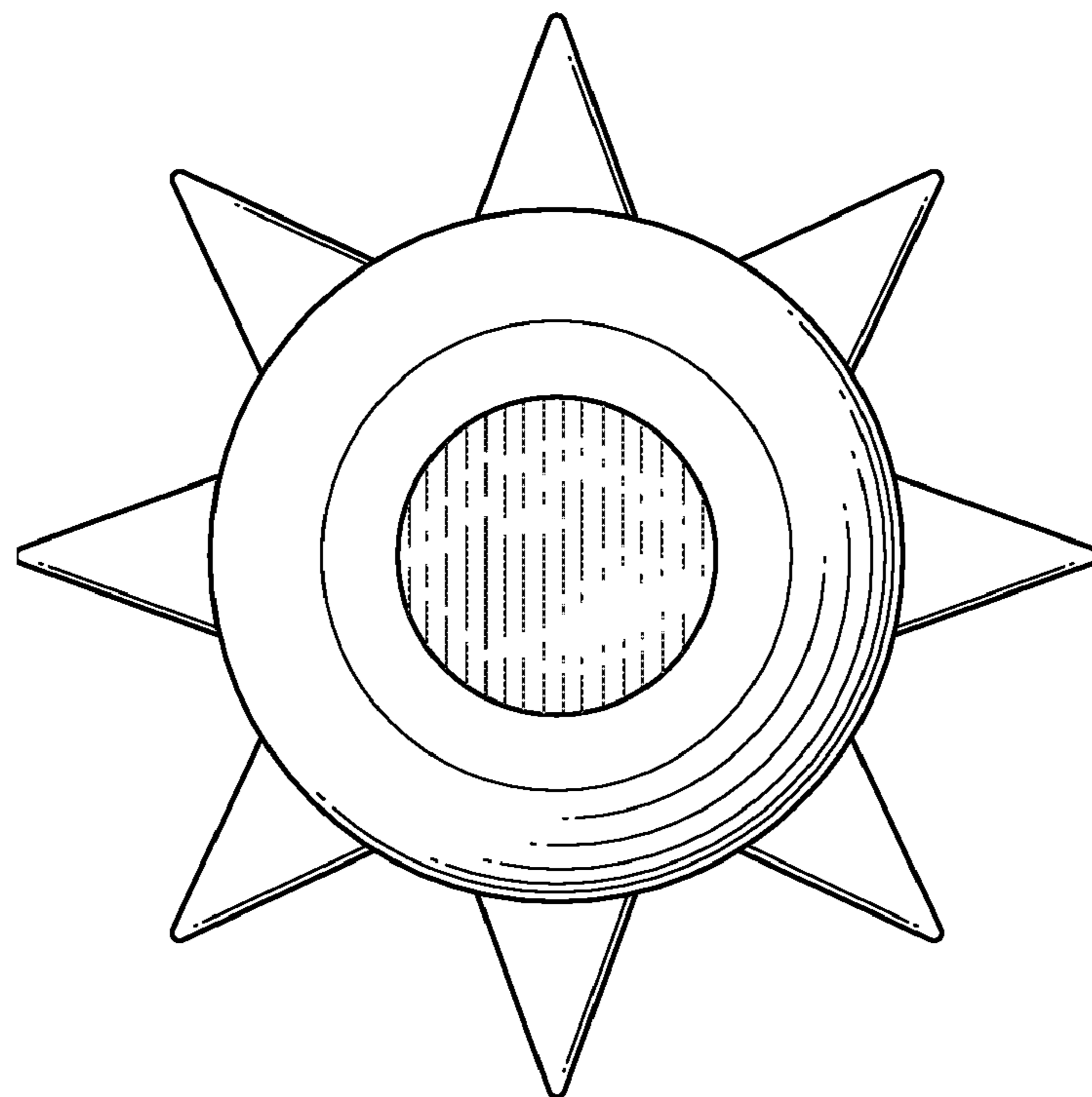

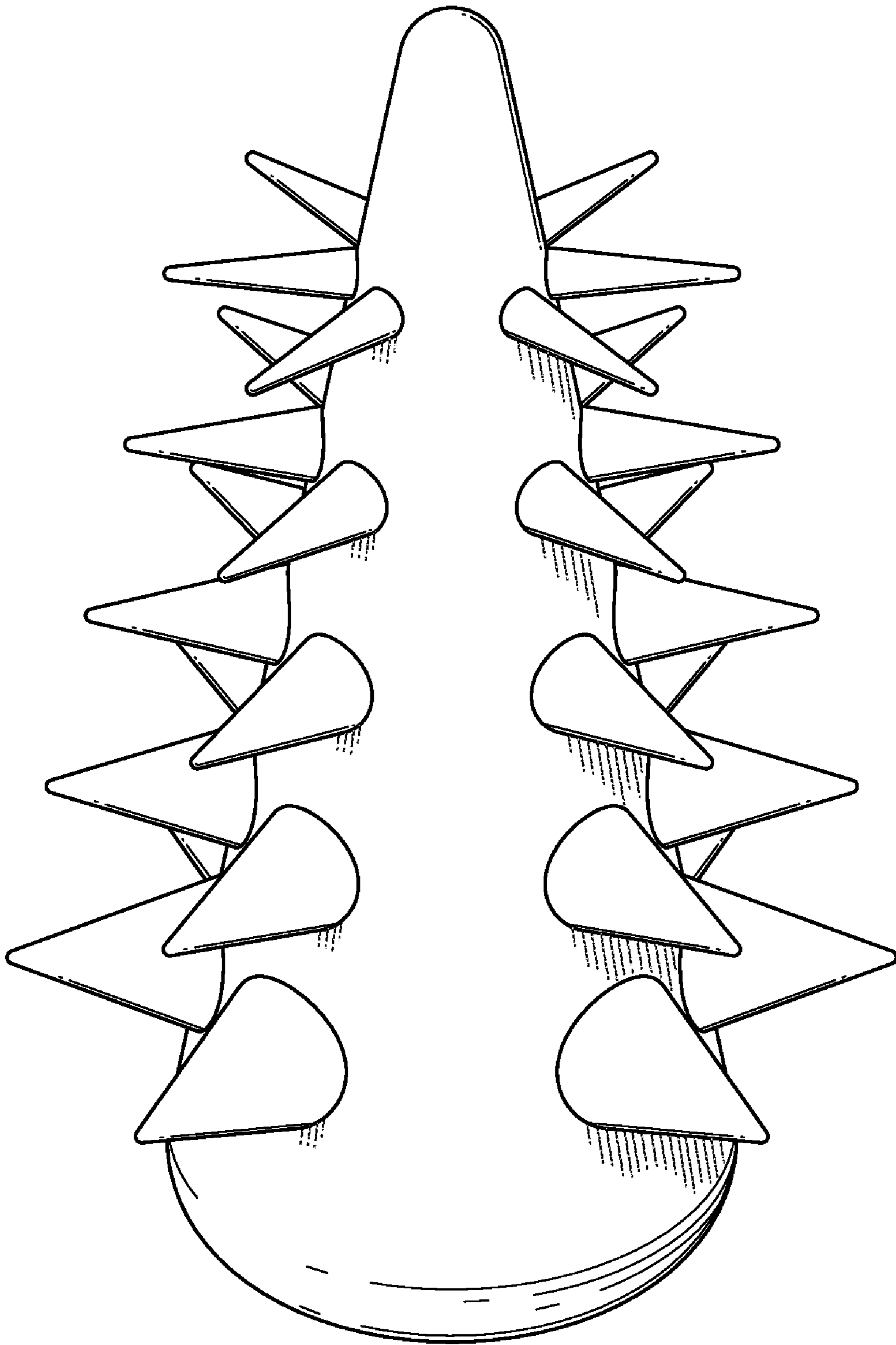

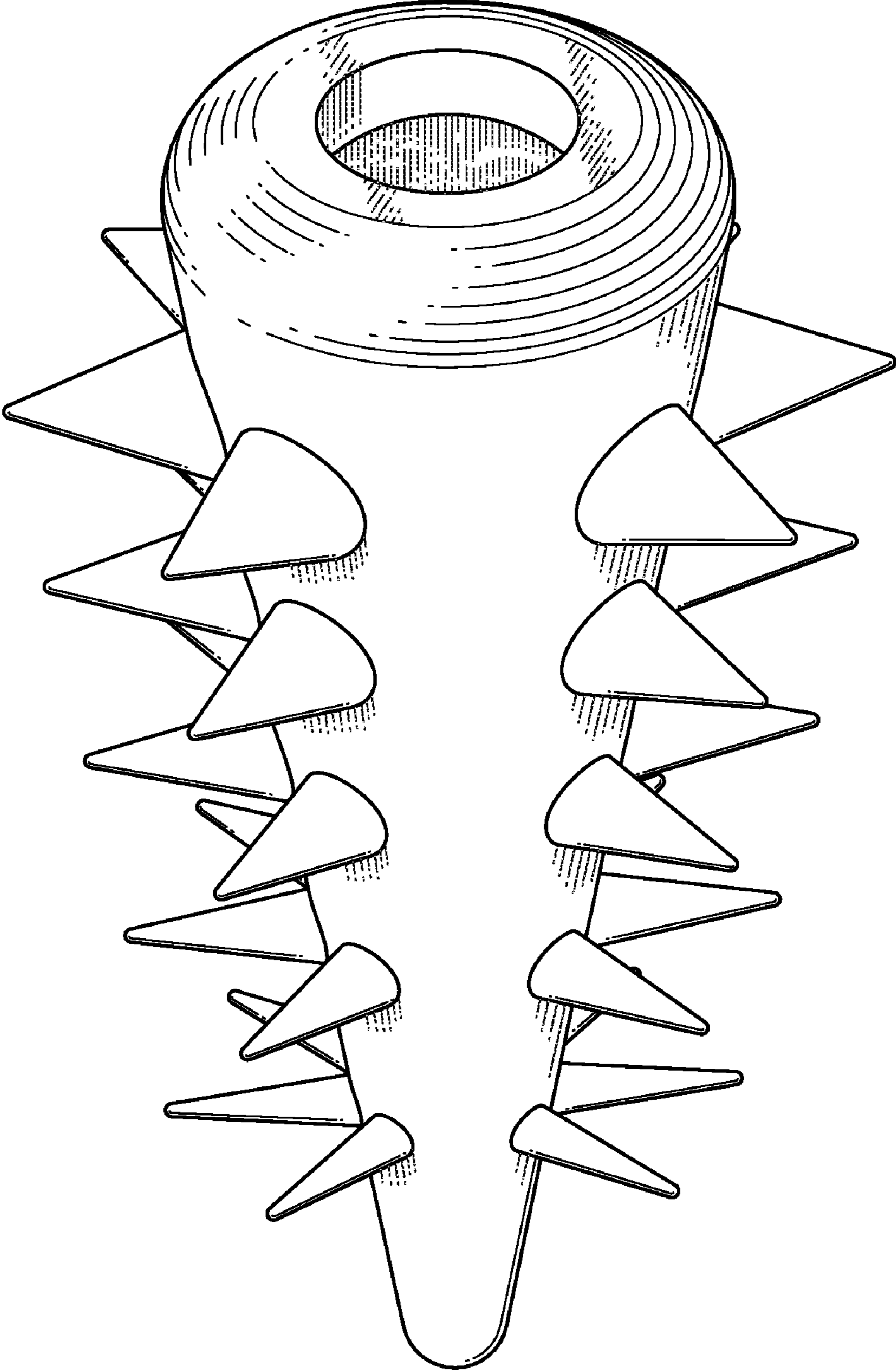

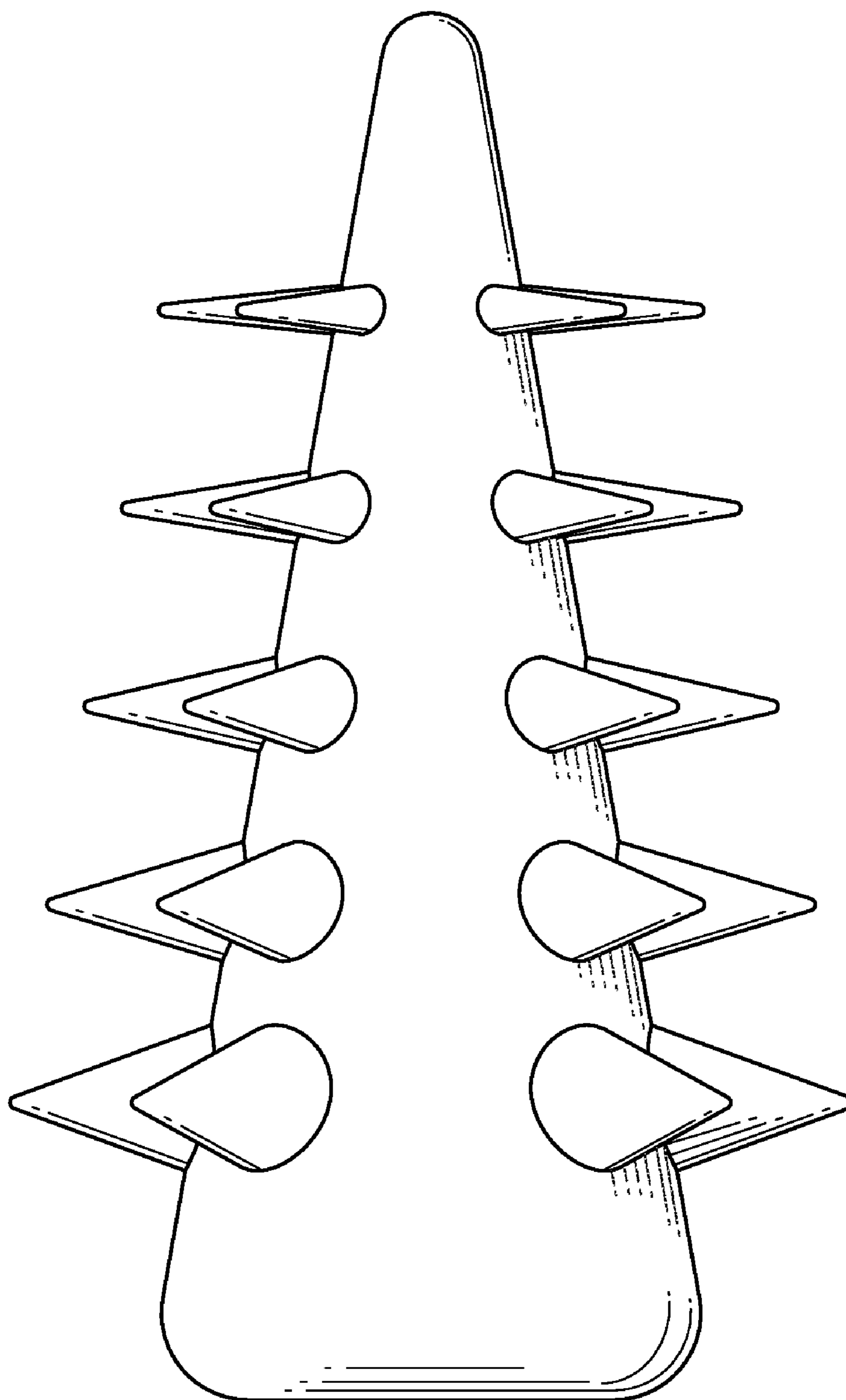

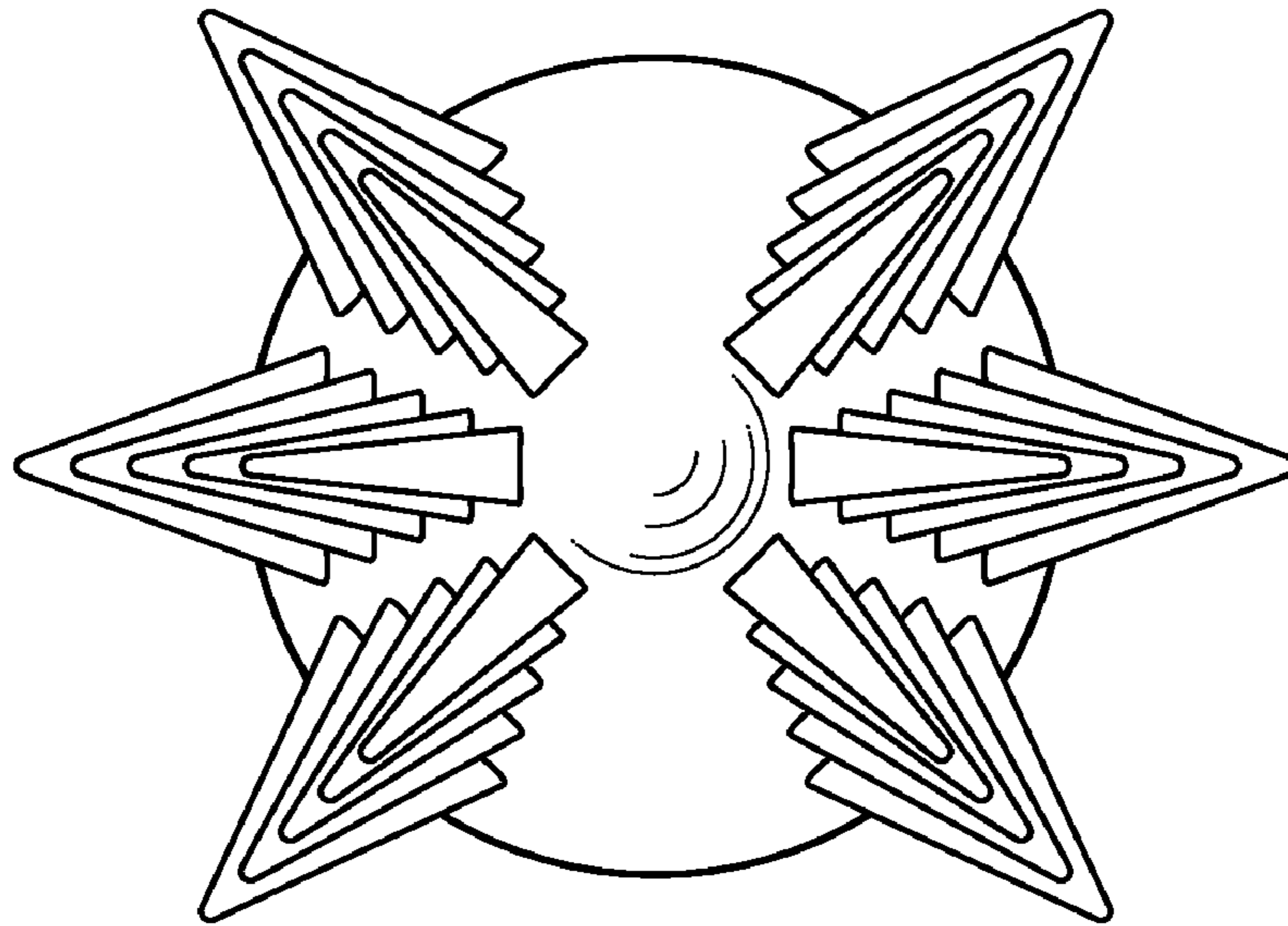

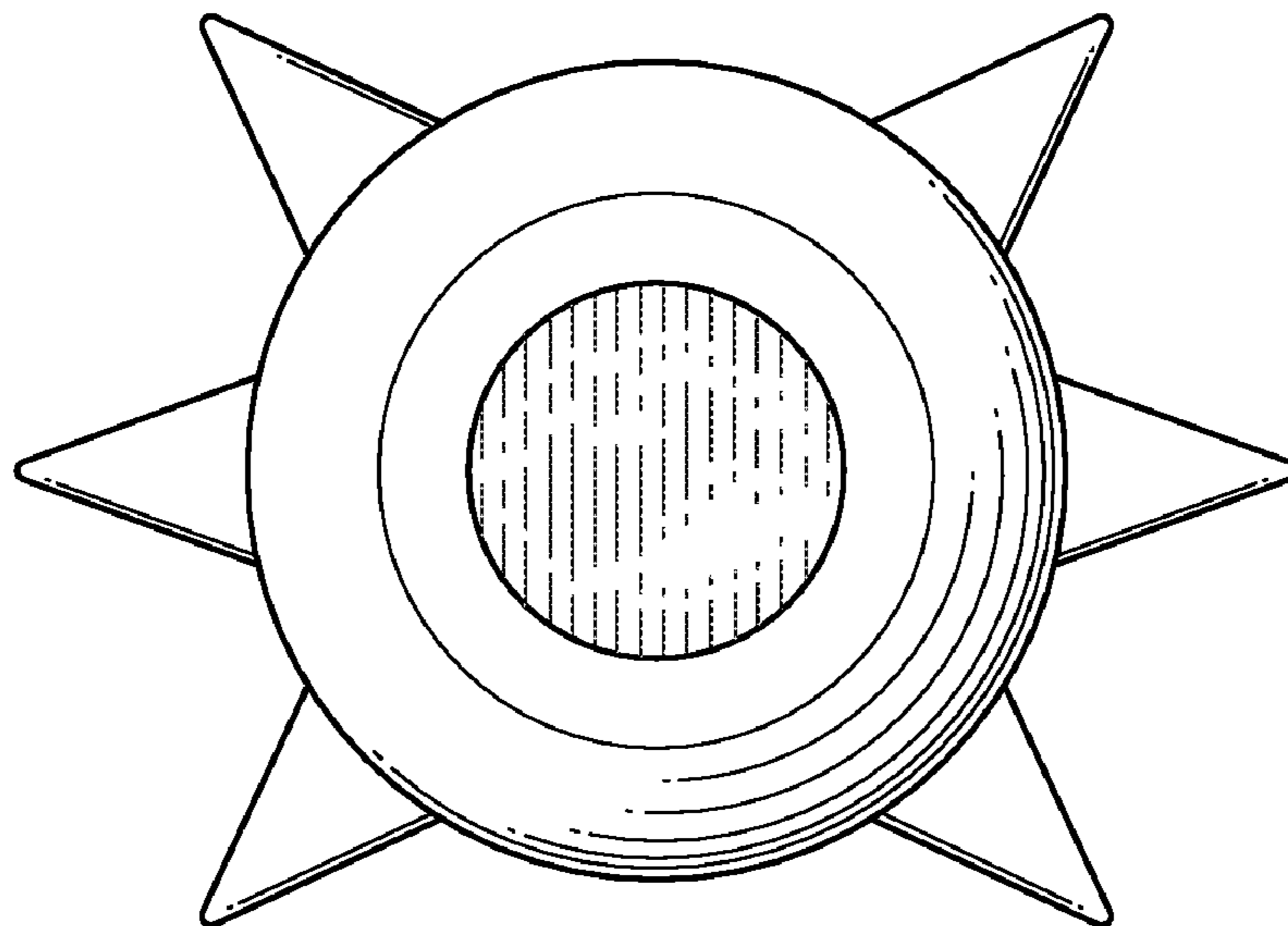
