(57) **CLAIM**

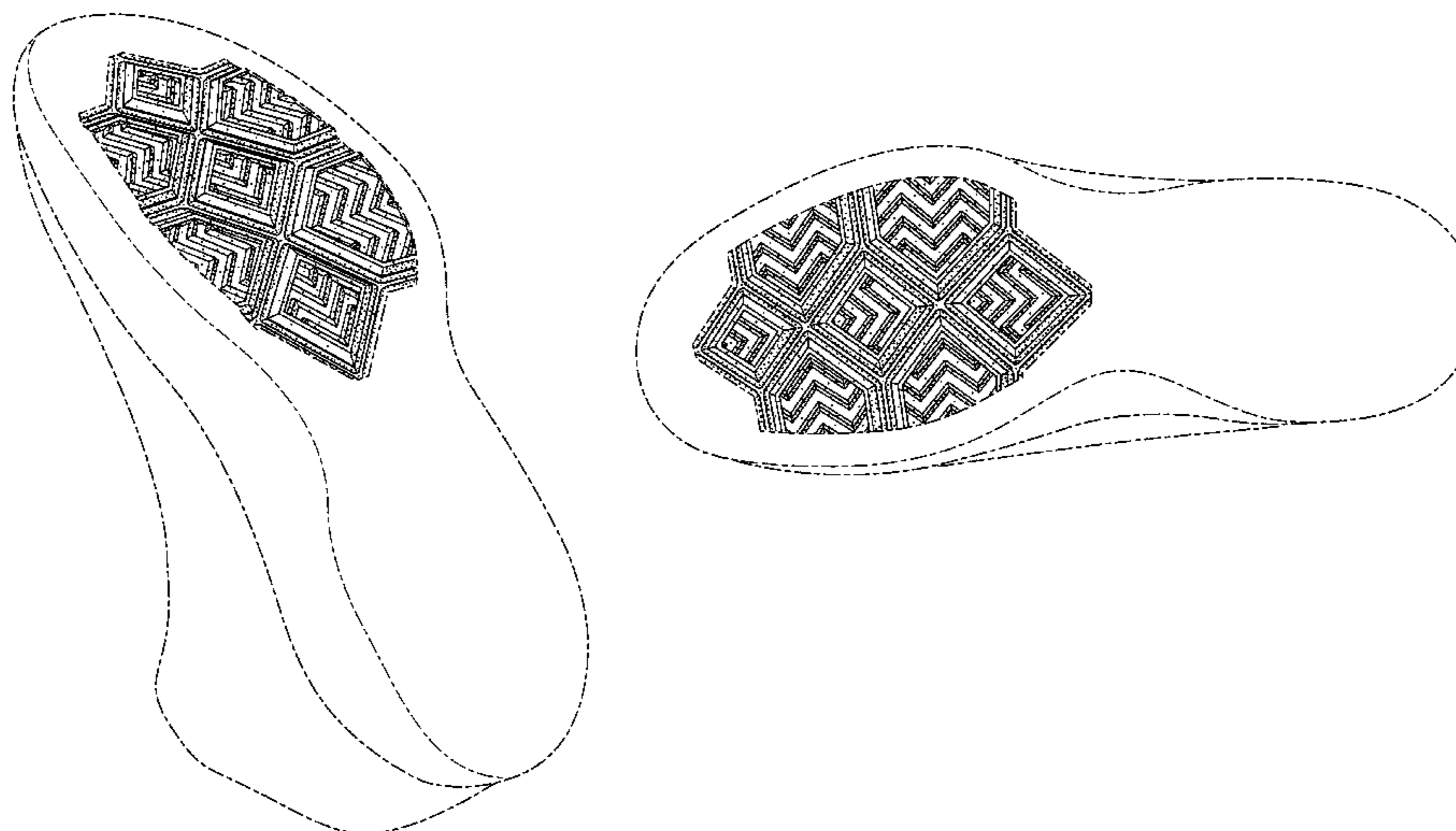
The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
FIG. 2 is a rear perspective view thereof; and,
FIG. 3 is a bottom view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken line showing of the remainder of the shoe is for environmental purposes only and forms no part of the claimed design.

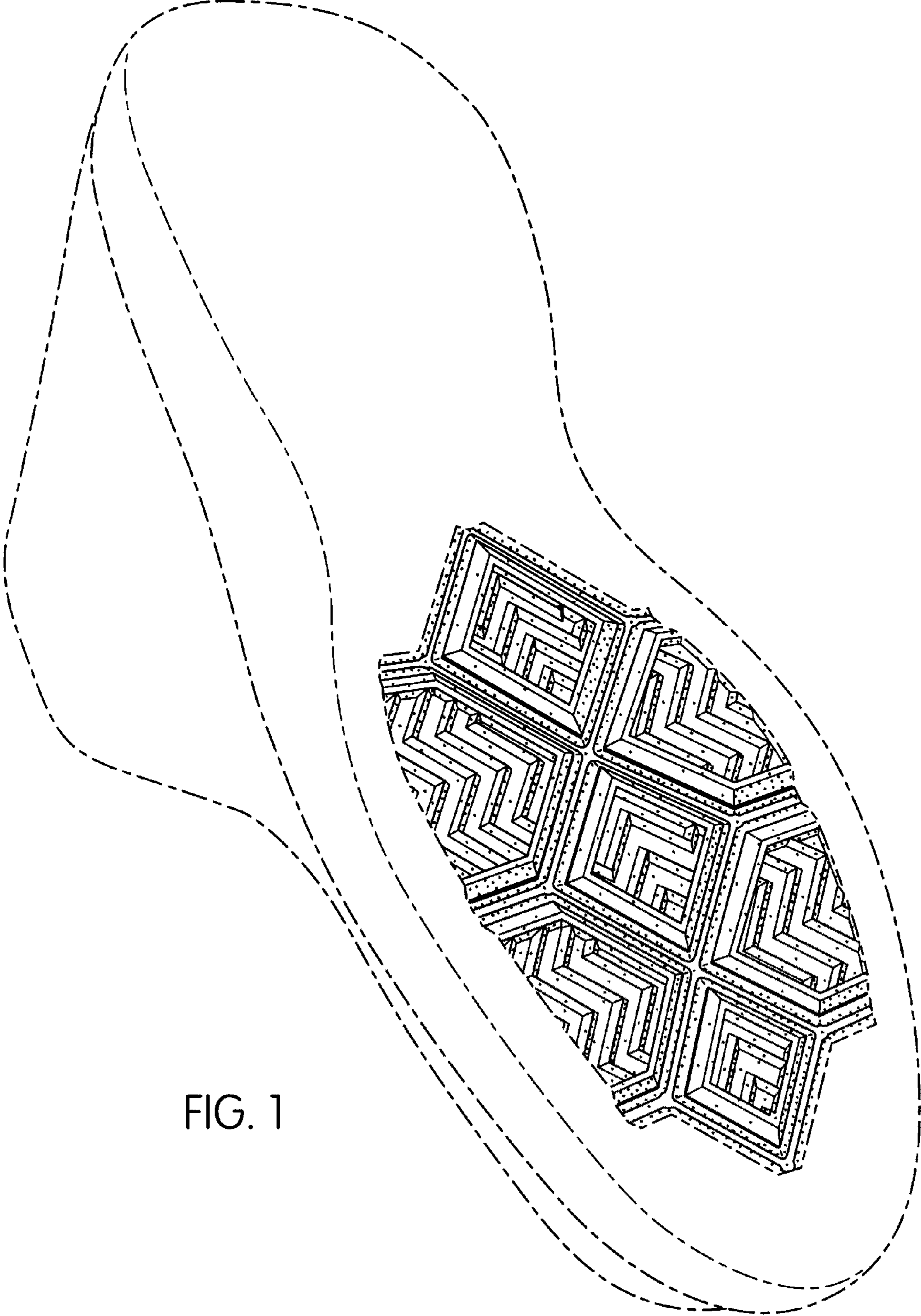

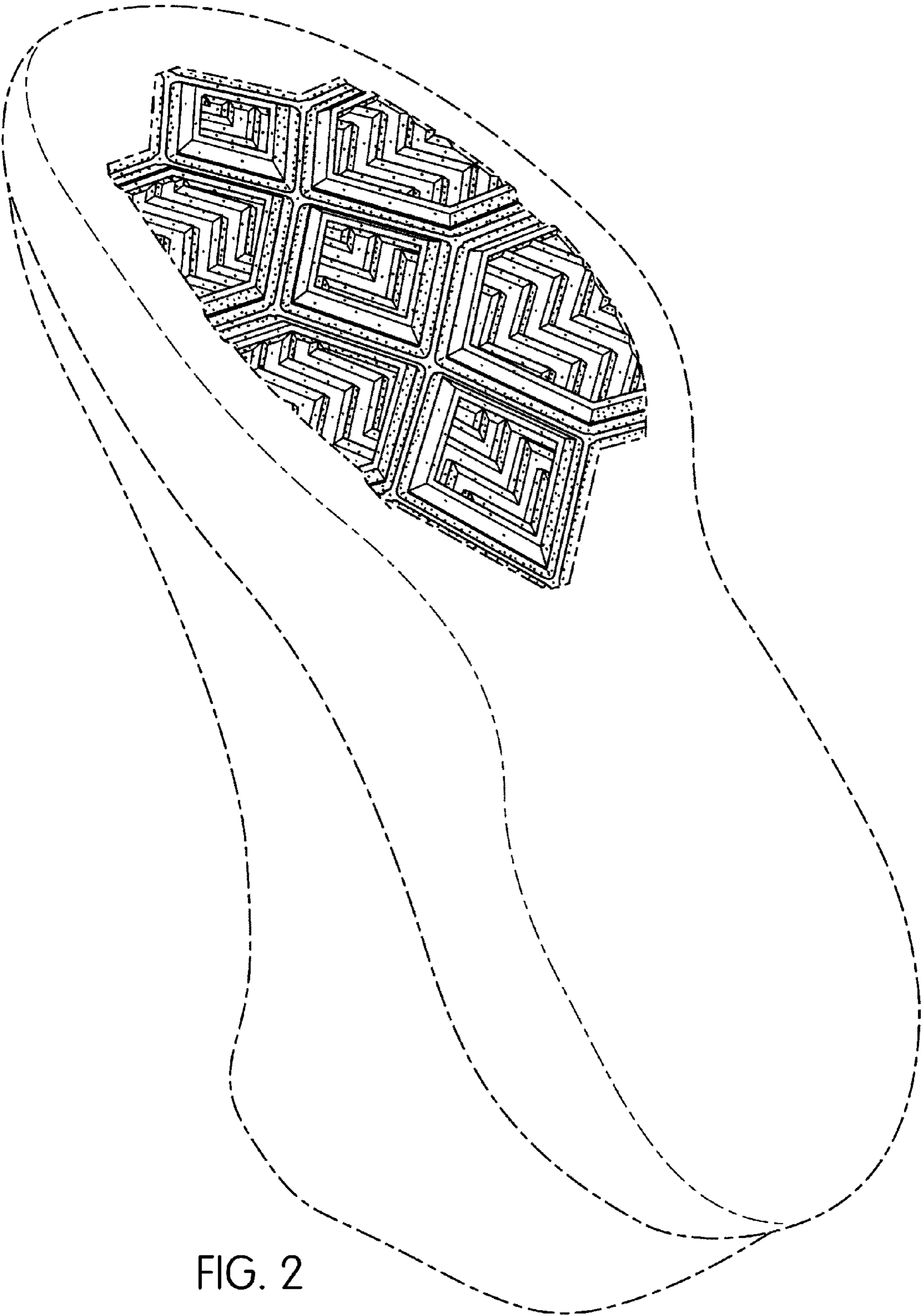

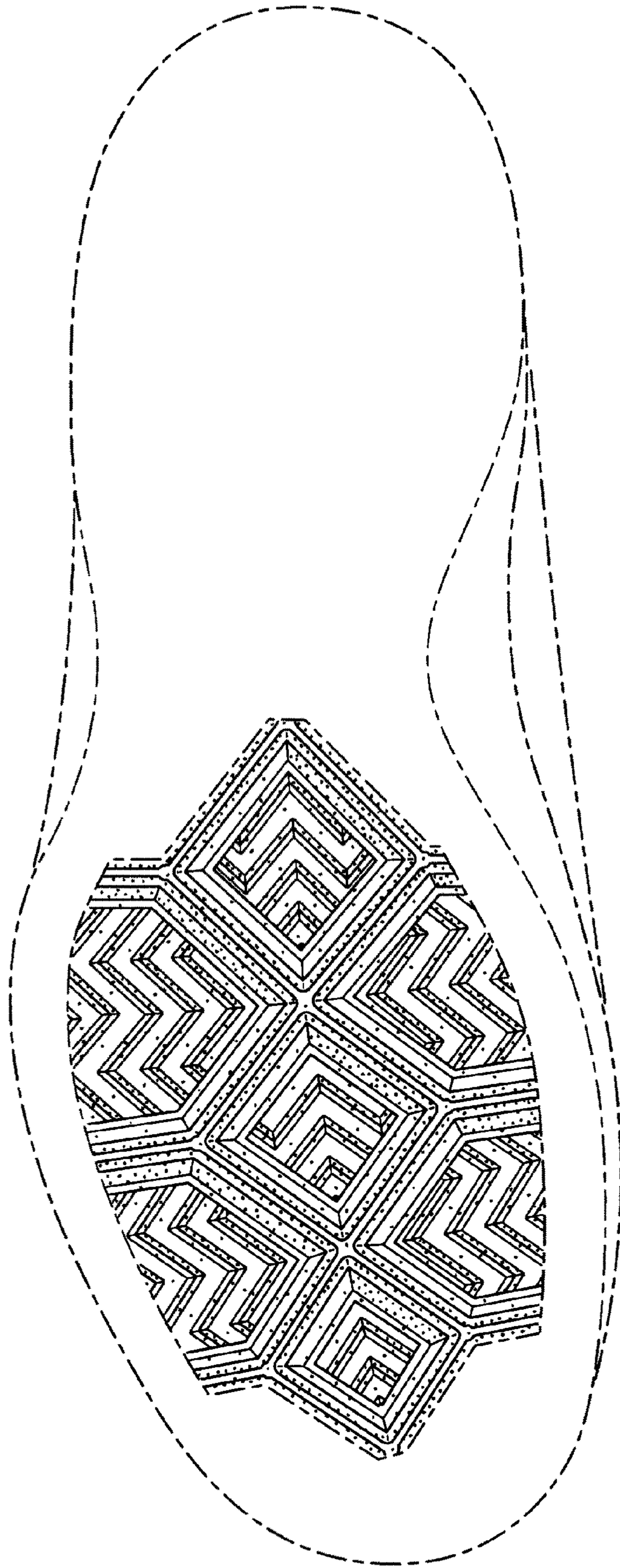
