**DESCRIPTION**

FIG. 1 is a side view of an accessory pouch according to our invention;

FIG. 2 is a front view of the pouch of FIG. 1;

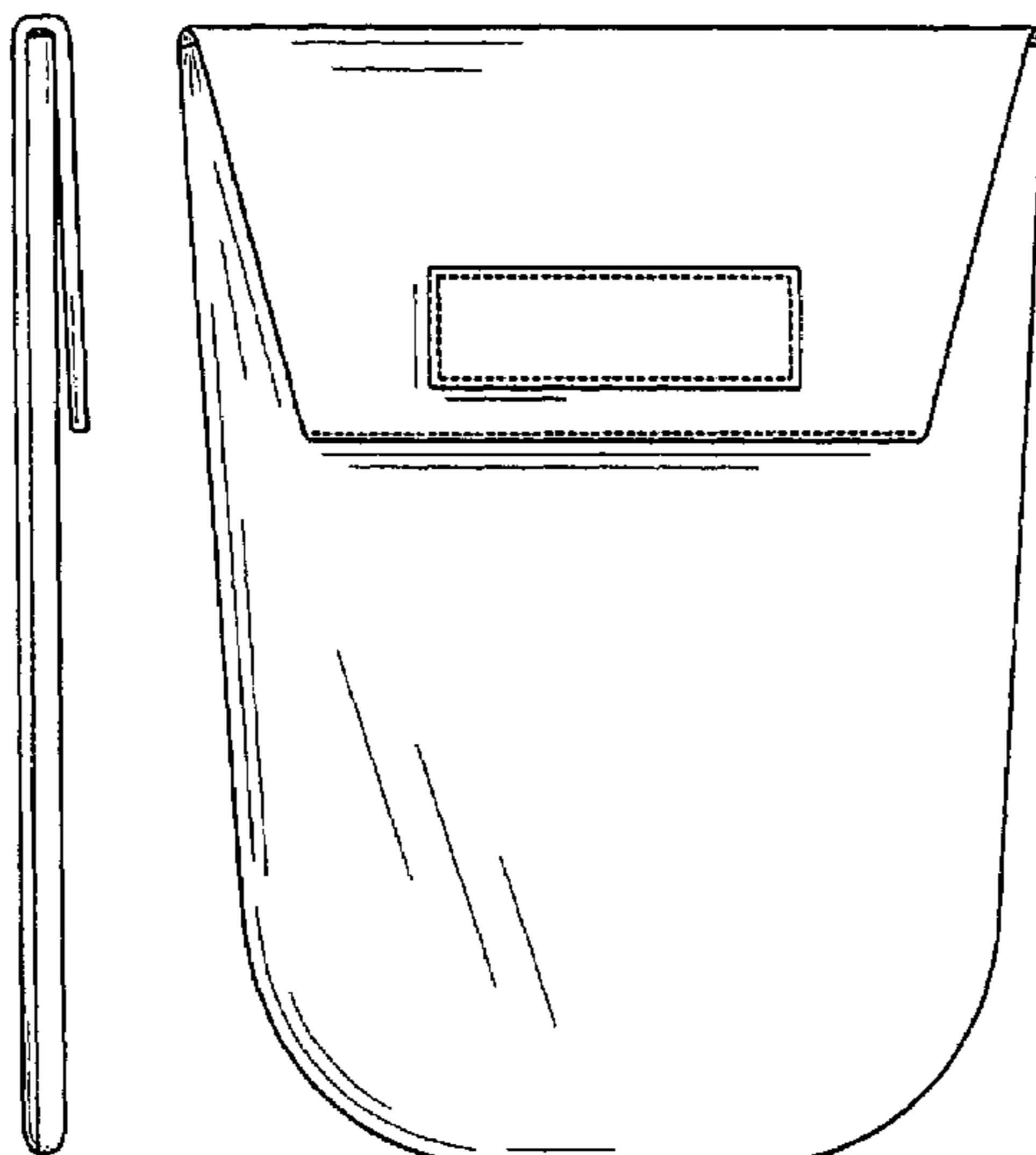
FIG. 3 is a rear view of the pouch of FIG. 1;

FIG. 5 is a rear view of the pouch of FIG. 1 with its top flap in an open position.

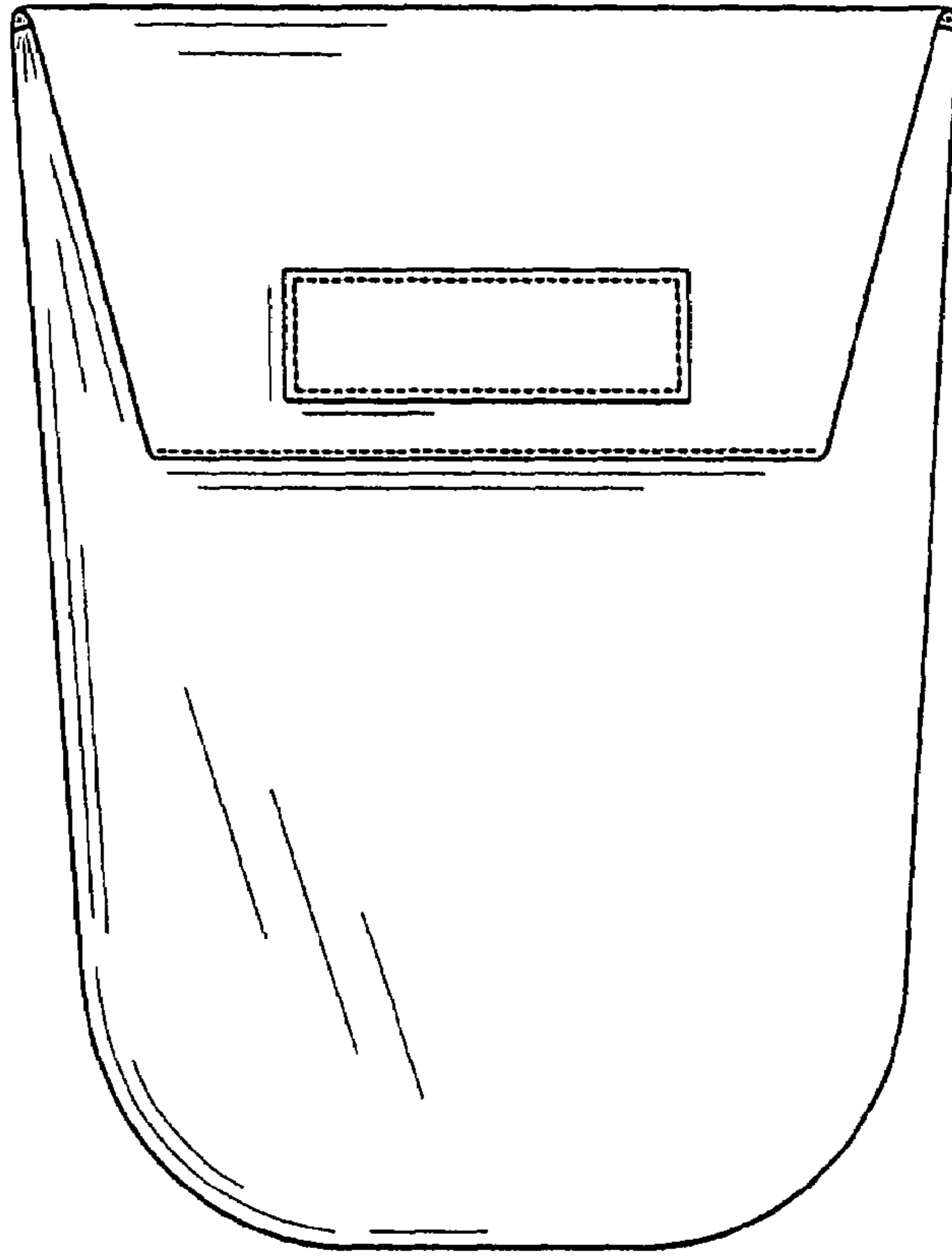
The broken lines in the drawings, indicating stitching, form part of the claimed design.

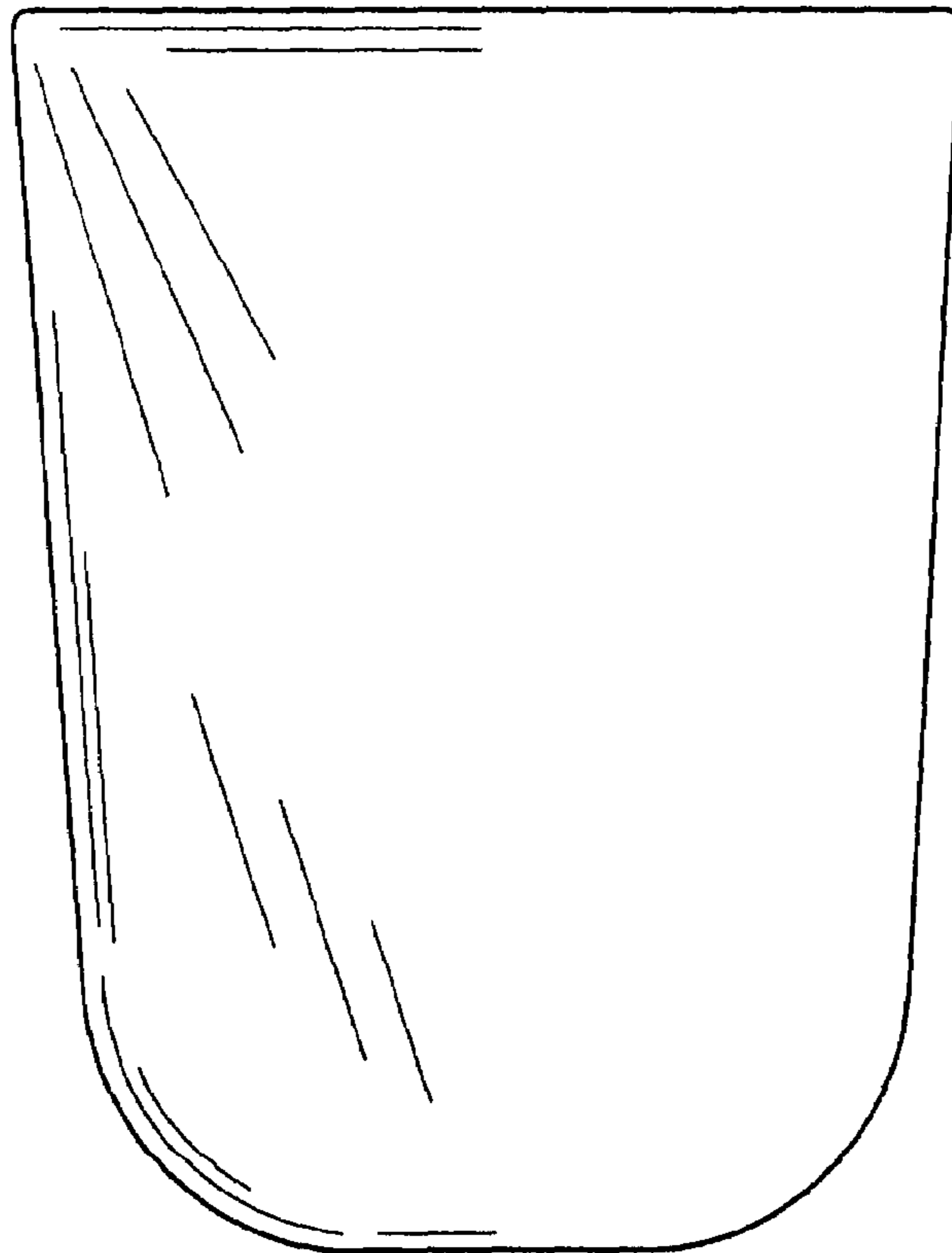




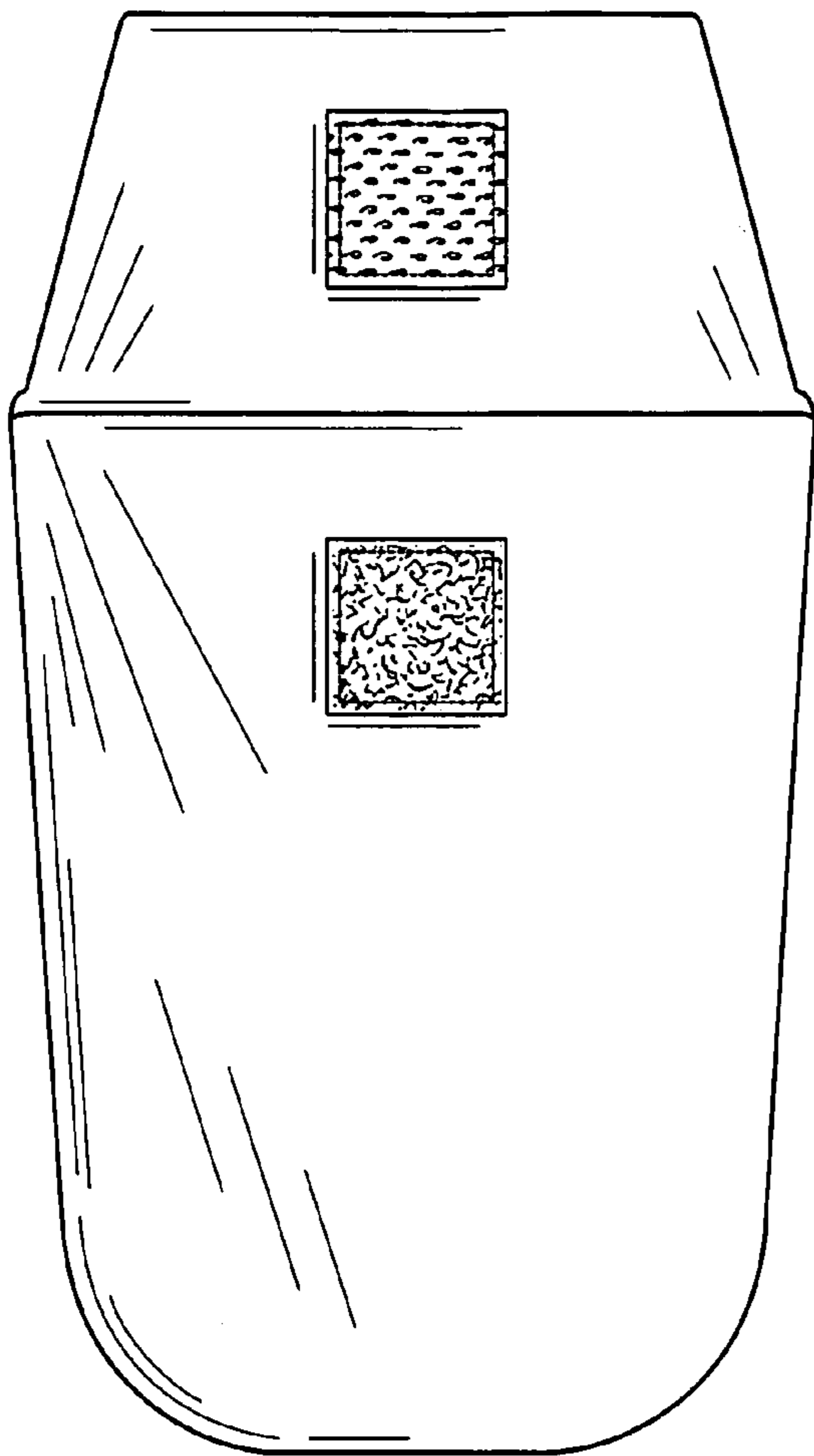

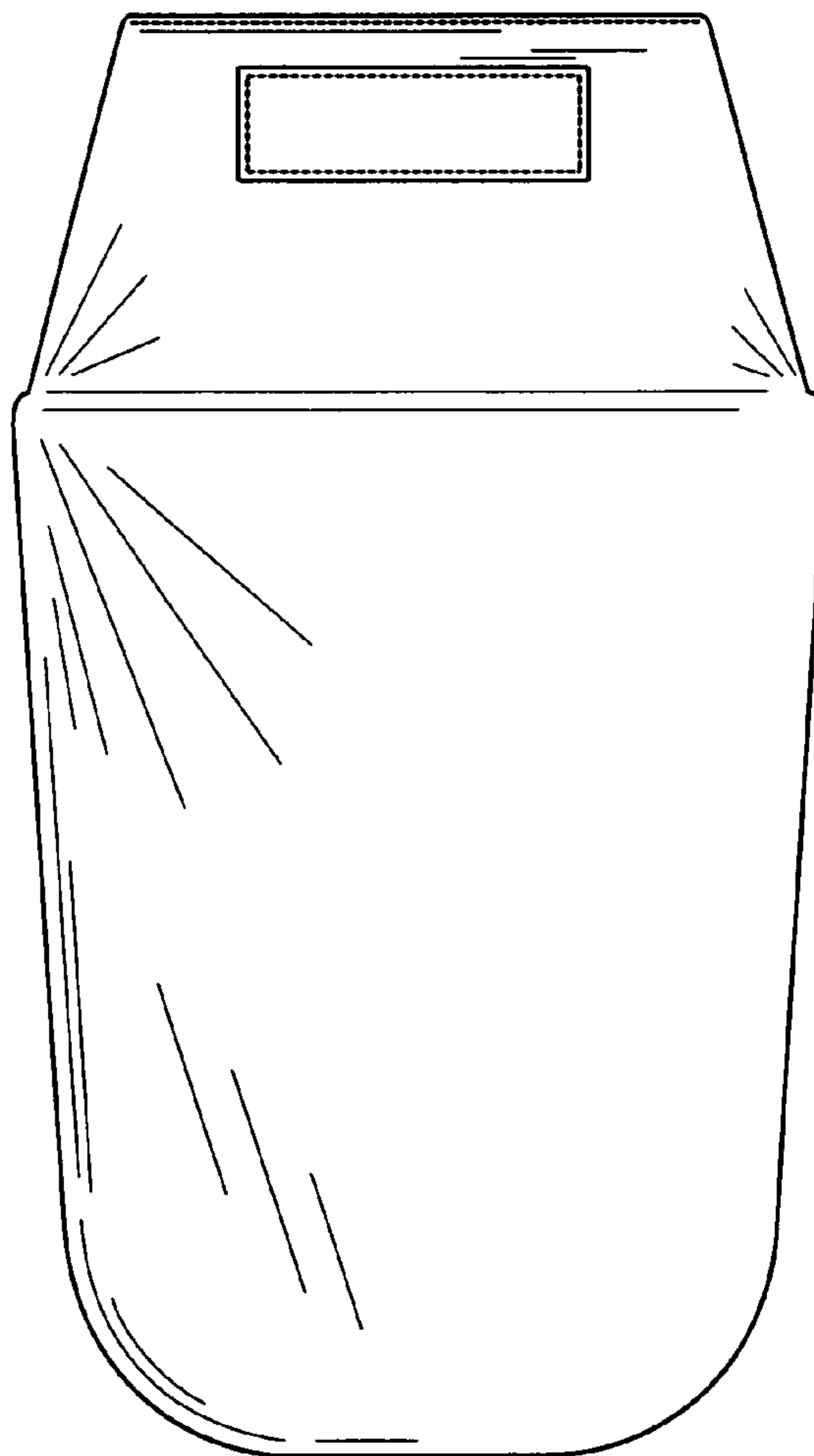
