The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front-left side perspective view of a chair showing our new design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is a left side perspective view thereof, the right side perspective view being a mirror image thereof; and,

FIG. 5 is a top perspective view thereof.

The unshown portions of the underside of the chair form no part of the claimed design.

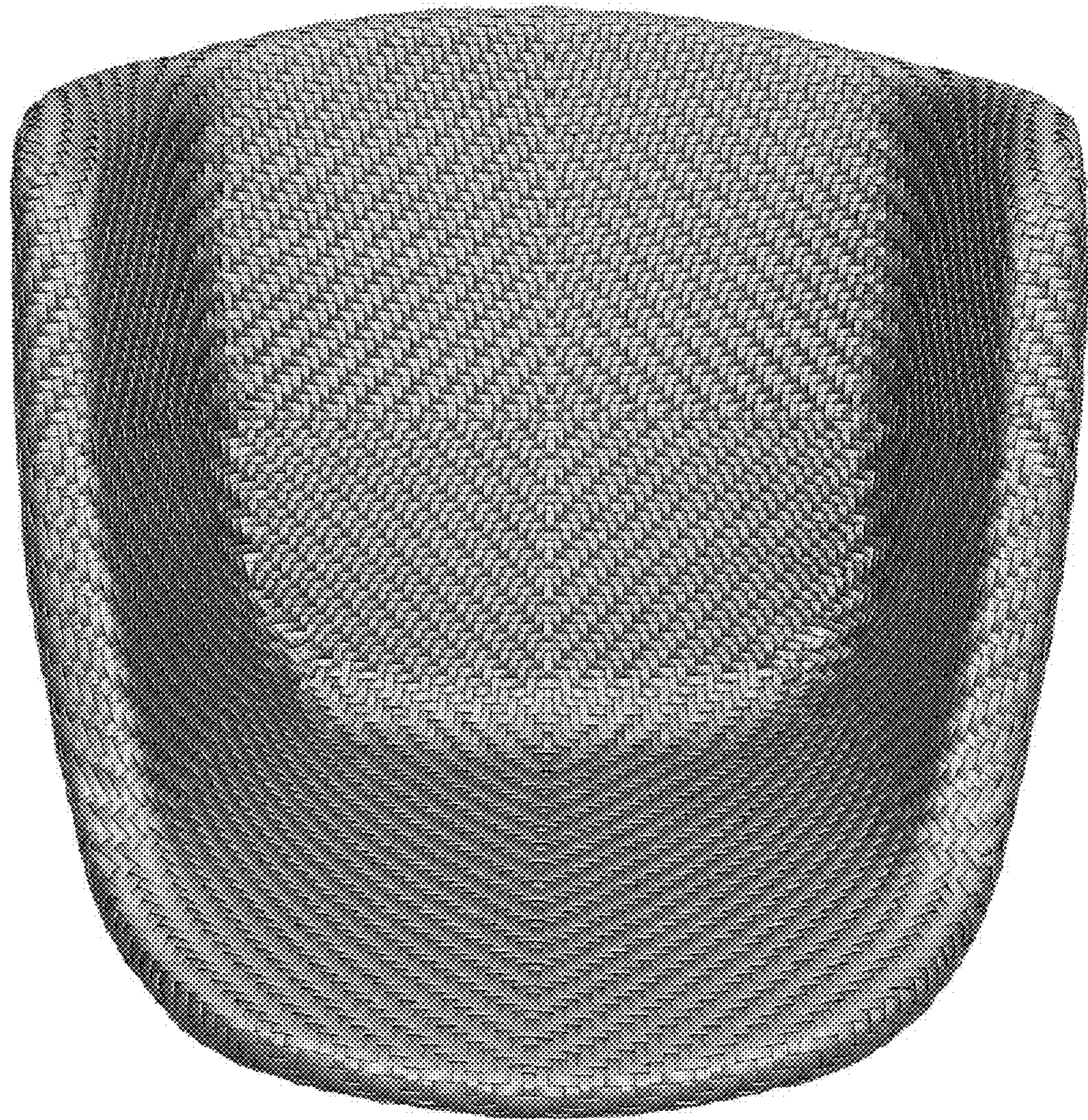
