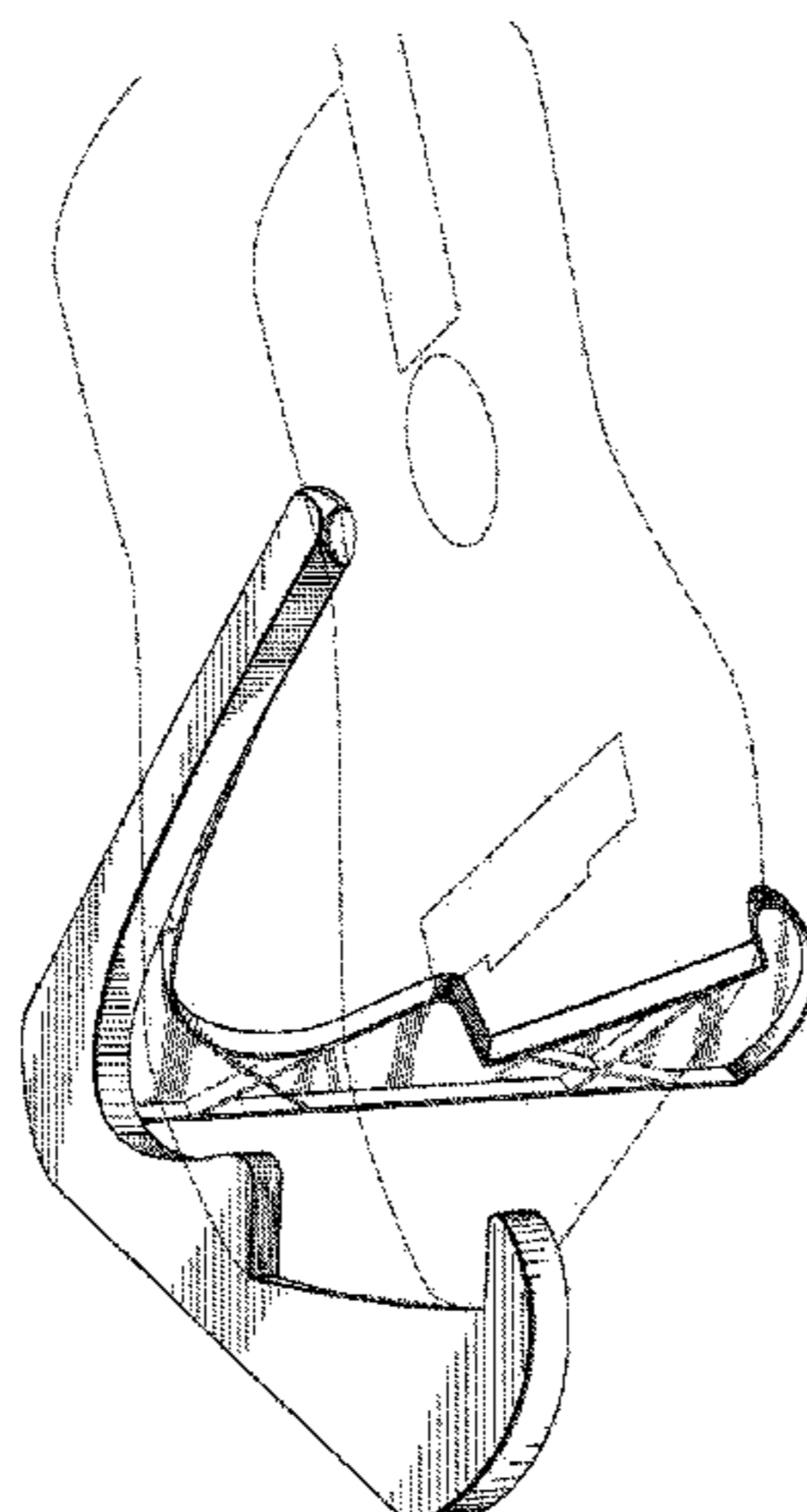
(57) **CLAIM**

The ornamental design for a guitar stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the new design for a guitar stand in an open position;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a left side view thereof, the right side view being a mirror image;  
FIG. 7 is a back view thereof in a closed position;  
FIG. 8 is a front view thereof in the closed position;  
FIG. 9 is a top plan view thereof in the closed position; and,  
FIG. 10 is a bottom plan view thereof in the closed position.  
The broken lines shown in the drawings form no part of the claimed invention.

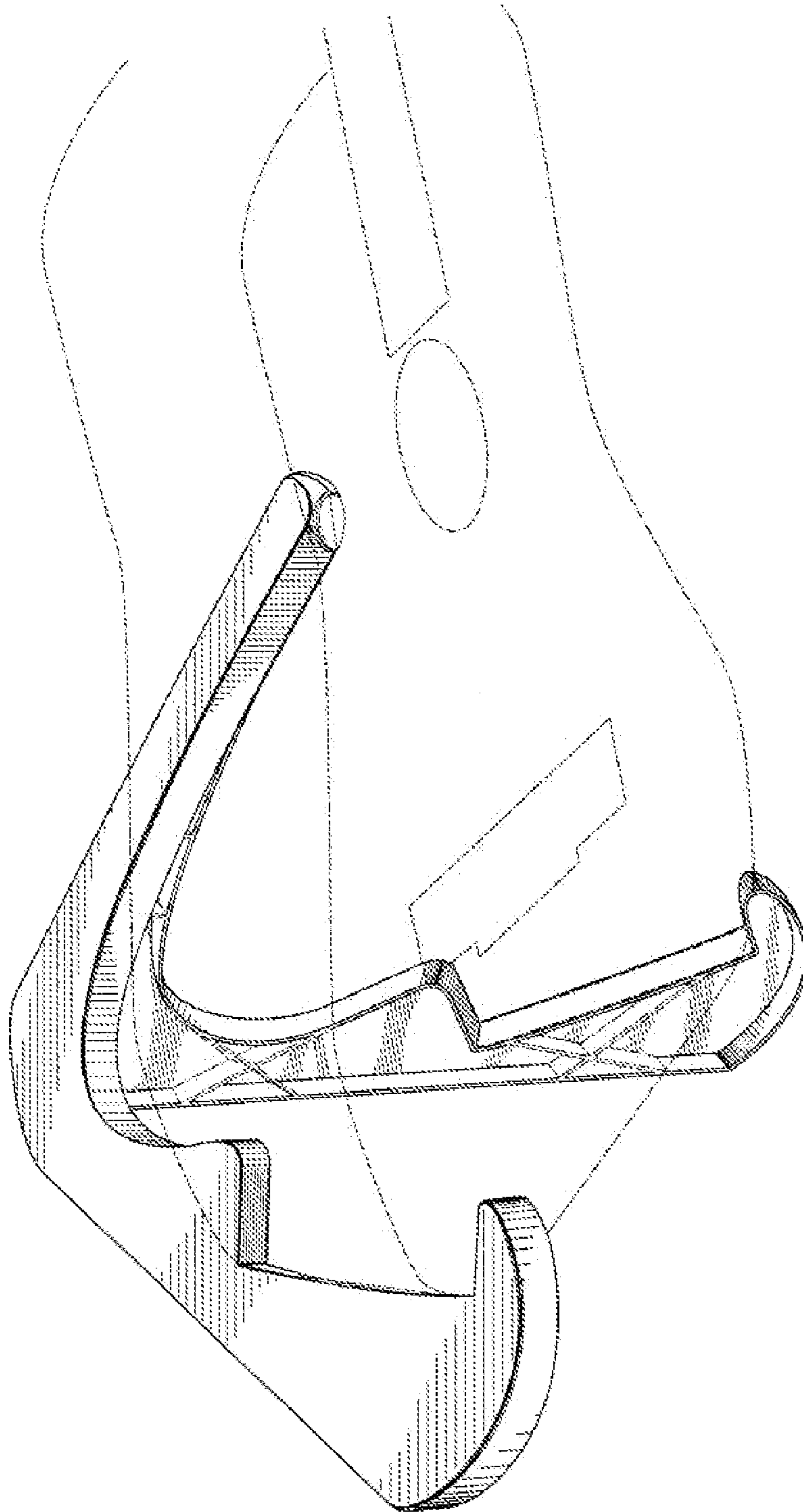

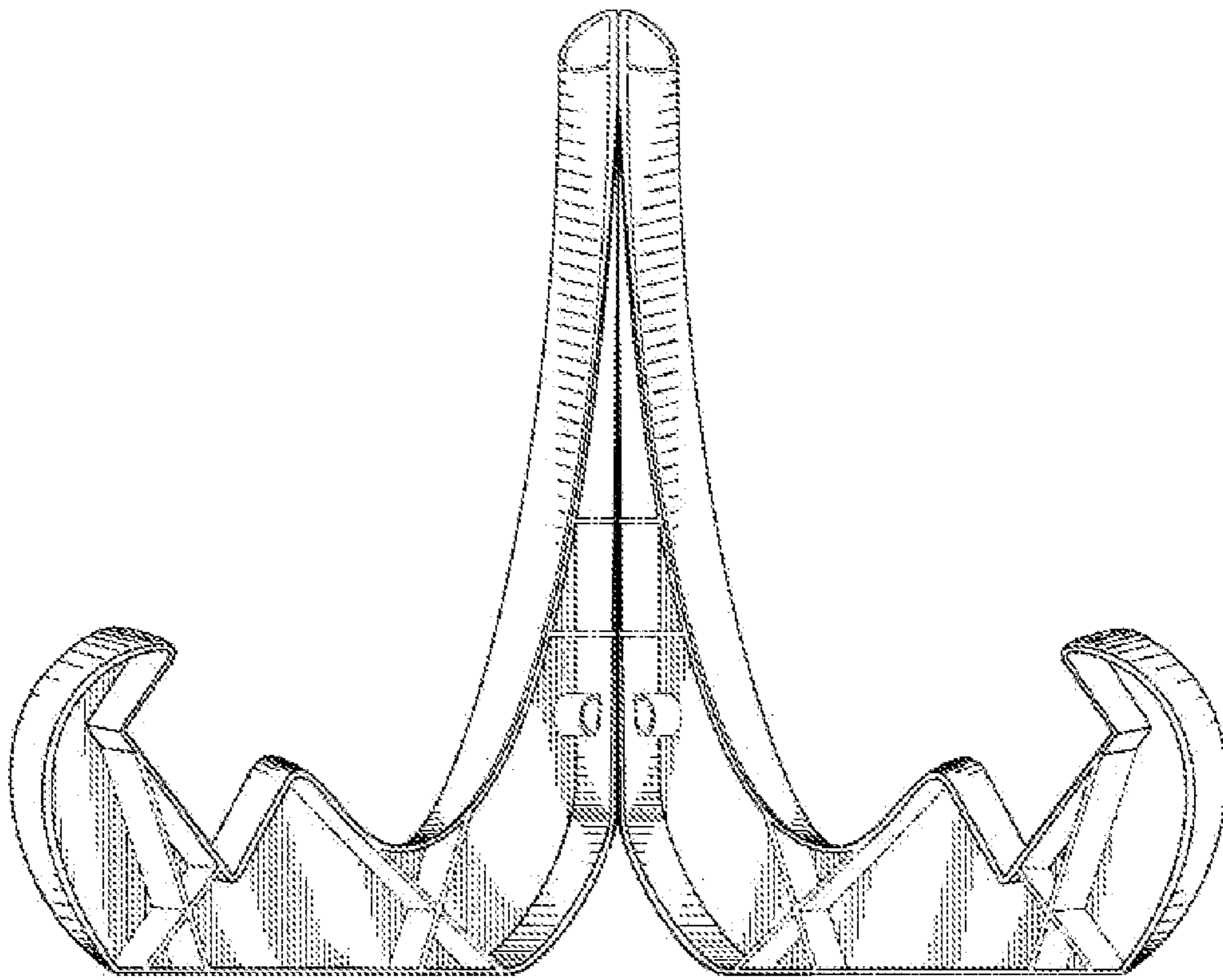

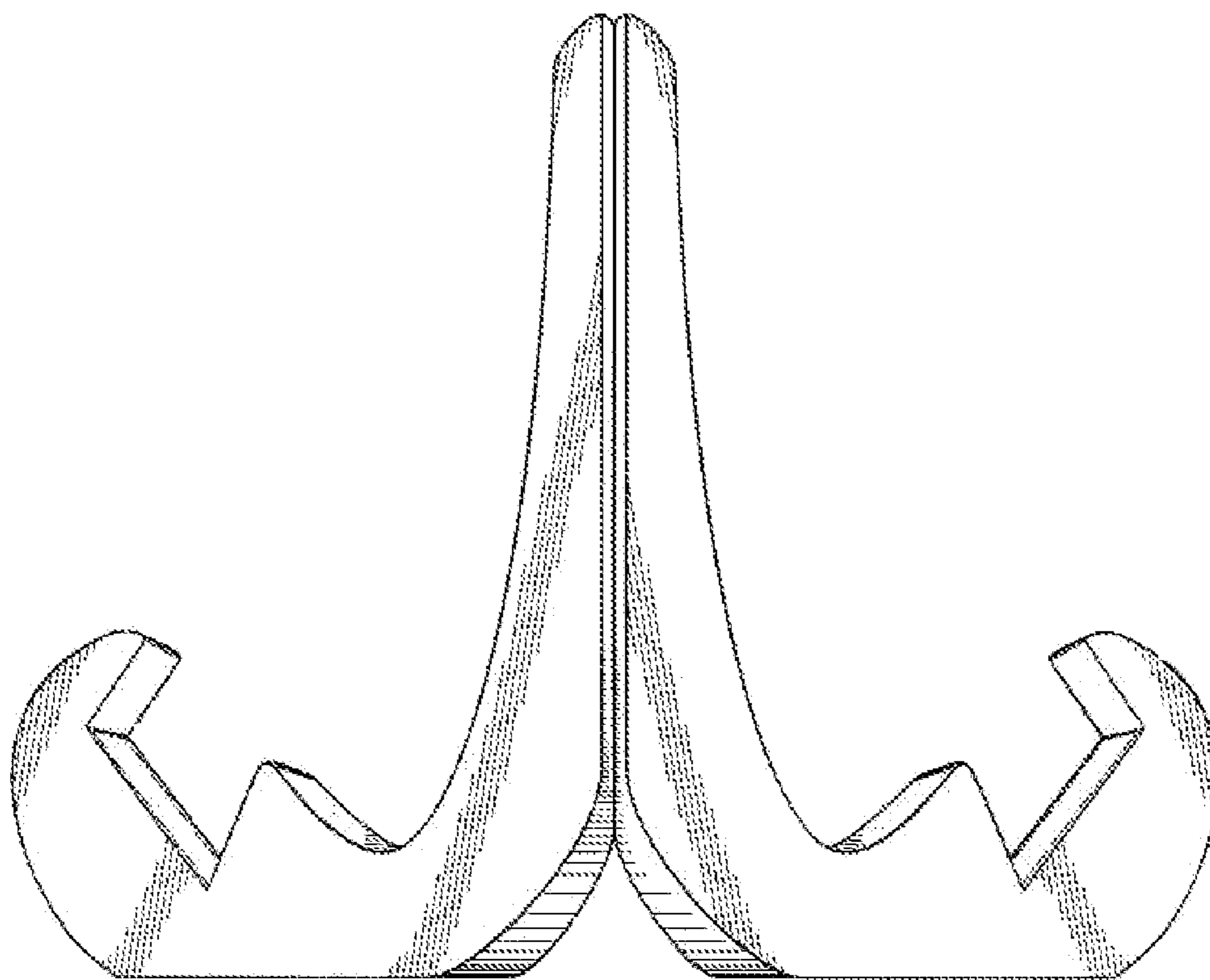

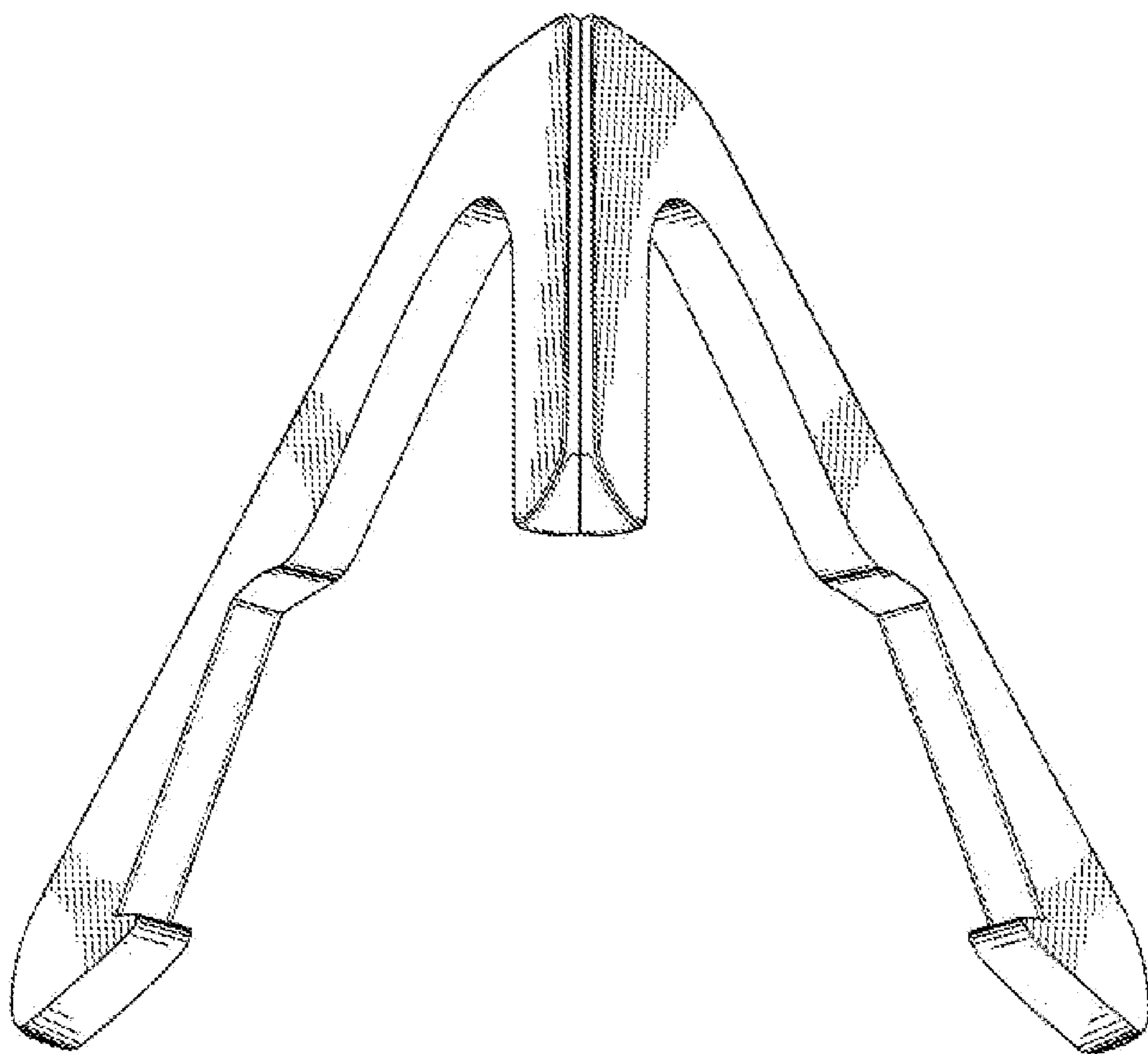

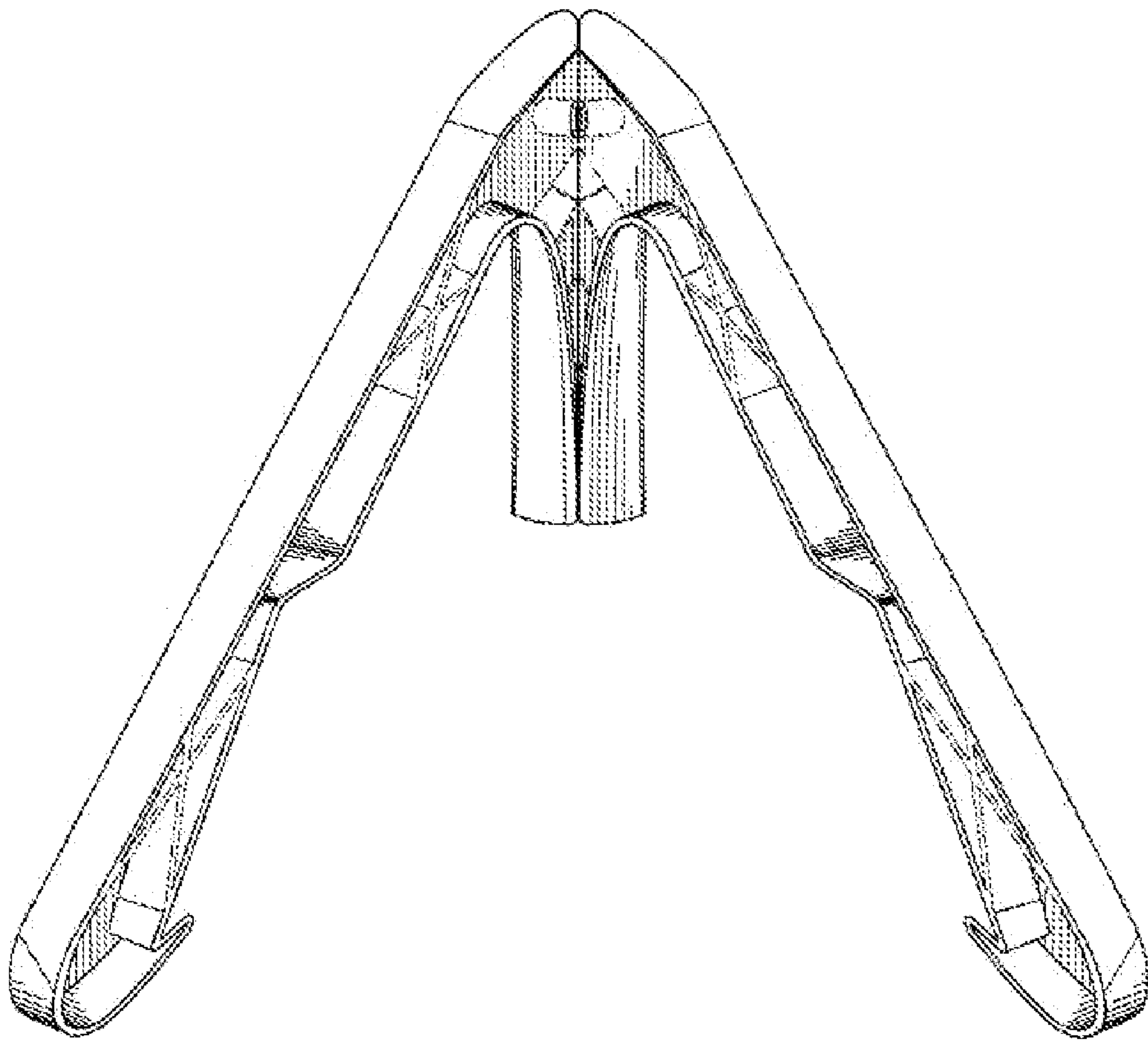

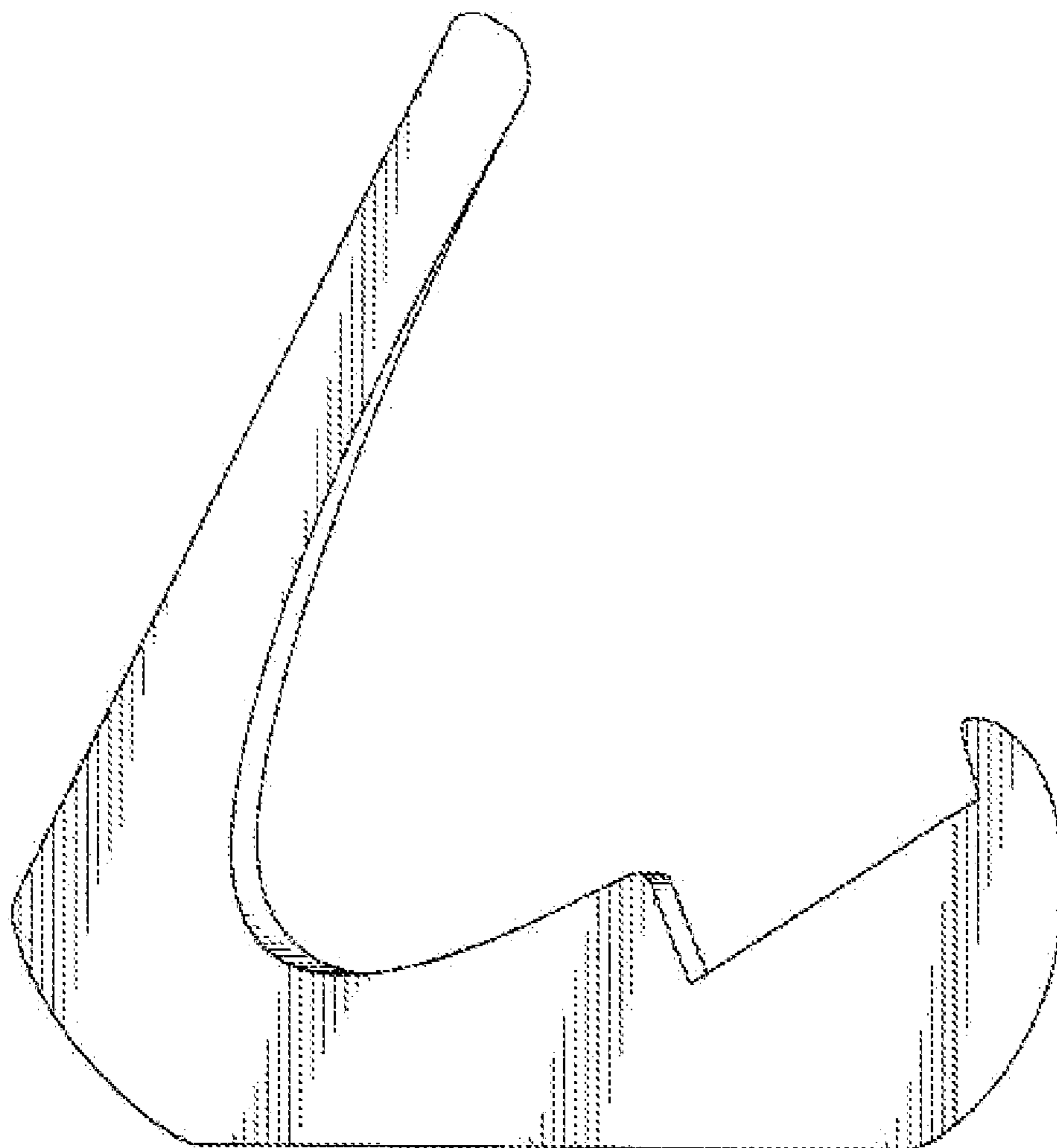

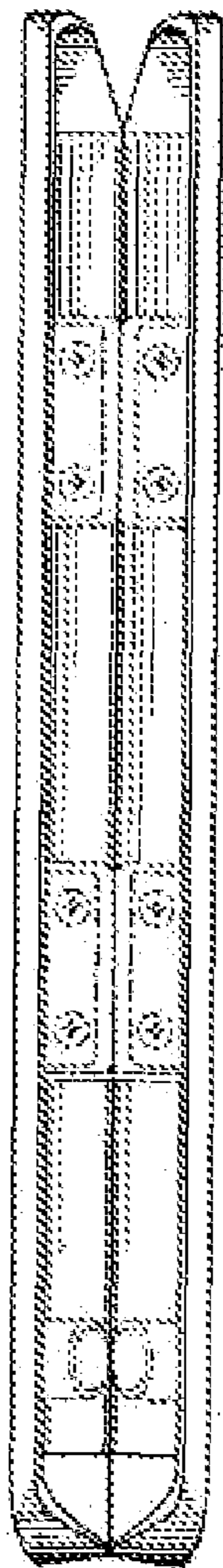

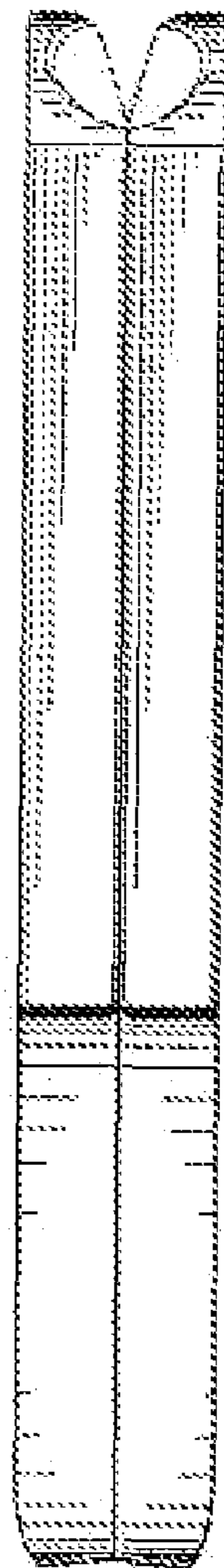

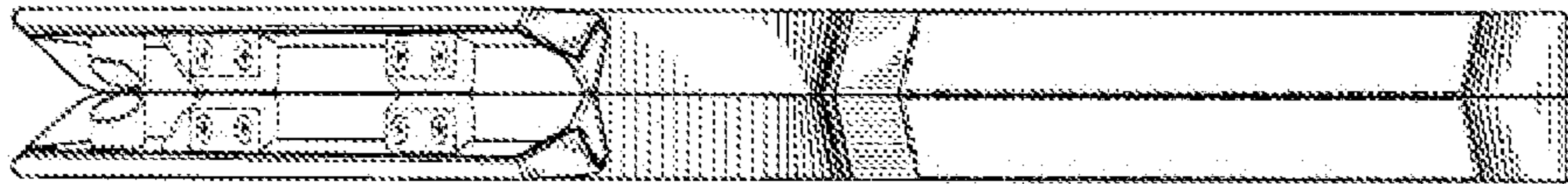

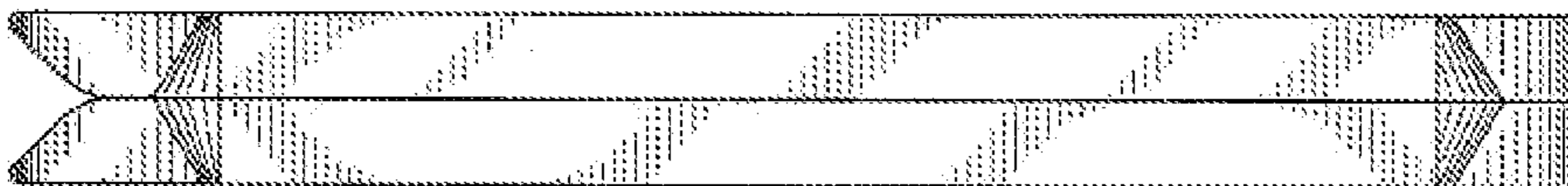
