The ornamental design for a pedestal for base of spa chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pedestal according to the present invention.

FIG. 5 is a bottom view of the pedestal of FIG. 1.

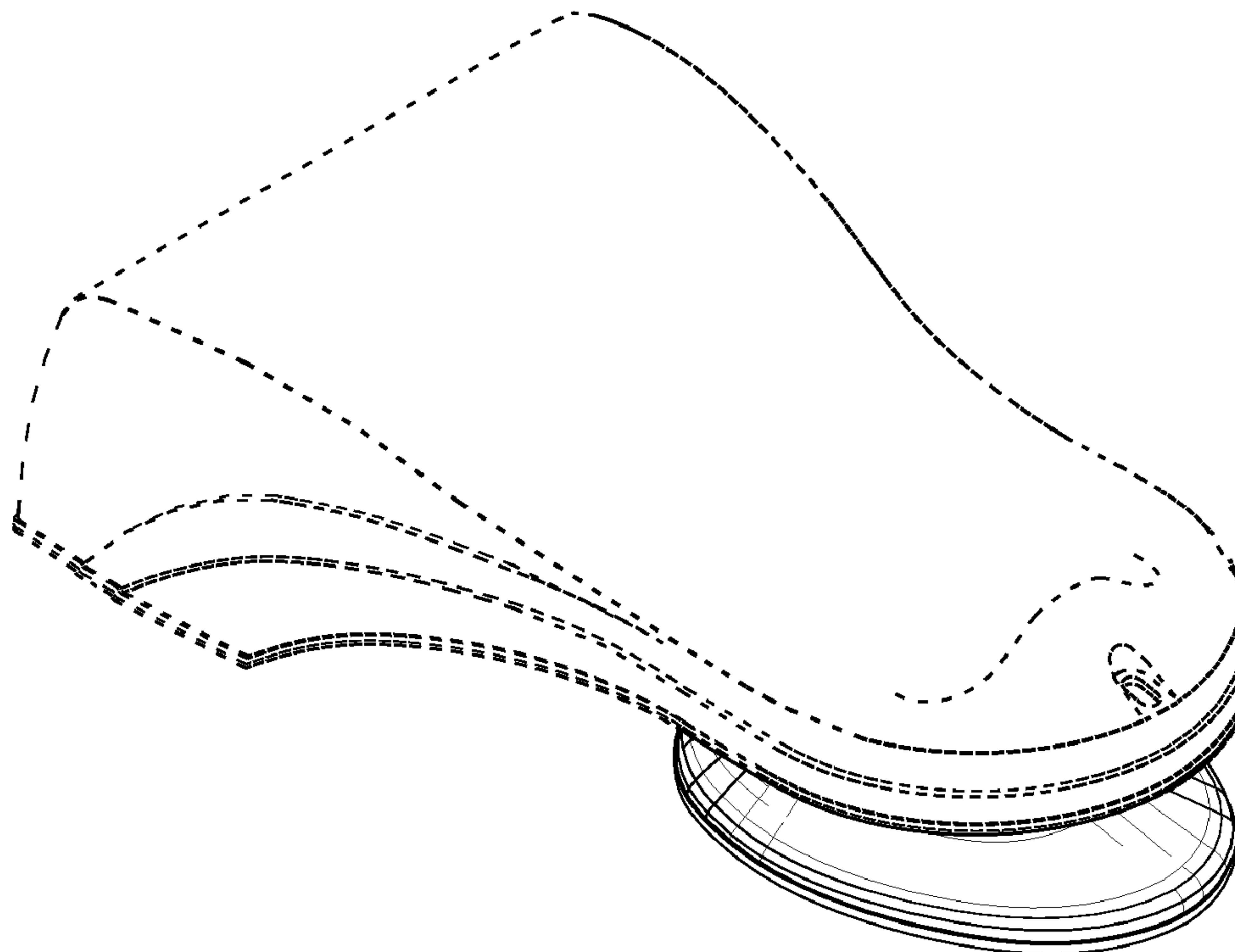
FIG. 6 is a right side view of the pedestal of FIG. 1.

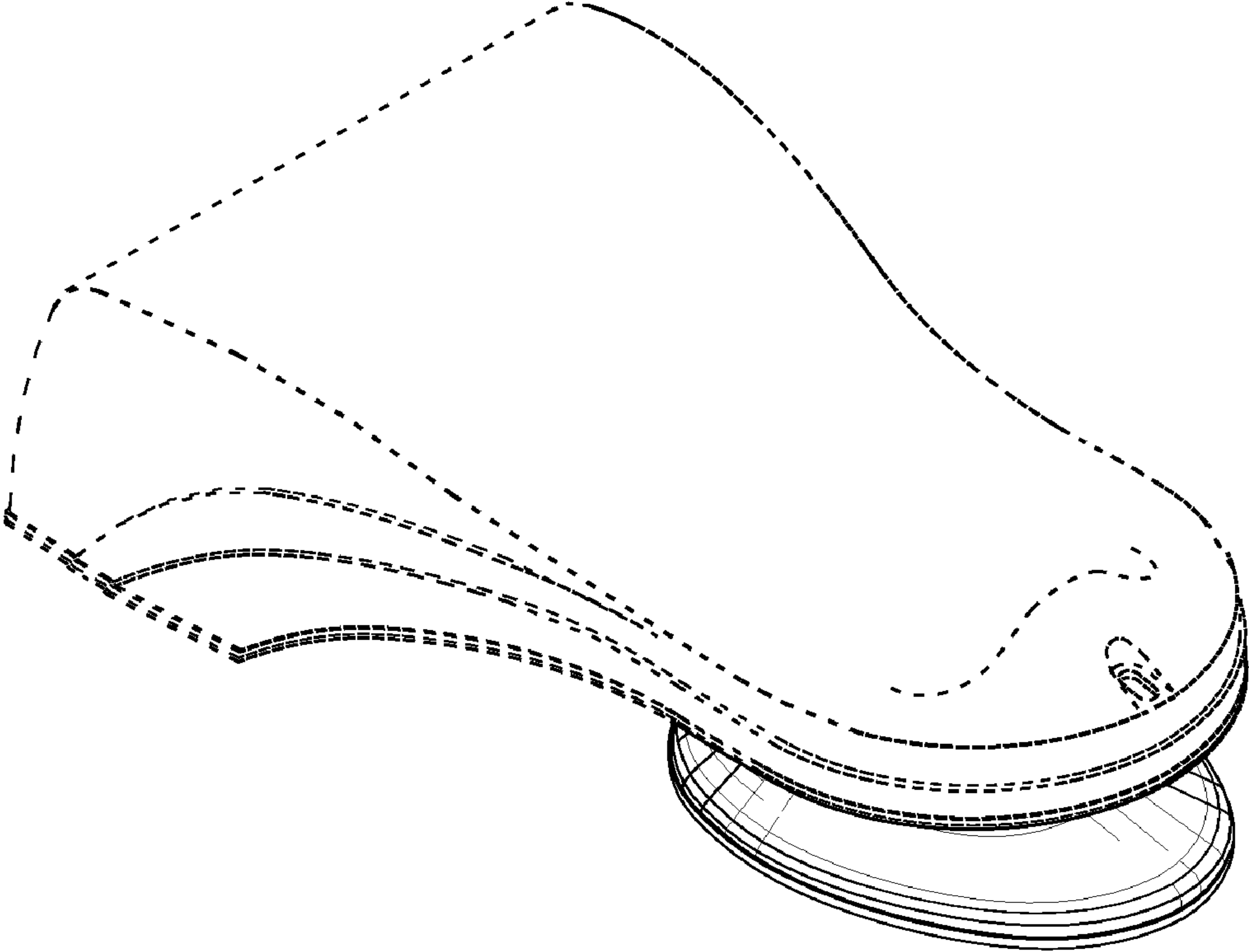

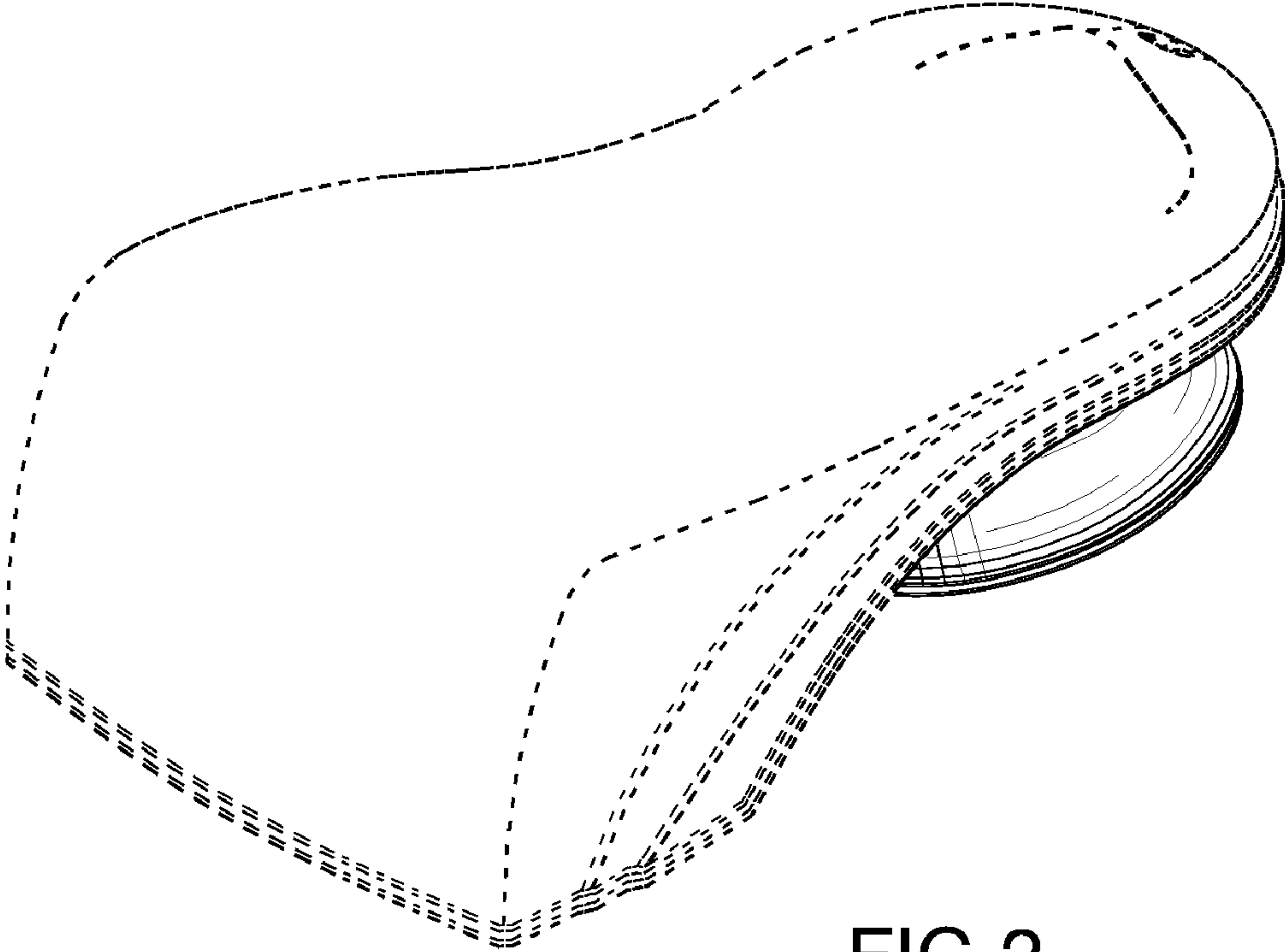

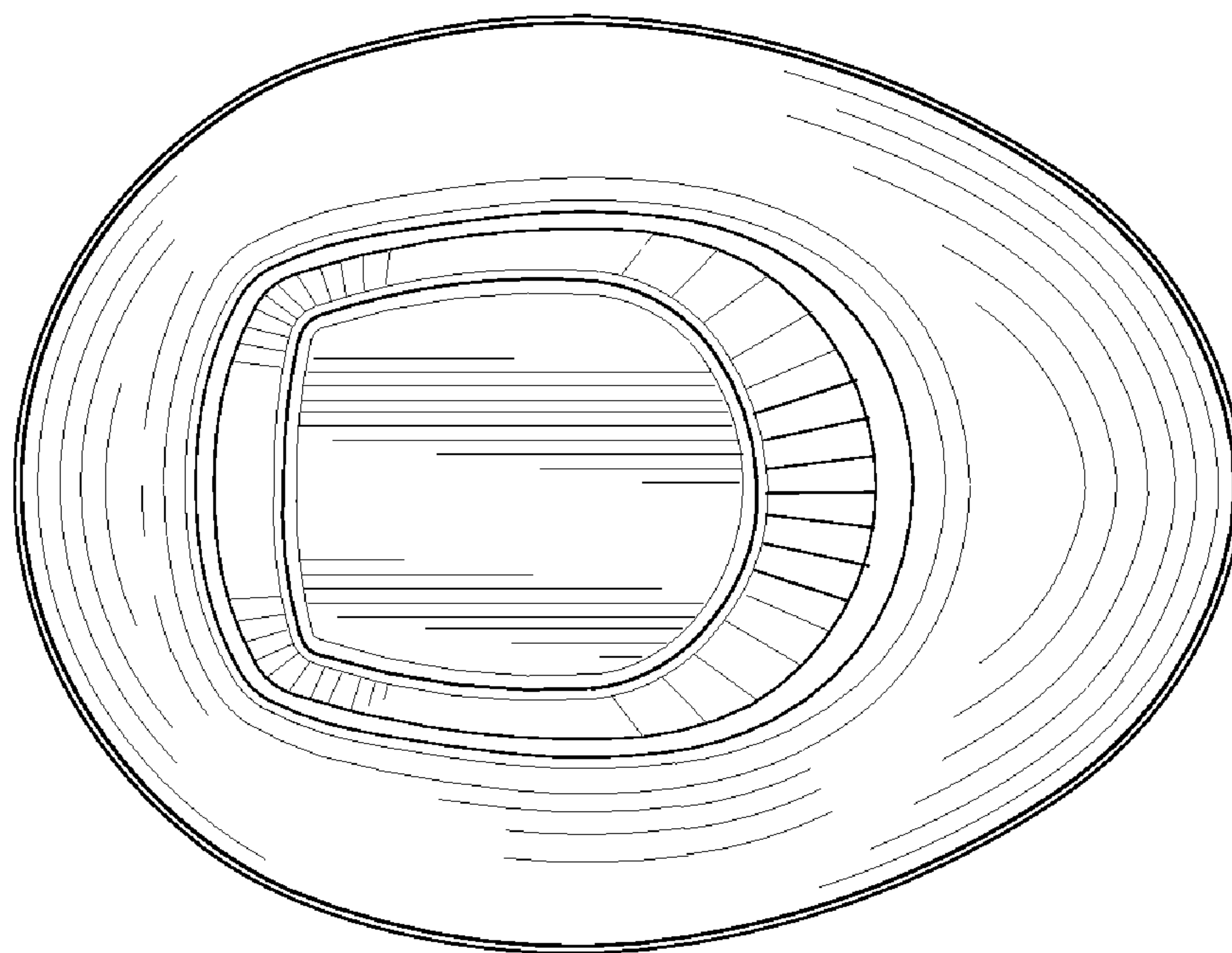

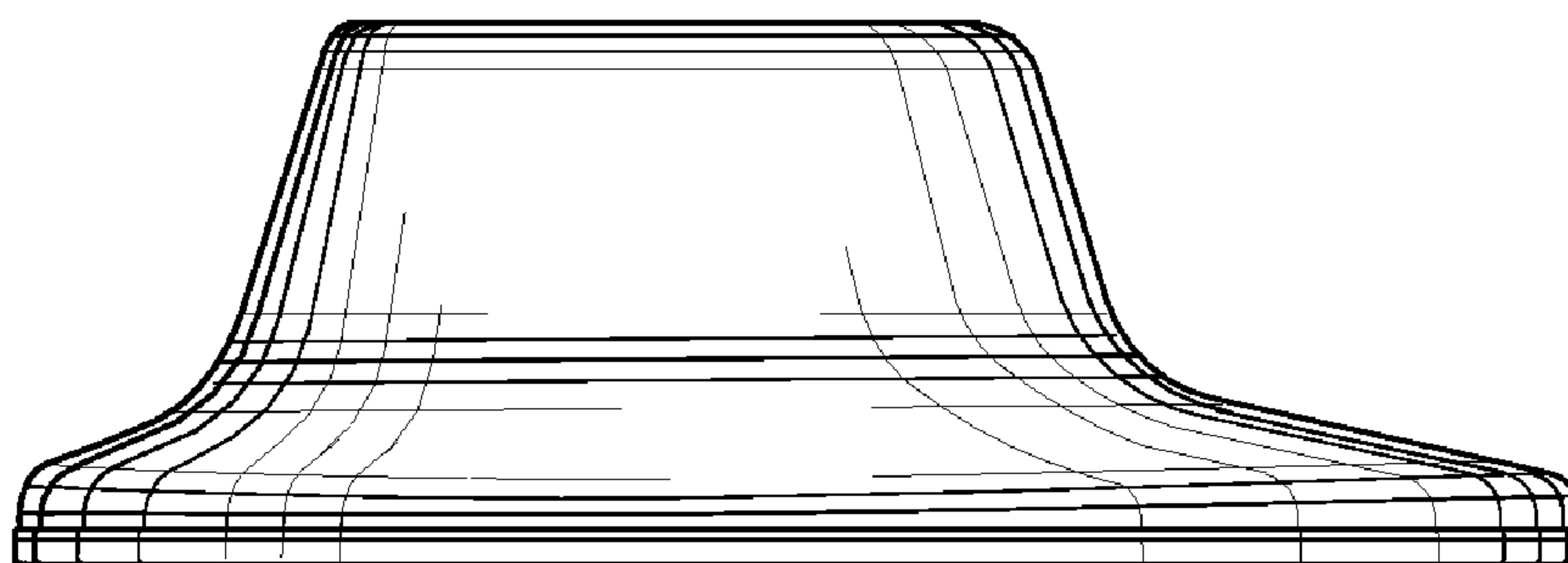

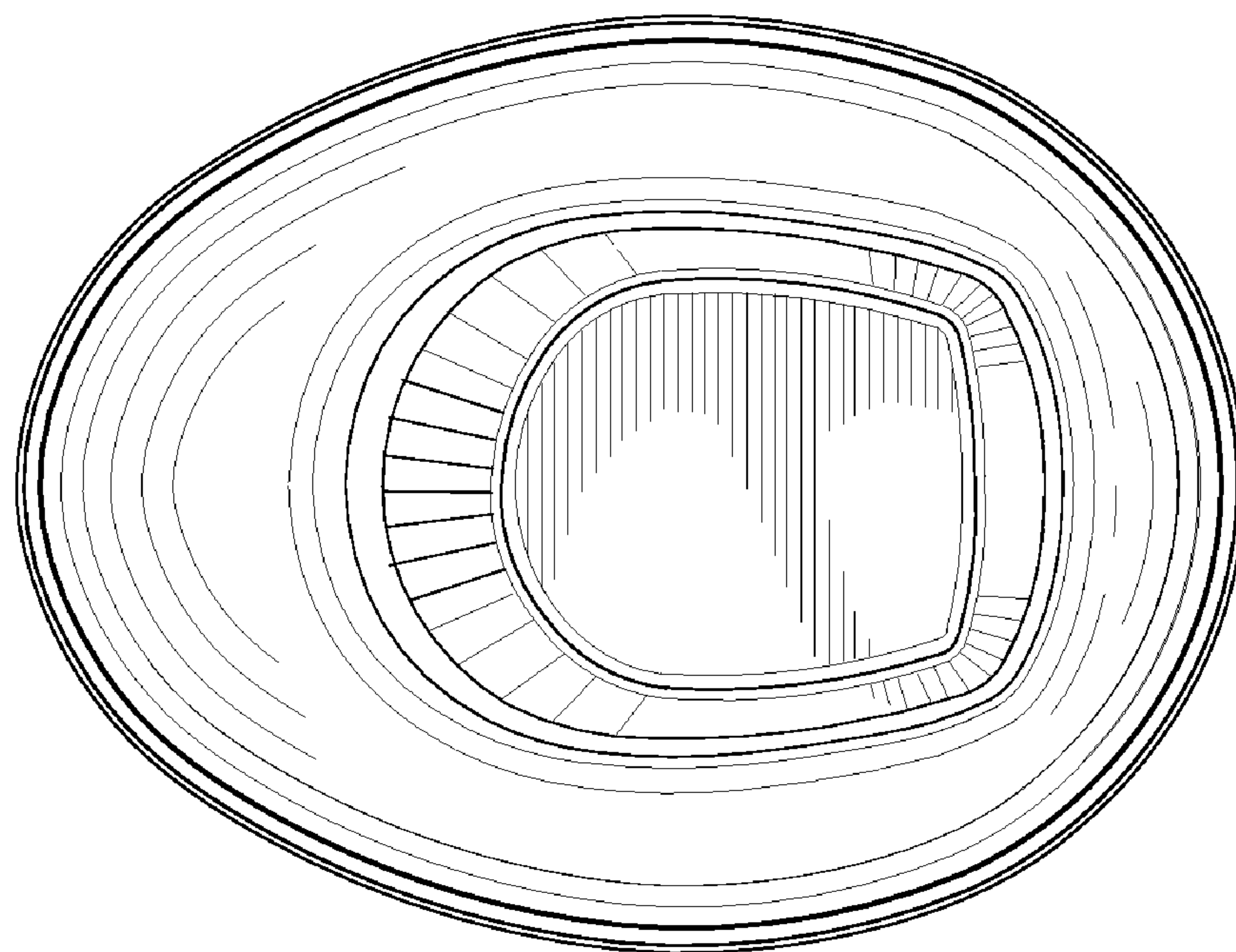

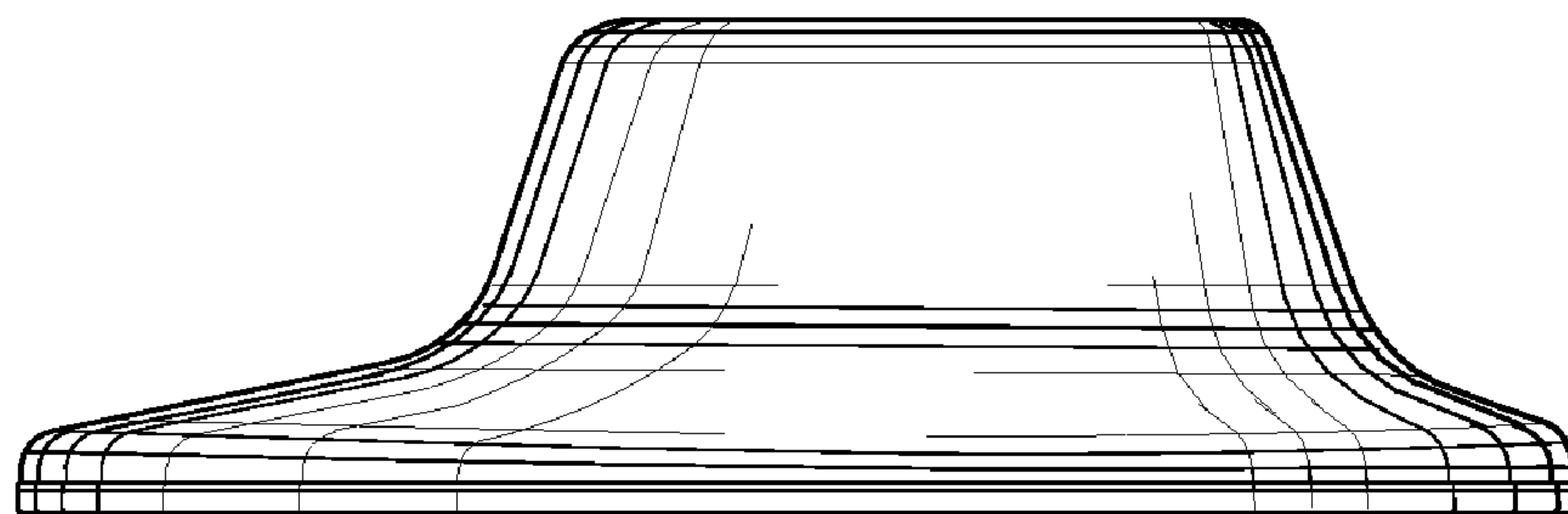

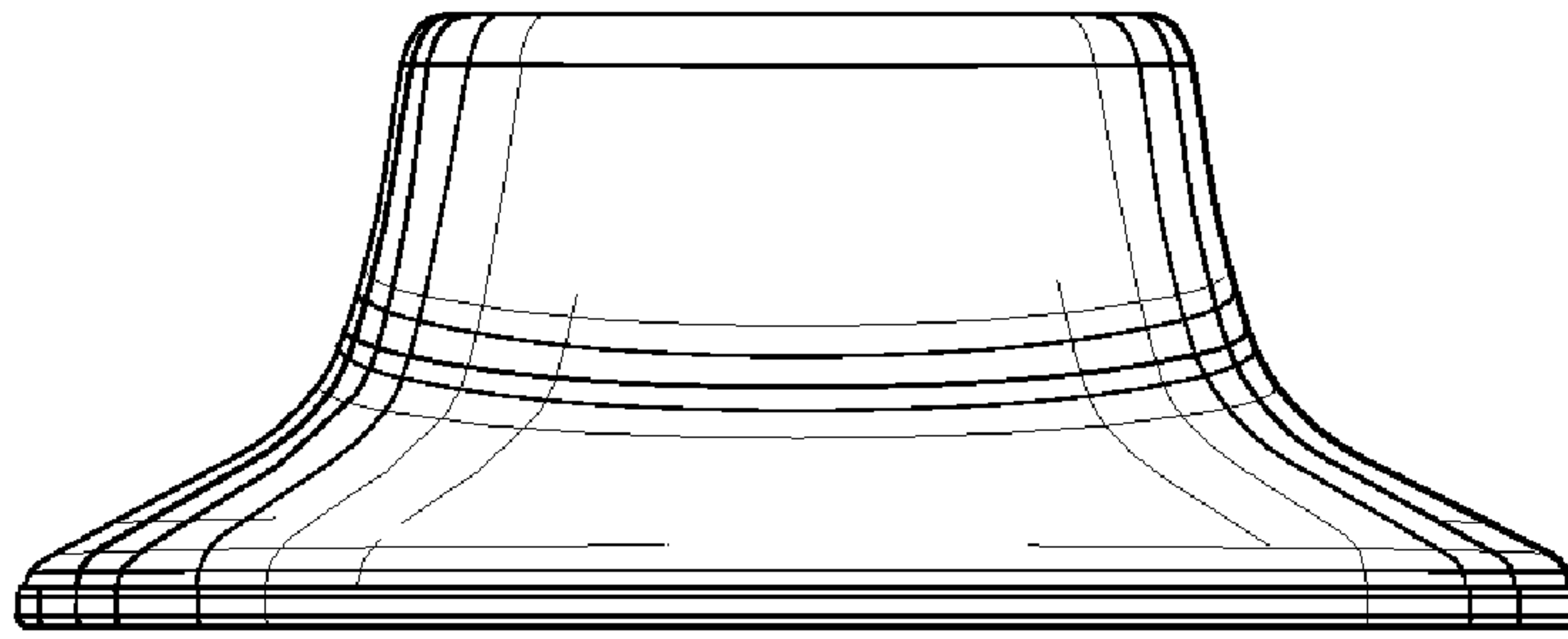

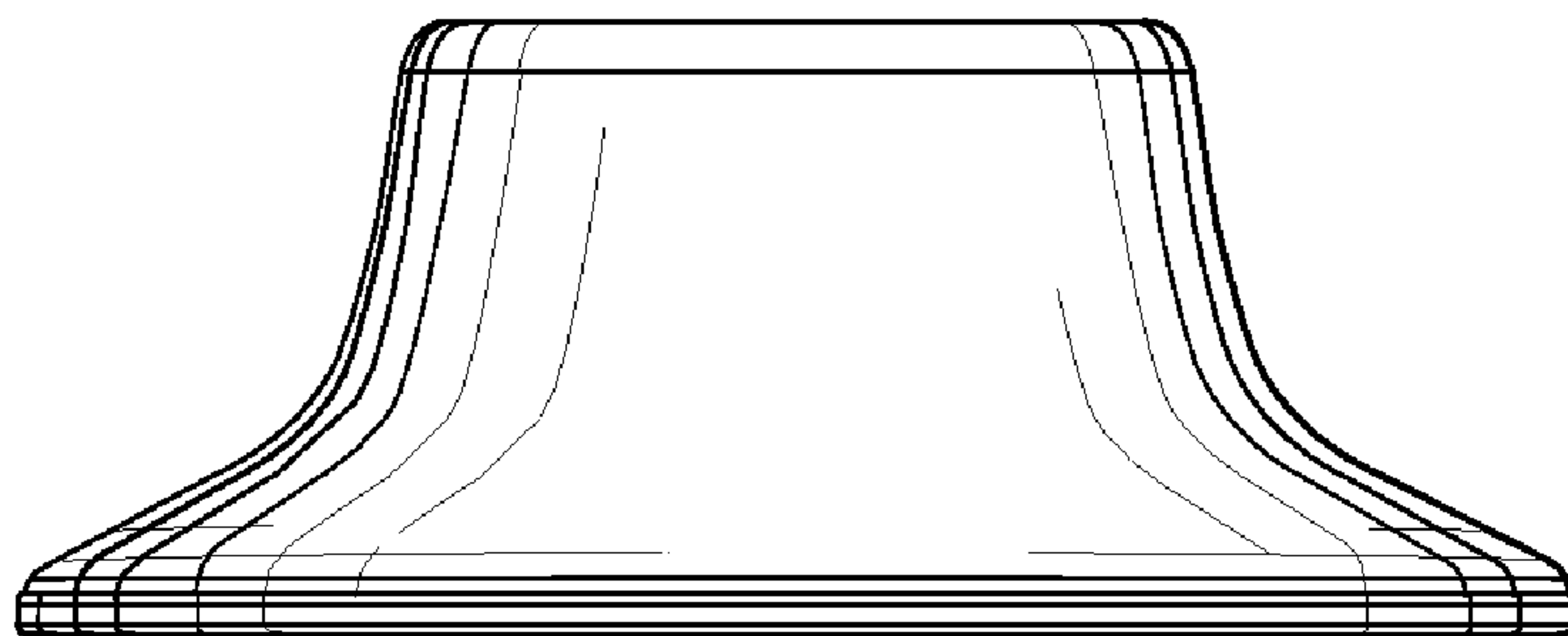
