The new ornamental design for a mug with a hockey blade handle, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a mug with a hockey blade handle.

FIG. 2 is a right side perspective view of a mug with a hockey blade handle.

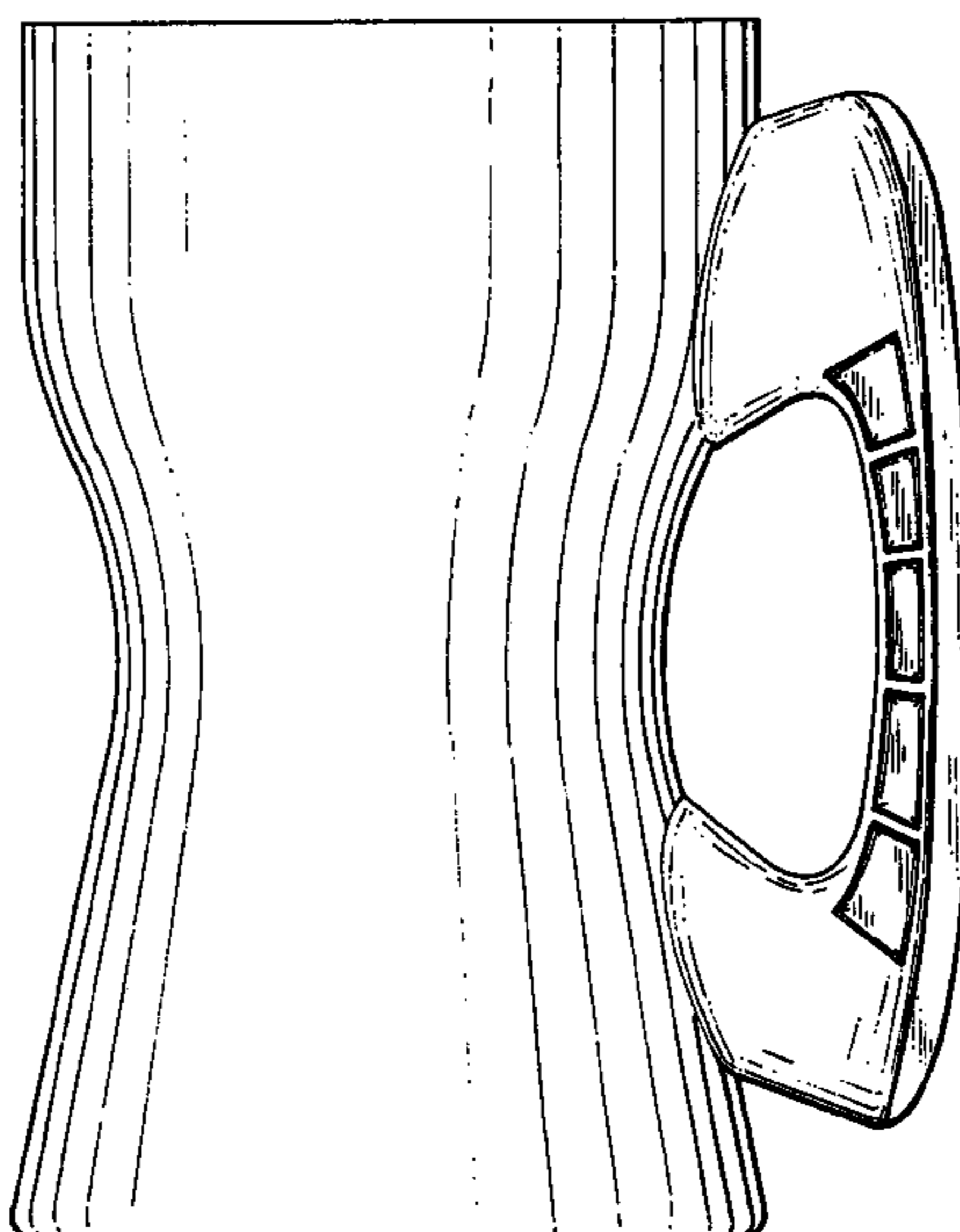
FIG. 3 is a back perspective view of a mug with a hockey blade handle.

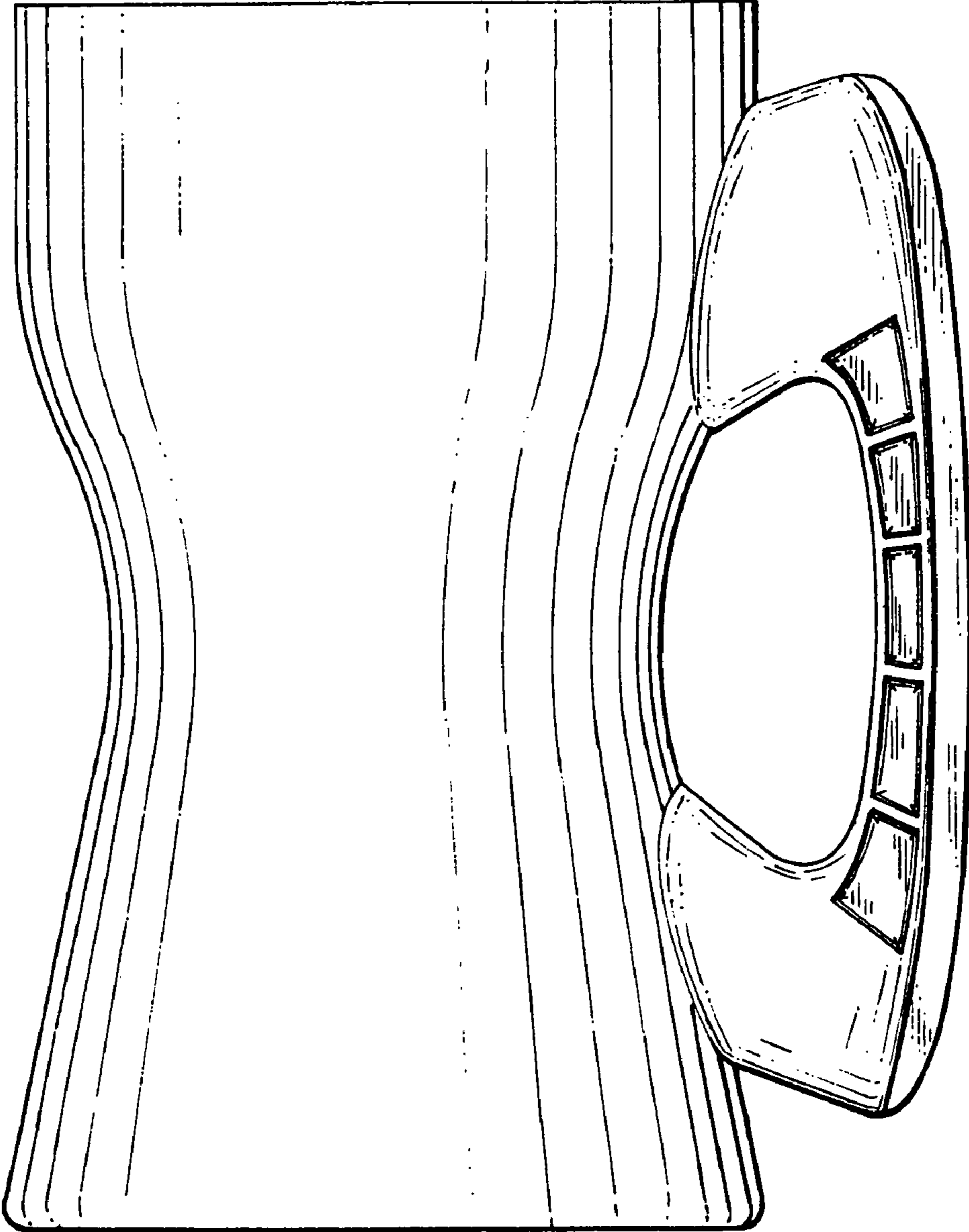

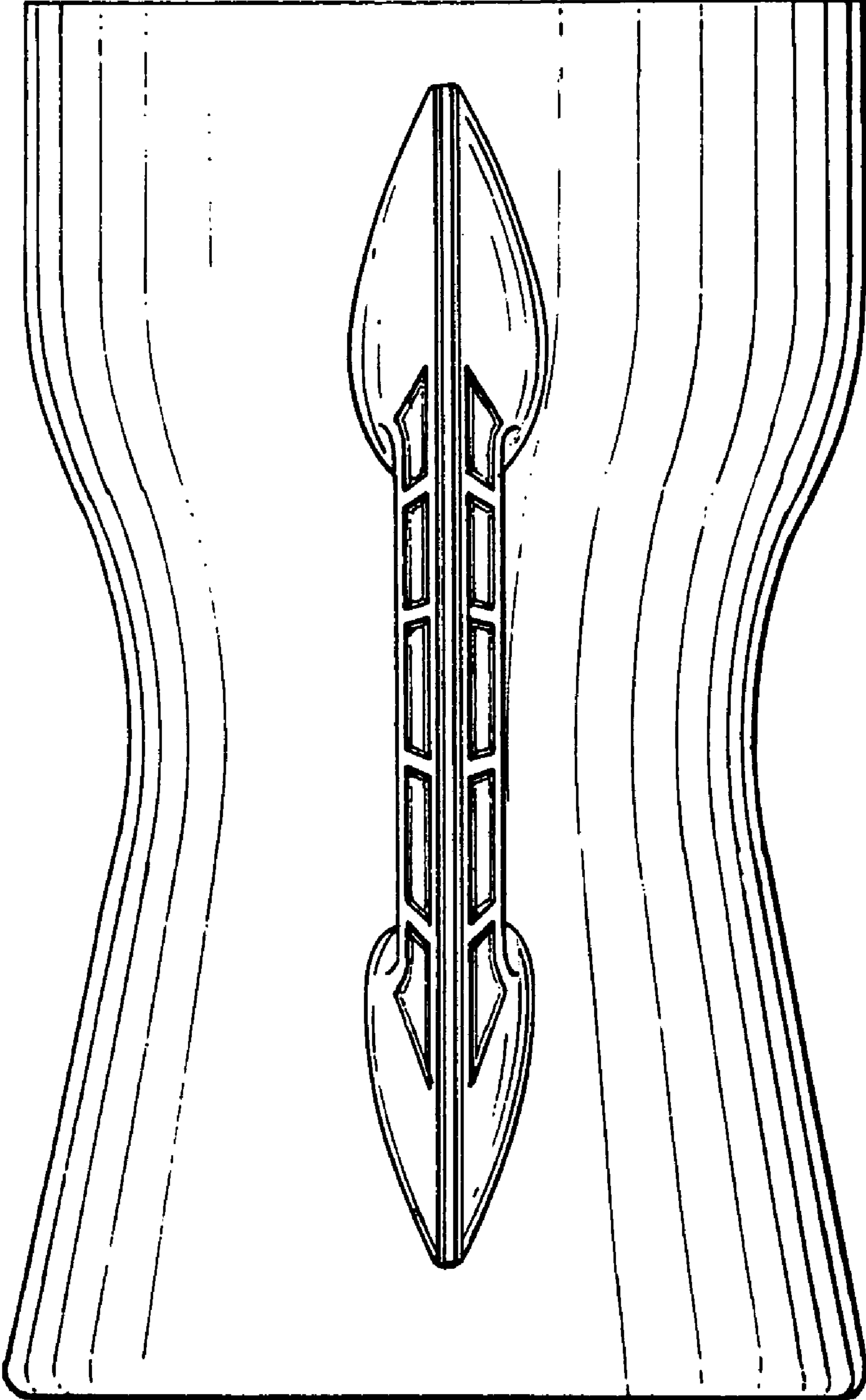

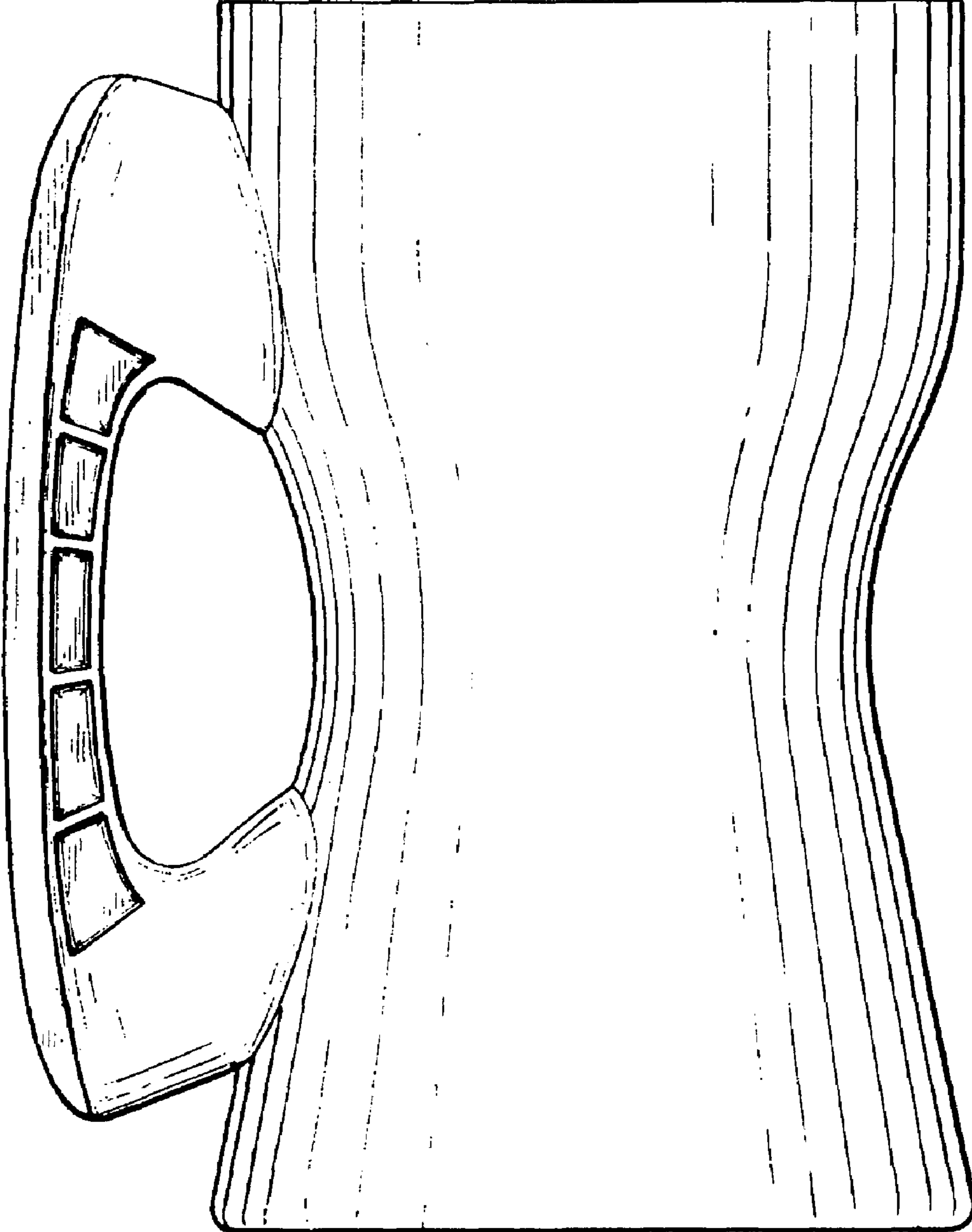

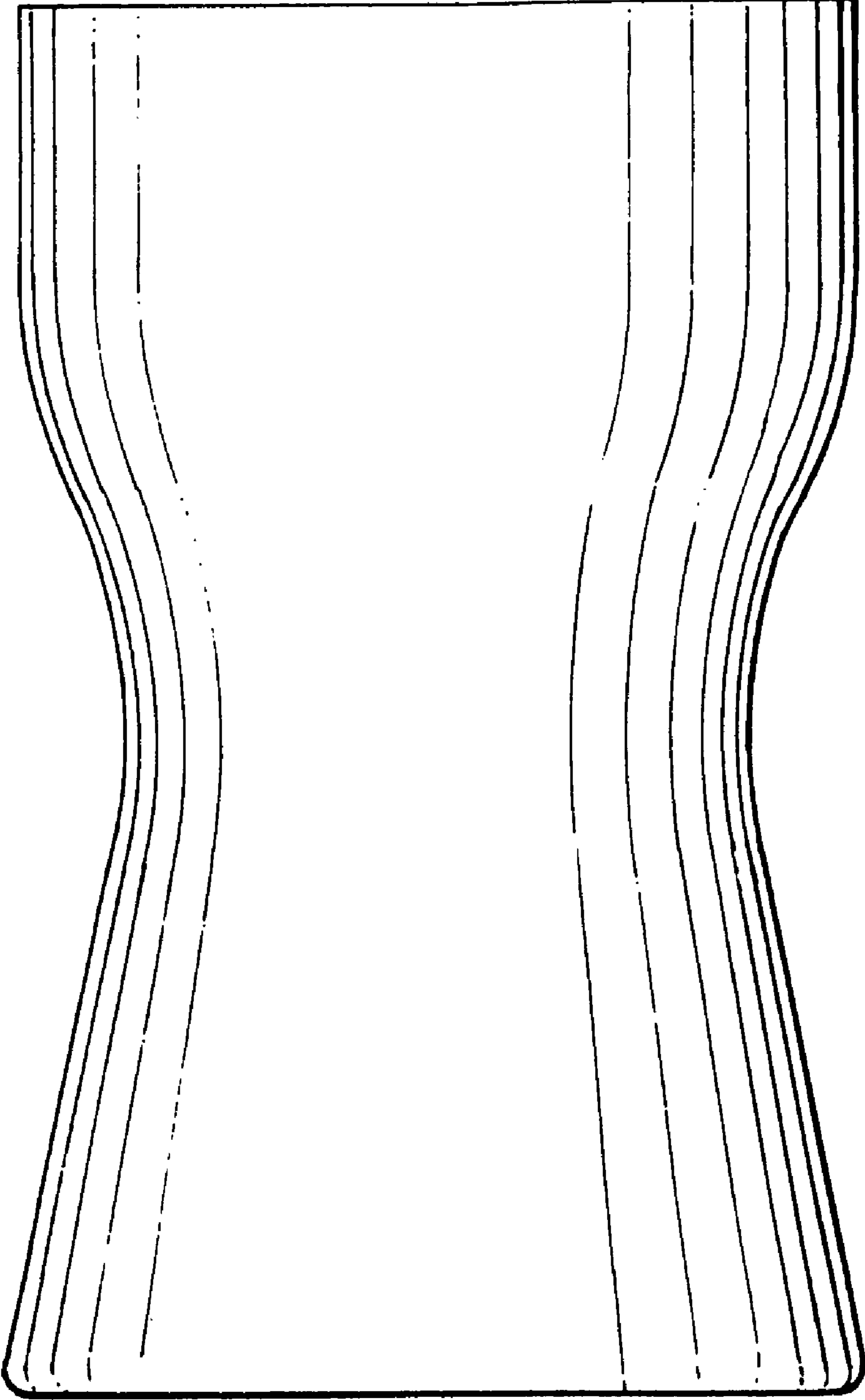

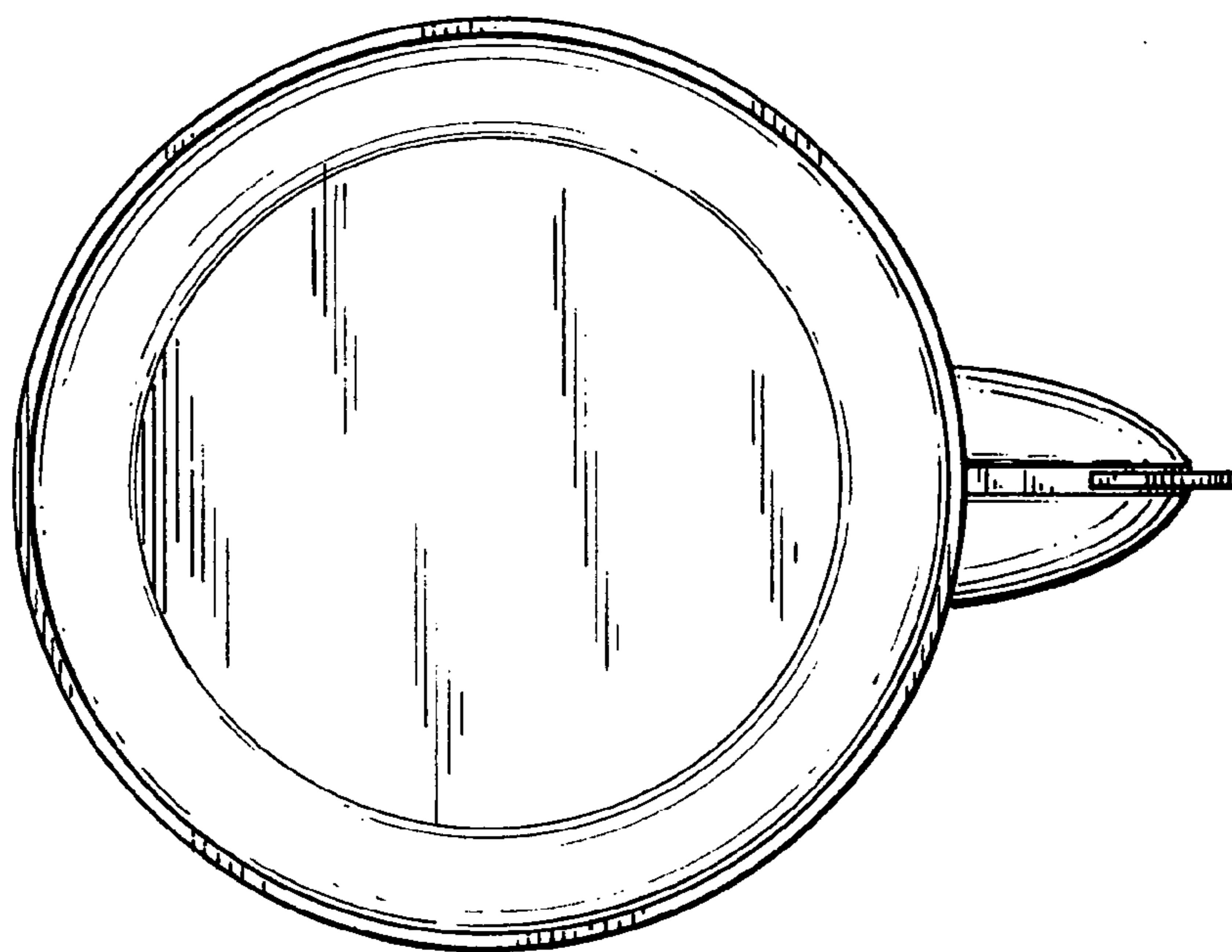

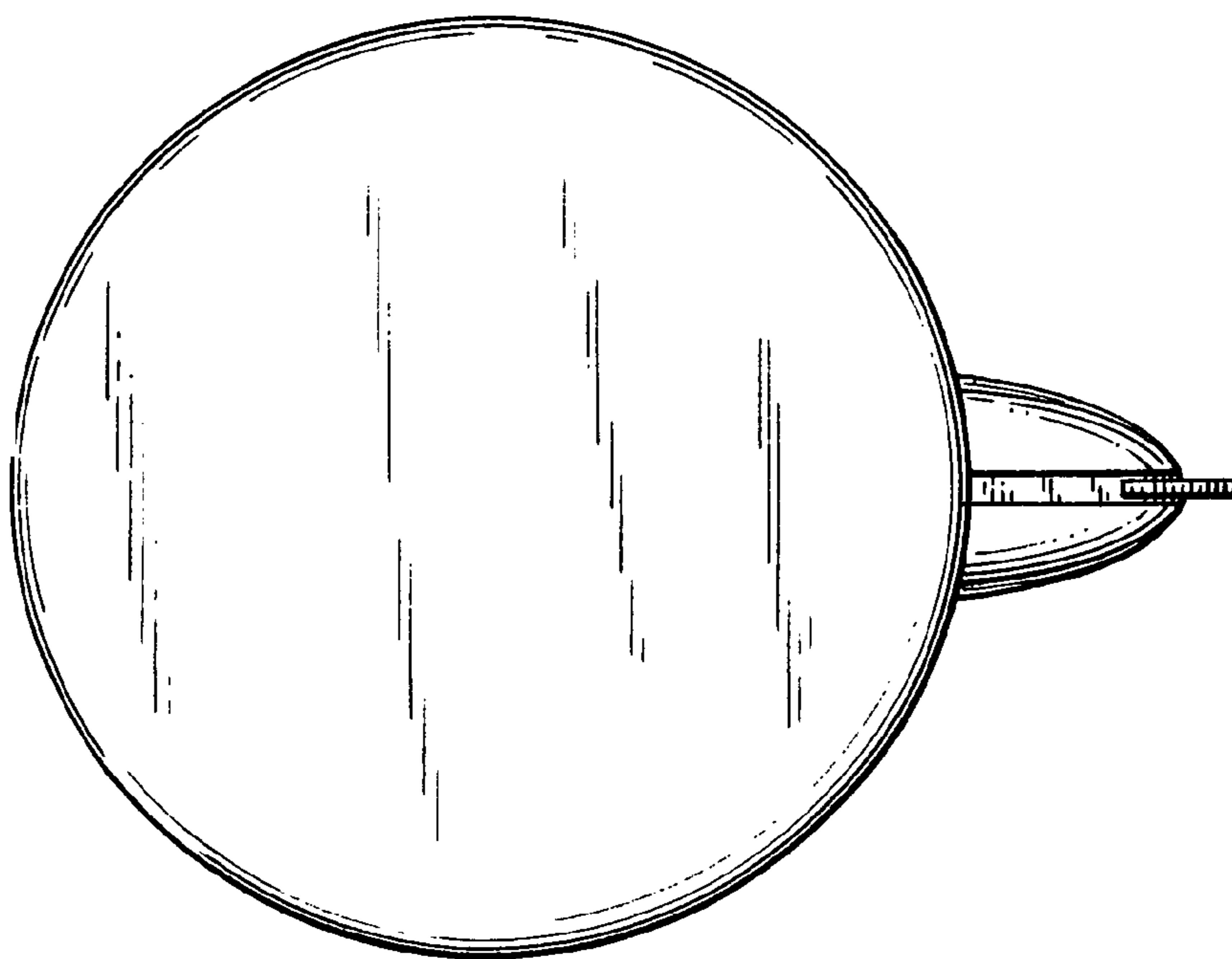
