**DESCRIPTION**

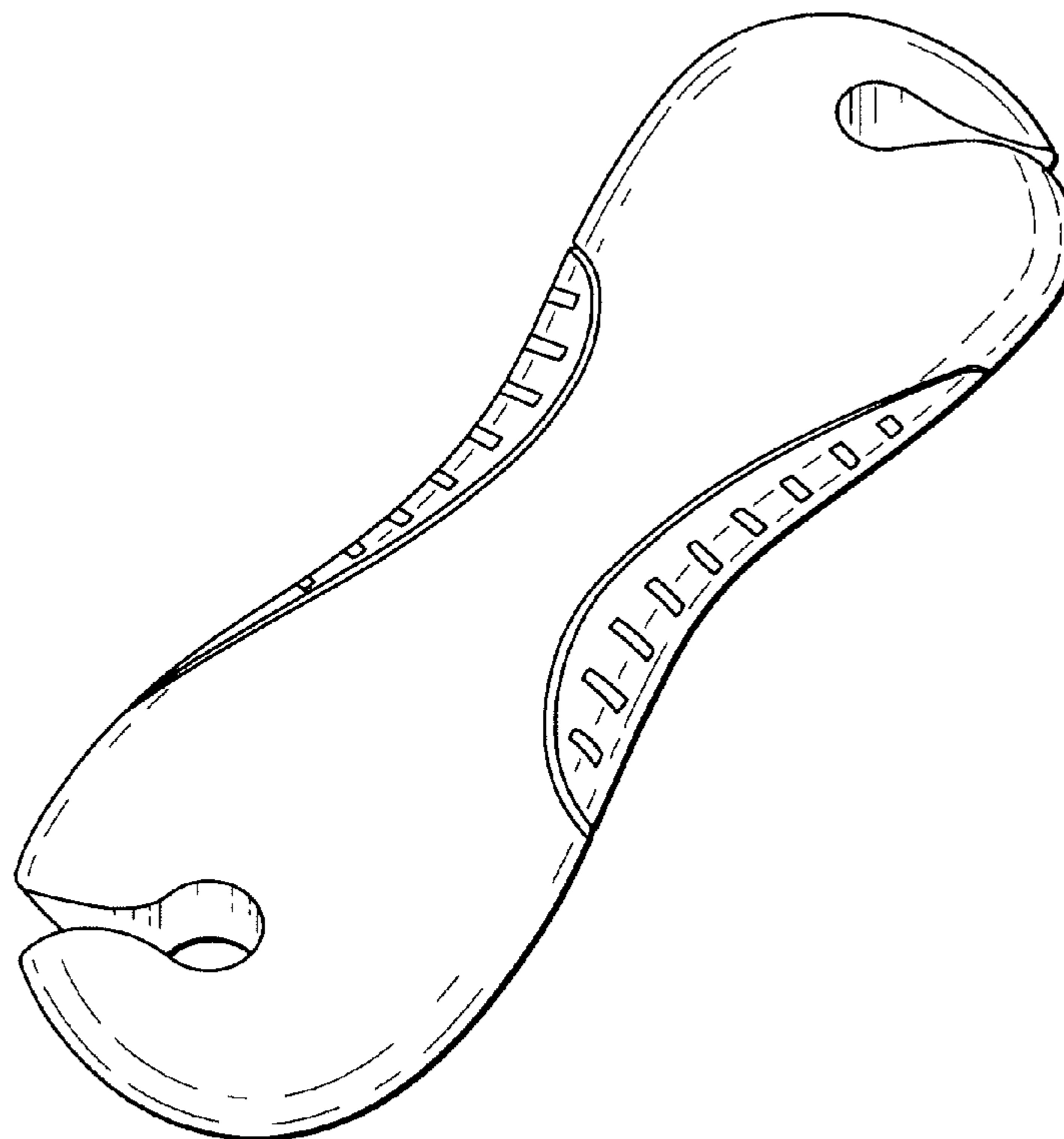
FIG. 1 is a front elevation view of a wrap device showing my new design;

FIG. 2 is a top view thereof;

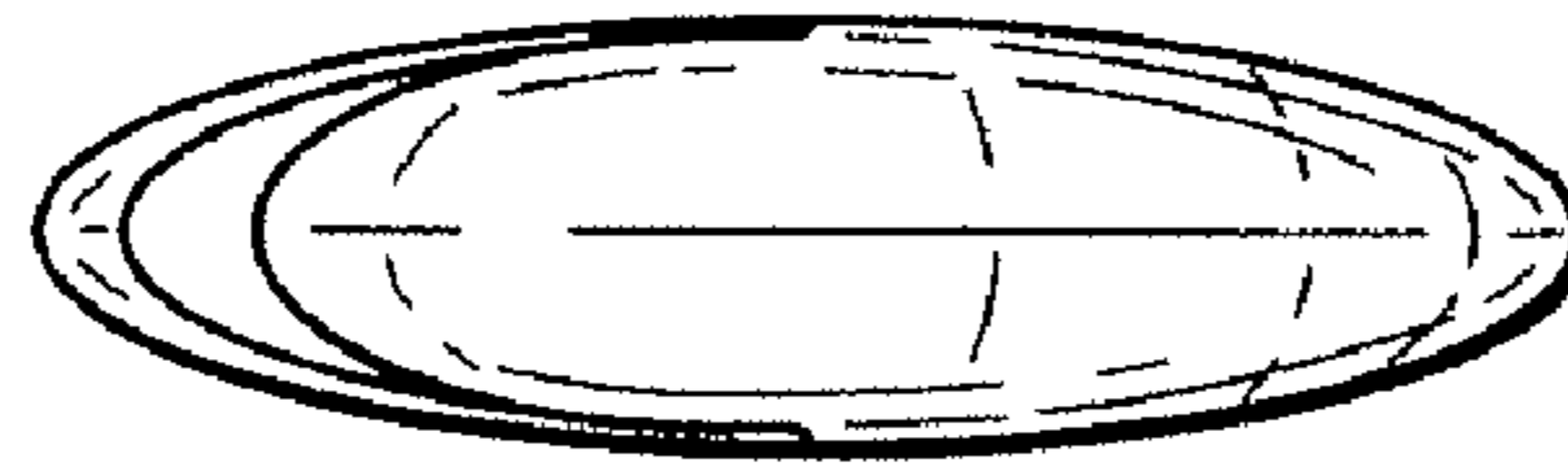
FIG. 3 is a right side elevation view thereof; and,

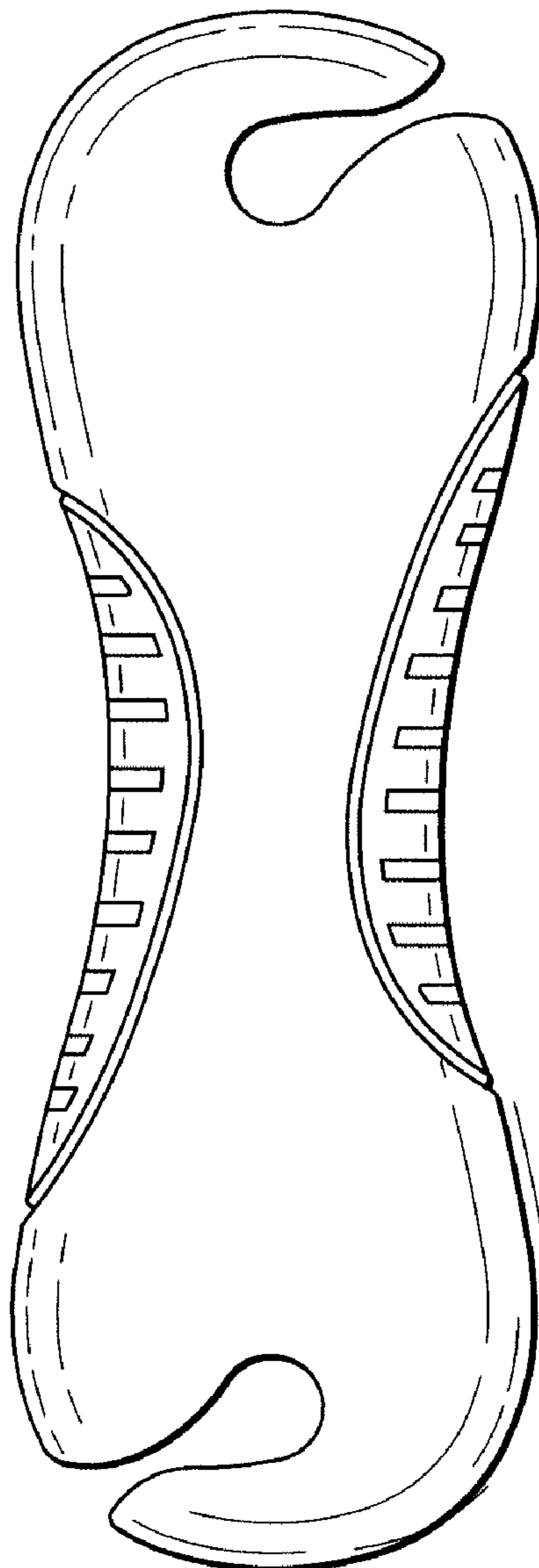

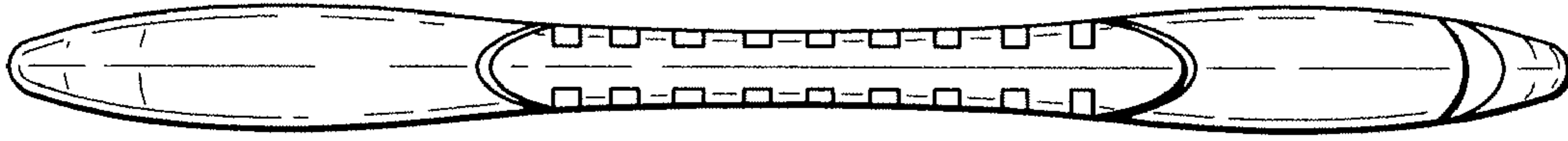
