**DESCRIPTION**

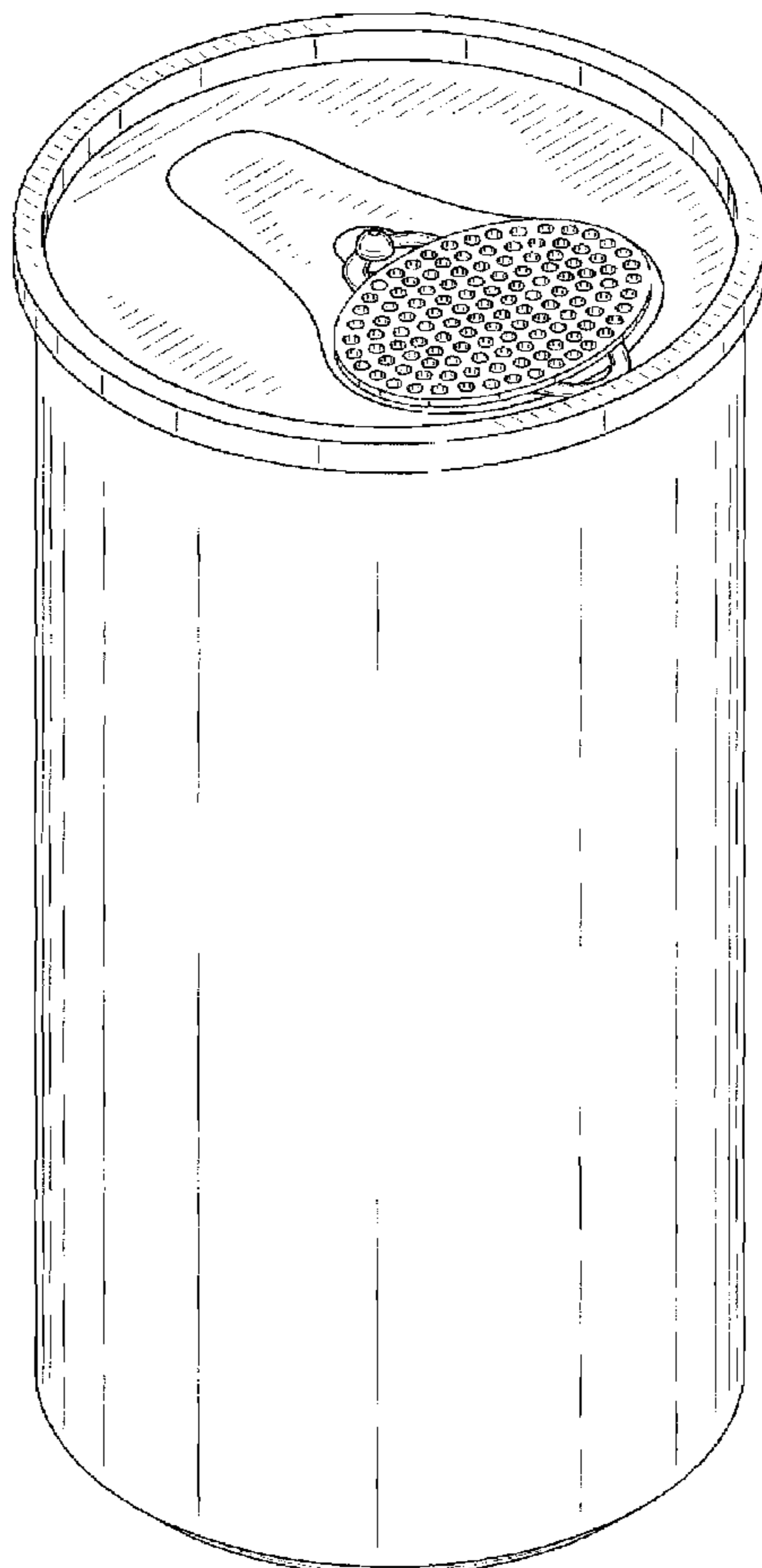

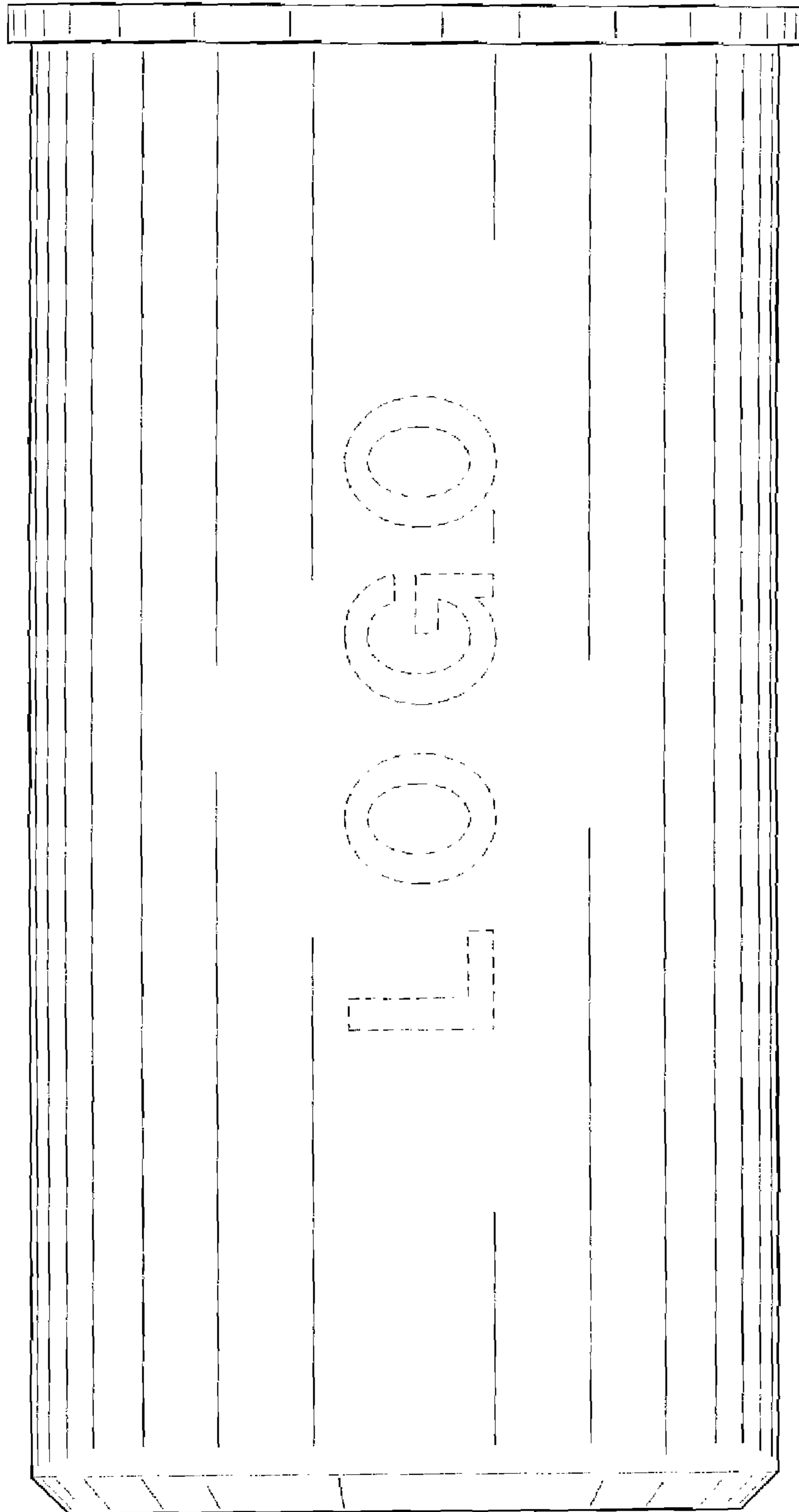
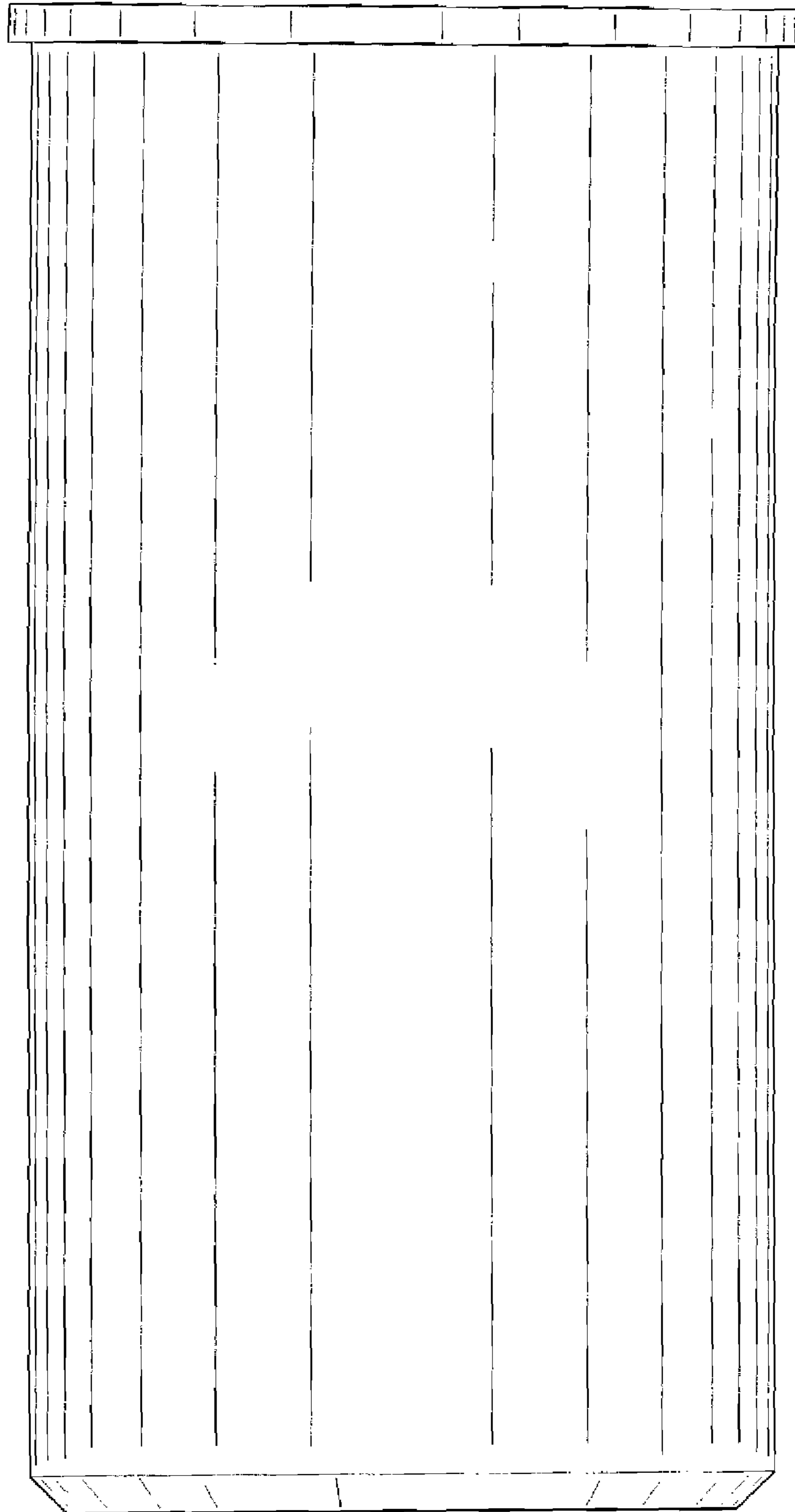

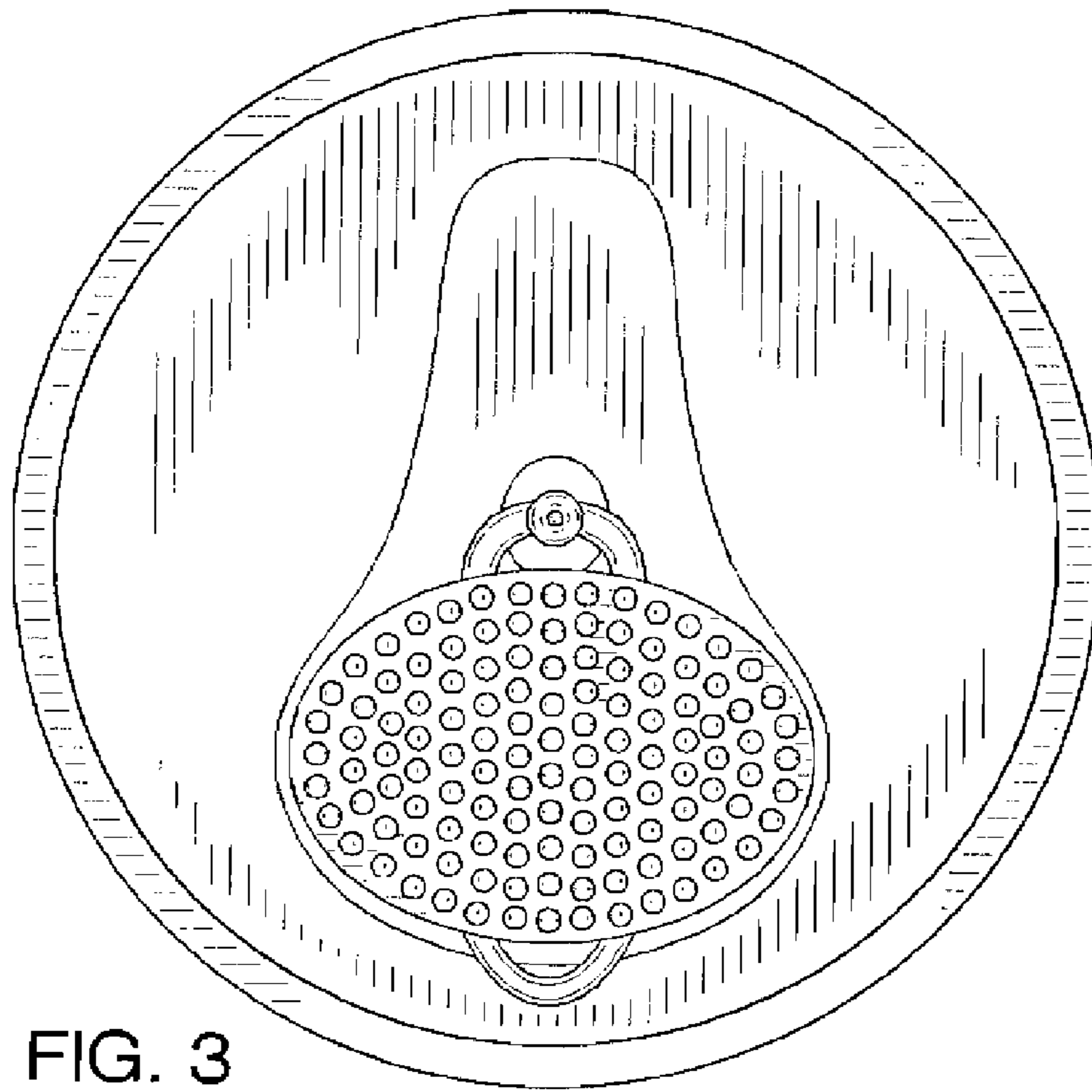

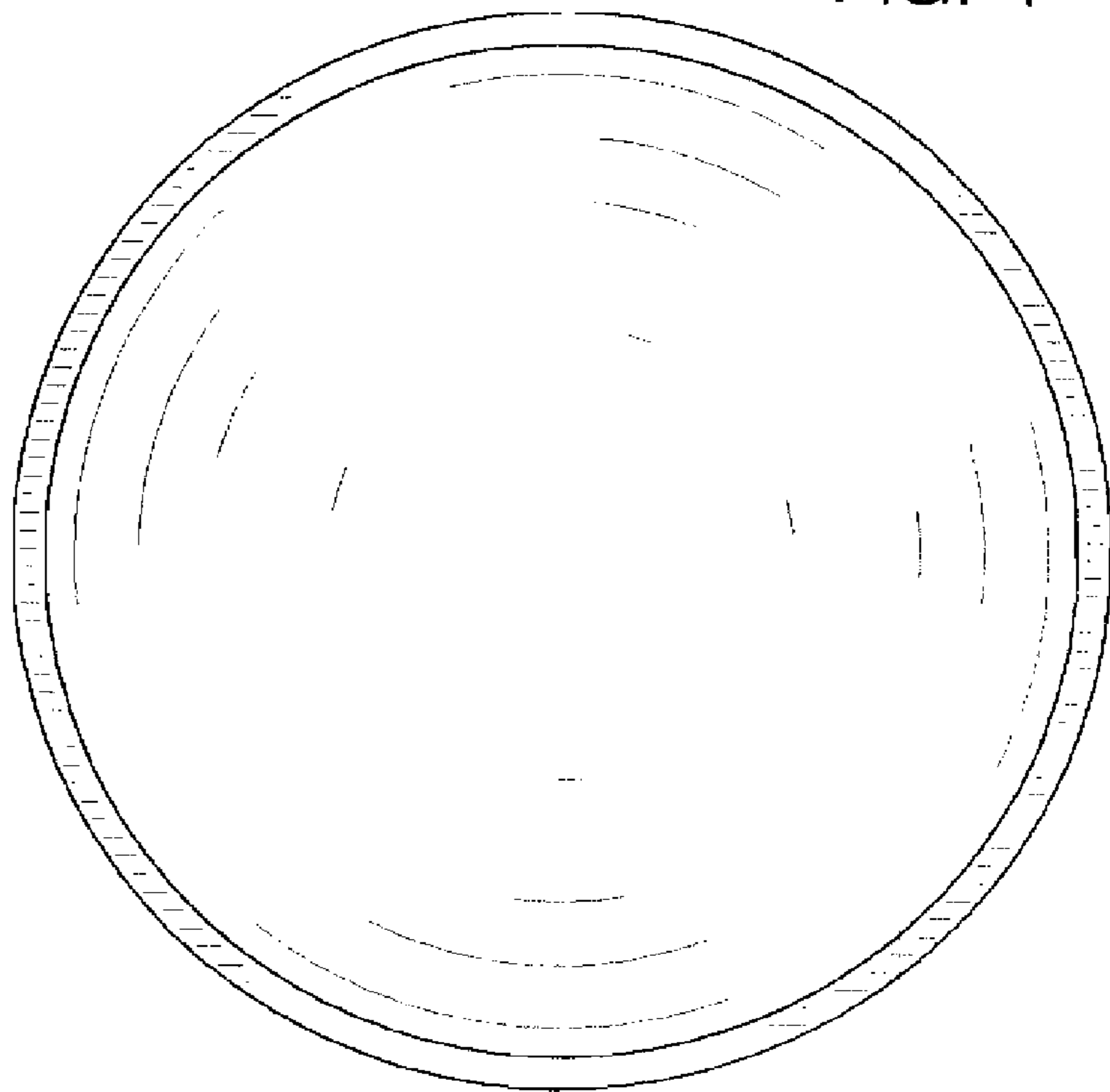
