(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a back elevation view of a bottle showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a side elevation view thereof;

FIG. 6 is an opposite side elevation view thereof; and,

FIG. 7 is a back perspective view thereof.

The broken line showing of a lower portion of a bottle clip is included for the purpose of illustrating only and form no part of the claimed design.

The shading in FIG. 1-7 excluding FIG. 2 is understood to indicate a flat surface.

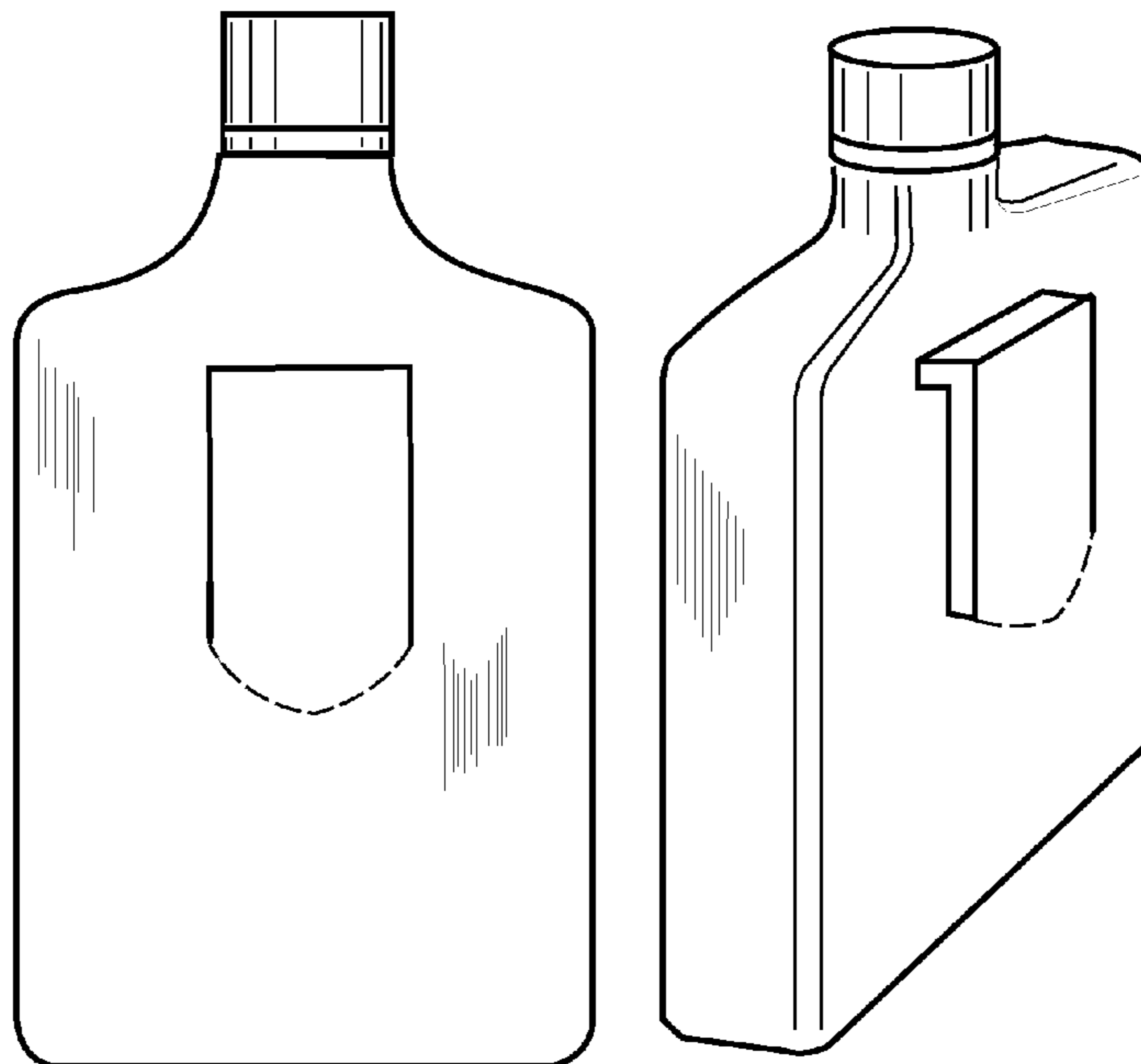

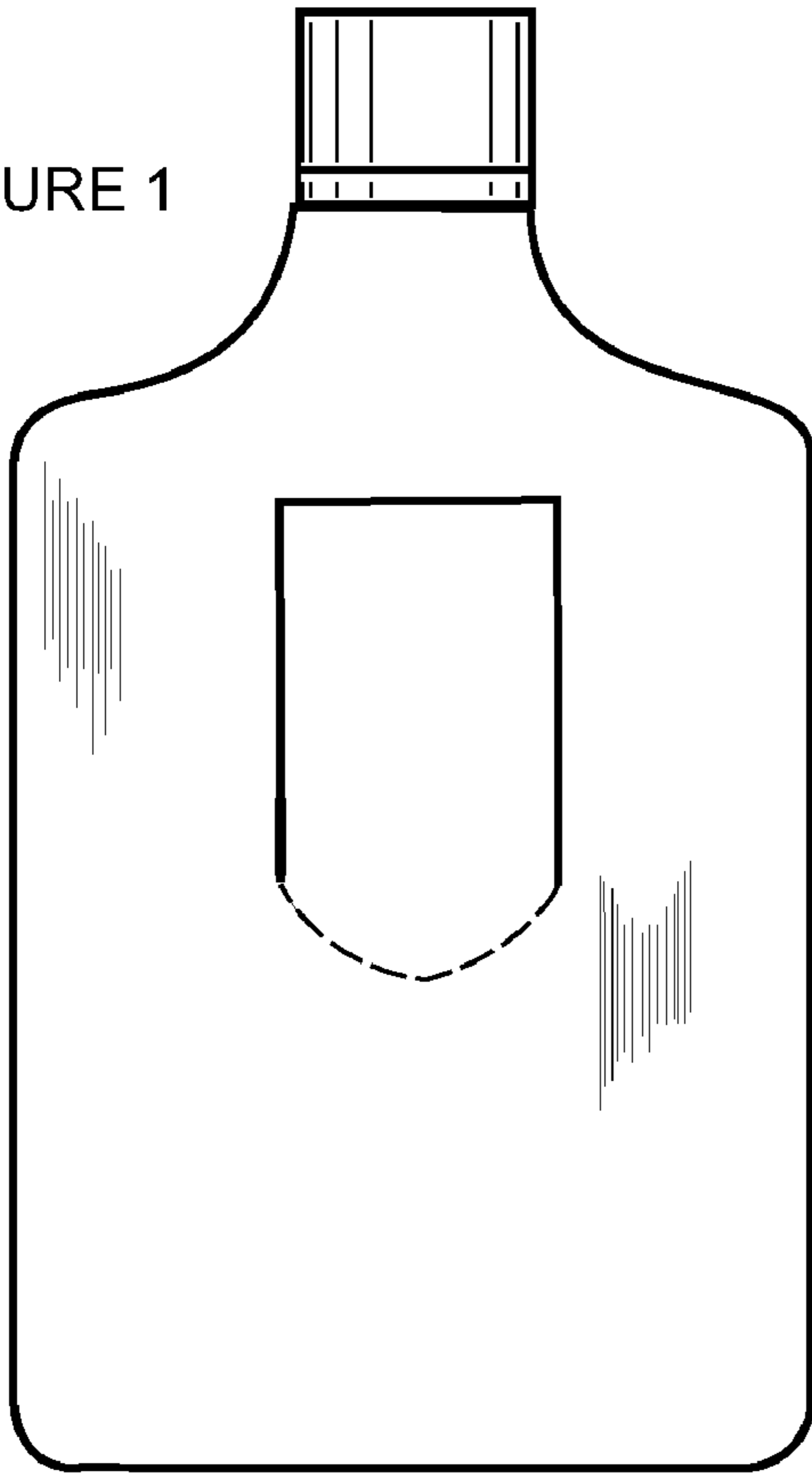

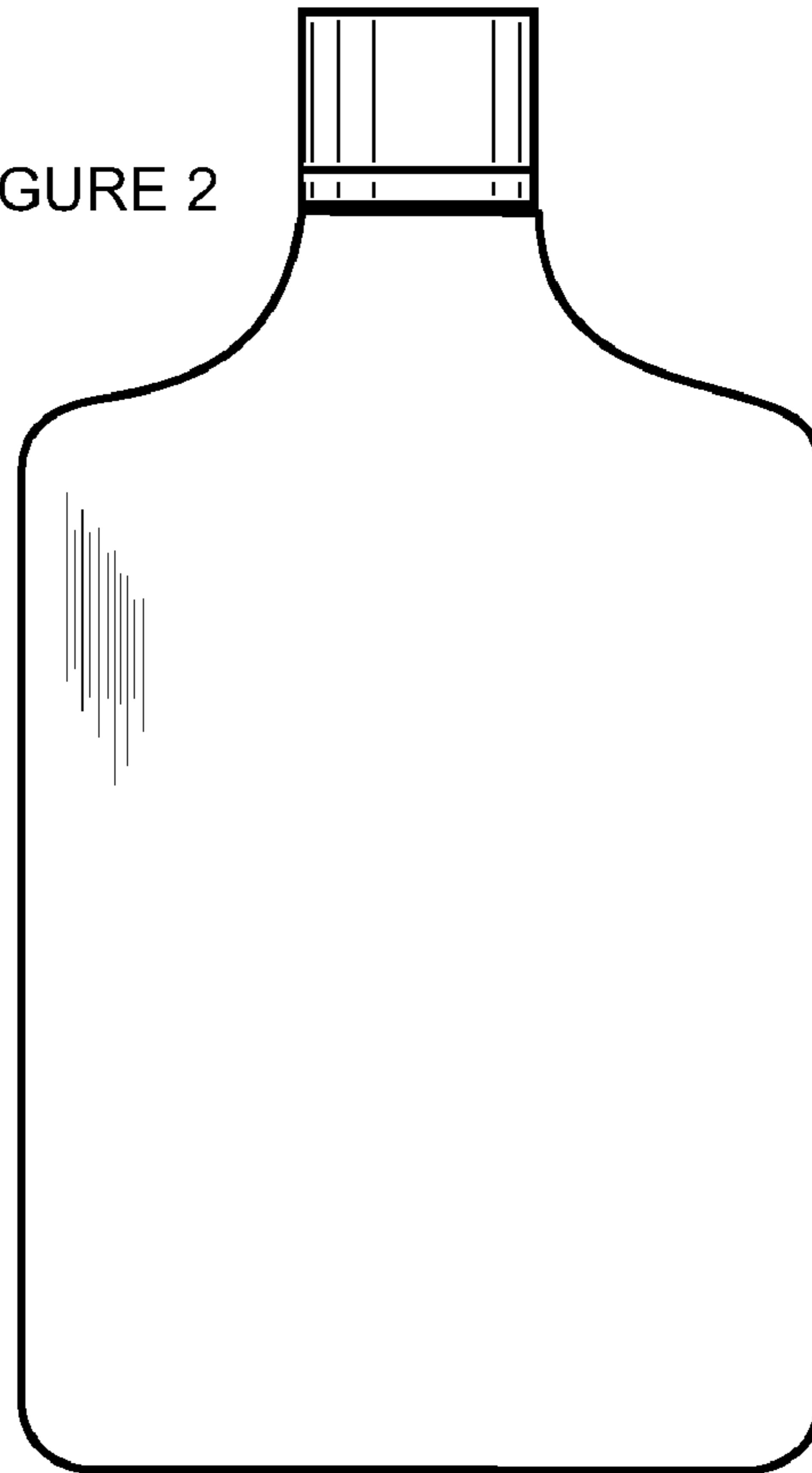

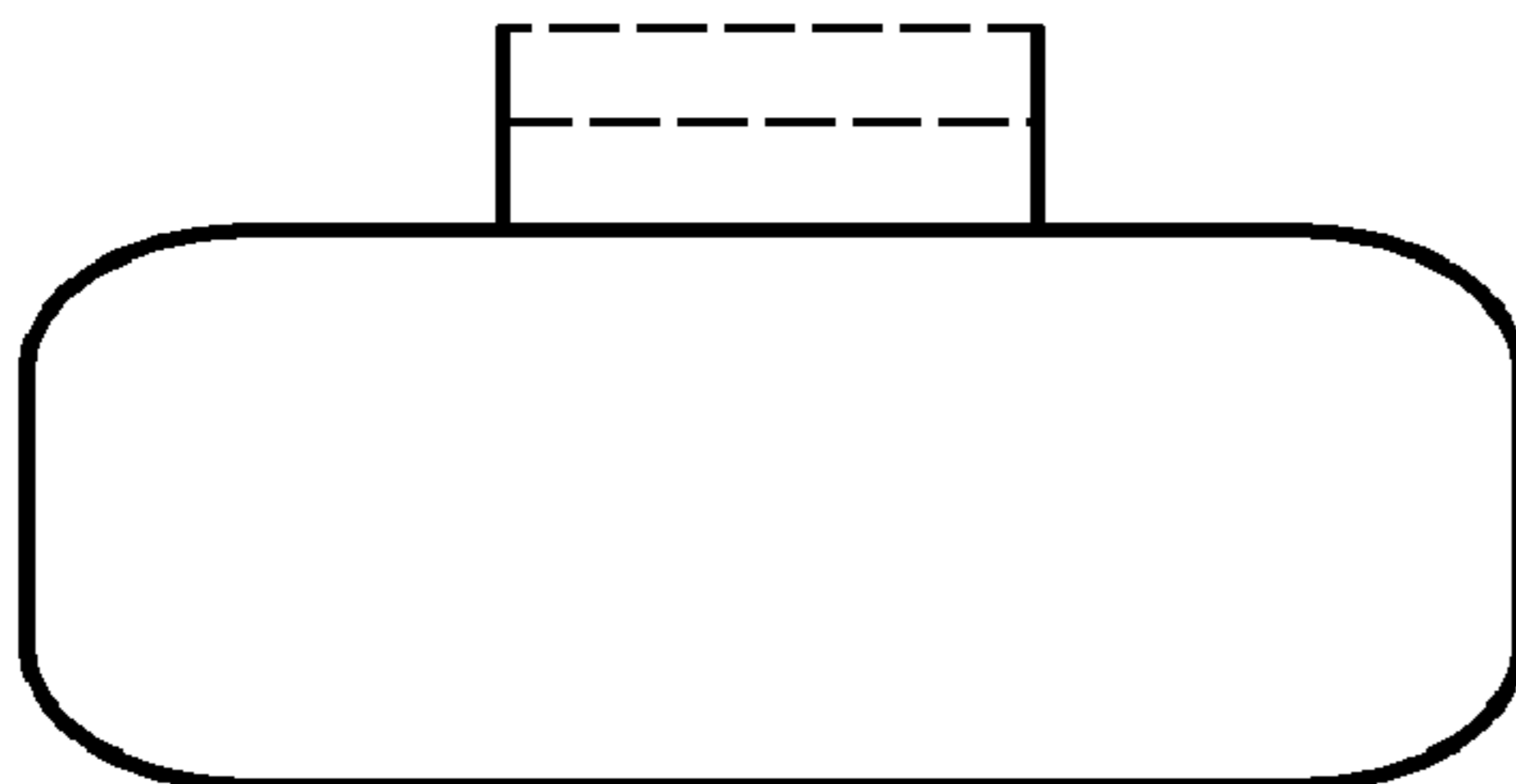

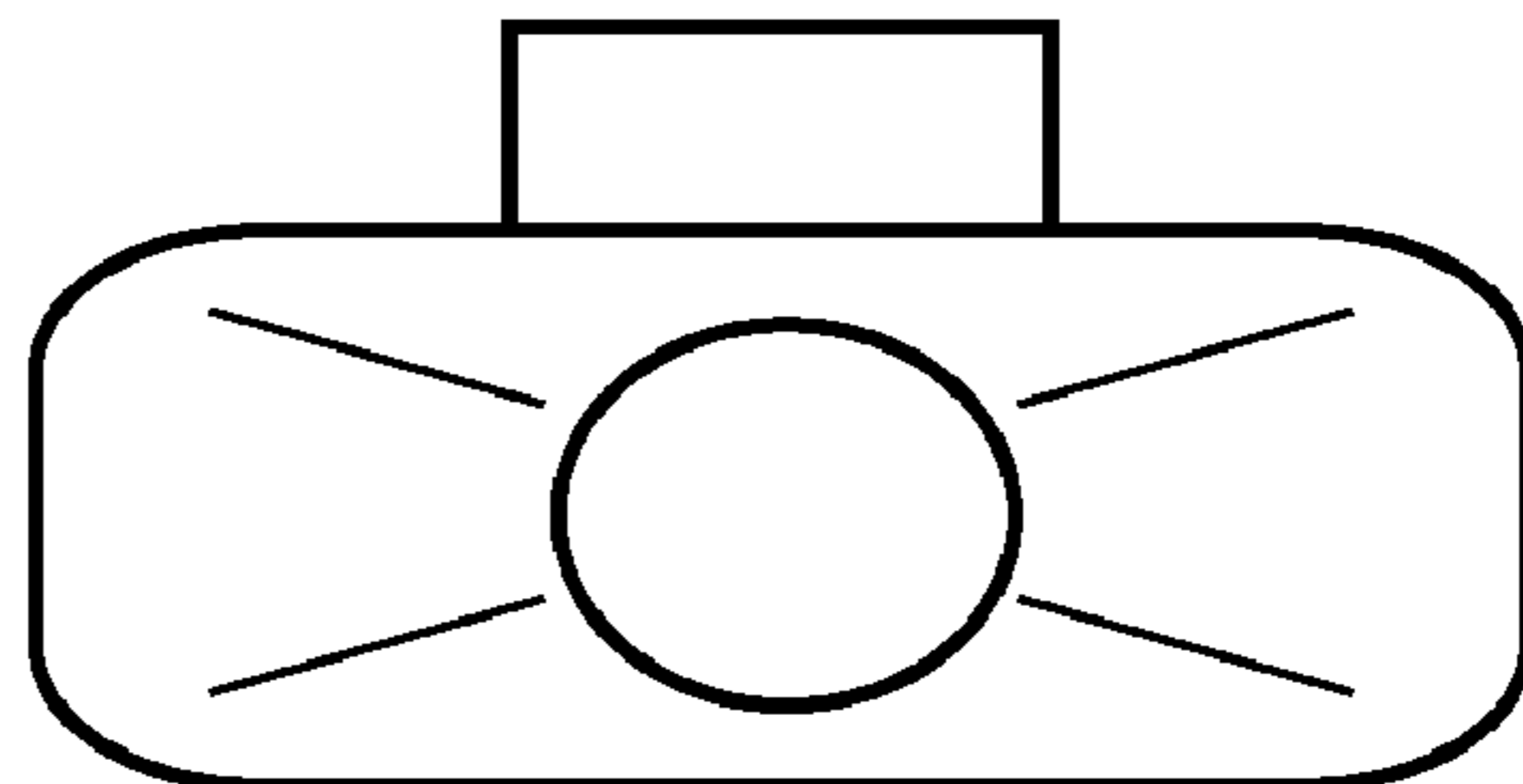

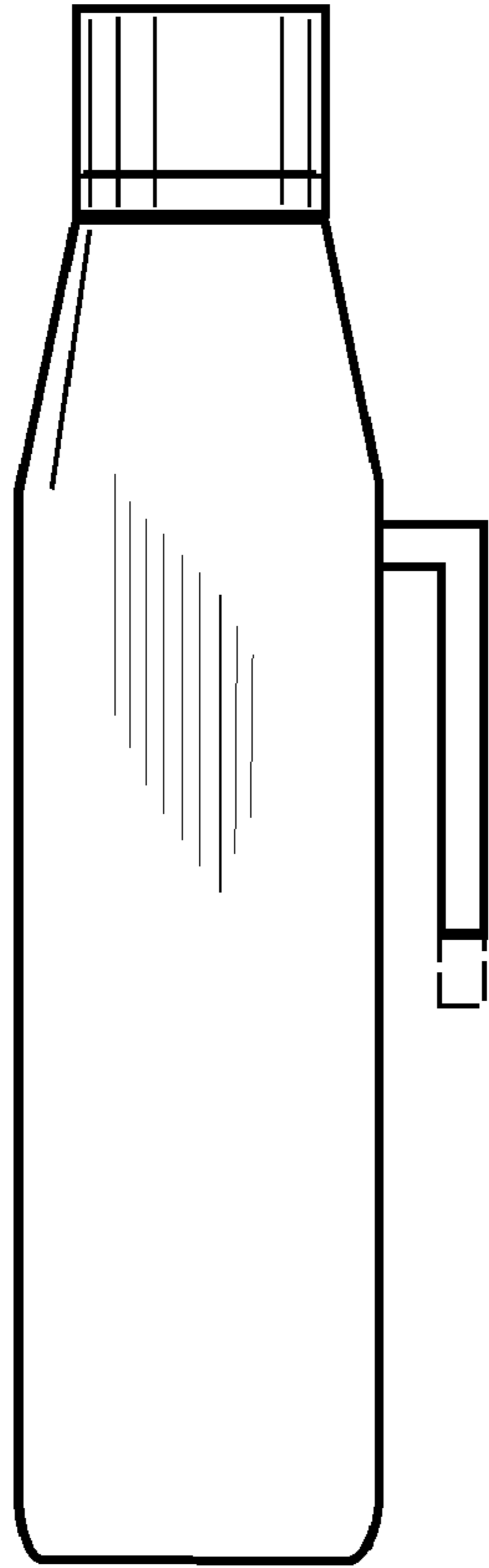

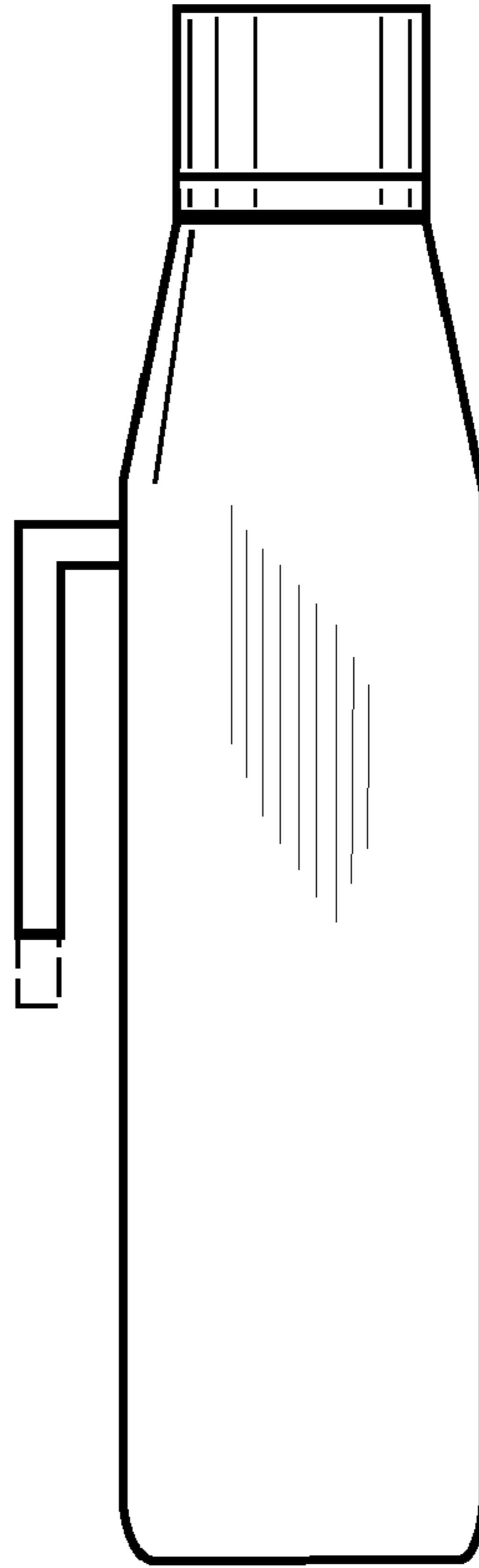
