FIG. 2 is a side view thereof;

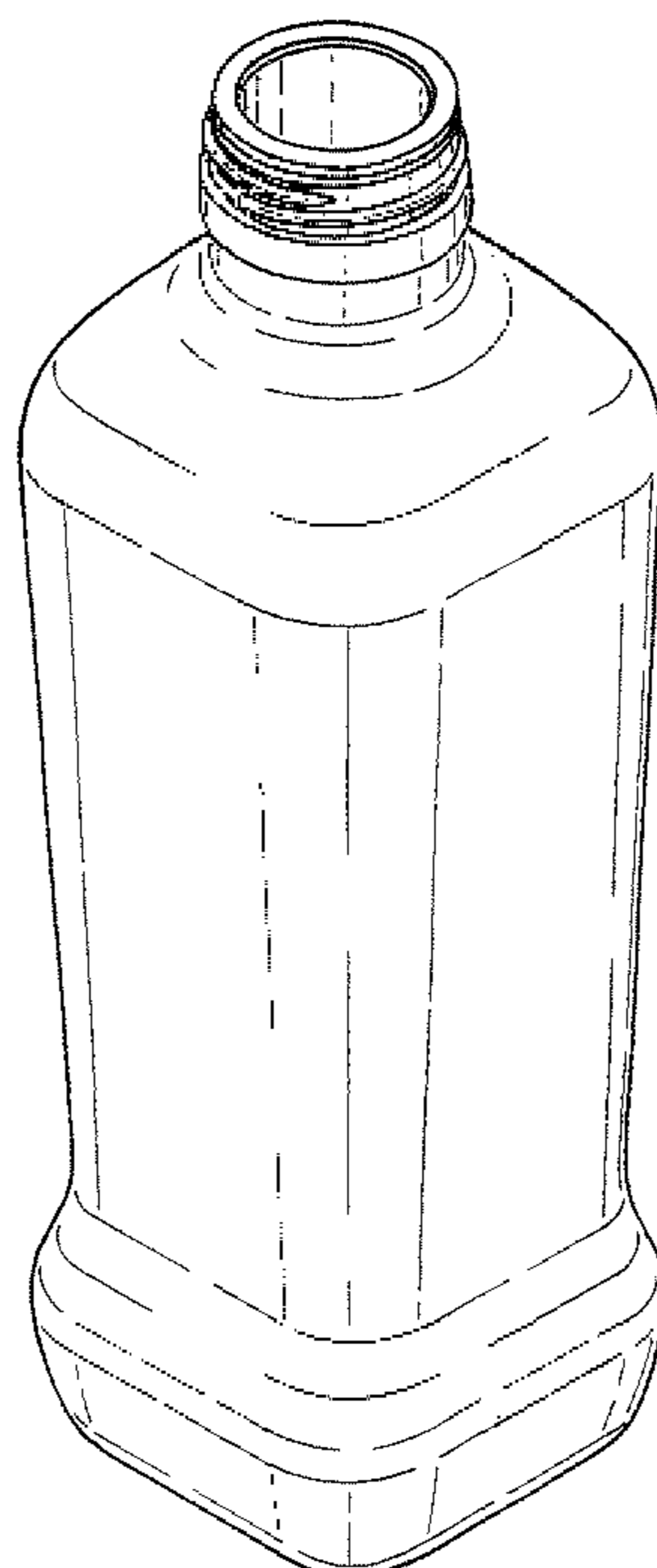
FIG. 3 is a side view from the other side thereof;

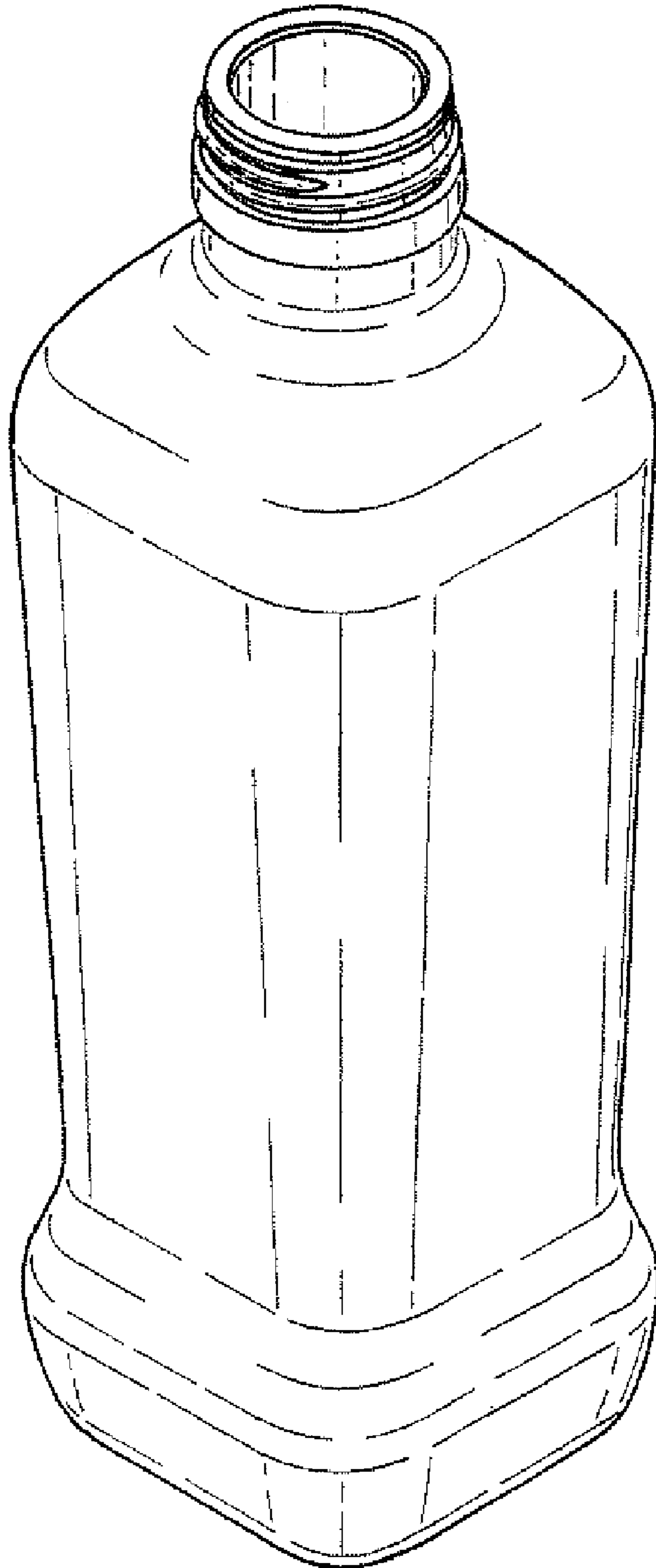

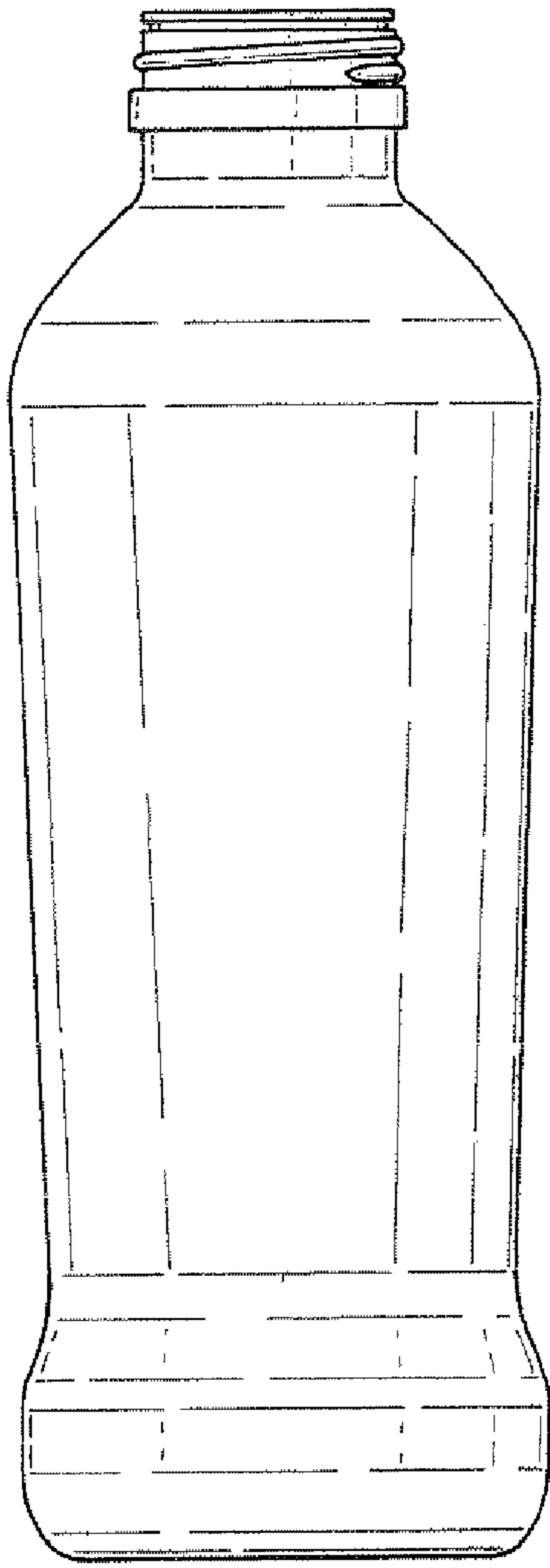

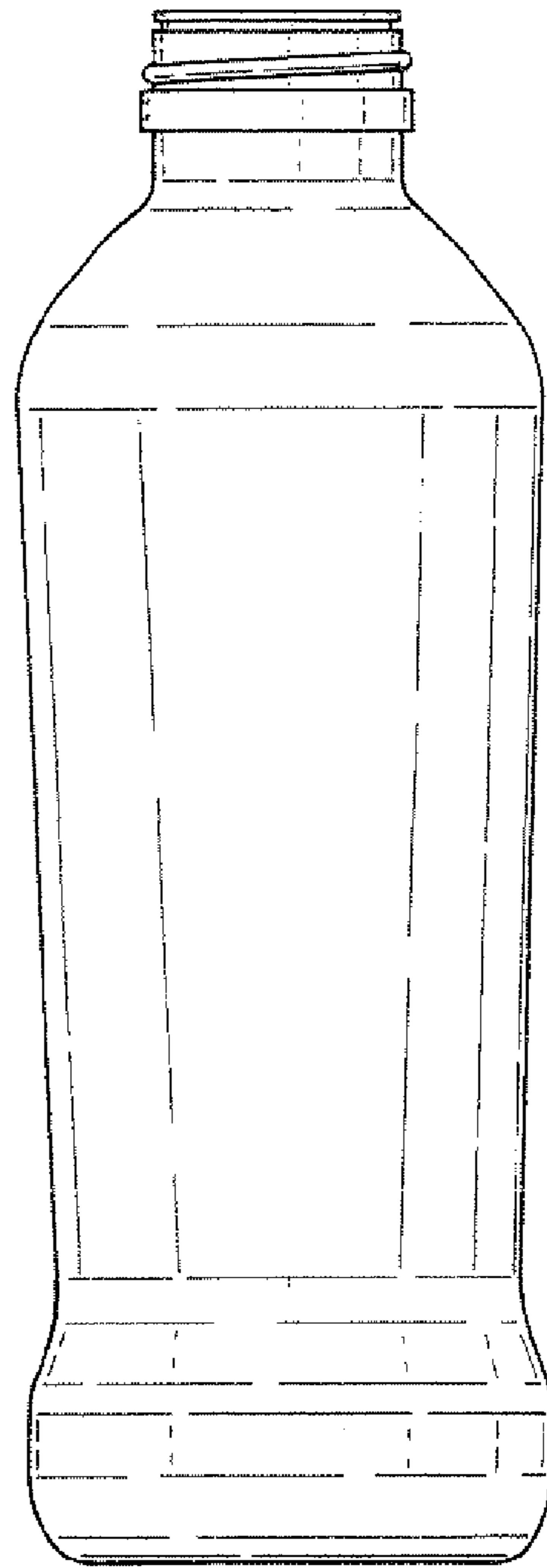

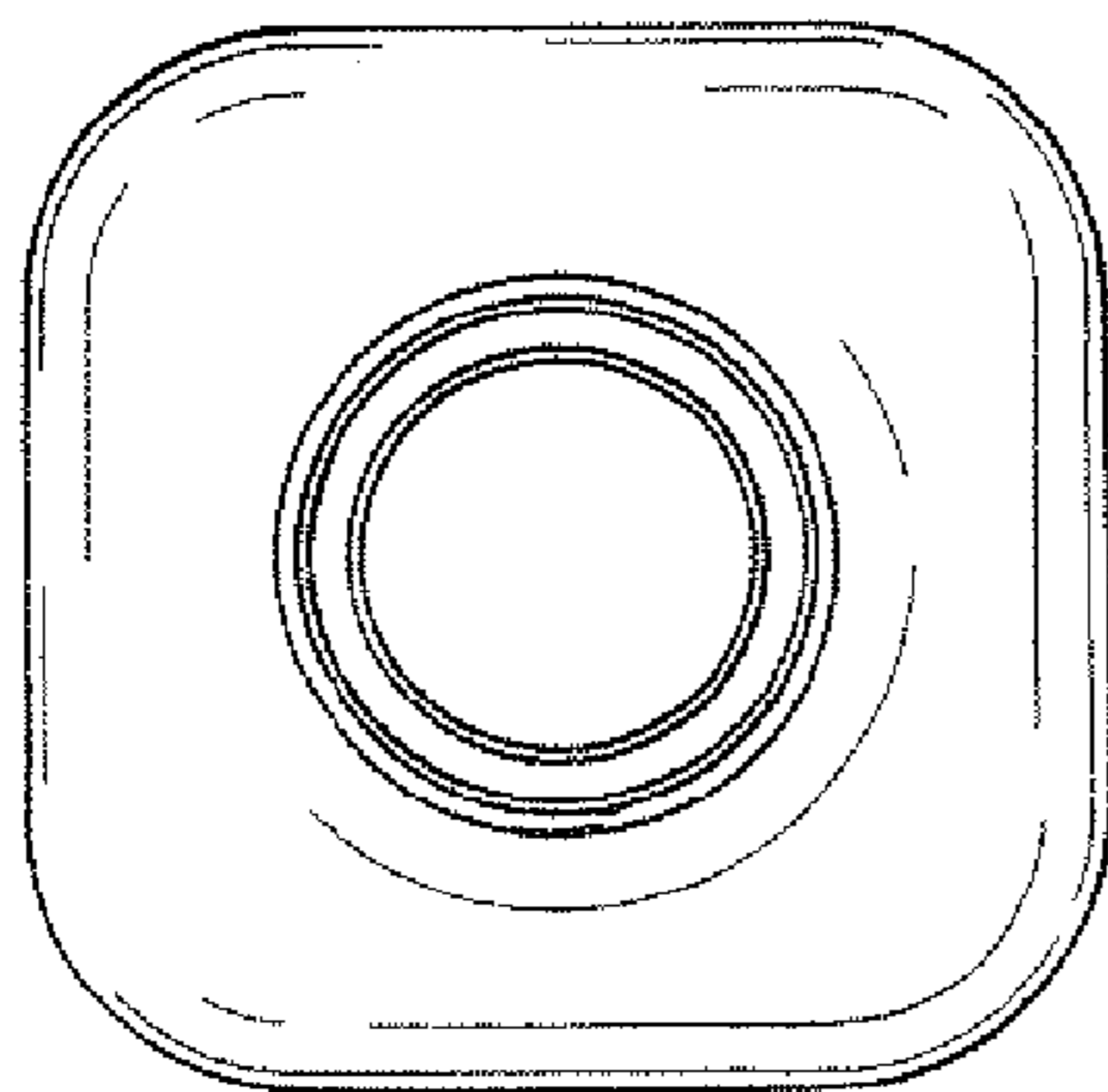

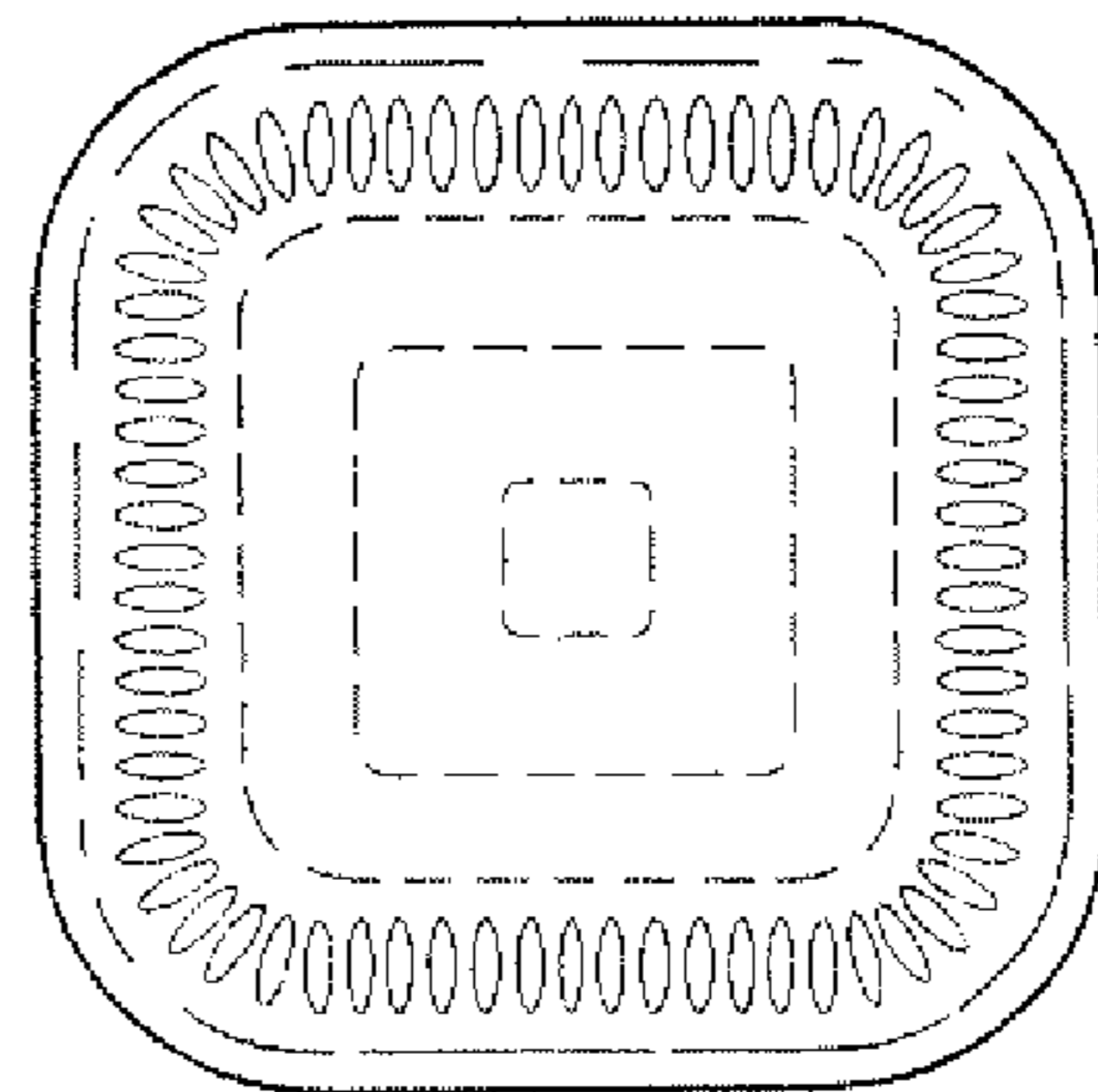
