(57) **CLAIM**

The ornamental design for a rear fender for a vehicle, as shown and described.

DESCRIPTION

This application is related to the following co-pending application:

Application Ser. No. 29/309,034, entitled “Vehicle, Toy, or Likeness Thereof”.

FIG. 1 is a left perspective view of an embodiment of a rear fender for a vehicle according to my novel design;

FIG. 9 is a front view of FIG. 7;

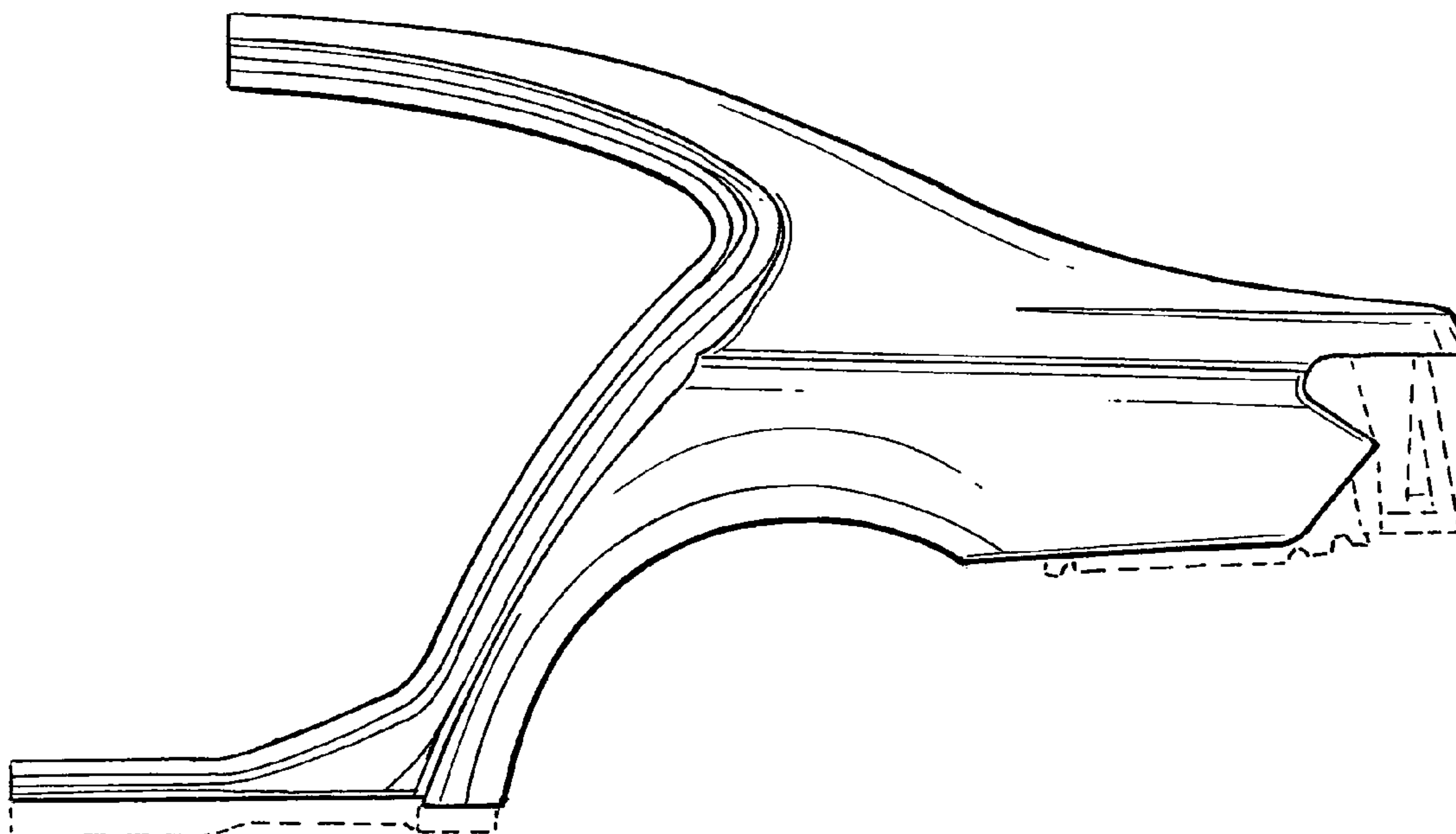
FIG. 10 is a top view of FIG. 7;

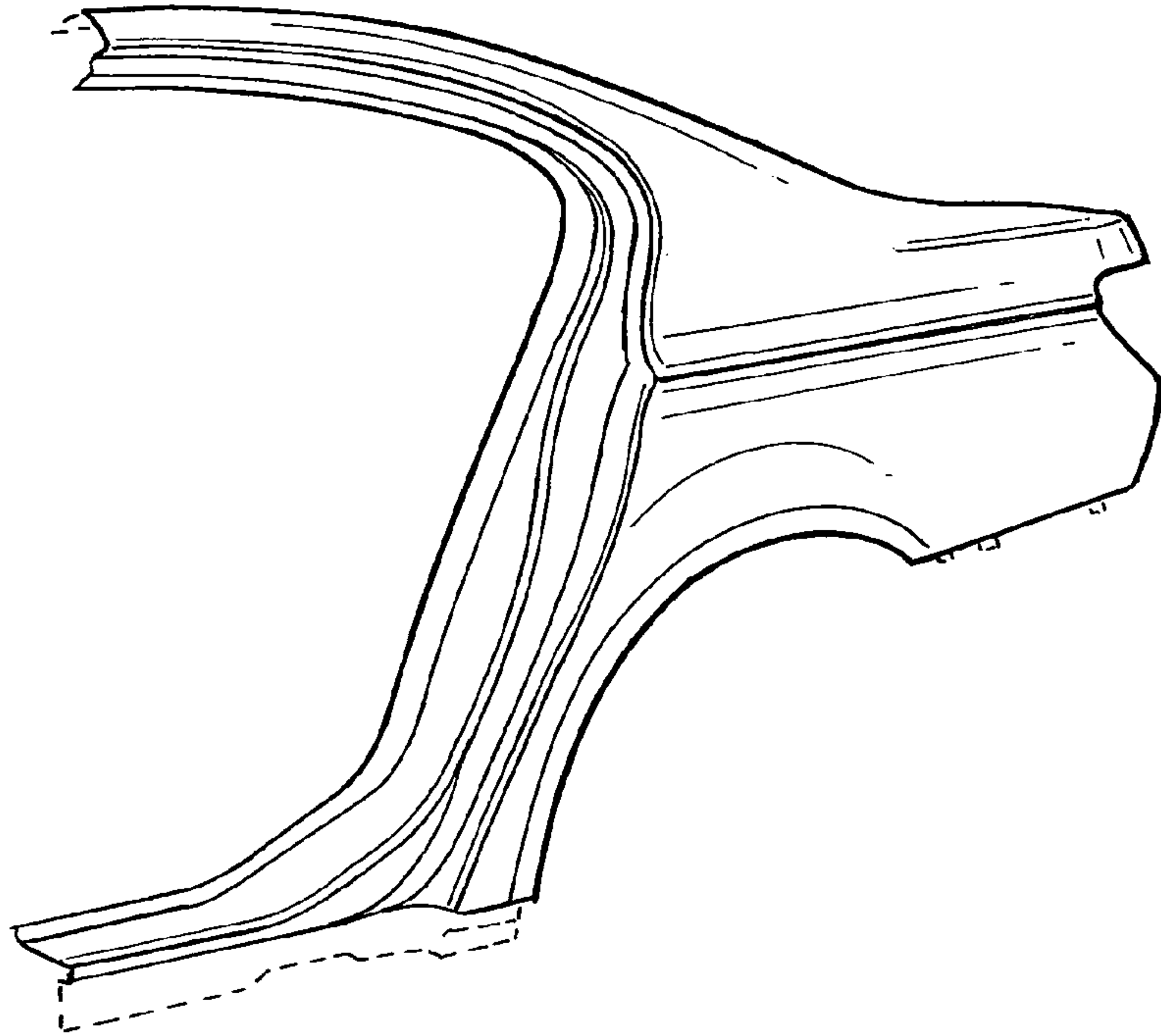

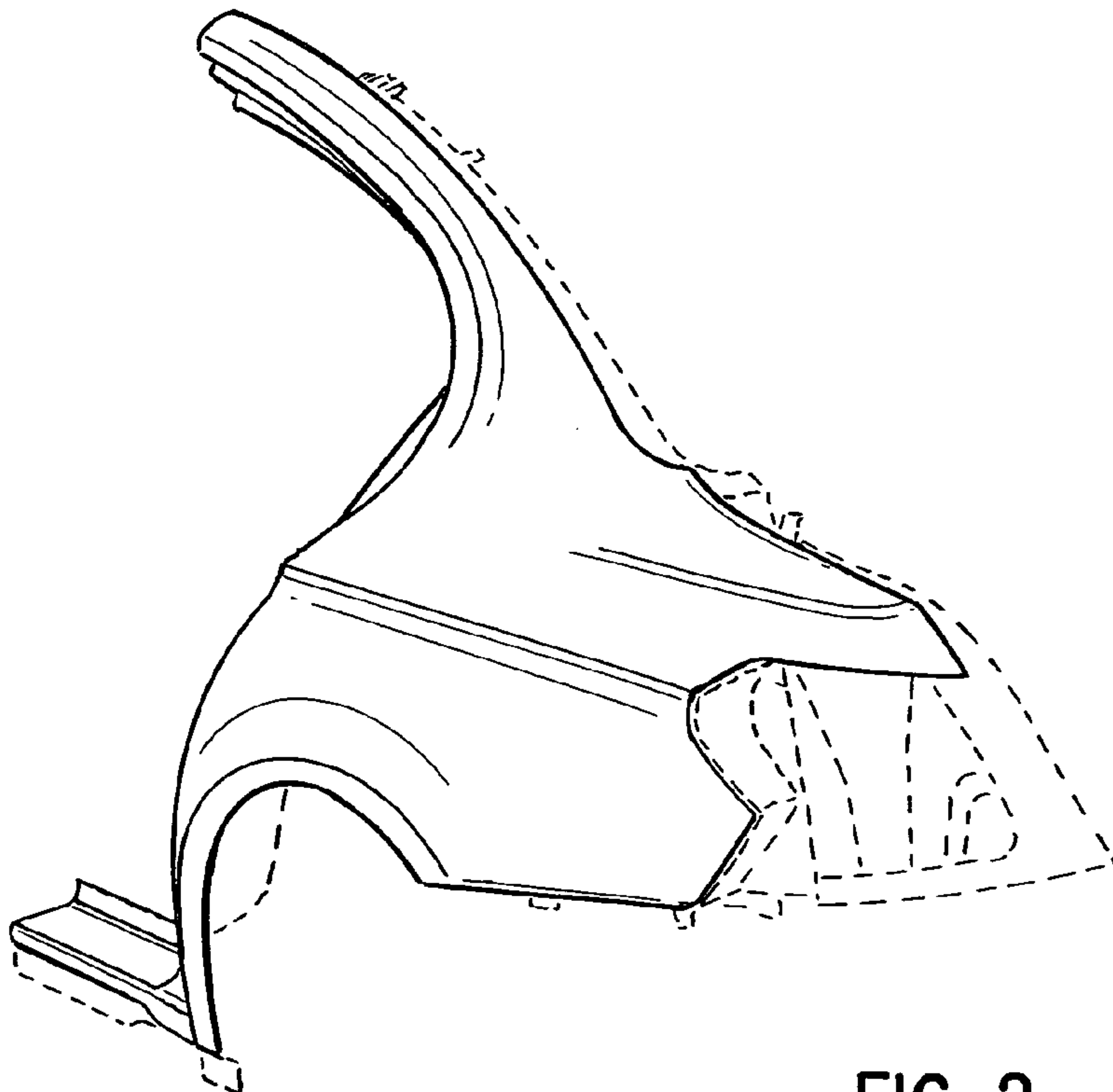

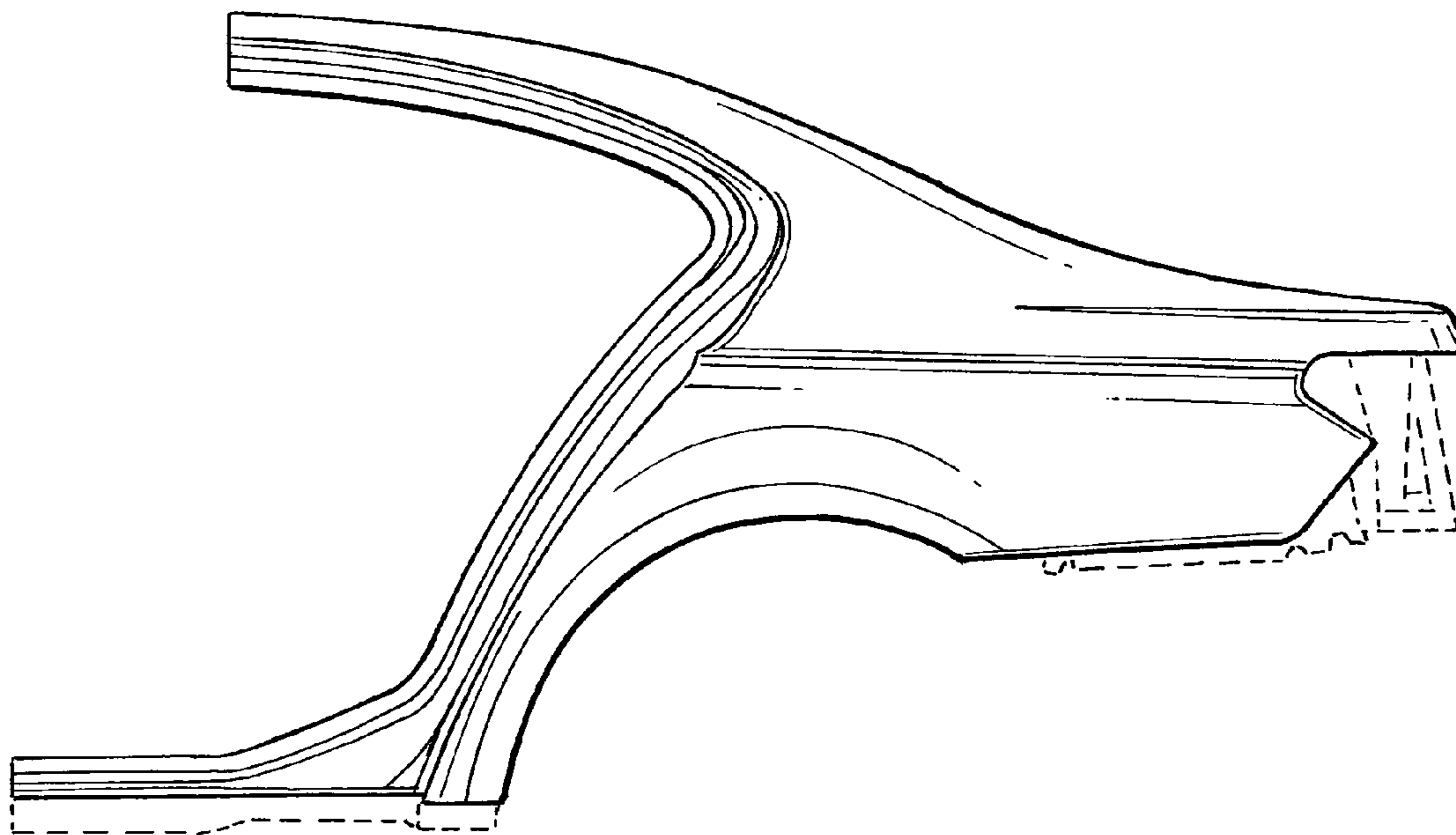

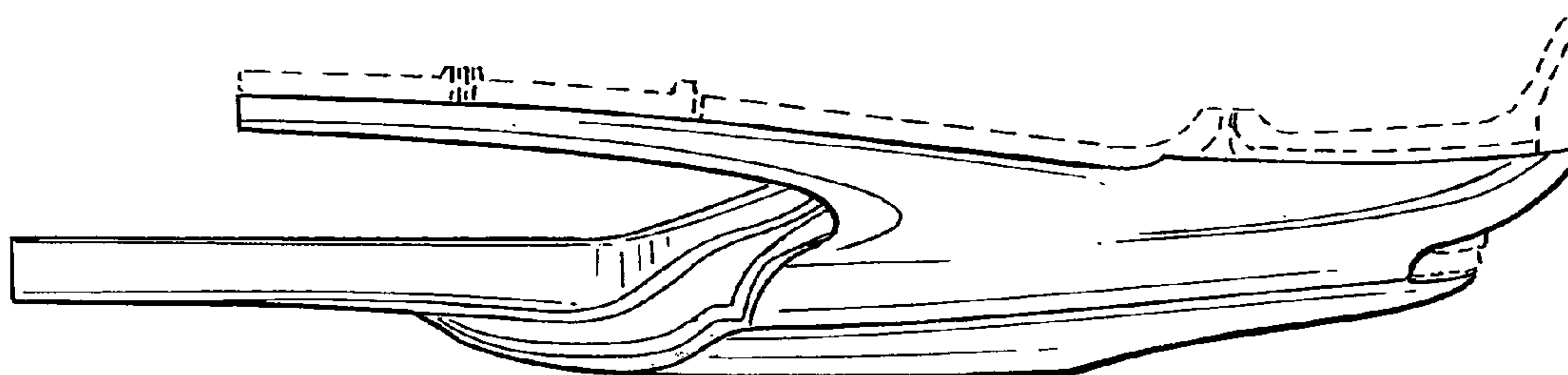

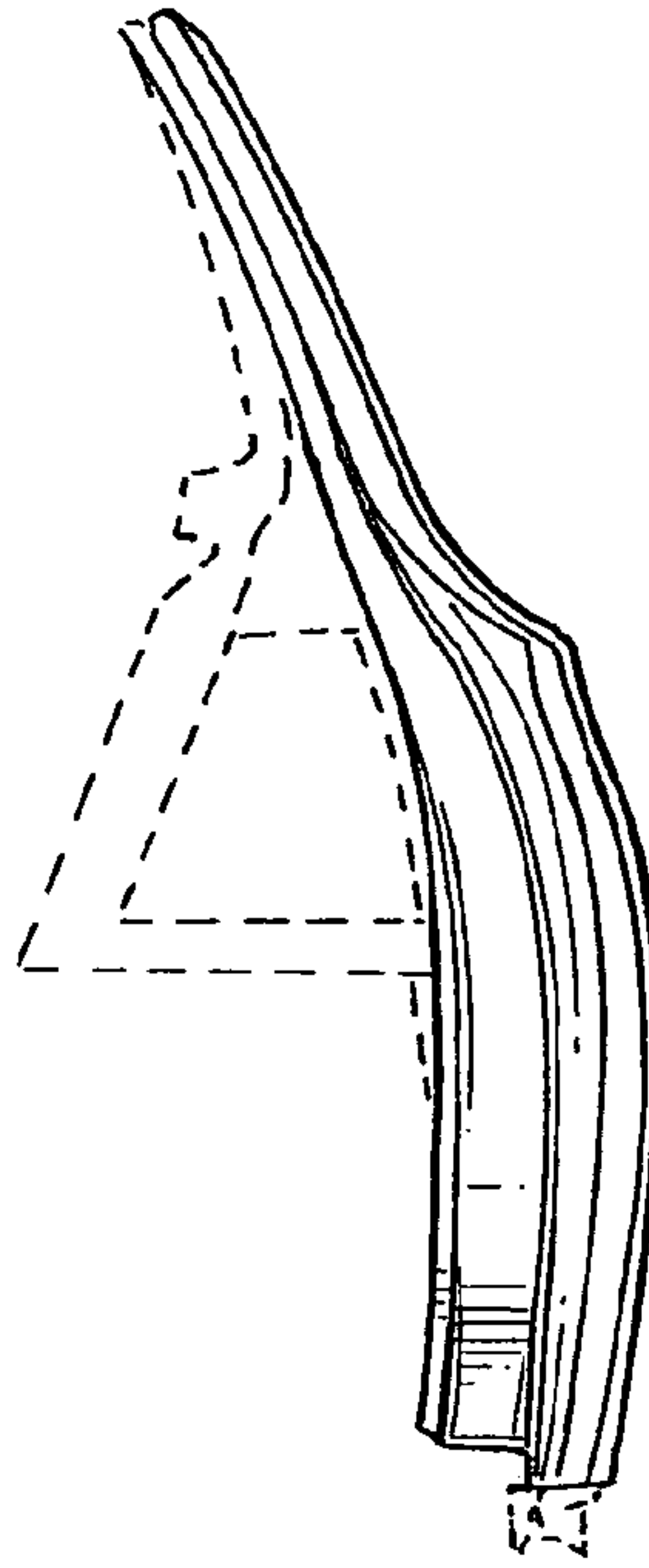

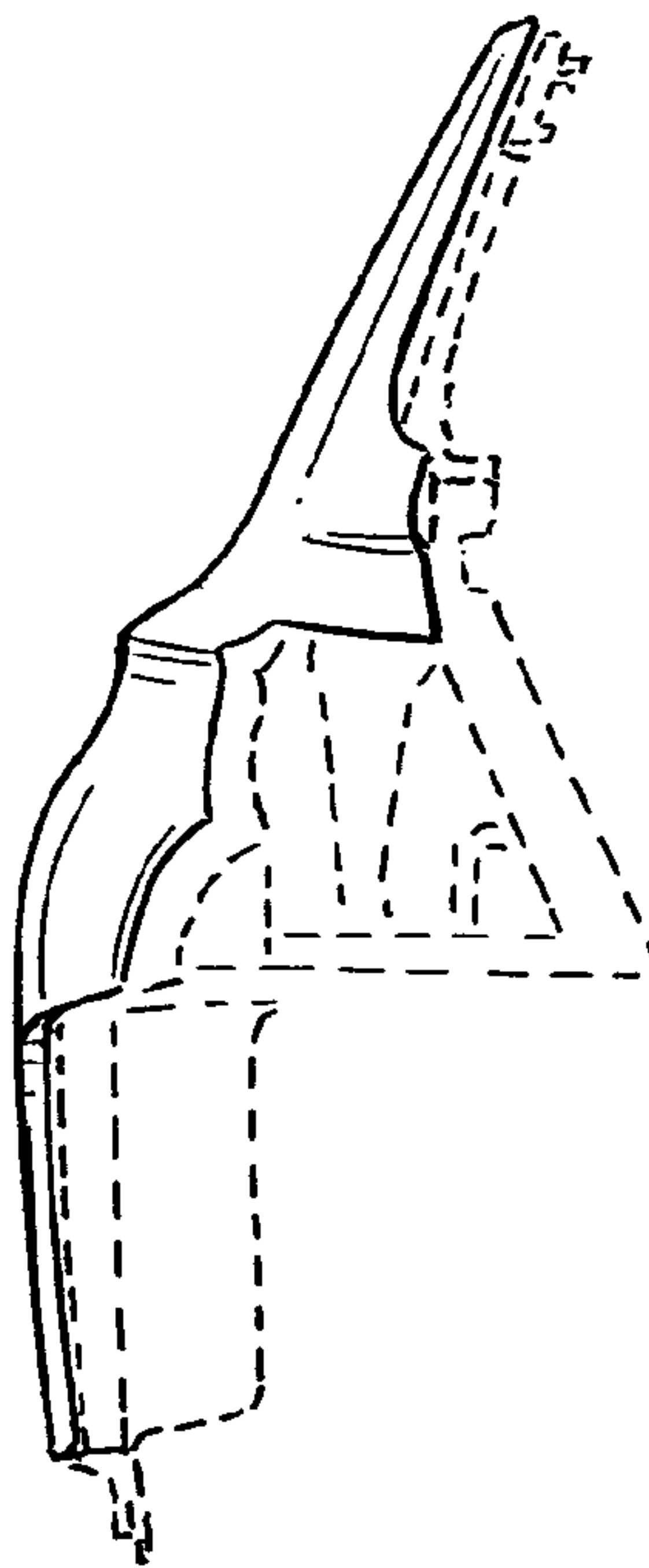

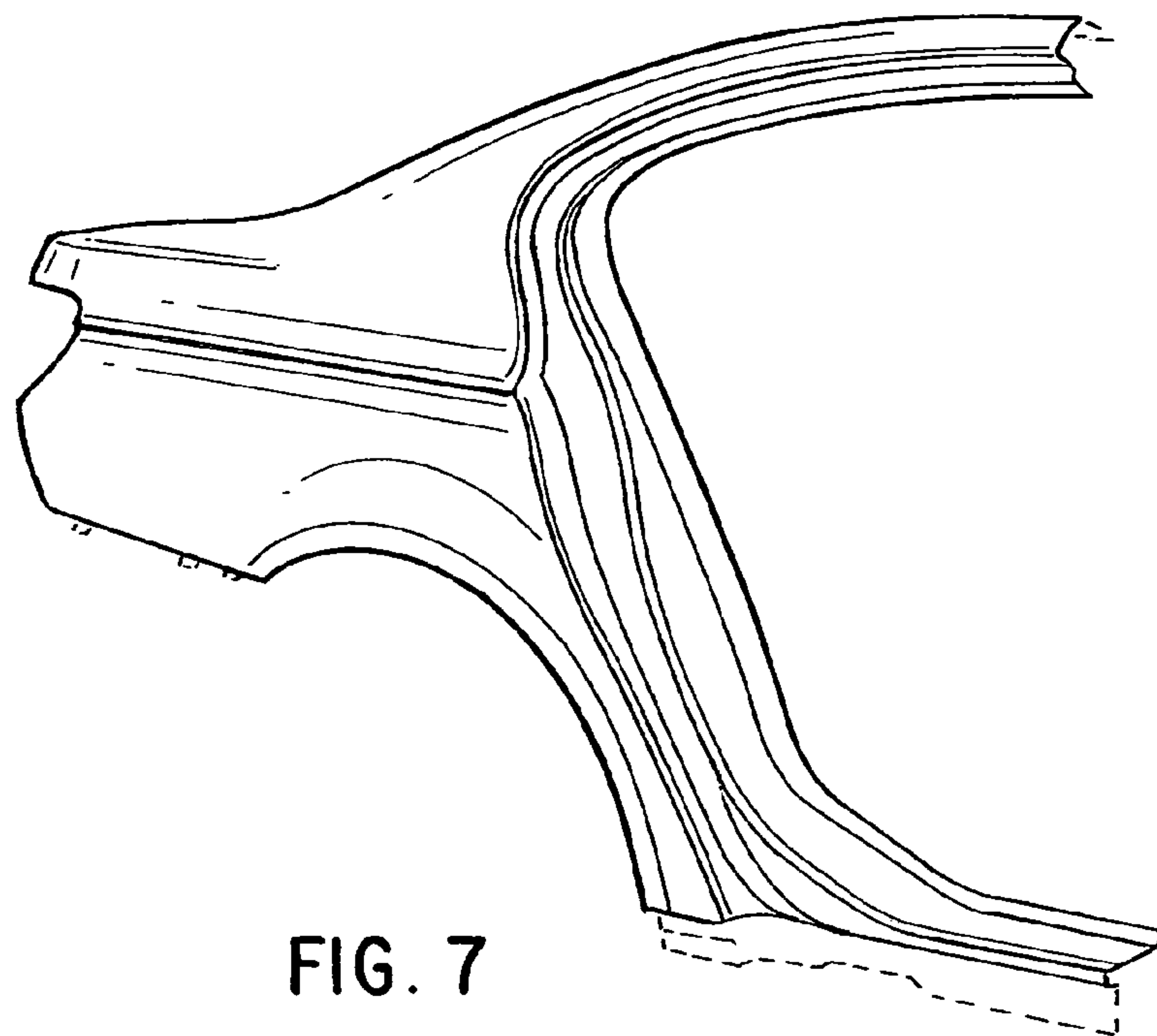

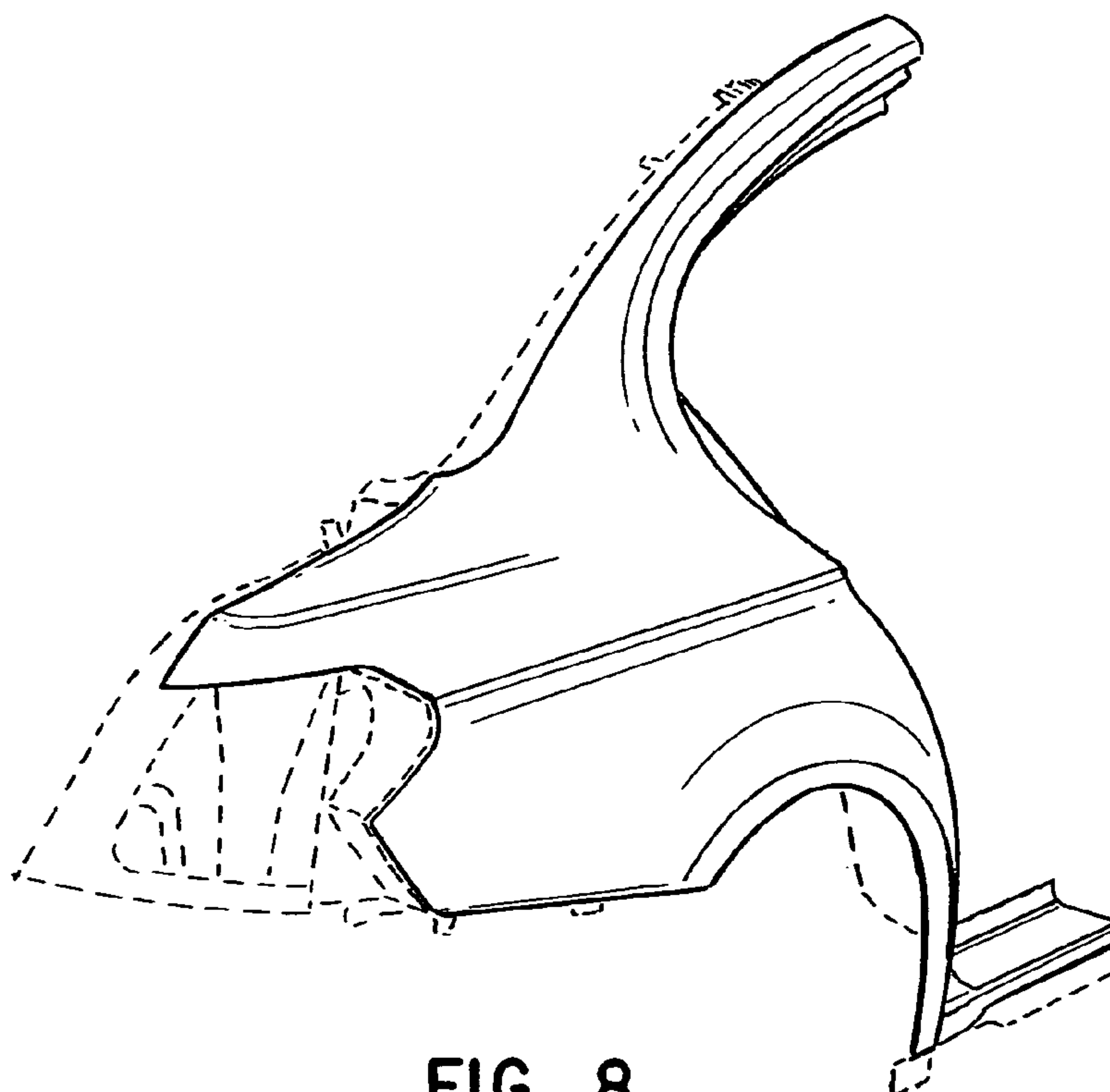

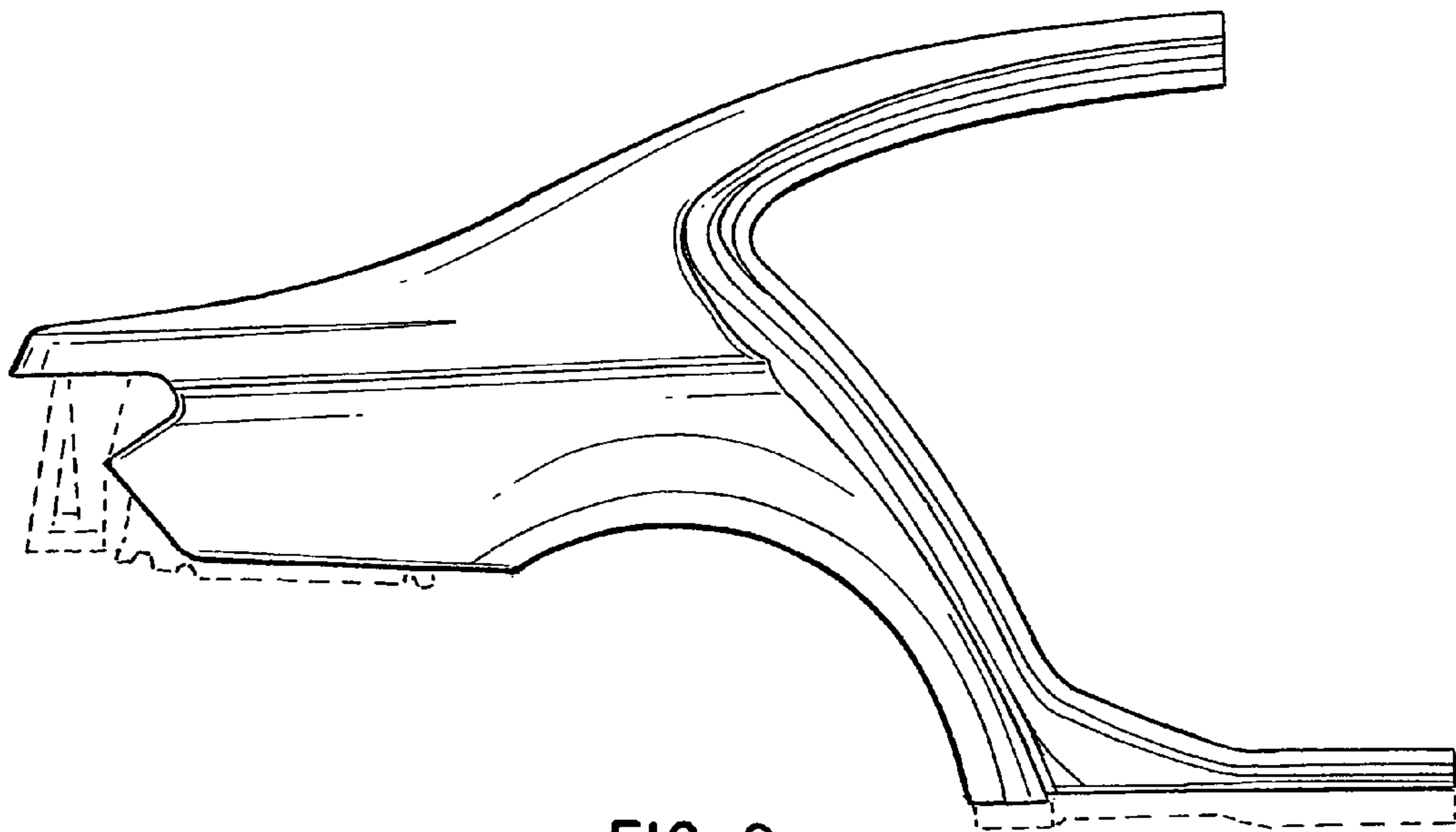

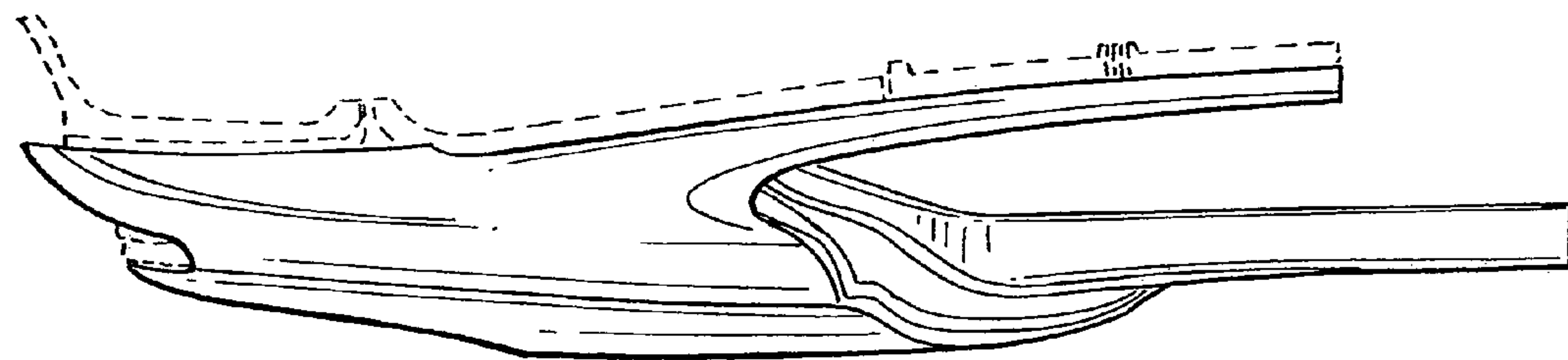

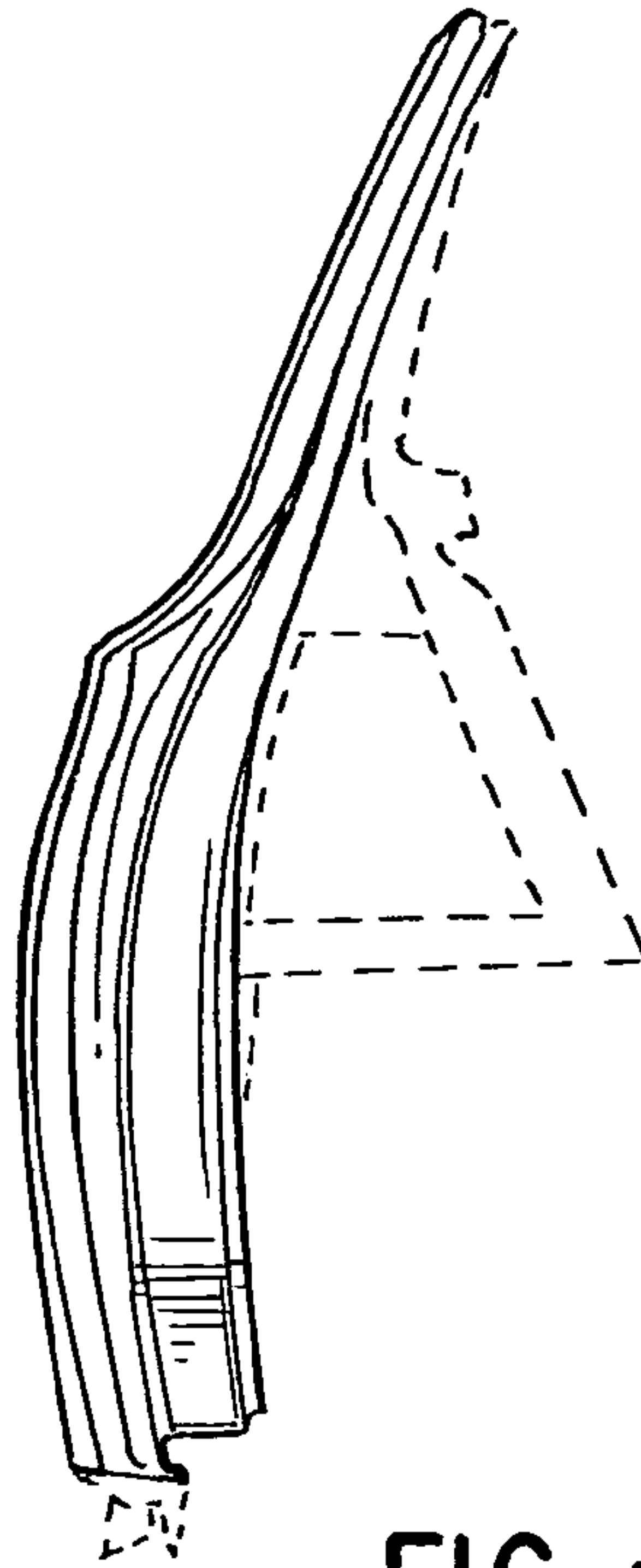

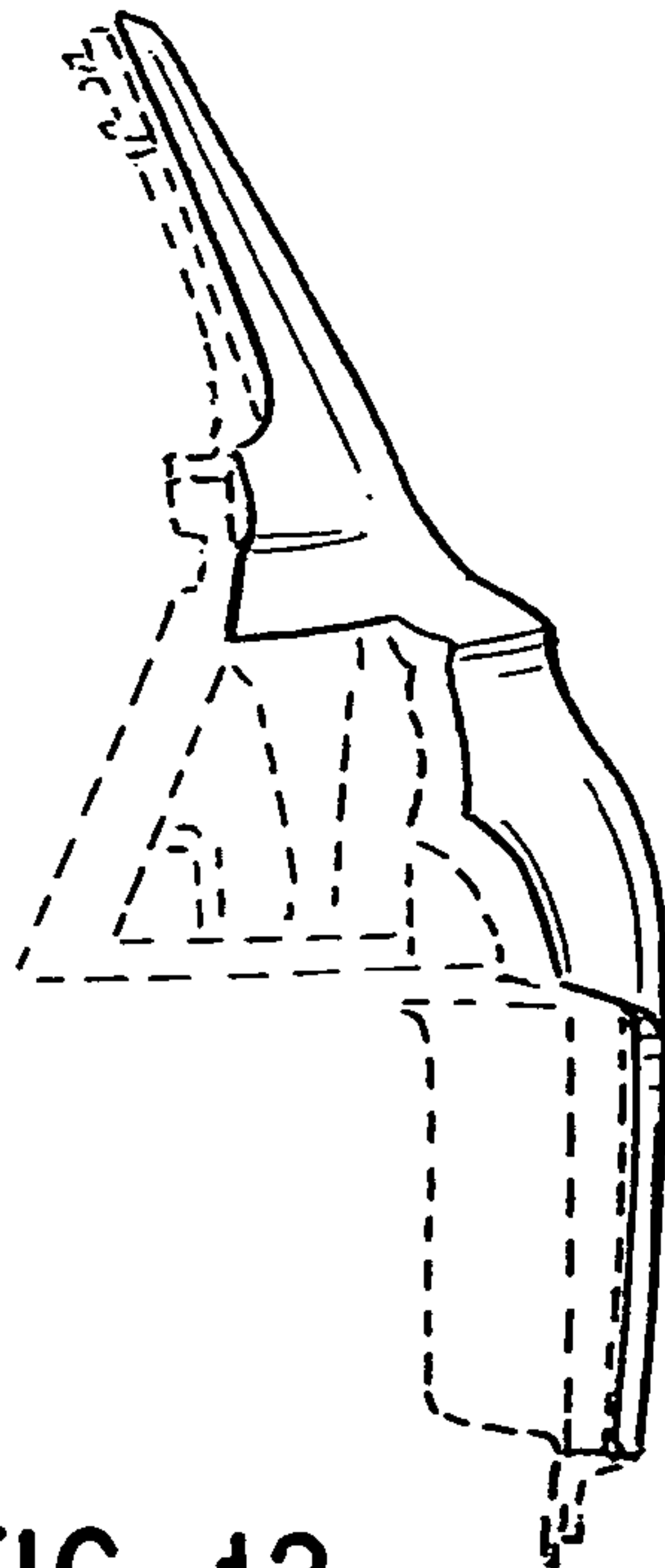
