FIG. 2 is a front view of the car dashboard;

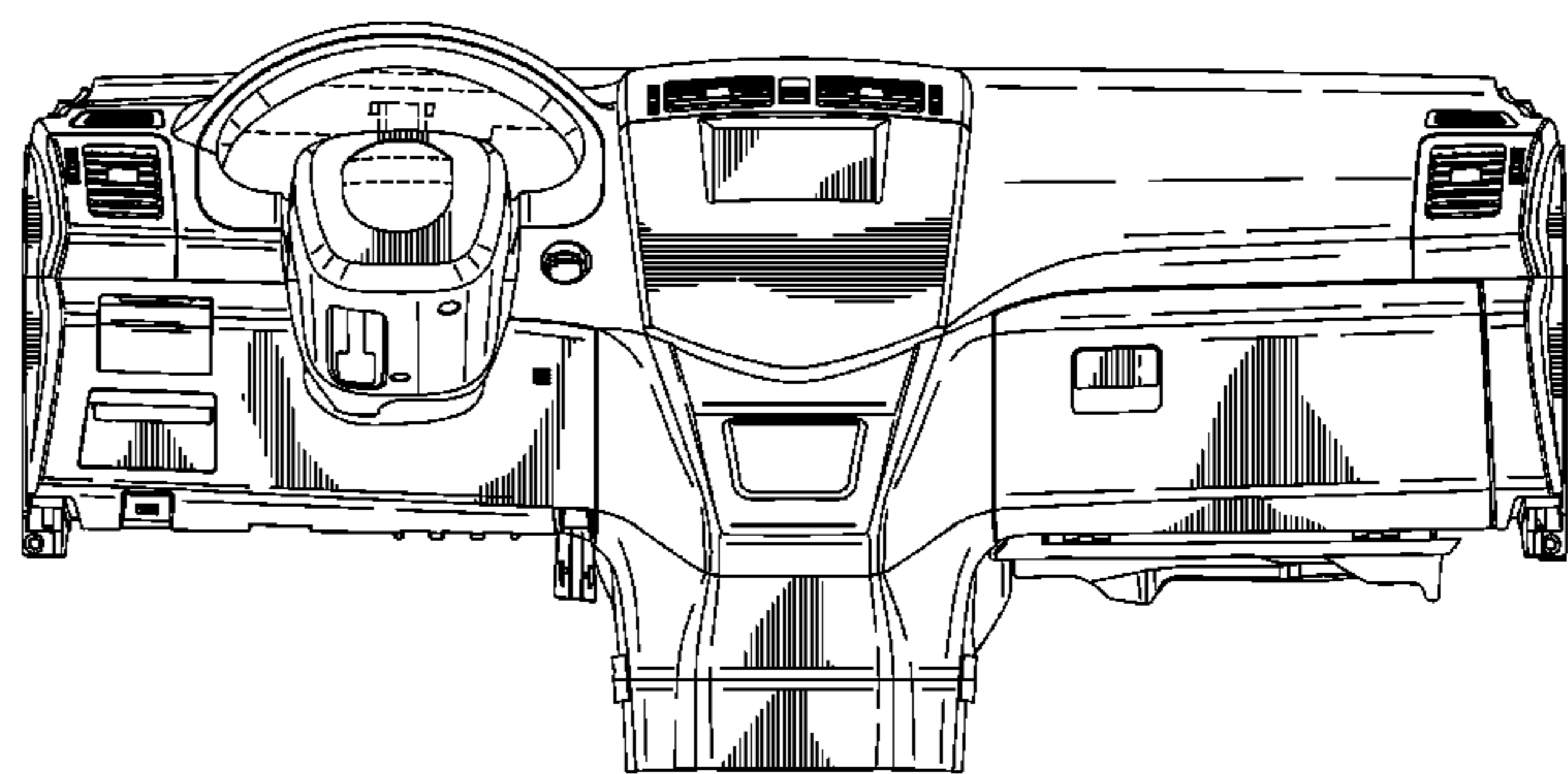
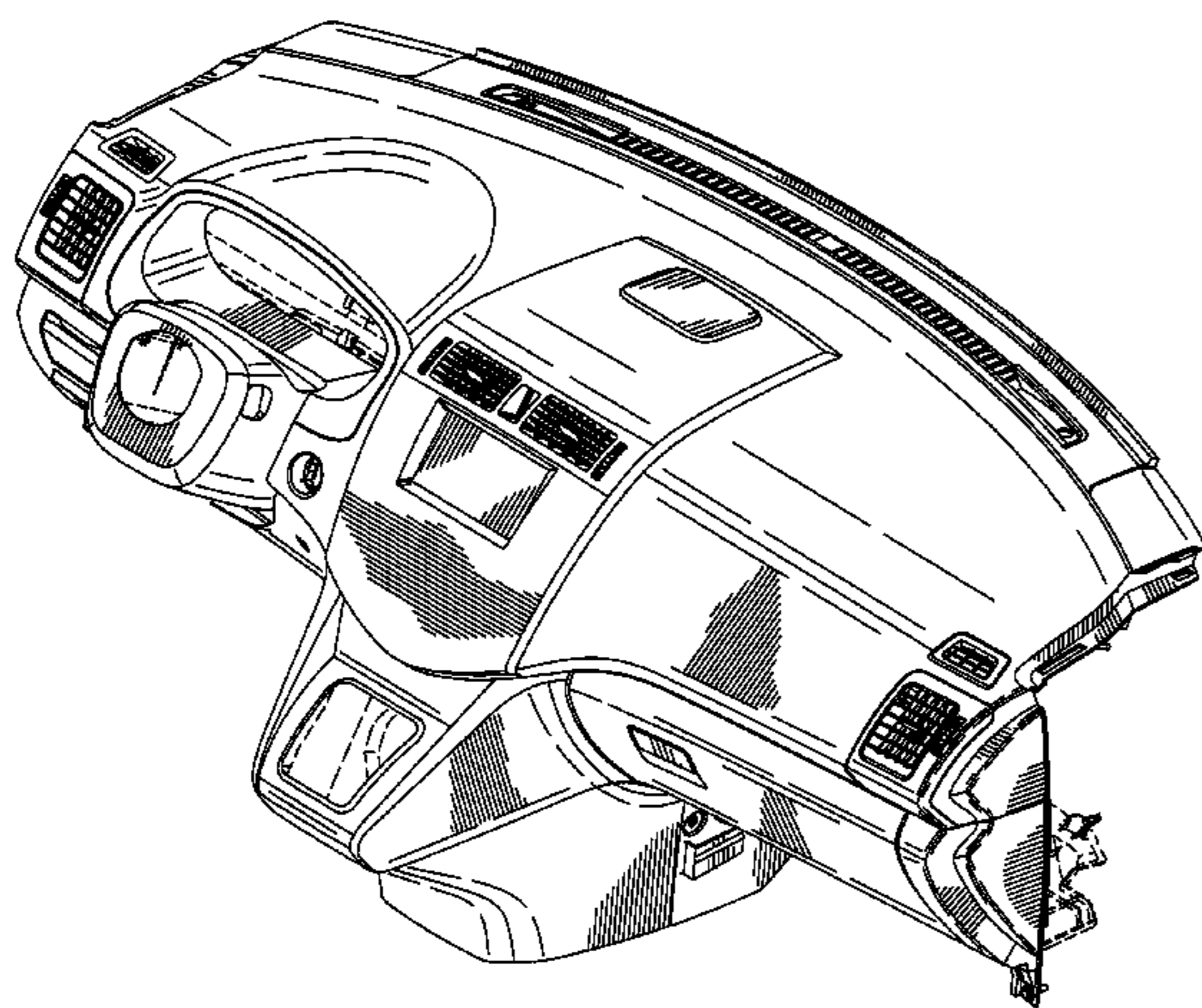
FIG. 3 is a top plan view of the car dashboard;

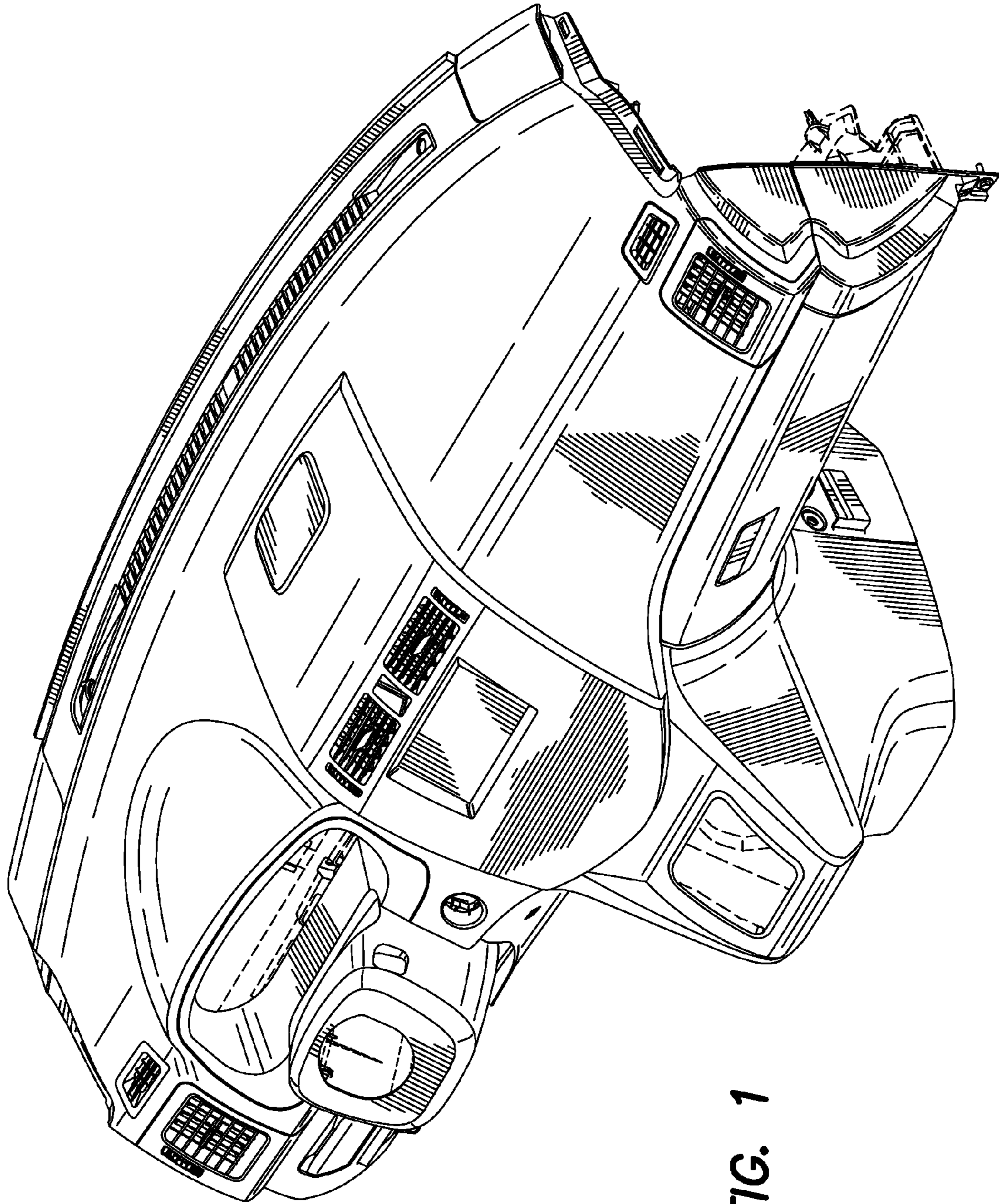

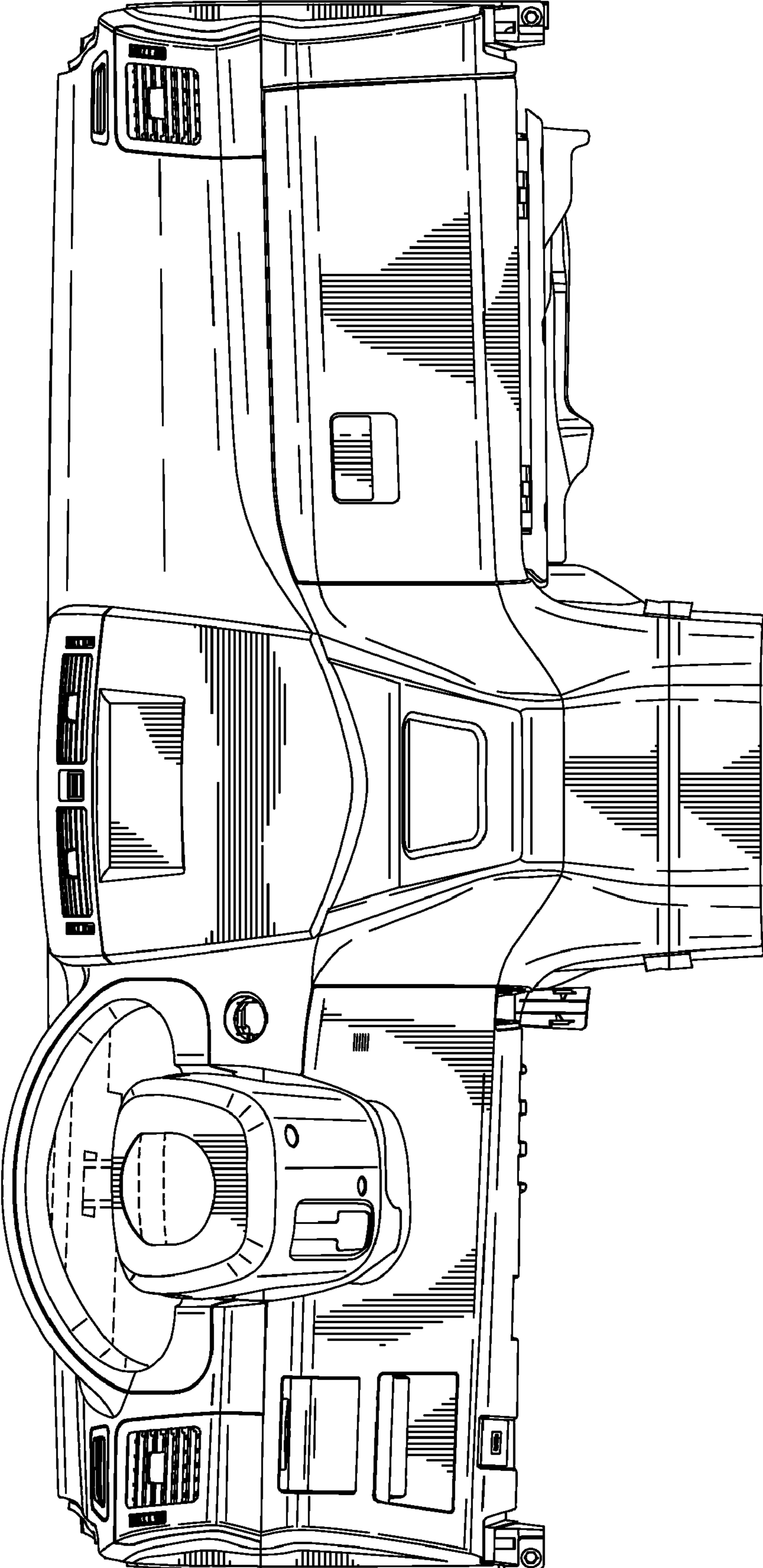

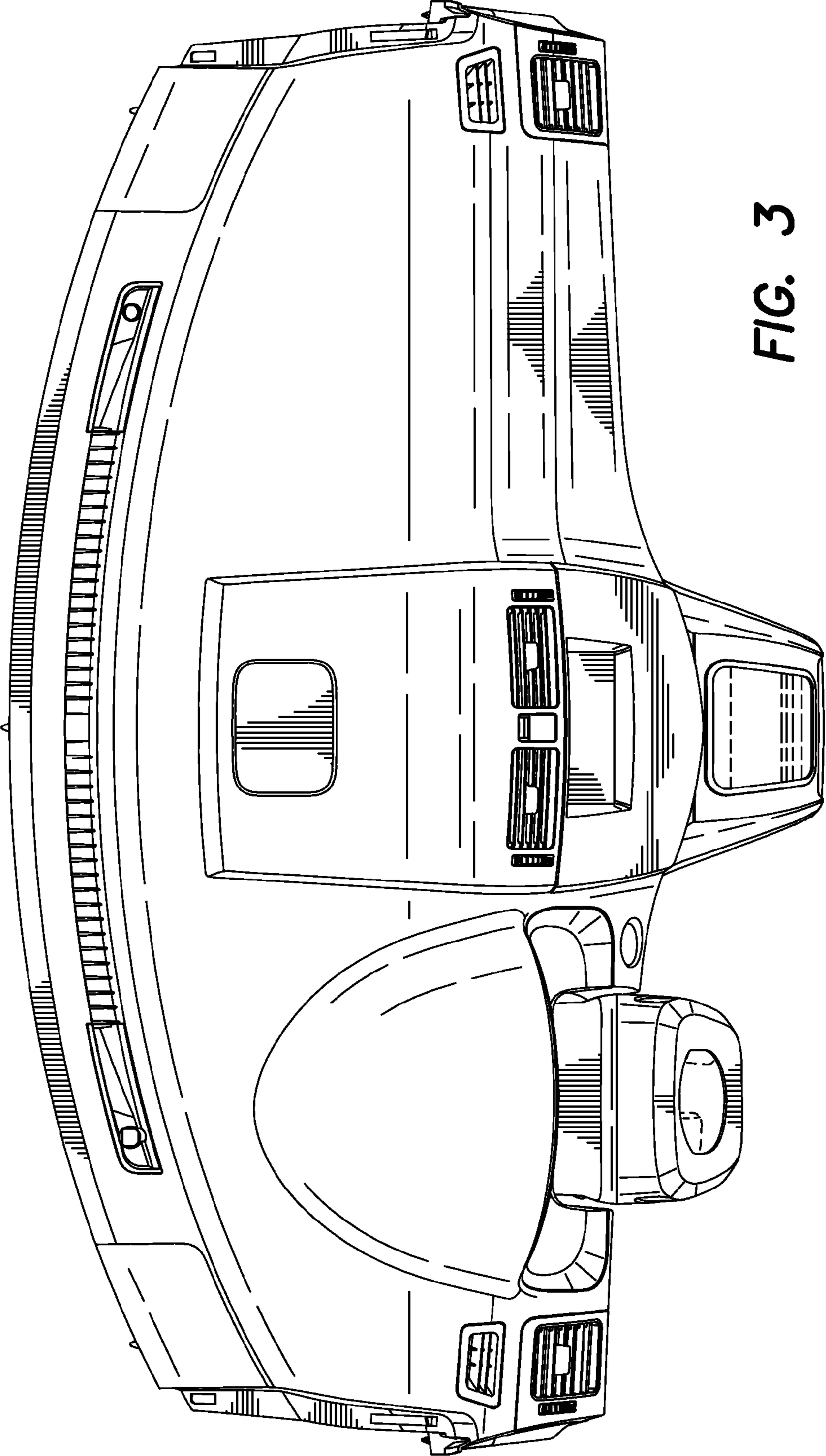

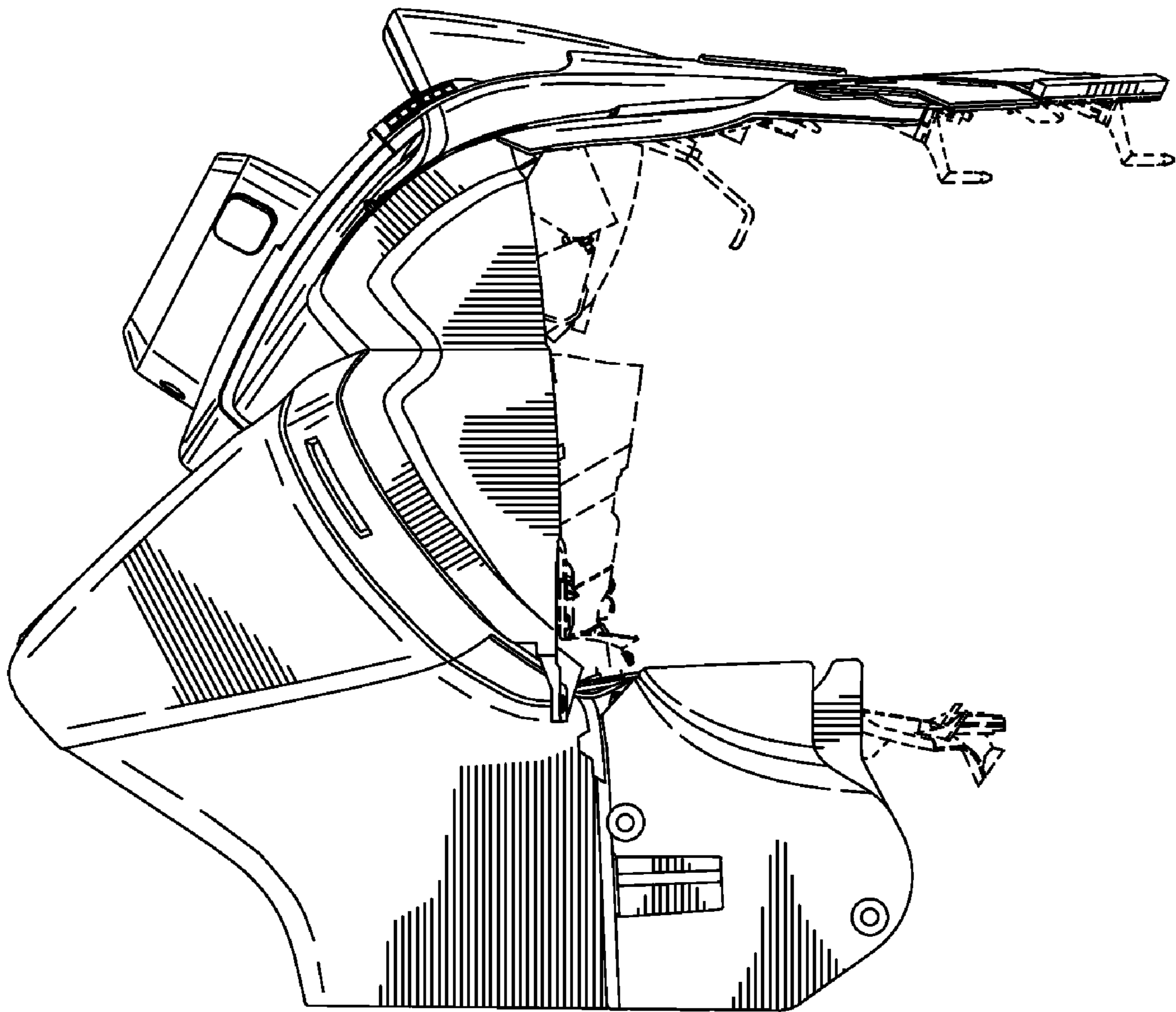

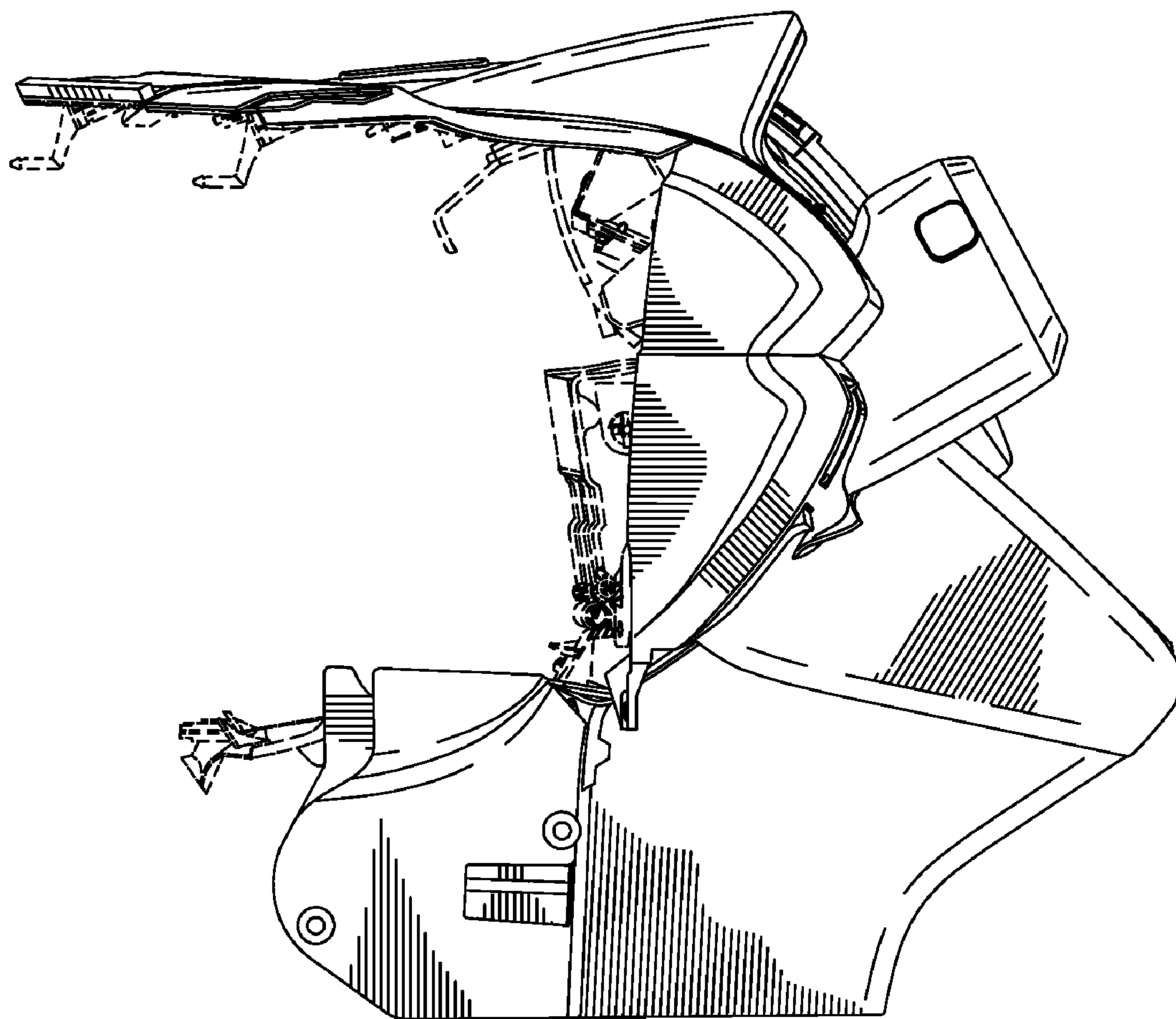
