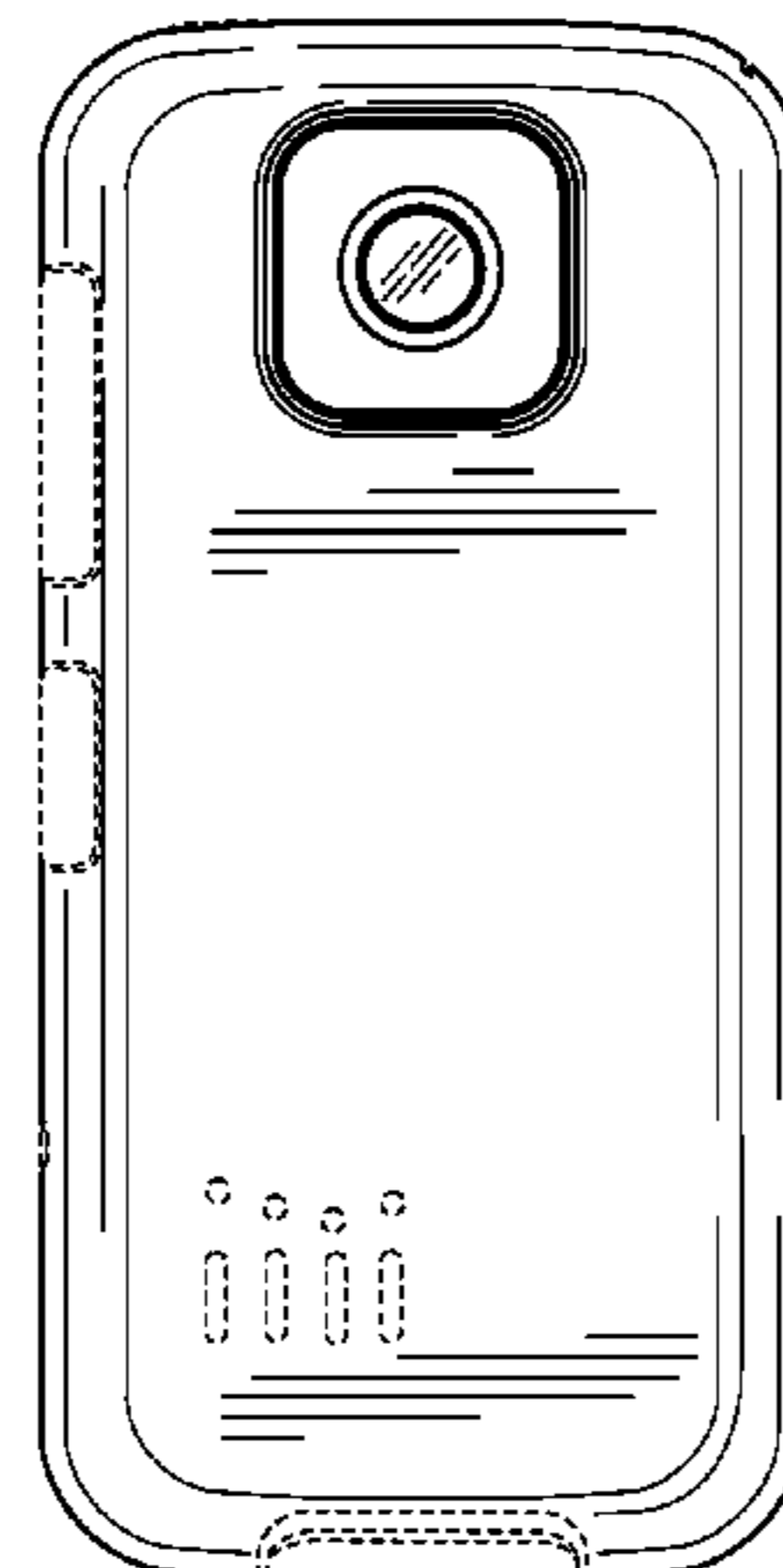
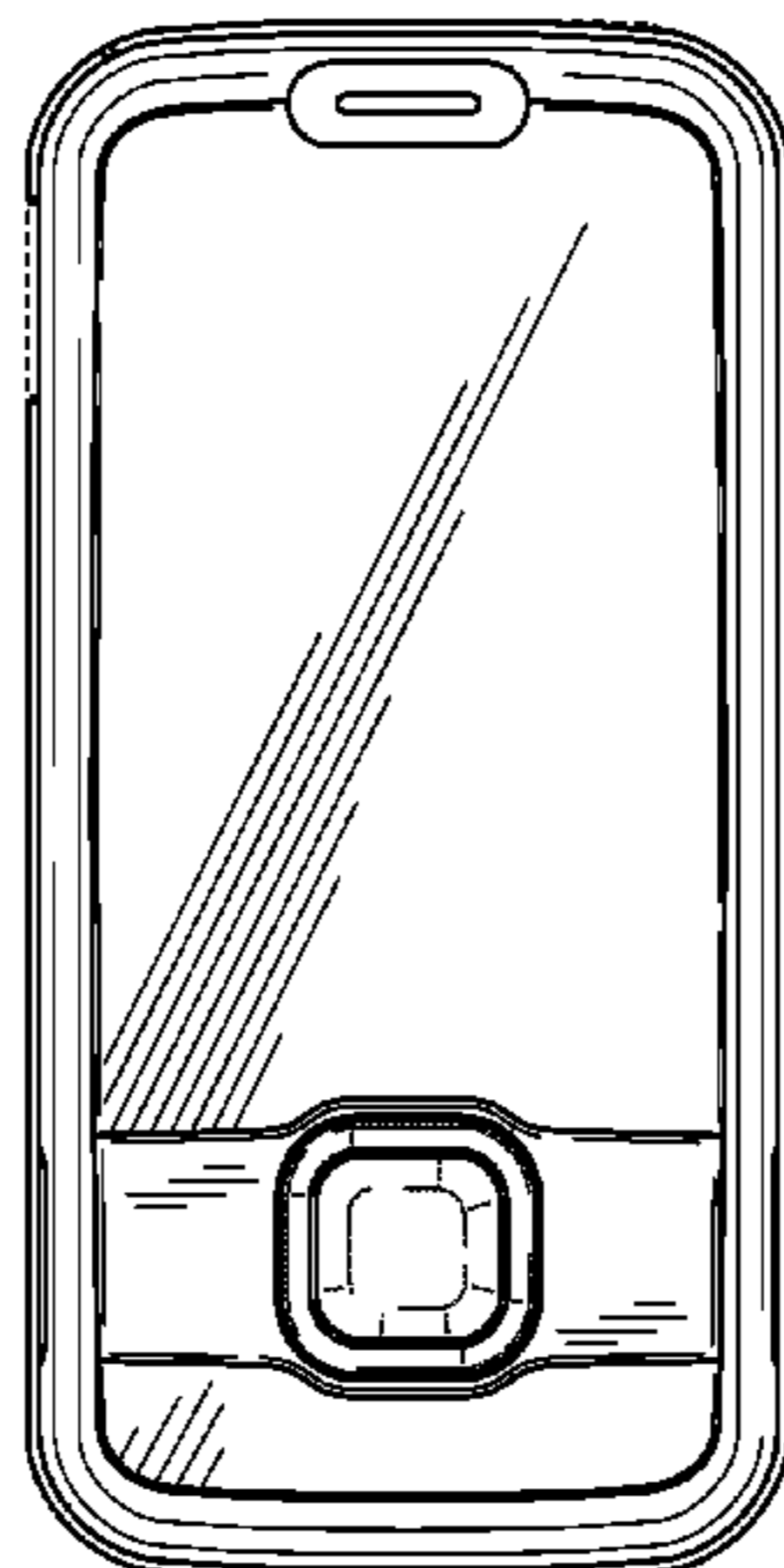
The ornamental design for a handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a handset showing our new design;

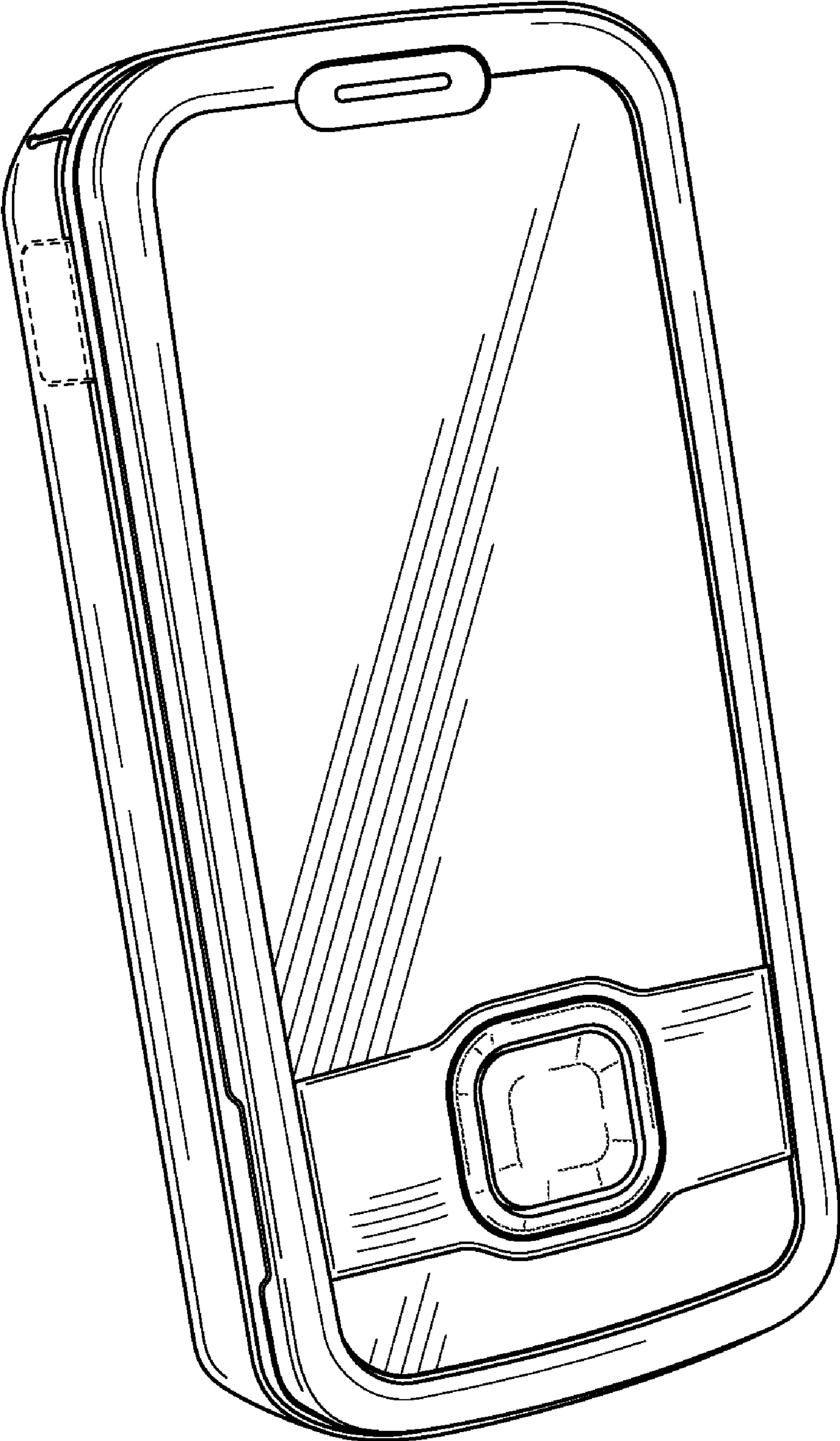

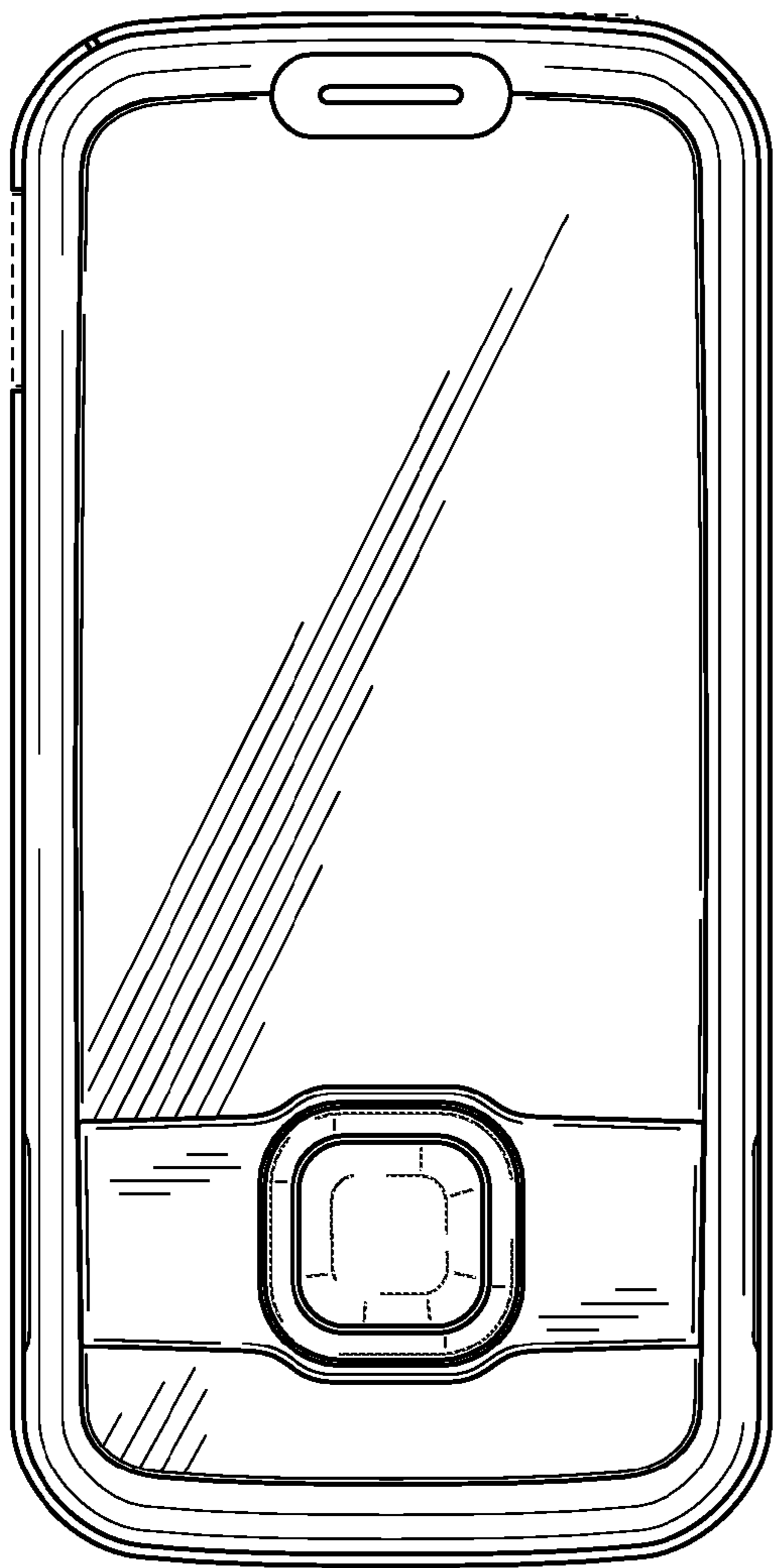

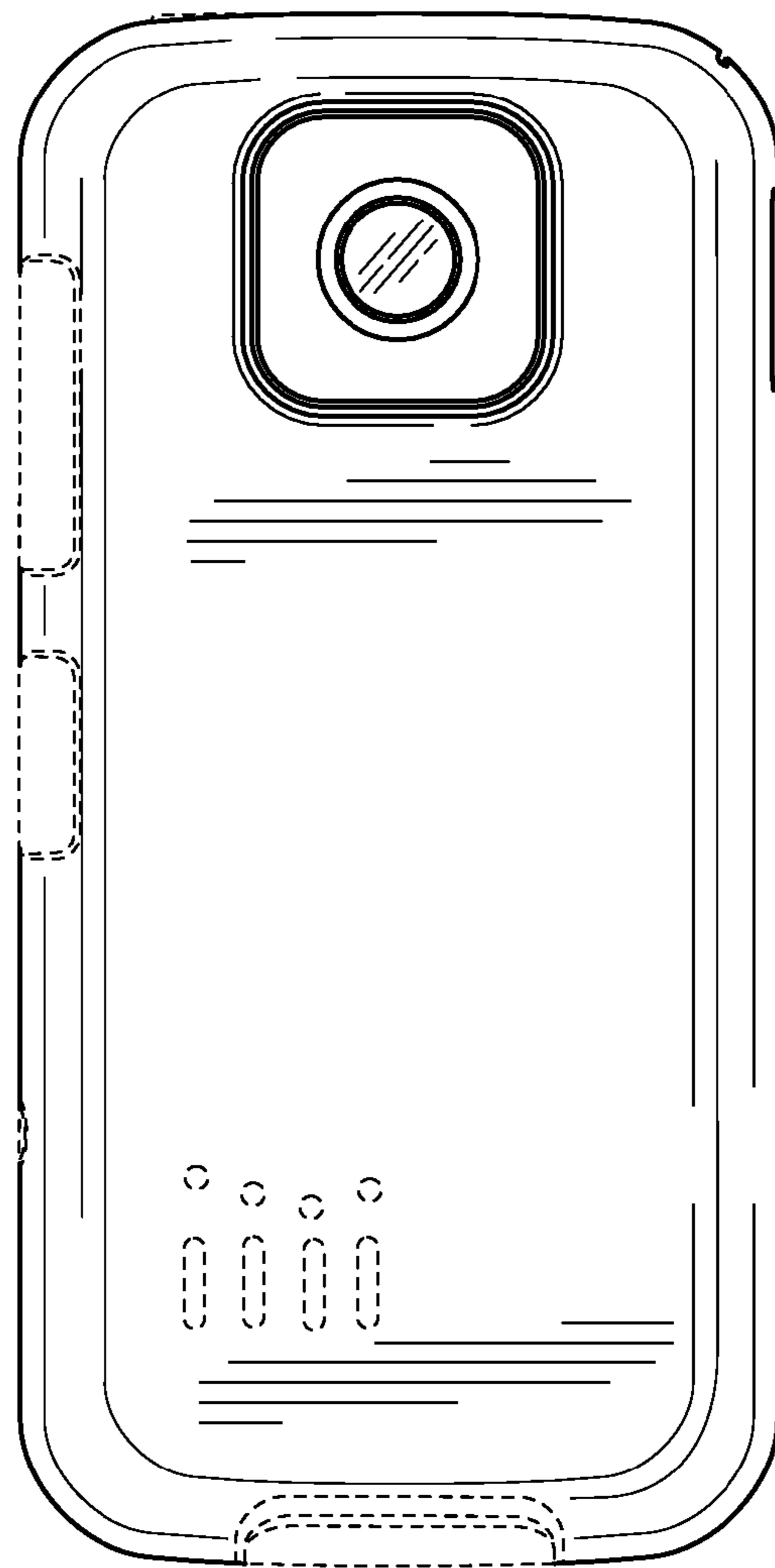

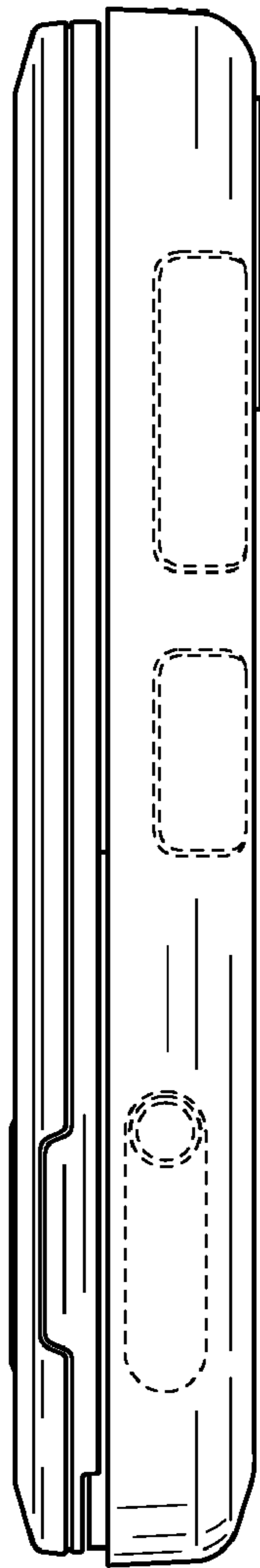

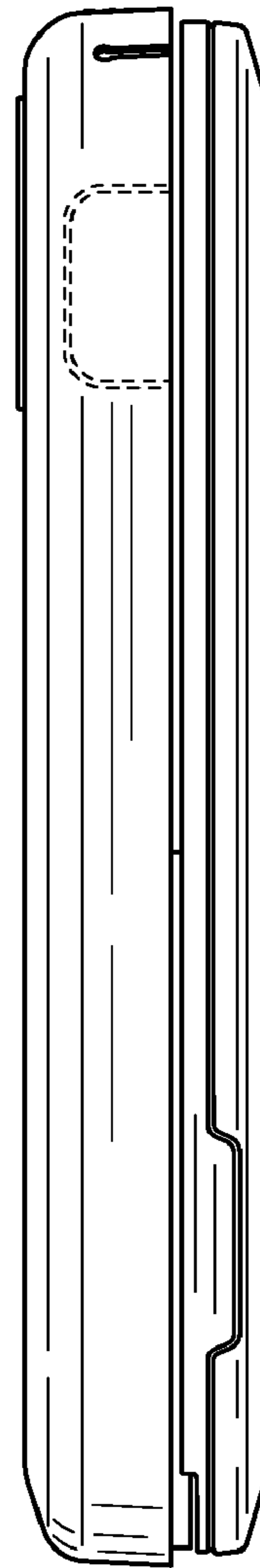

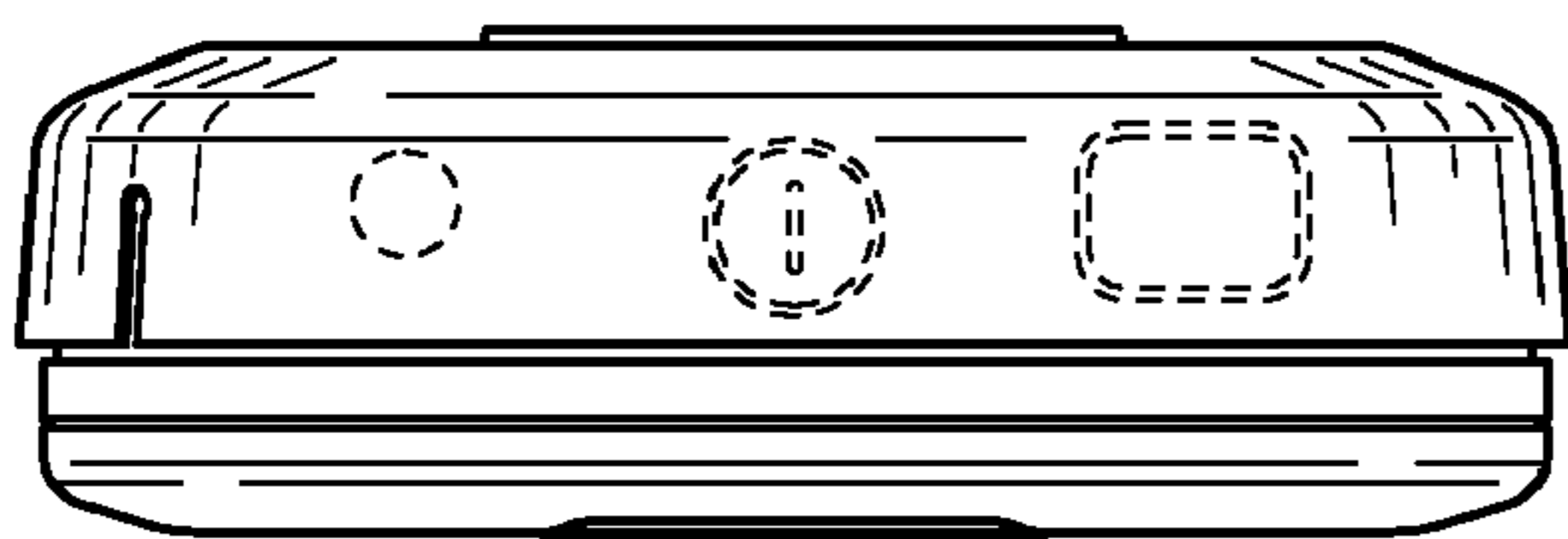

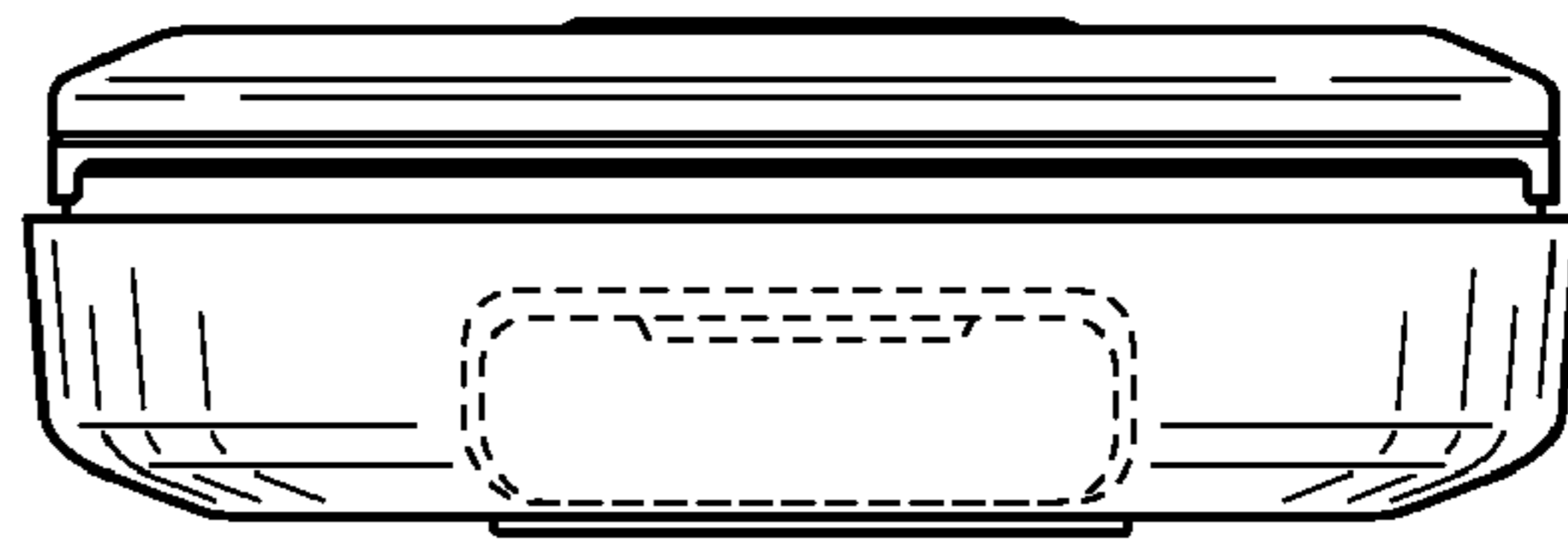

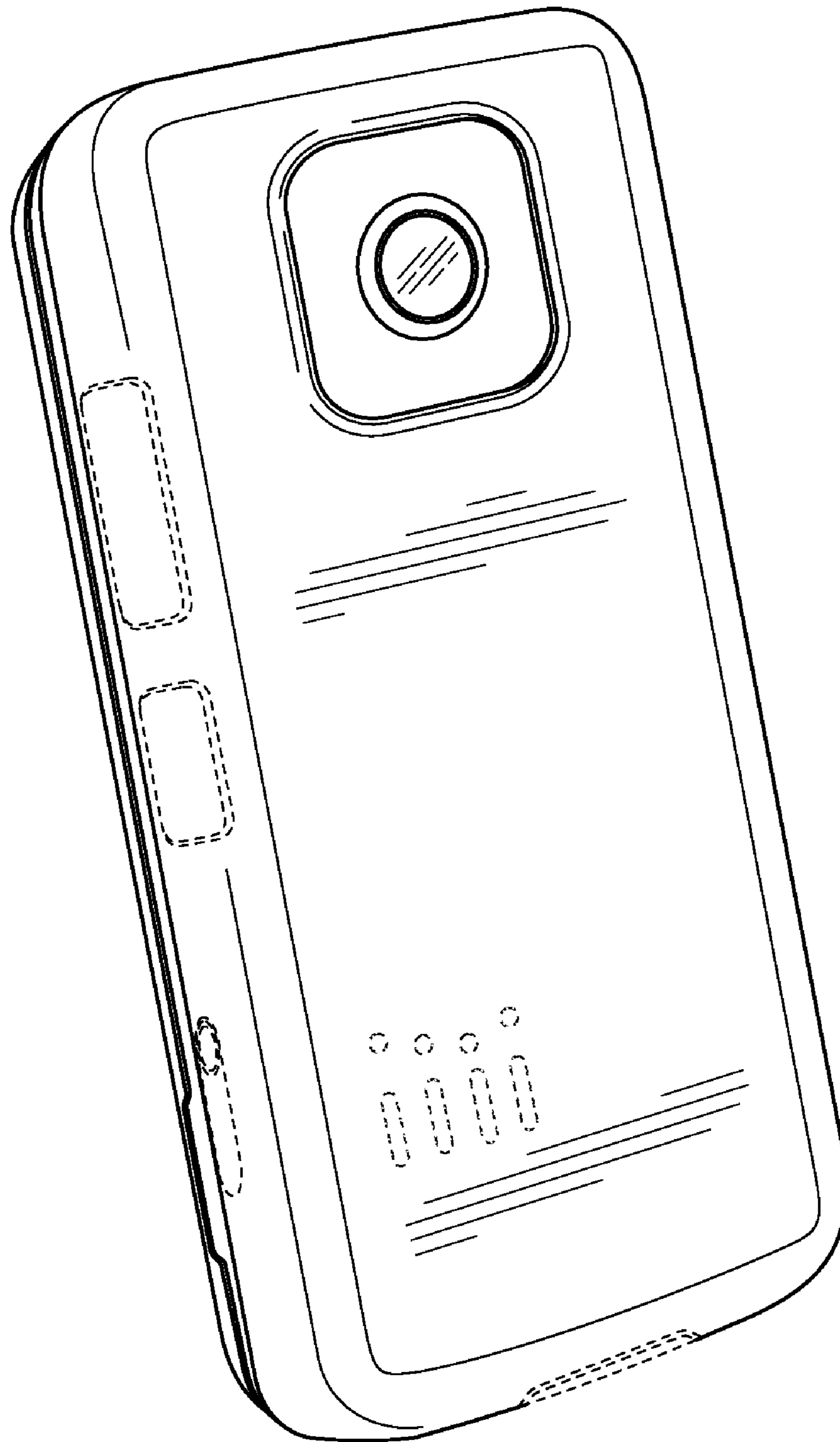
