(57) **CLAIM**

The ornamental design for a mobile digital device with retractable keyboard, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile digital device with retractable keyboard;

FIG. 2 is a front elevation view of the mobile digital device with retractable keyboard as shown in FIG. 1;

FIG. 3 is a rear elevation view of the mobile digital device with retractable keyboard as shown in FIG. 1;

FIG. 4 is a left side view of the mobile digital device with retractable keyboard as shown in FIG. 1;

FIG. 5 is a right side view of the mobile digital device with retractable keyboard arm as shown in FIG. 1;

FIG. 6 is a top plan view of the mobile digital device with retractable keyboard as shown in FIG. 1; and

FIG. 7 is a bottom plan view thereof of the mobile digital device with retractable keyboard as shown in FIG. 1.

FIG. 8 is a perspective view of a second embodiment according to a modified form of the invention;

FIG. 9 is a front elevation view of the mobile digital device with retractable keyboard as shown in FIG. 8 above;

FIG. 10 is a rear elevation view of the mobile digital device with retractable keyboard as shown in FIG. 8 above;

FIG. 11 is a left side view of the mobile digital device with retractable keyboard as shown in FIG. 8 above;

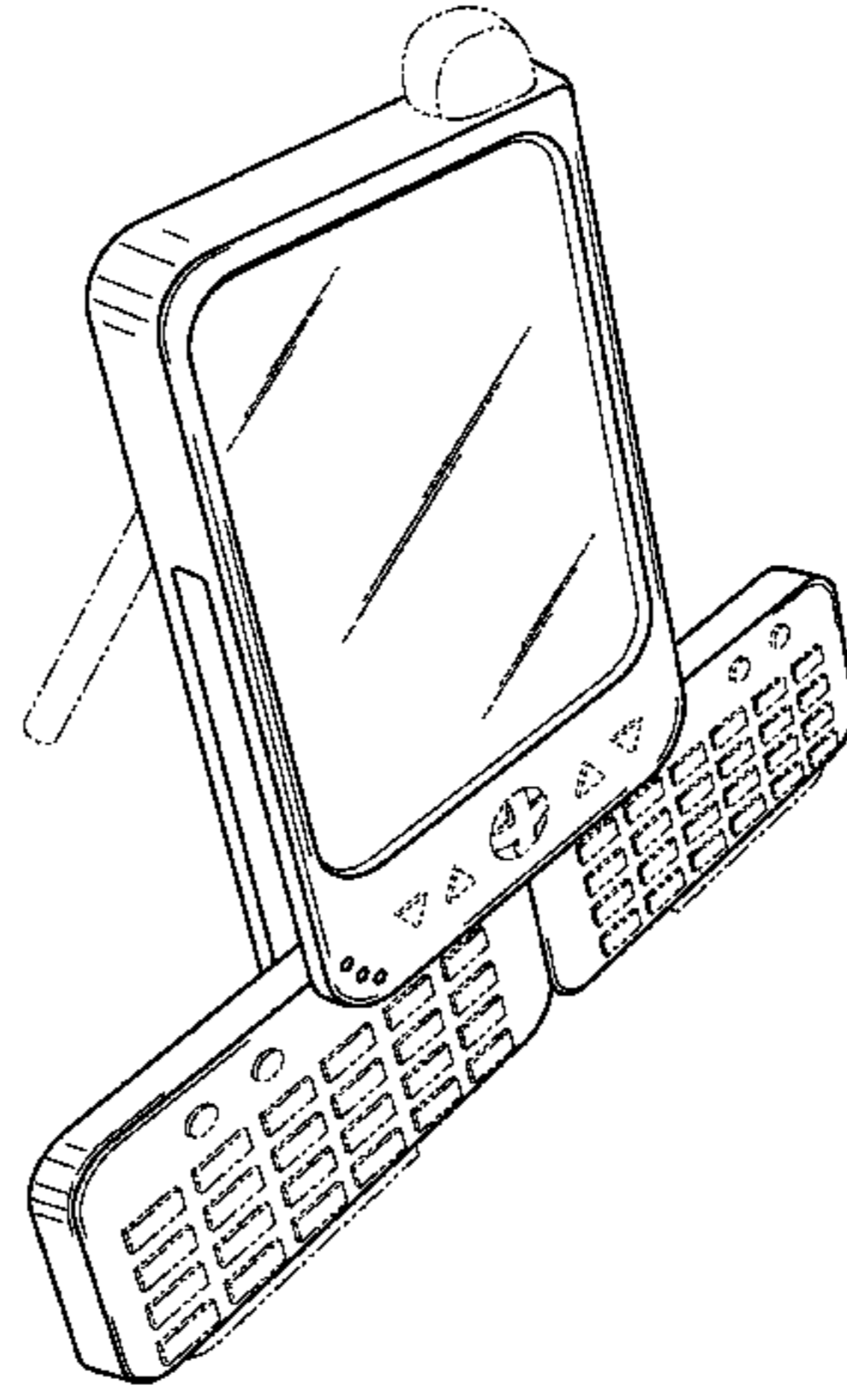
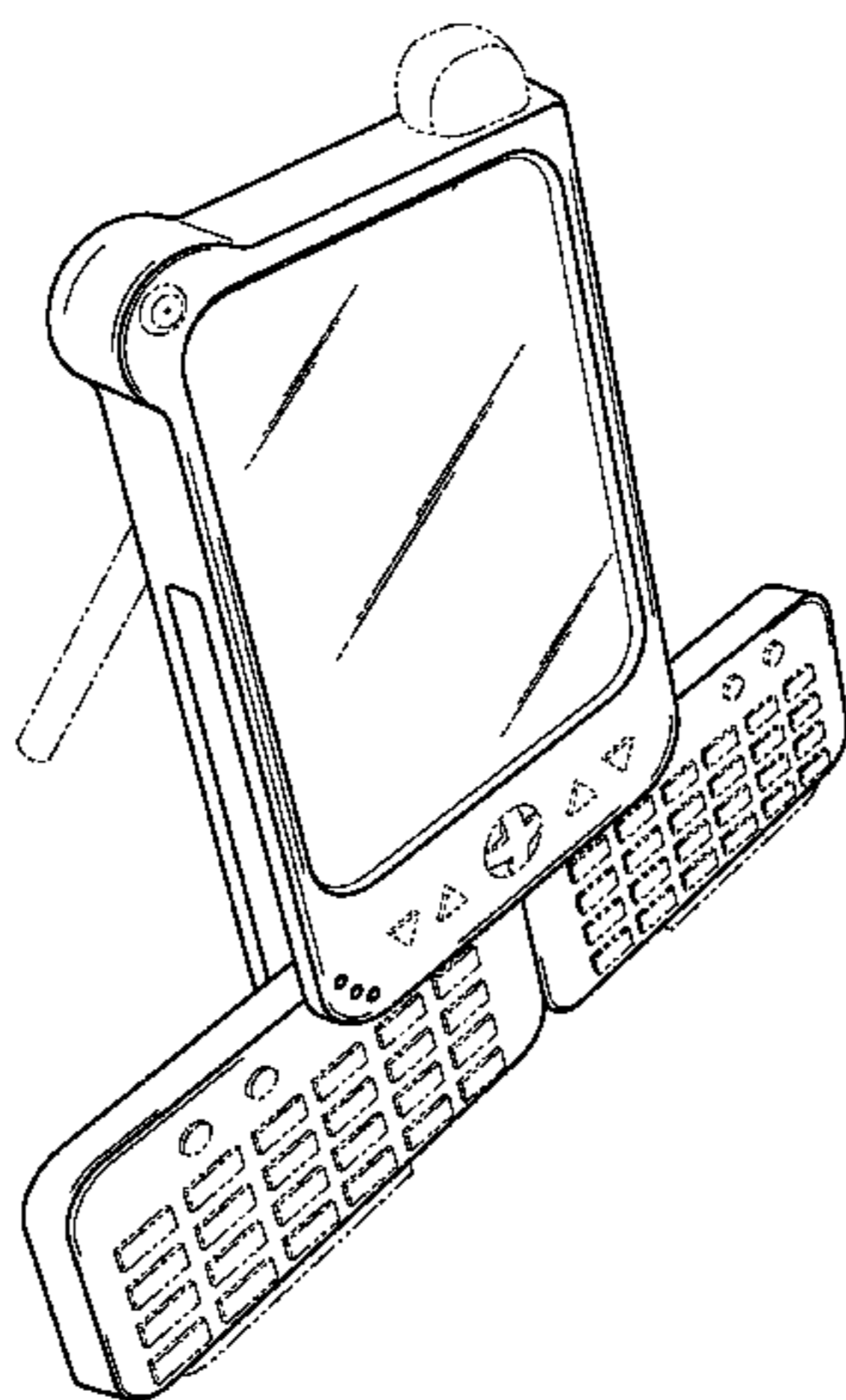
FIG. 12 is a right side view of the mobile digital device with retractable keyboard as shown in FIG. 8 above;

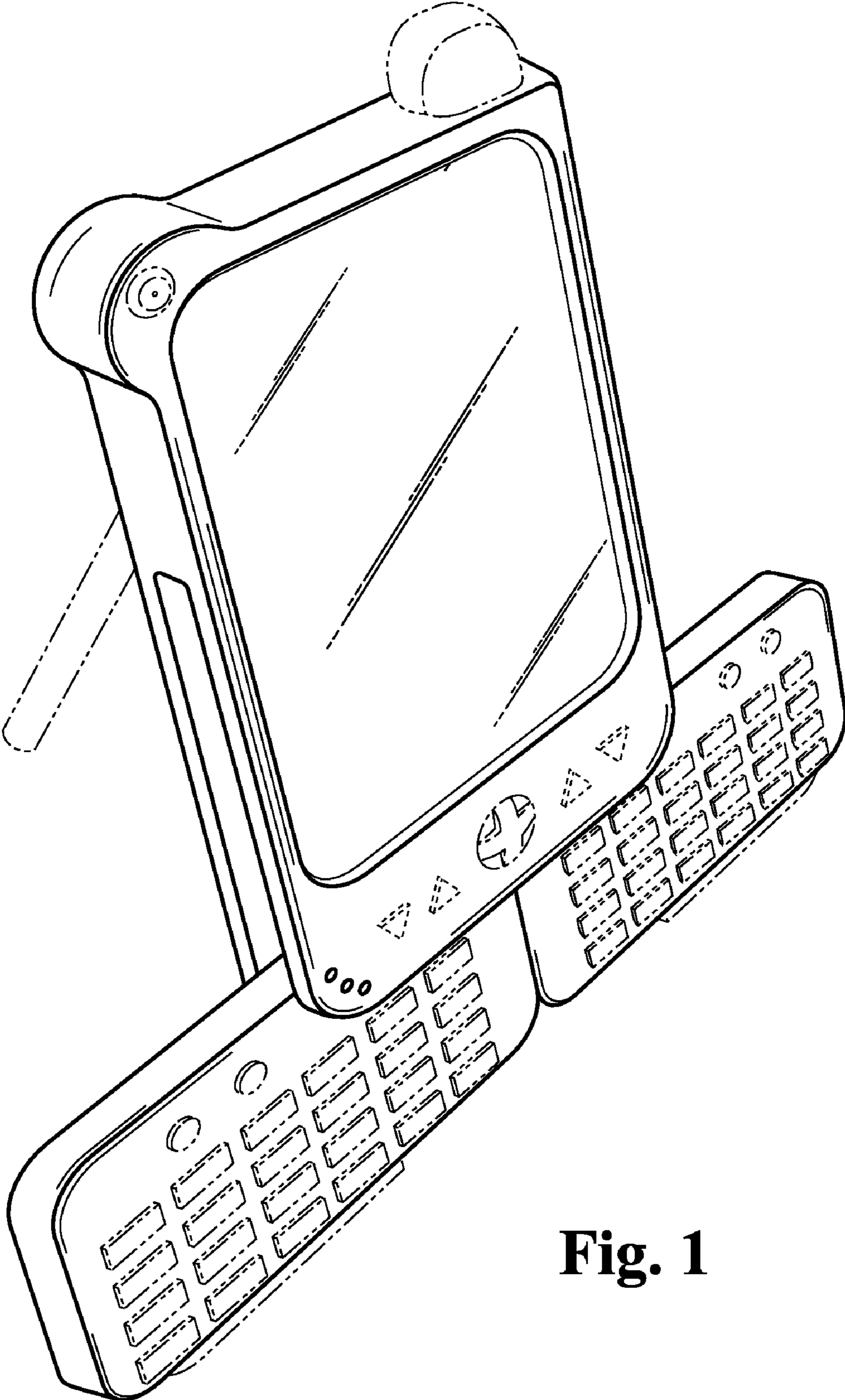

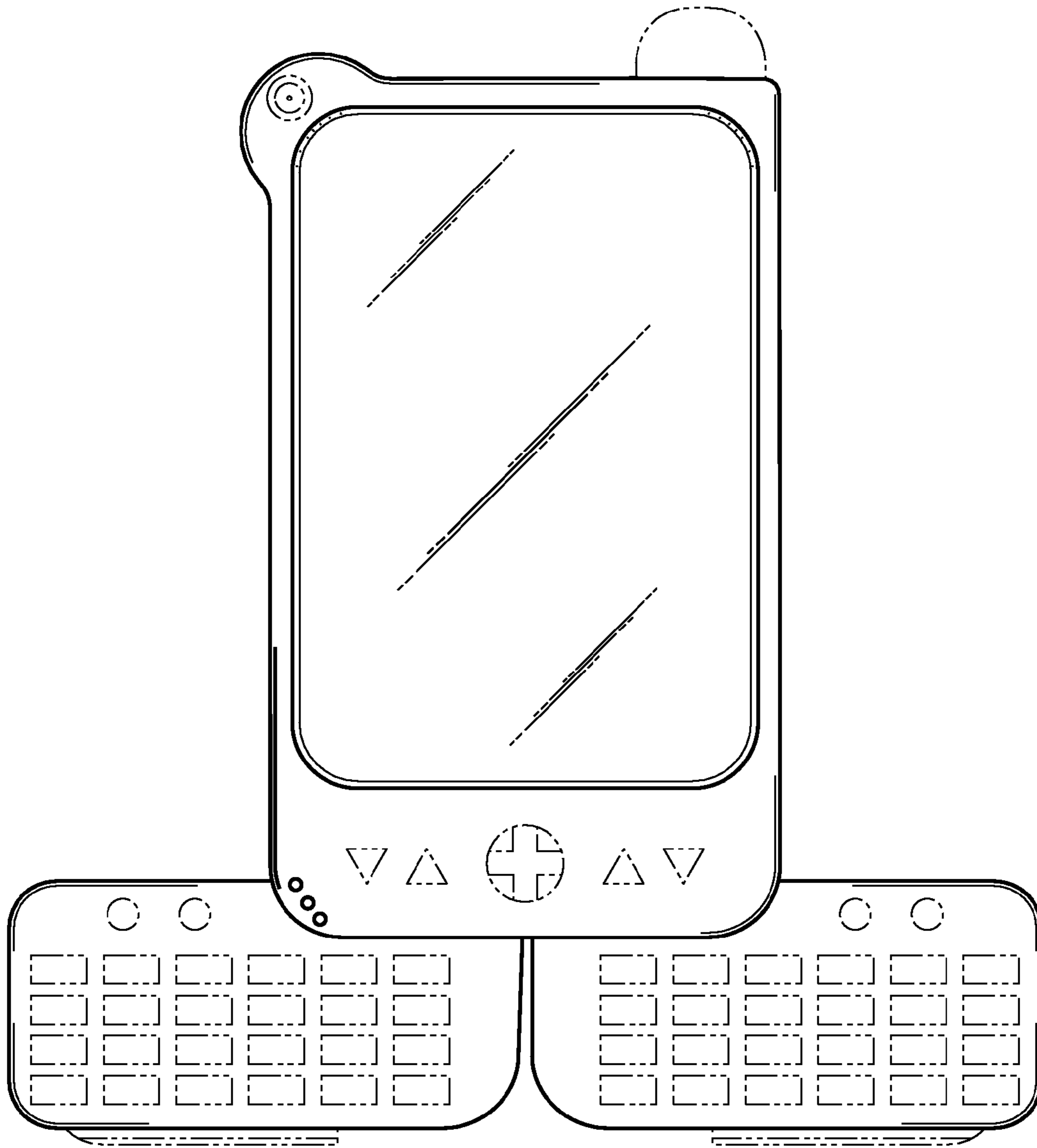

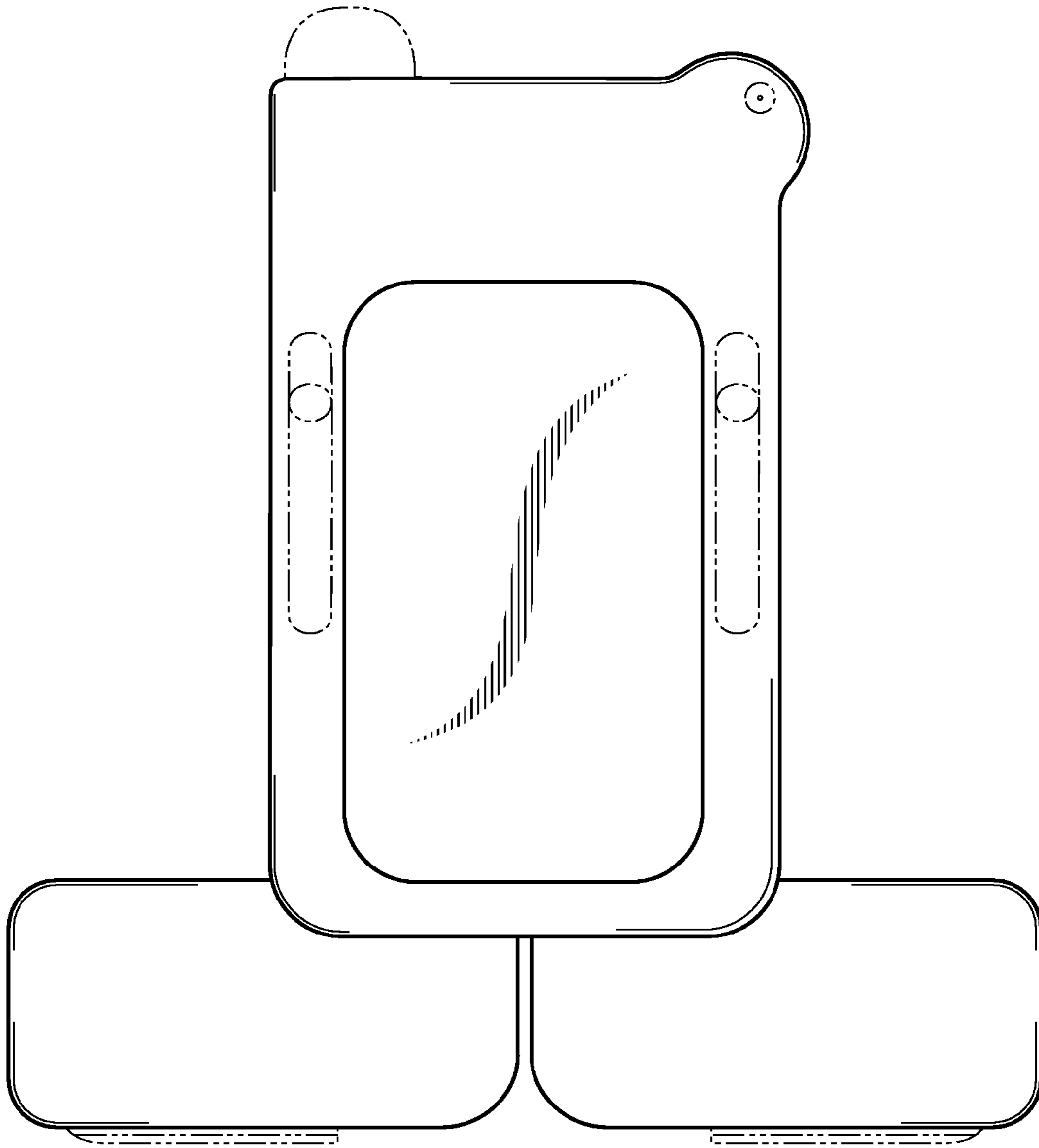

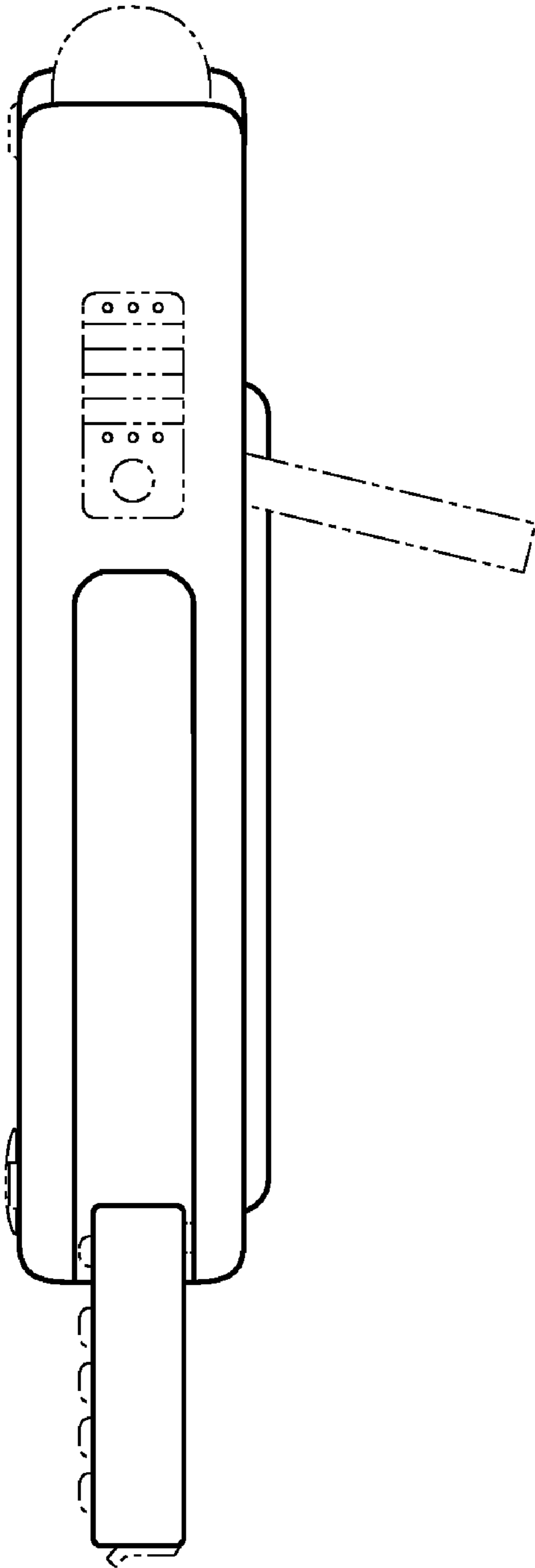

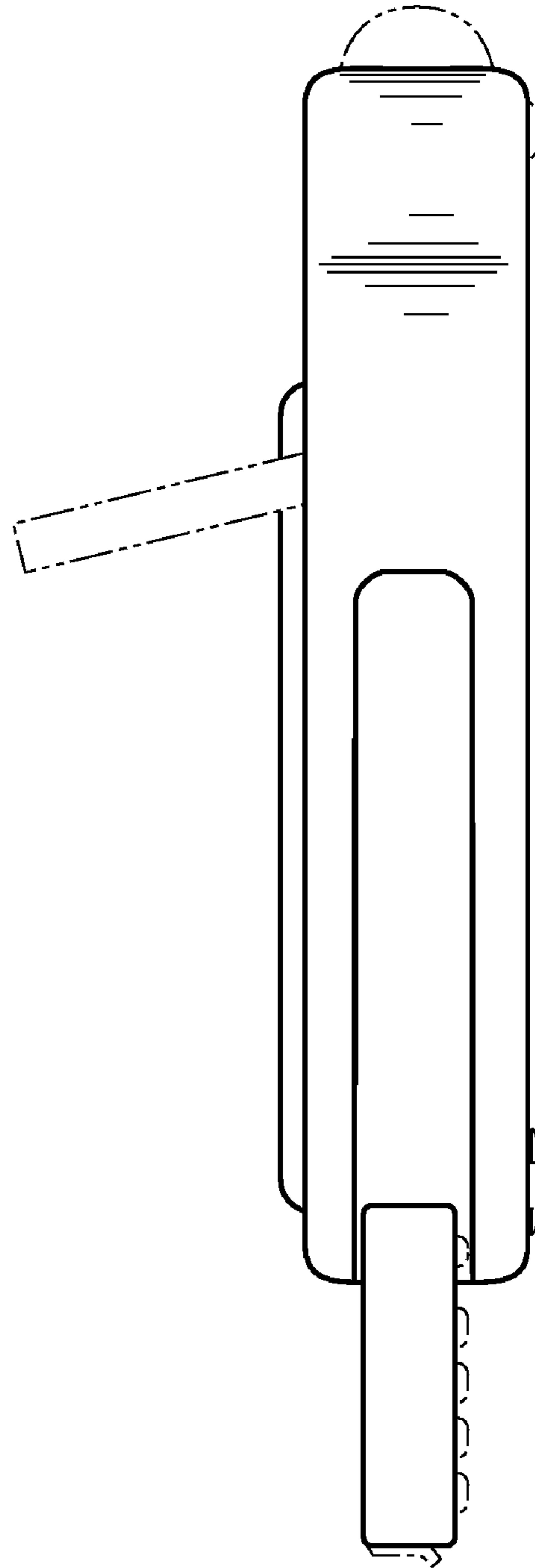

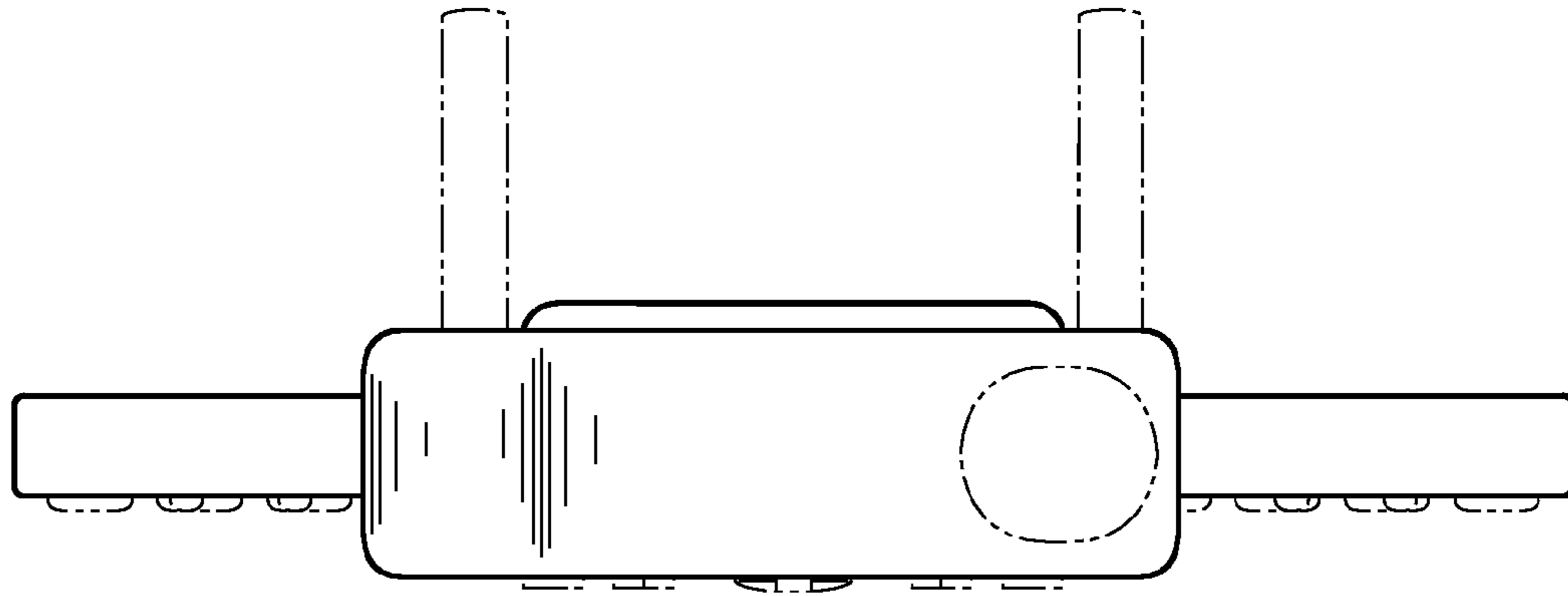

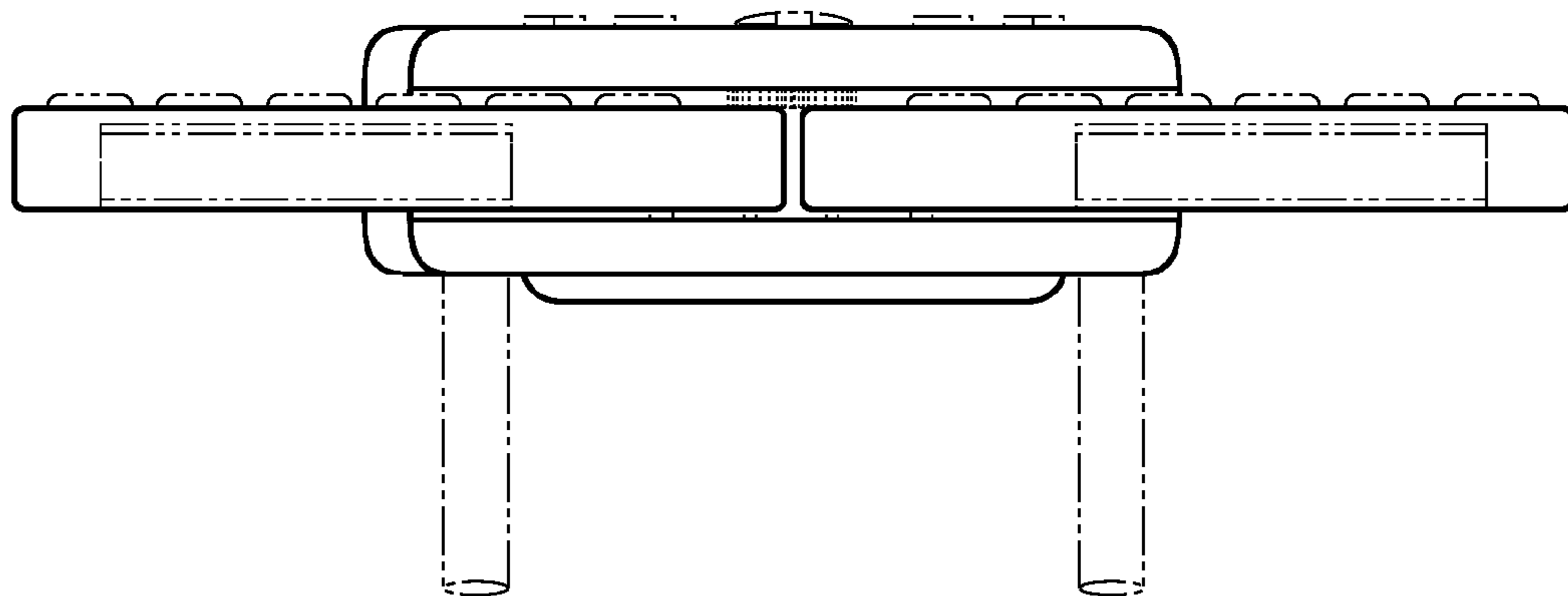

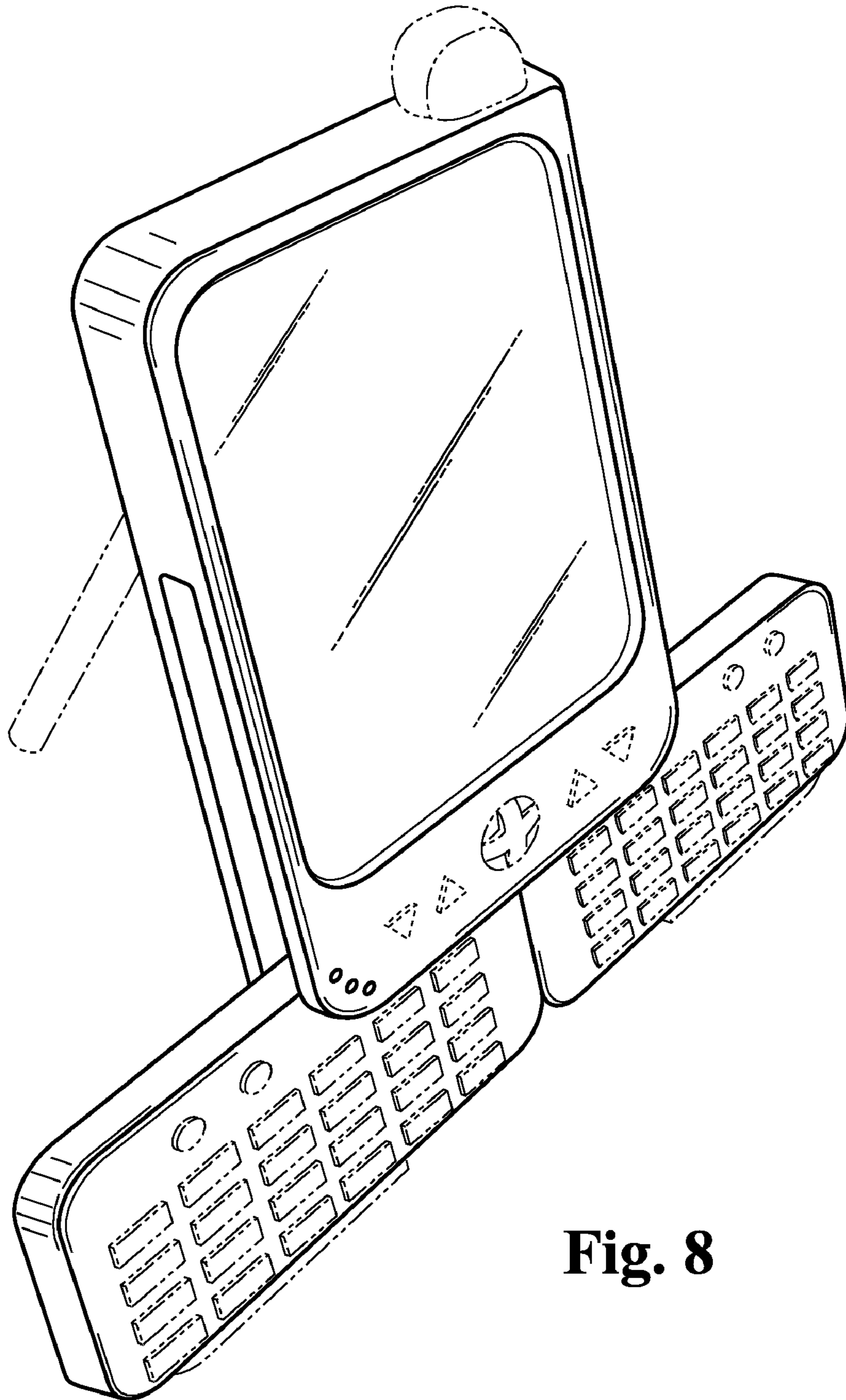

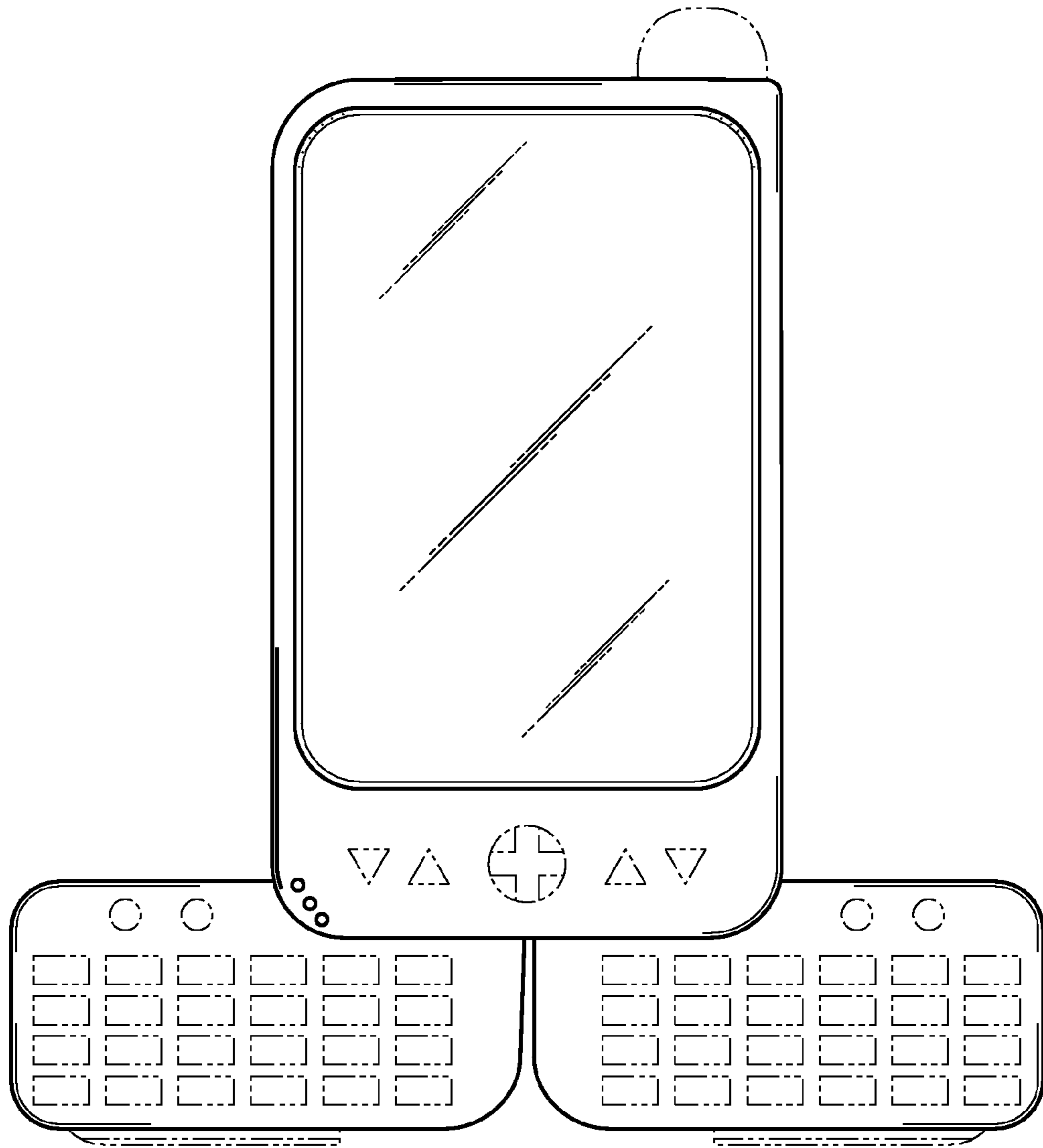

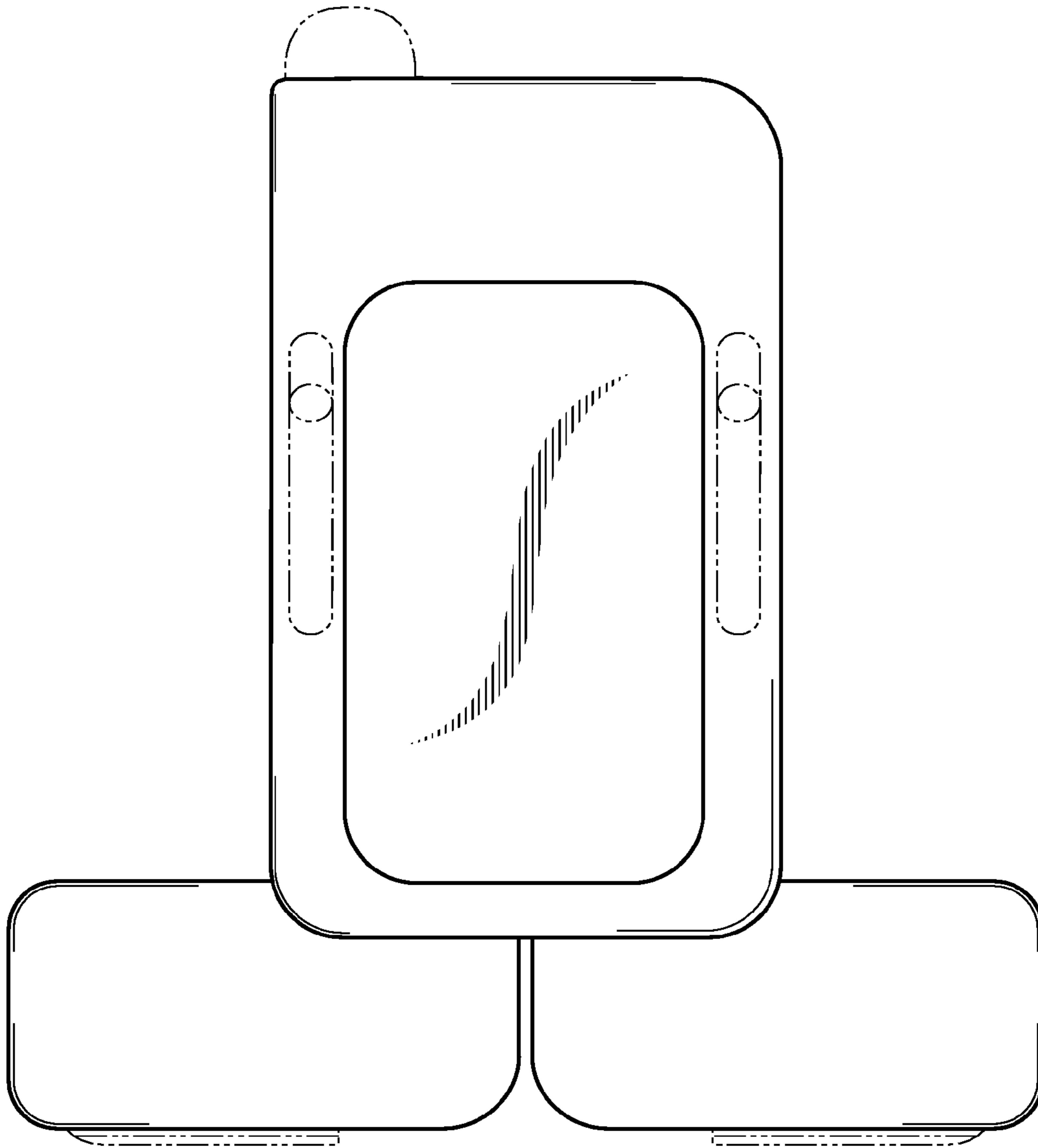

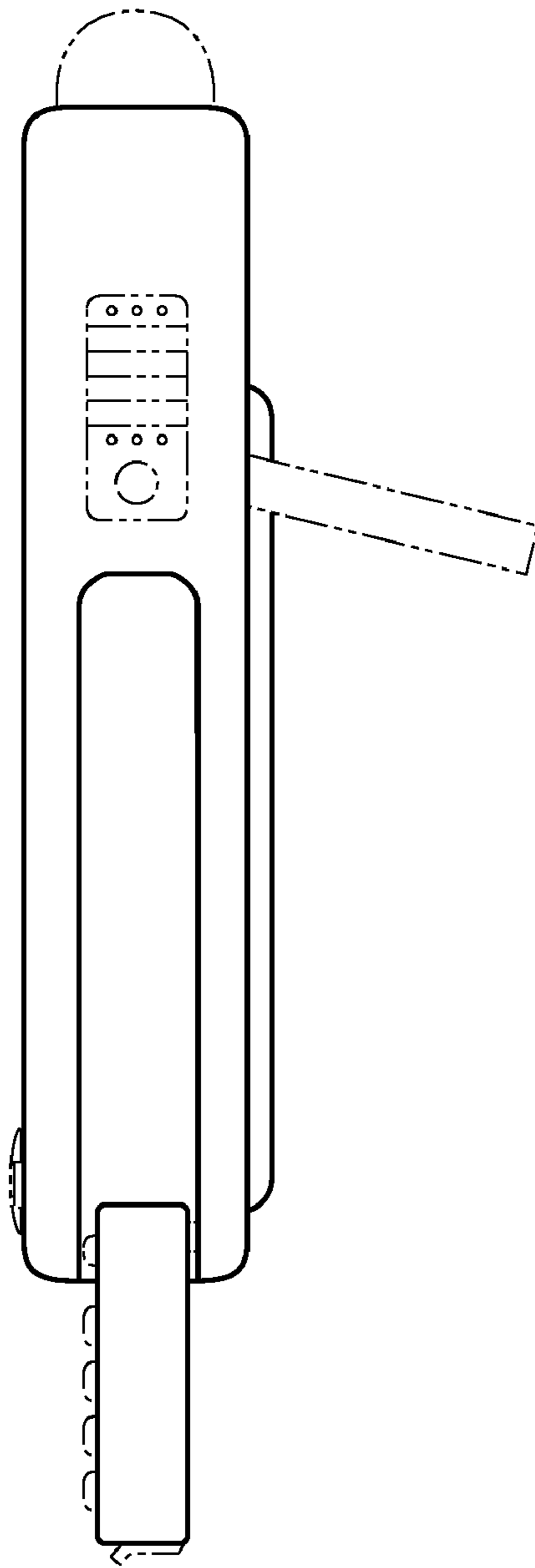

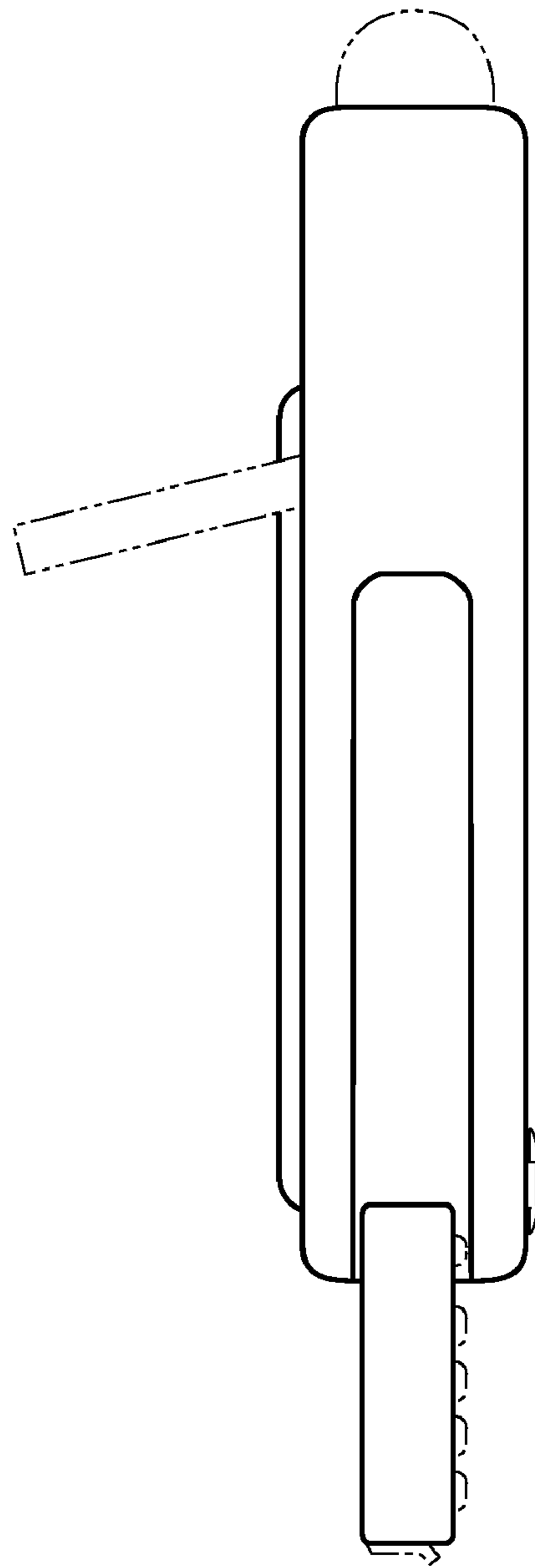

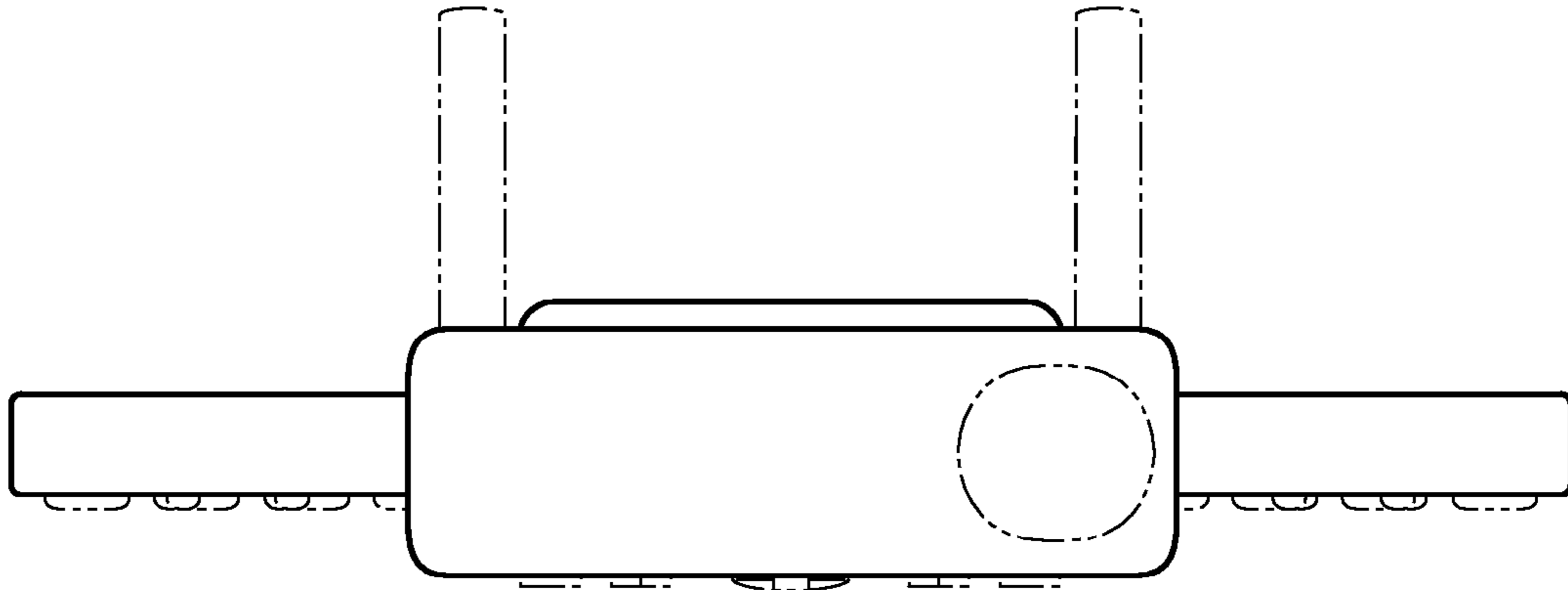

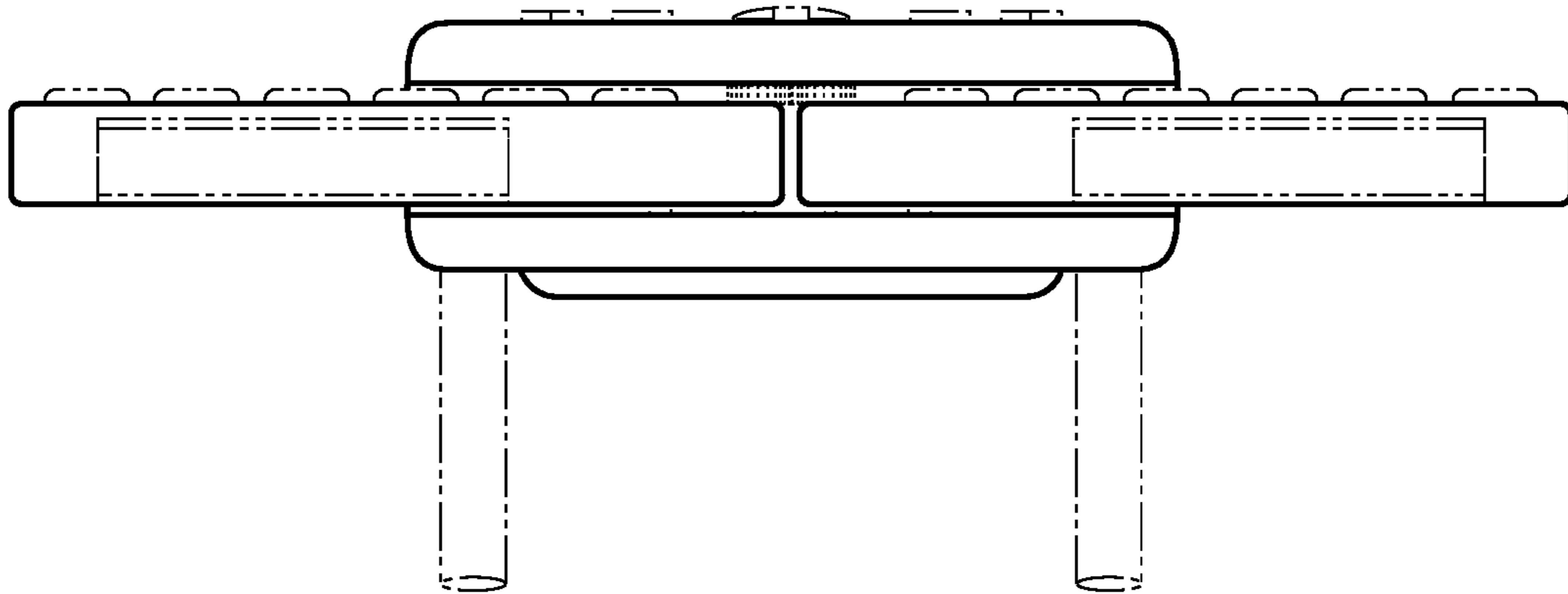
