The ornamental design for a grill portion of an off-highway truck, as shown and described.

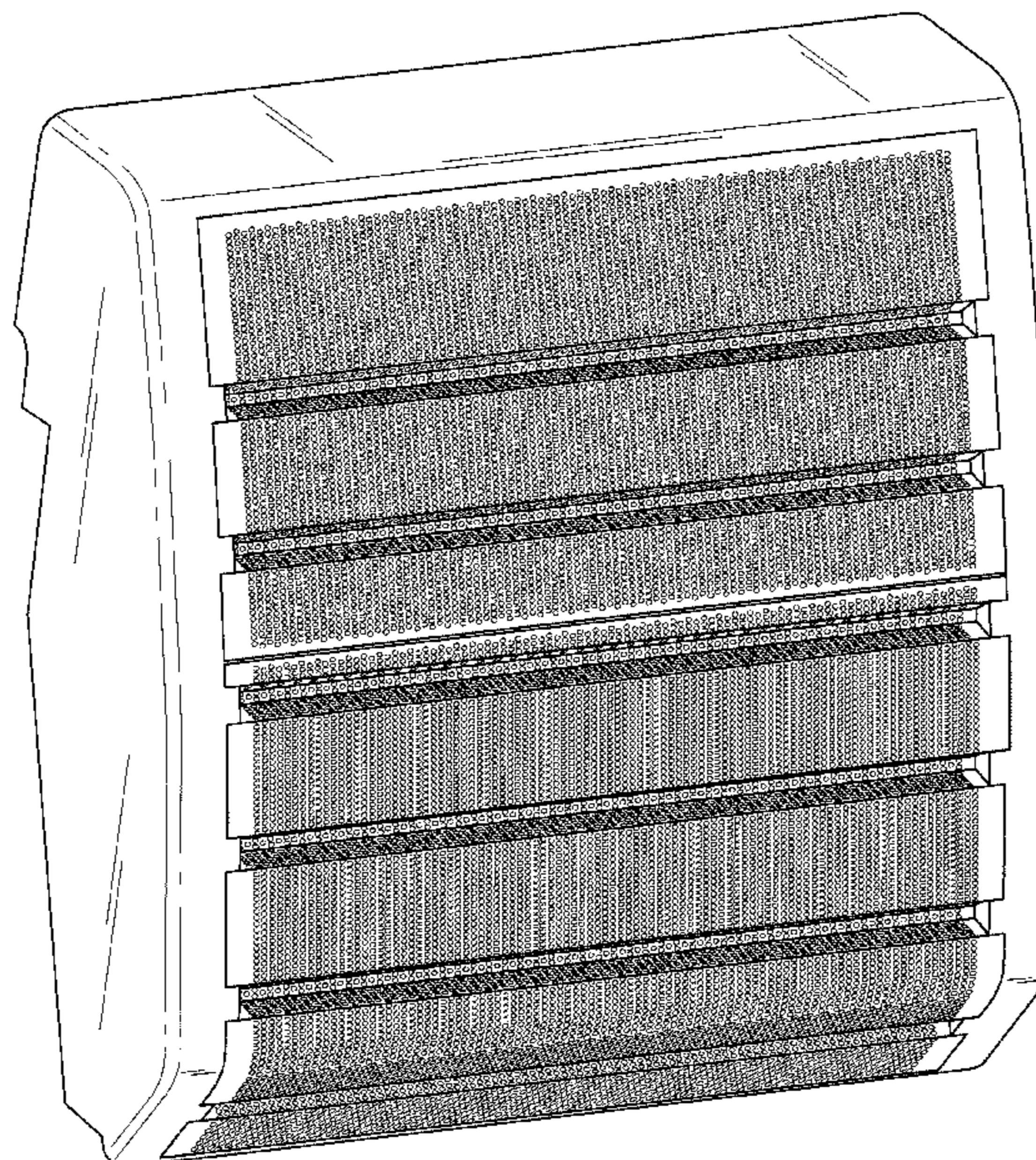
**DESCRIPTION**

FIG. 2 is a top right front perspective view thereof.

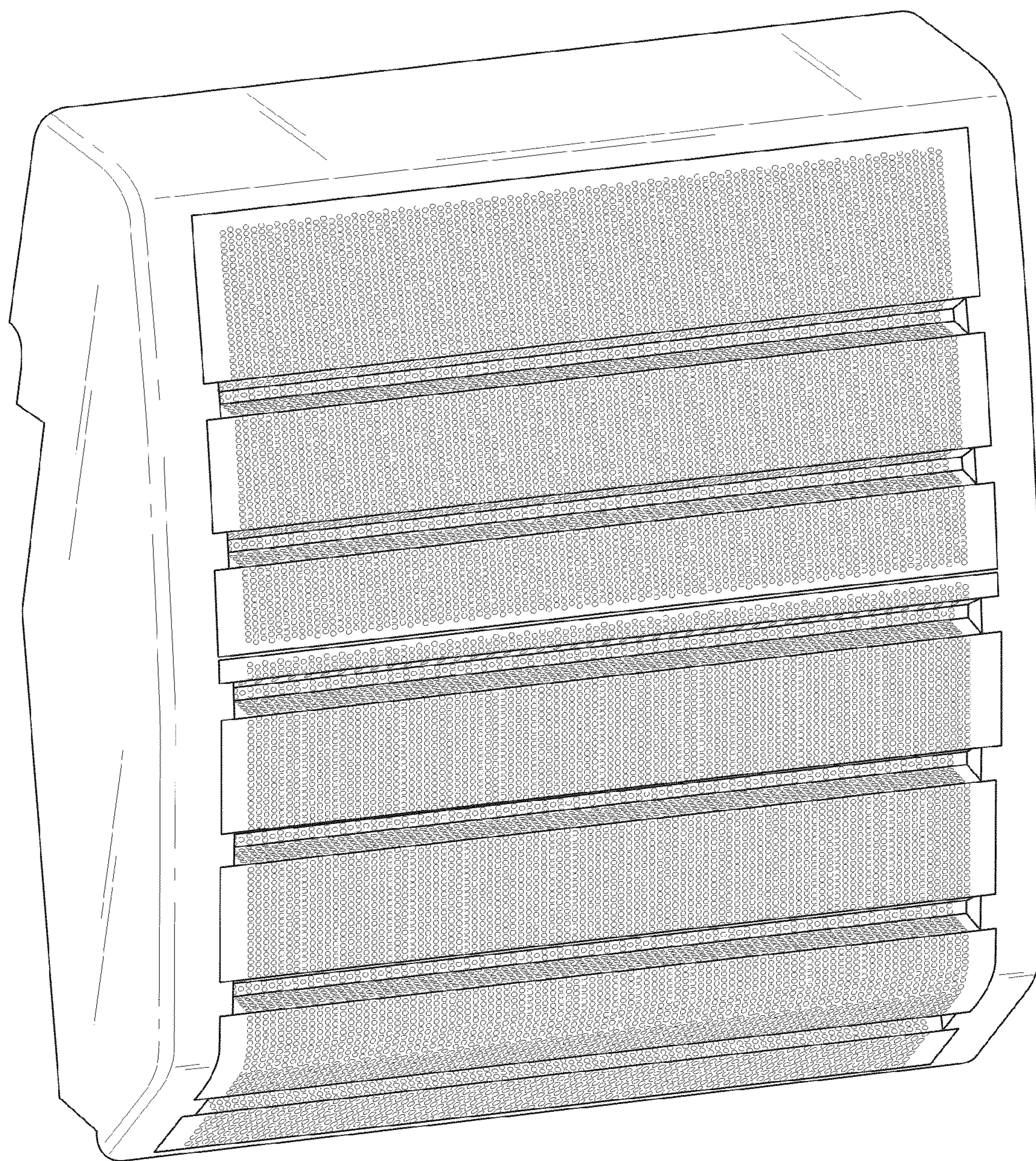
The bottom and rear views form no part of the claimed design.
