DESCRIPTION

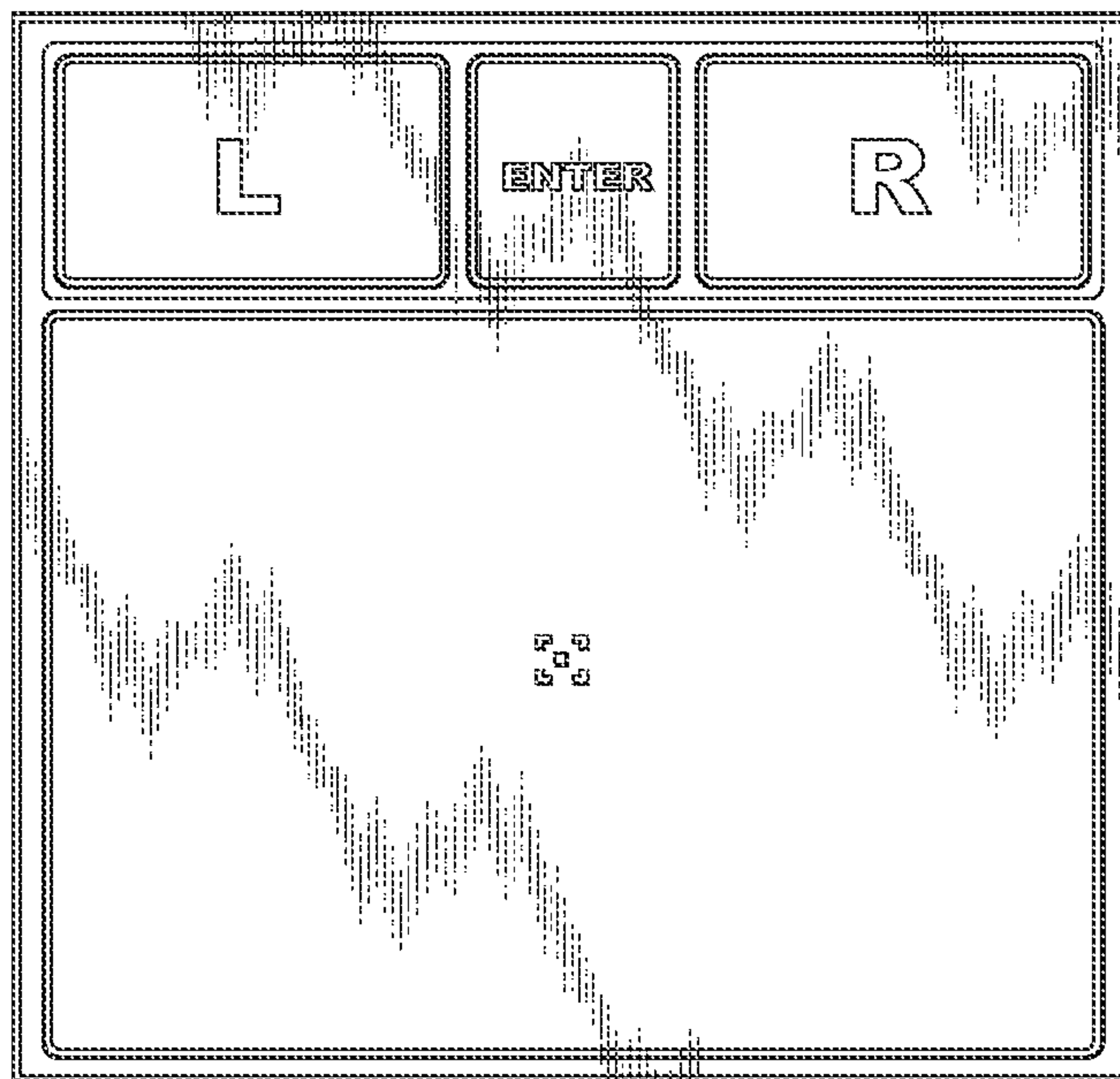
FIG. 1 is a front view of a computer operating apparatus;

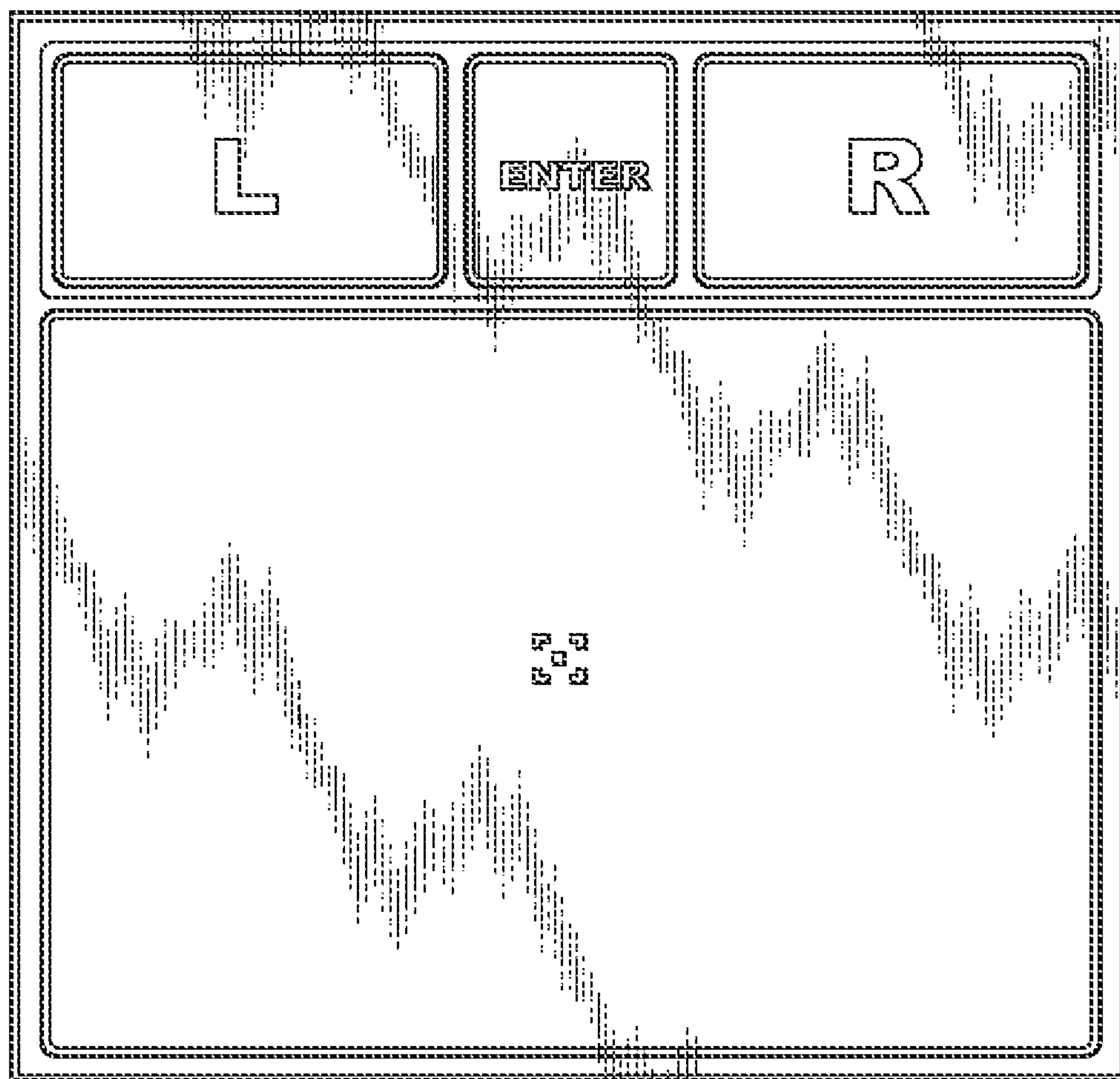

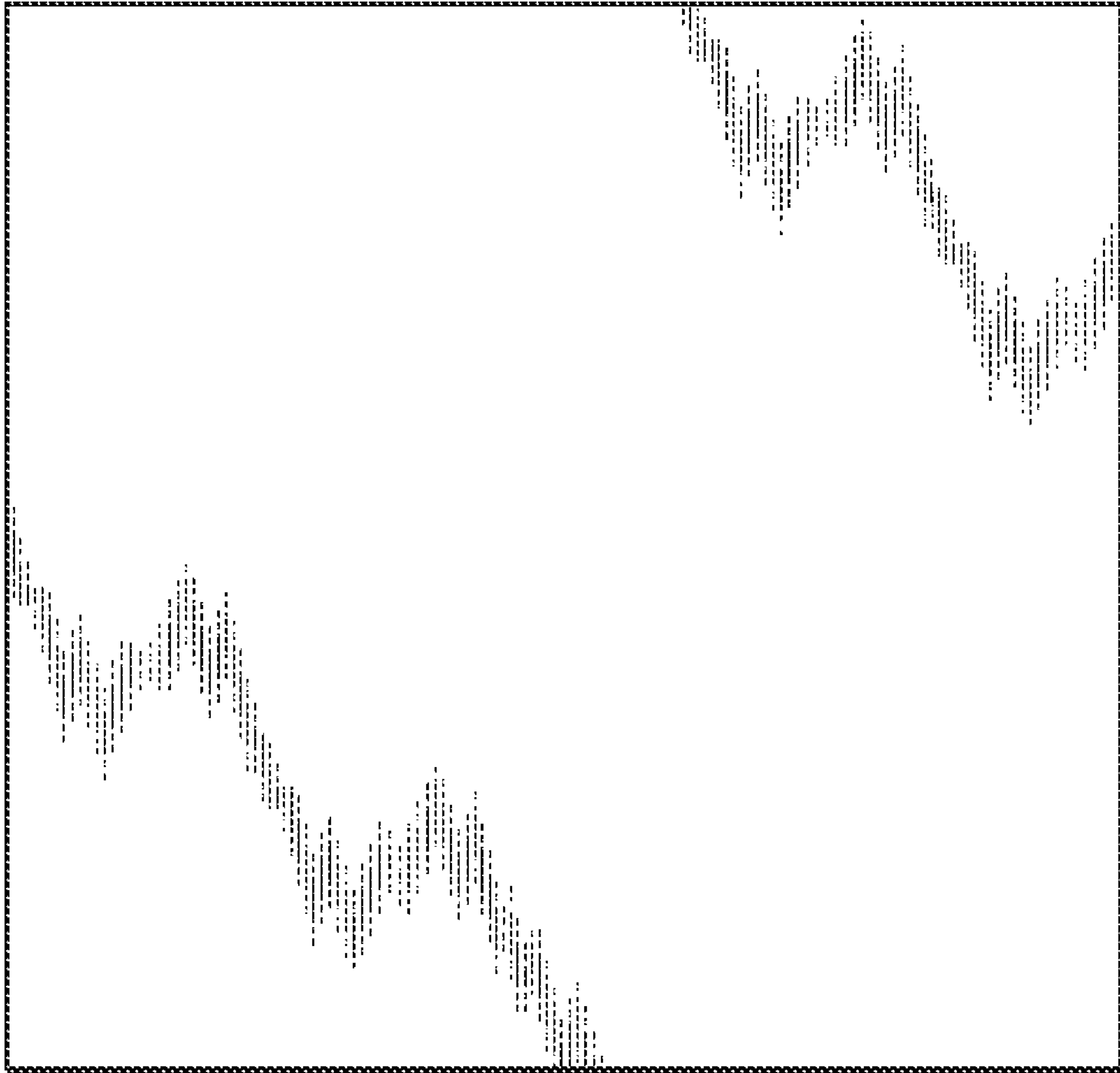
