FIG. 4 is a side elevation of the side opposite shown in FIG. 3;

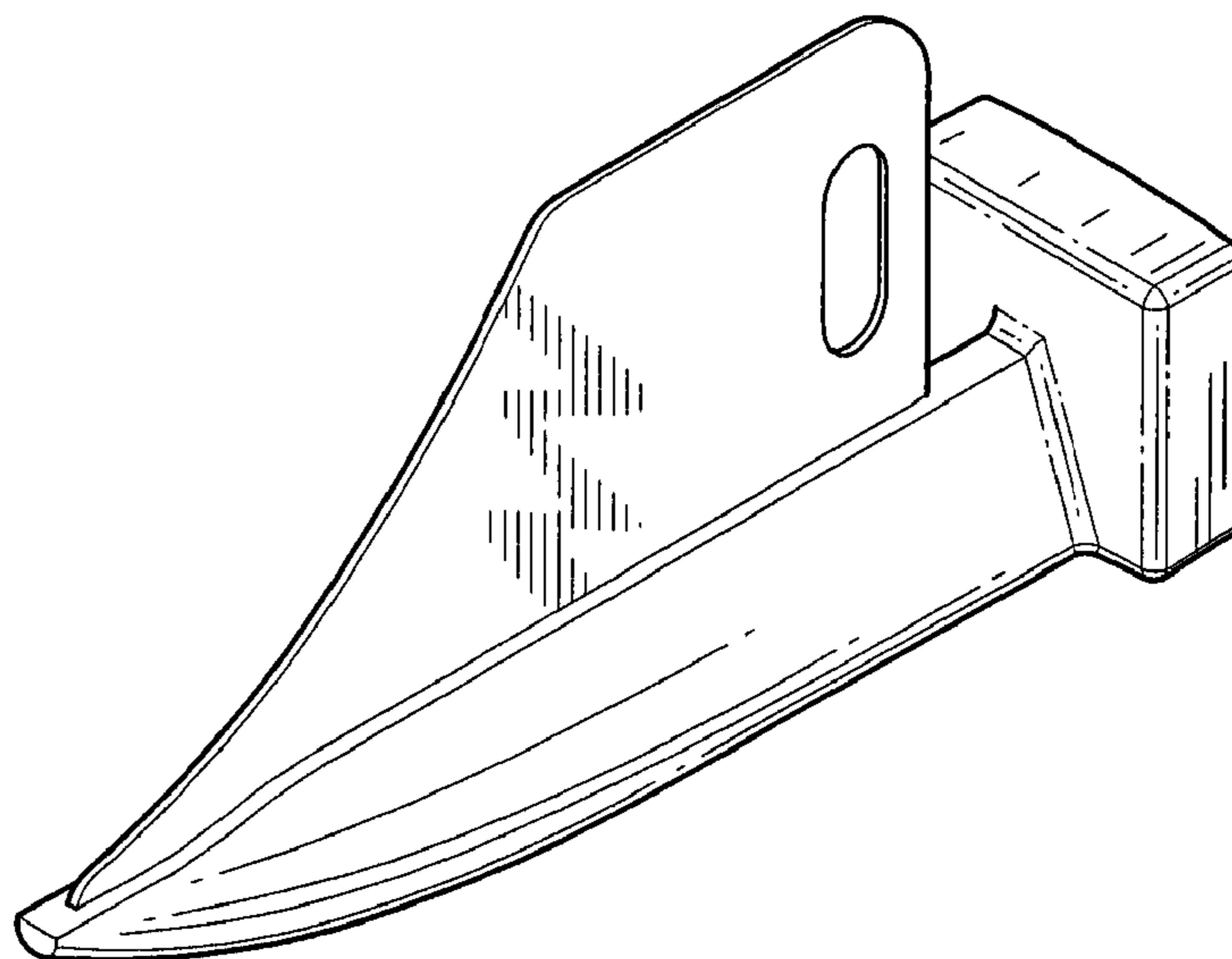
FIG. 5 is a bottom plan view thereof;

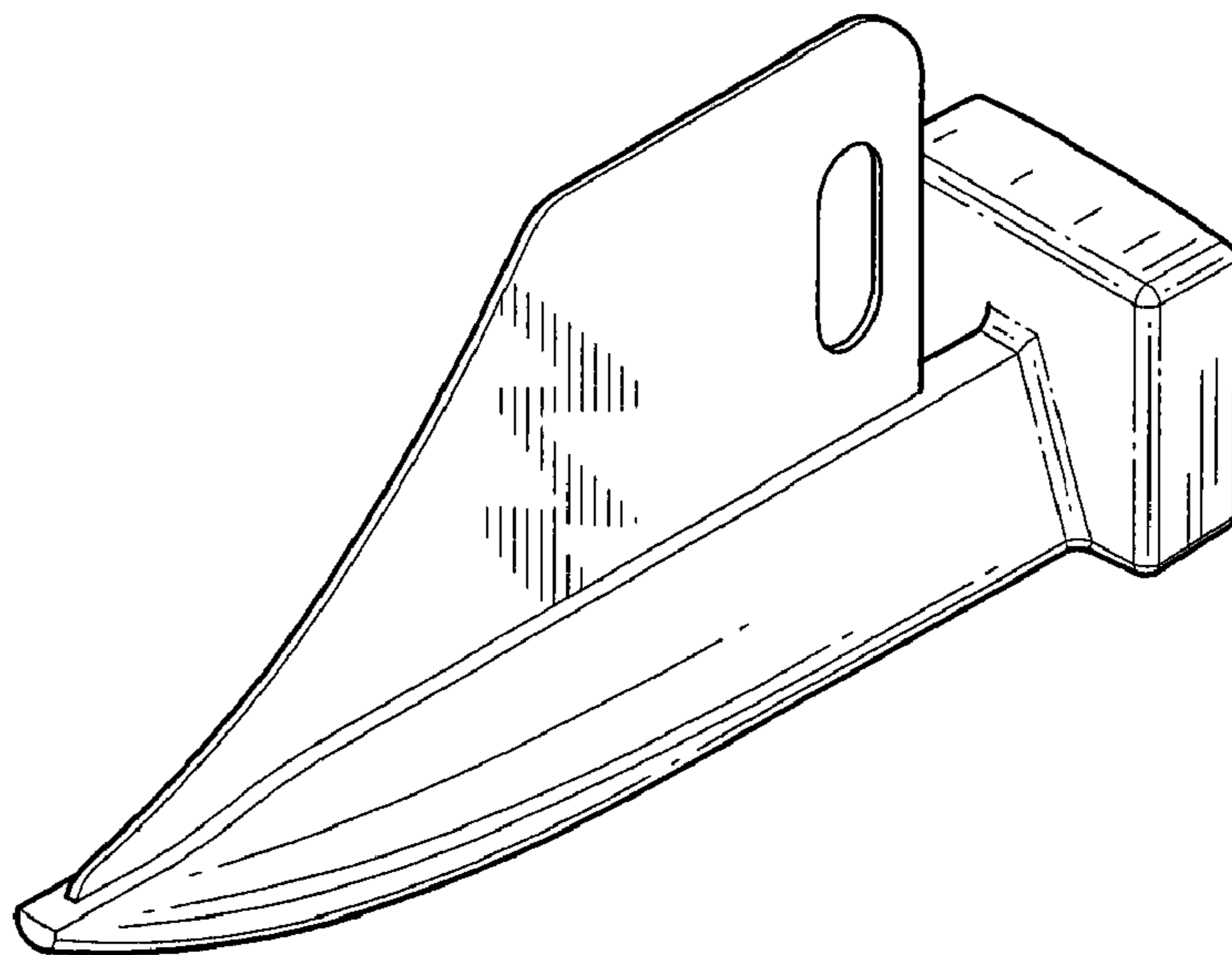

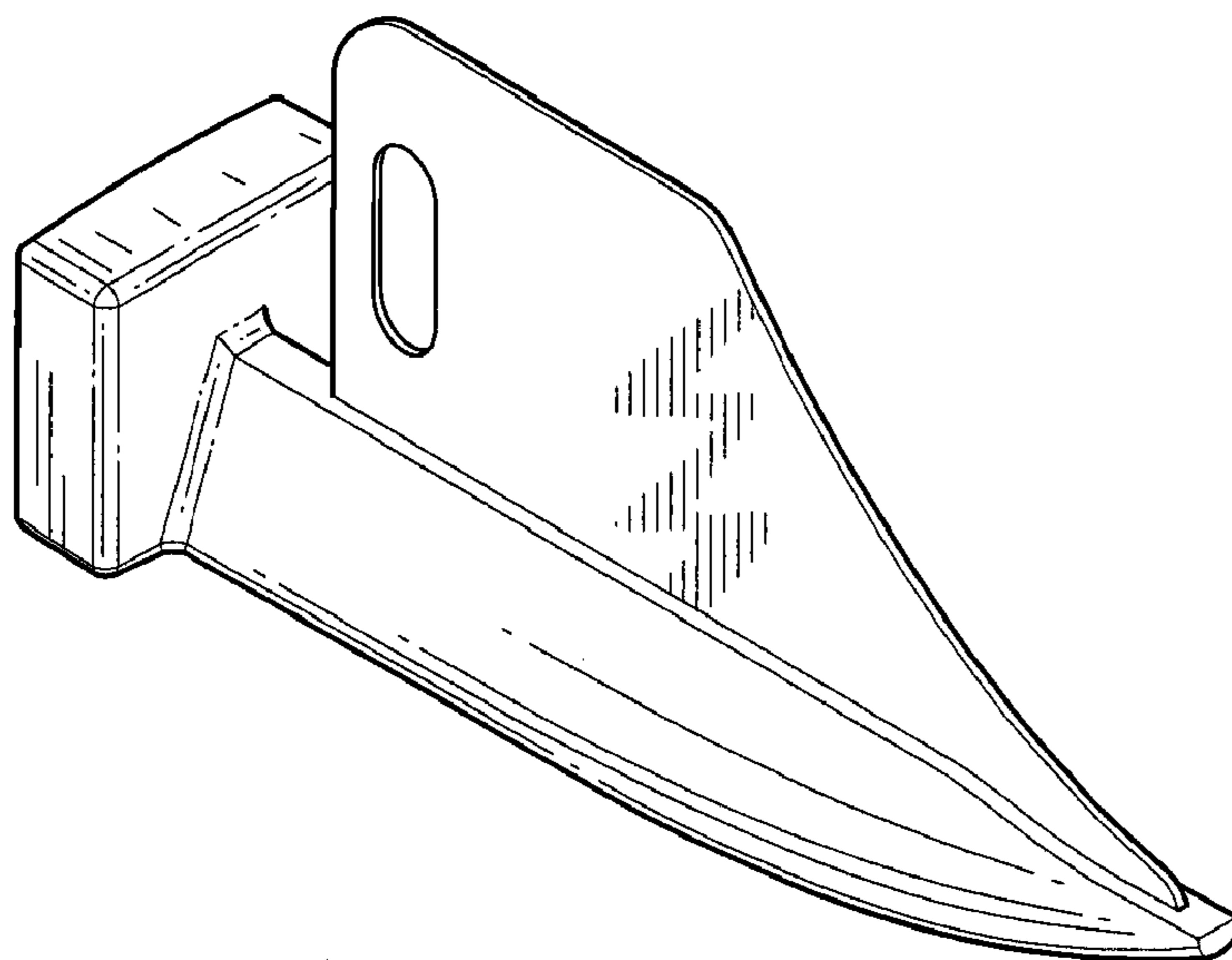

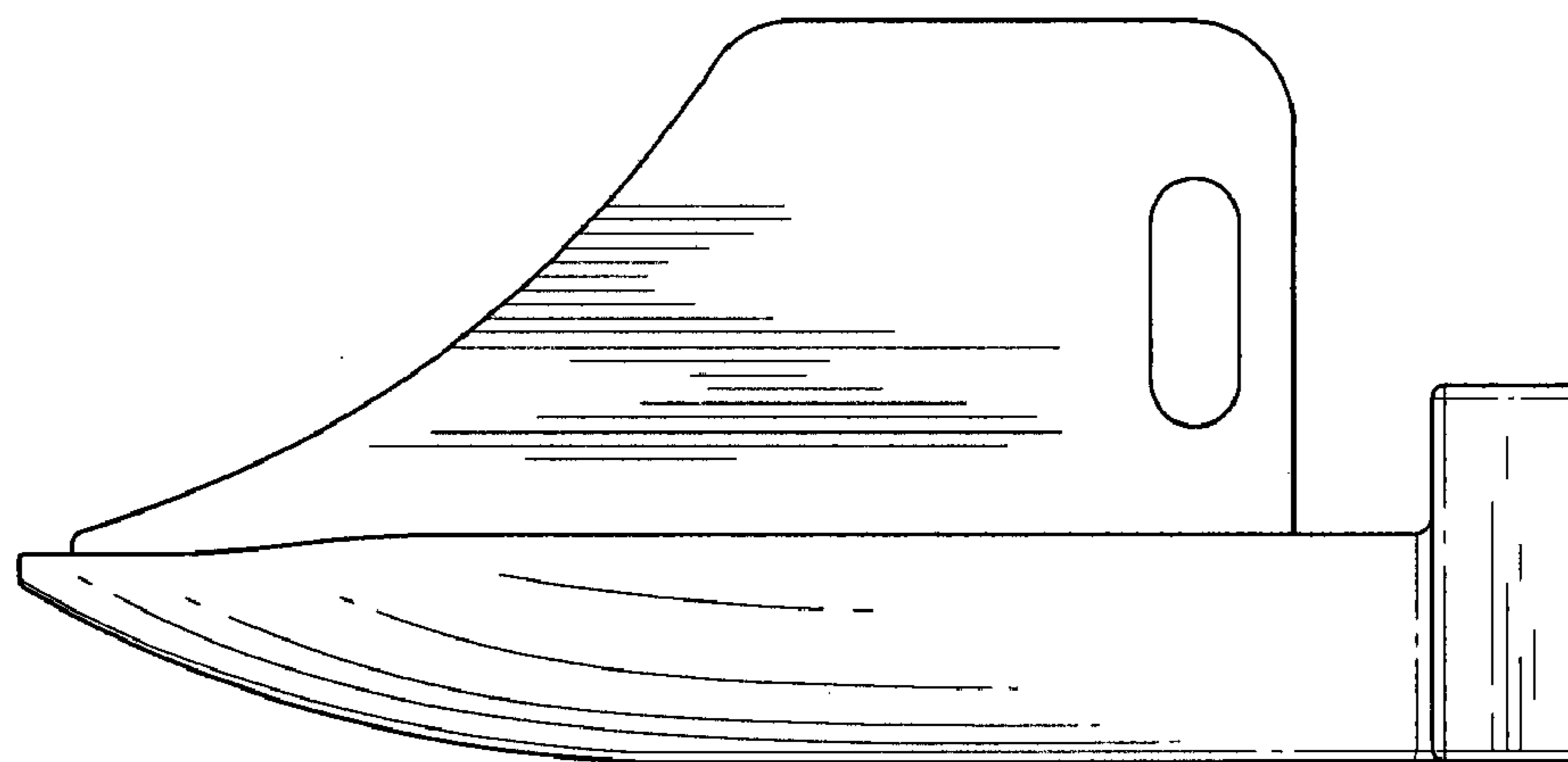

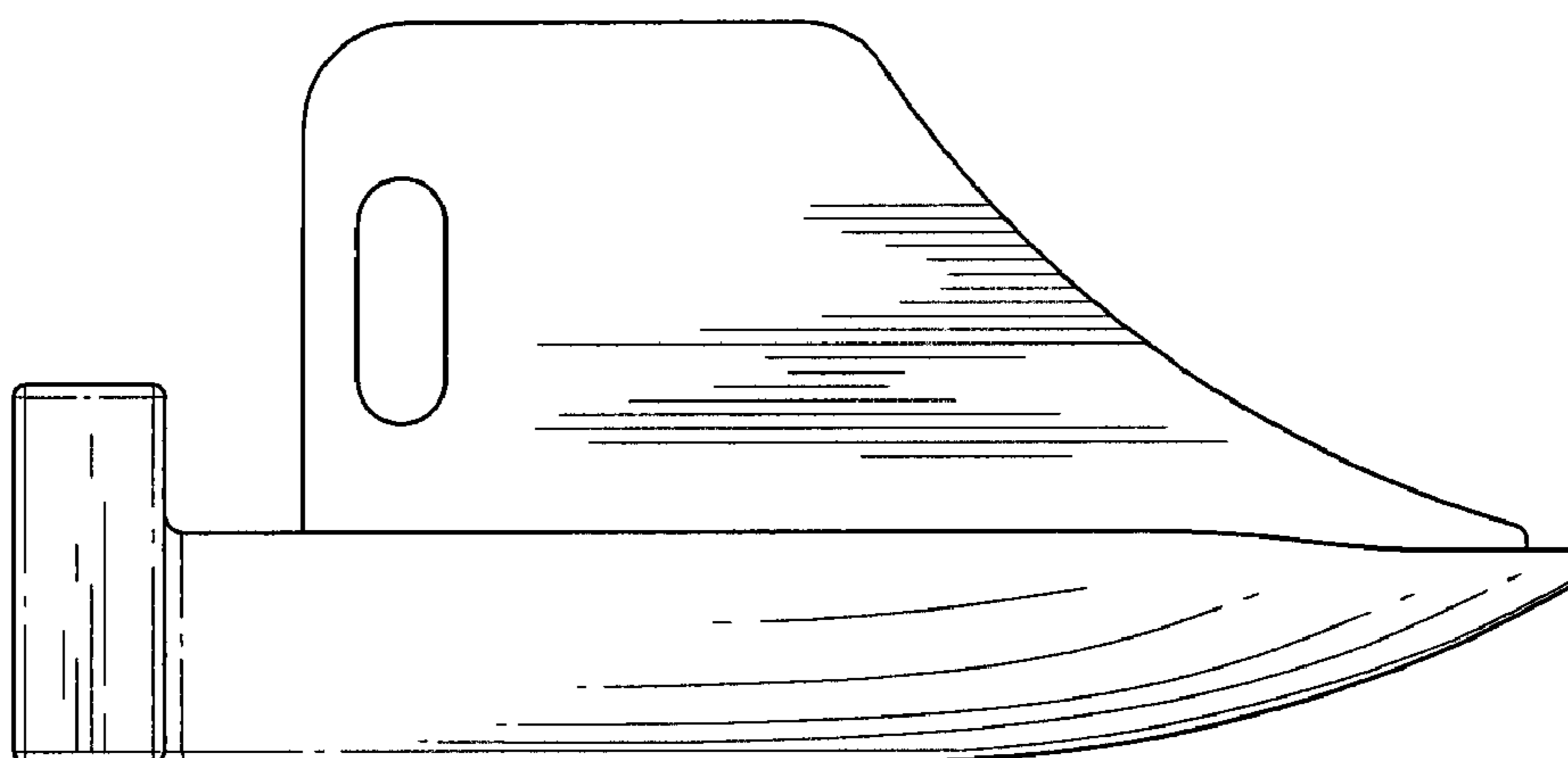

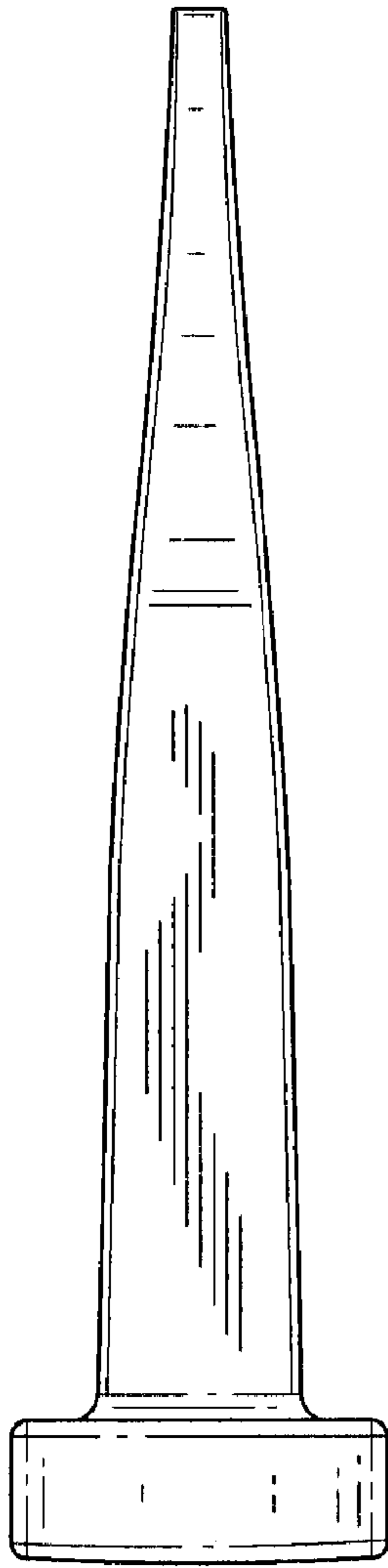

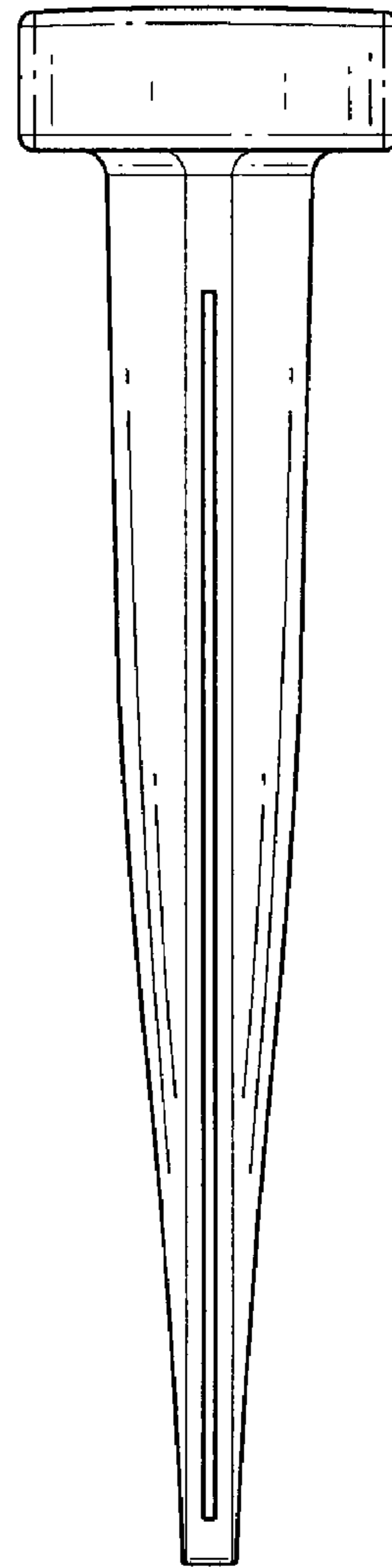

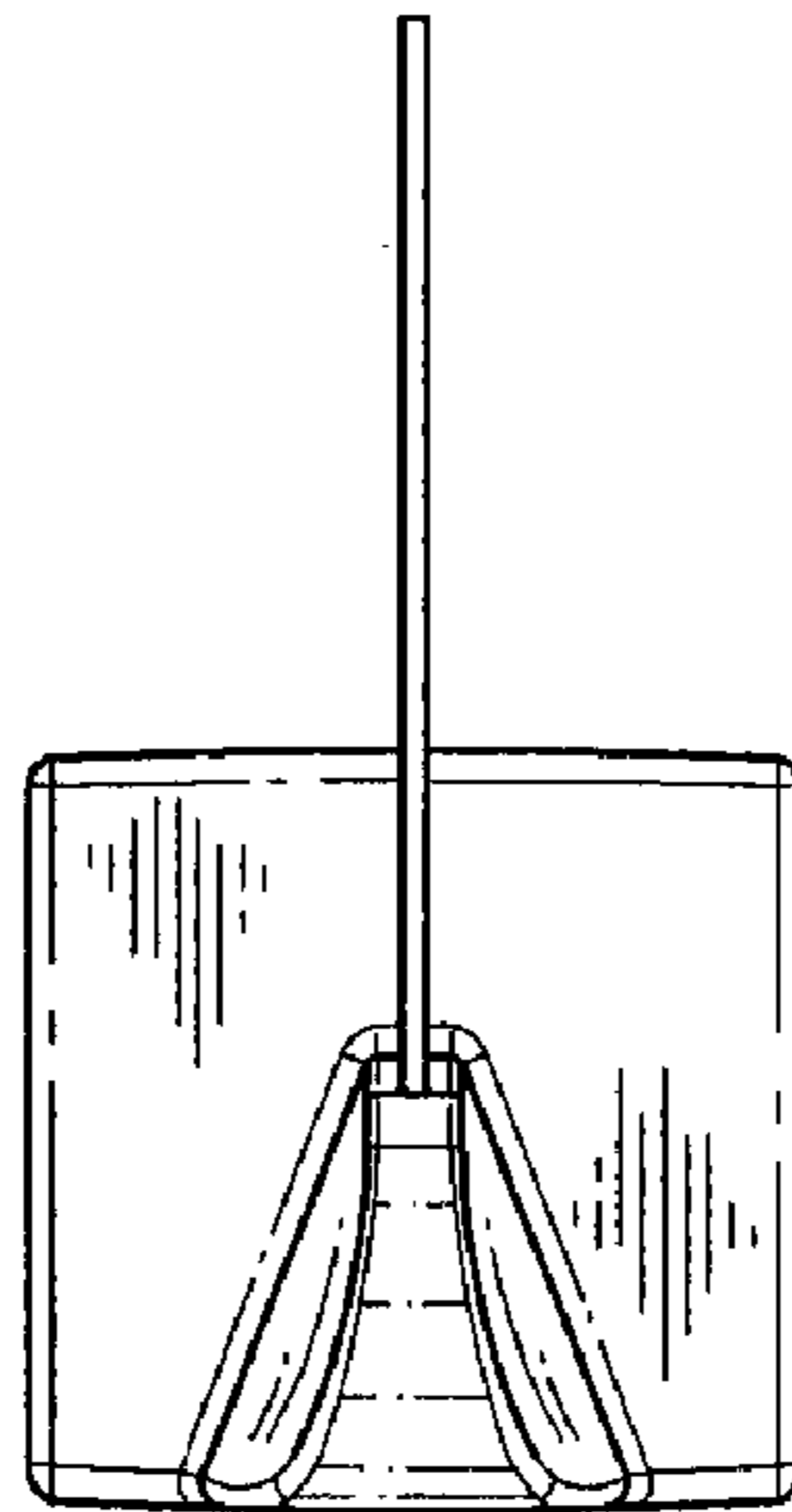

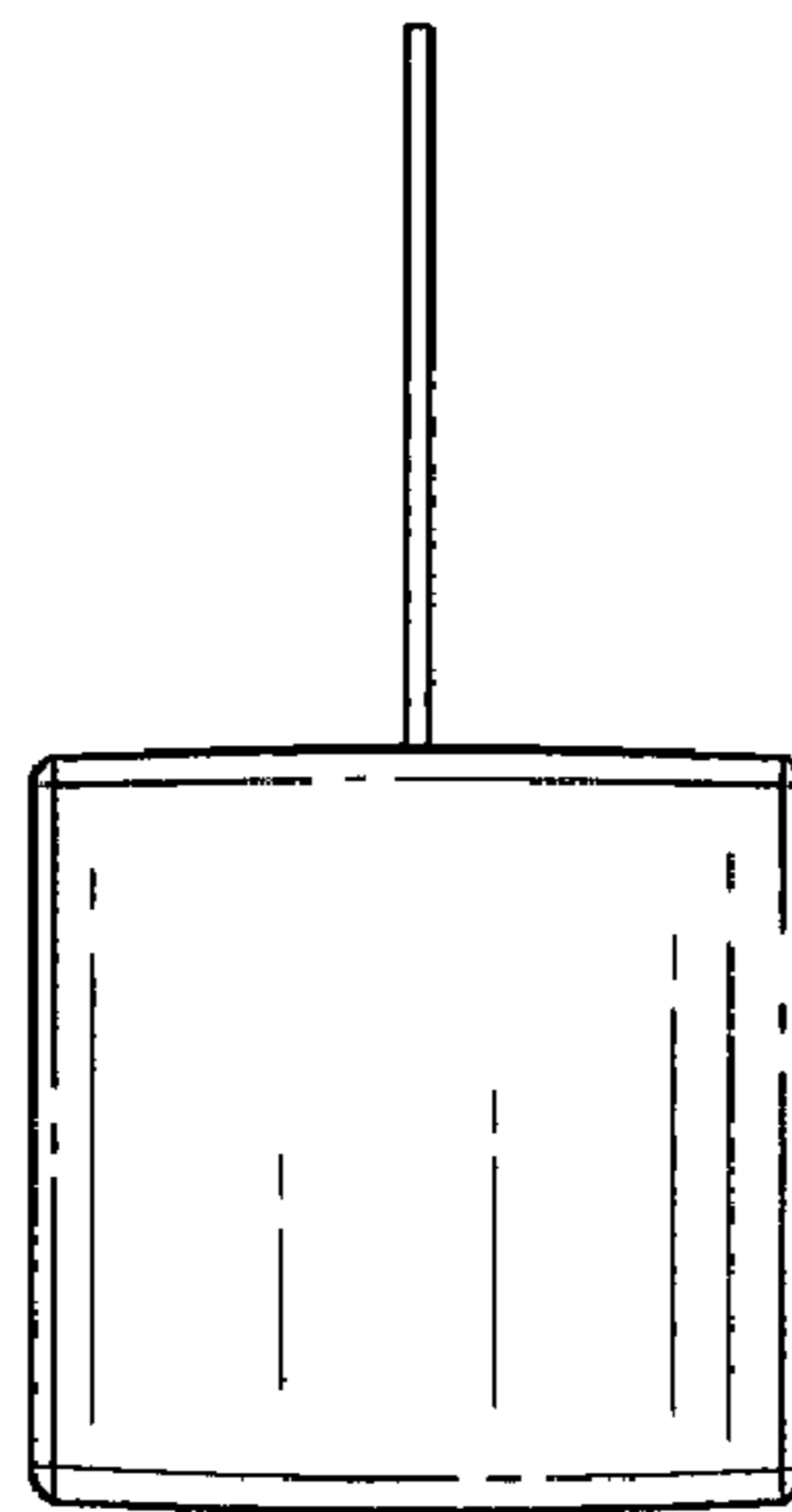
