FIG. 7 is a second end view thereof.

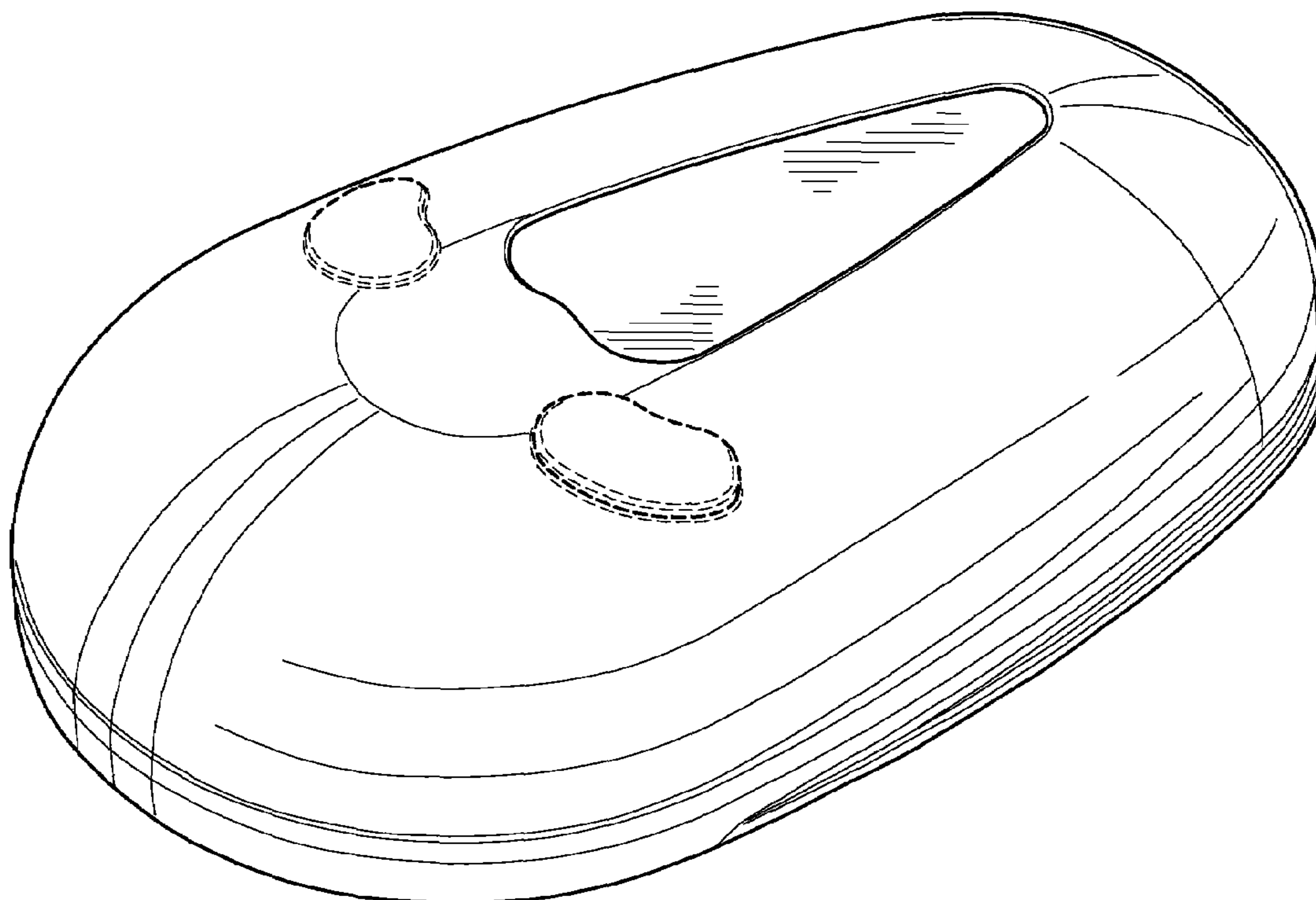

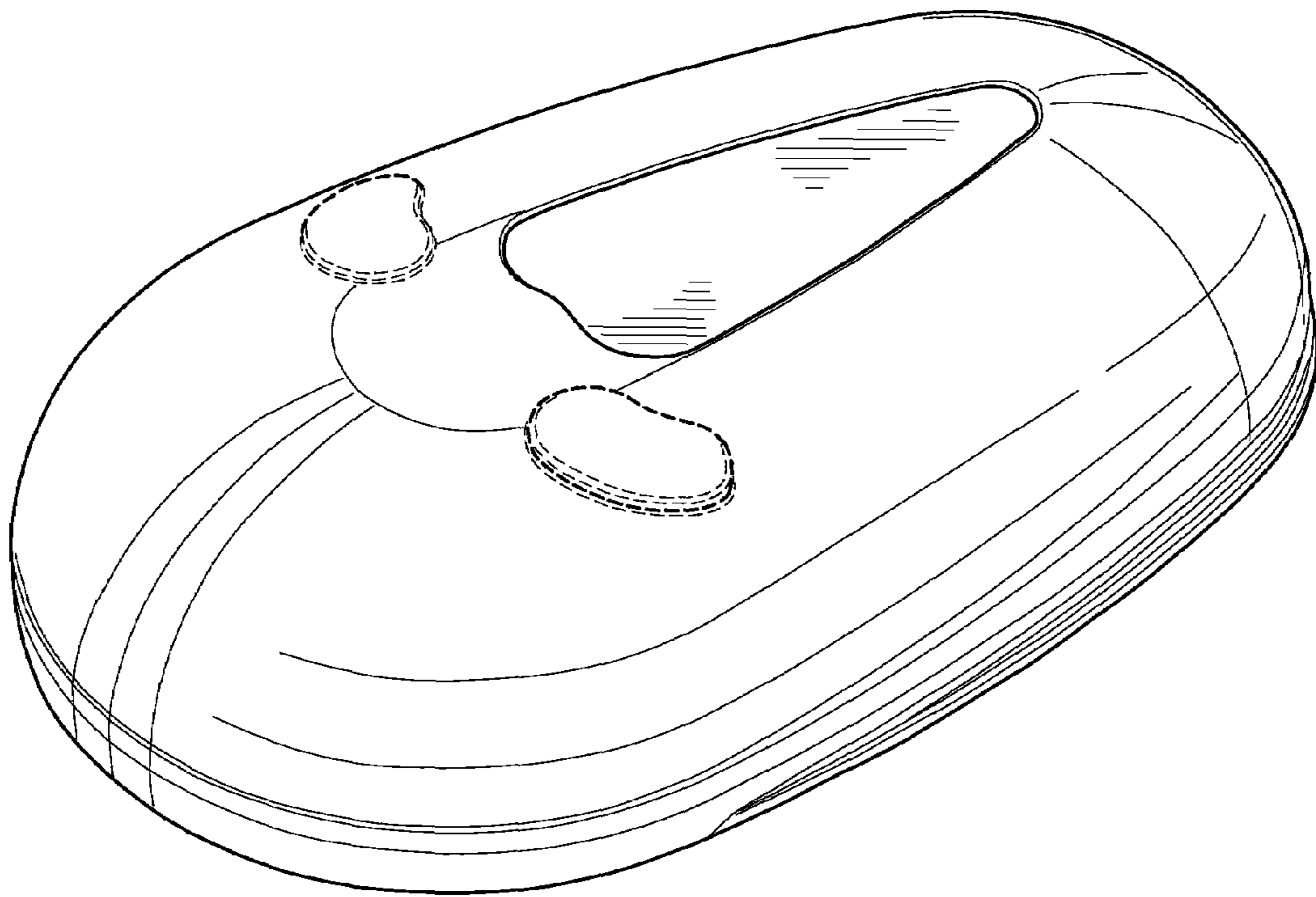

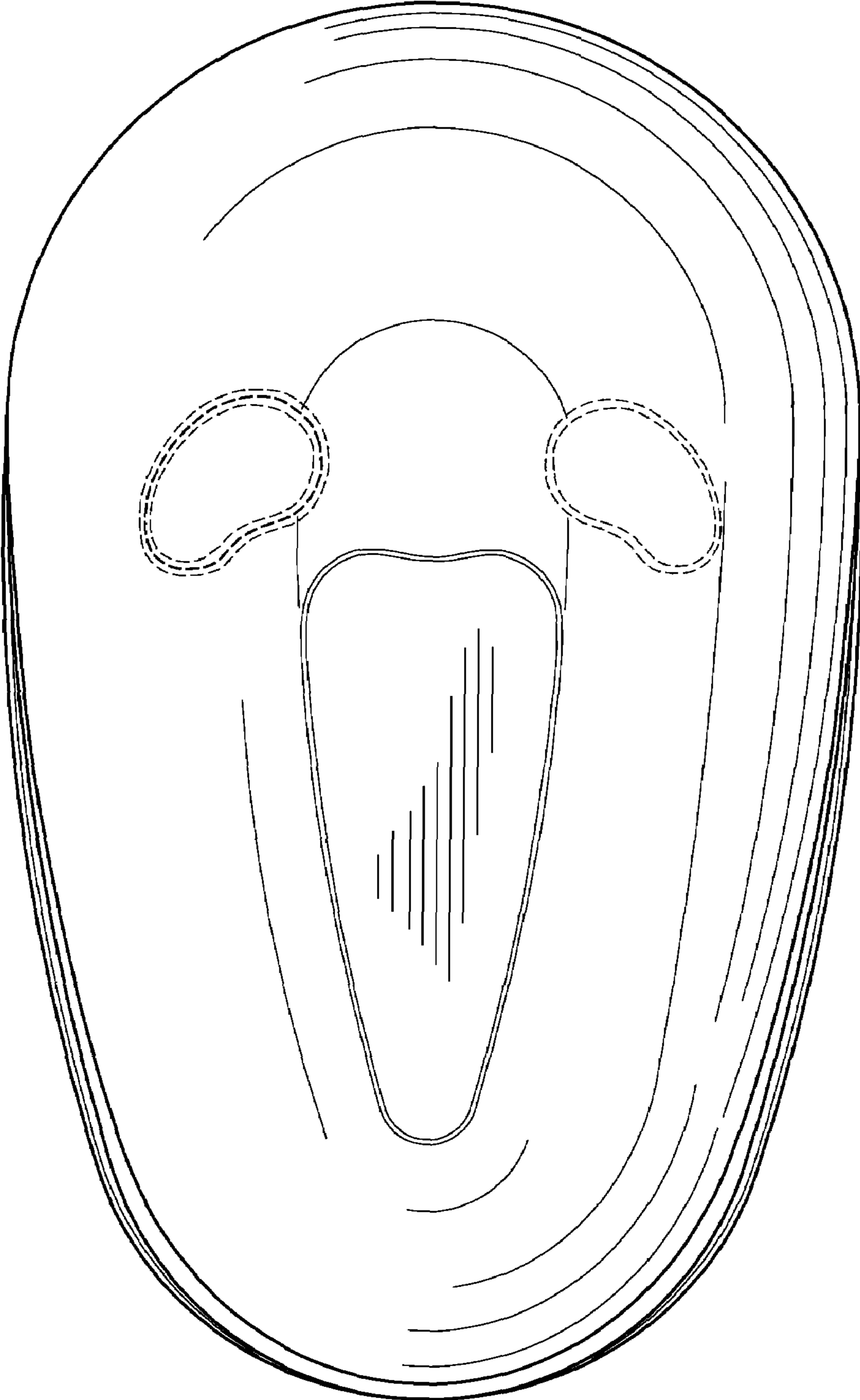

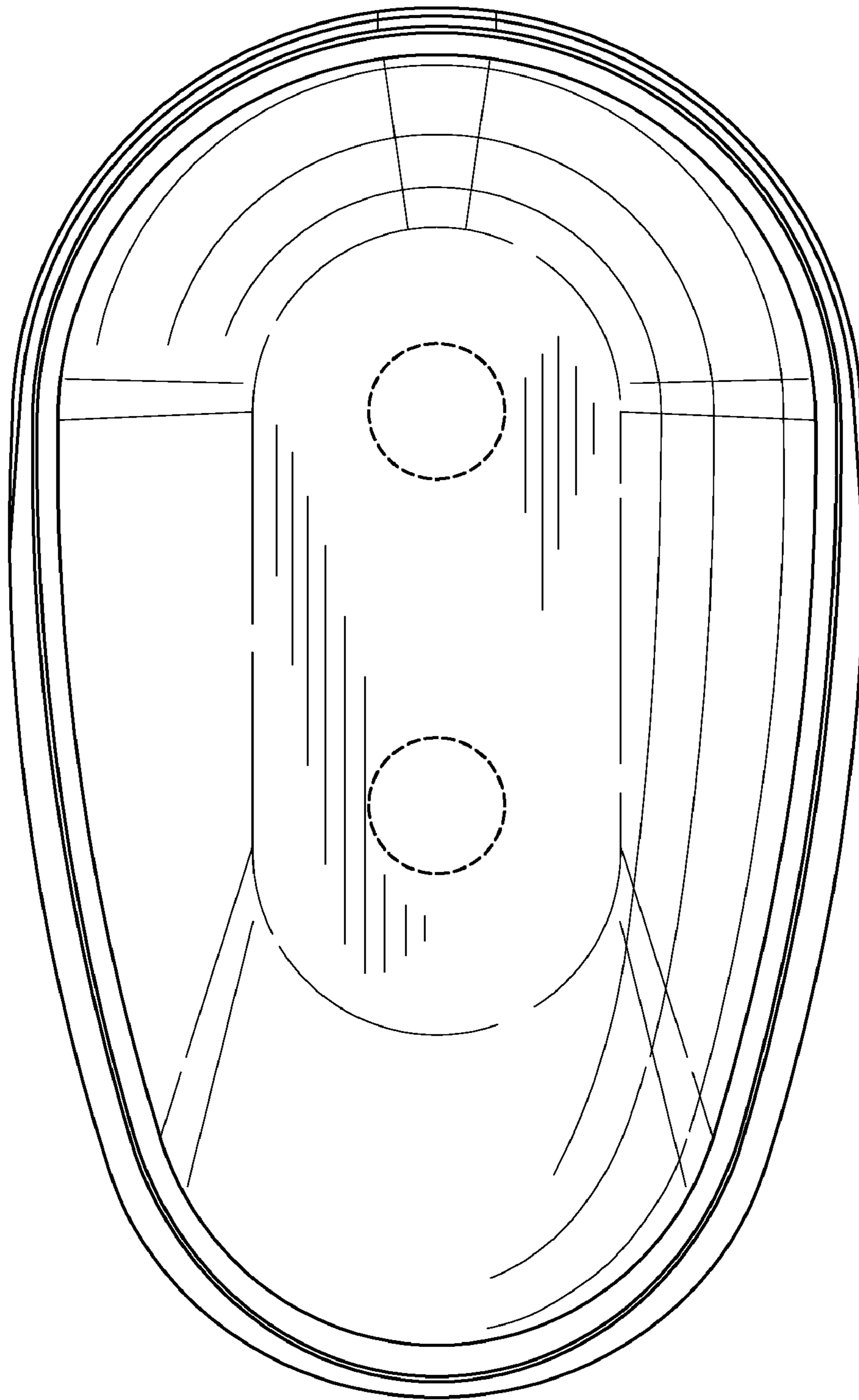

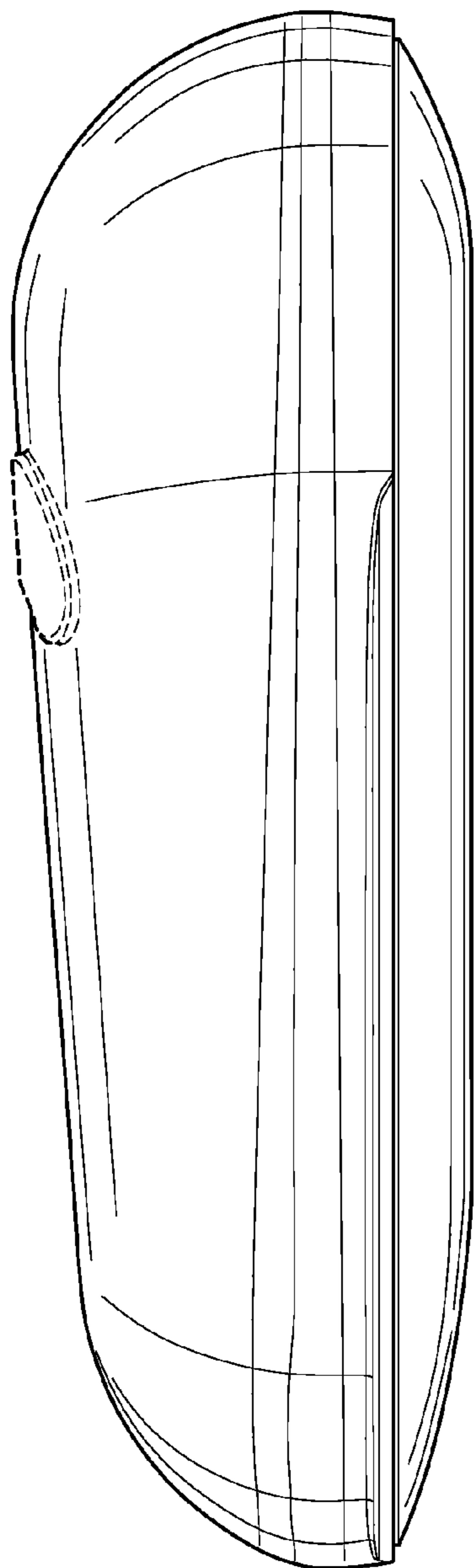

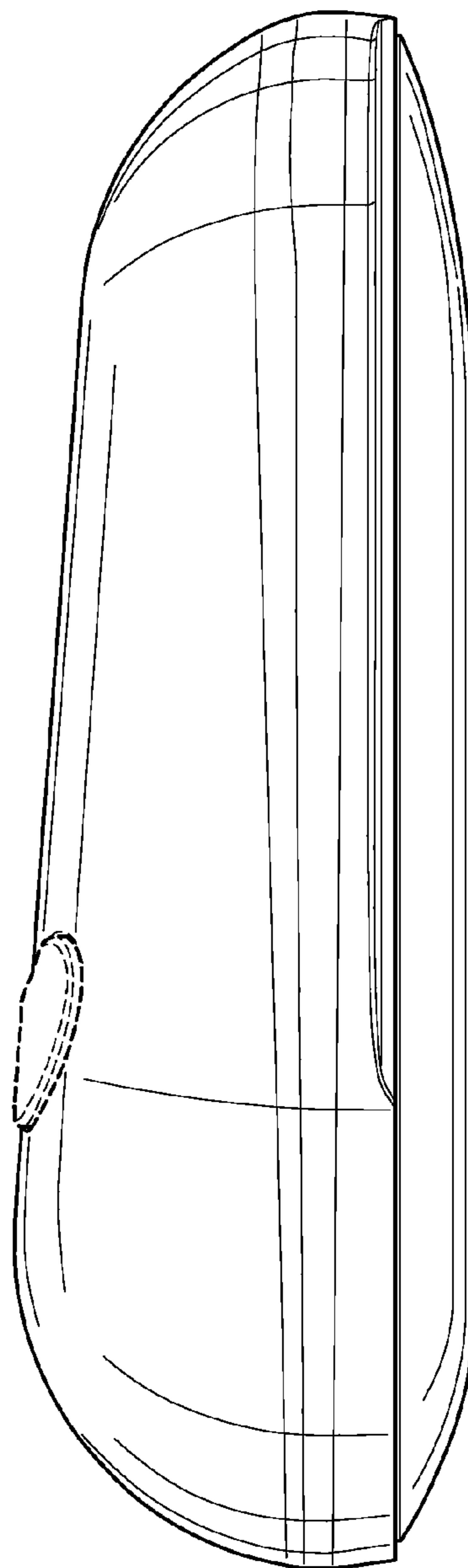

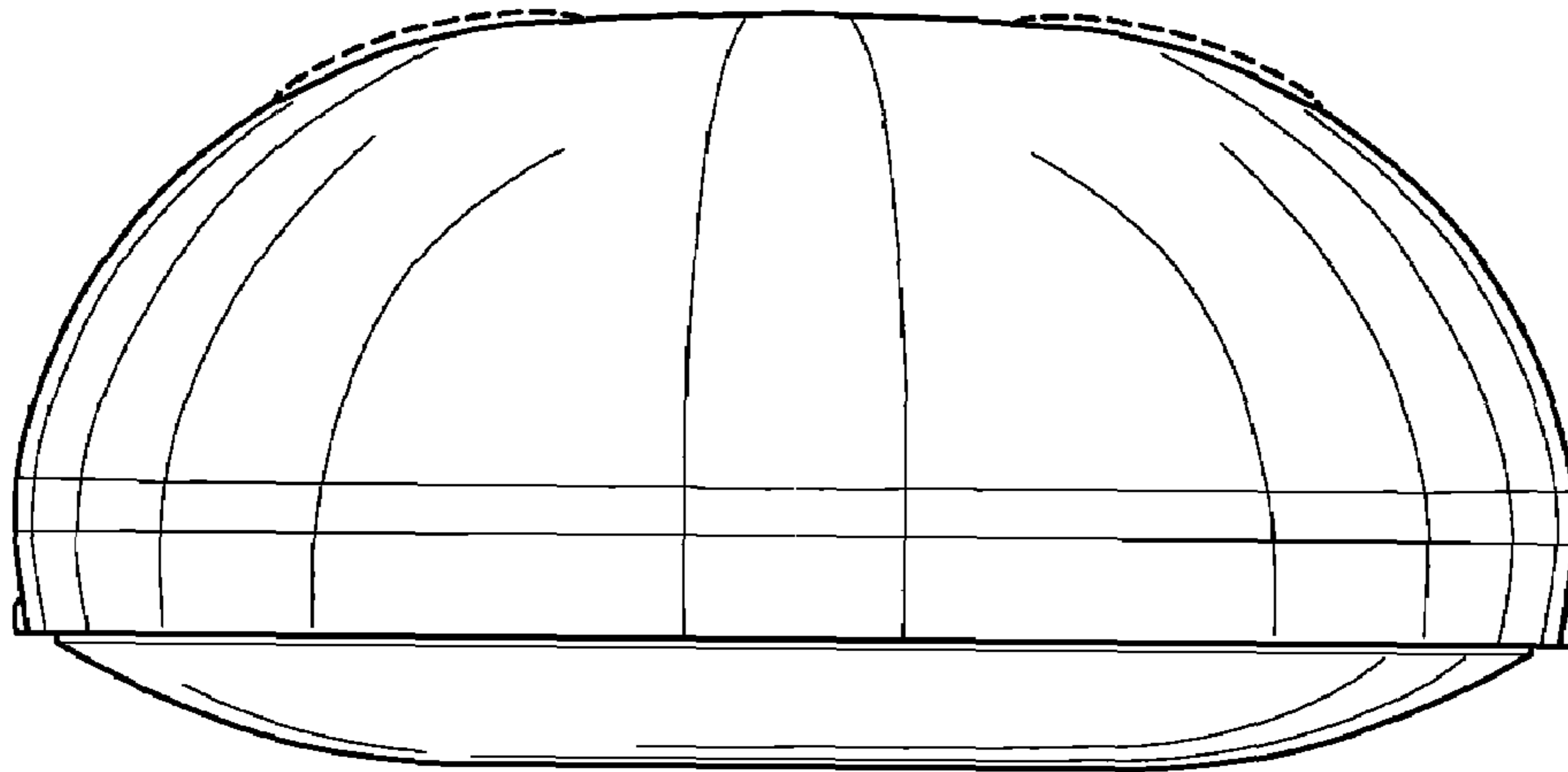

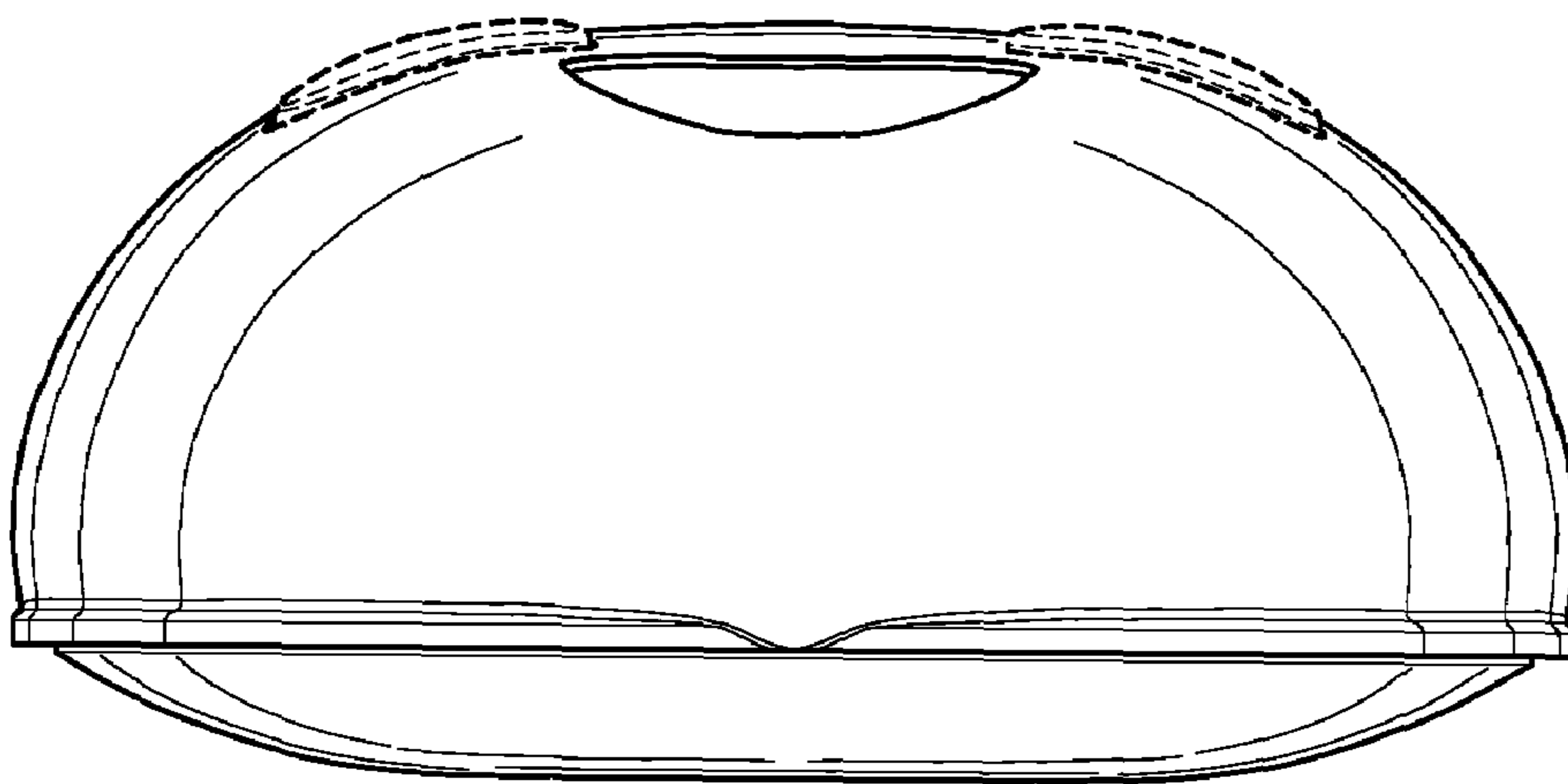
