**DESCRIPTION**

FIG. 4 is side view thereof;

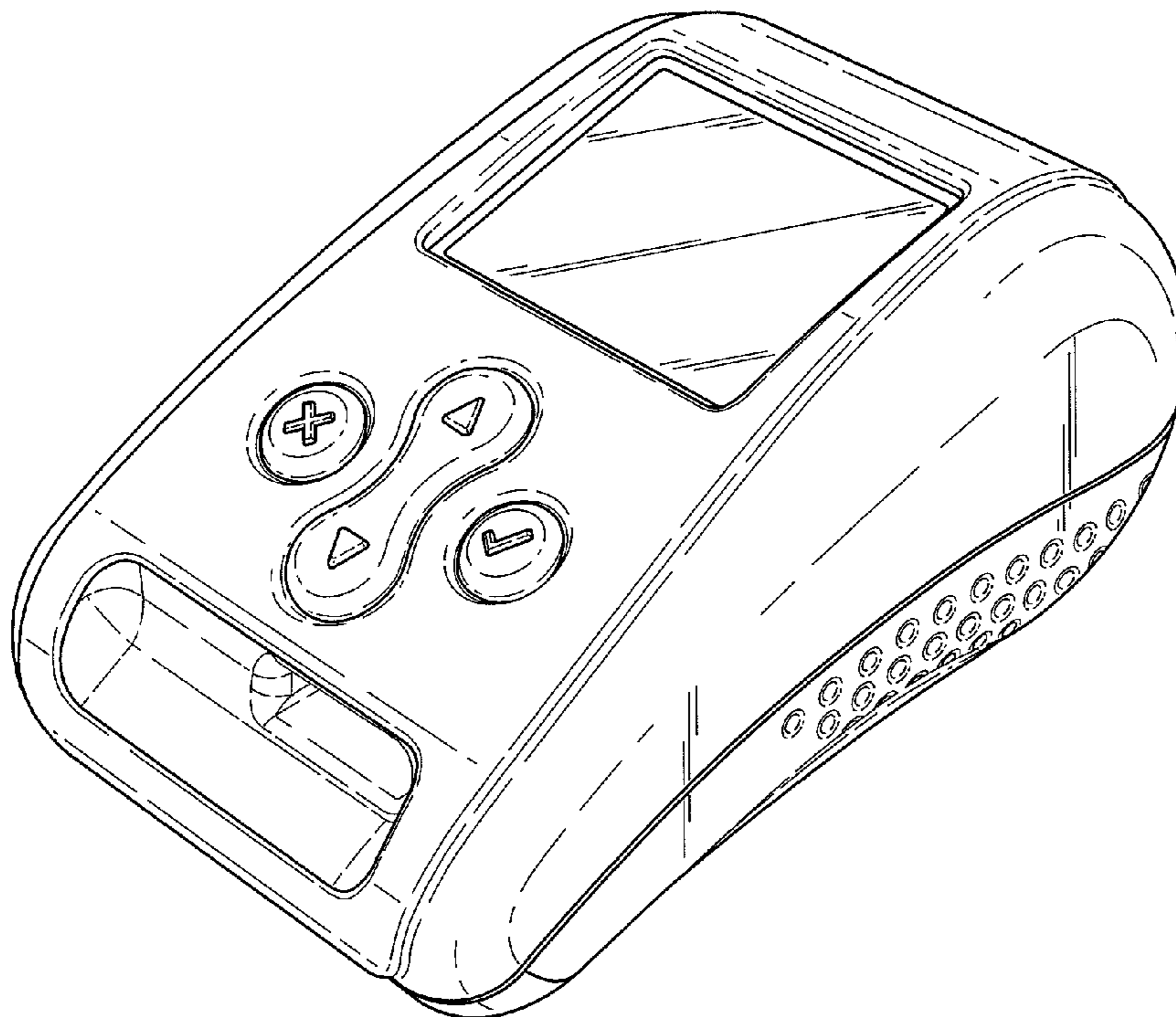
FIG. 5 is another side view thereof;

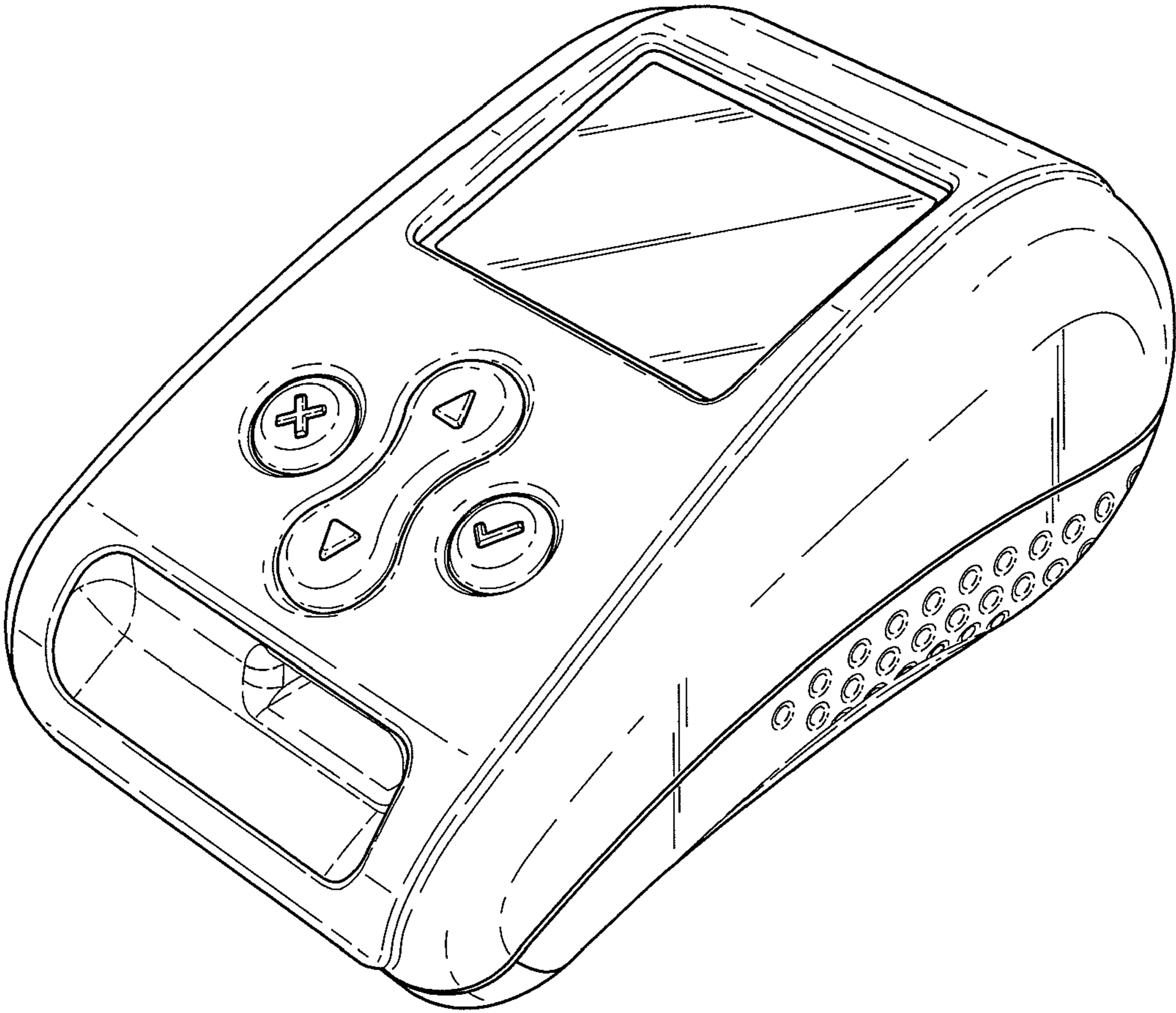

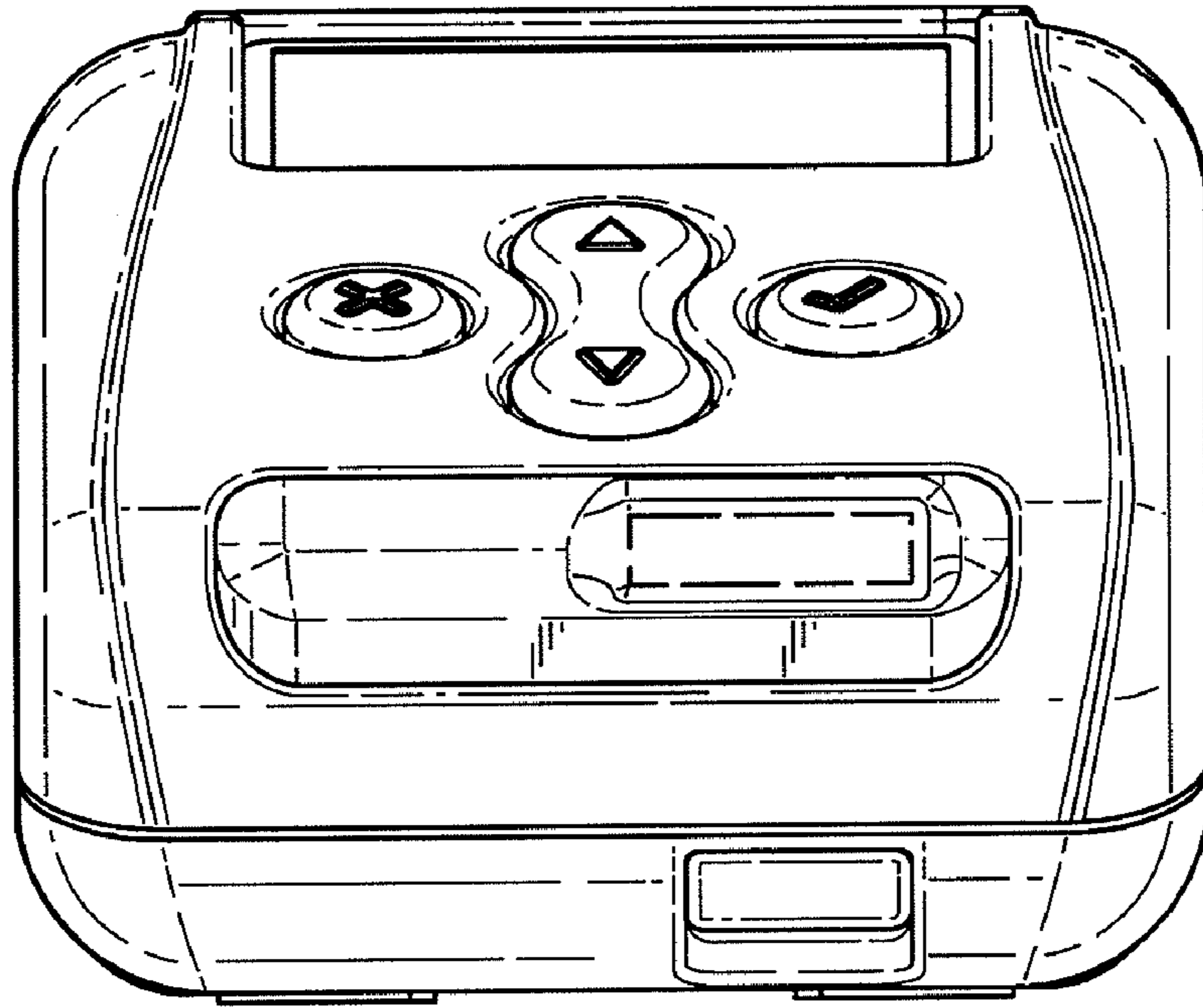

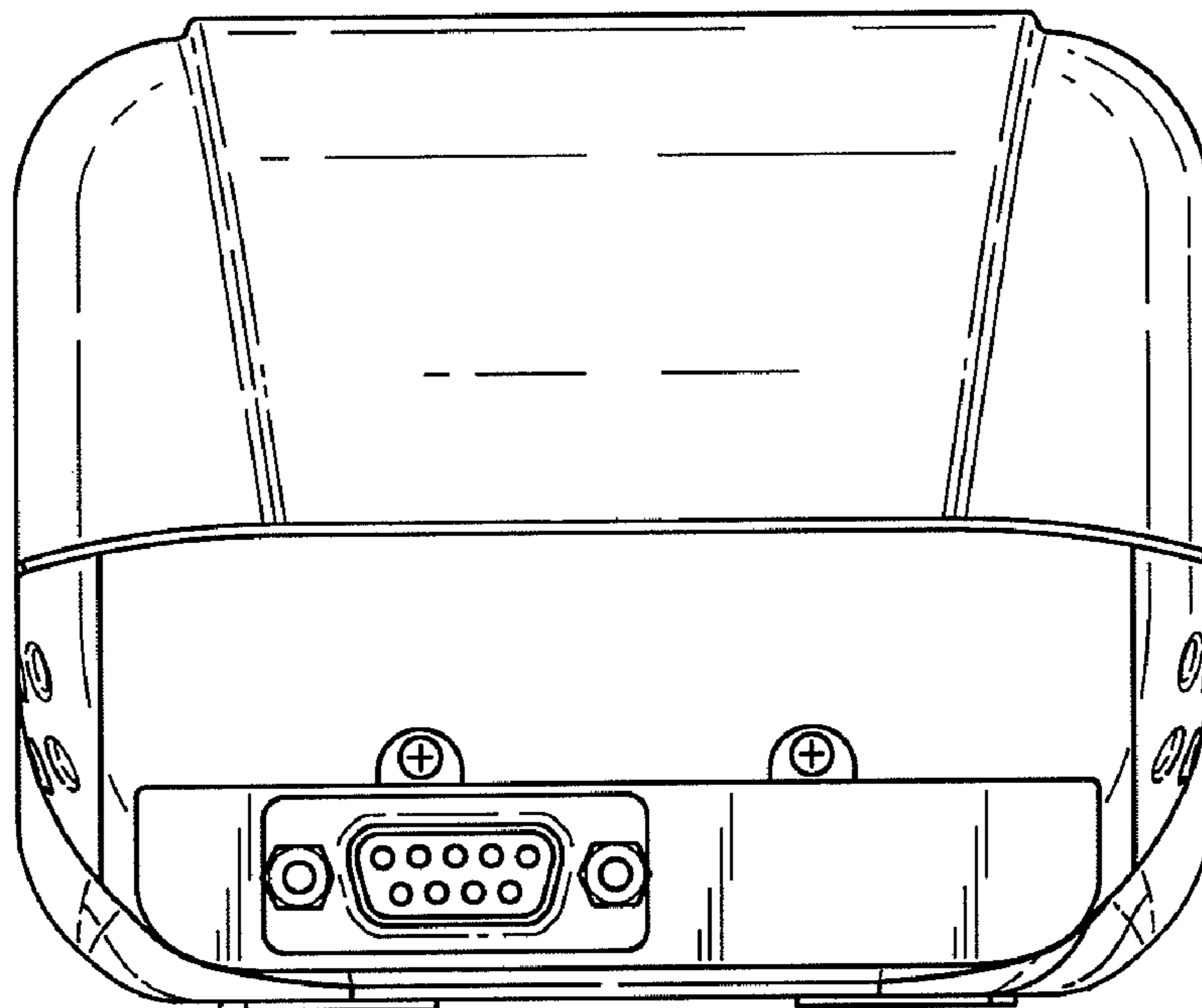

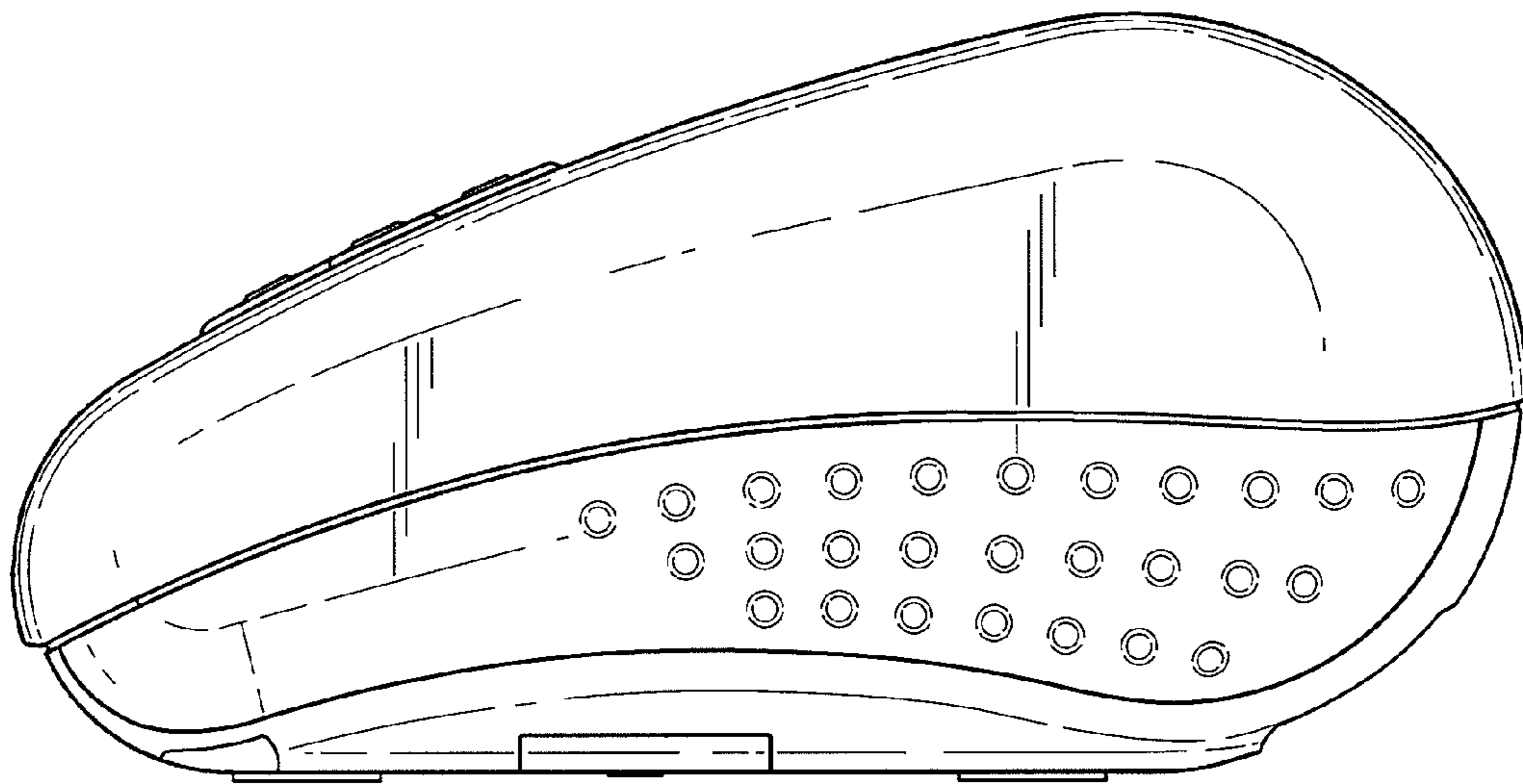

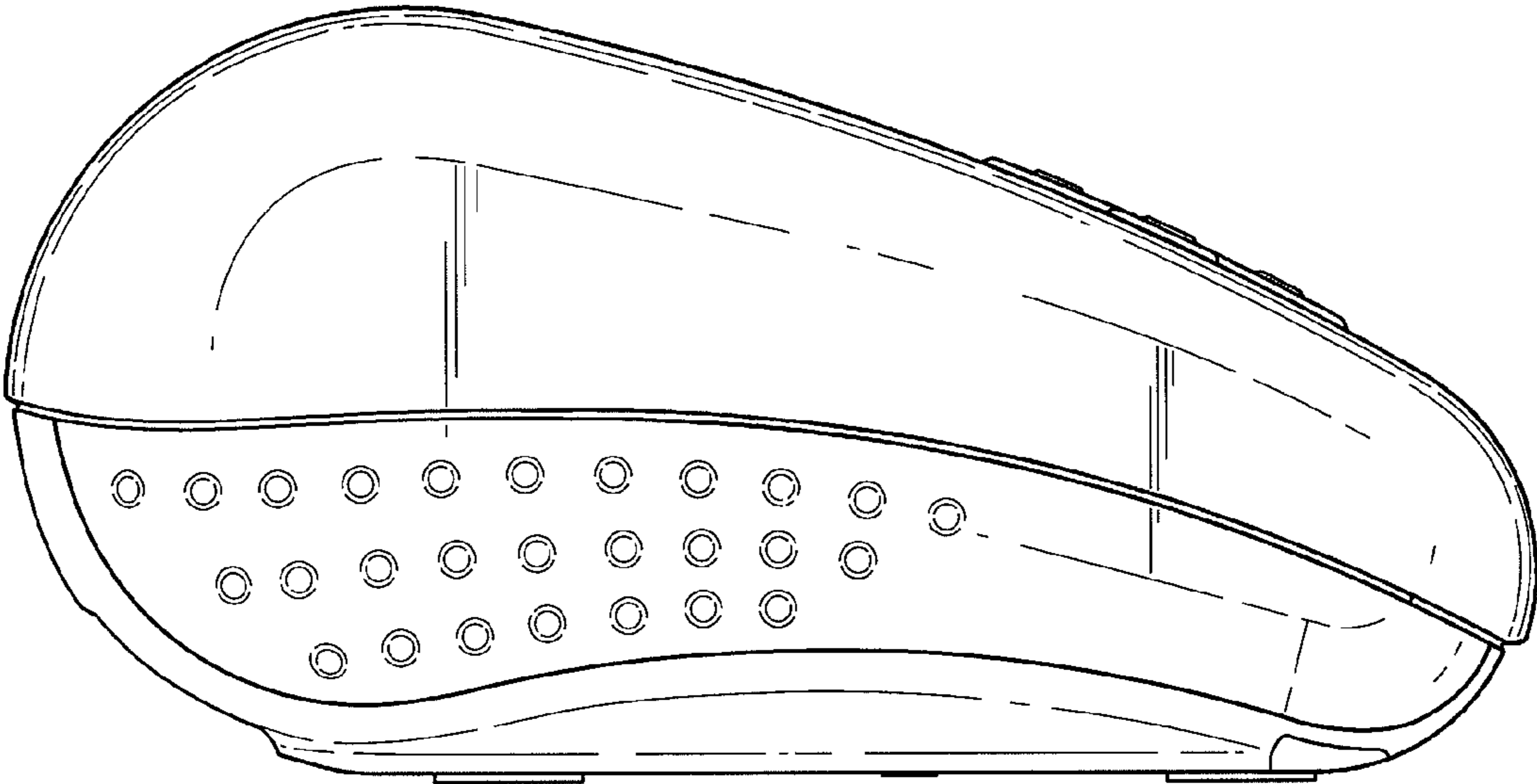

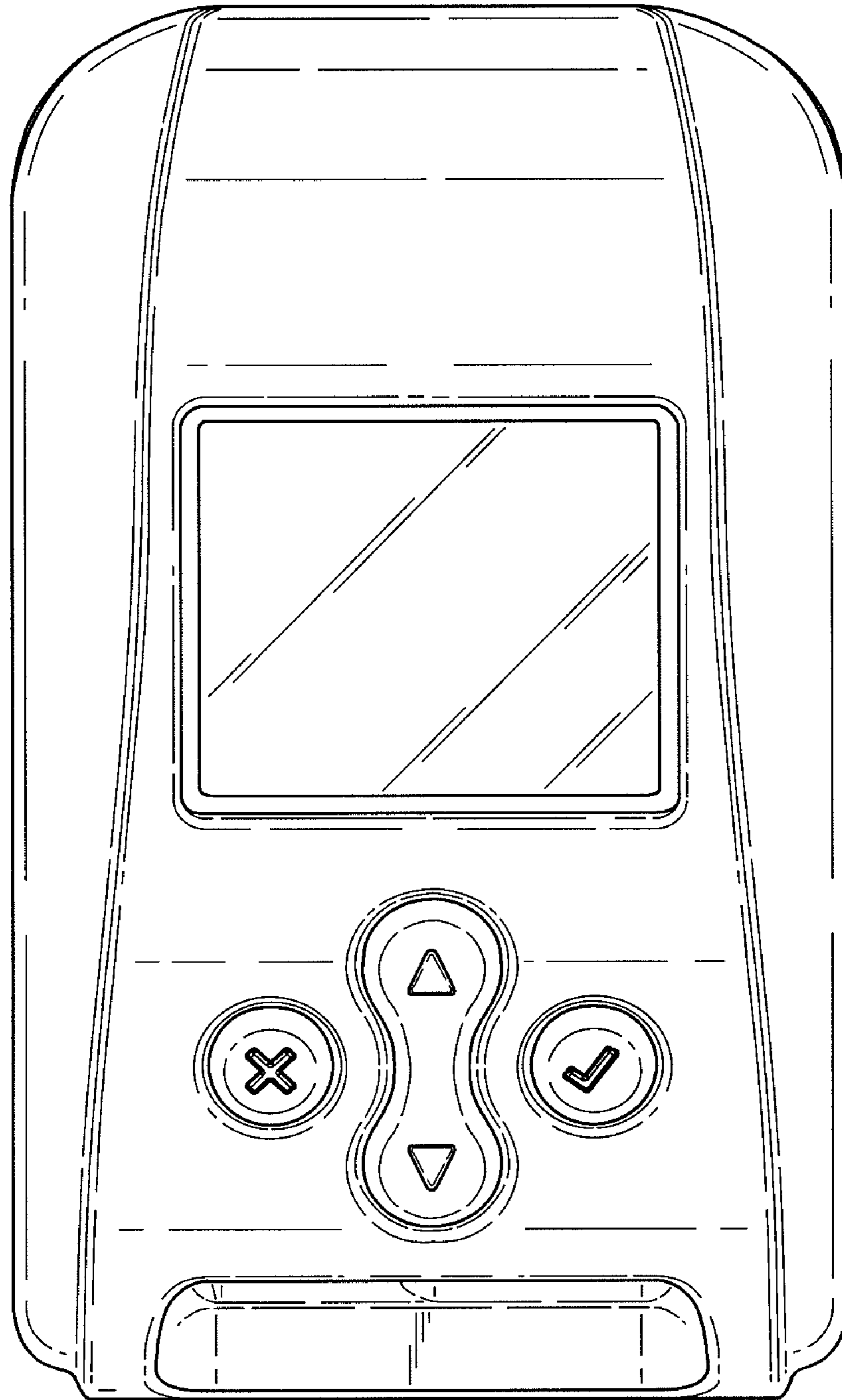

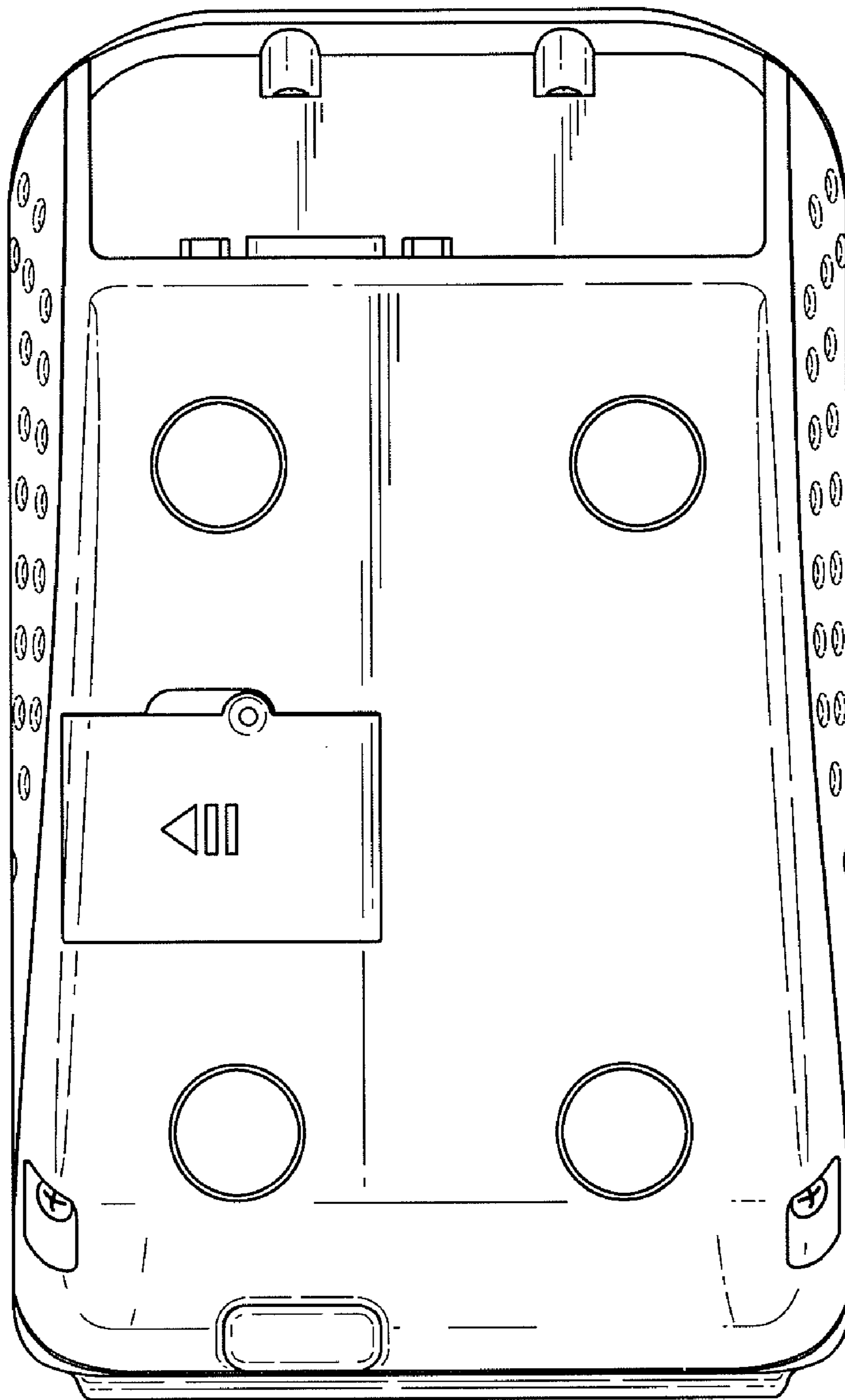
