(57) **CLAIM**

The ornamental design for a bi-pod hunters blind, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective environmental view of a bi-pod hunters blind, in an extended deployment state, showing my new design;

FIG. 2 is a front view thereof;

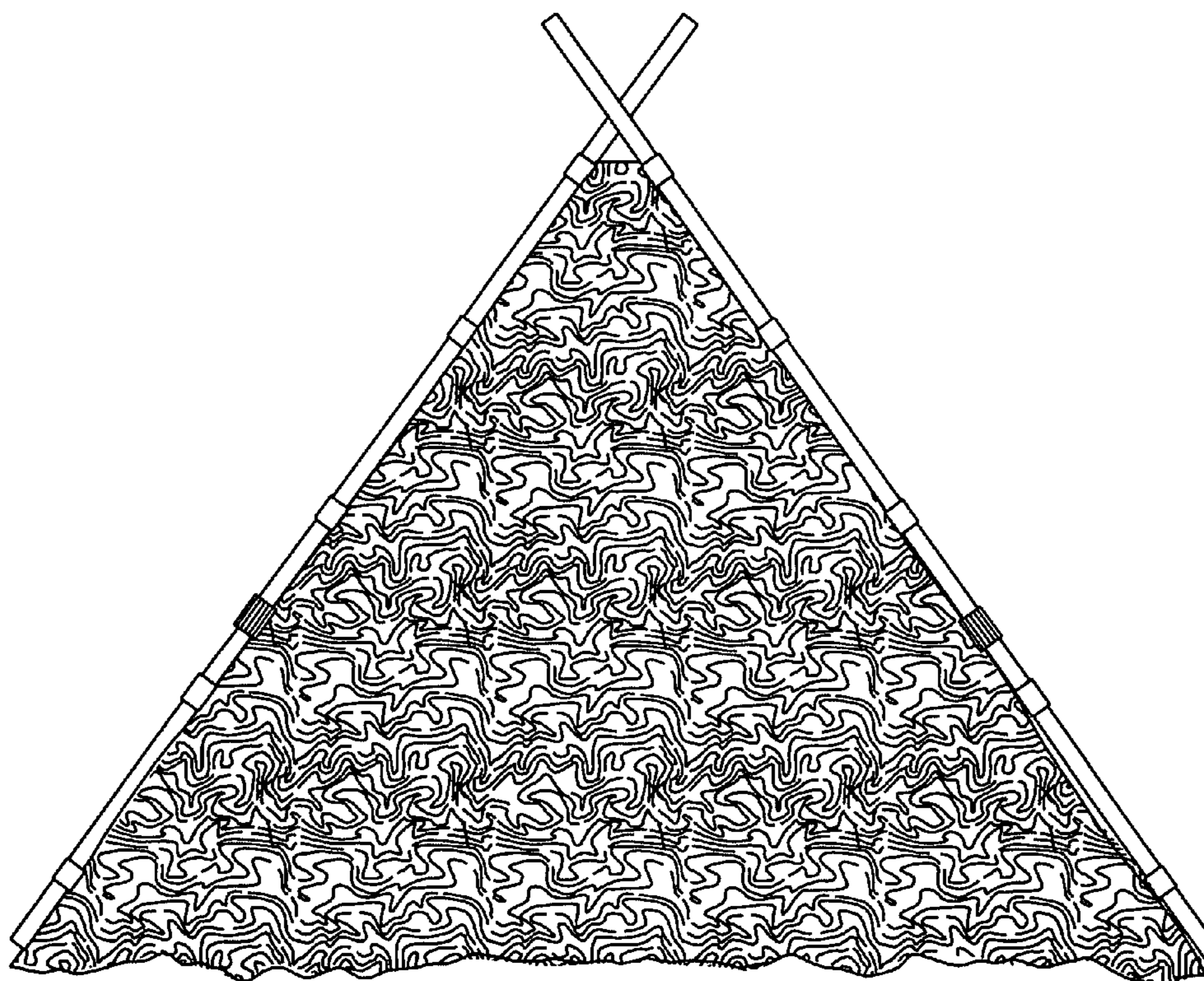
FIG. 3 is a side view thereof;

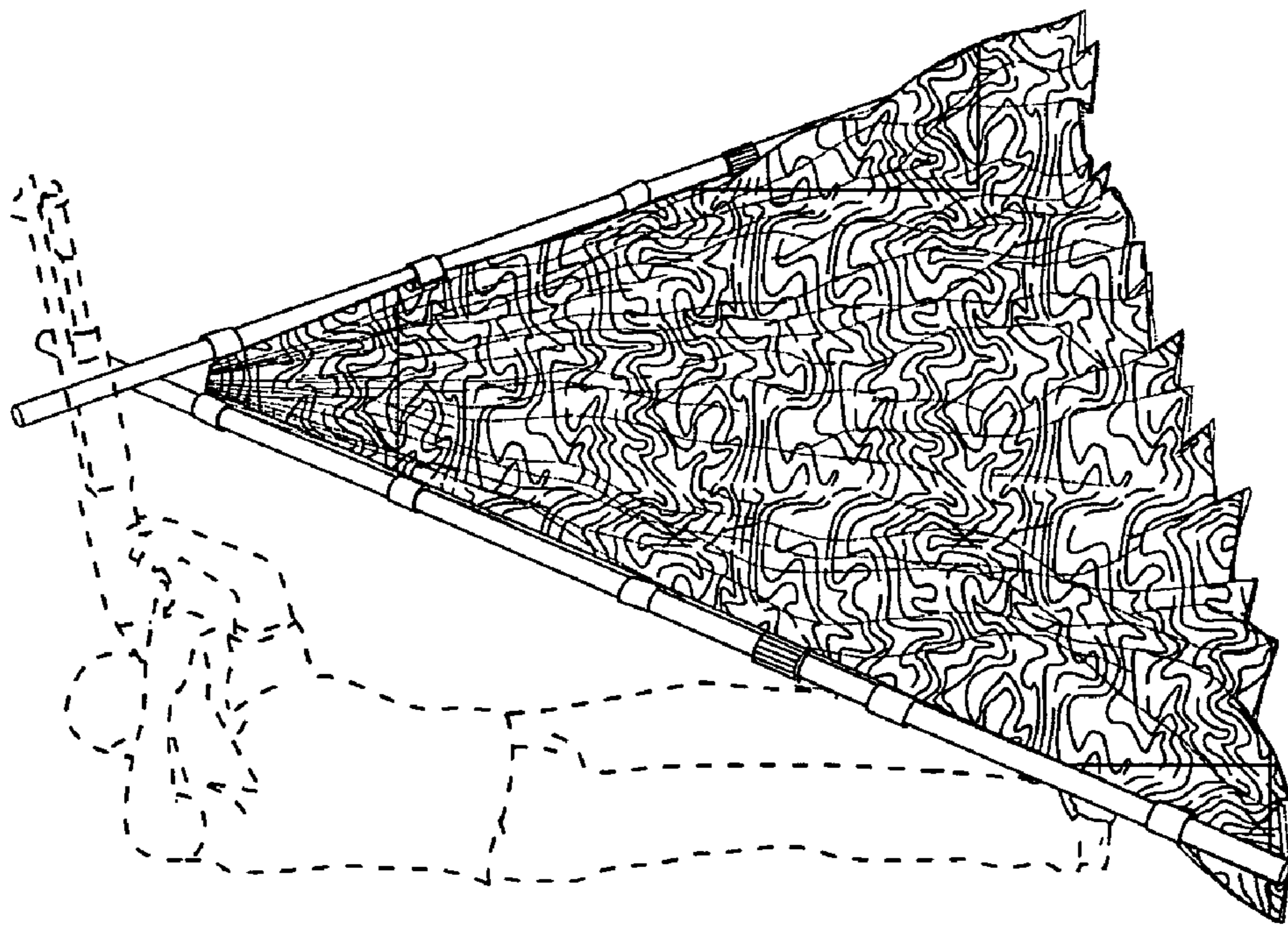

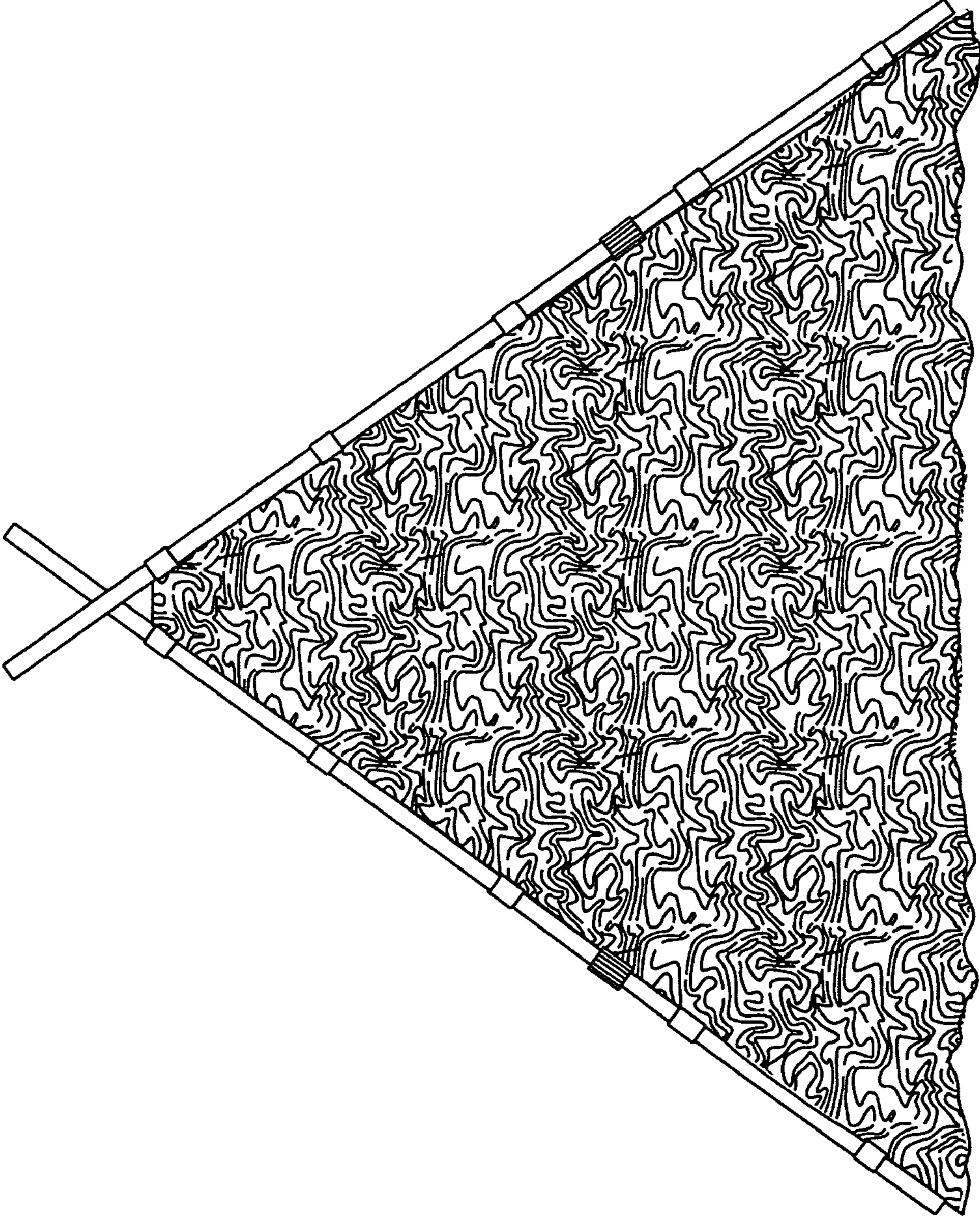

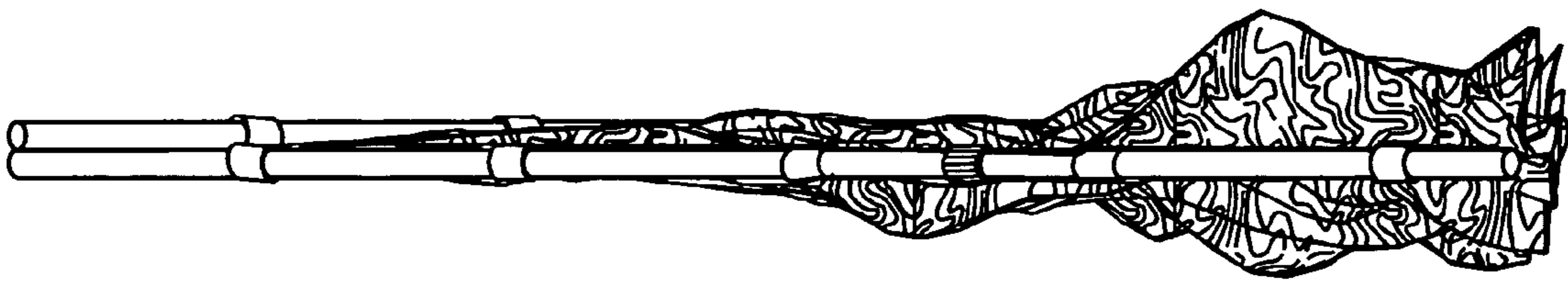

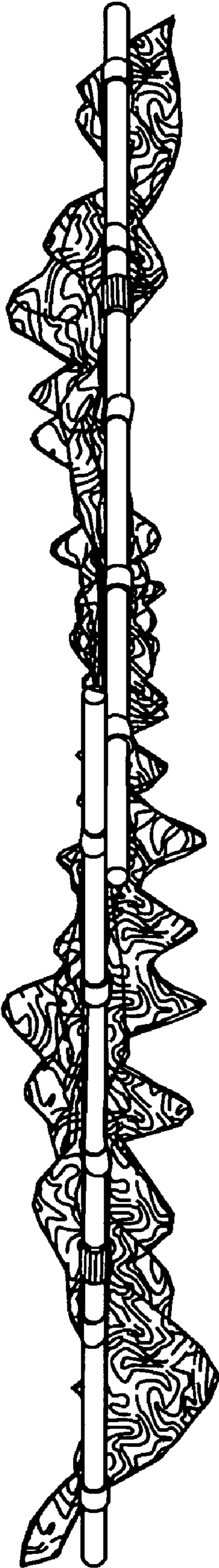
