The ornamental design for a feline tube toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a feline tube toy according to a preferred embodiment of the present invention;

FIG. 7 is a bottom plan view thereof;

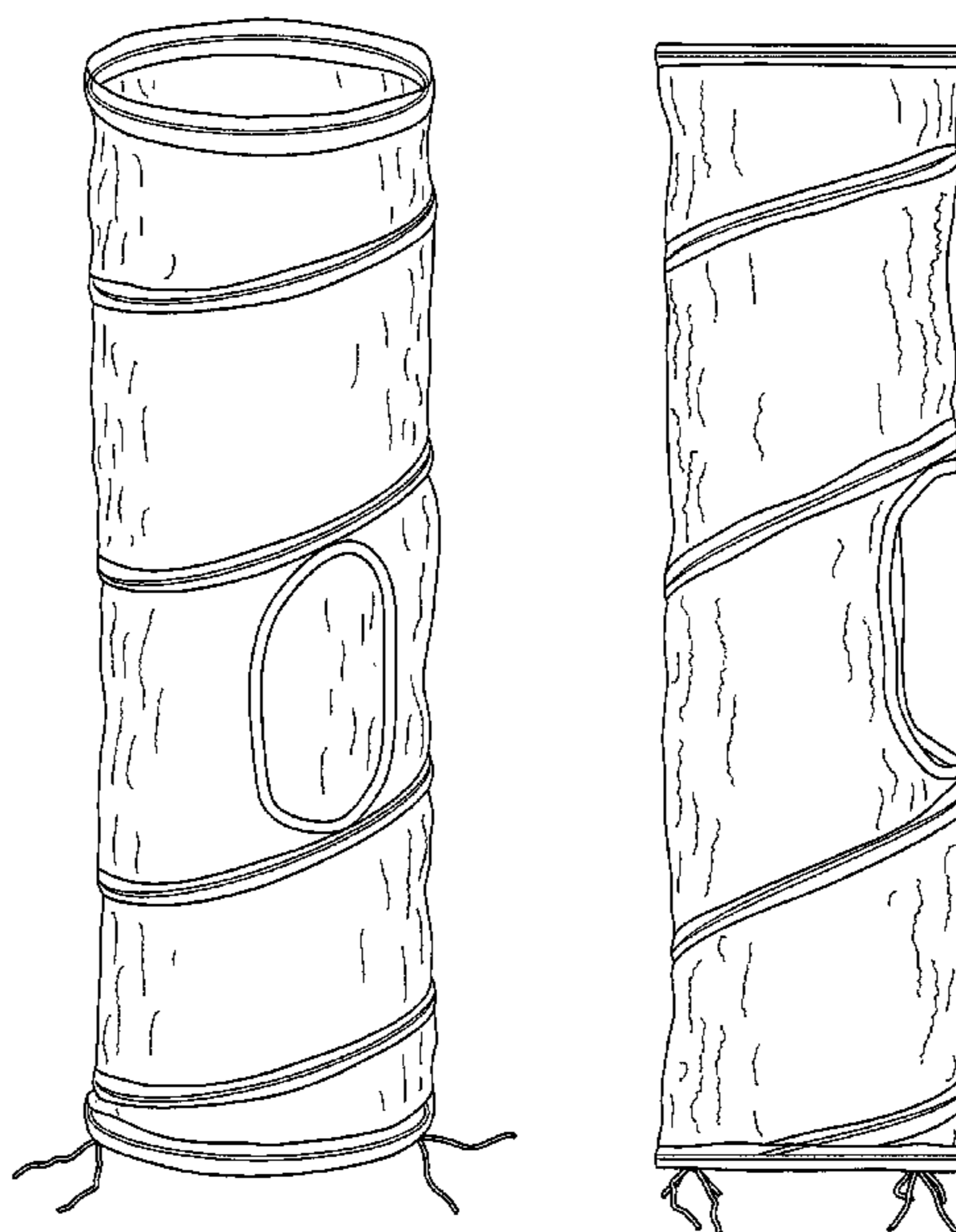
FIG. 8 is a top plan view of the feline tube toy when compressed for storage;

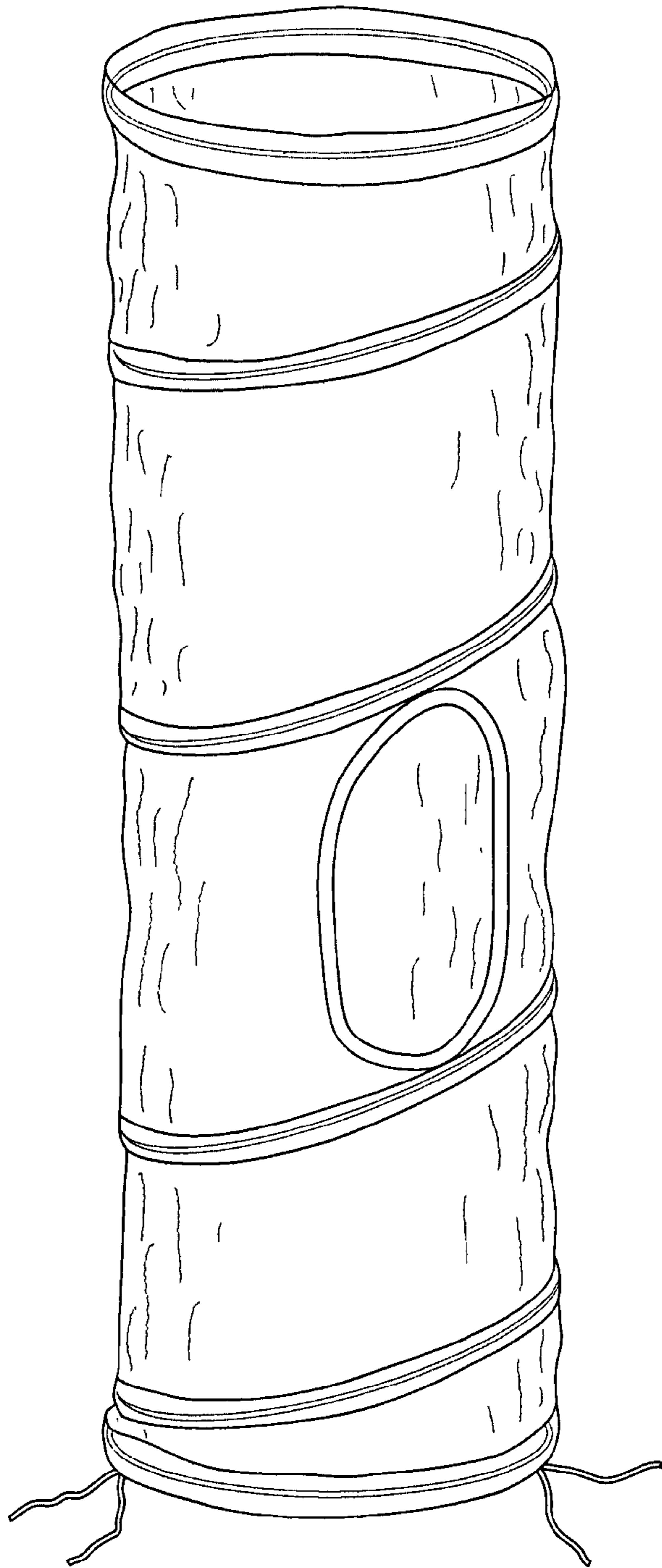

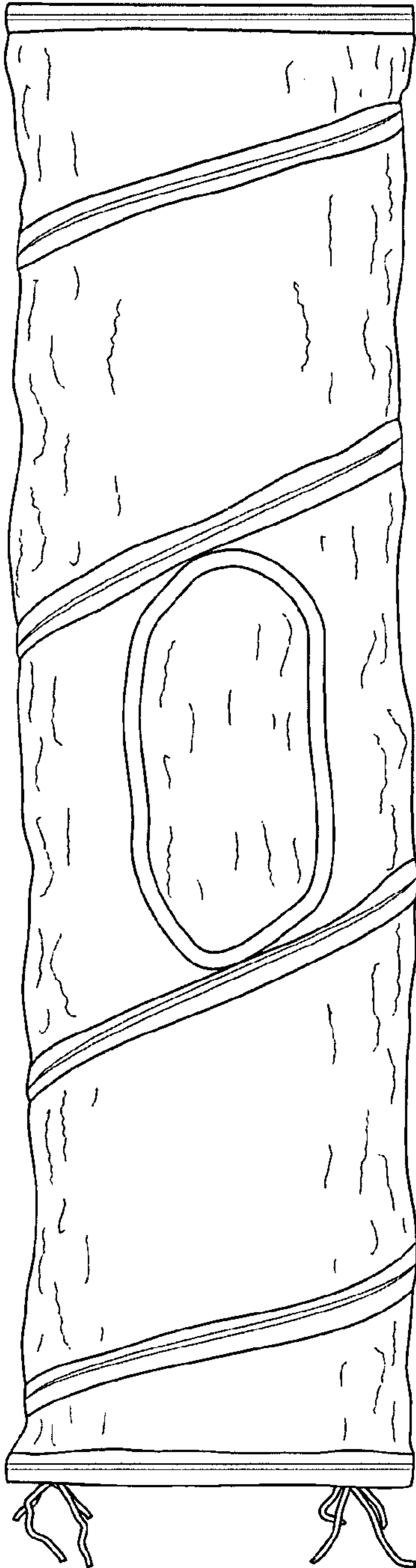

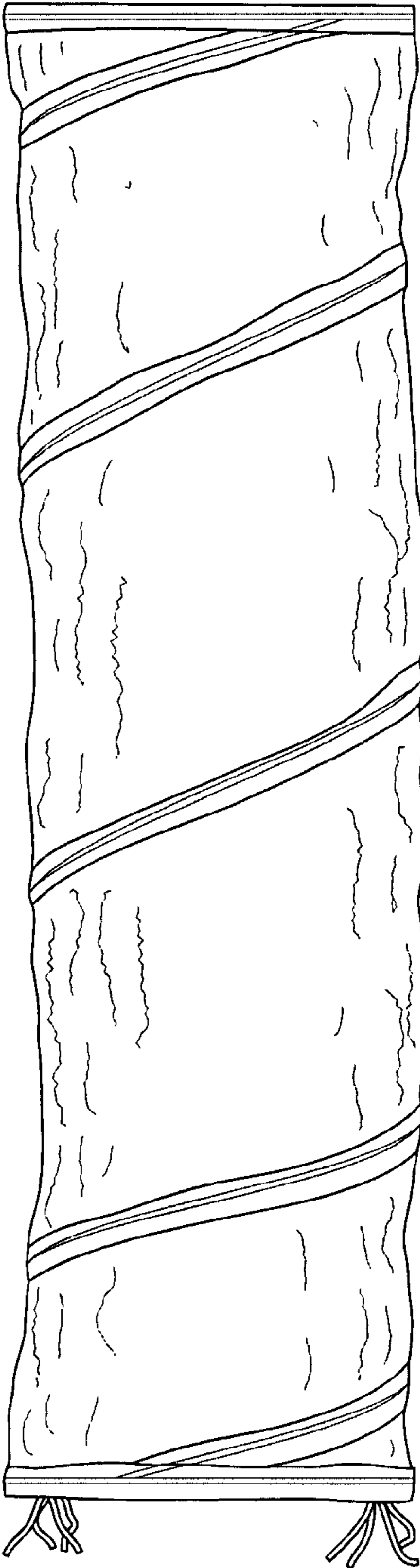

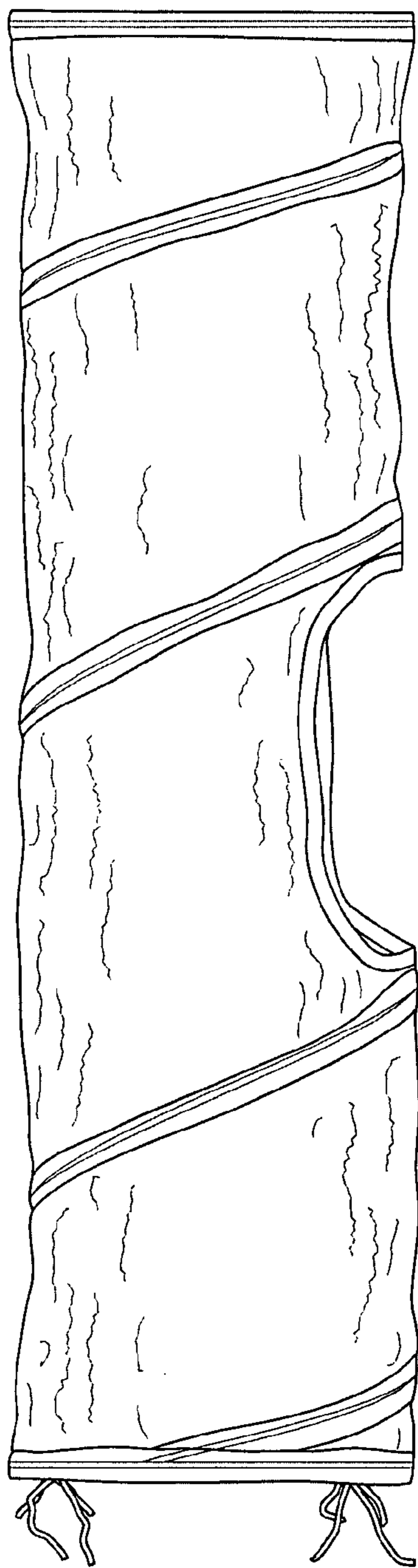

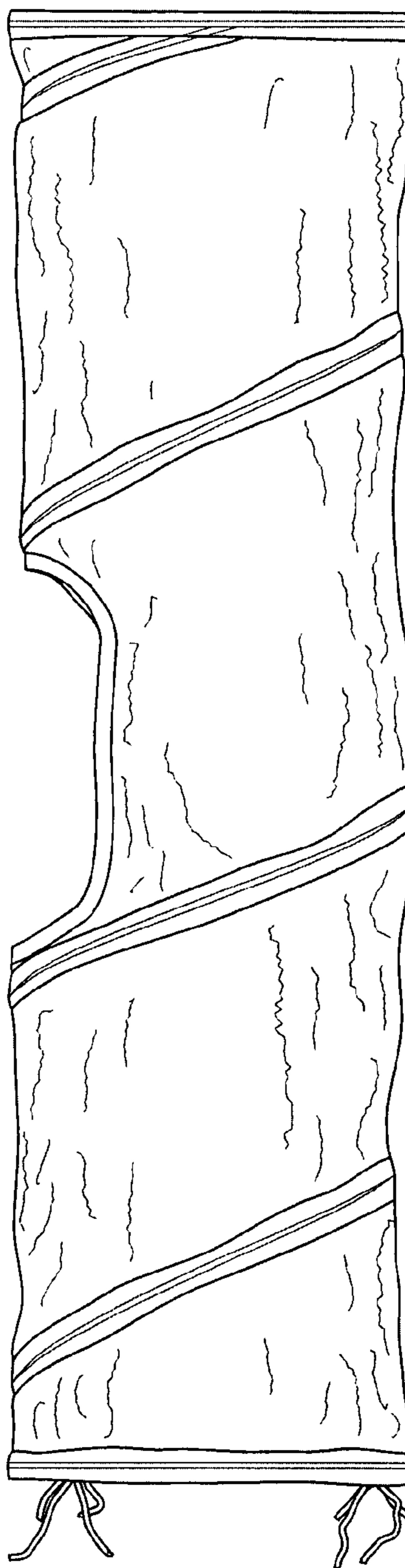

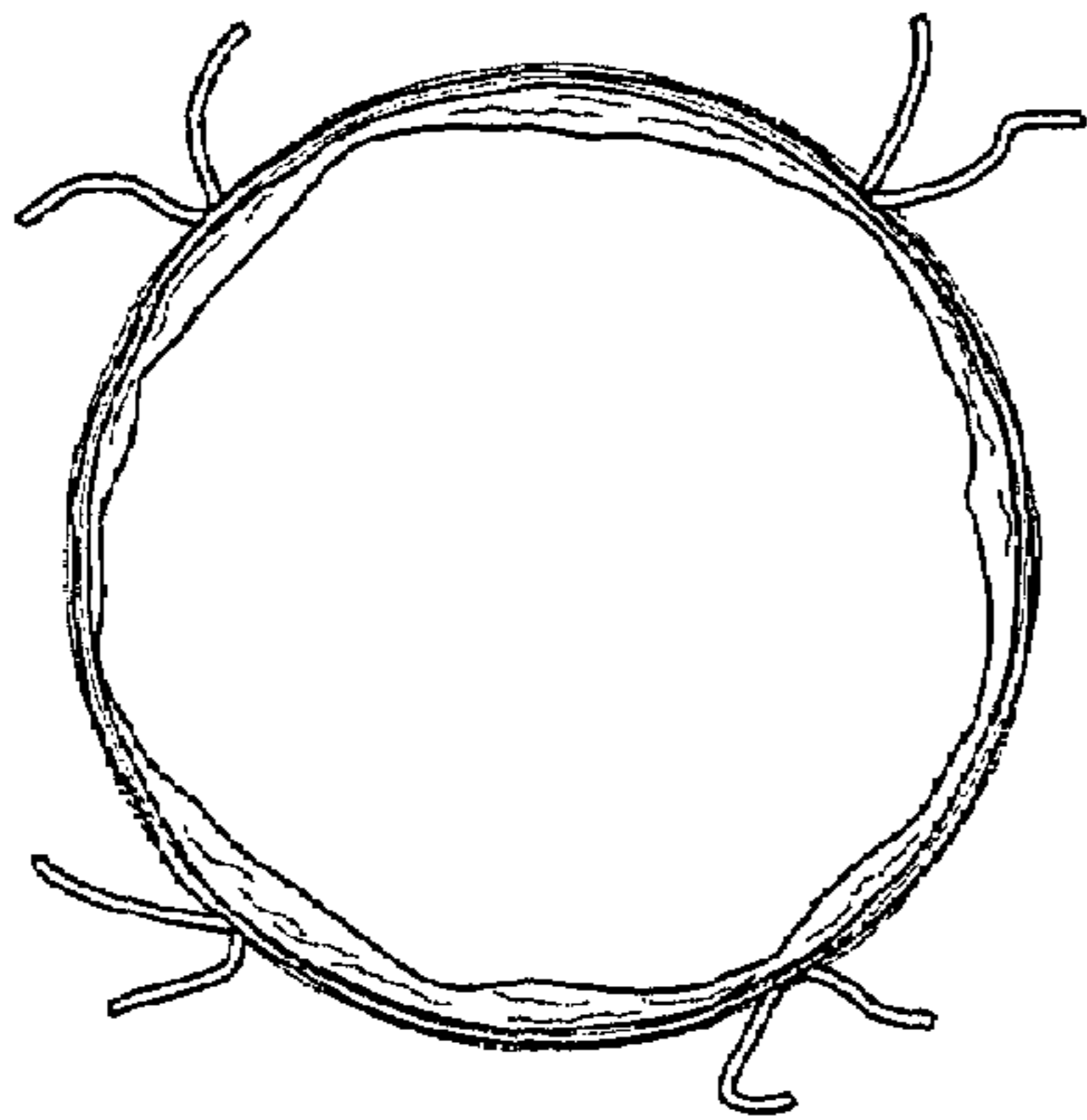

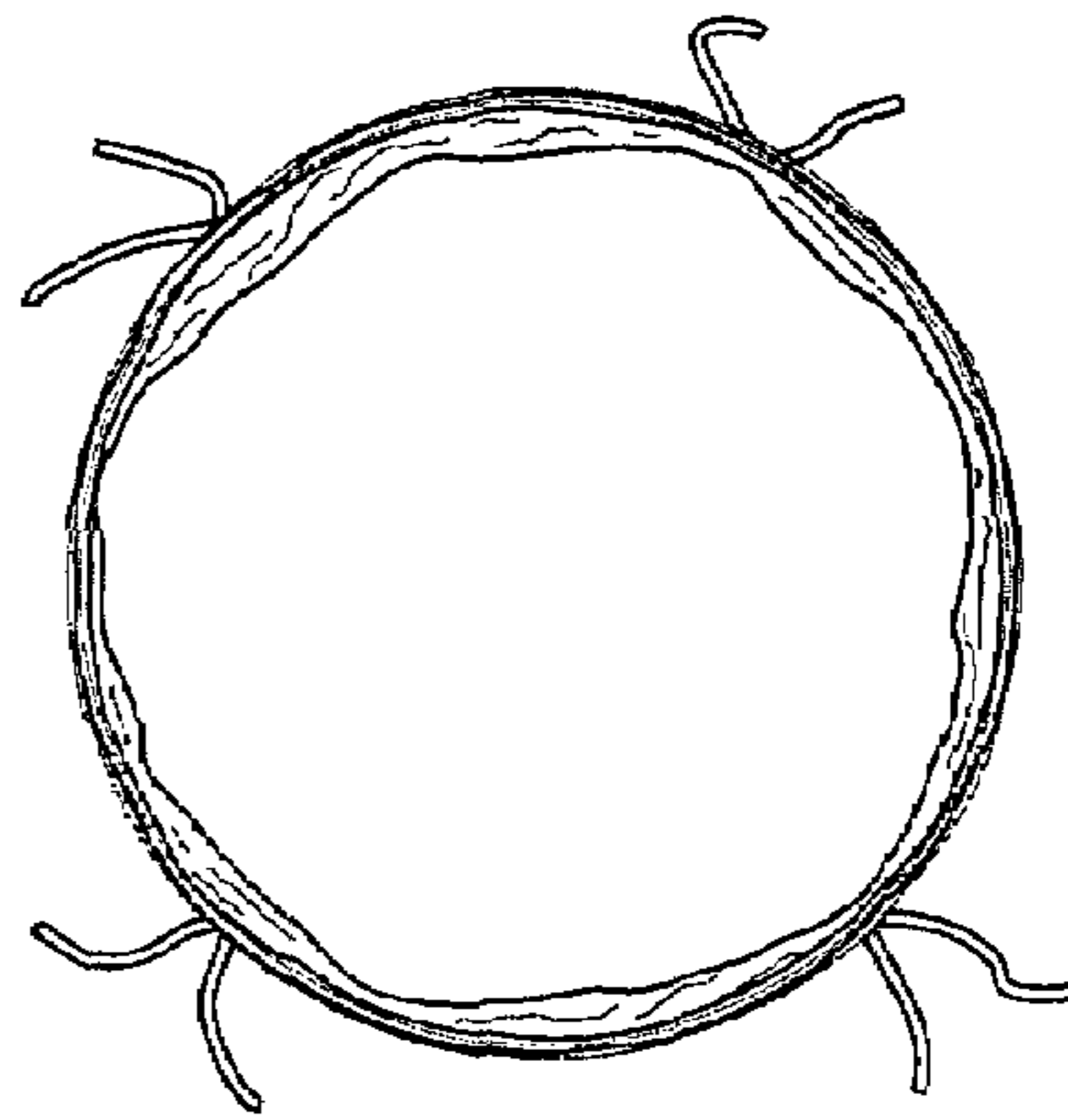

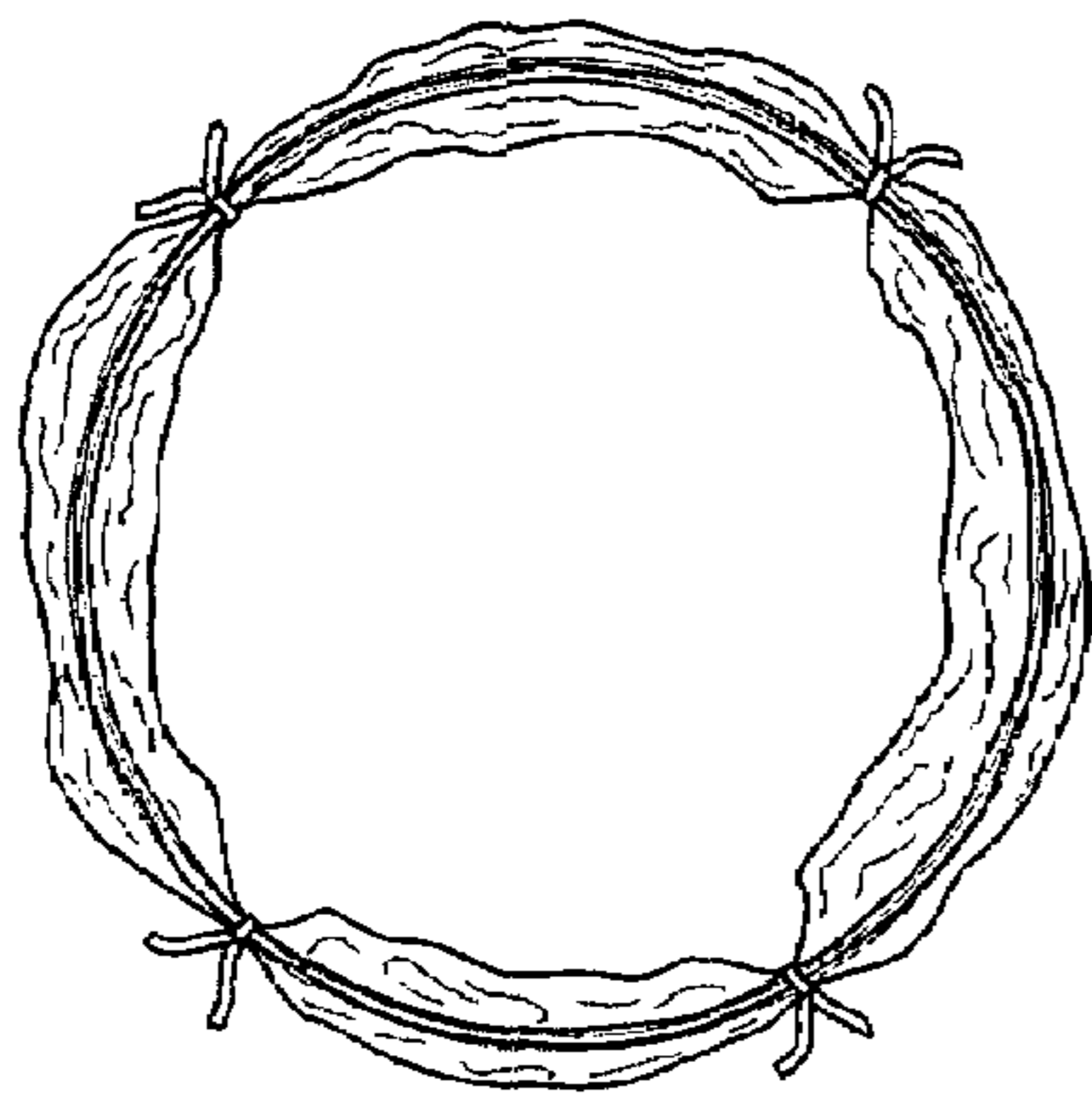

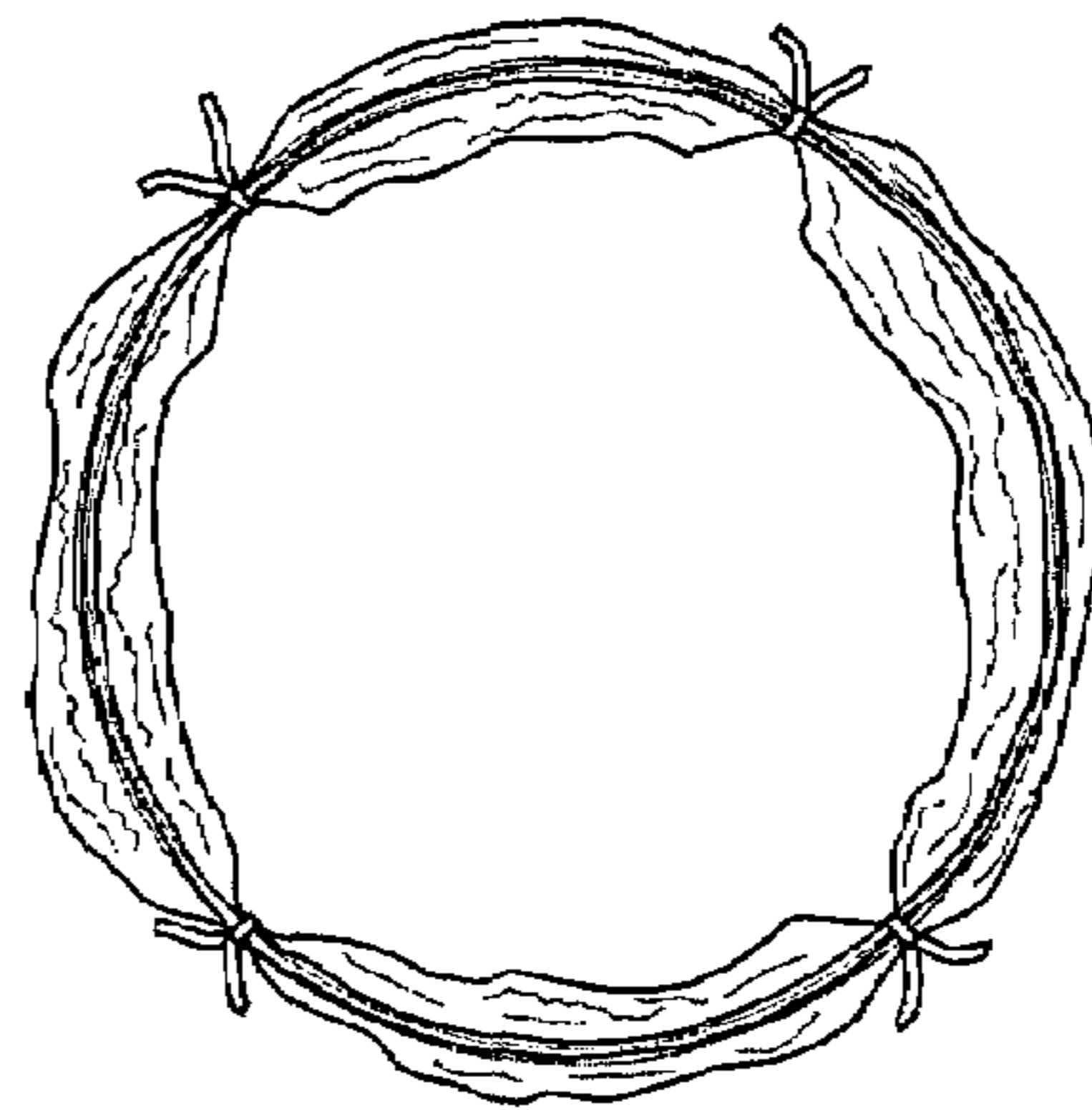

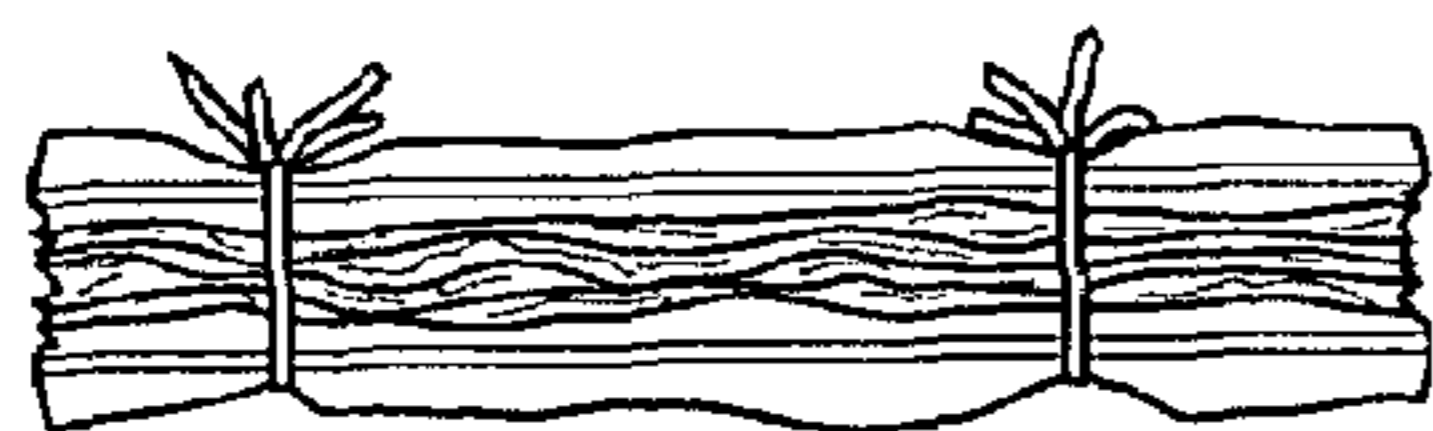

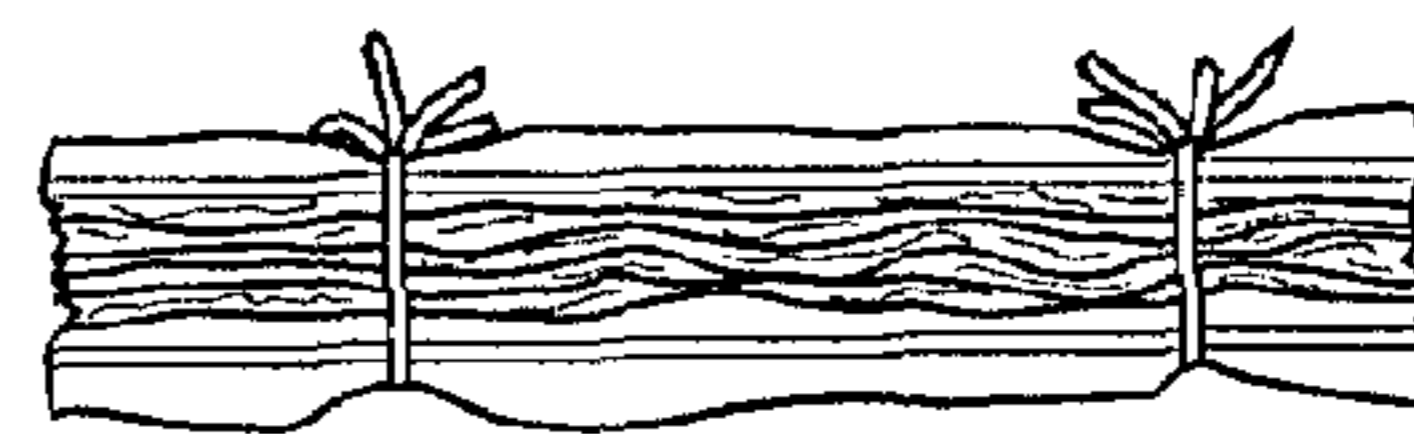
