(57) **CLAIM**

The ornamental design for a combination hat and helmet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the design;

FIG. 2 is a front elevation view of the design, the opposing rear side view of the design being identical thereto and therefore not illustrated;

FIG. 3 is a right side elevation view of the design, the opposing left side view of the design being identical thereto and therefore not illustrated;

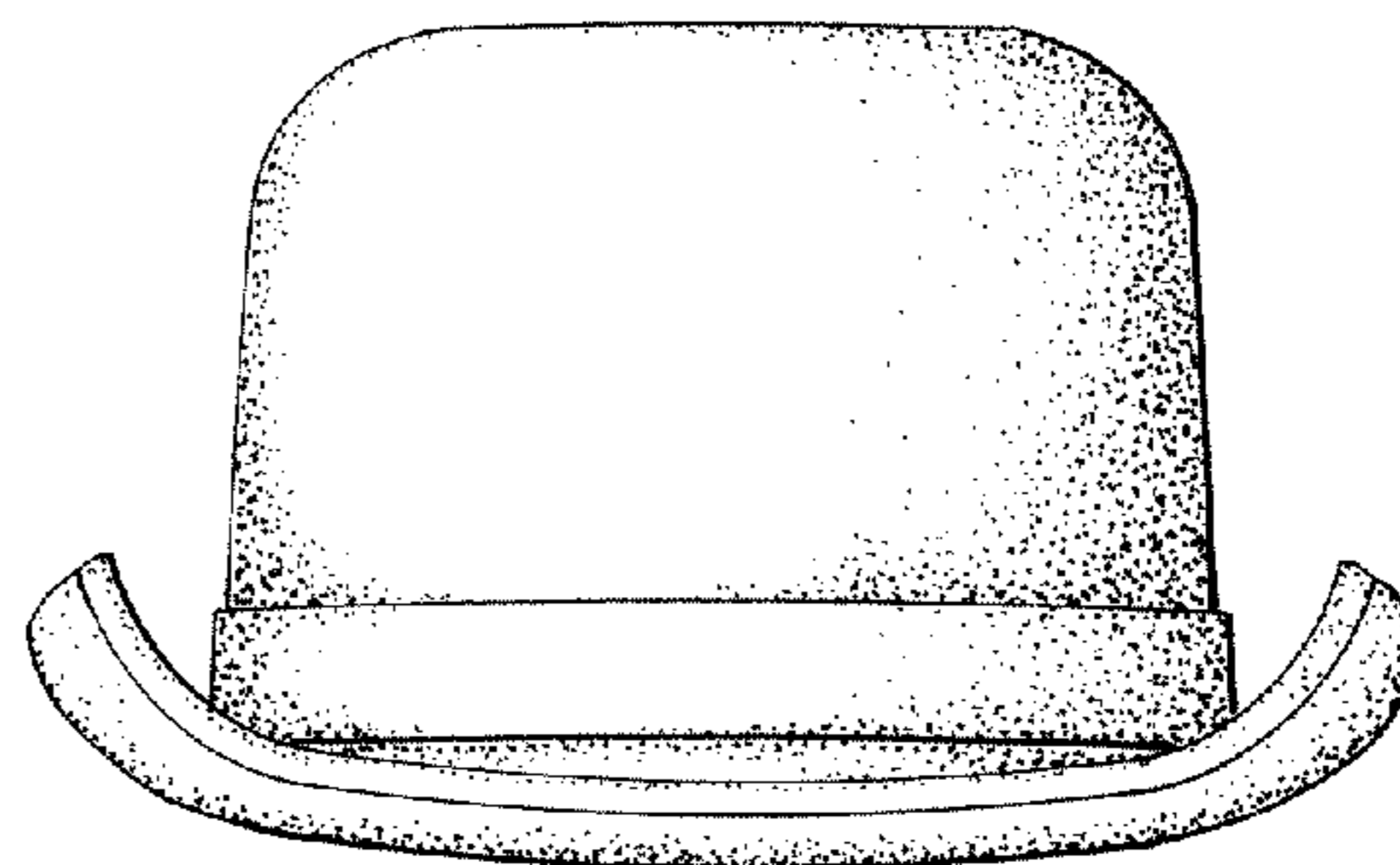
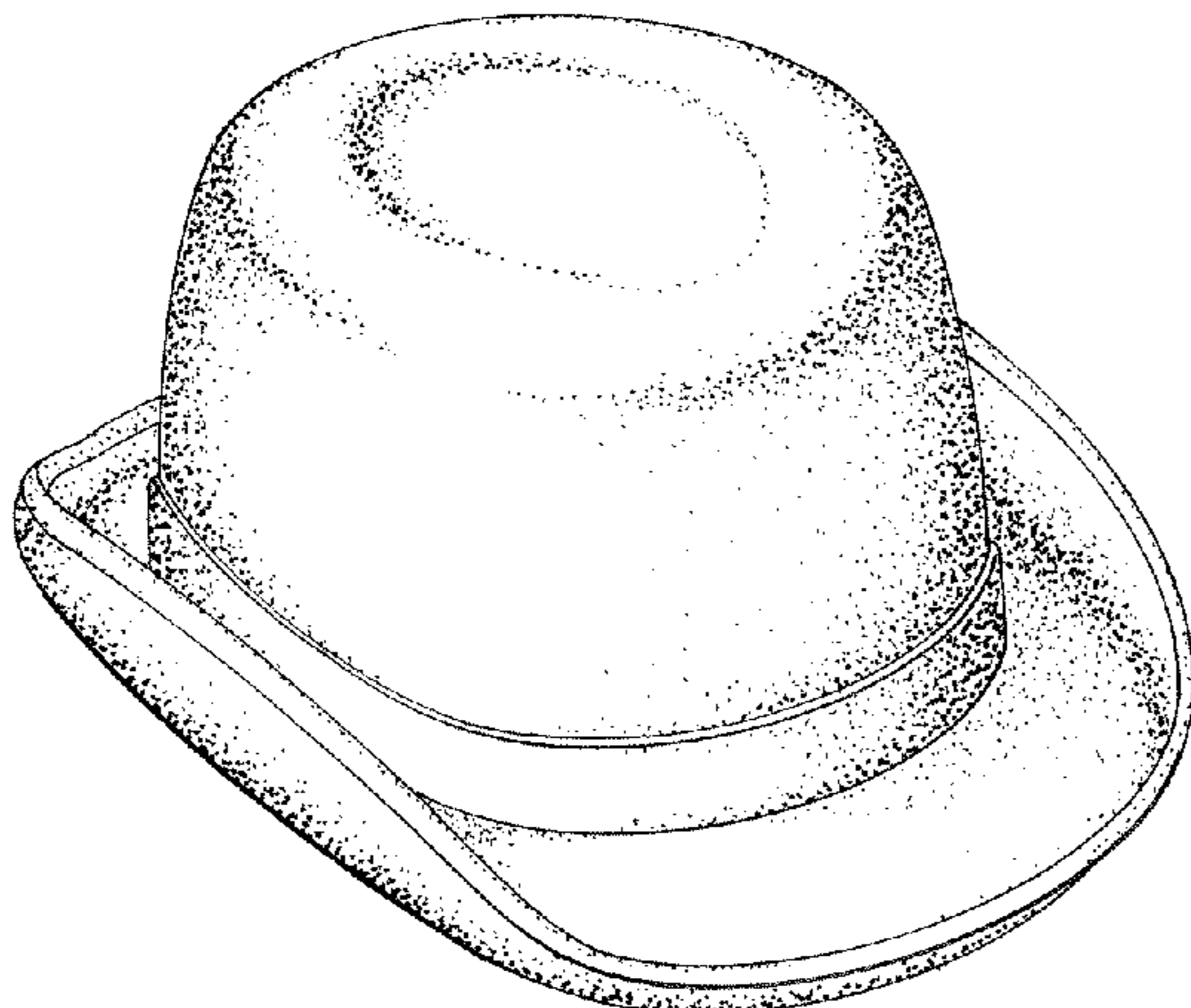
FIG. 4 is a bottom view of the design; and,

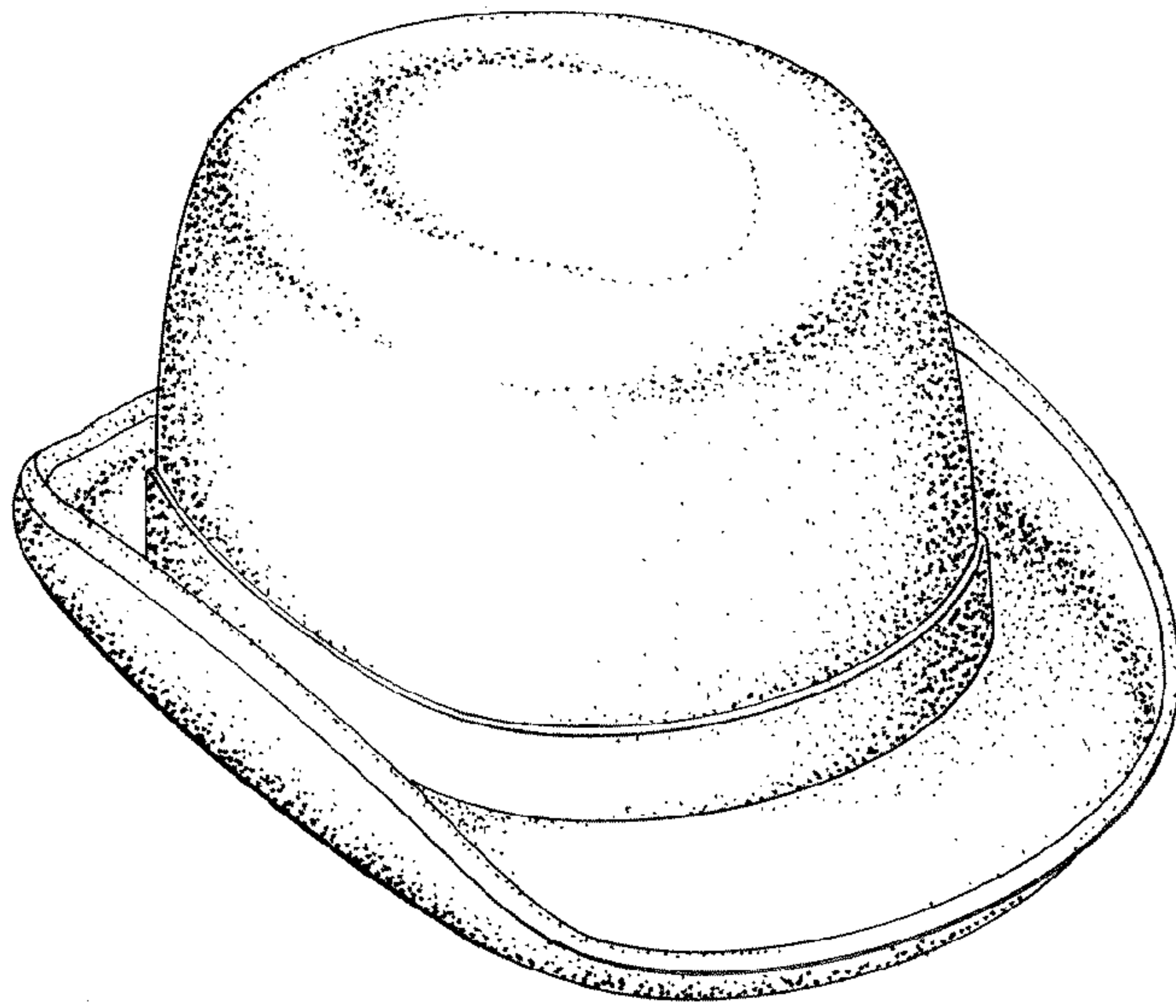

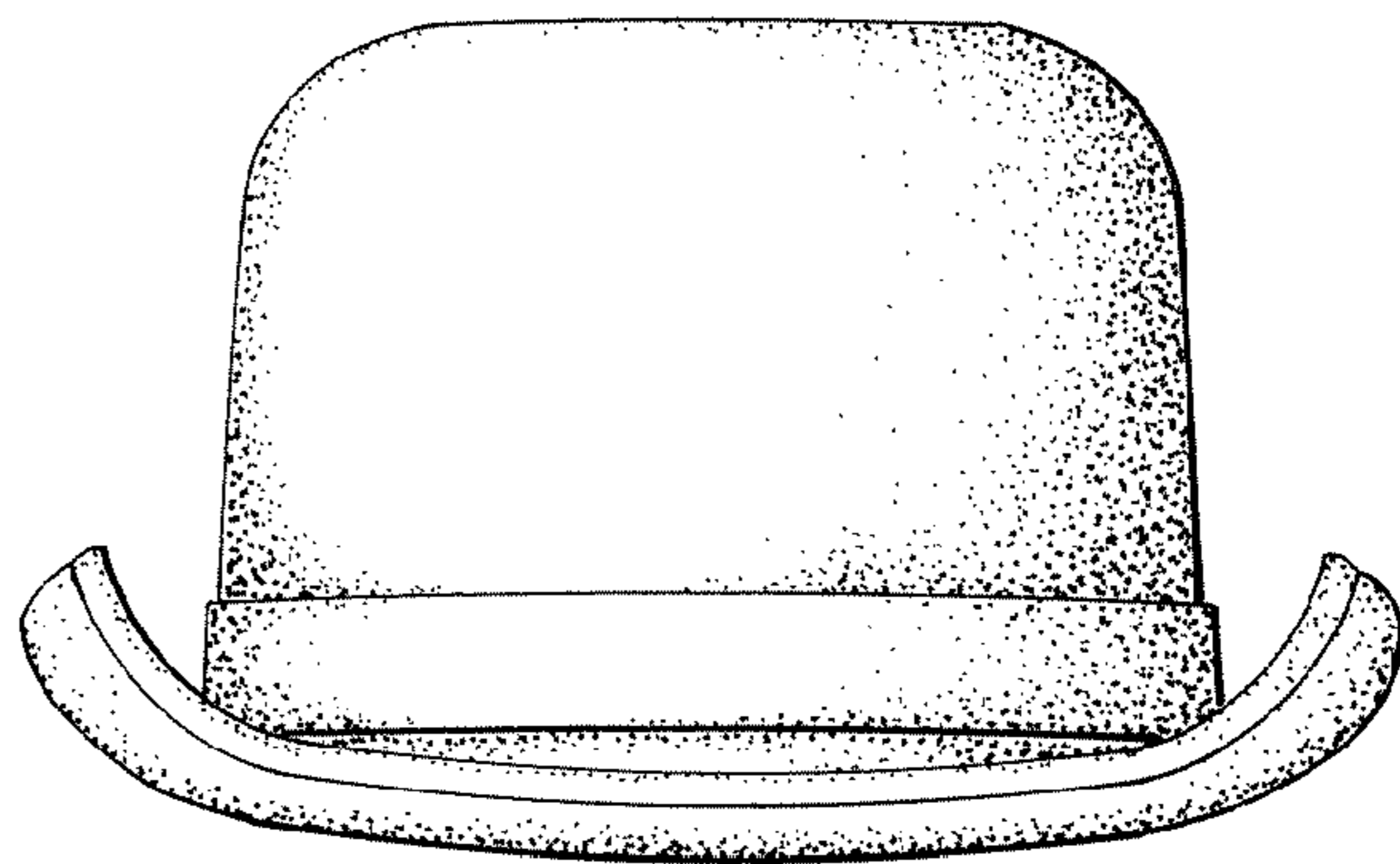

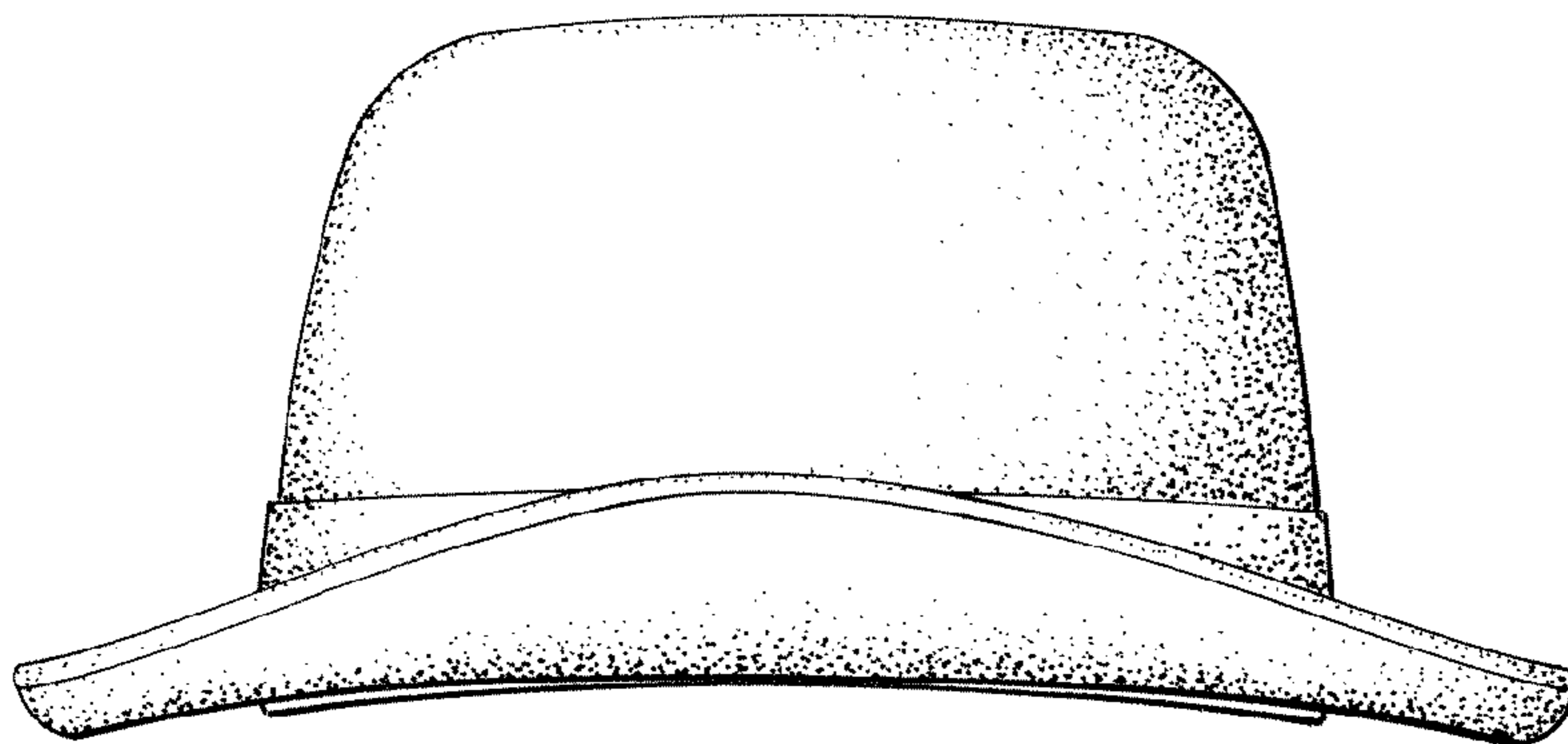

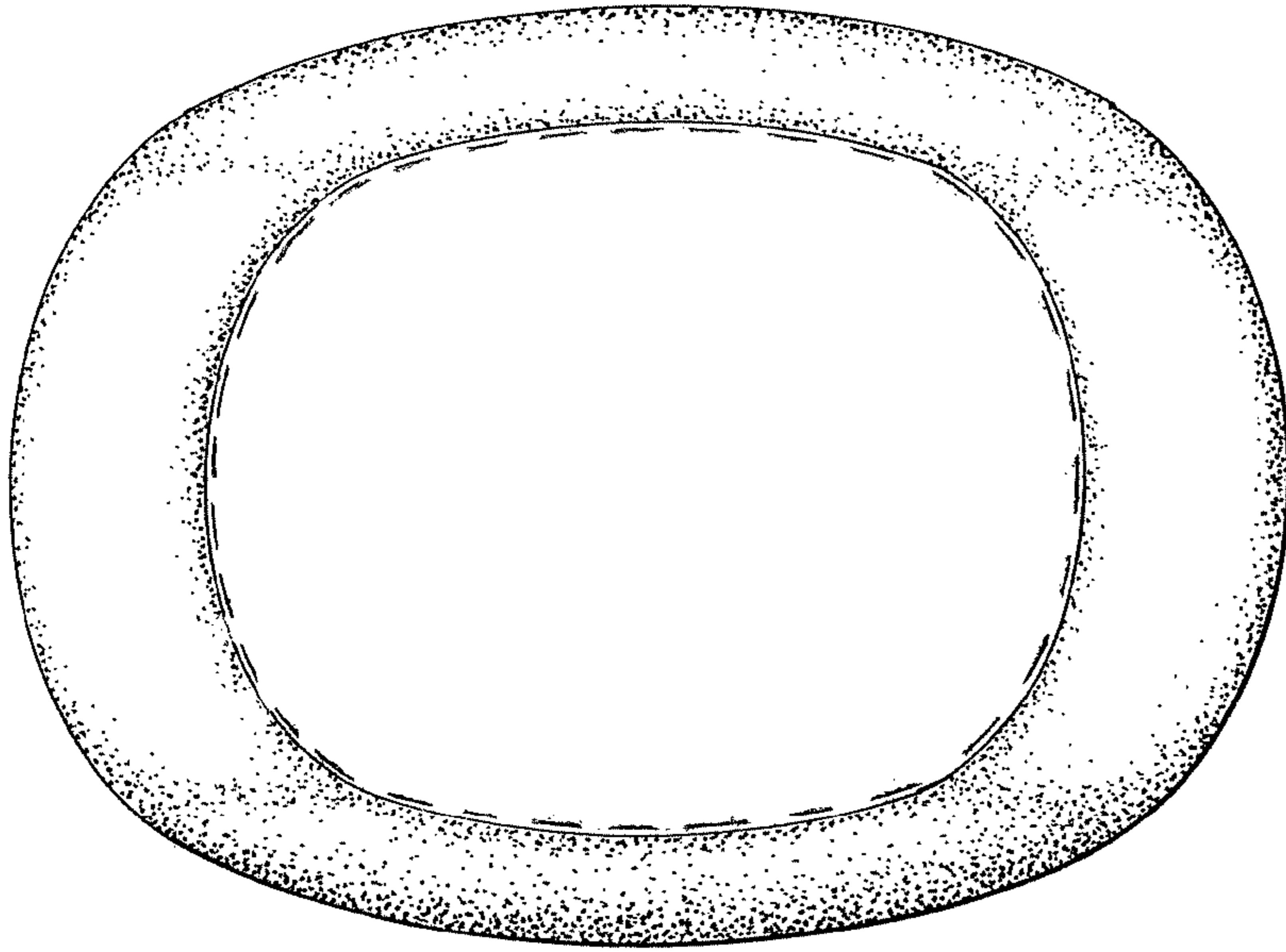
