(57) **CLAIM**

We claim the ornamental design for a pair of shoe soles, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the left component of a pair of shoe soles showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a left side view thereof;

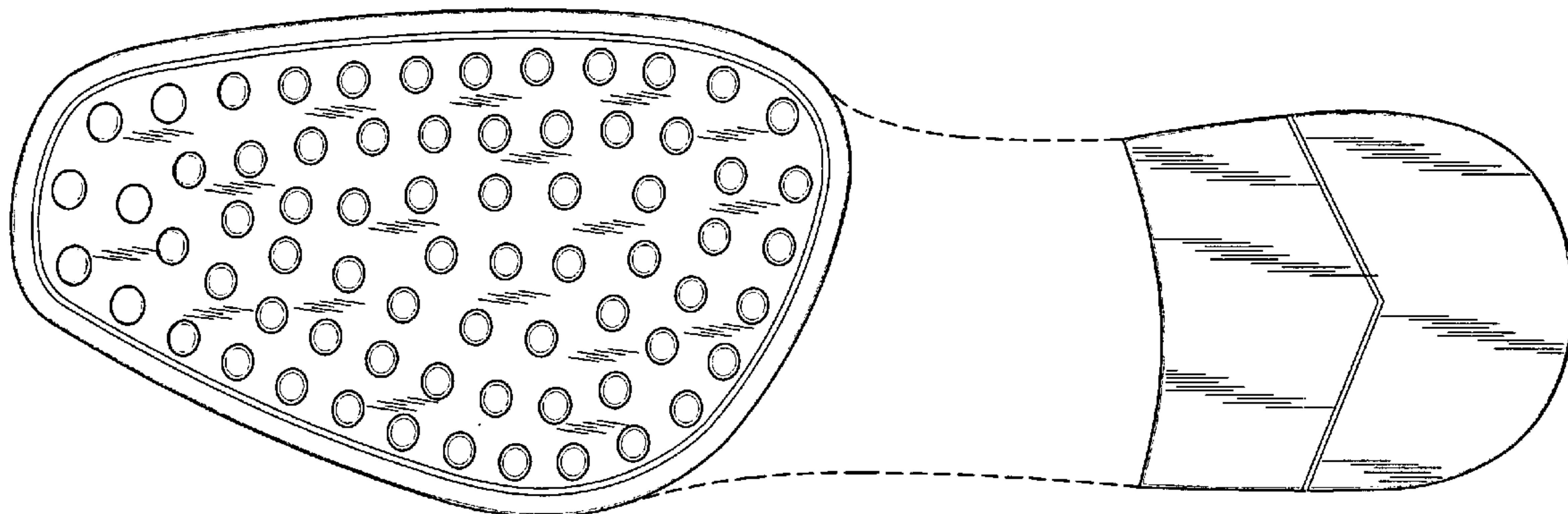
FIG. 4 is a right side view thereof; and,

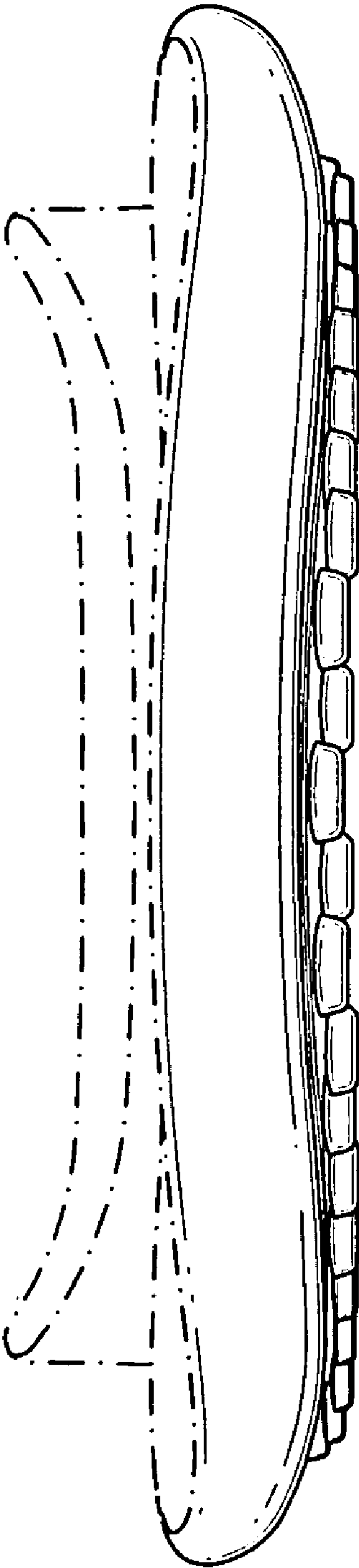
FIG. 5 is a bottom plan view thereof.

Dot-dashed lines have been used in FIGS. 1 and 2 to show the boundaries of disclaimed portions of the drawings. Dashed lines have been used throughout to depict details that are environmental only and form no part of the claimed design.

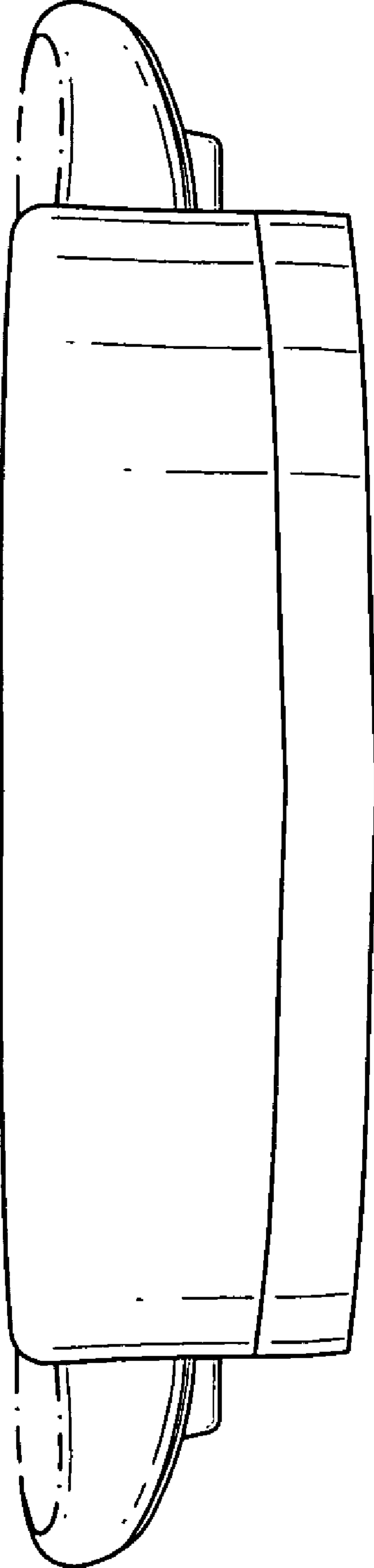

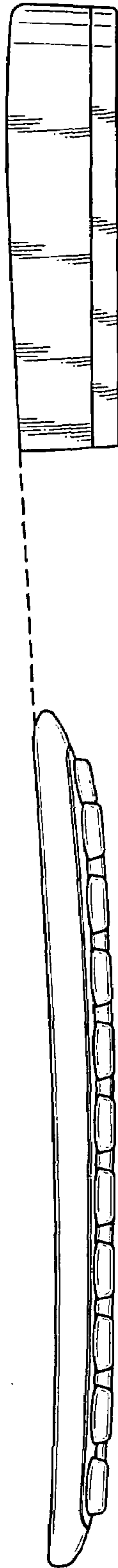
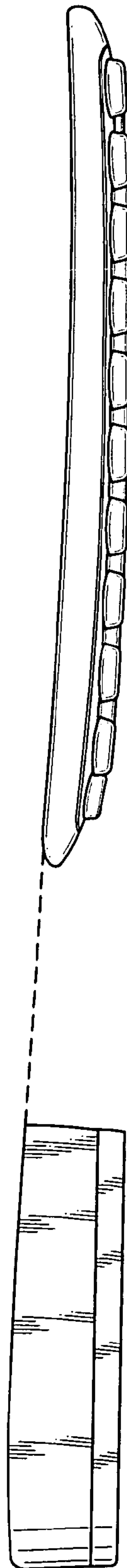

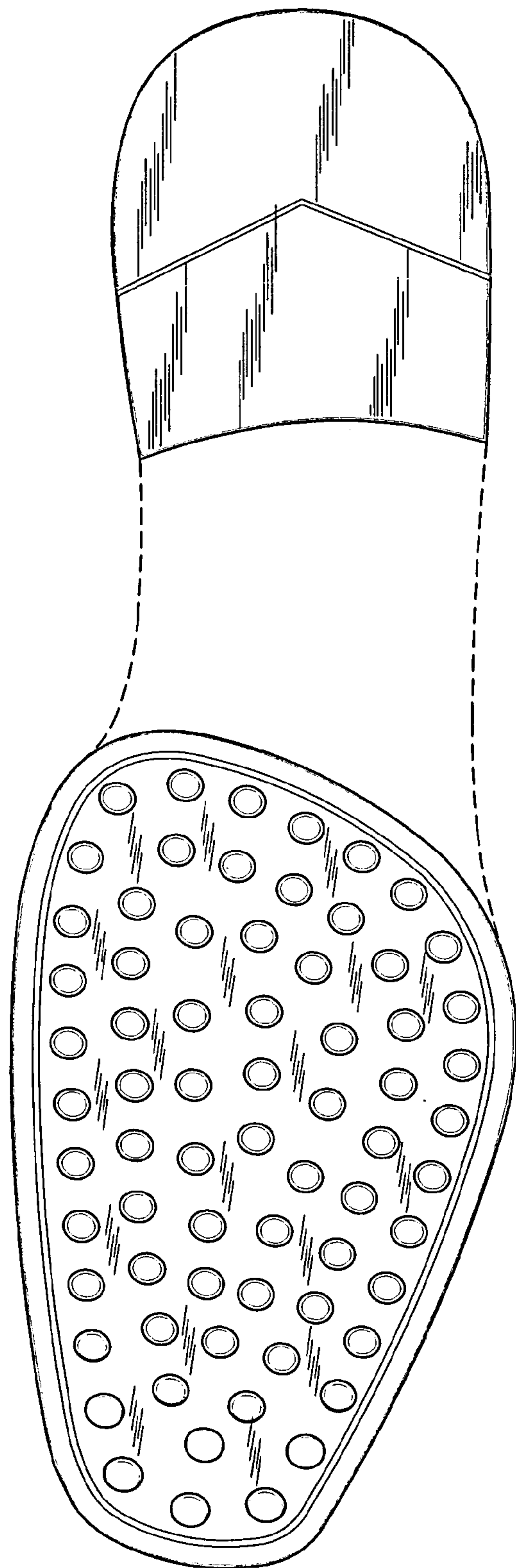
