The ornamental design of a combined cover for surface, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the combined covers for surface of my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

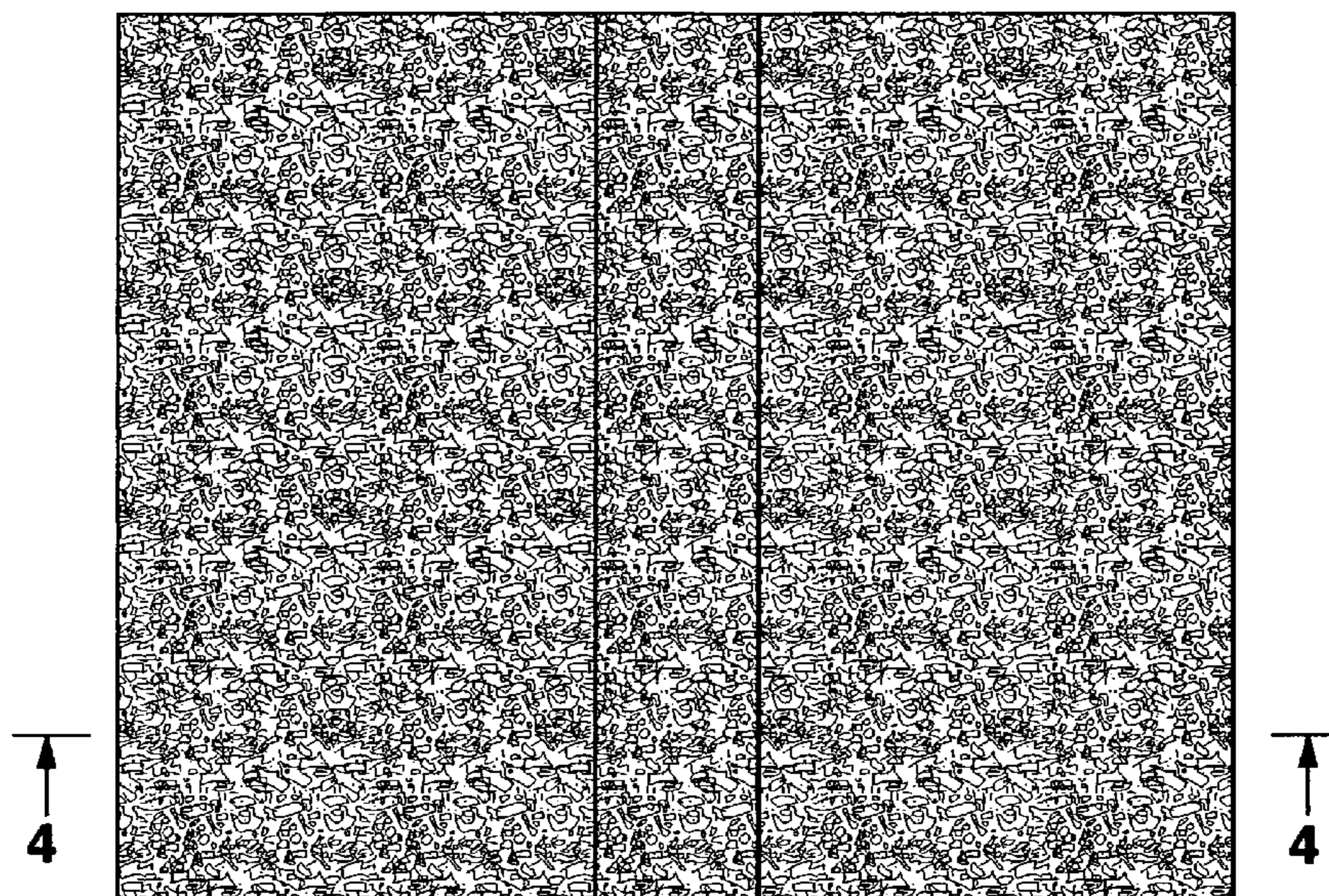
FIG. 4 is an enlarged foreshortened sectional view taken along the line 4—4 of FIG. 1;

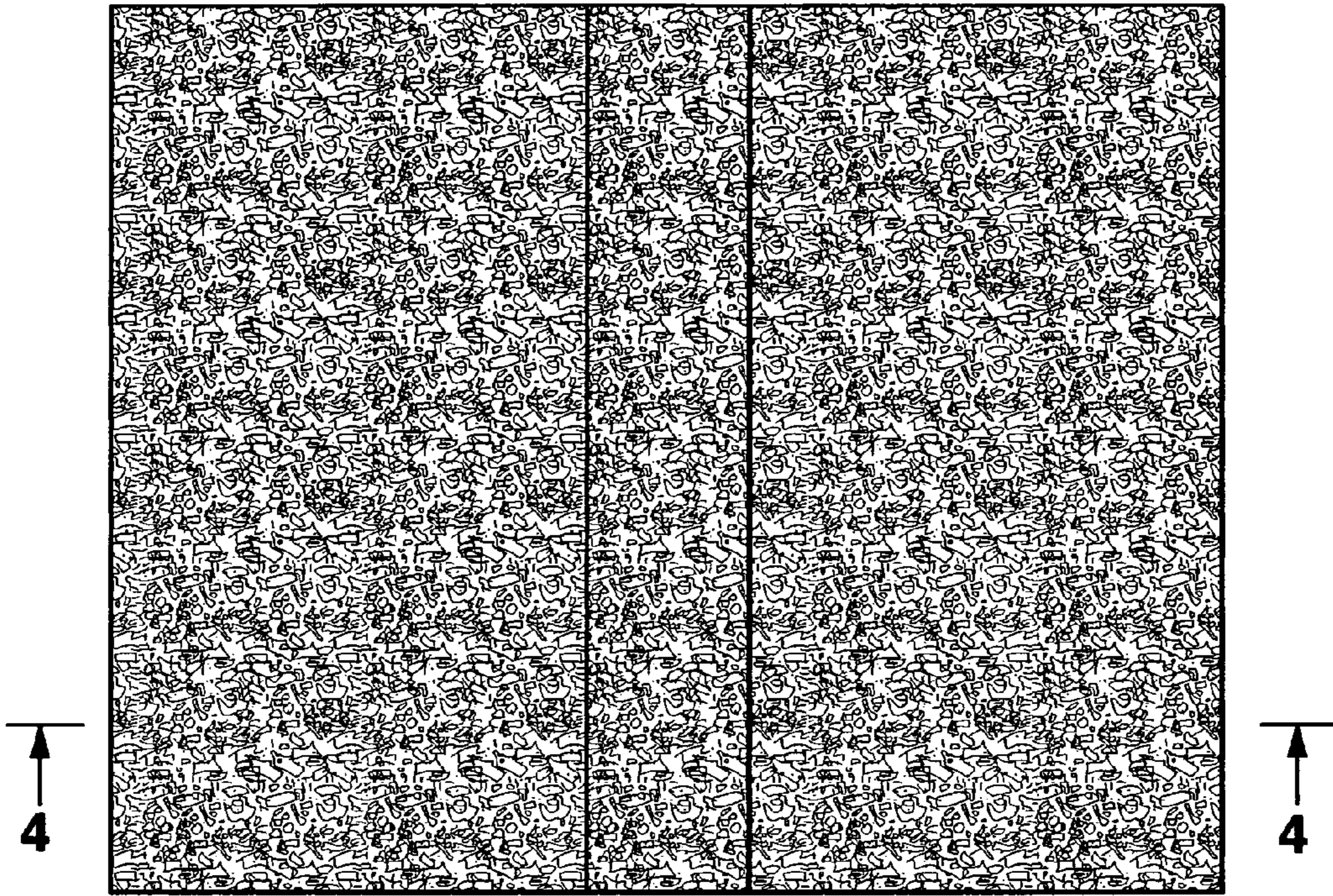

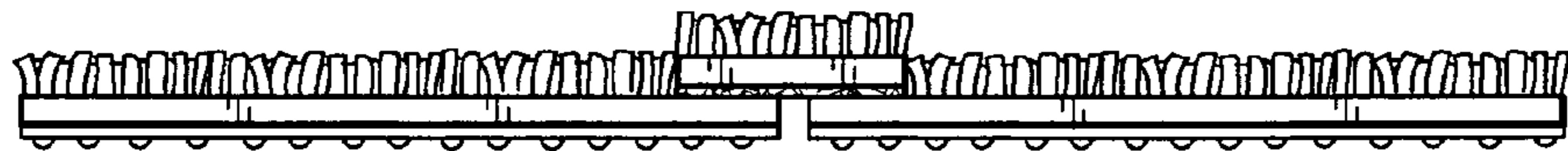

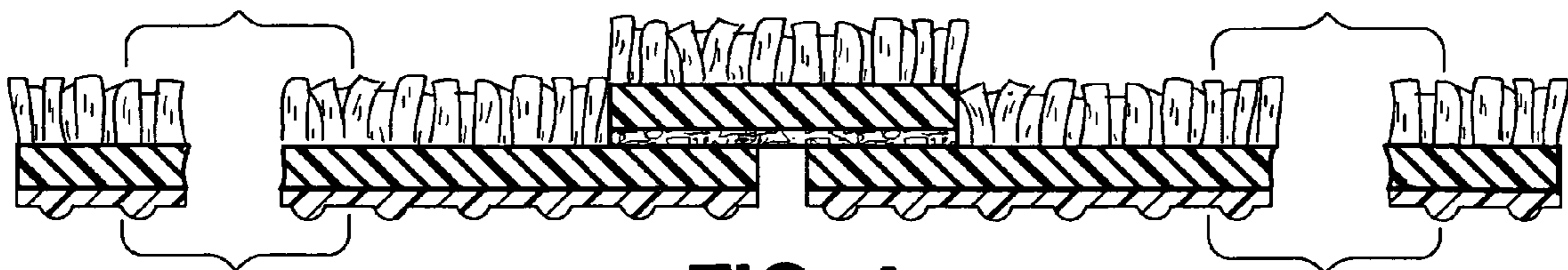
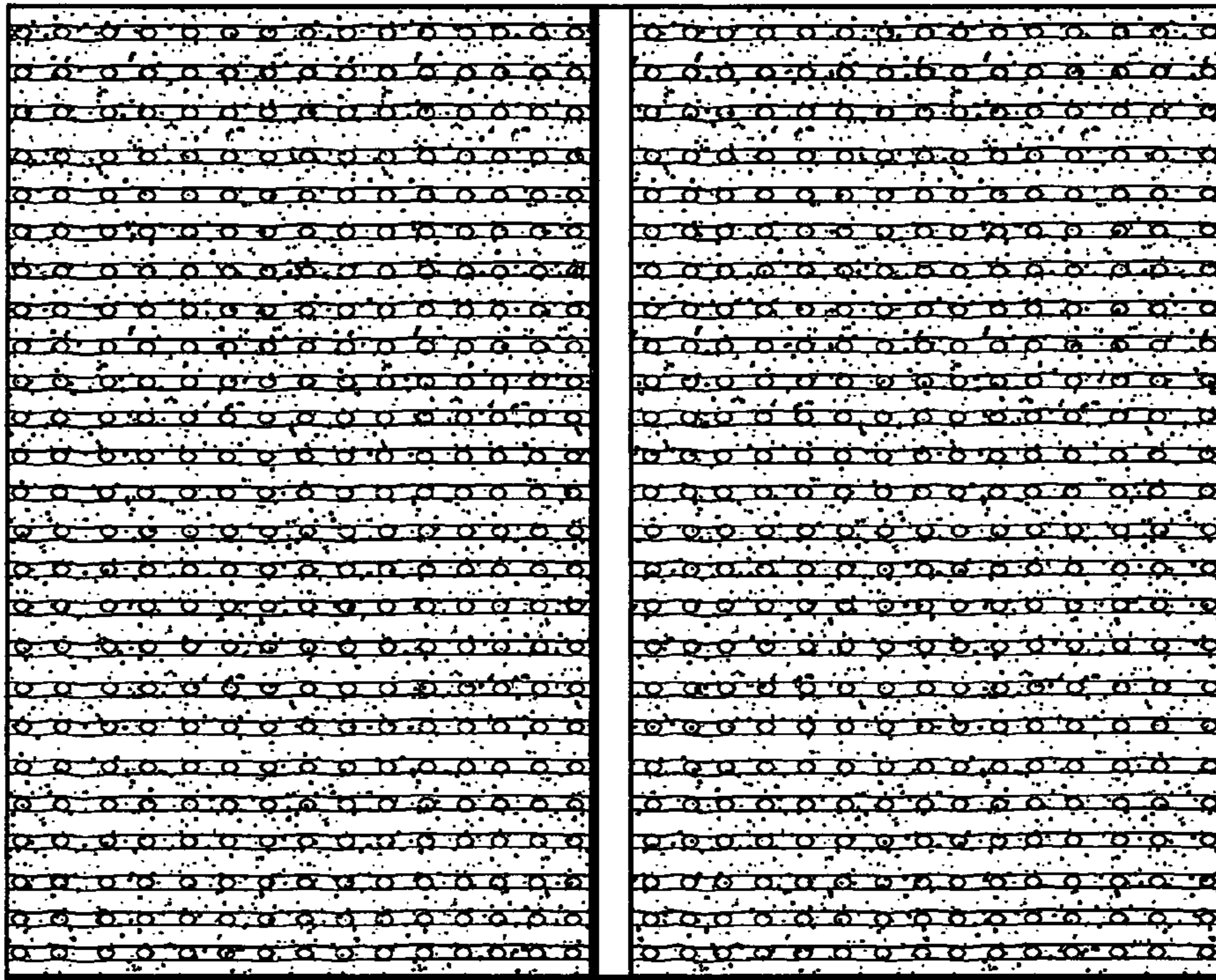
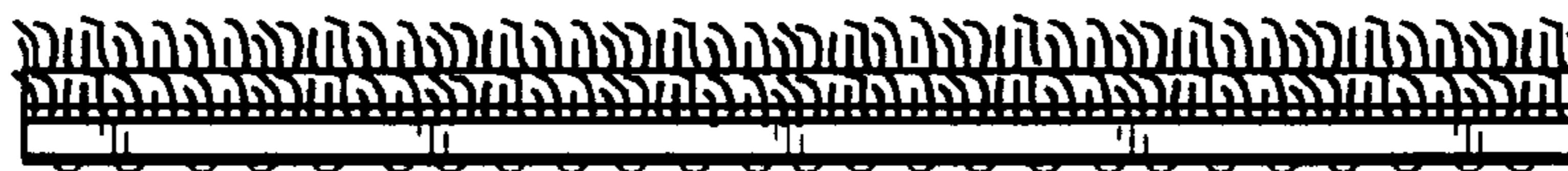

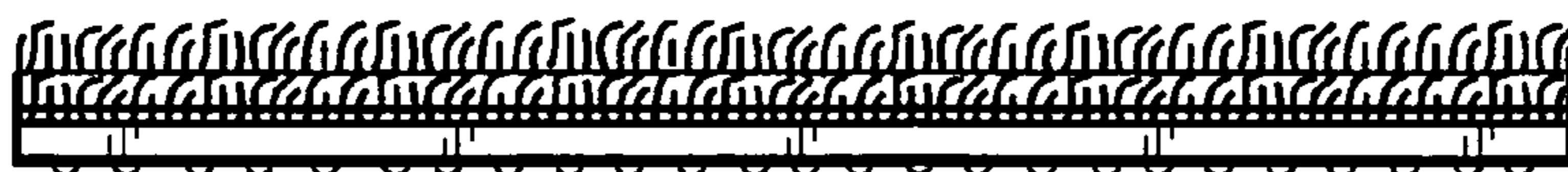
