FIG. 5 is left side view thereof.

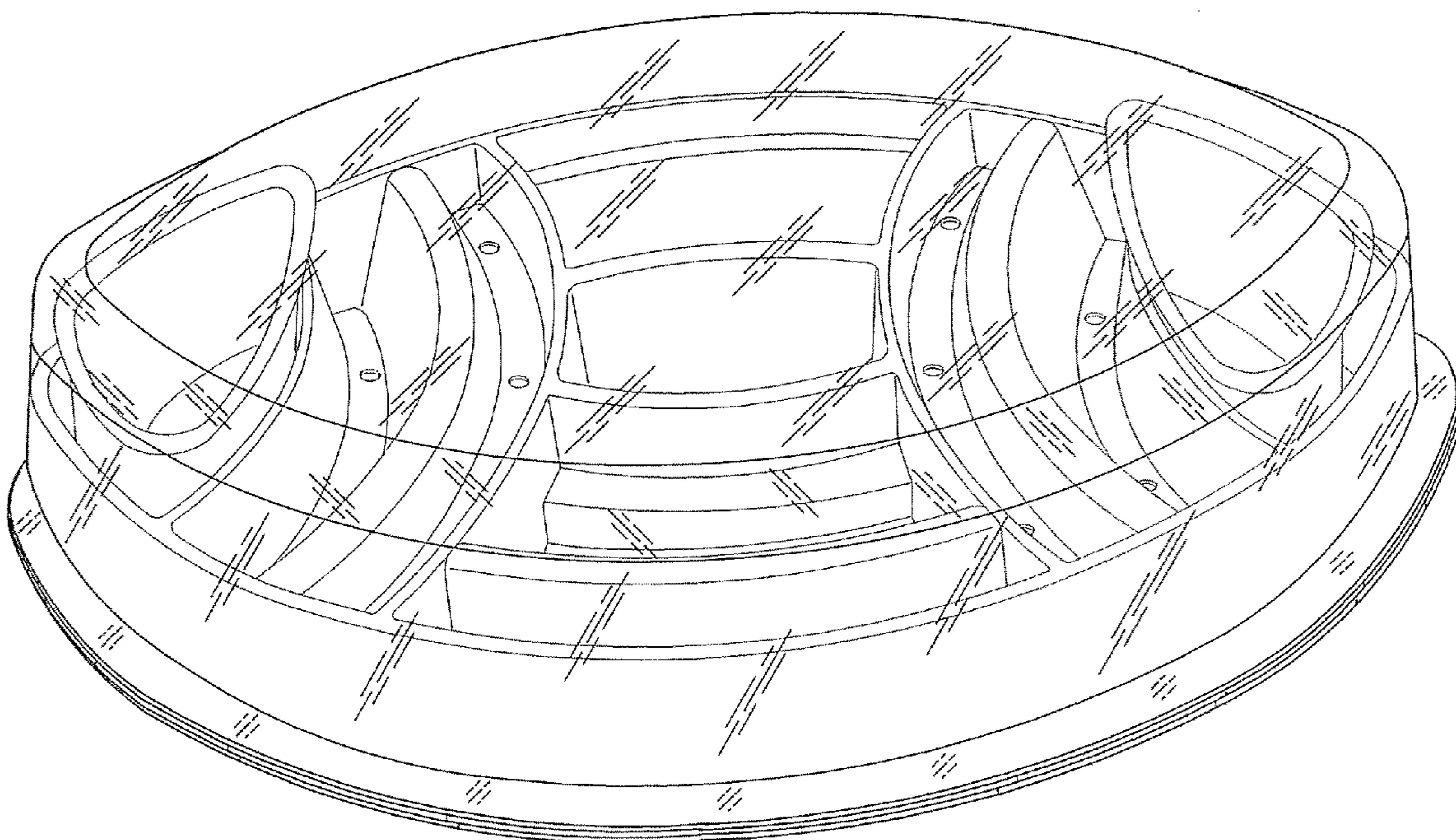
FIG. 6 is a right side view thereof;

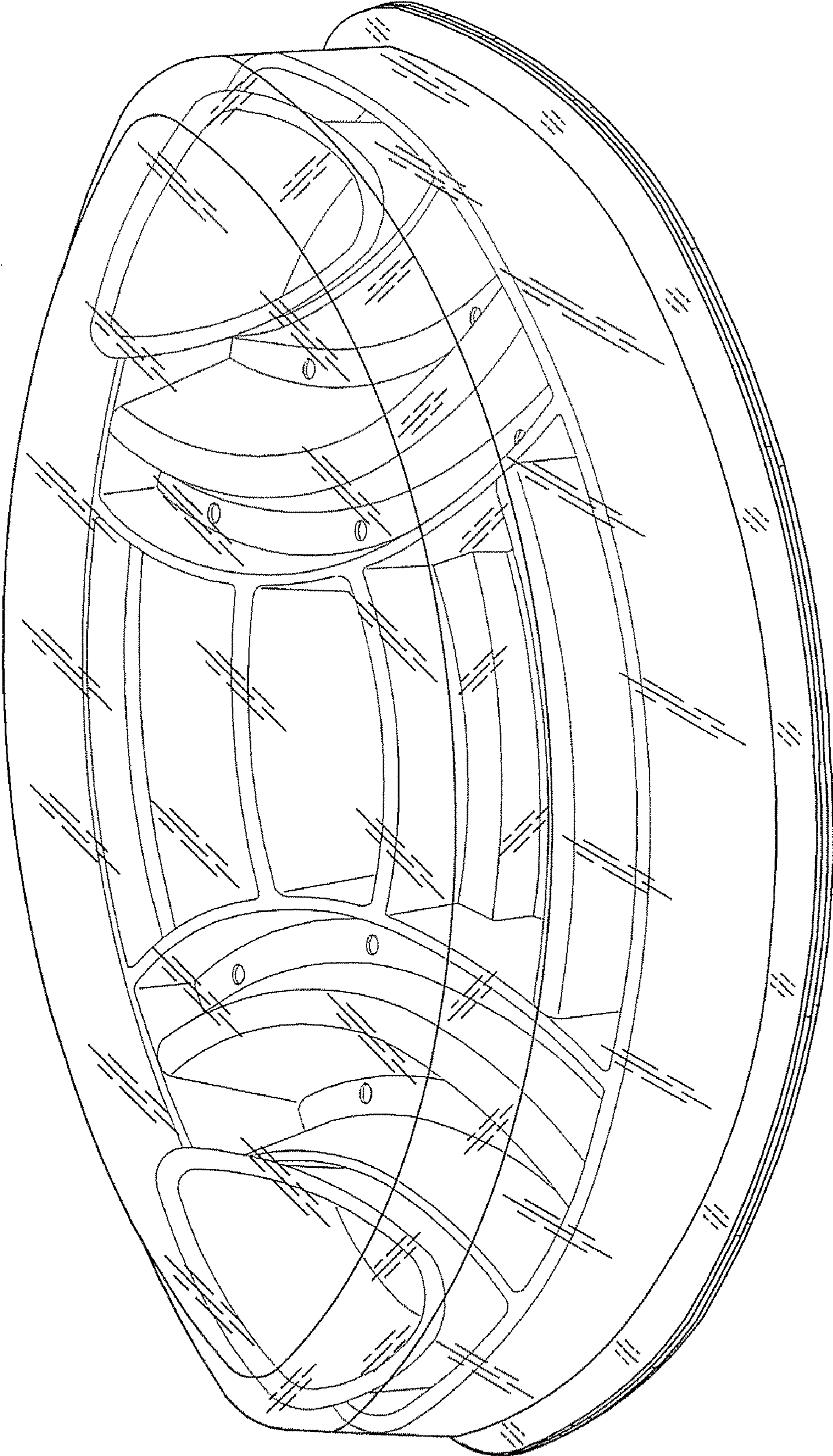

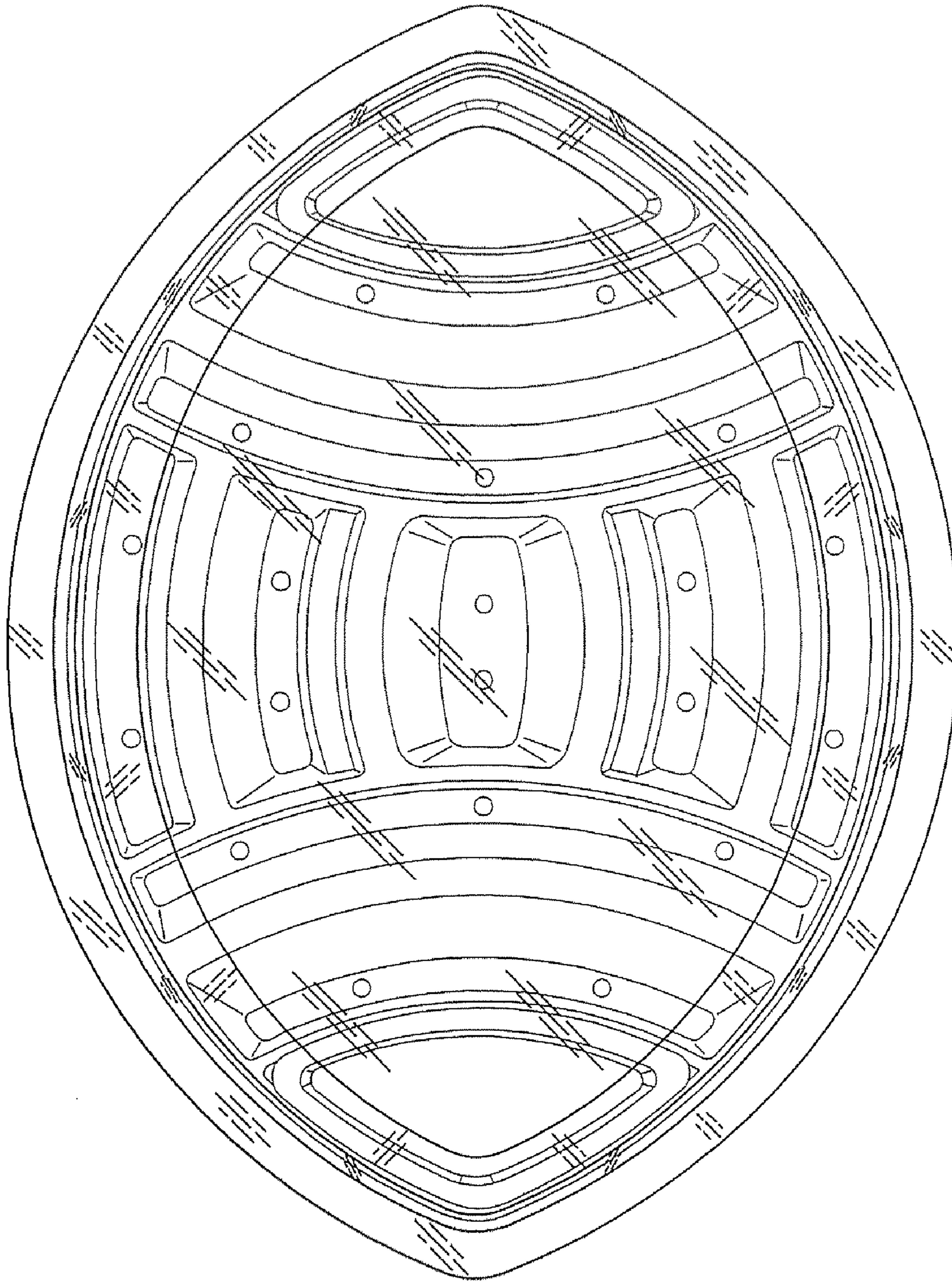

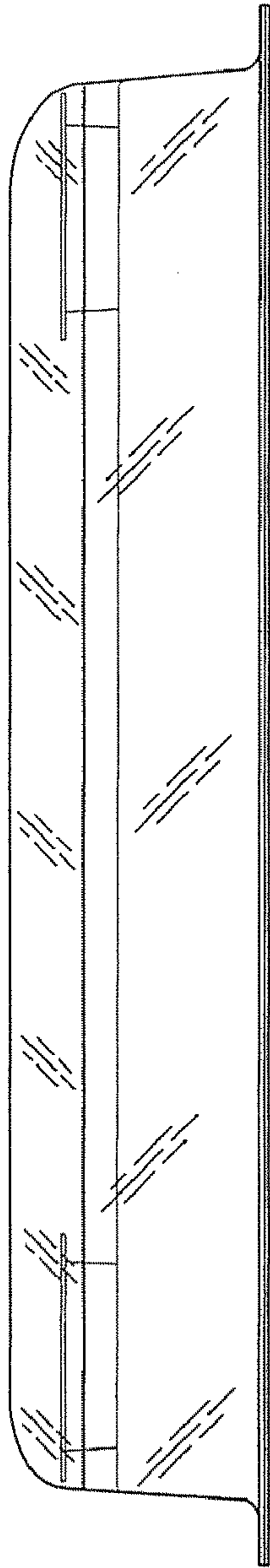

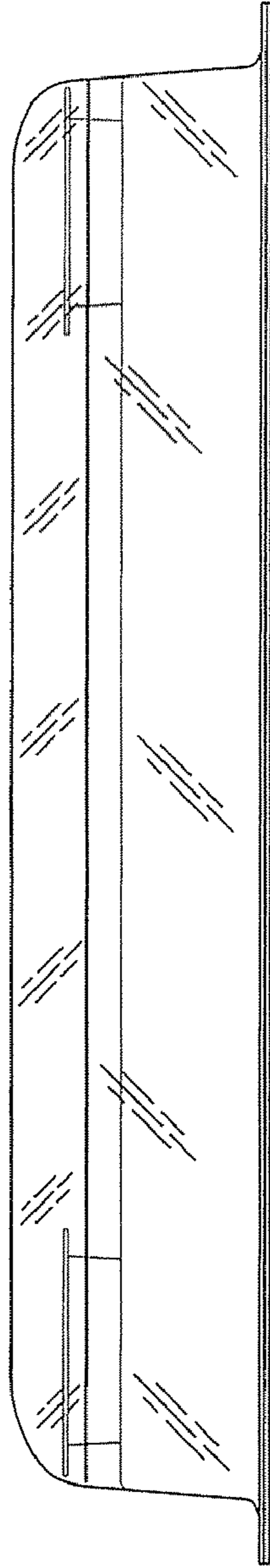

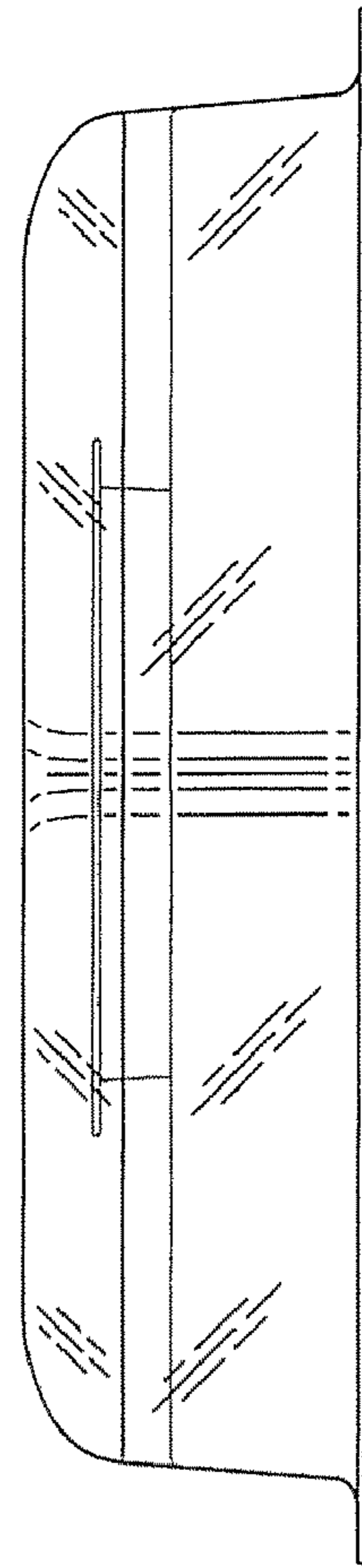

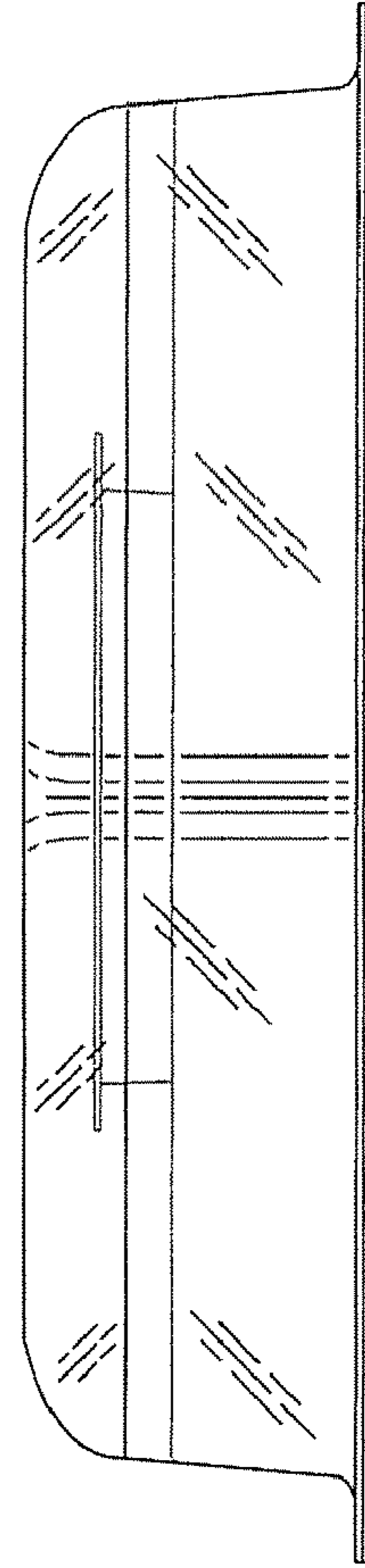

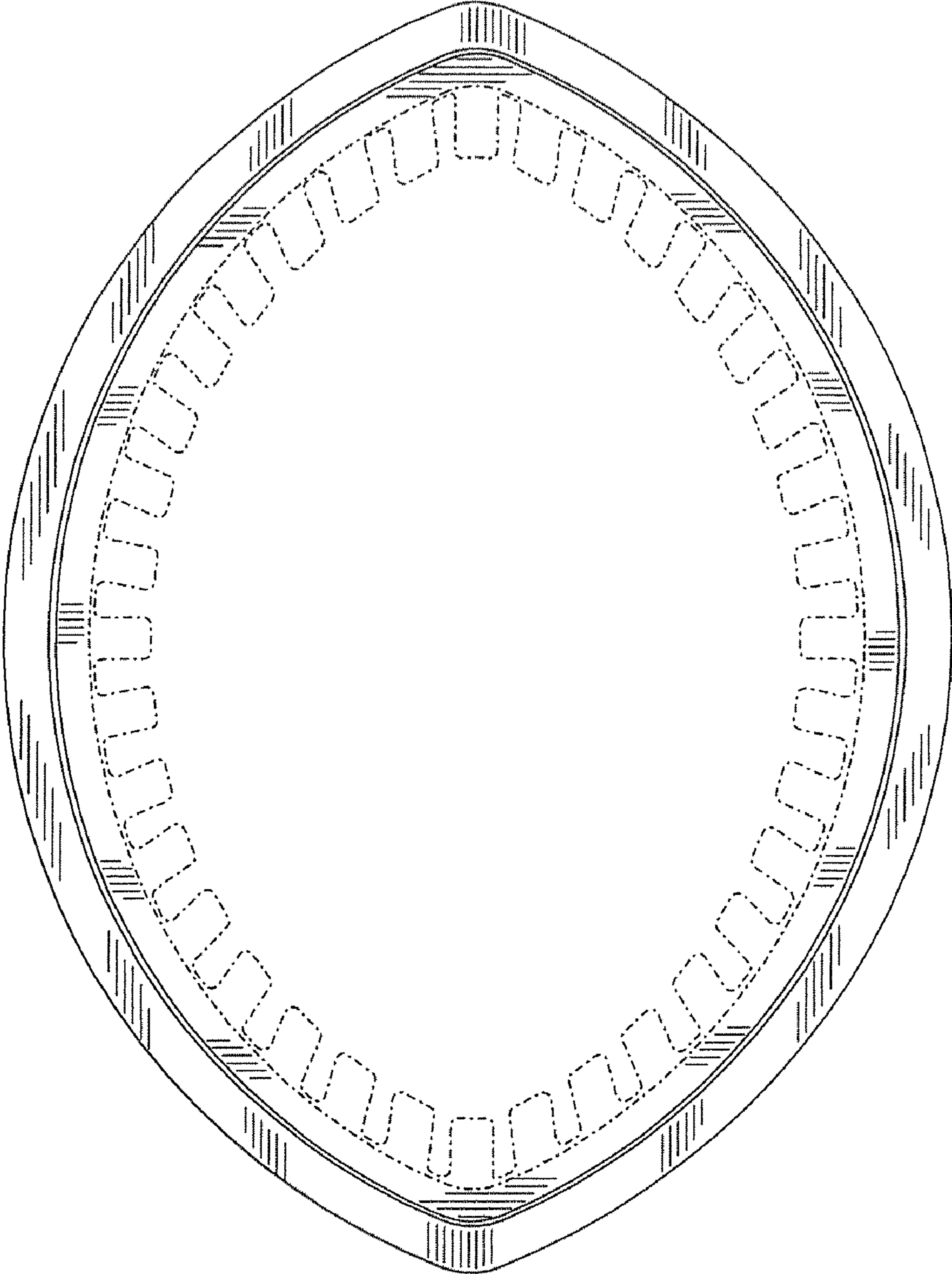

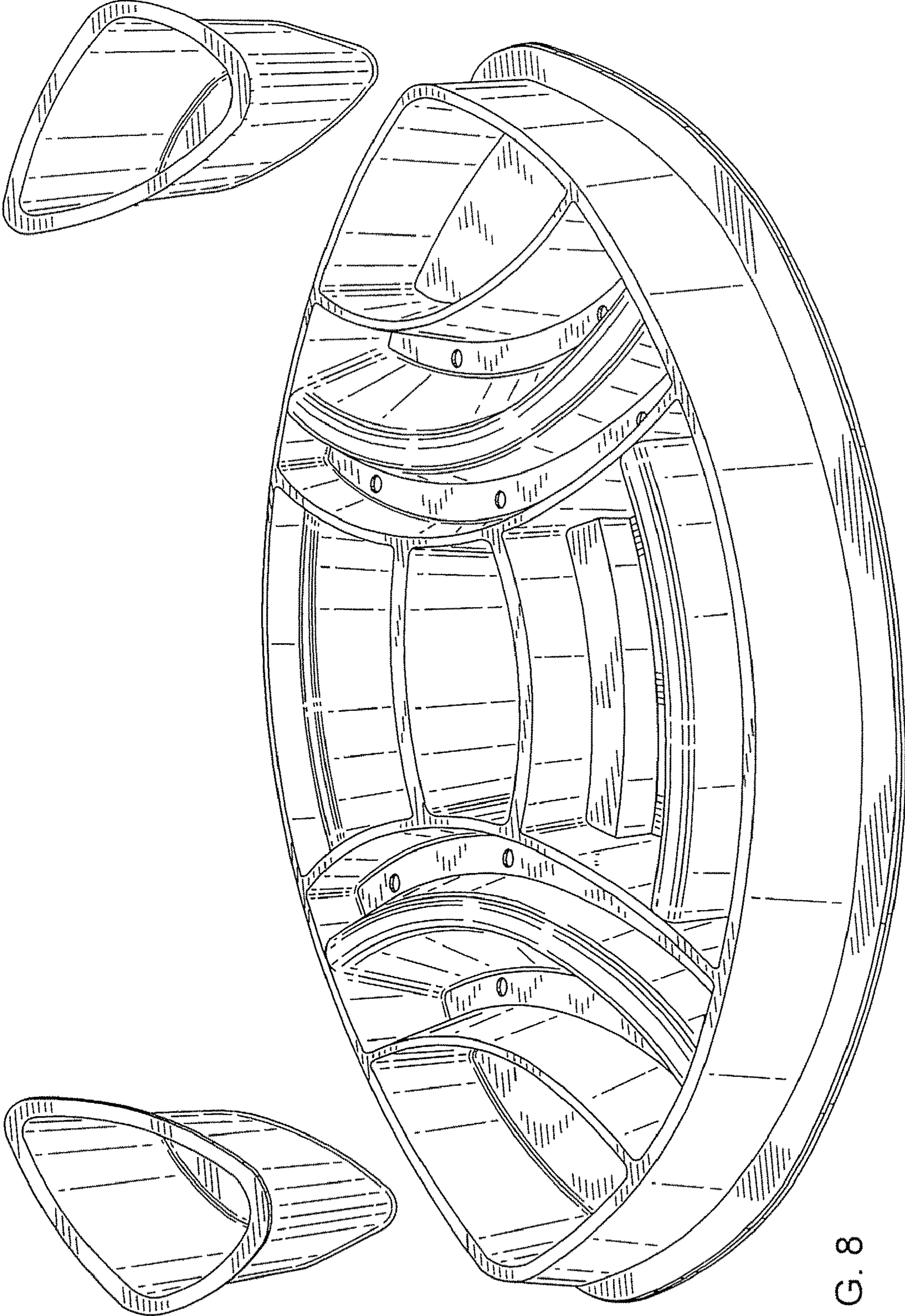
