**DESCRIPTION**

FIG. 12 is a front view of the spoon in the cutlery set;

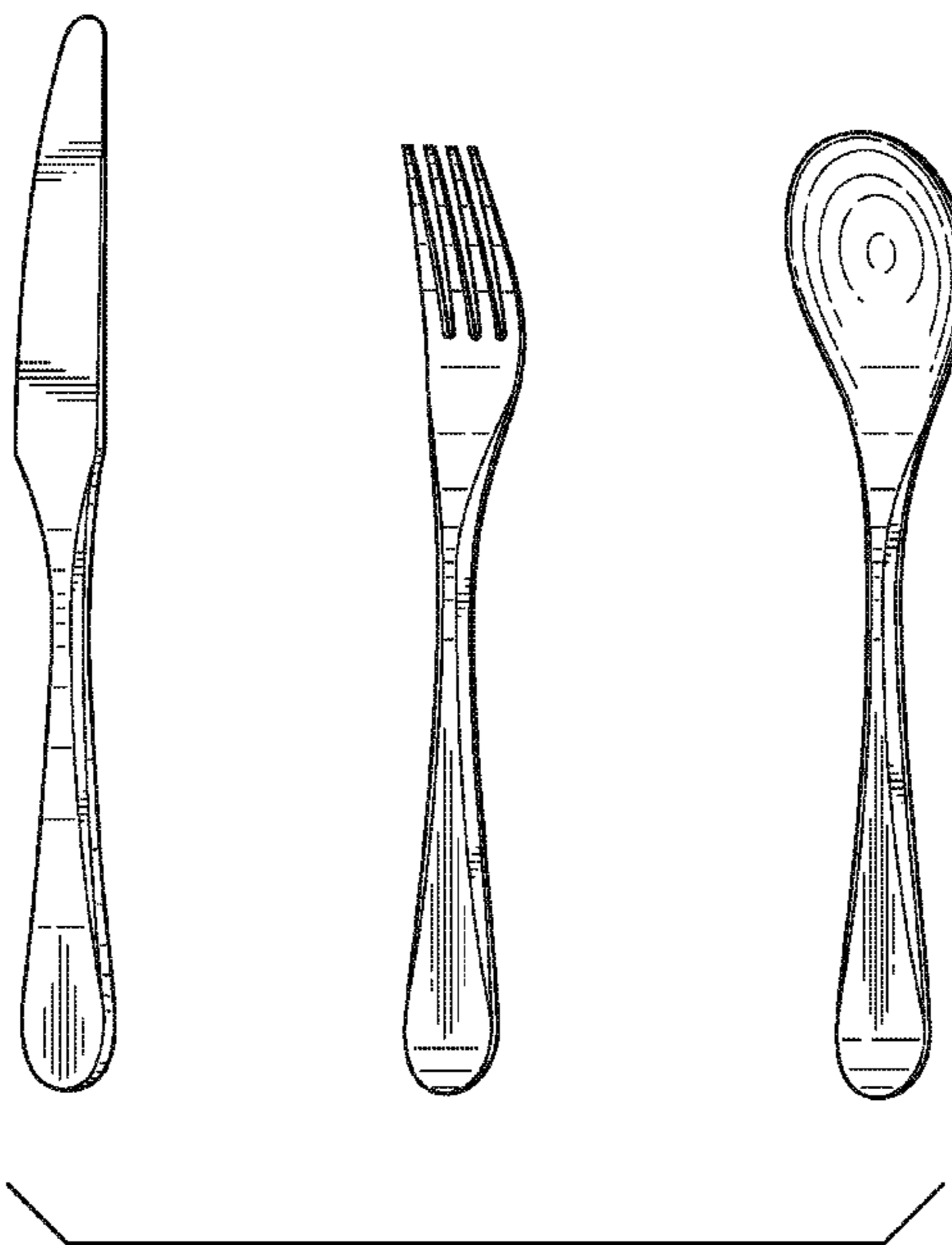
FIG. 13 is a back view of the spoon;

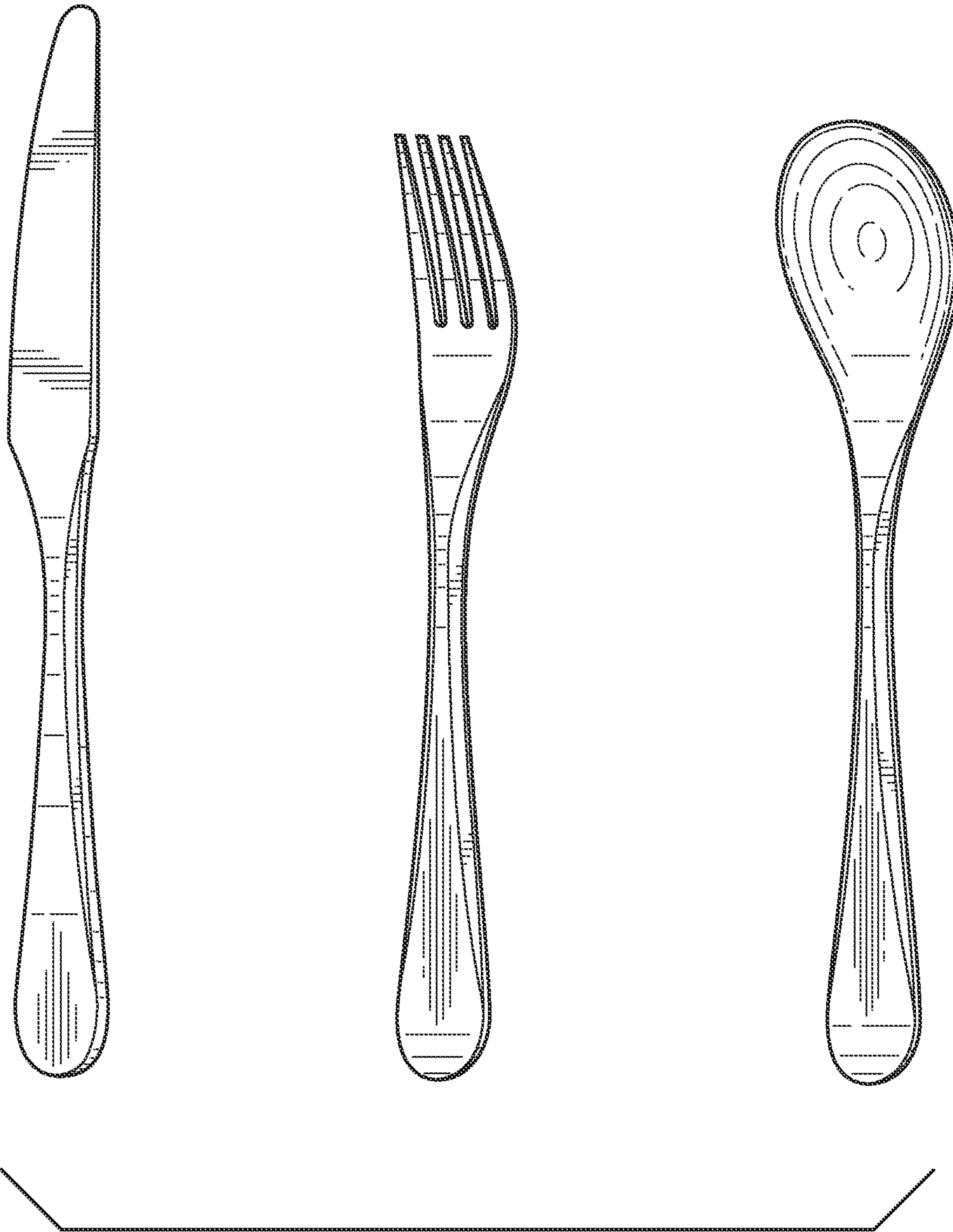
FIG. 14 is a left side view of the spoon, the right side view

FIG. 15 is a handle end view of the spoon; and,

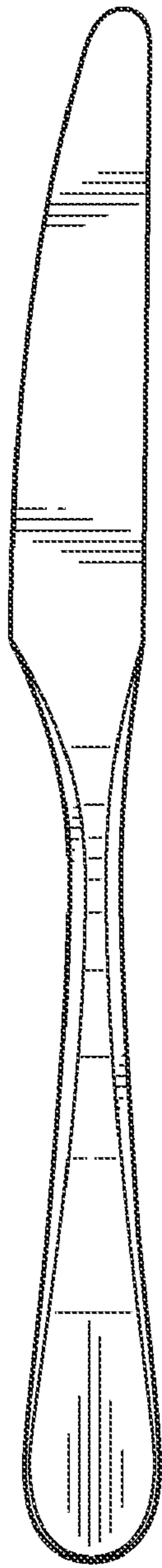
FIG. 16 is a bowl end view of the spoon.

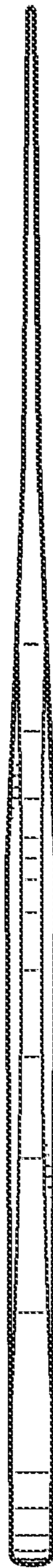

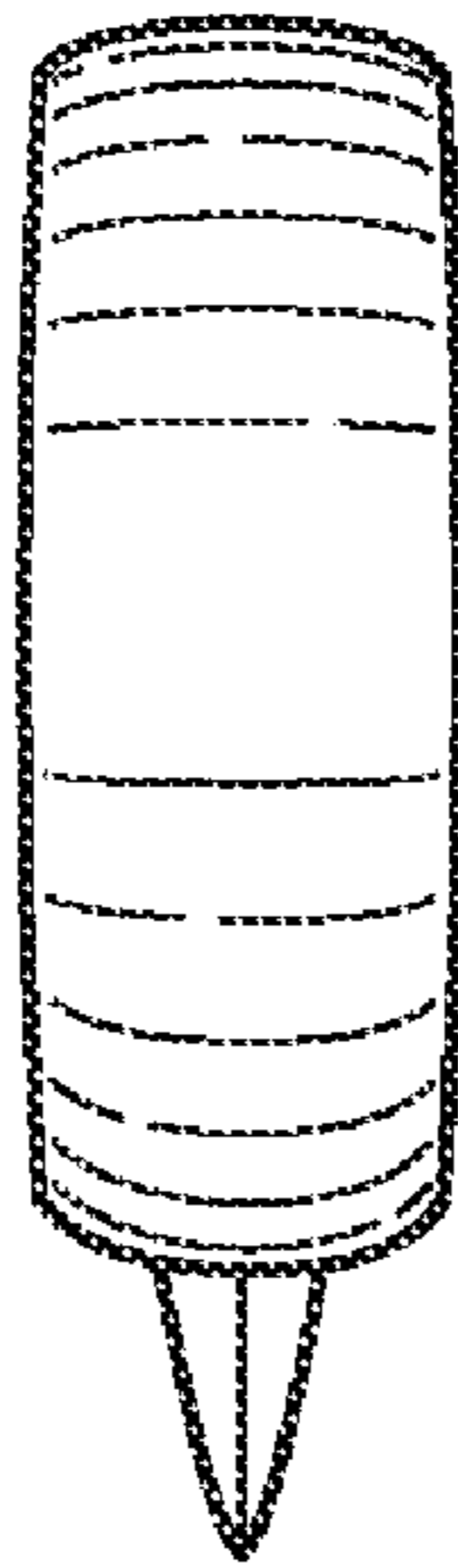

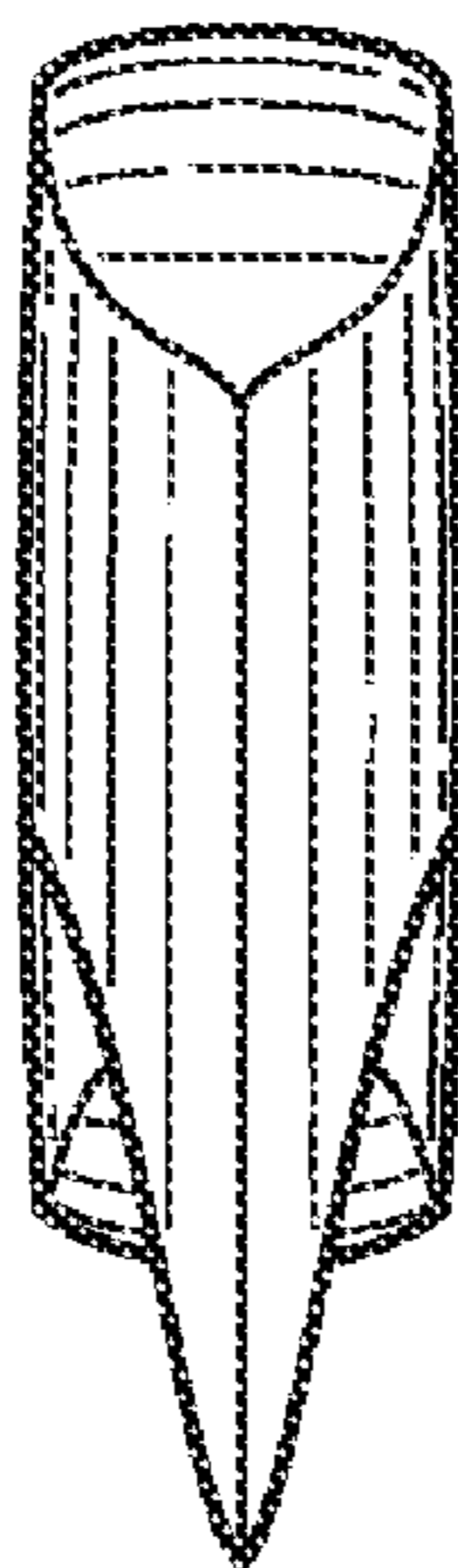

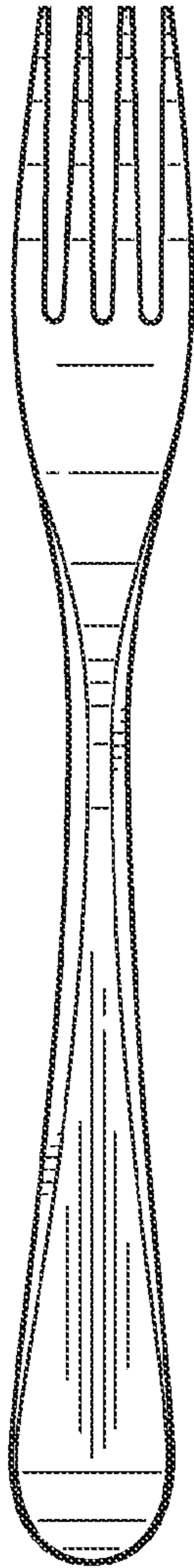

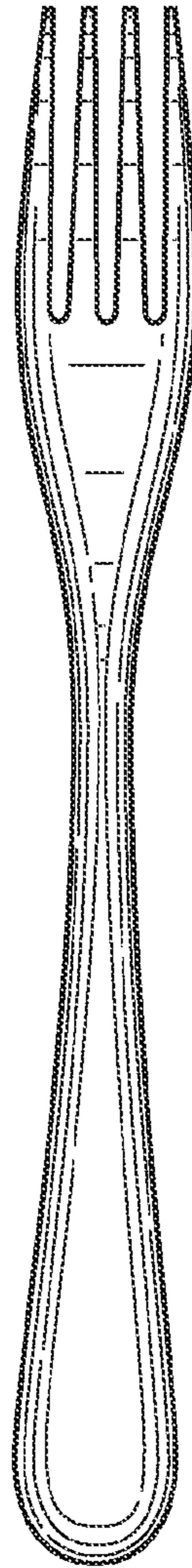

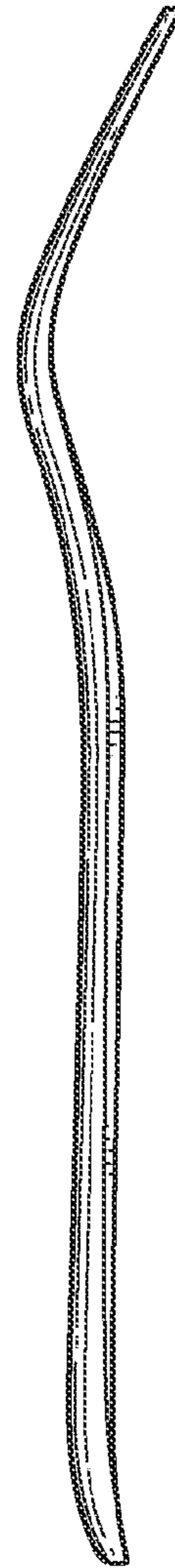




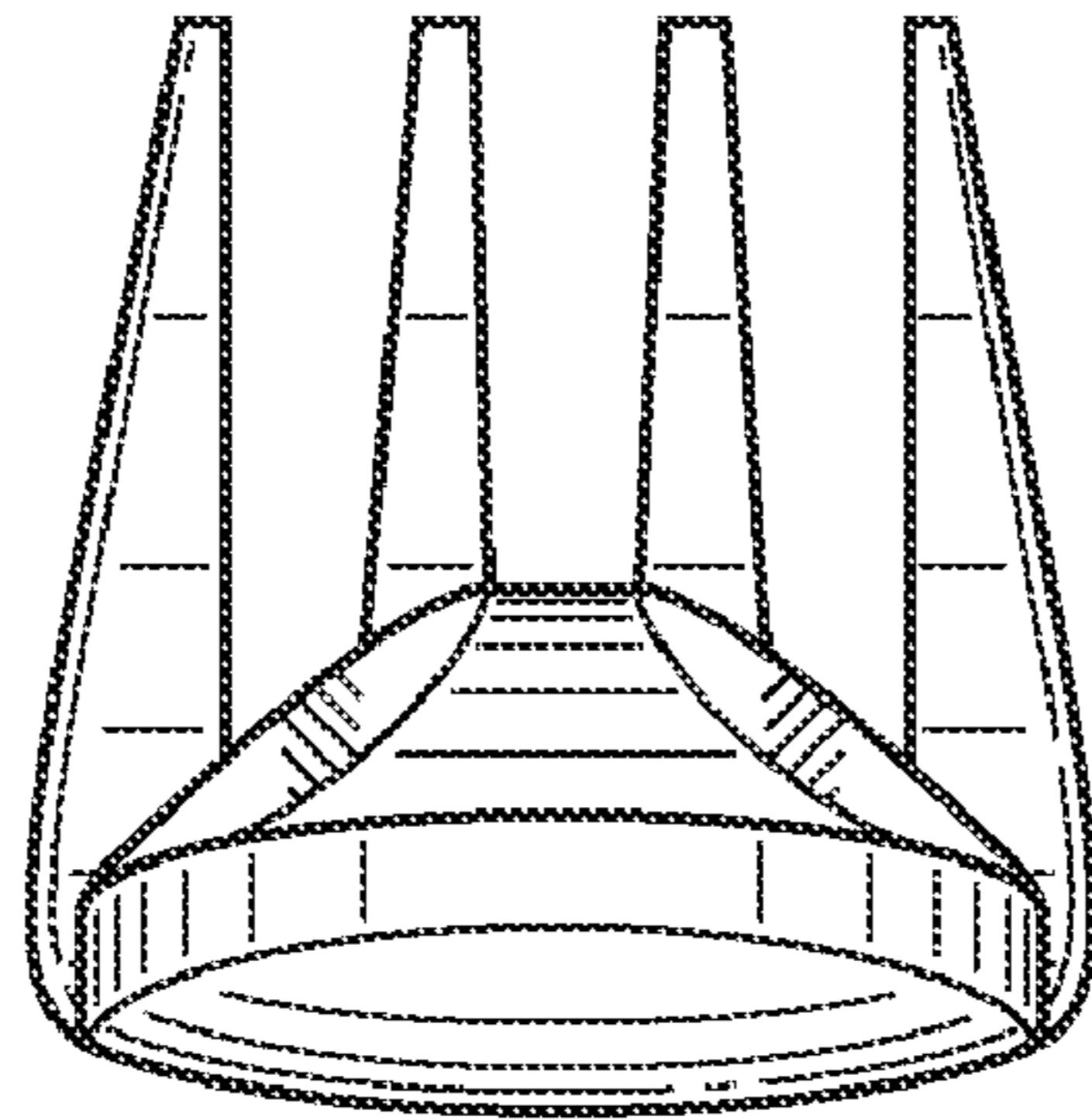

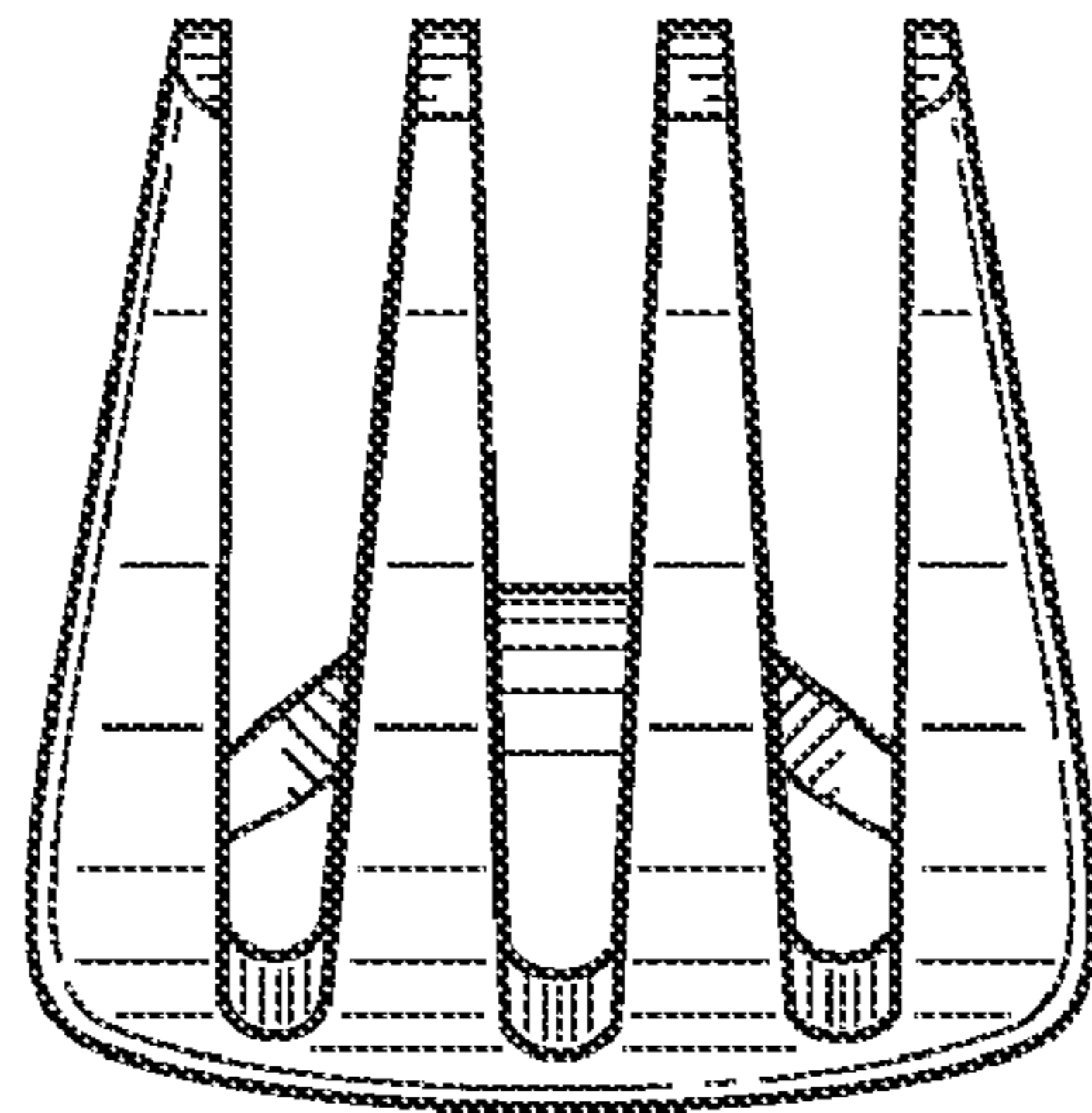

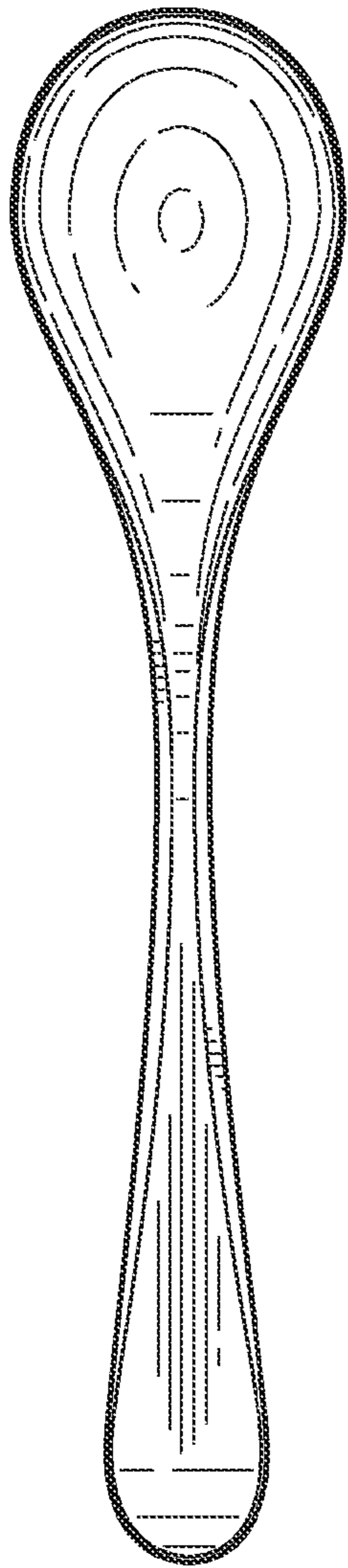

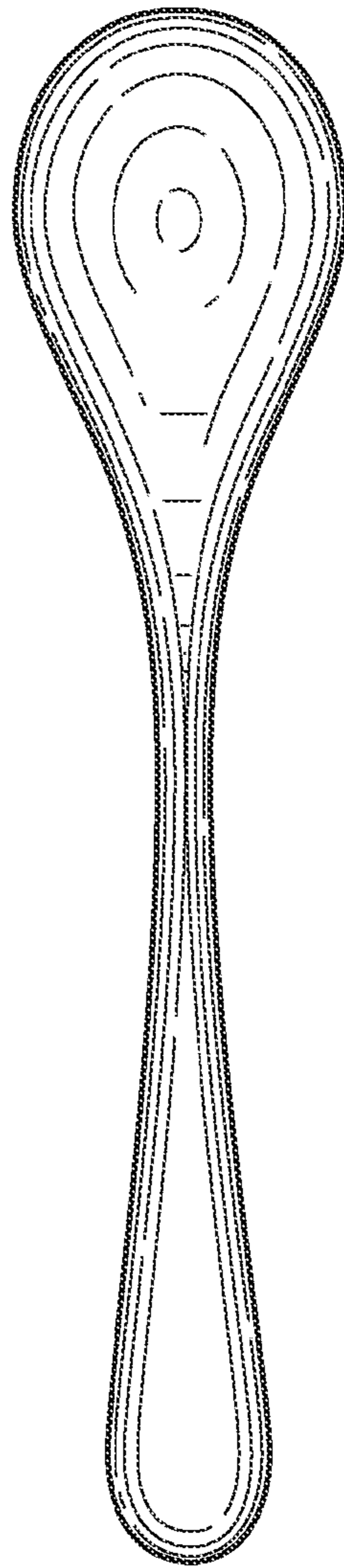

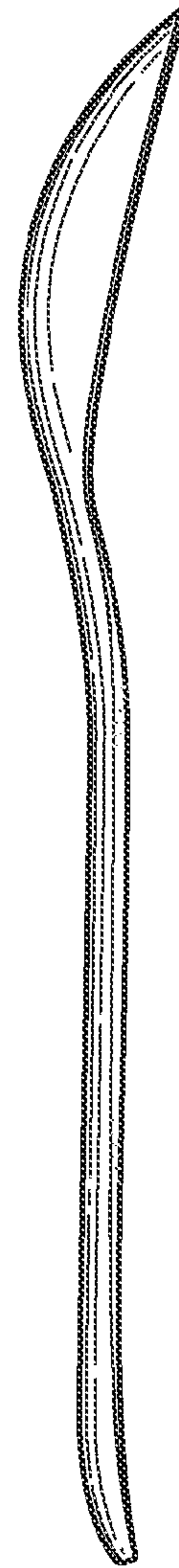

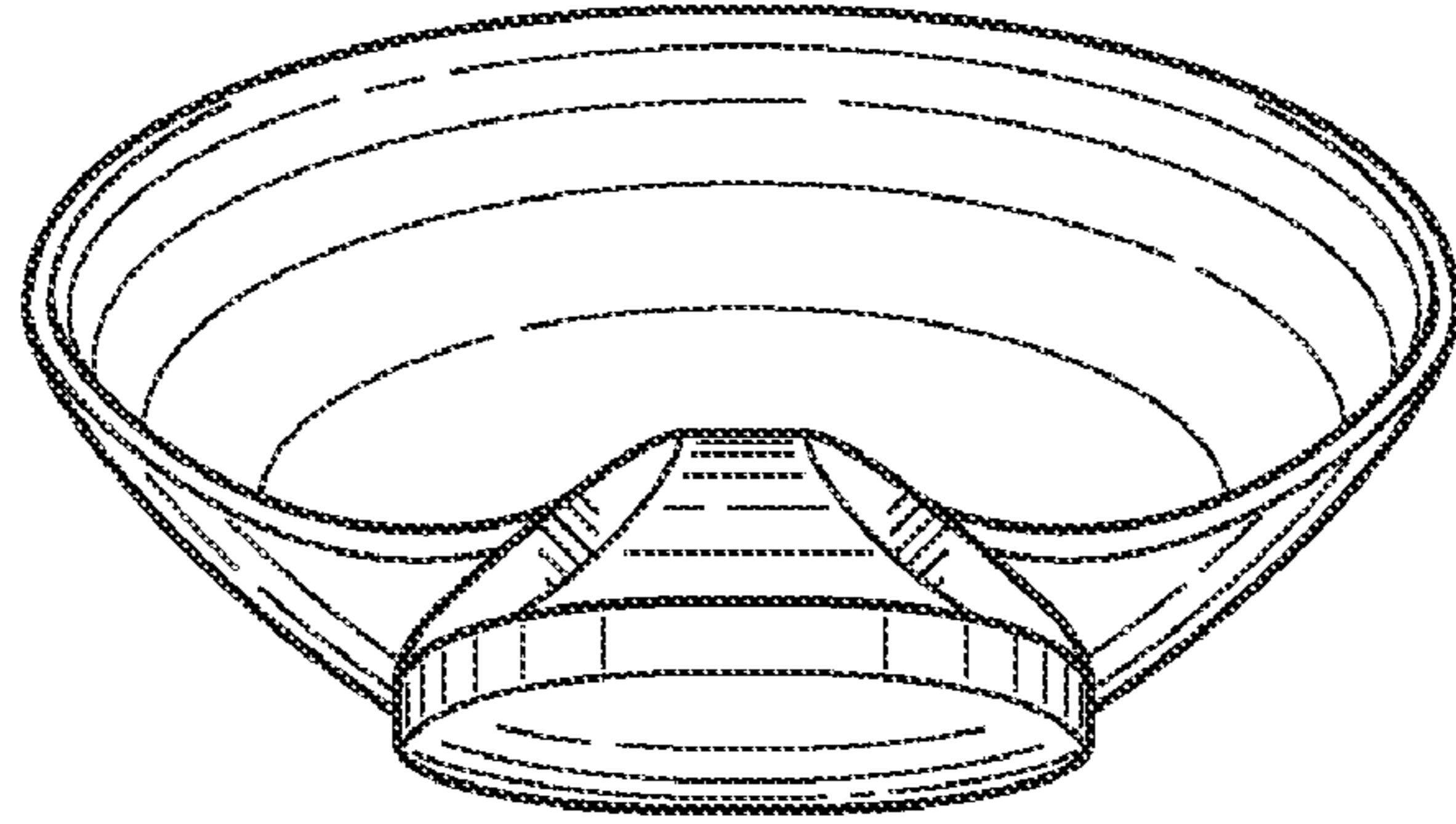

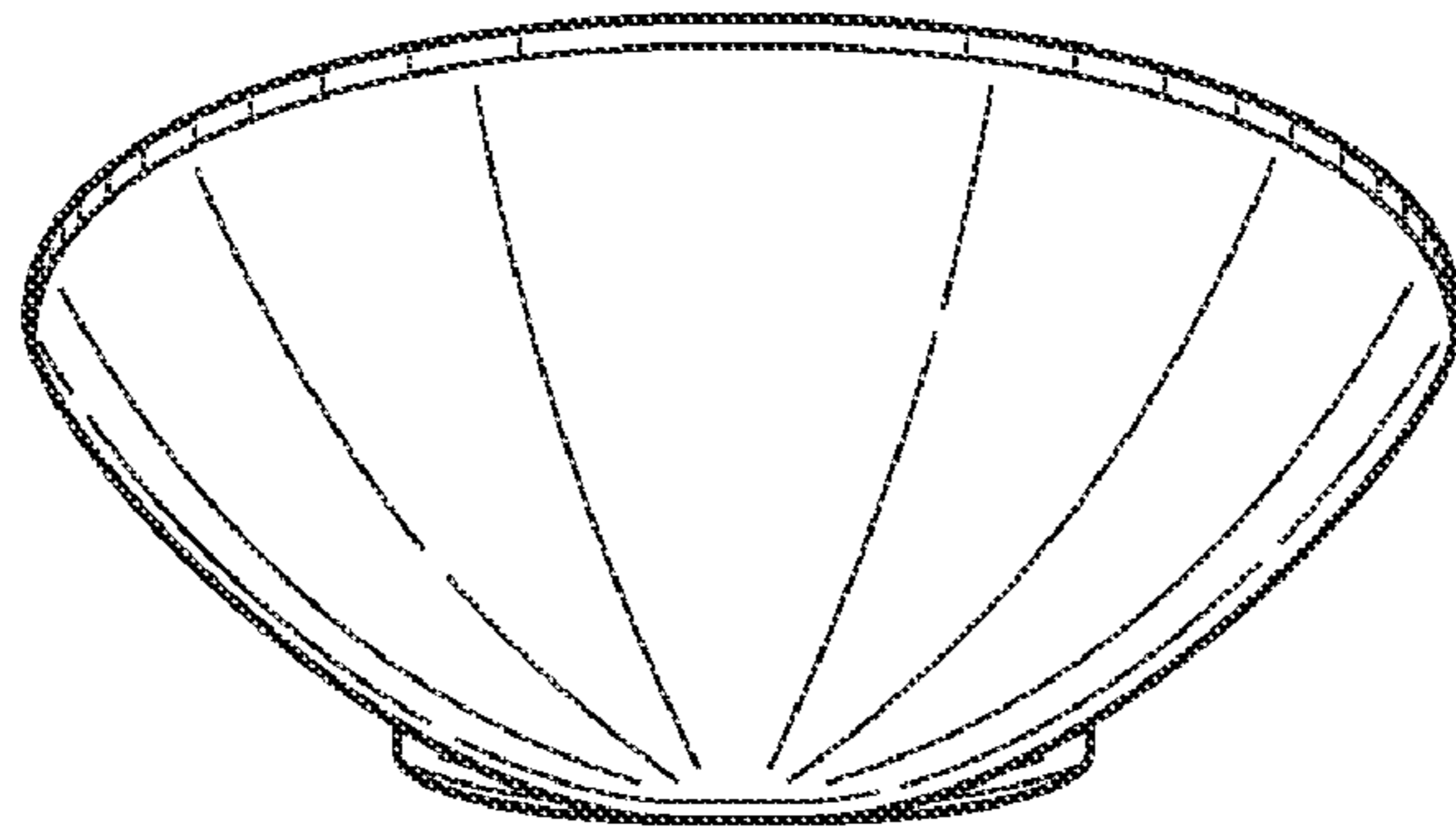
