(57) **CLAIM**

The ornamental design for a remote controller for vehicles, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a remote controller for vehicles, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a cross-sectional view thereof; taken along line 8-8 of FIG. 2;

FIG. 9 is a cross-sectional view thereof; taken along line 9-9 of FIG. 4; and,

FIG. 10 is a reference bottom view showing the light-transmitting portion of the design in a lighted state.

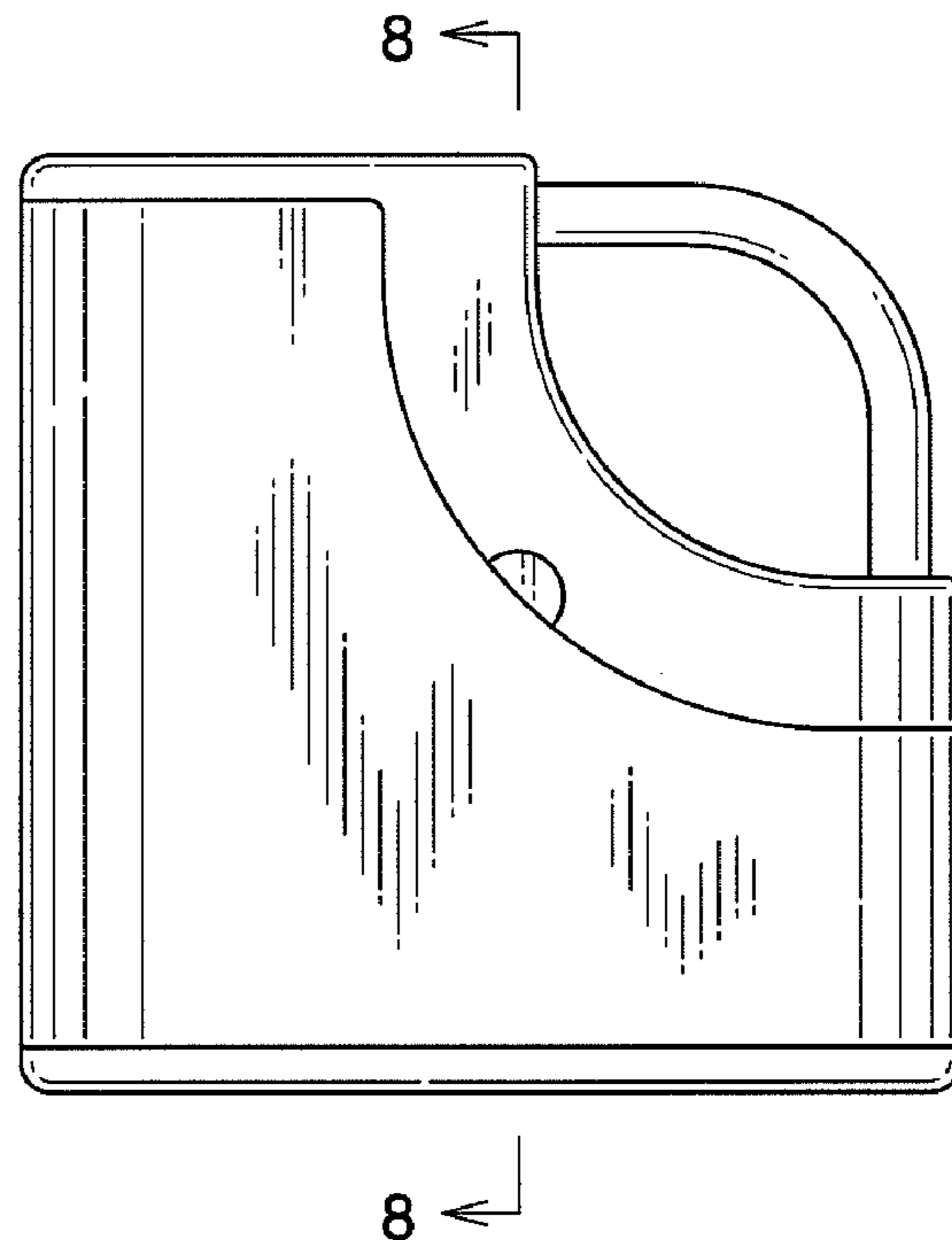
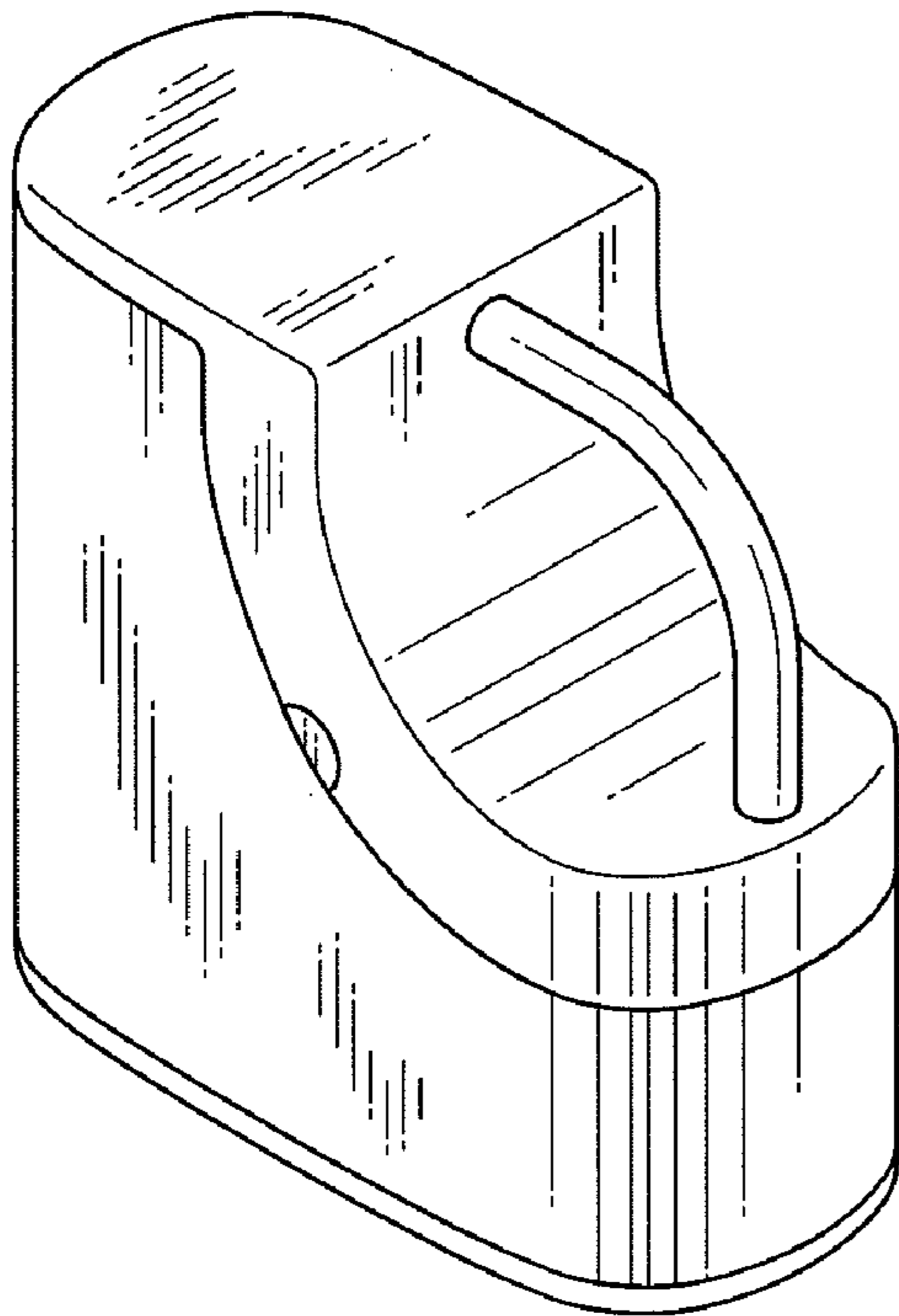

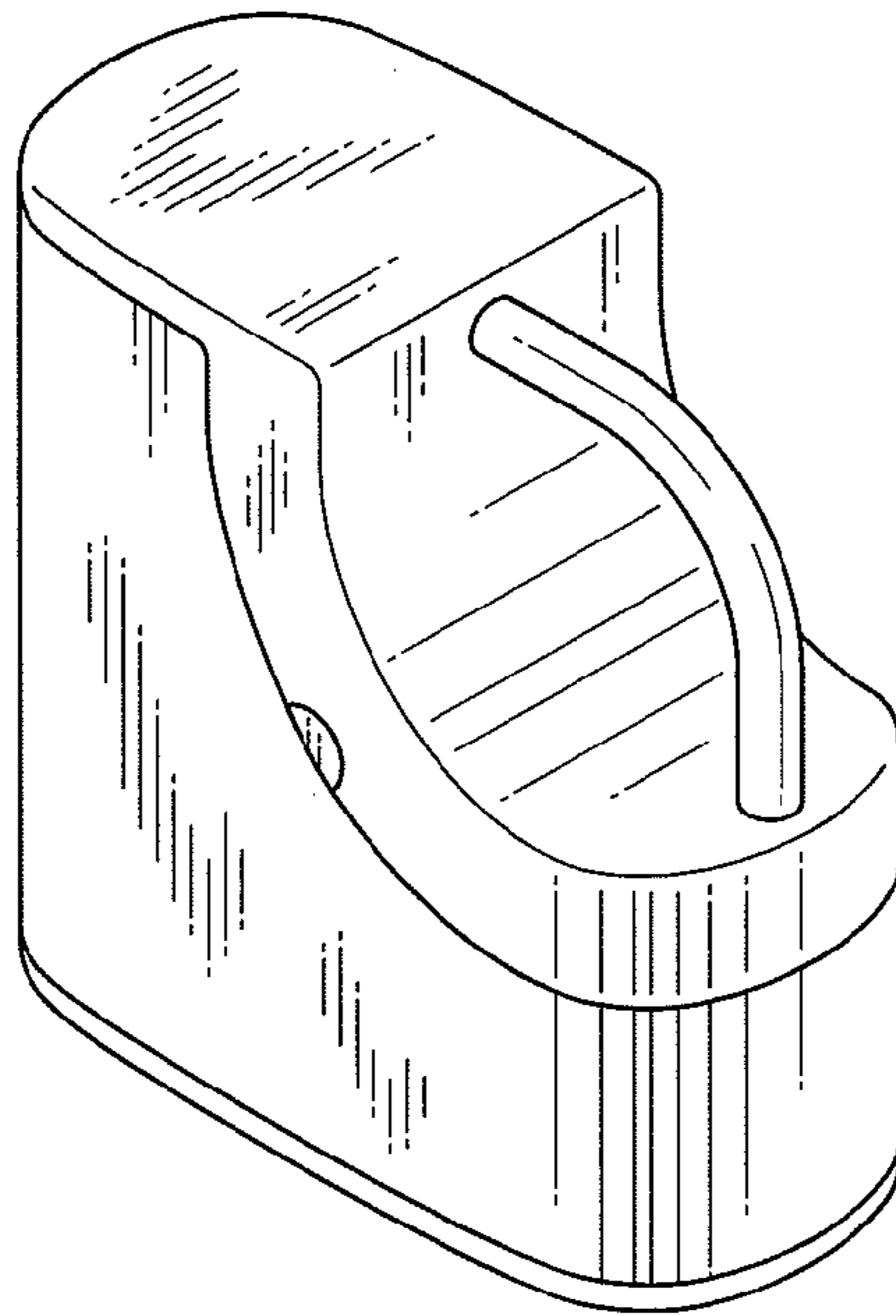
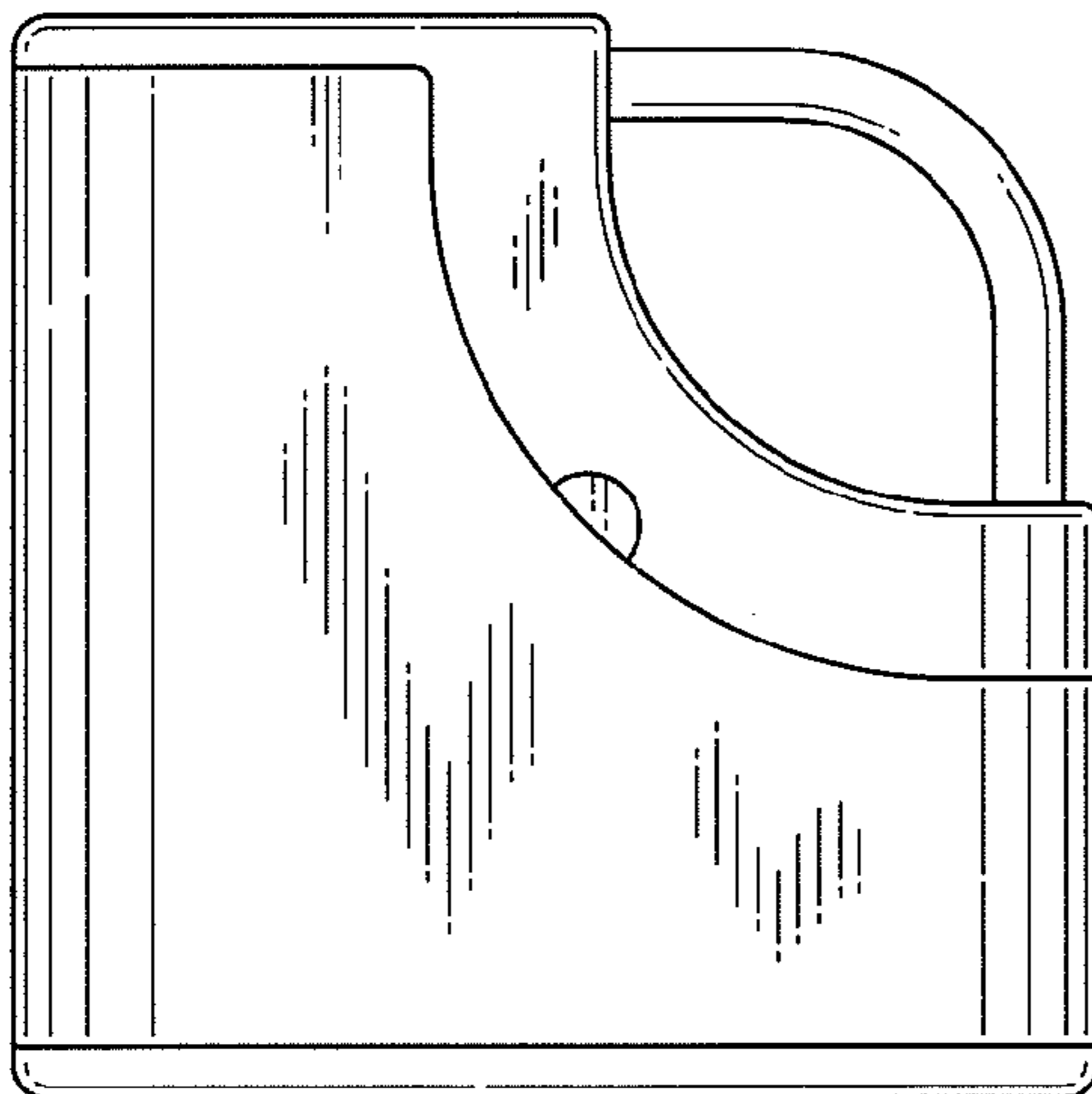

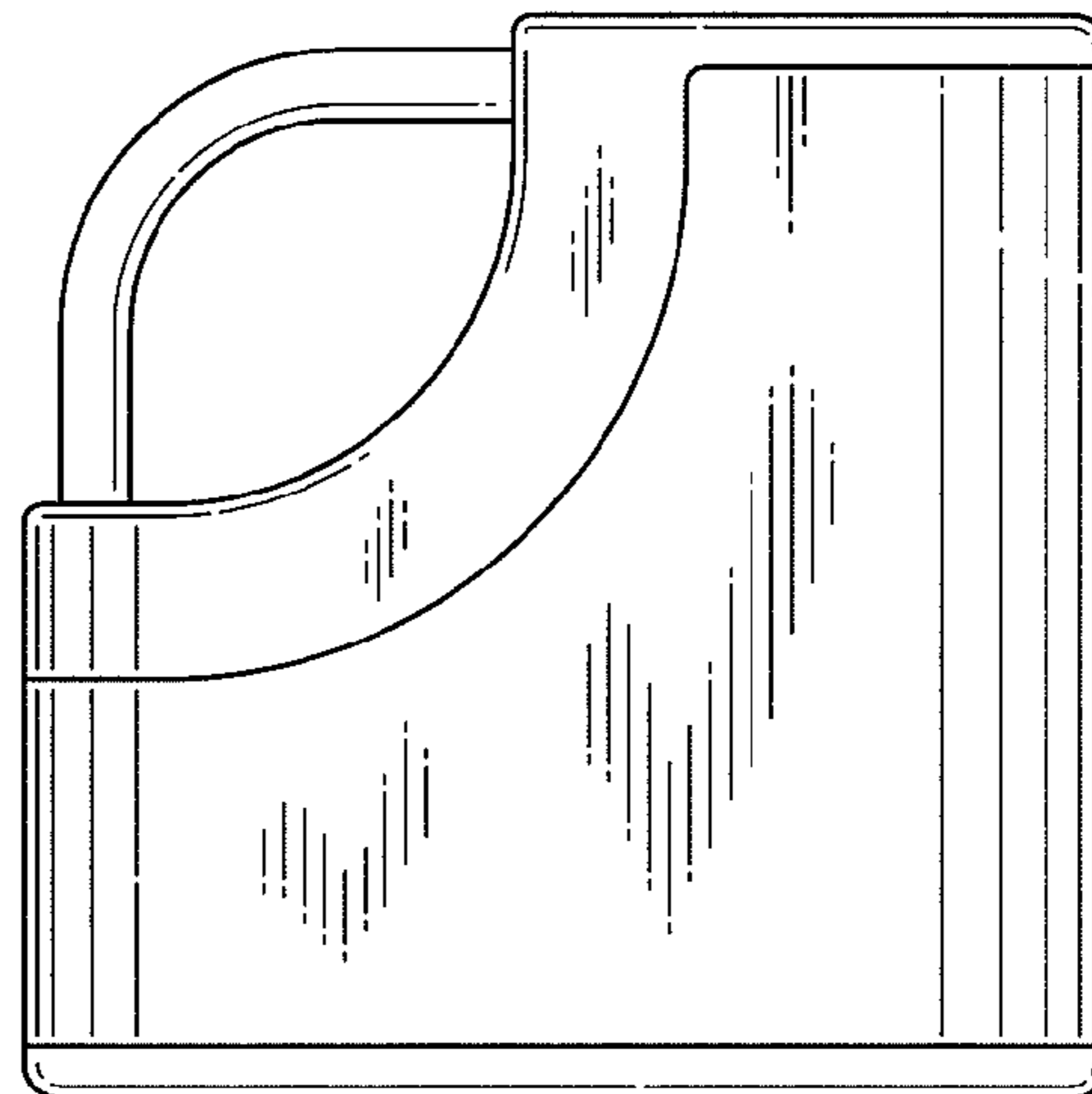

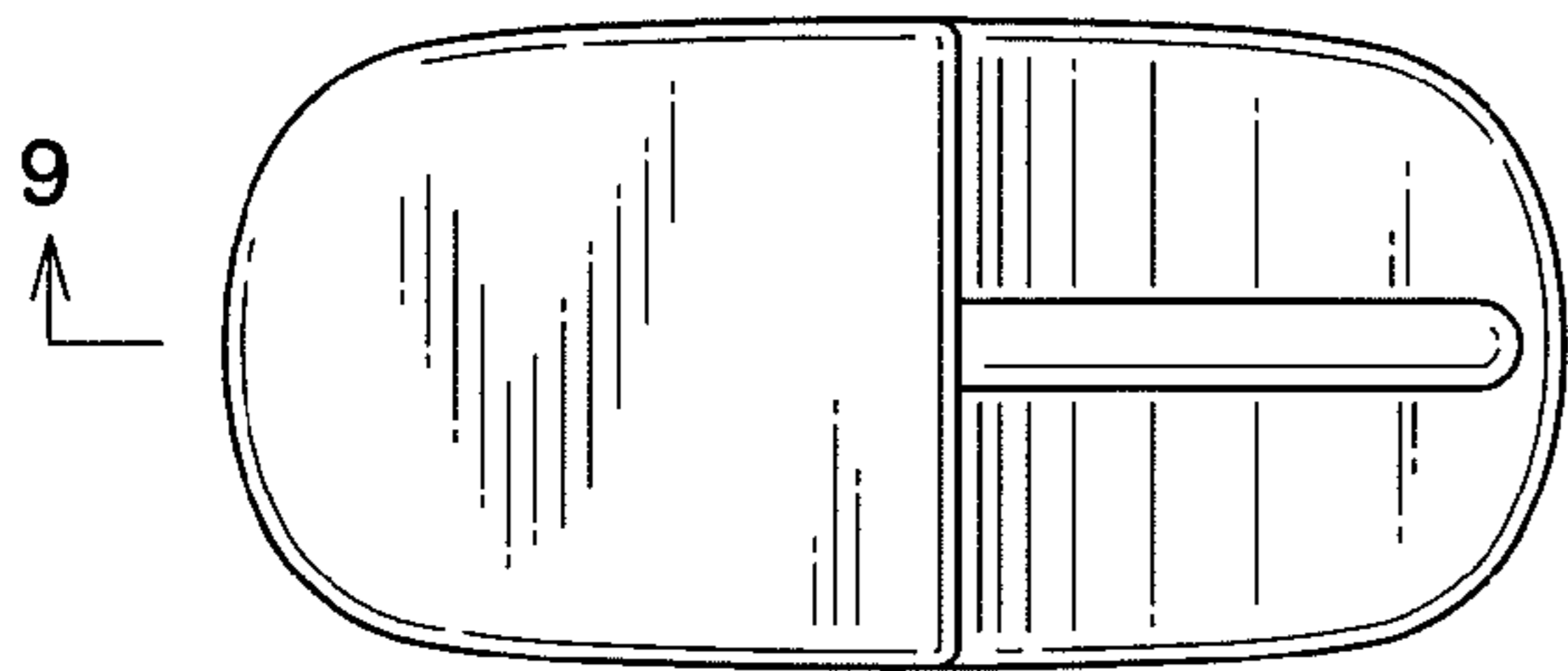

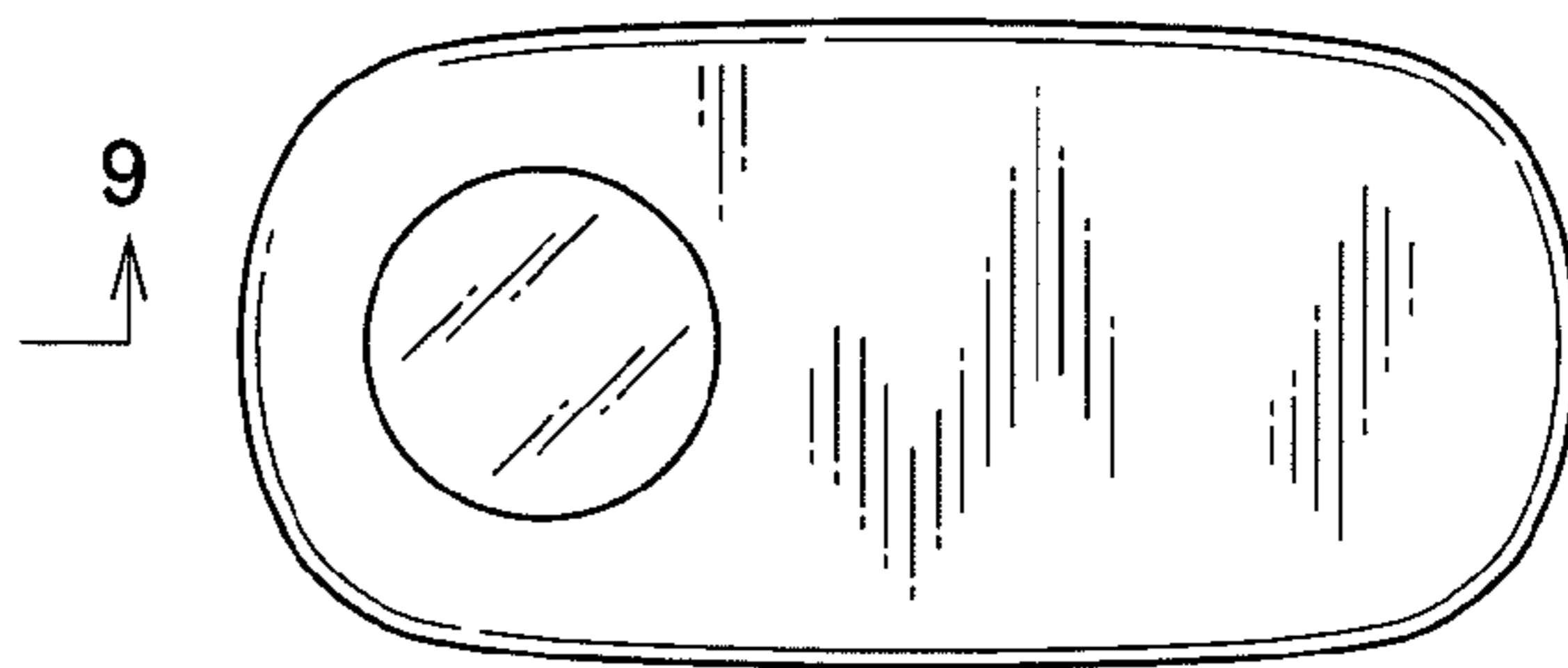

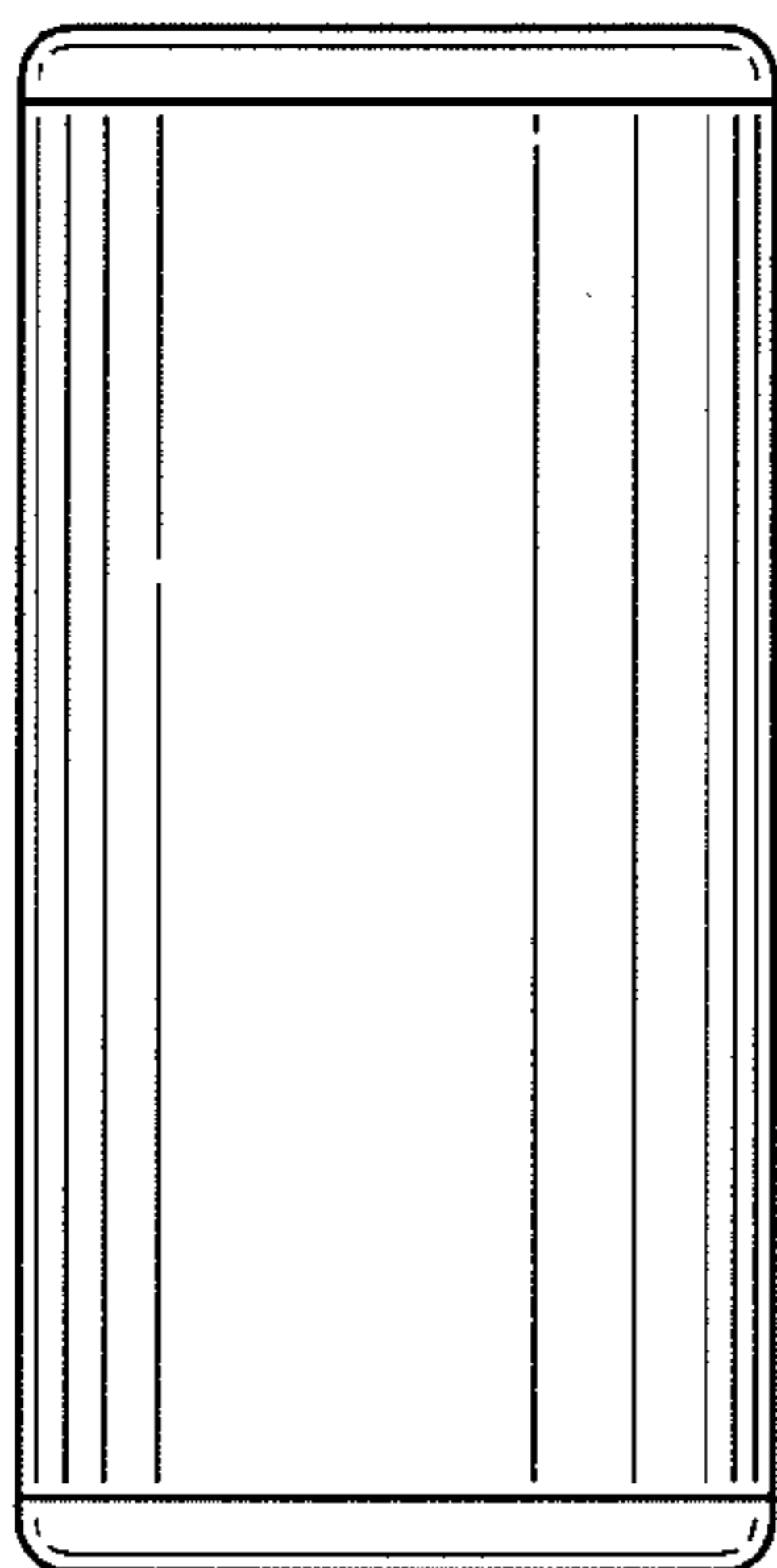

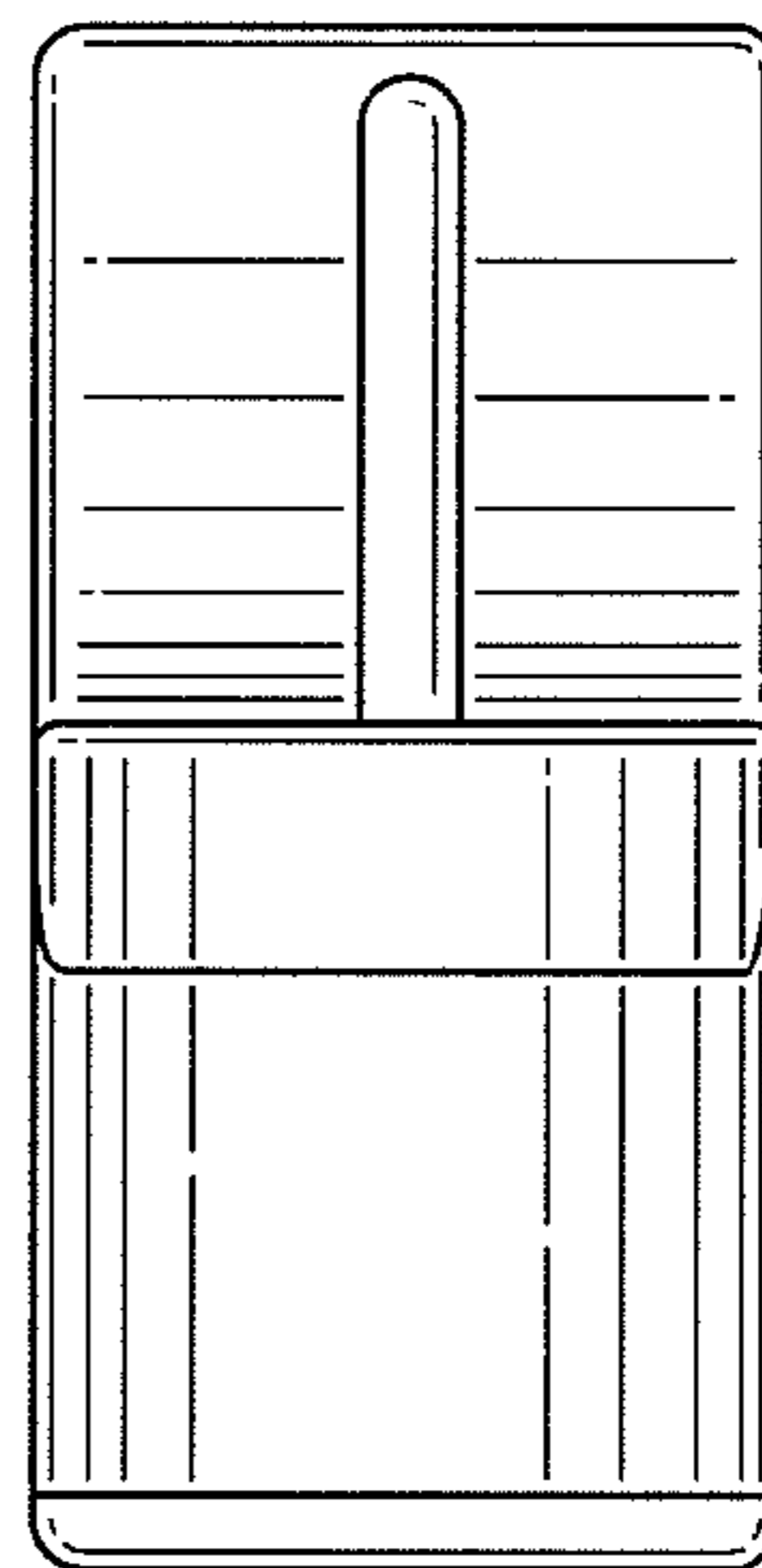

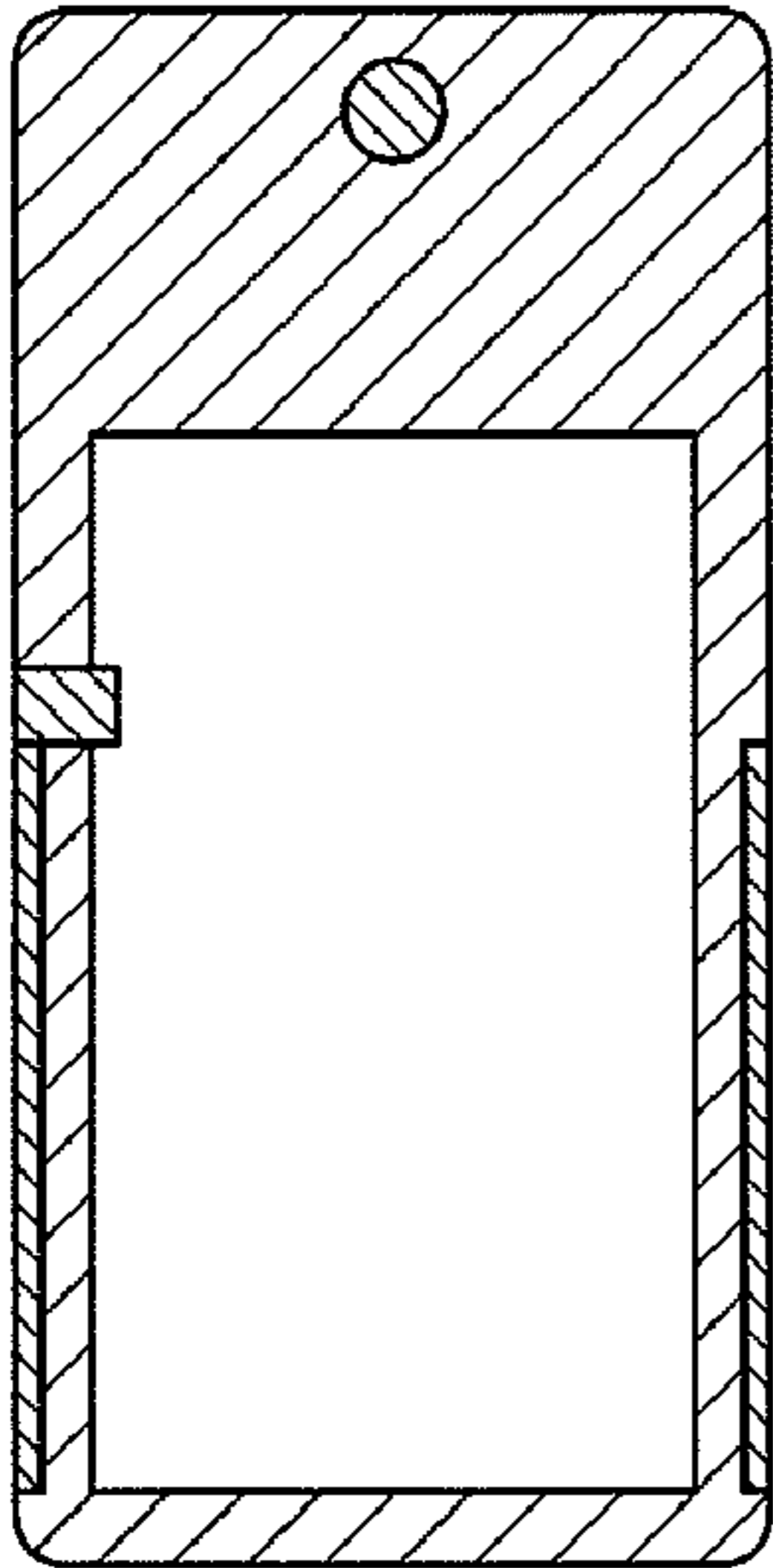

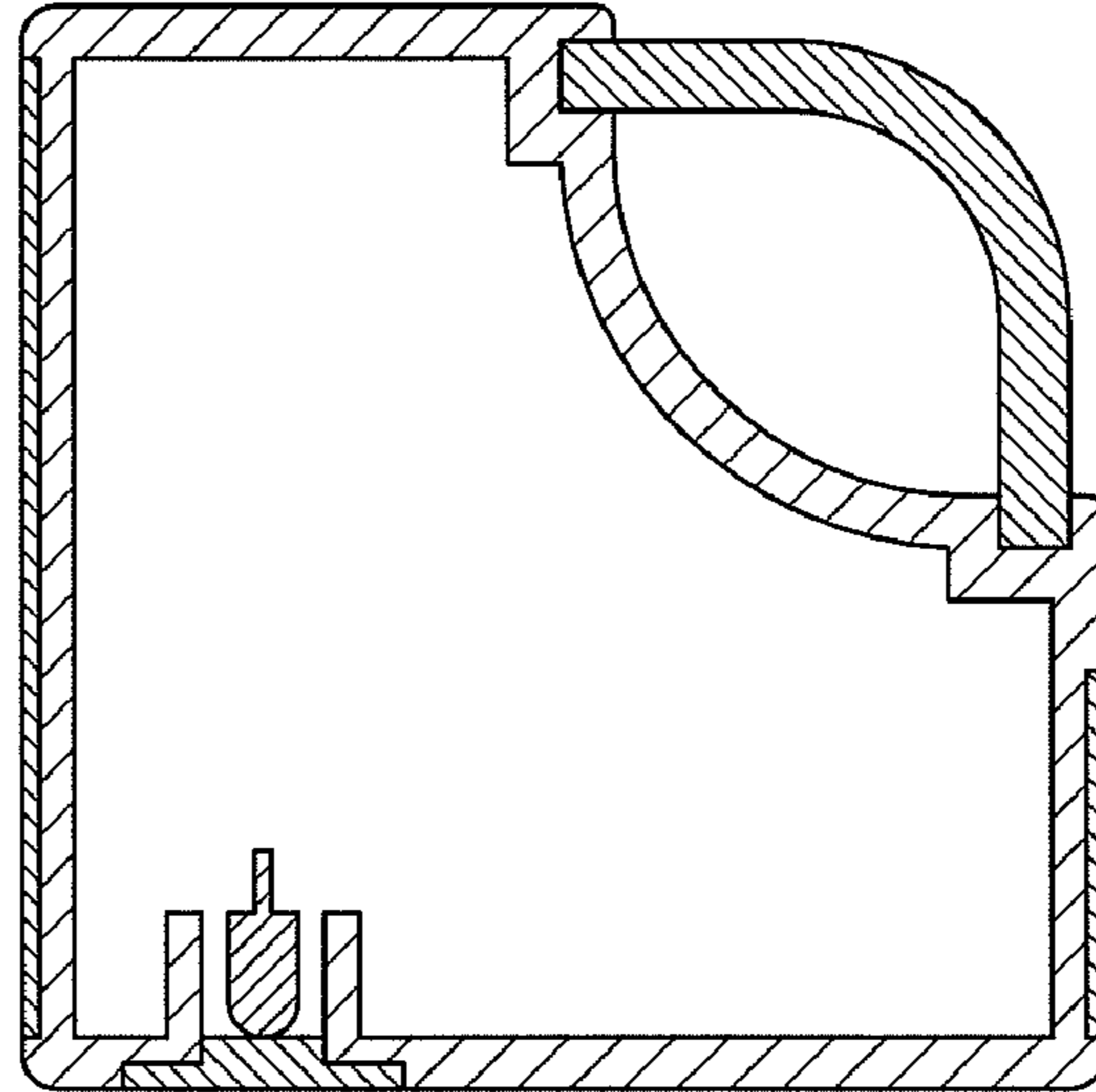
